(57) **CLAIM**

We claim the ornamental design for a box for moxibustion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a box for moxibustion, showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

FIG. 5 is a right-side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is an exploded perspective view thereof;

FIG. 9 is a top plan view of a metal lid insert of the design, the remainder of the design omitted for clarity of illustration;

FIG. 10 is a front elevation view of FIG. 9, the rear elevation view, right-side elevation view, and left-side elevation view all being identical thereto;

FIG. 11 is a top plan view of a metal insert of the design, the bottom plan view being a mirror image thereof, the remainder of the design omitted for clarity of illustration;

FIG. 12 is a front elevational view thereof;

FIG. 13 is a right-side elevation view thereof;

FIG. 14 is a left-side elevation view thereof, the rear elevation view being a mirror image thereof;

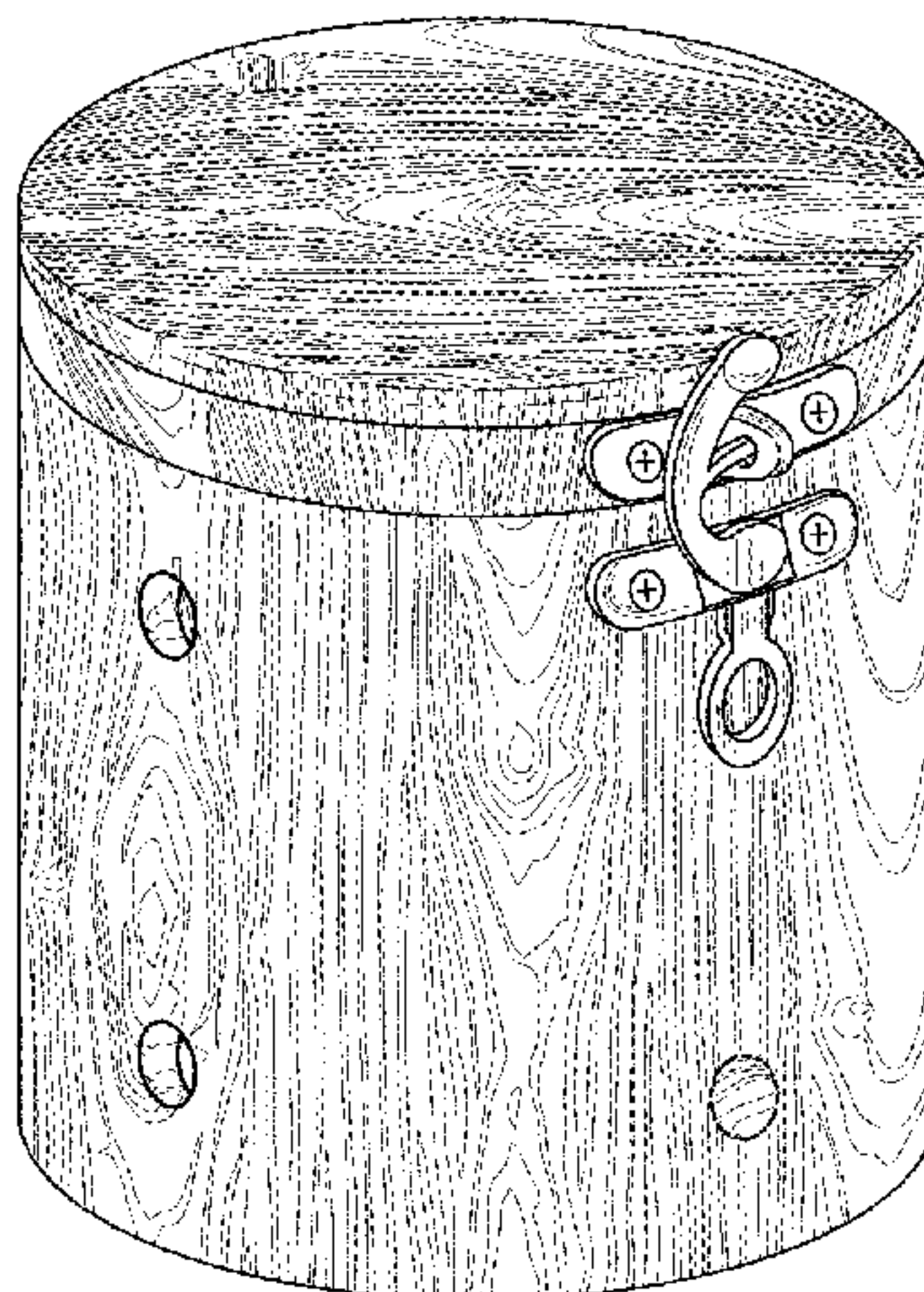
FIG. 15 is a front elevation view of a screen insert of the design, the rear elevation view, left-side elevation view, and right-side elevation view all being identical thereto, the remainder of the design omitted for clarity of illustration;

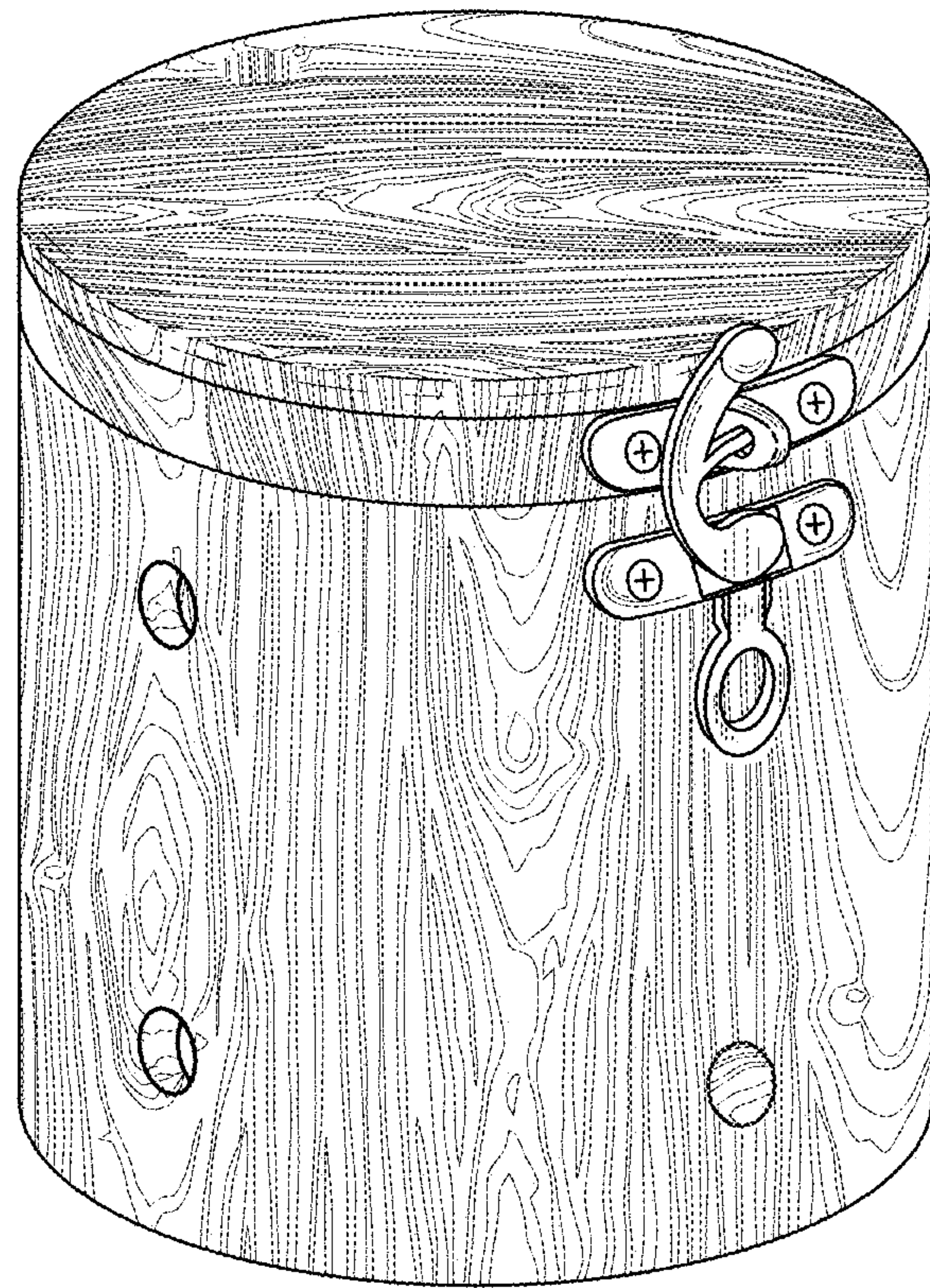

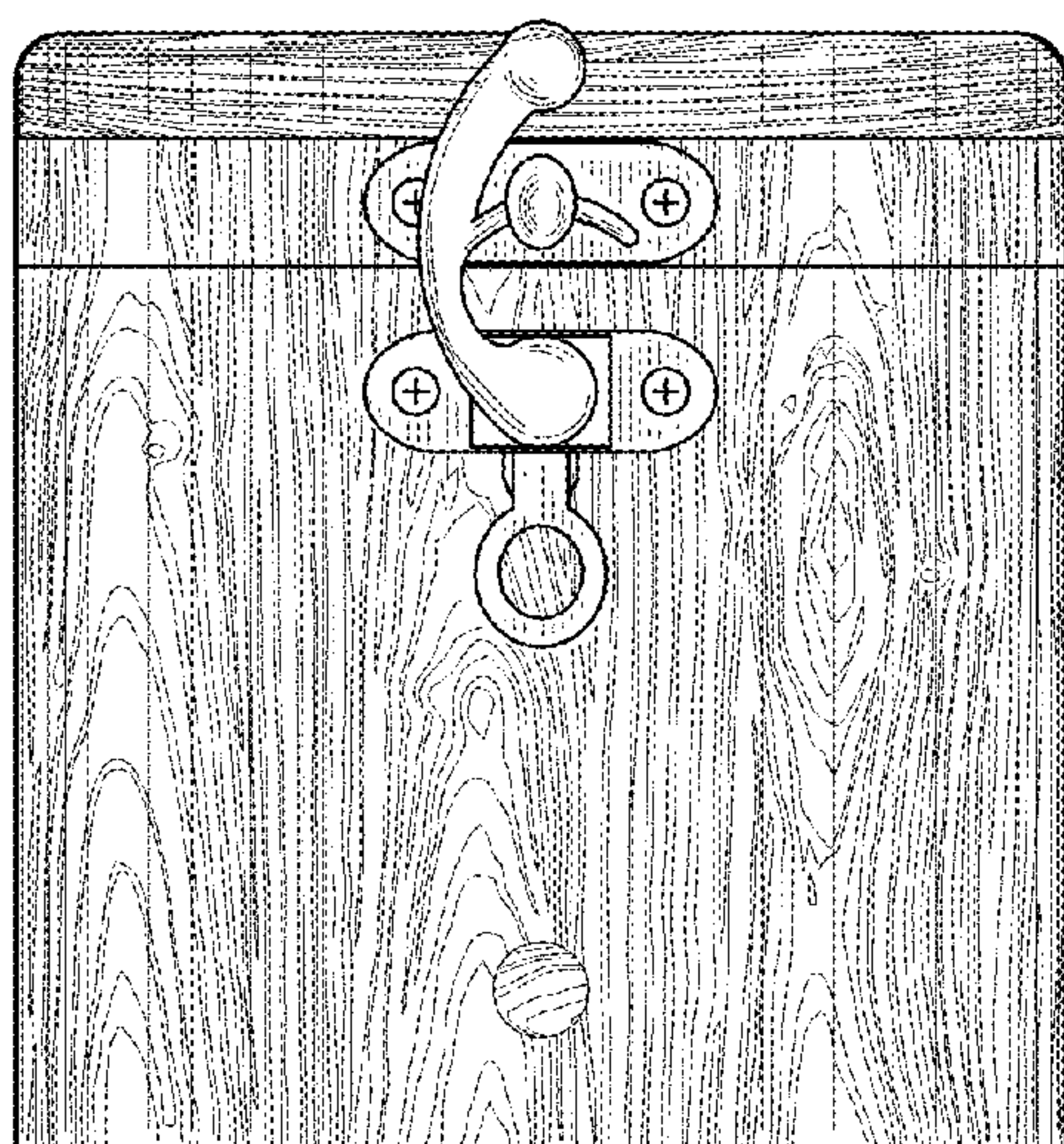

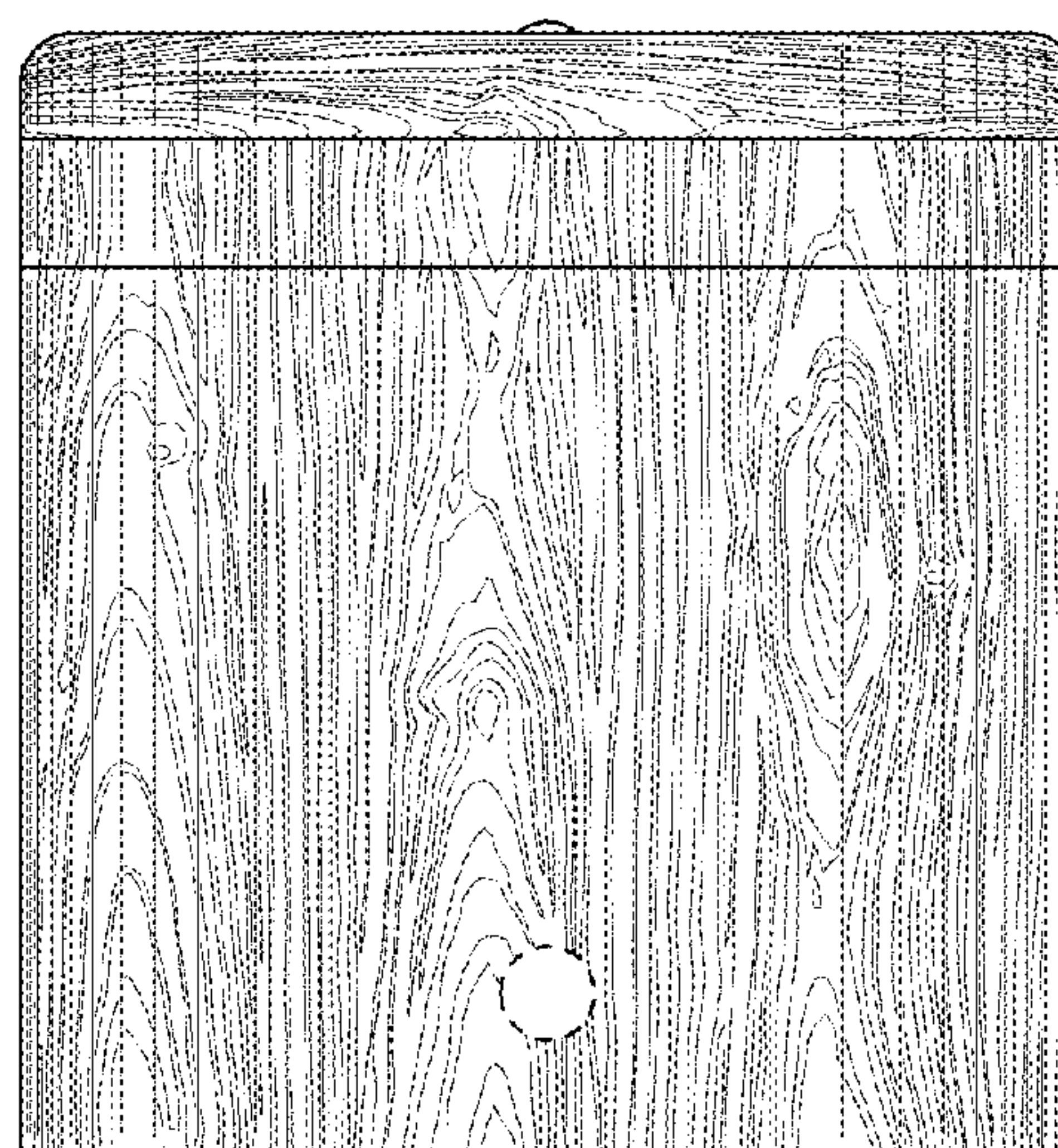

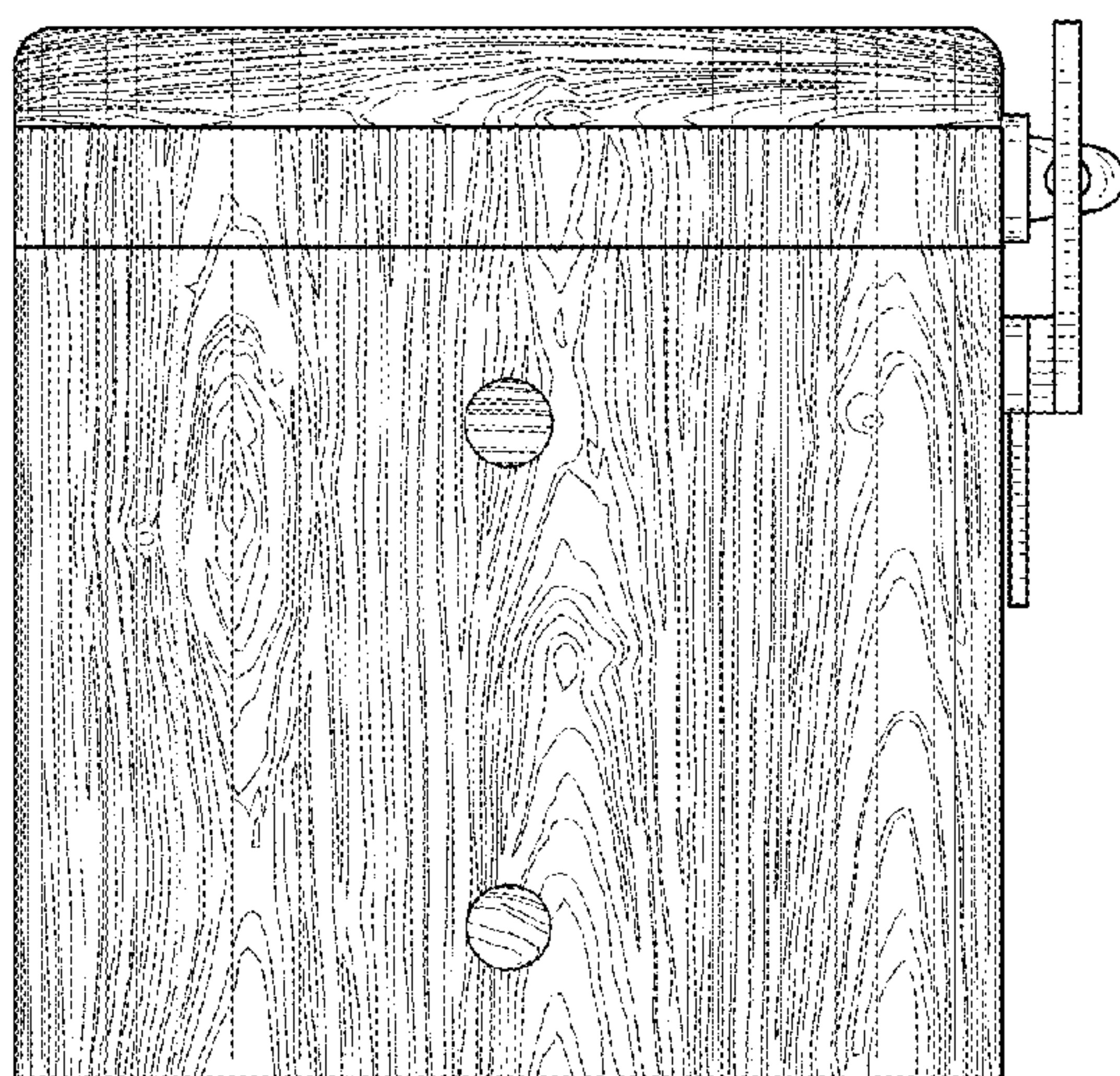

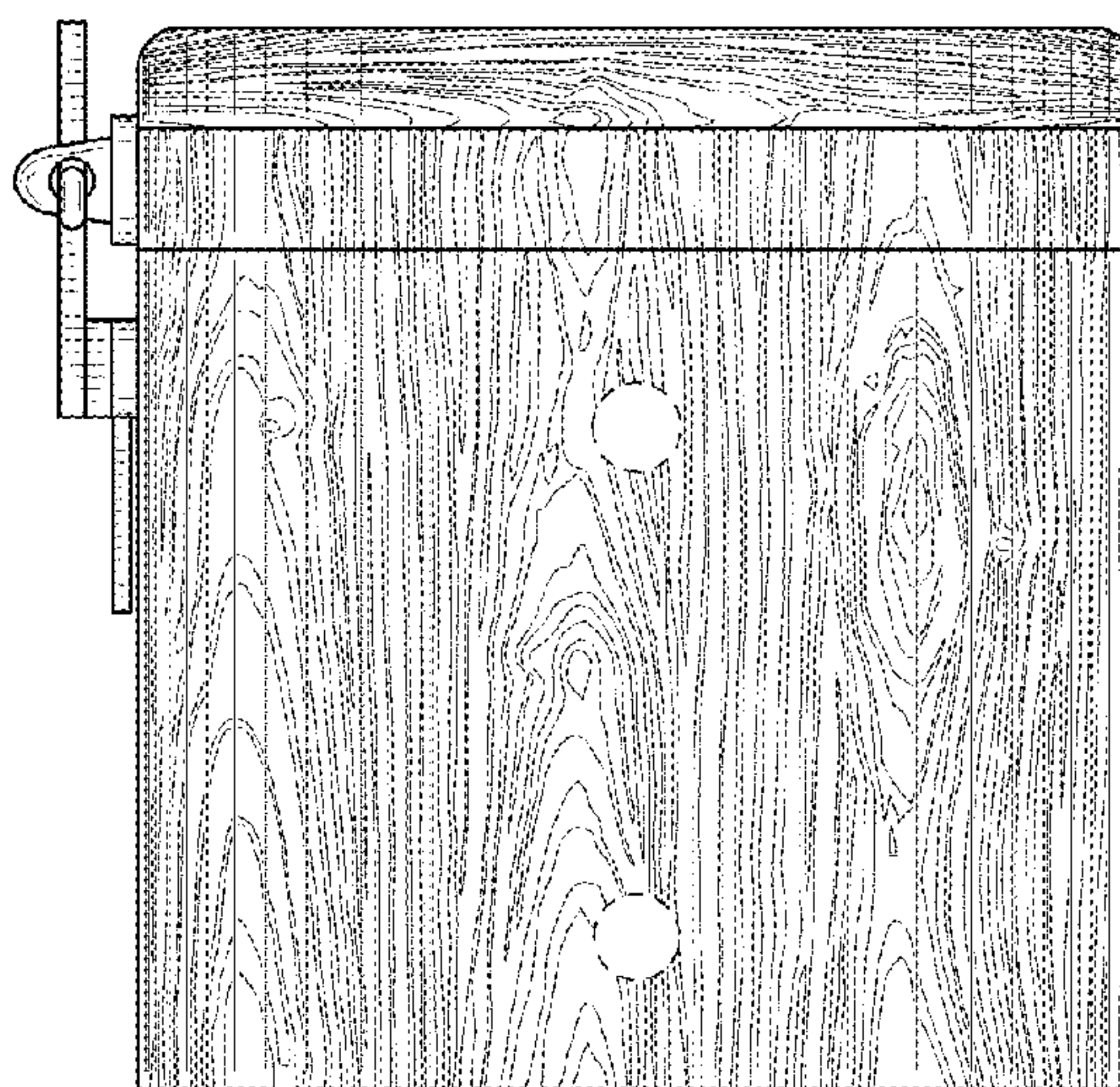

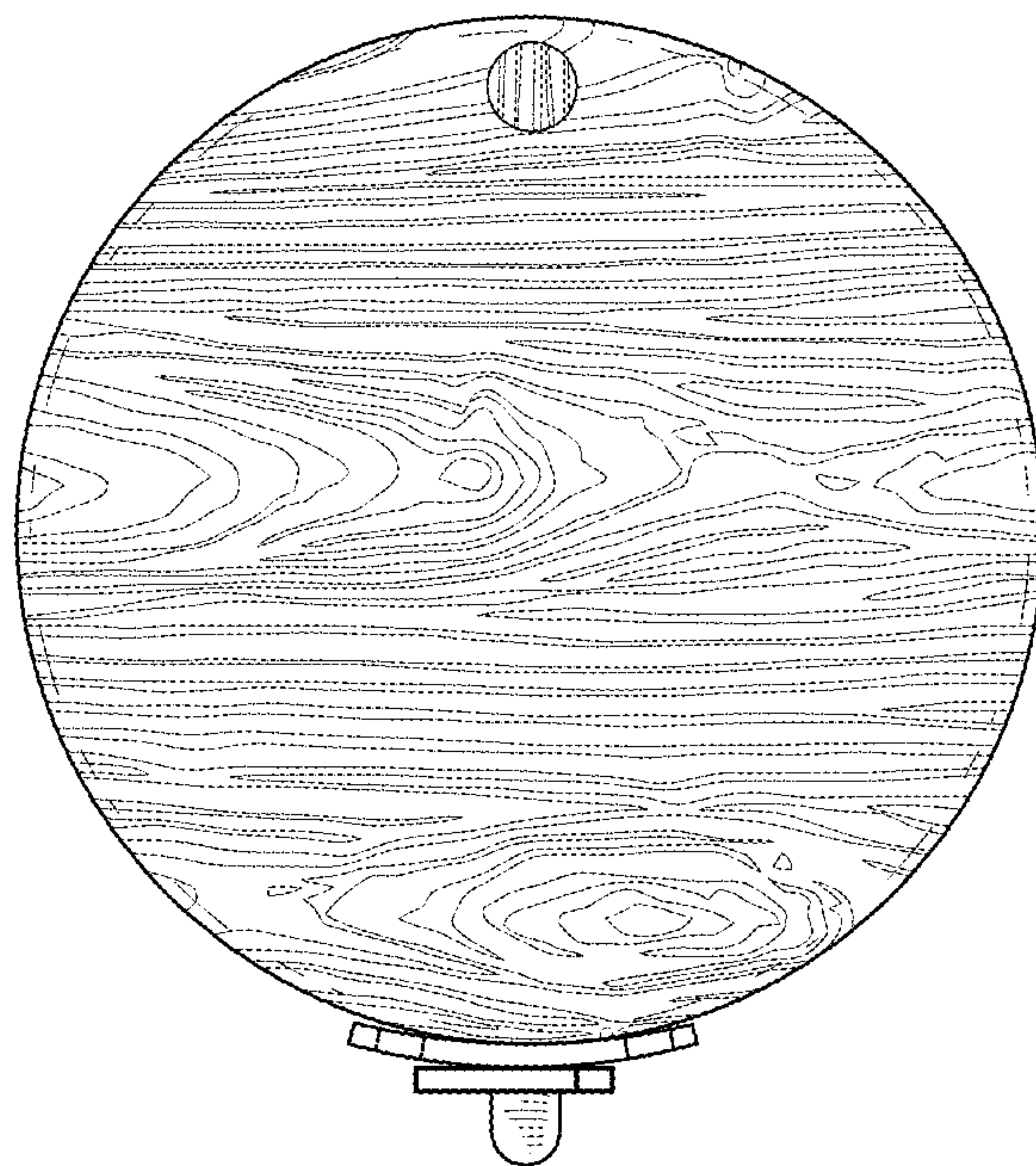

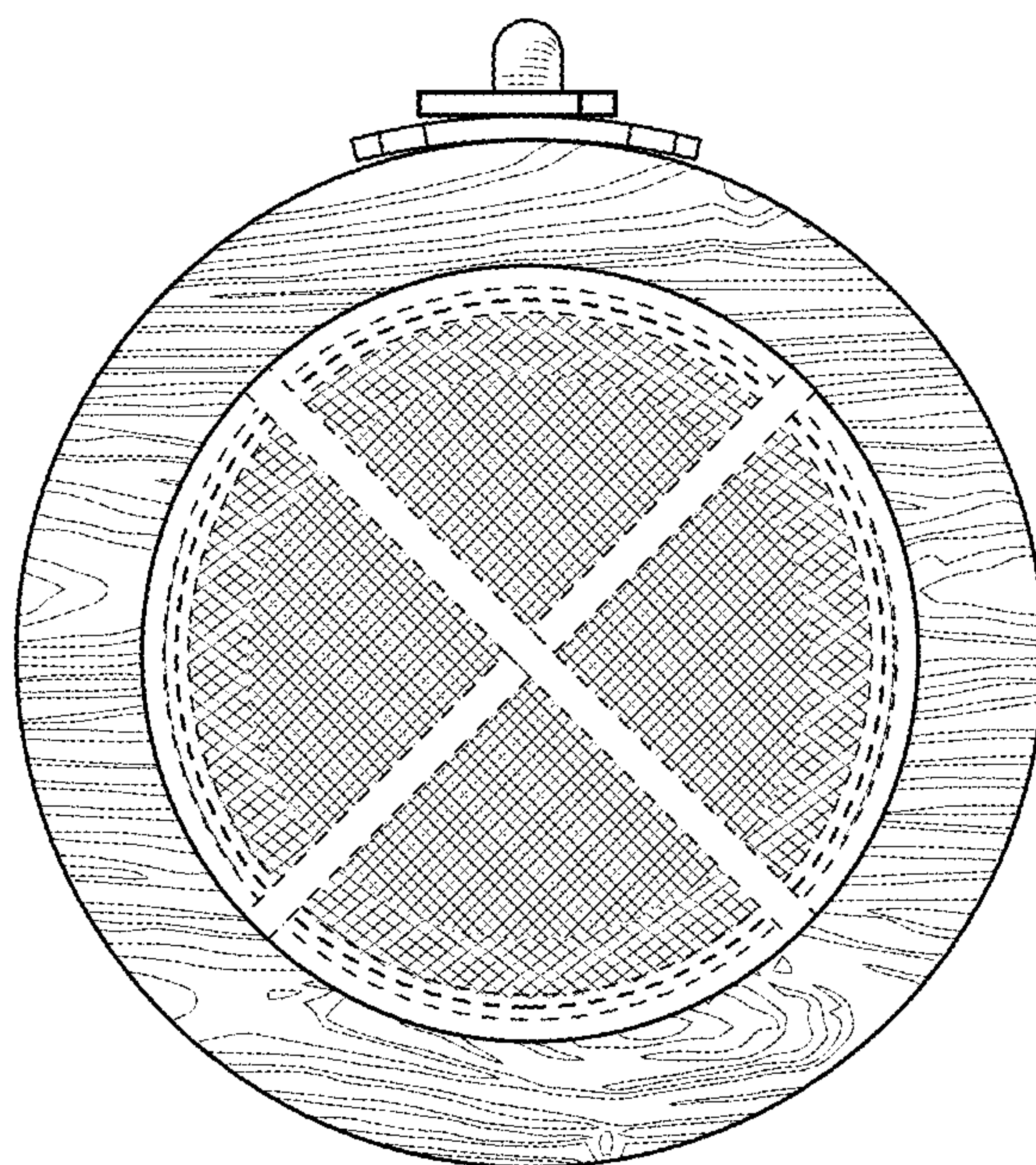
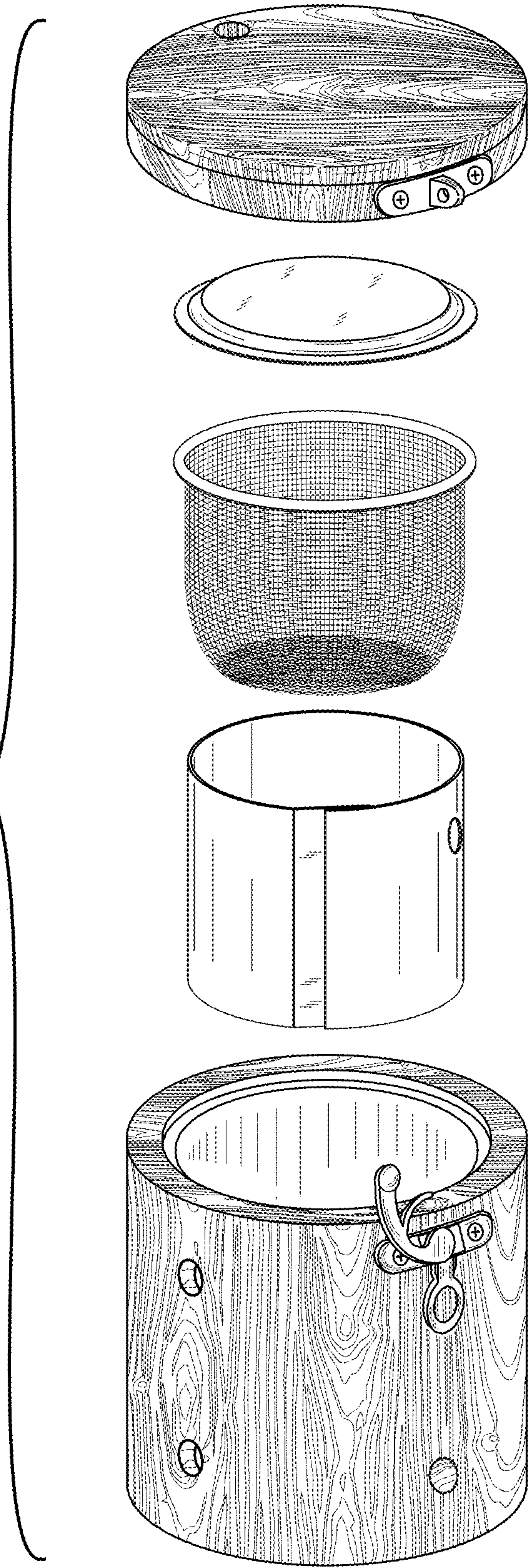

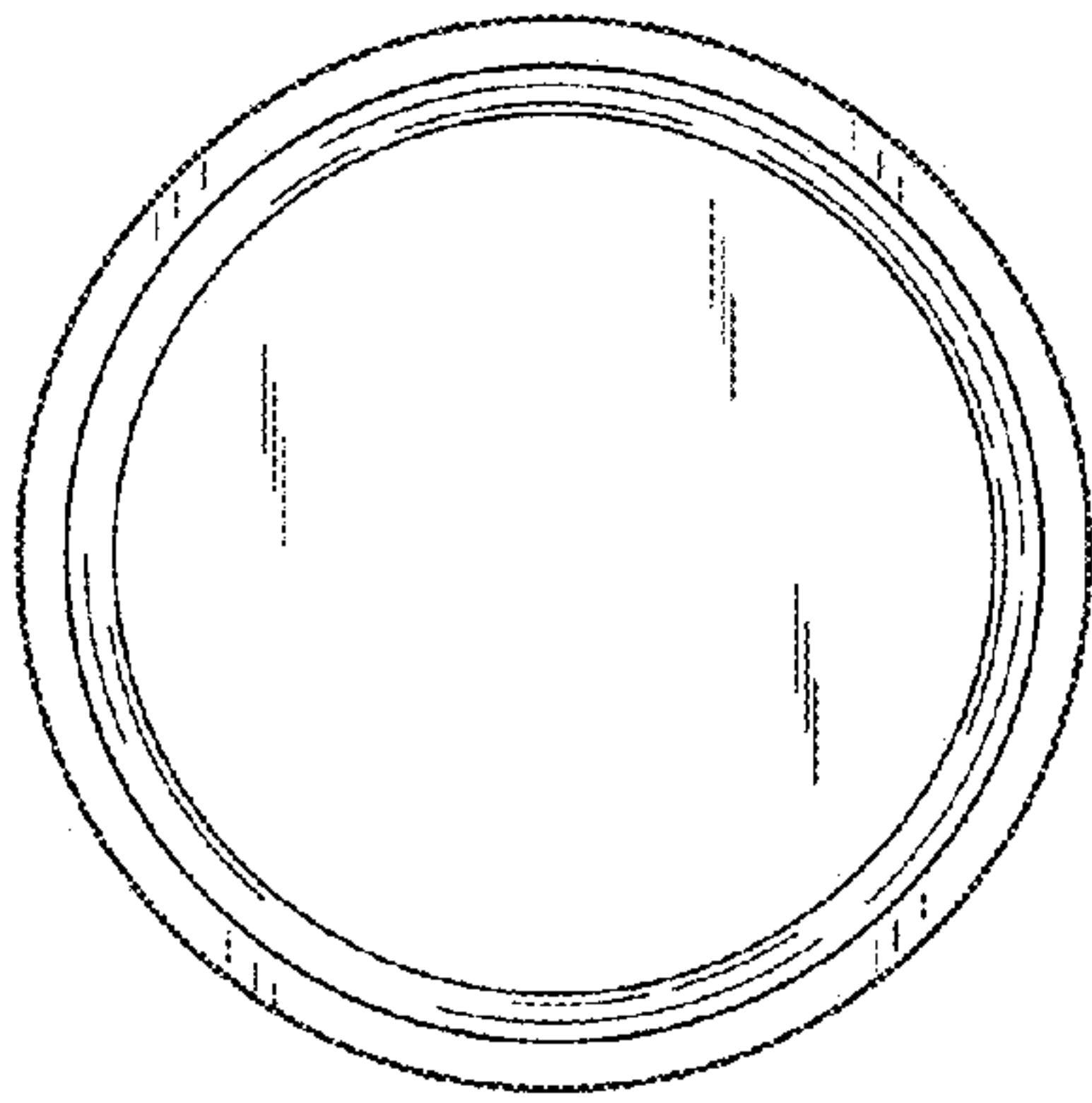

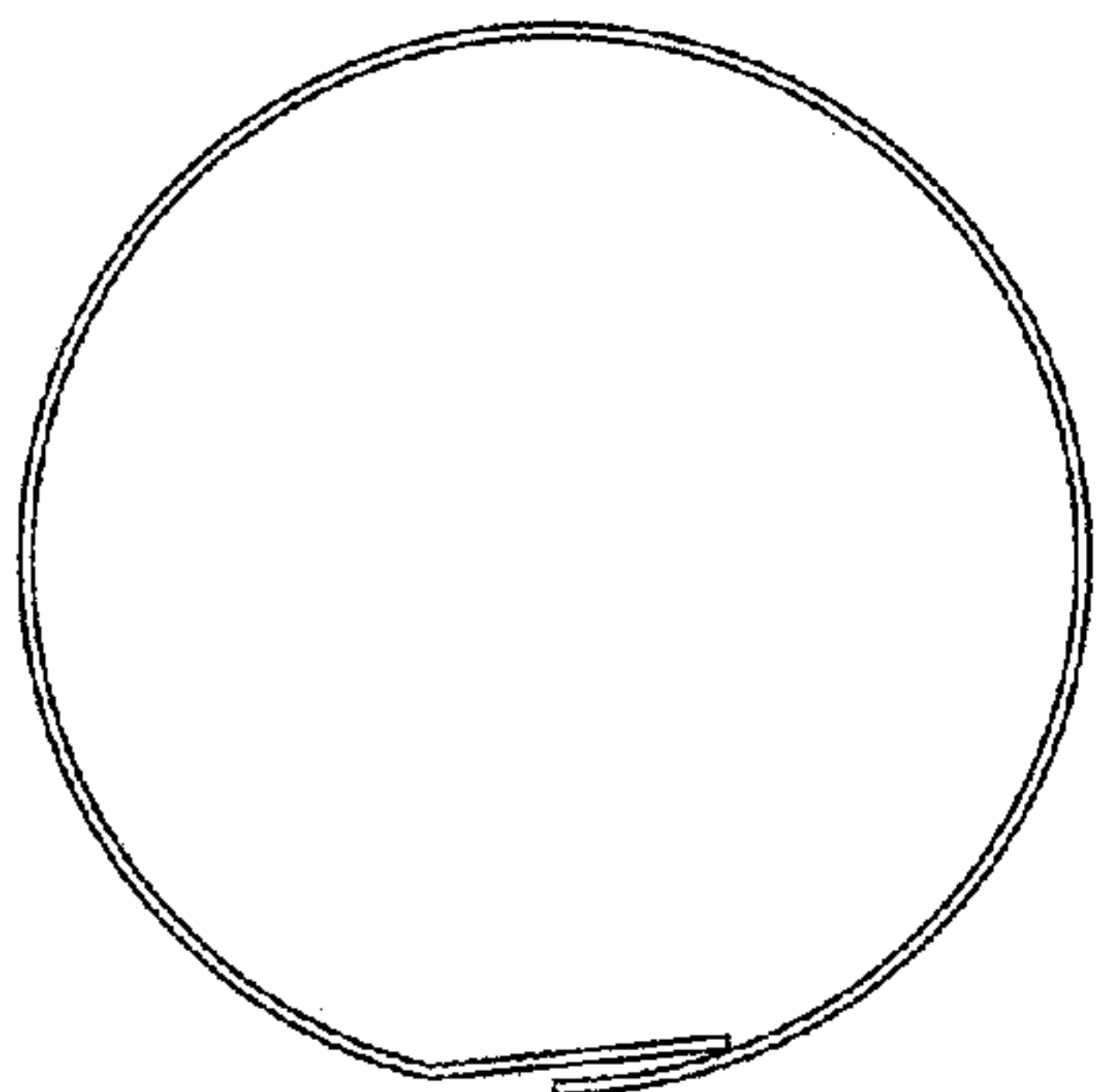

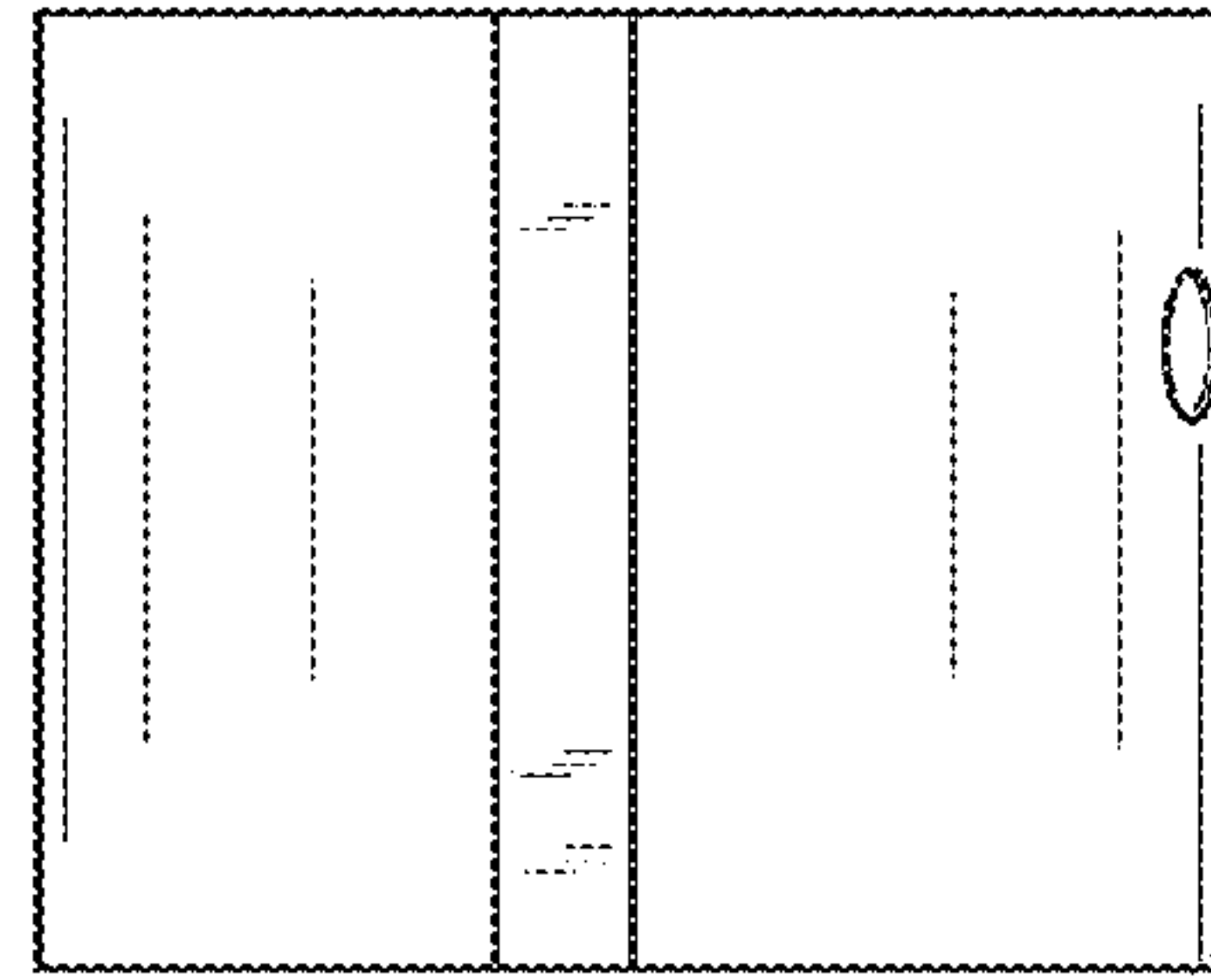

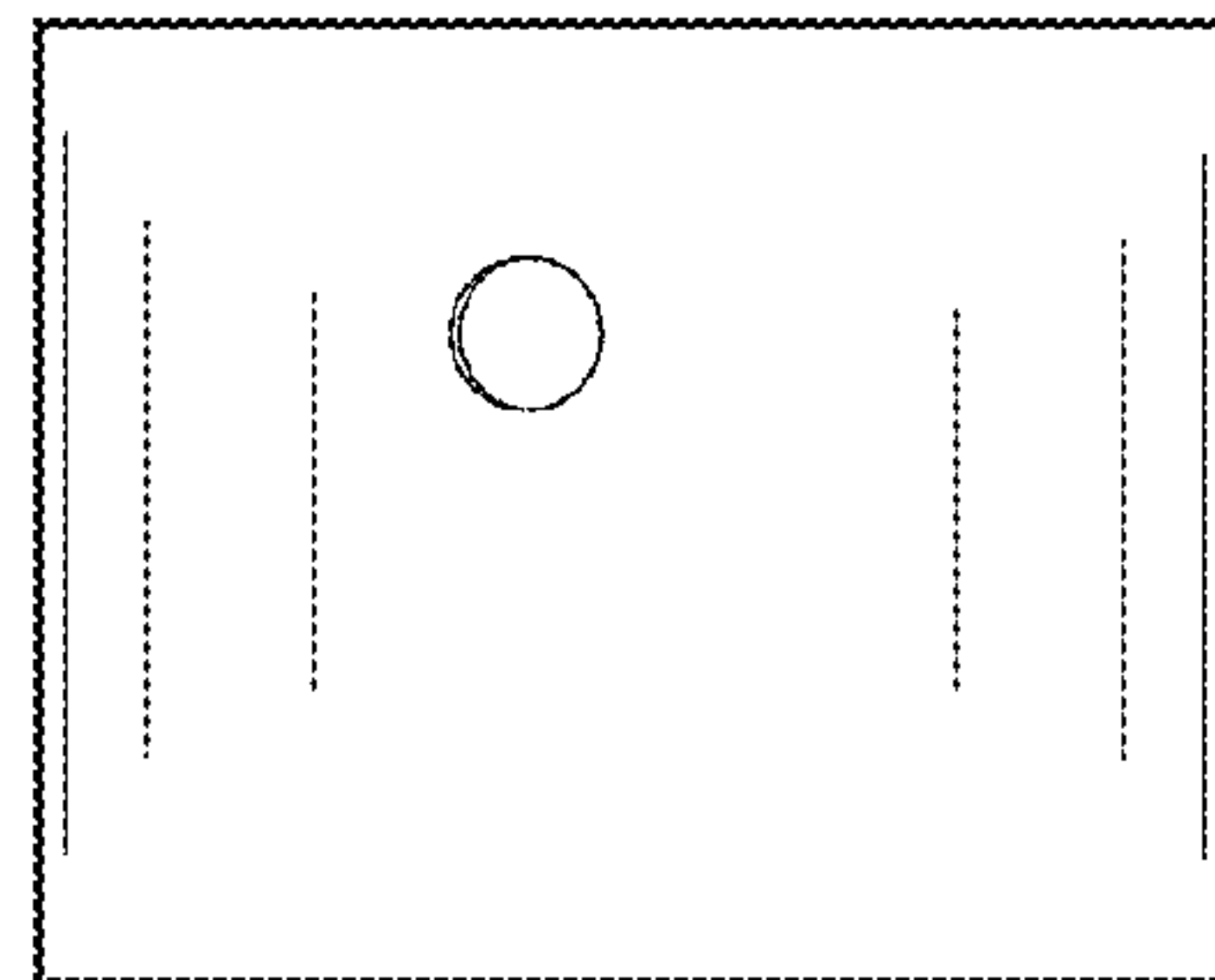

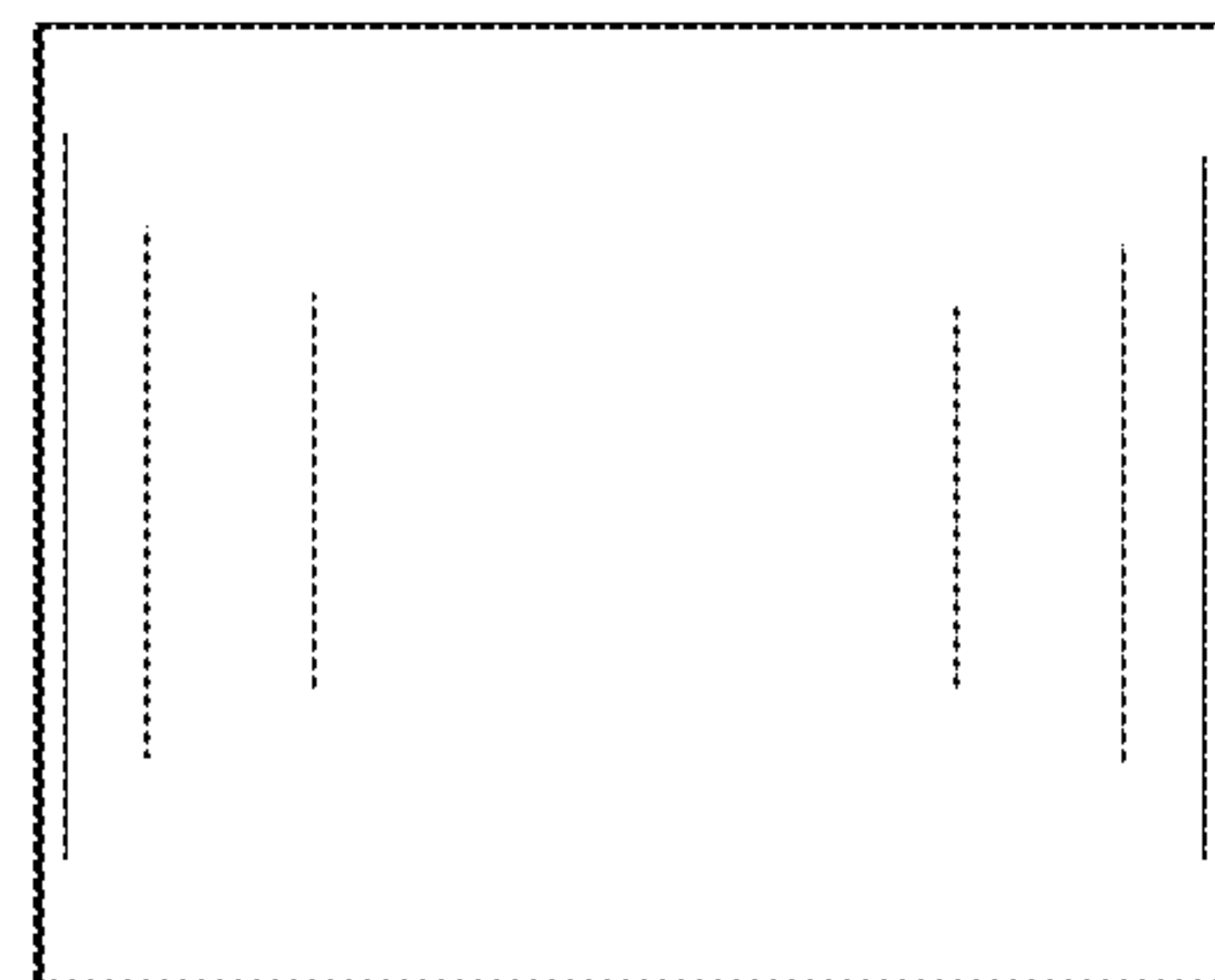

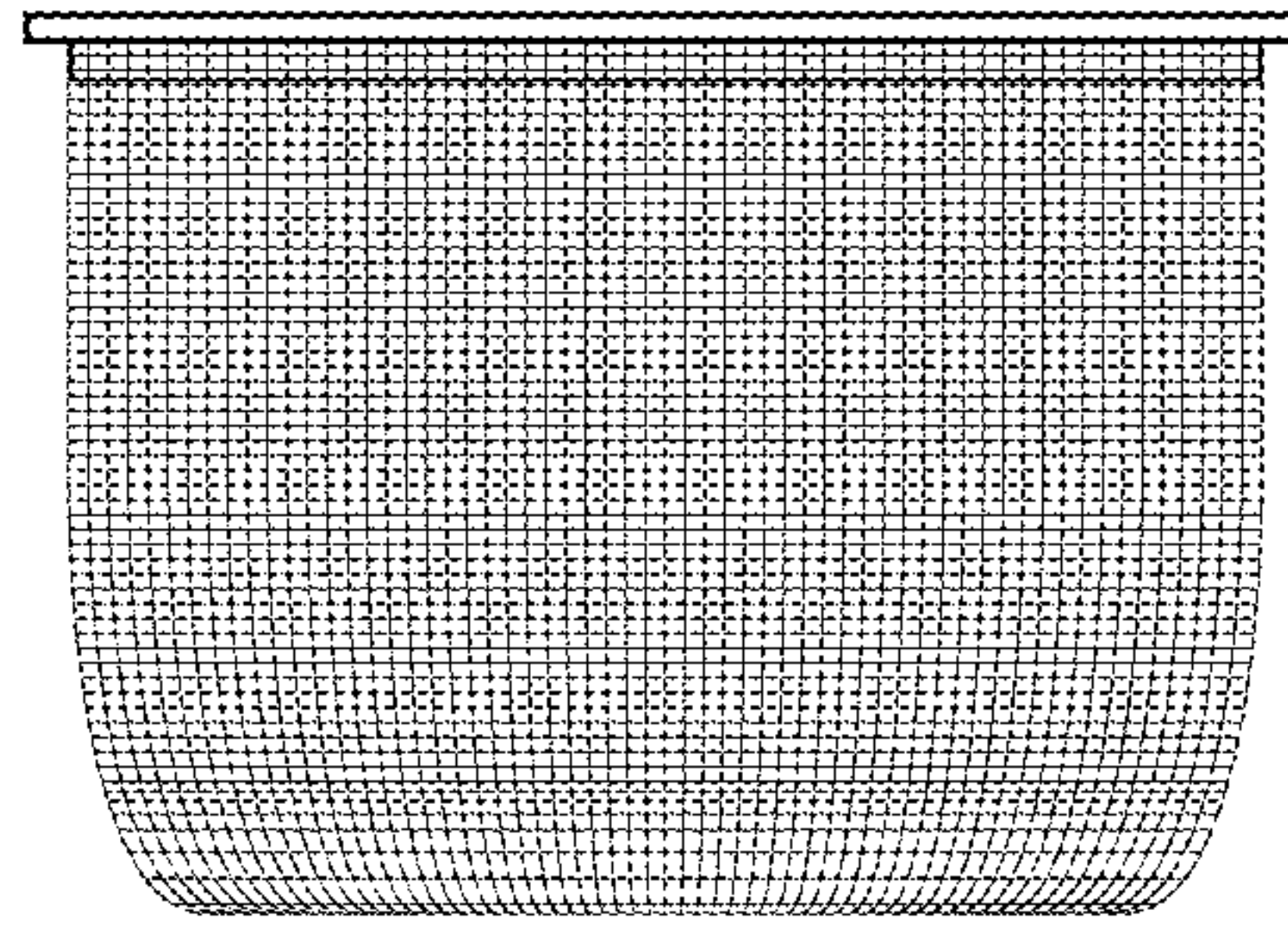

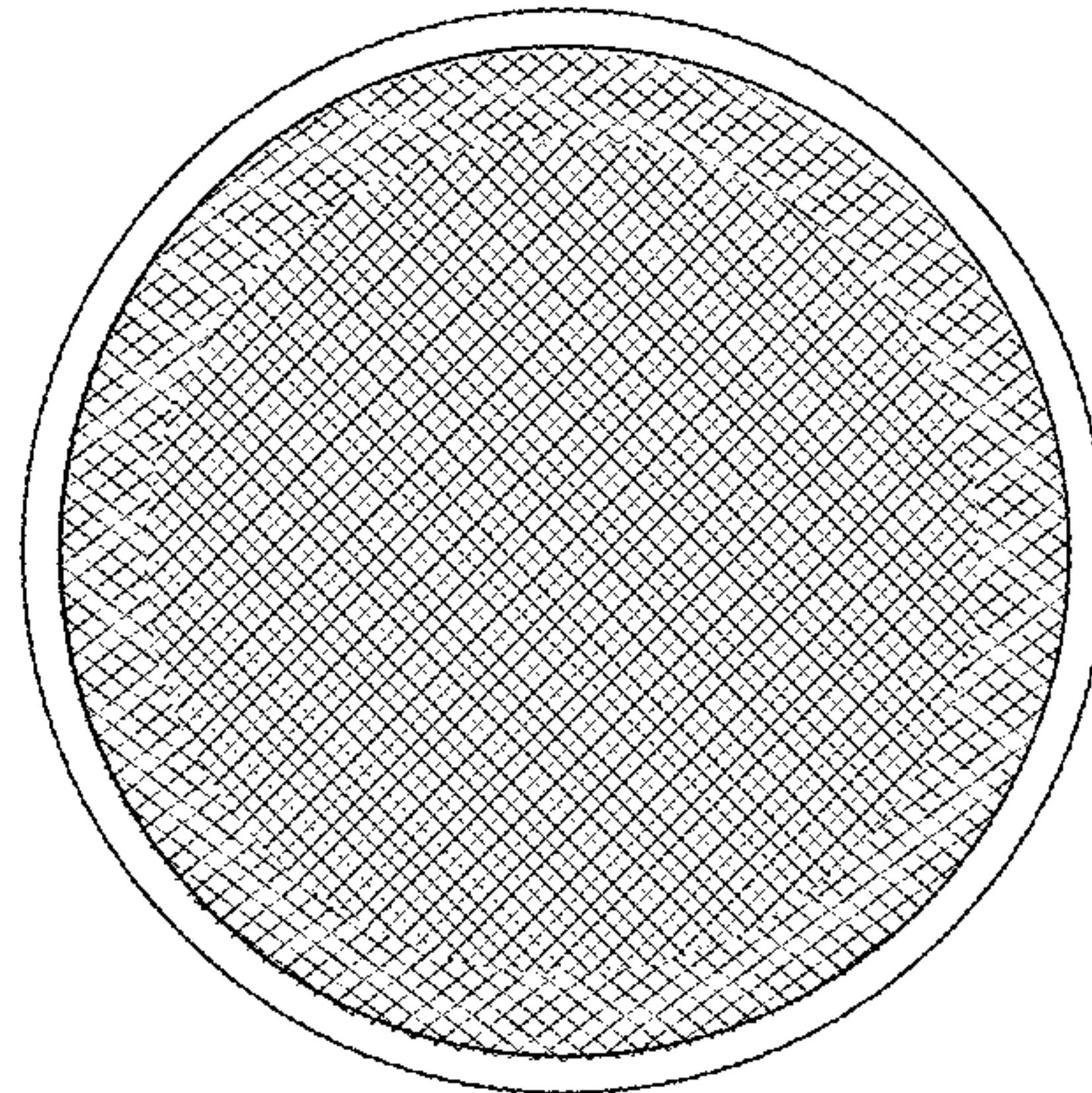

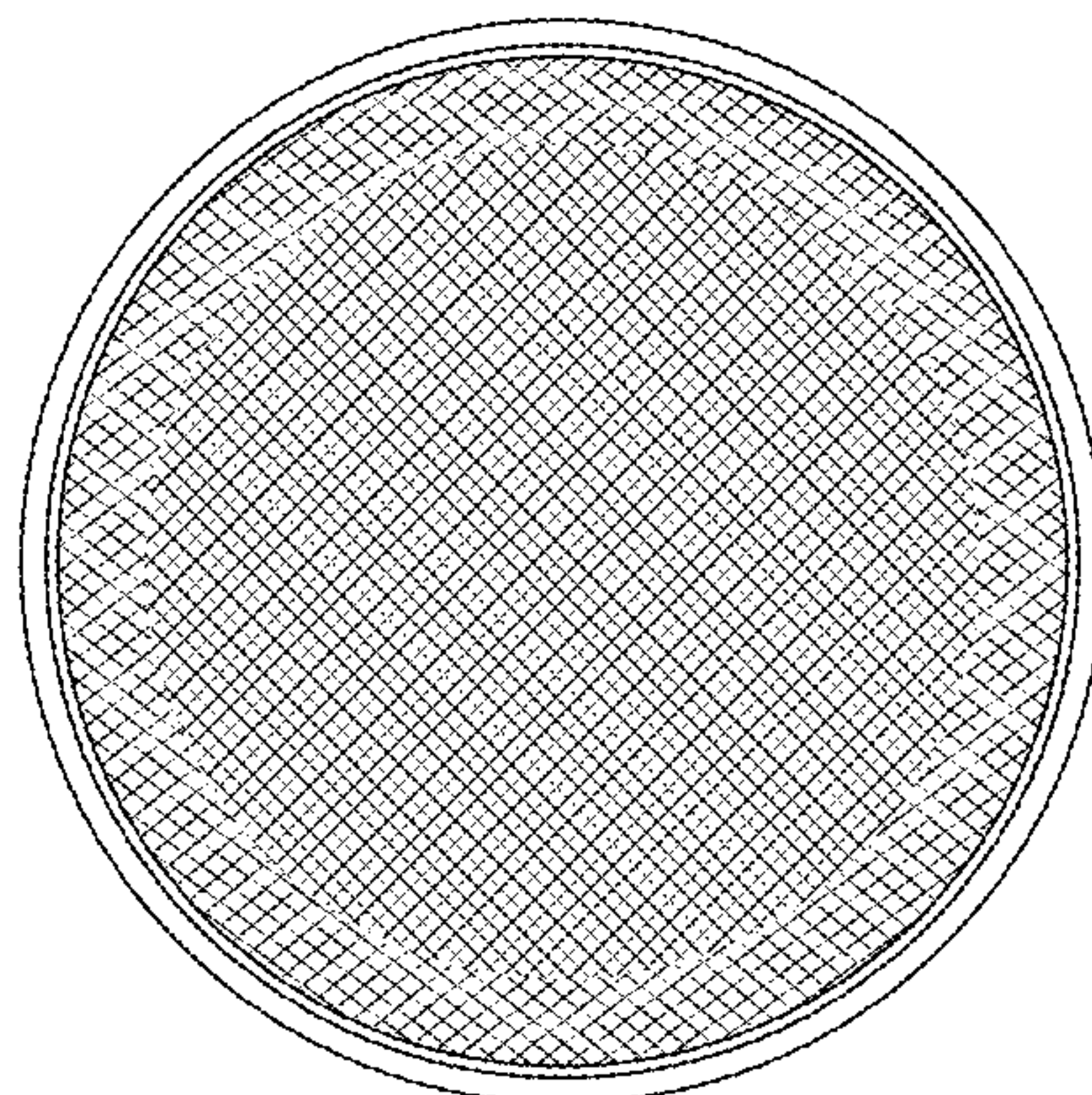
