FIG. 4 is a top plan view thereof.

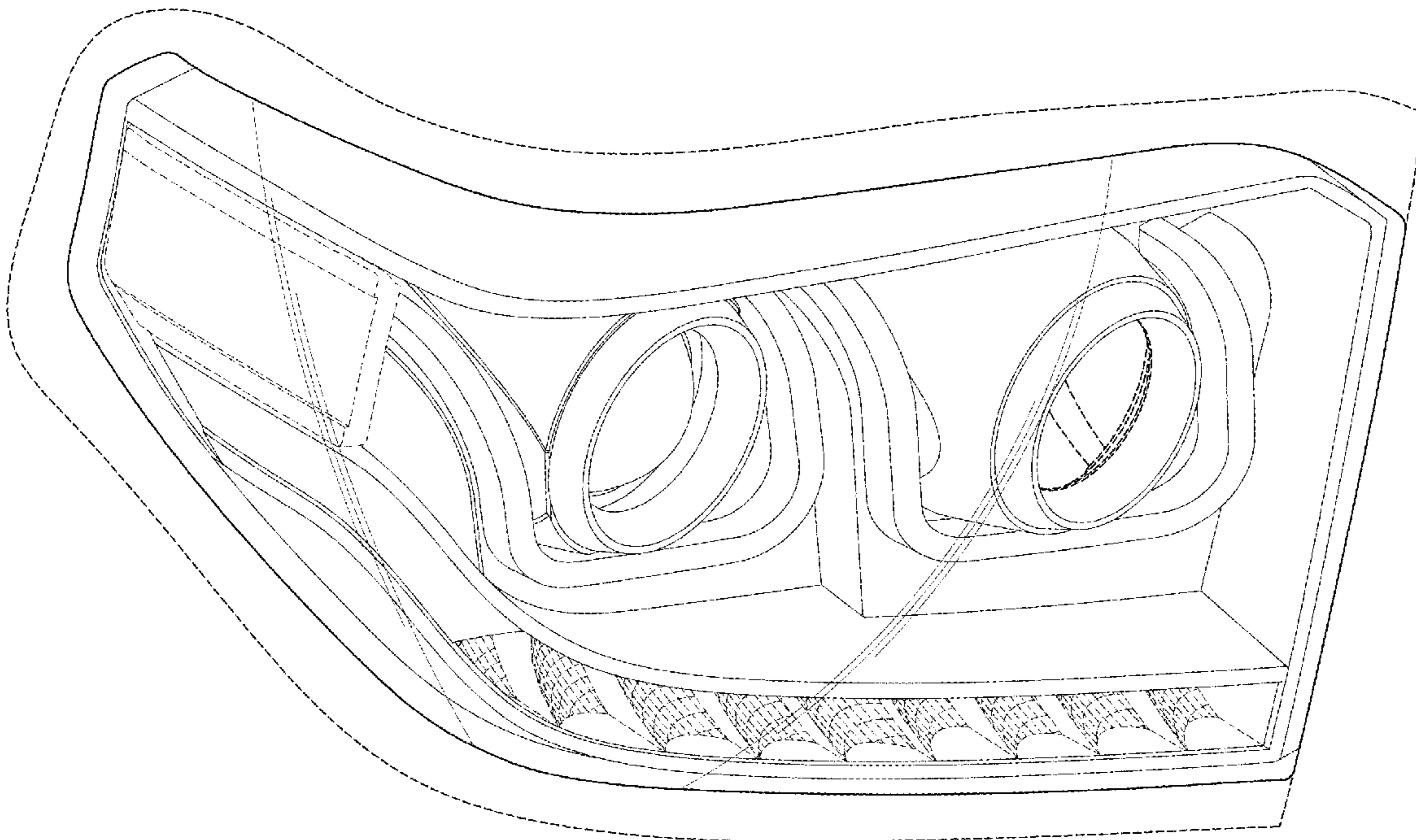
The broken lines in the drawings illustrate portions of the vehicle headlight which form no part of the claimed design.

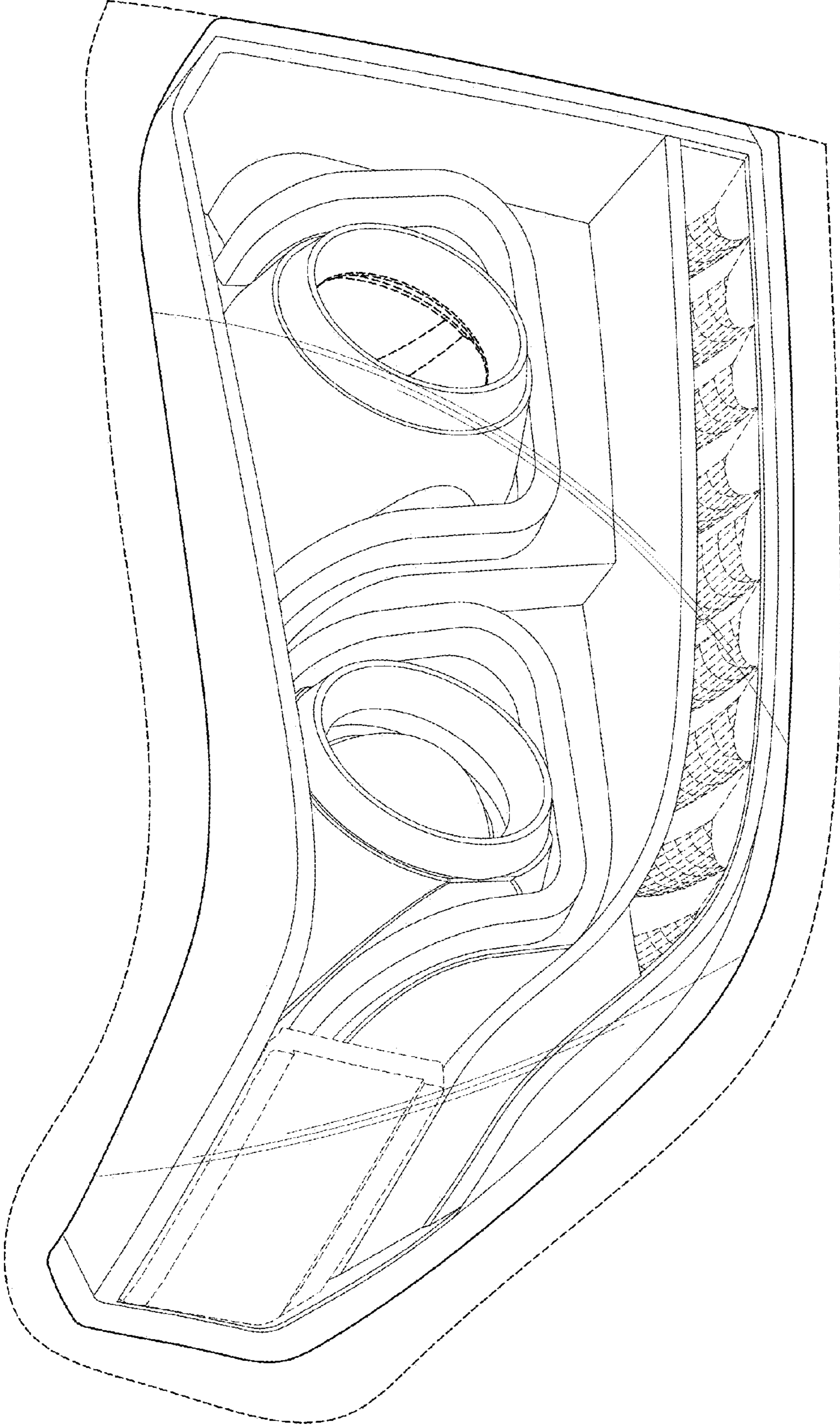

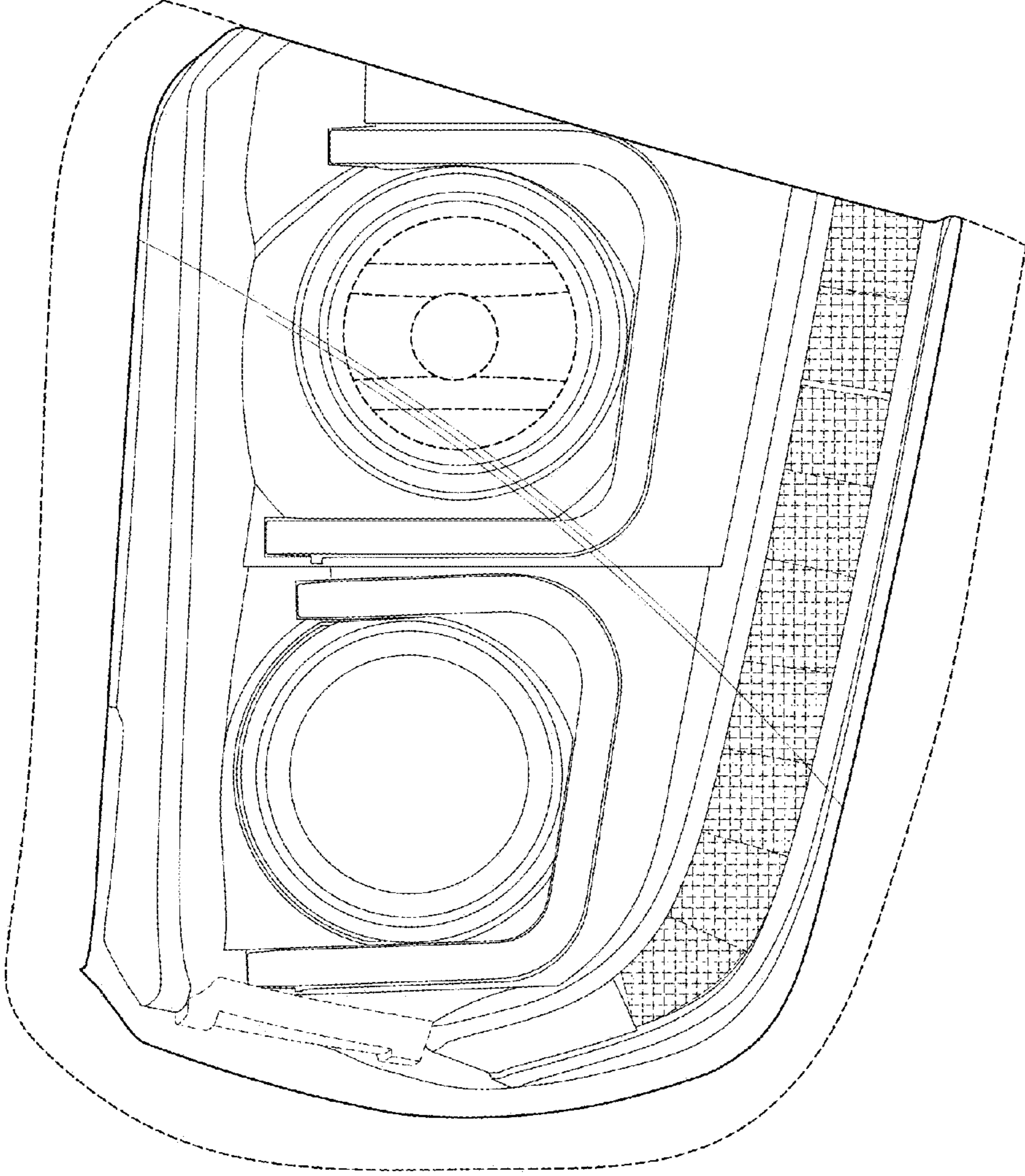

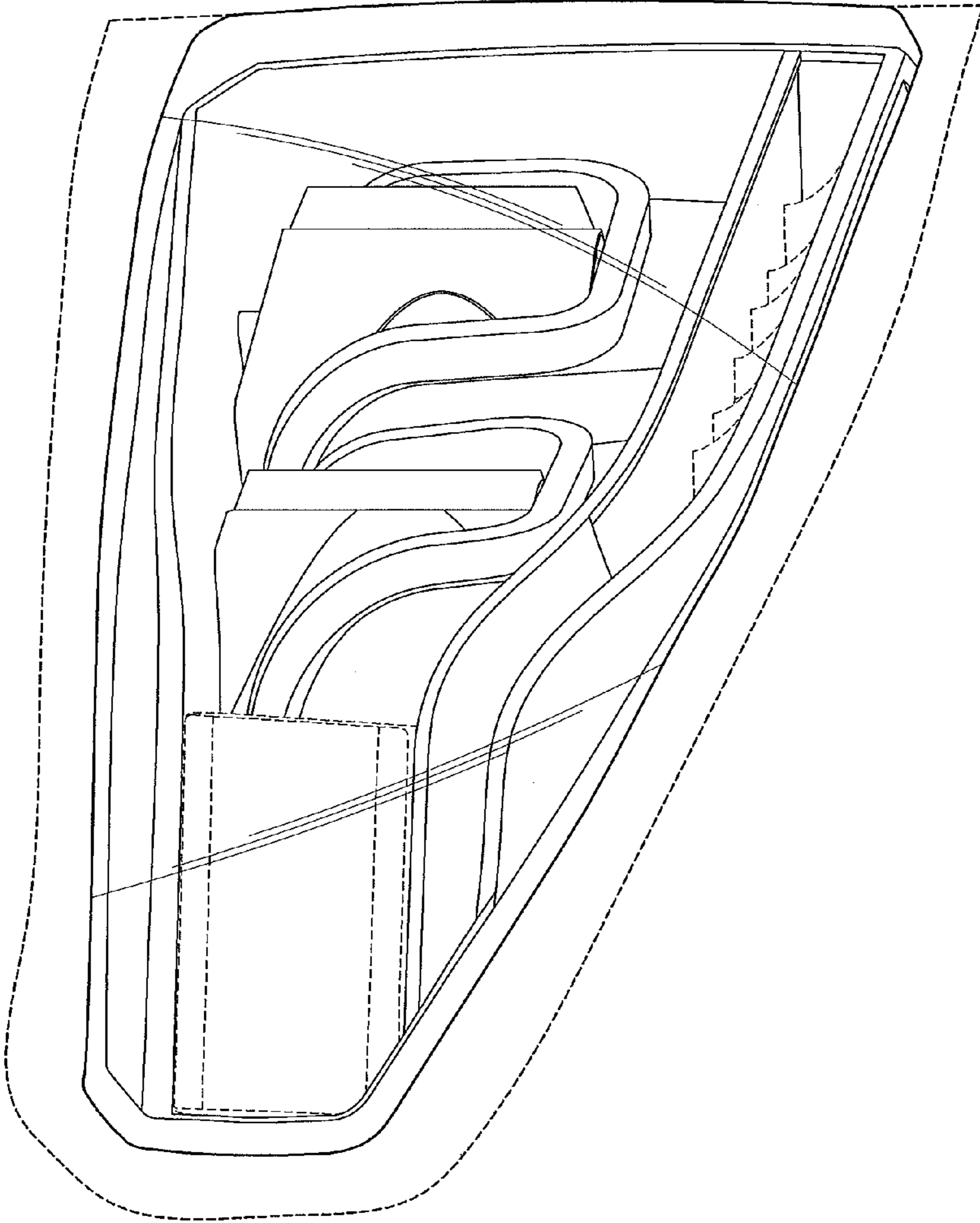

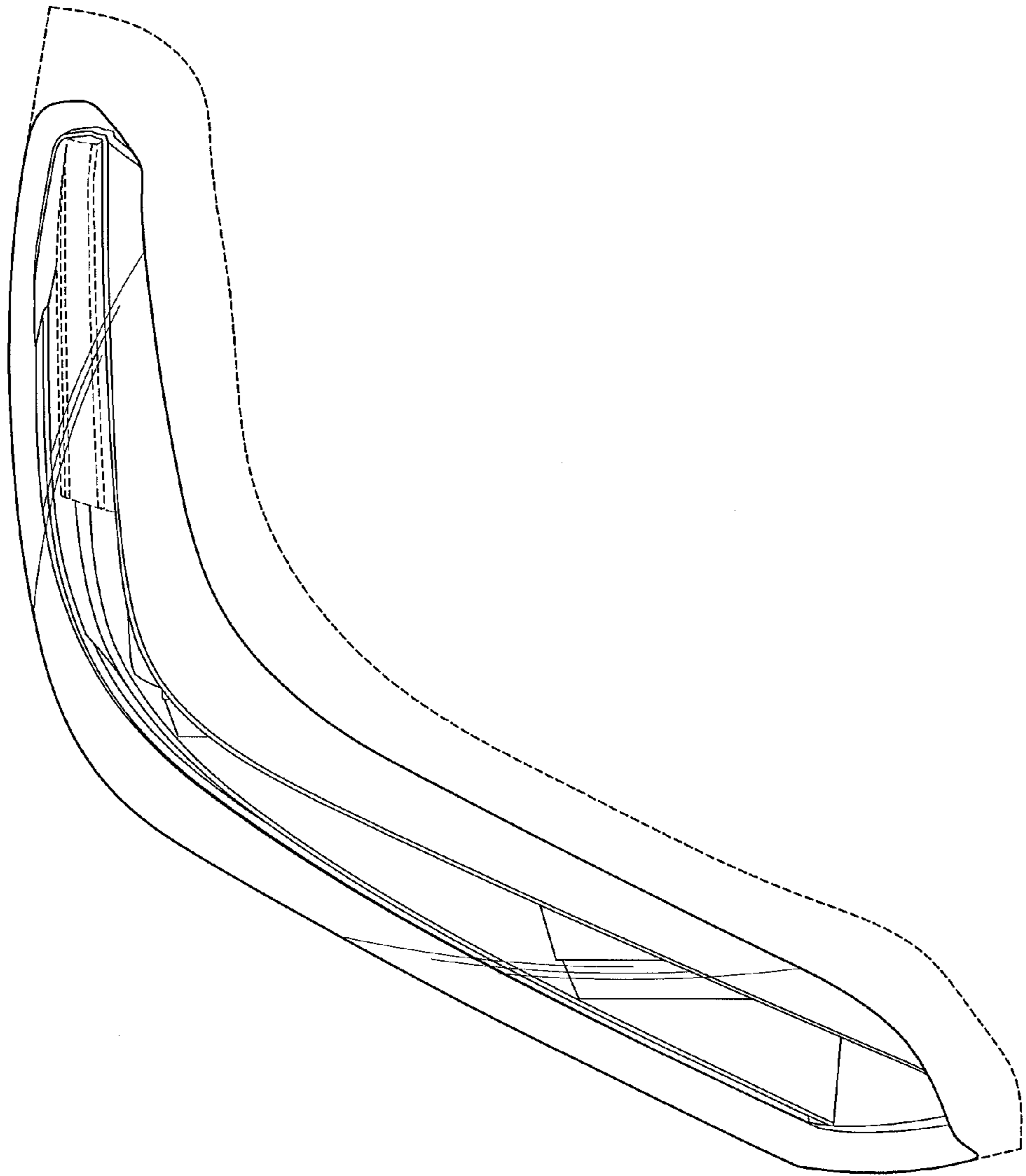
