(57) **CLAIM**

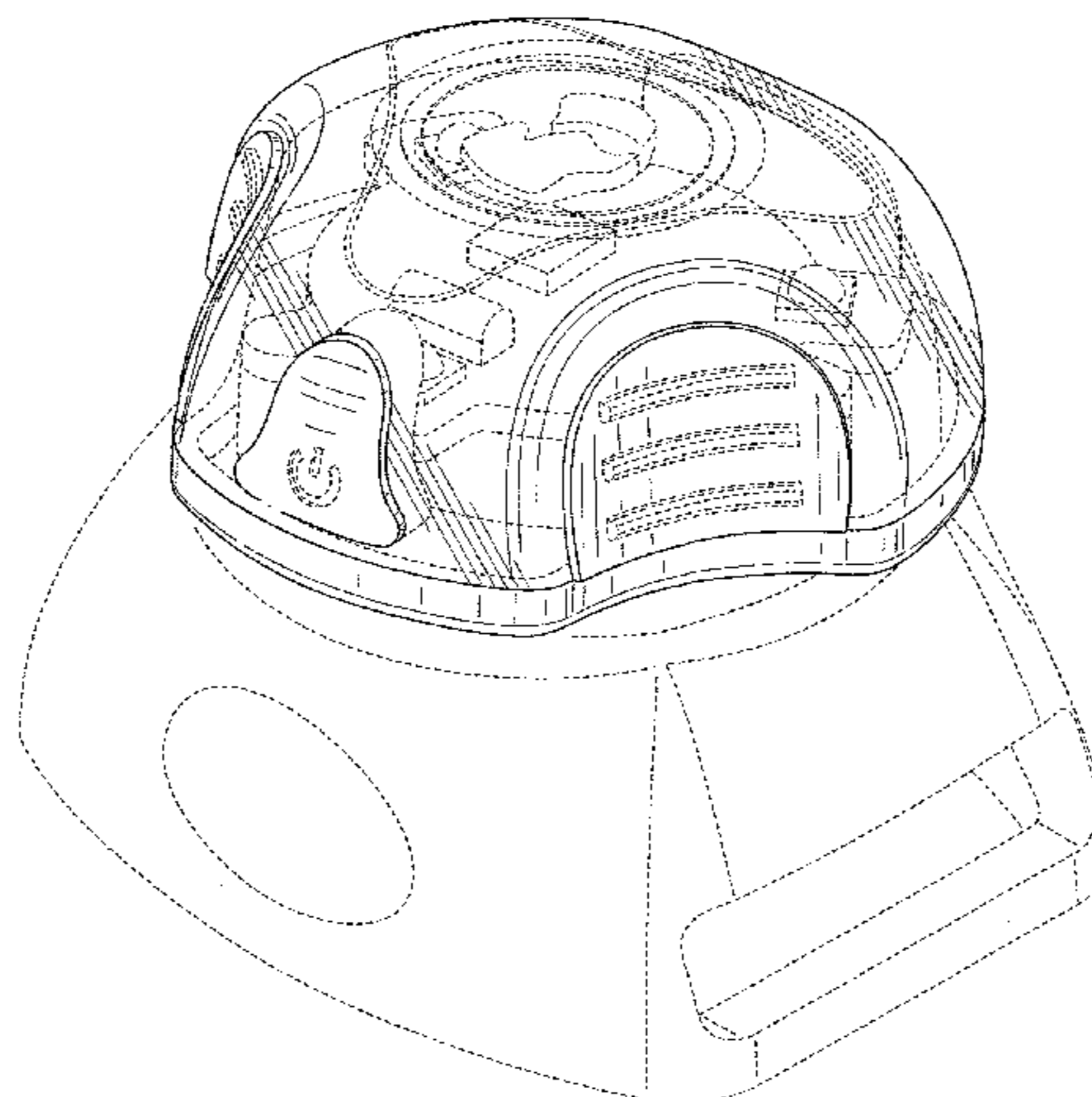
The ornamental design for a light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a light, in accordance with the present invention;
FIG. 2 is a left elevation view of the portion of the light of FIG. 1;
FIG. 3 is a right elevation view of the portion of the light of FIG. 1;
FIG. 4 is a rear elevation view of the portion of the light of FIG. 1;
FIG. 5 is a front elevation view of the portion of the light of FIG. 1;
FIG. 6 is a top plan view of the portion of the light of FIG. 1; and,
FIG. 7 is a bottom plan view of the portion of the light of FIG. 1.

The broken line showing represents portions of the article not claimed and forms no part of the claimed design. For example, unshaded areas encompassed by broken lines are not part of the claimed design. As another example, in some drawings dashed lines are used in association with transparent and/or translucent surfaces to indicate that any features that may be seen through the transparent and/or translucent surfaces are not part of the claimed design, wherein oblique line shading is used to show transparent and/or translucent surfaces.

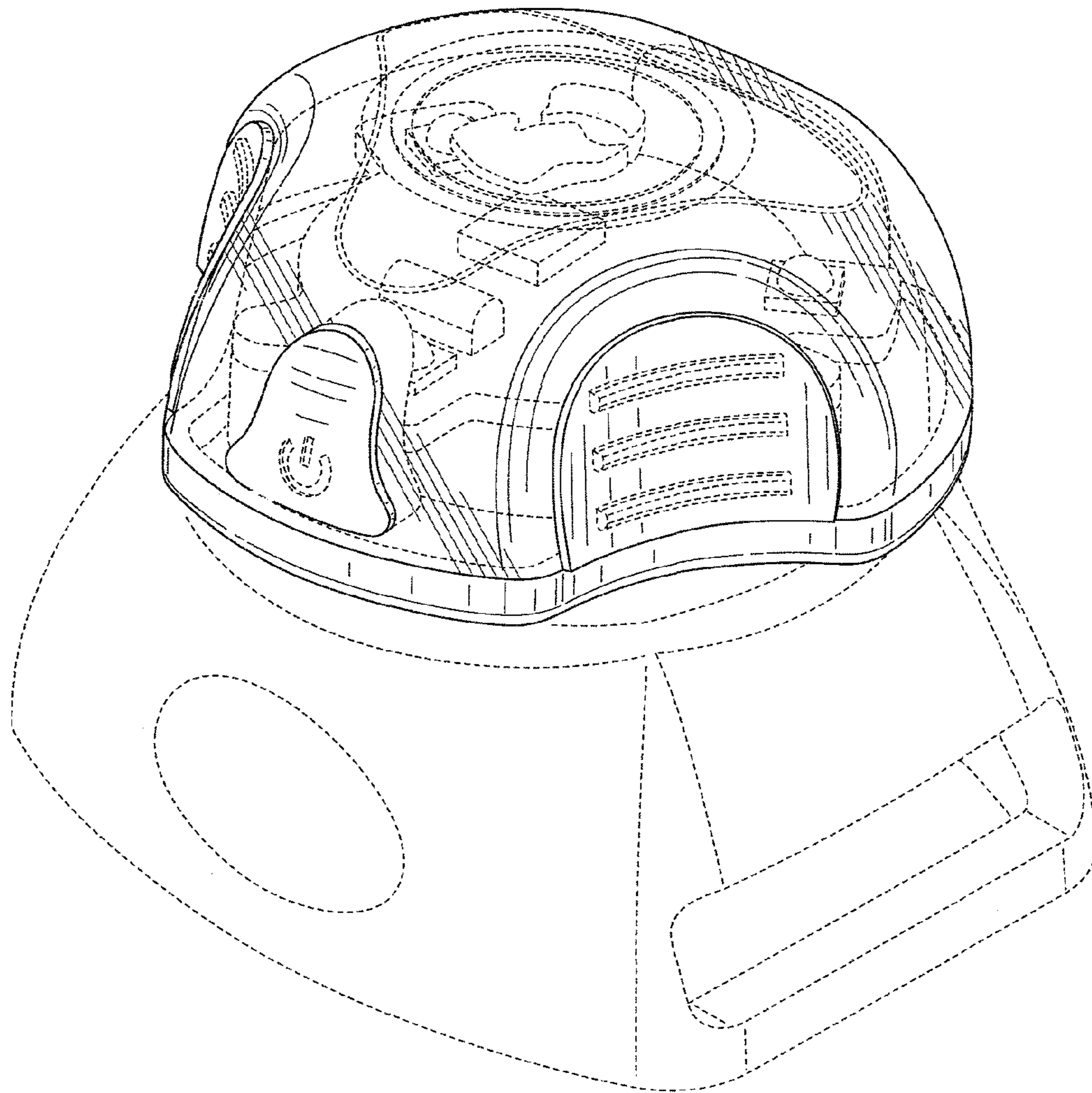

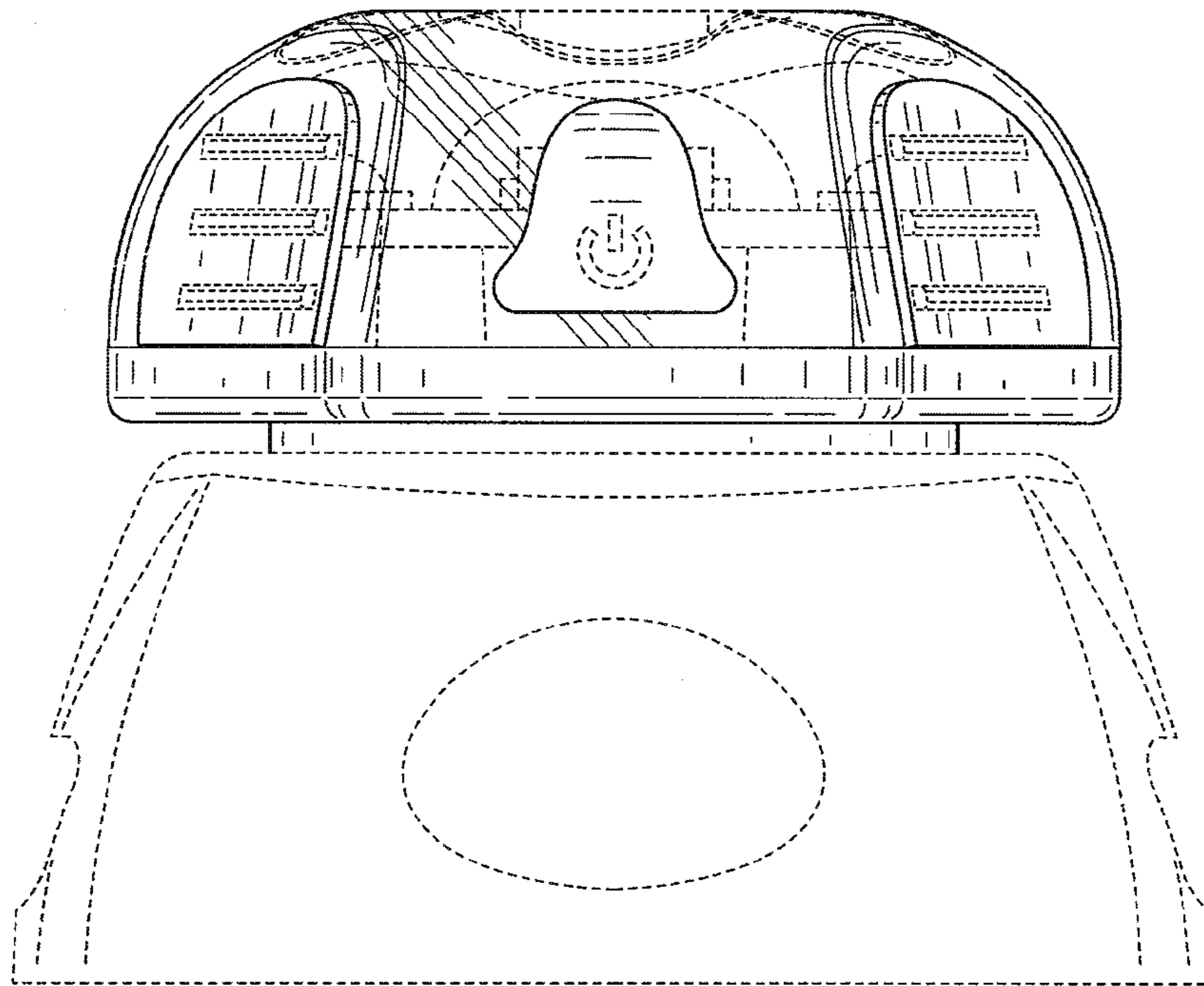

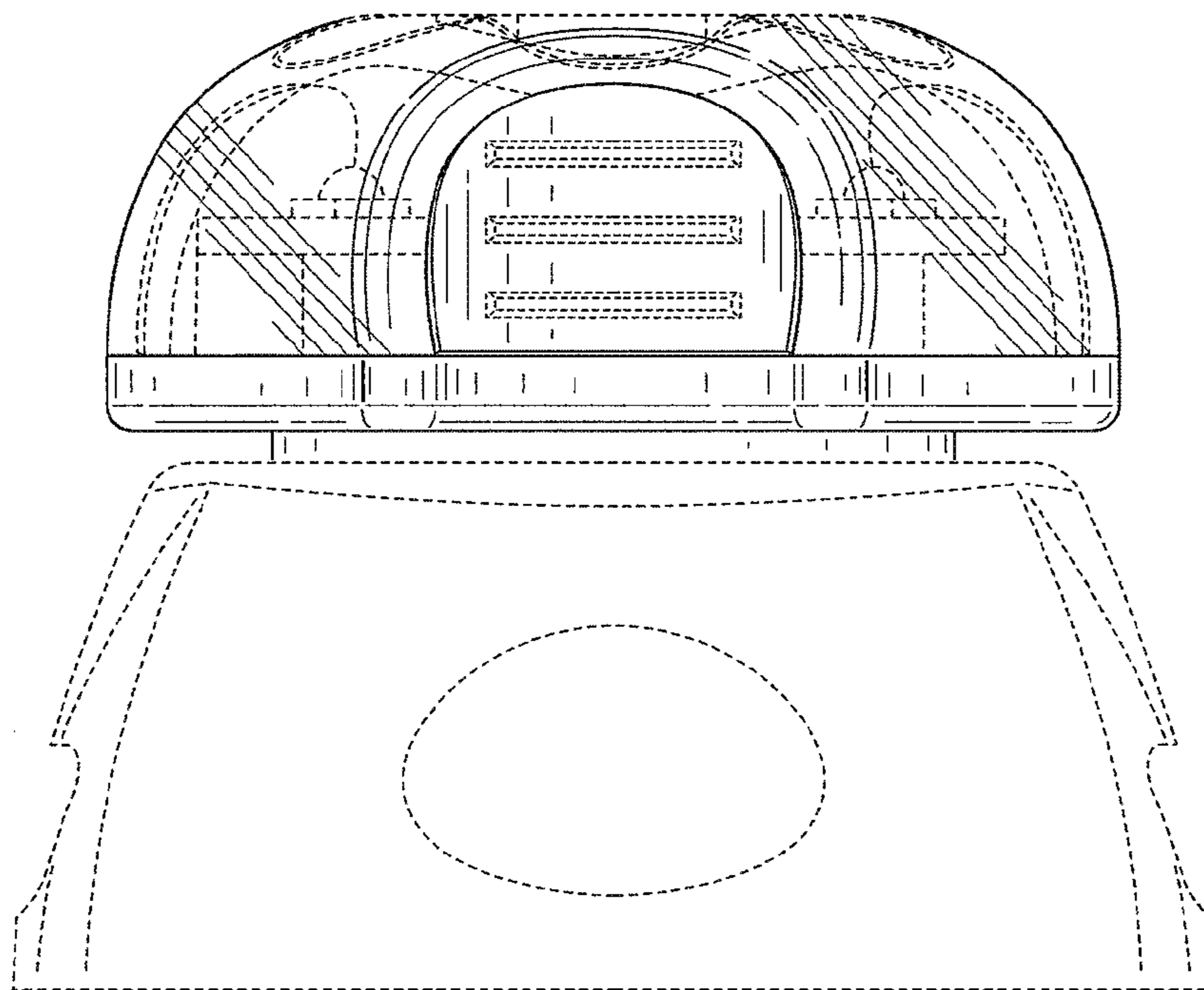

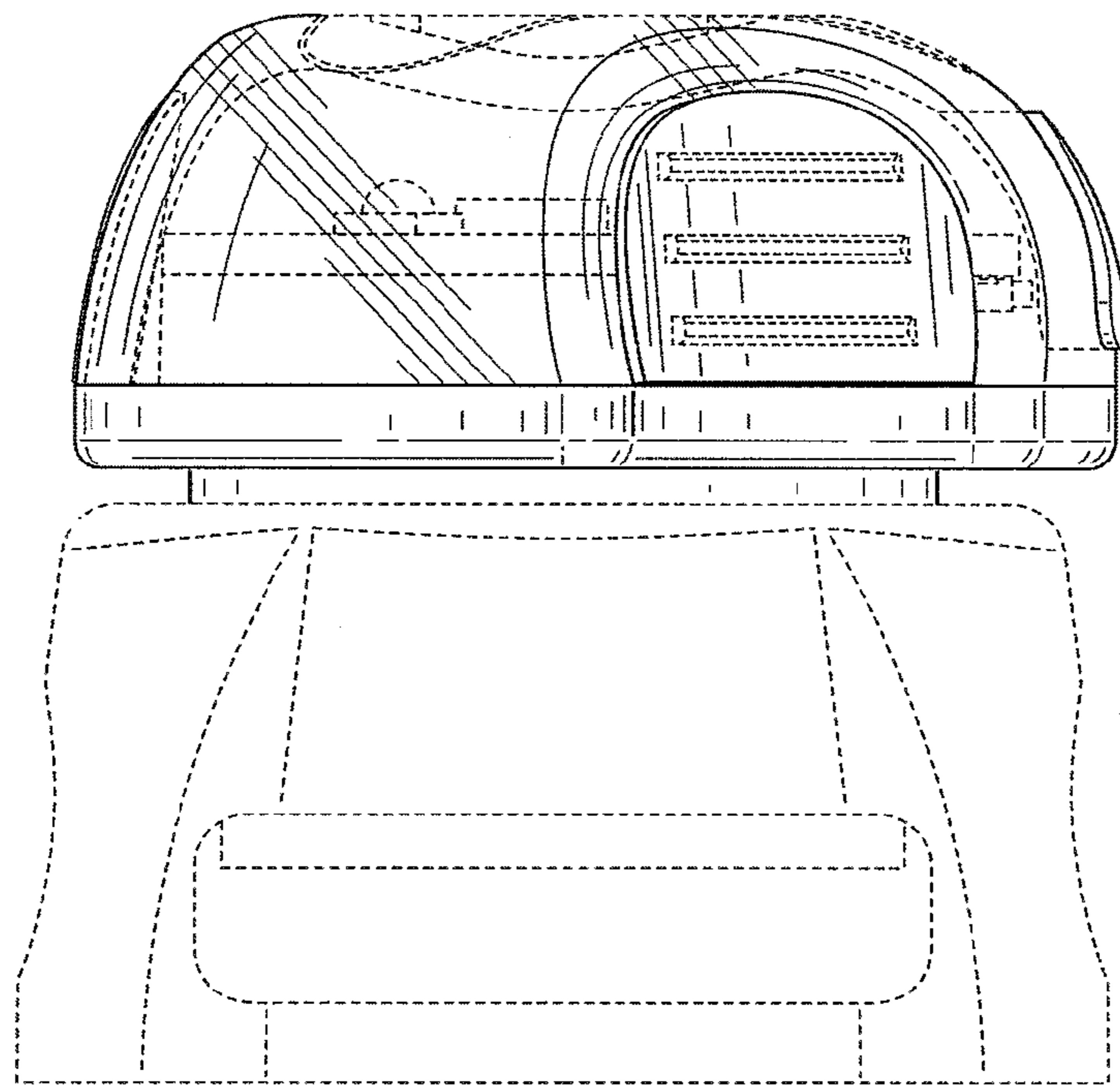

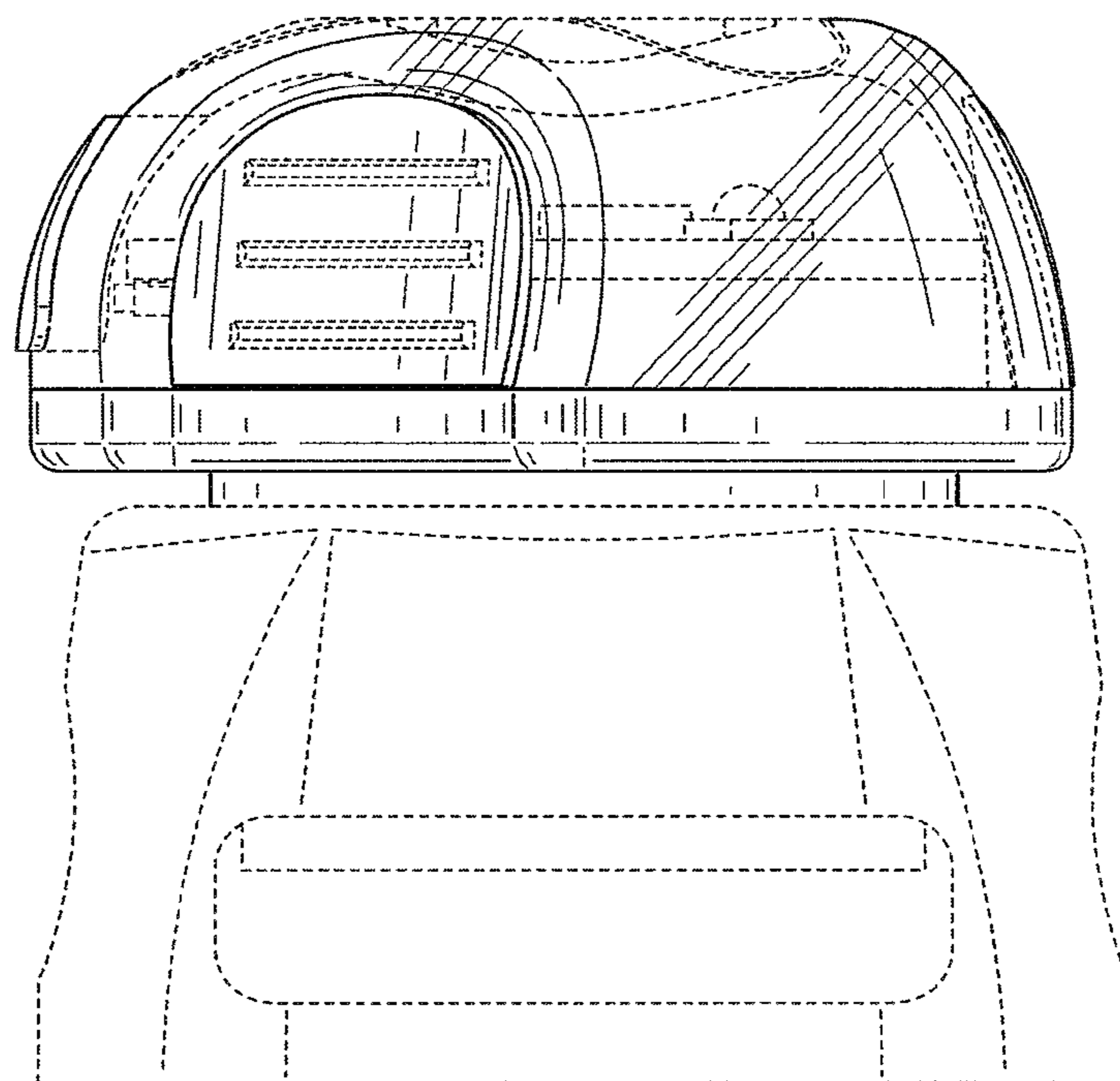

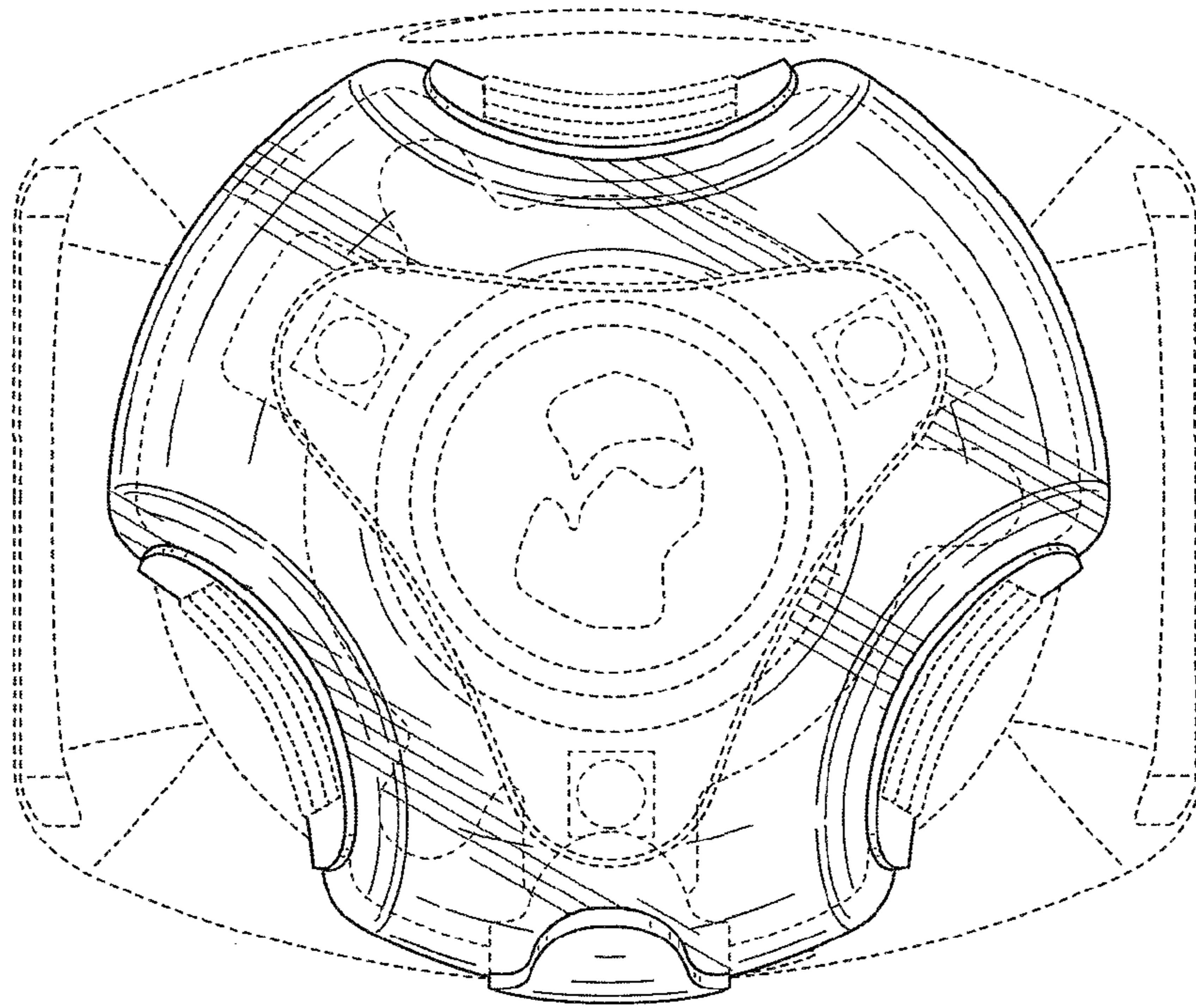

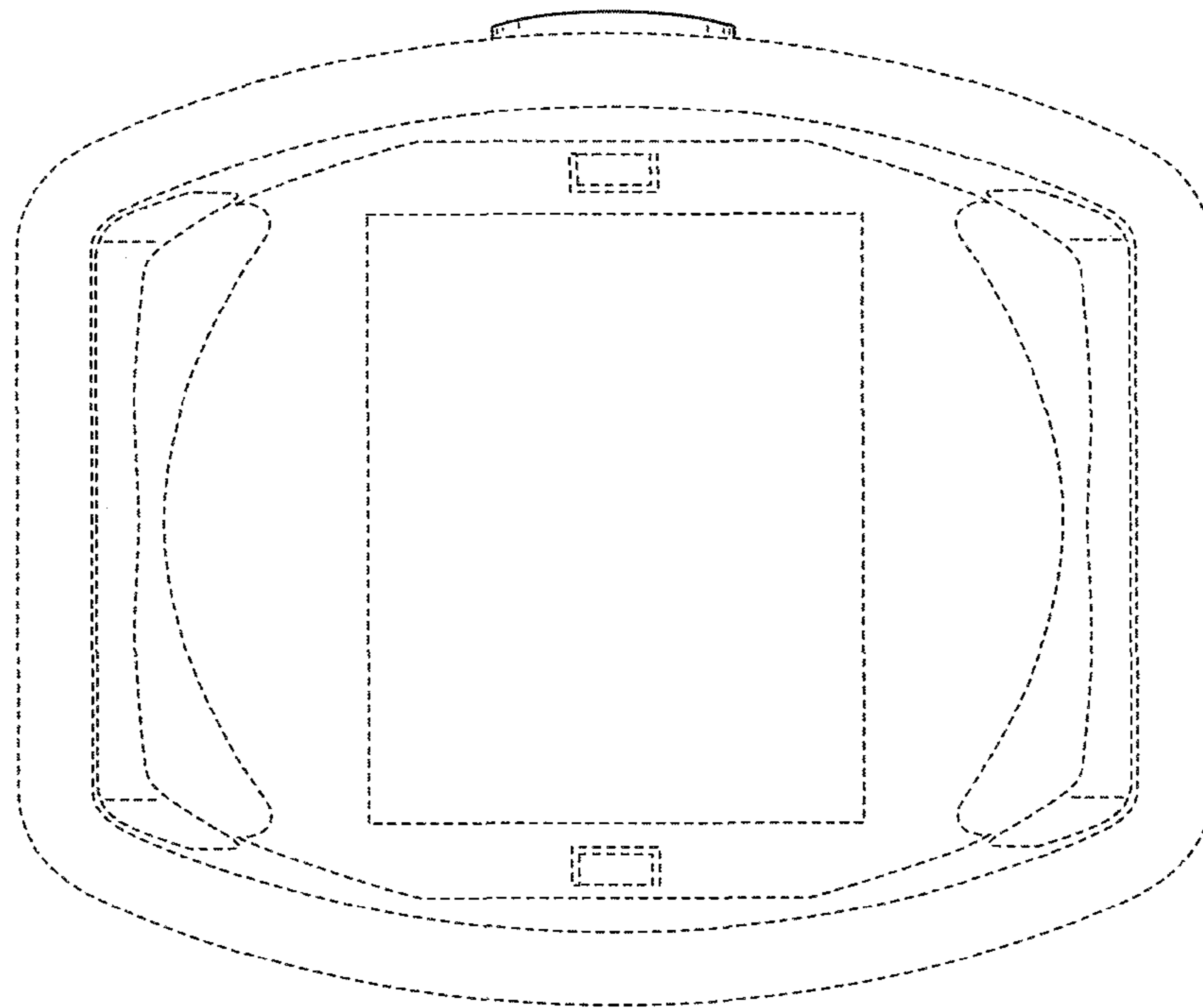
