I claim the ornamental design for a standing lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a standing lamp, according to an embodiment of the invention;
FIG. 2 is a front view of a standing lamp, according to FIG. 1;
FIG. 3 is a rear view of a standing lamp, according to FIG. 1;
FIG. 4 is a side view of a standing lamp, according to FIG. 1;
FIG. 5 is an opposite side view of a standing lamp, according to FIG. 1;
FIG. 6 is a top view of a standing lamp, according to FIG. 1; and,
FIG. 7 is a bottom view of a standing lamp, according to FIG. 1.

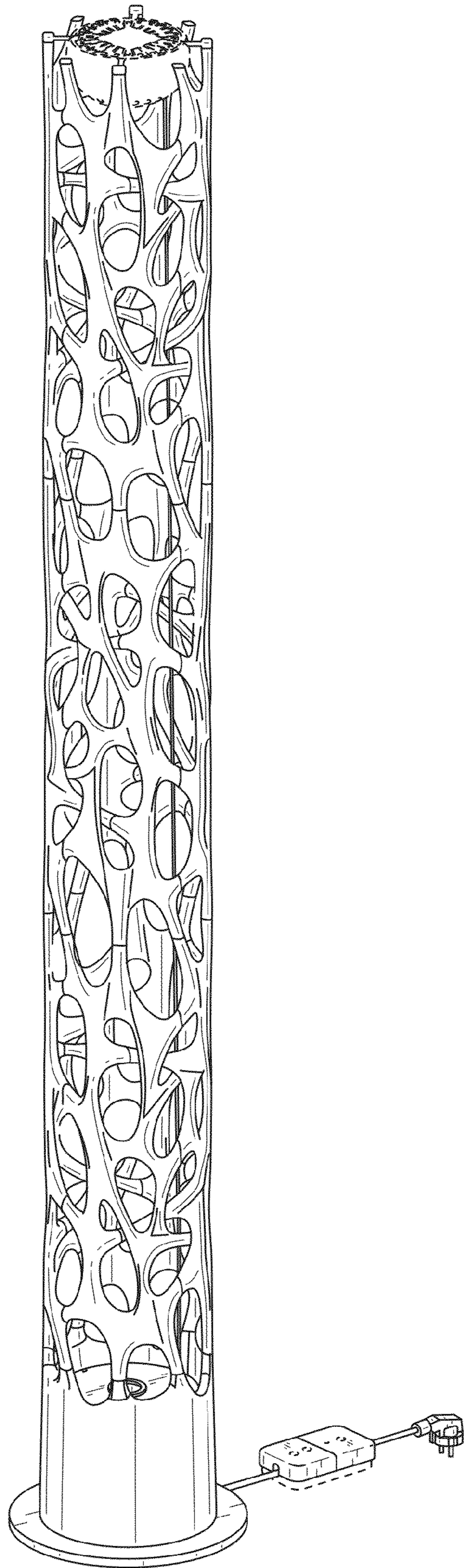

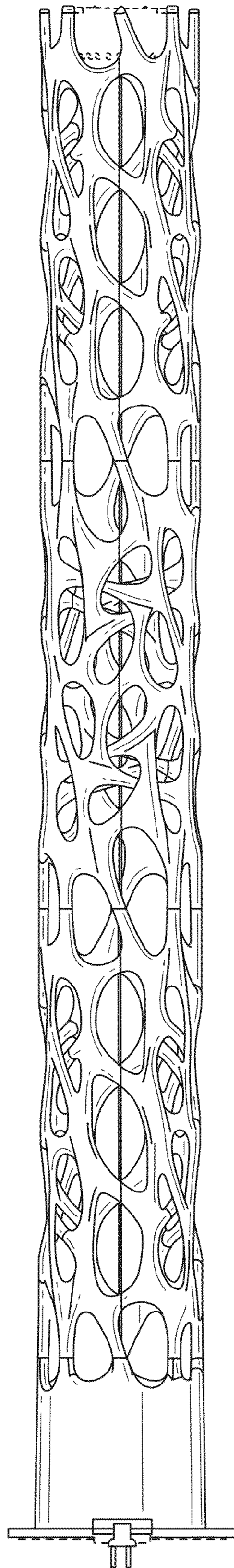

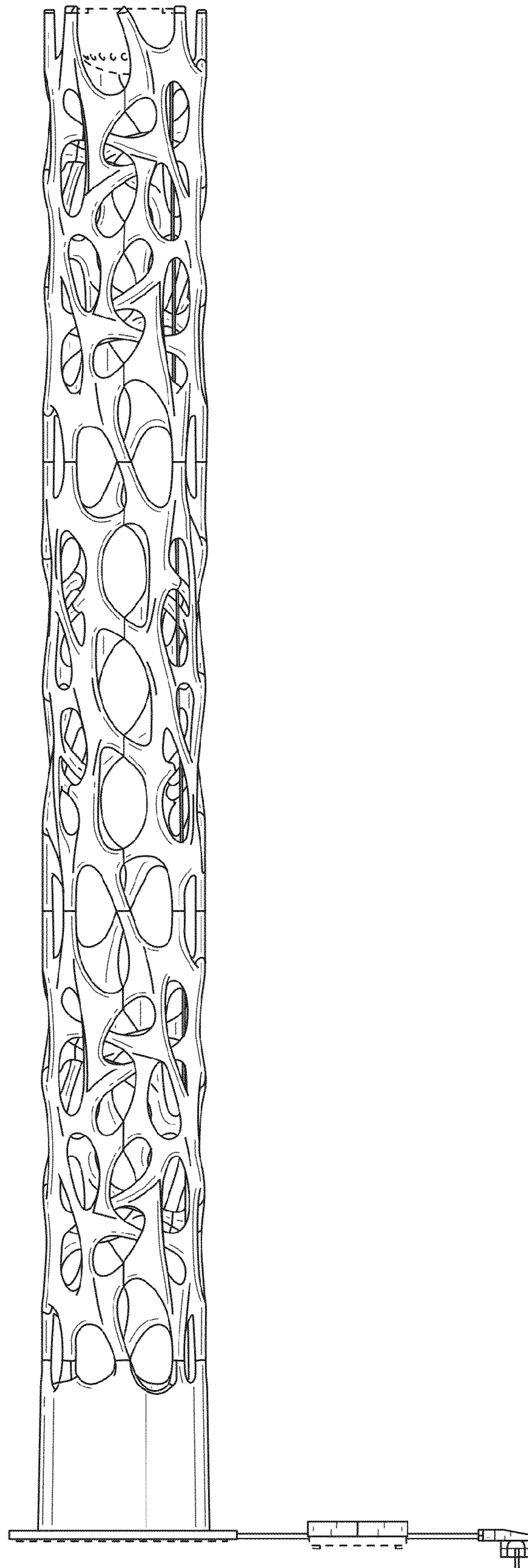

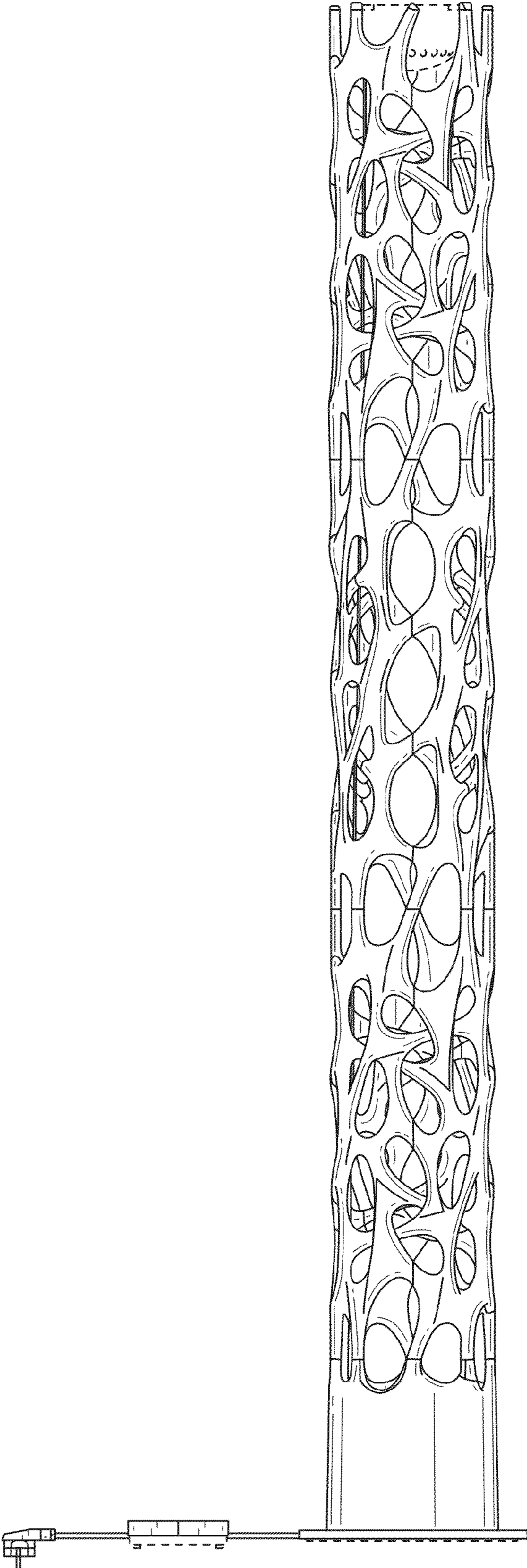

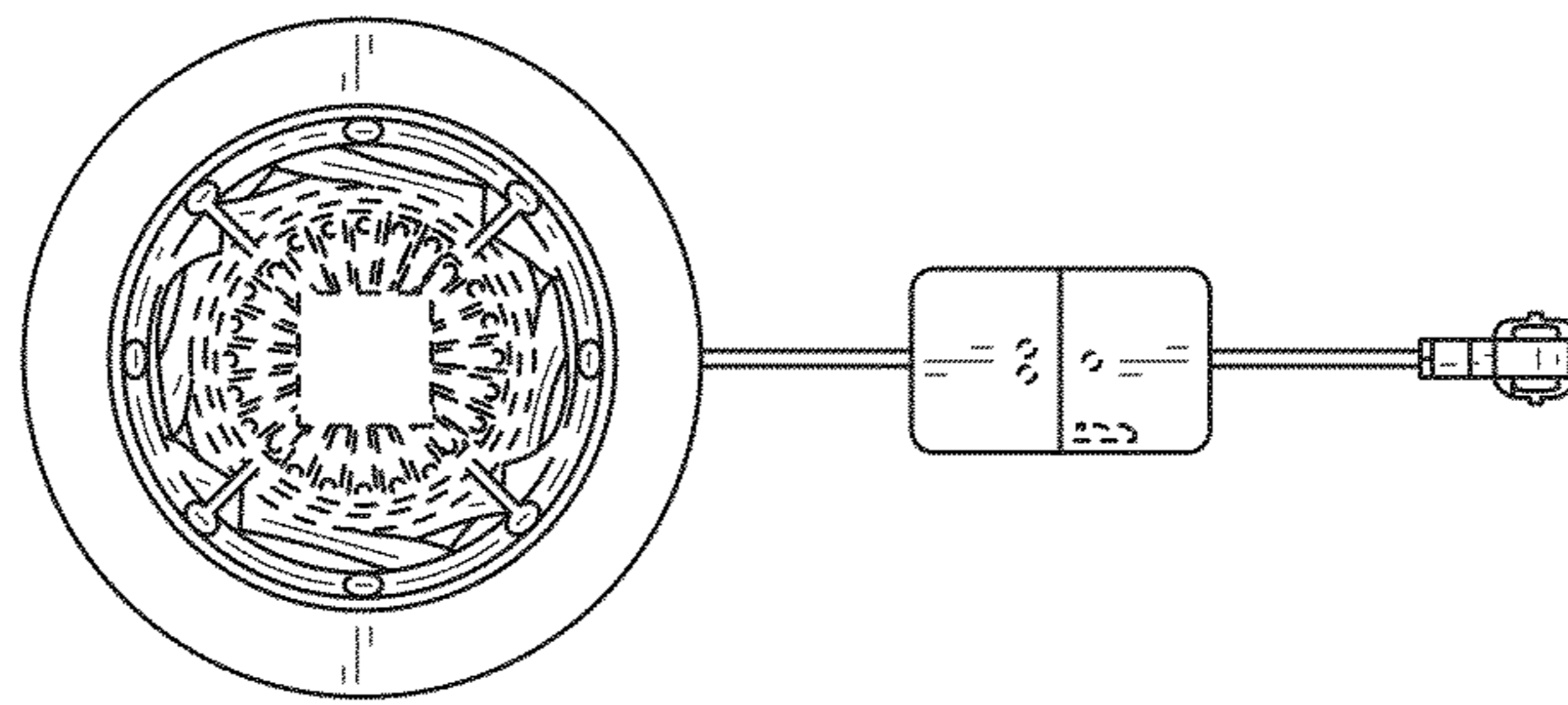

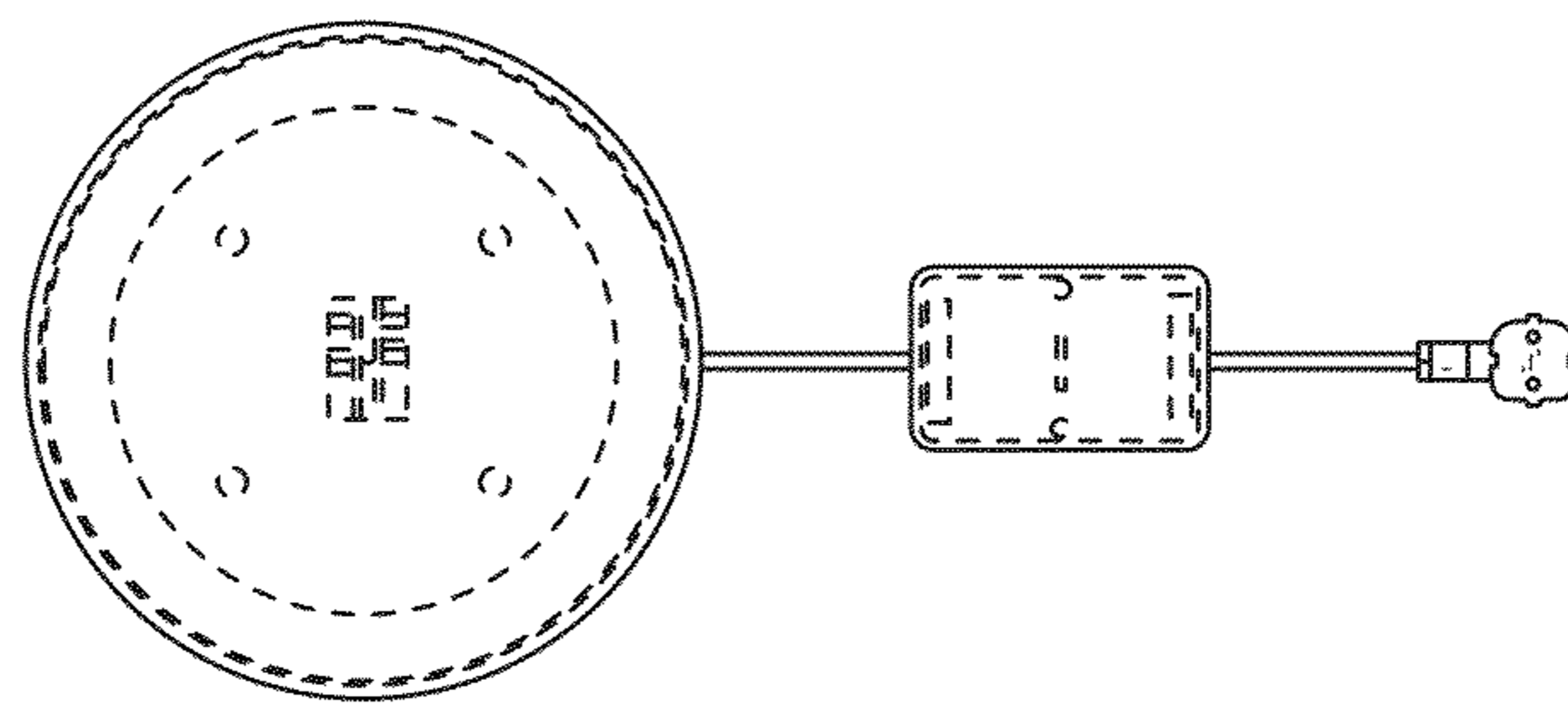
