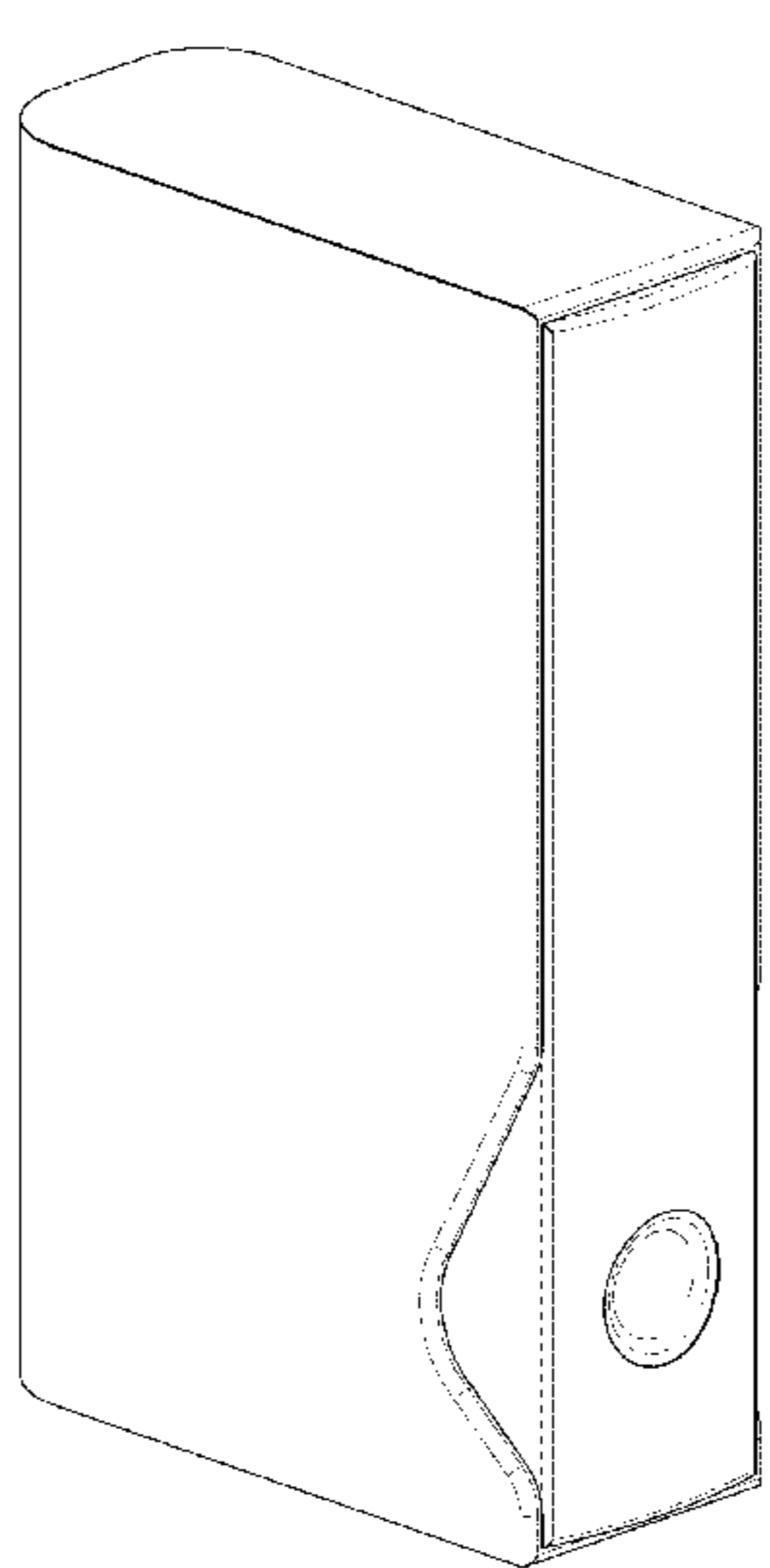

The ornamental design for a container for simulated cigarettes, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container for simulated cigarettes showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a perspective view thereof in an open position; and,

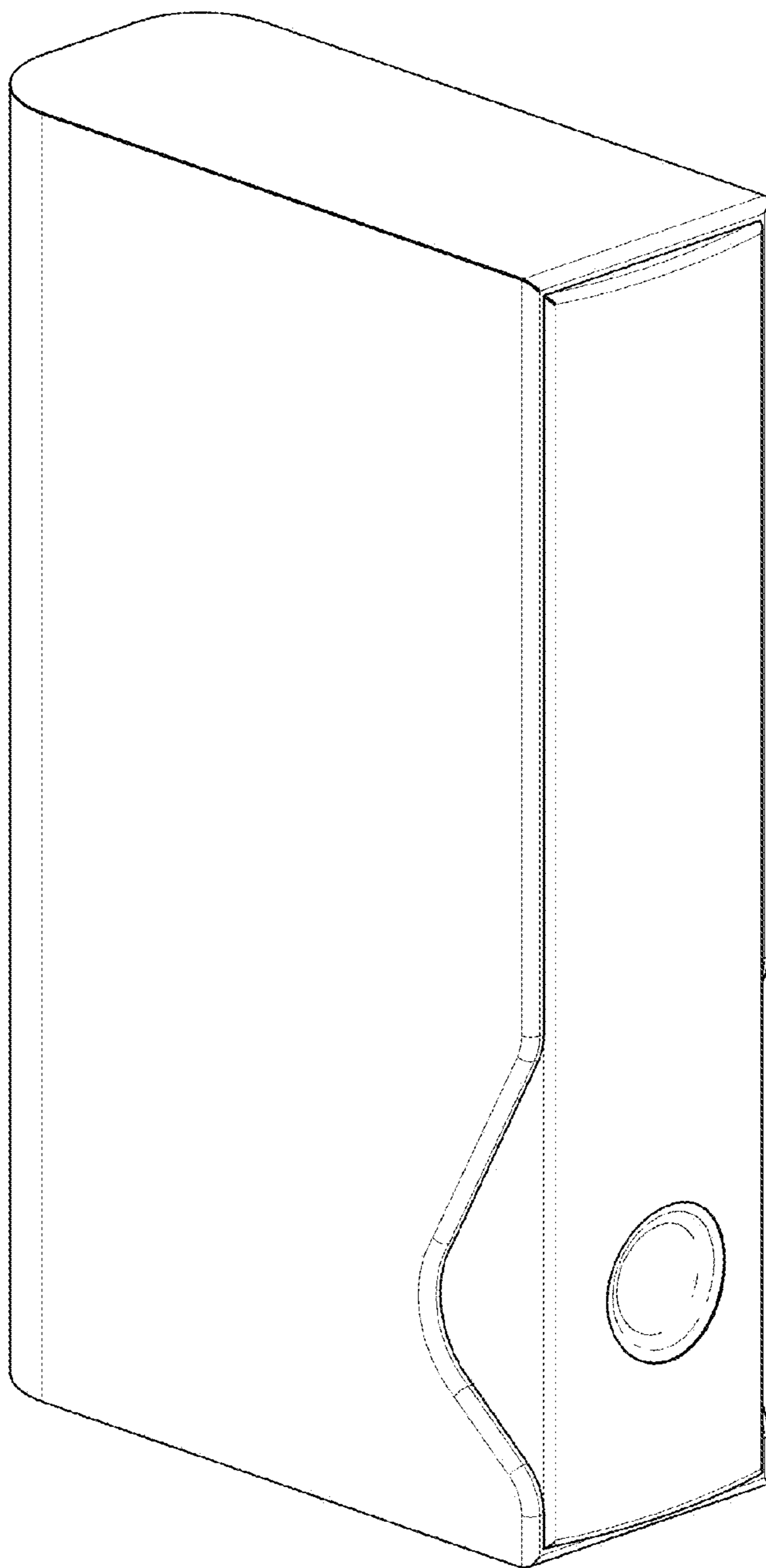

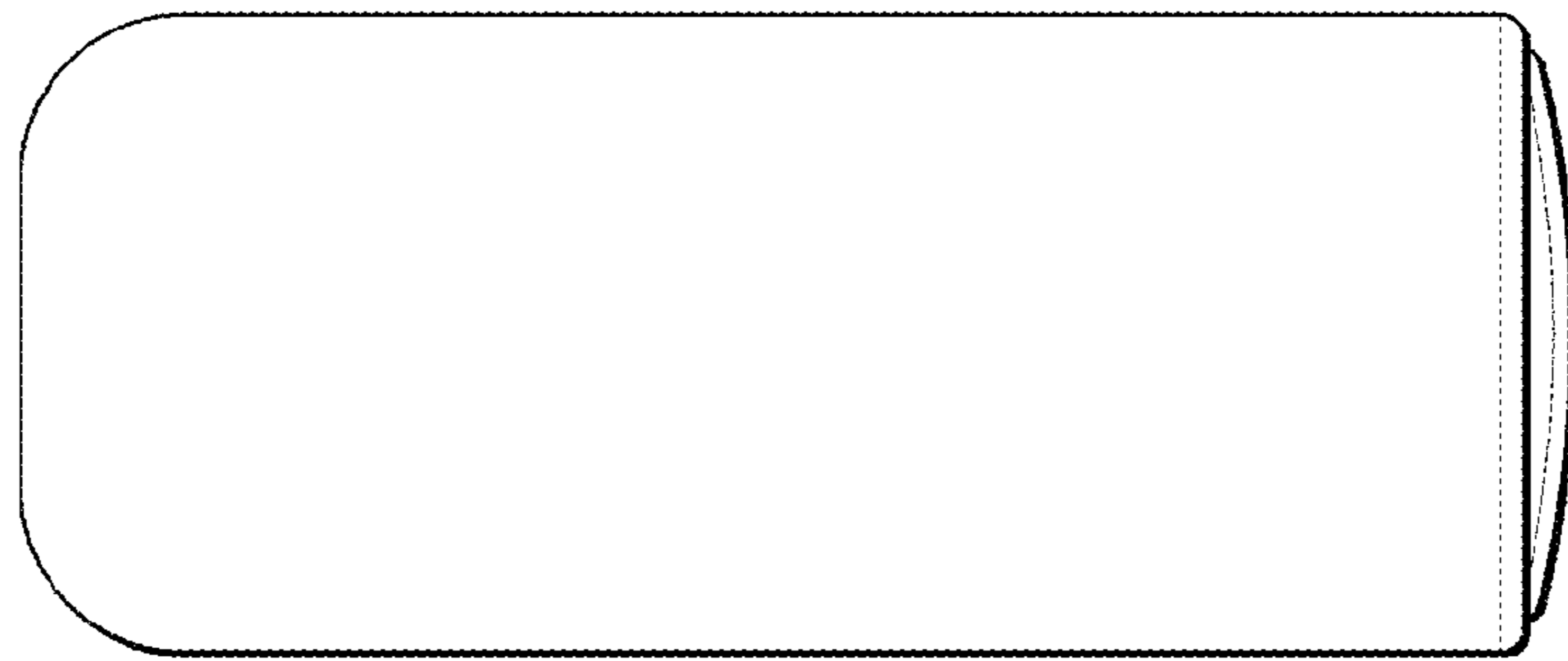

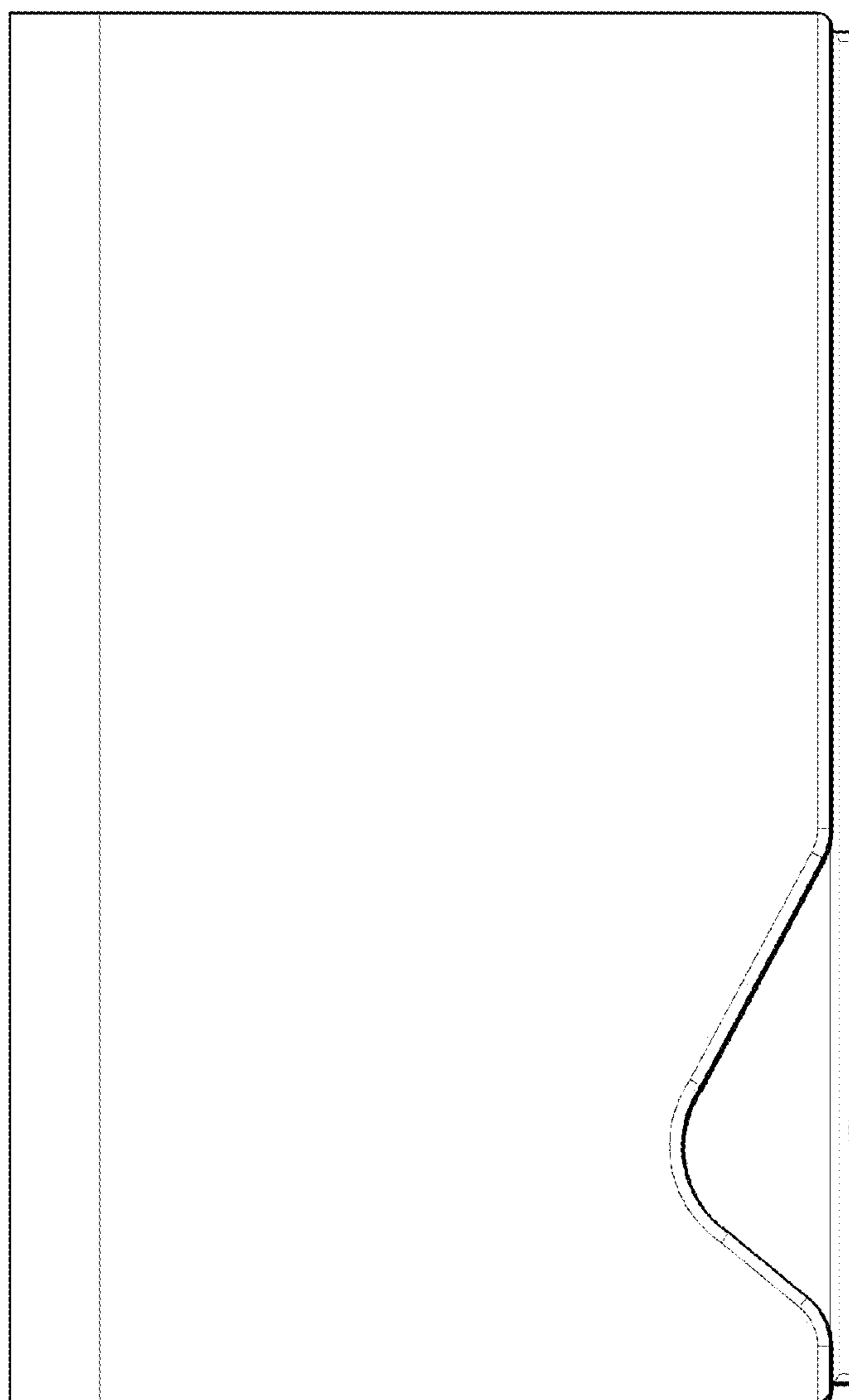

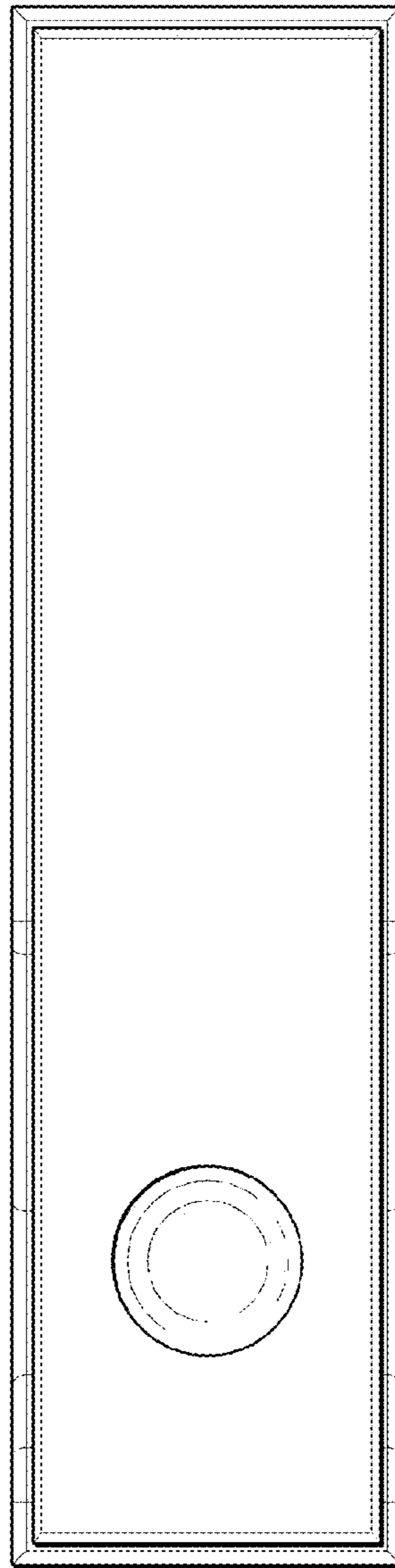

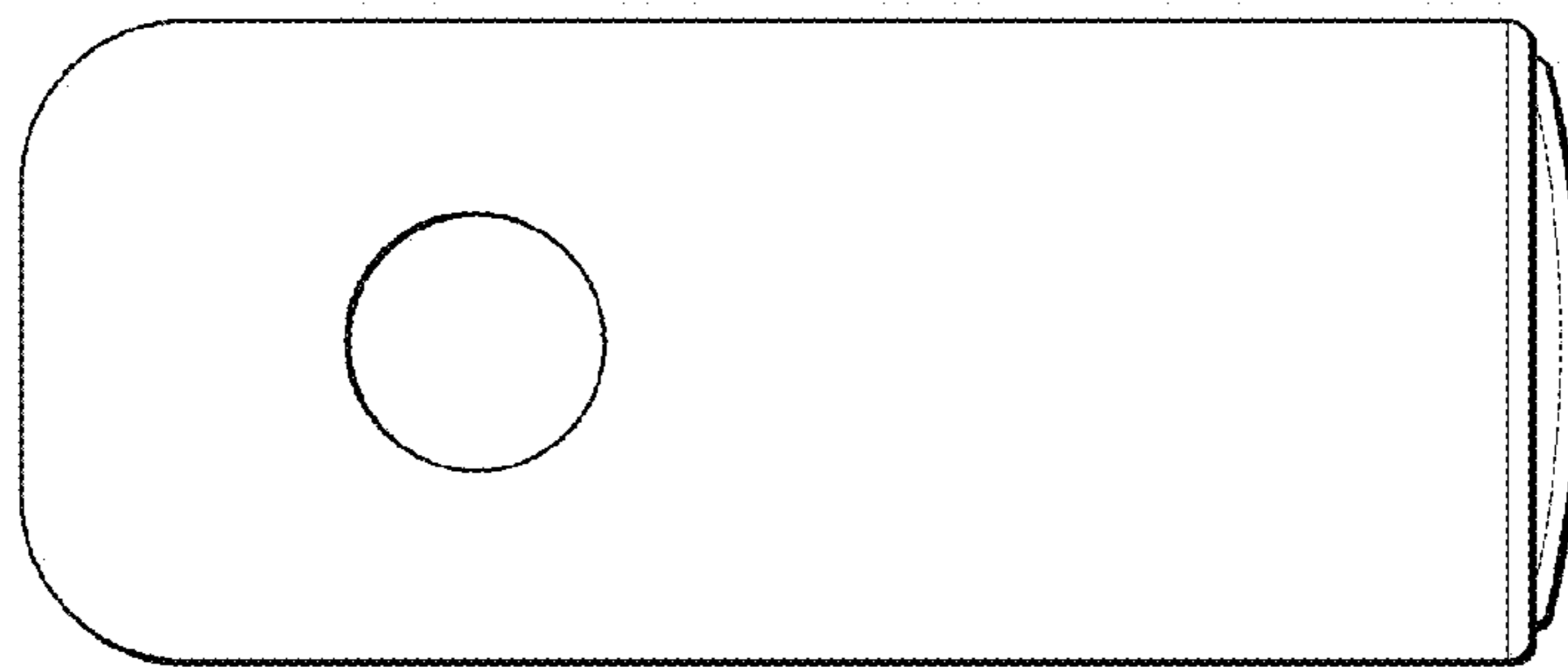

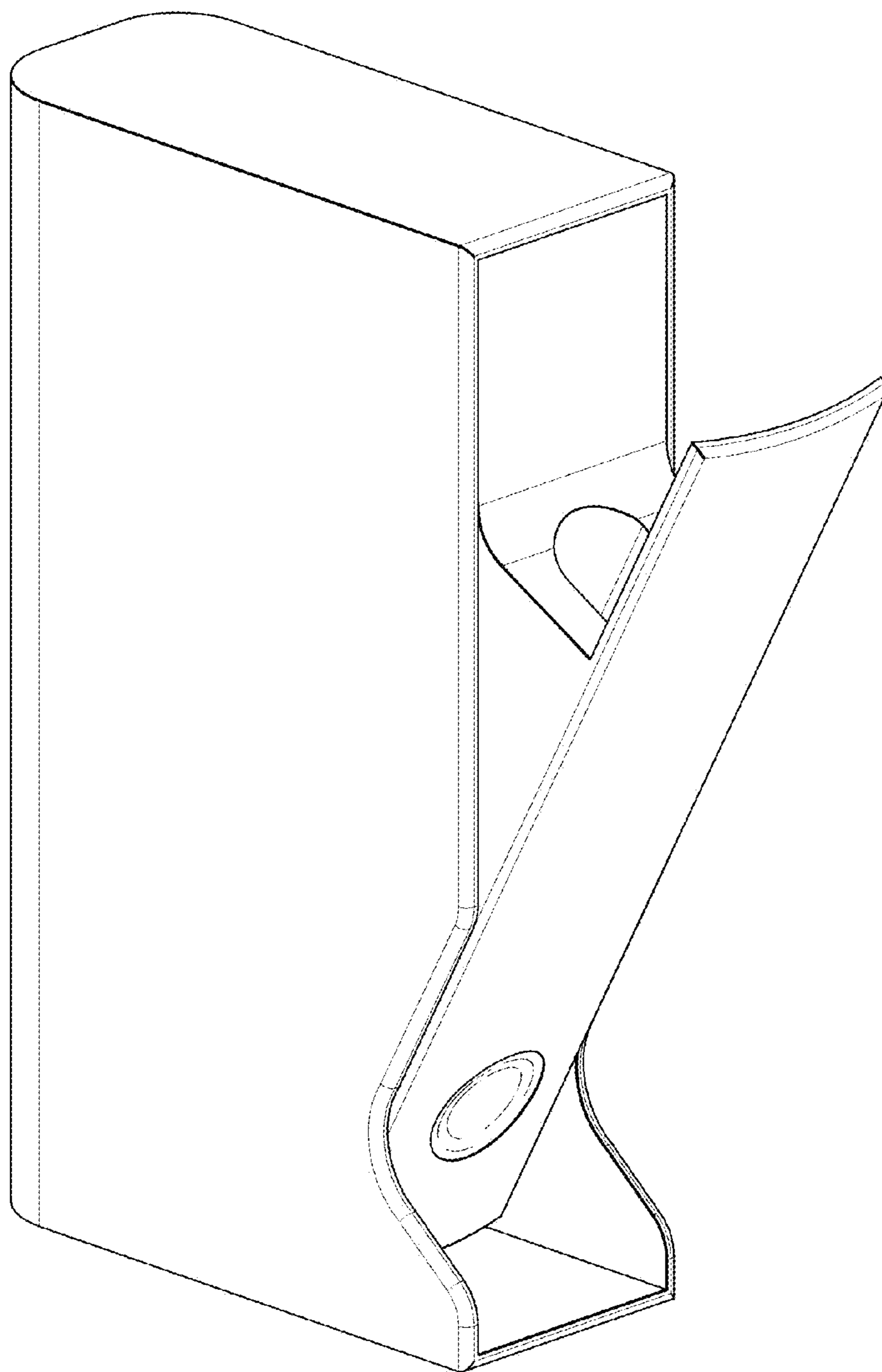

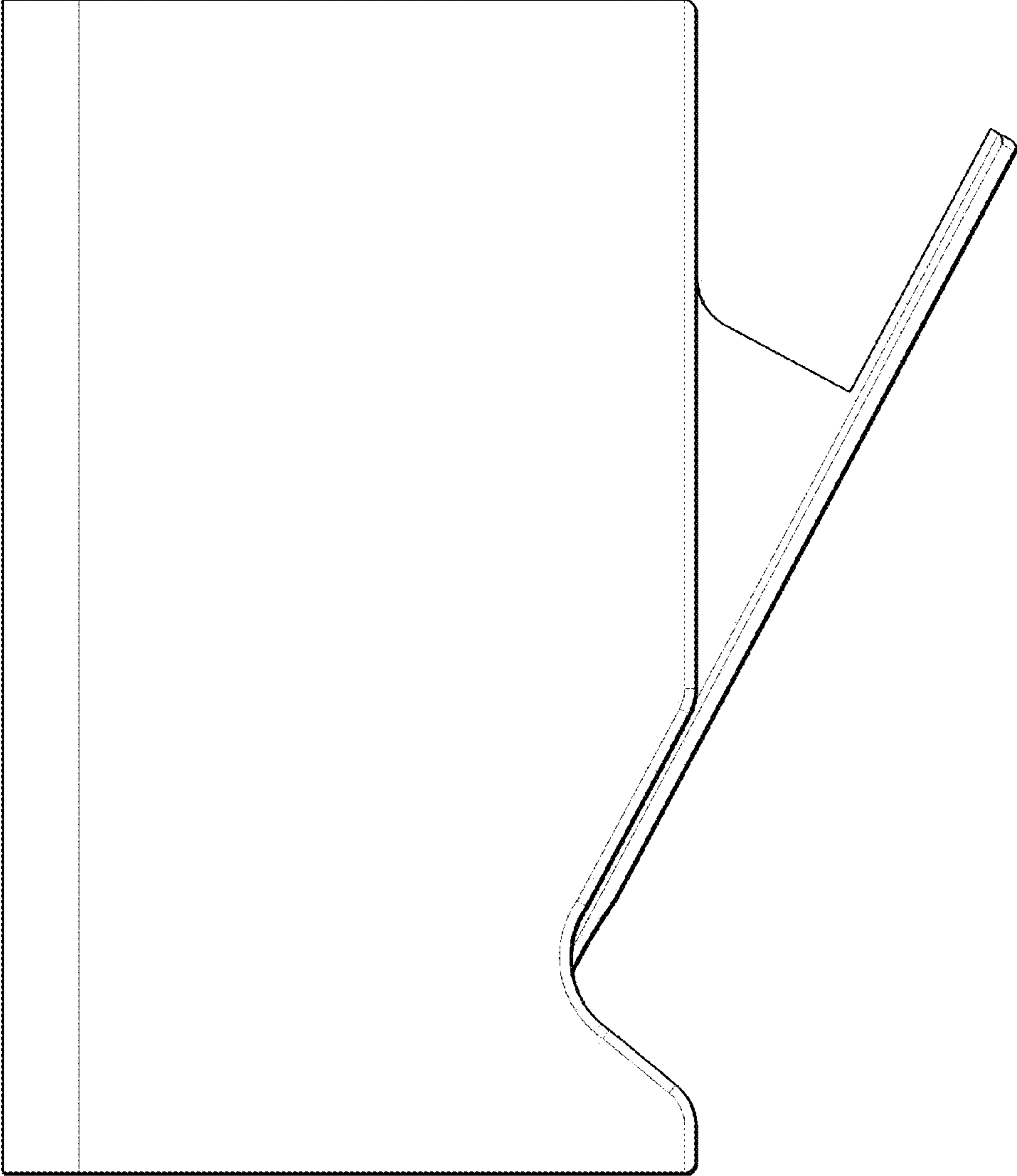
