FIG. 3 is a rear view thereof.

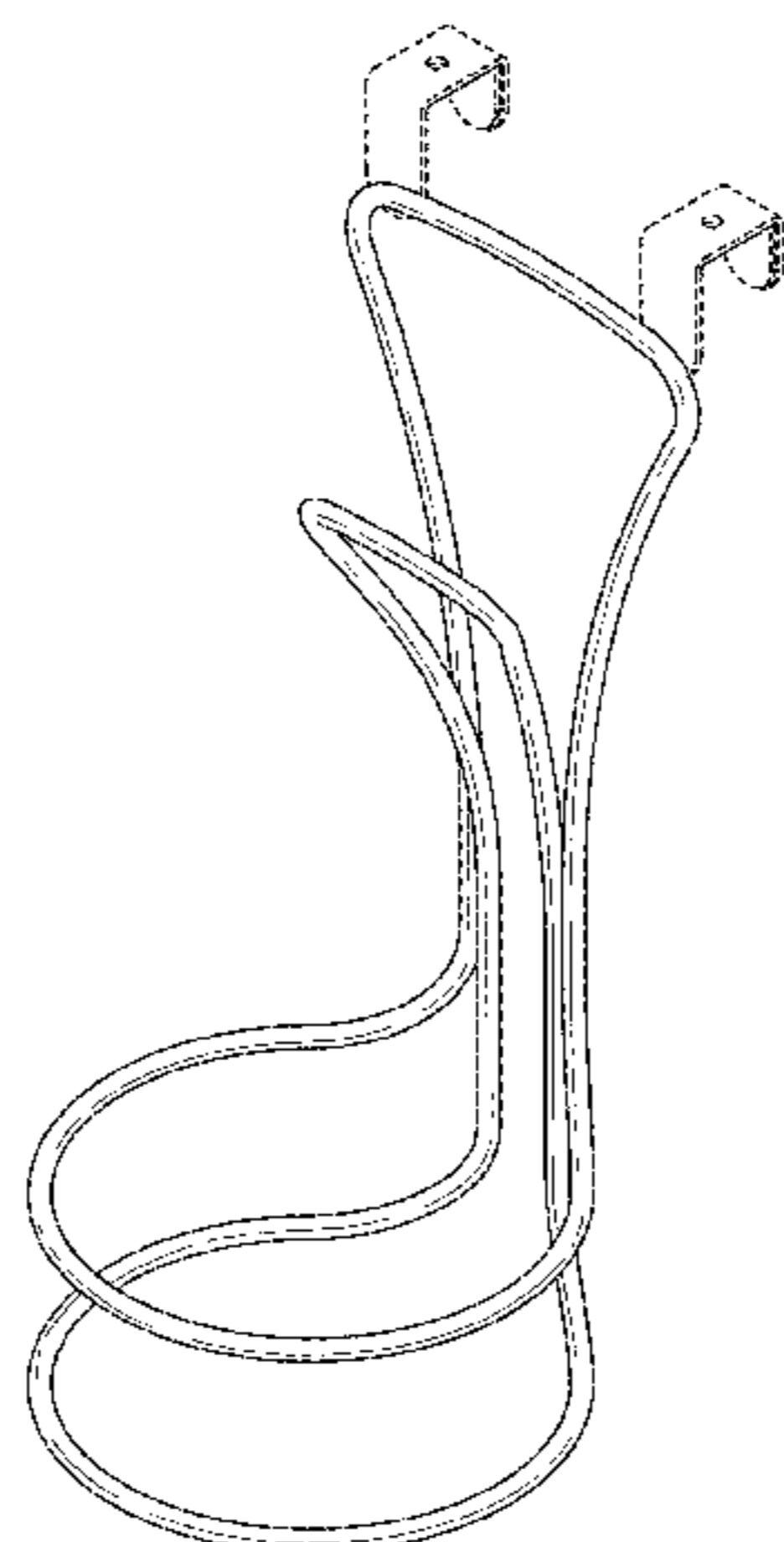
FIG. 4 is a right side view thereof, a left side view being a mirror image of the right side view.

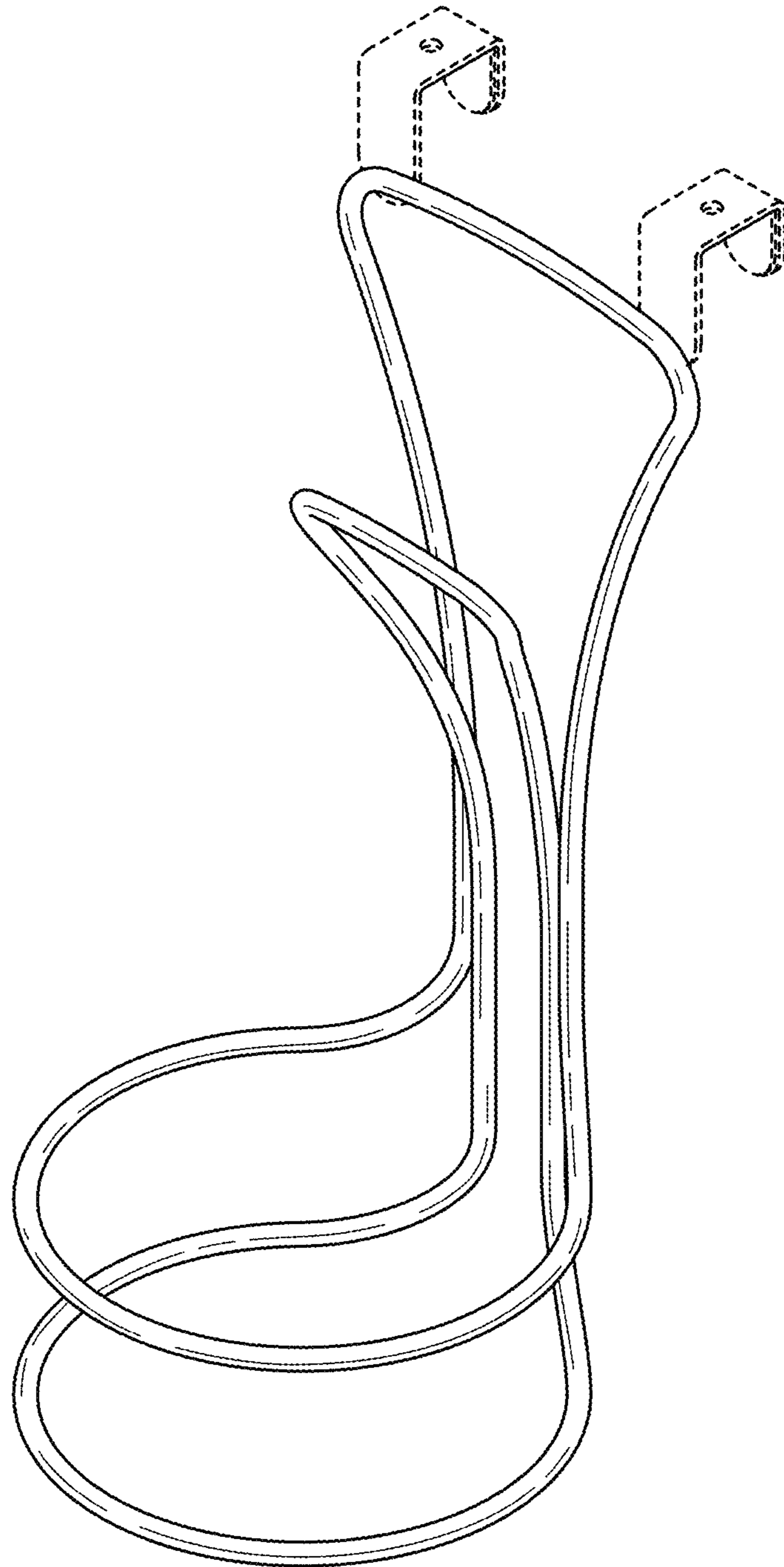

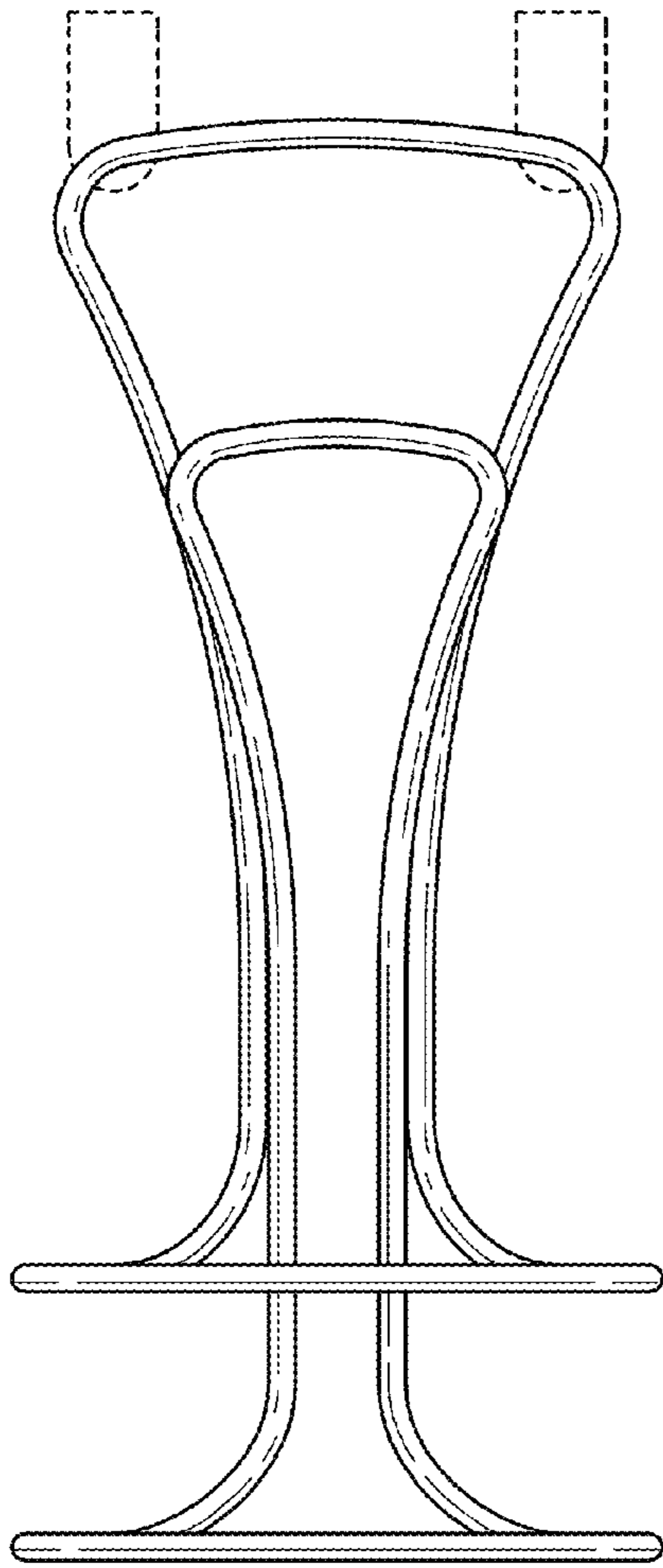

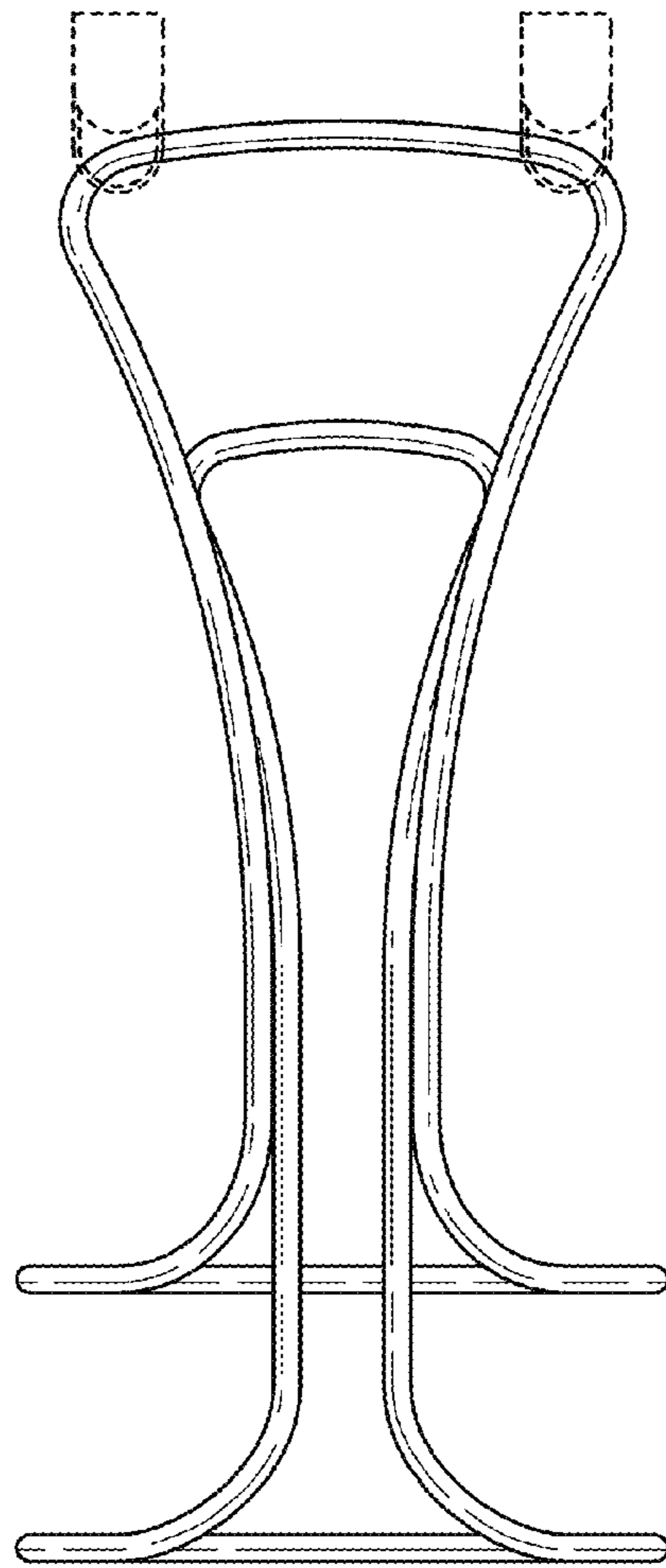

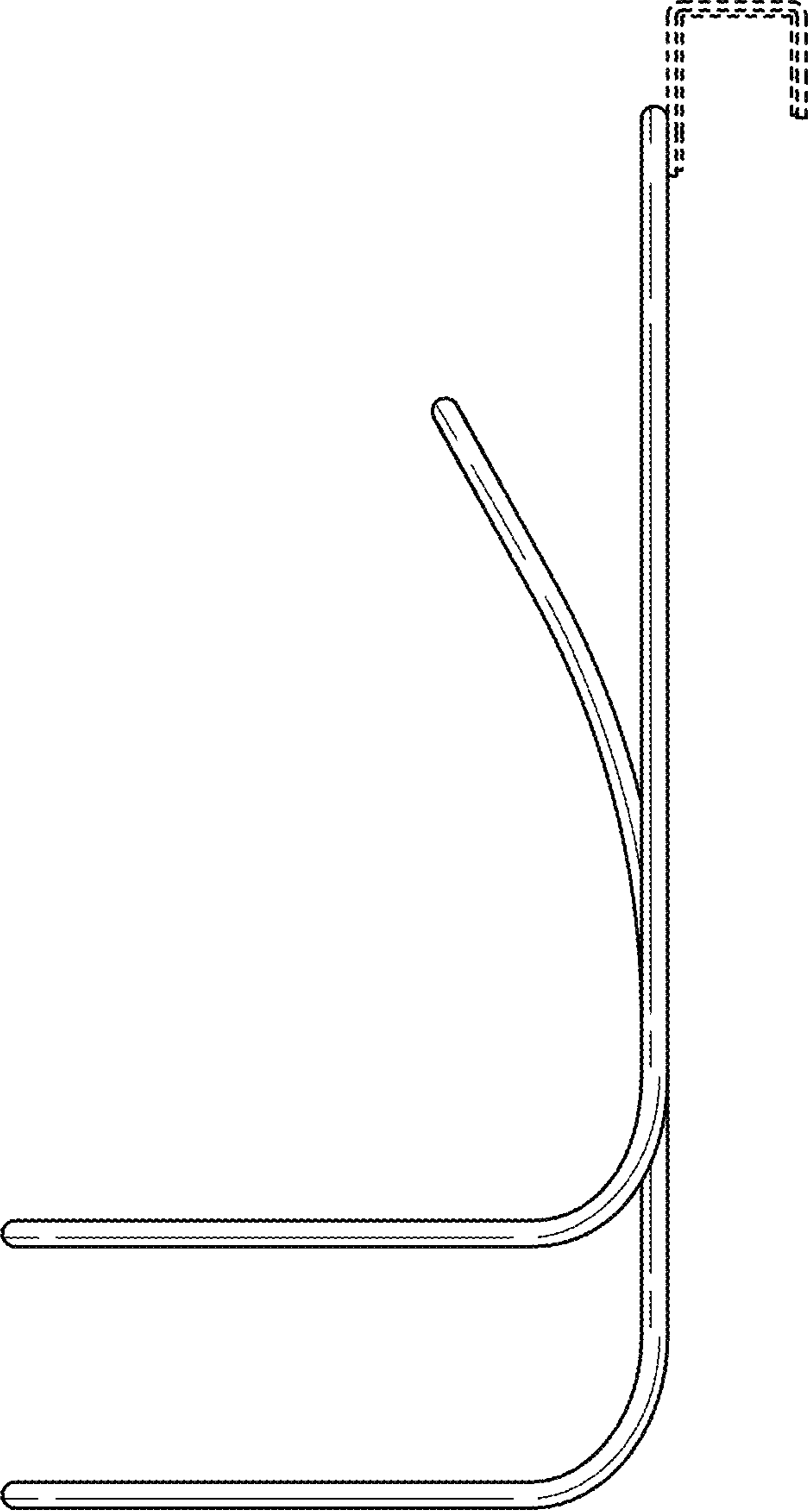

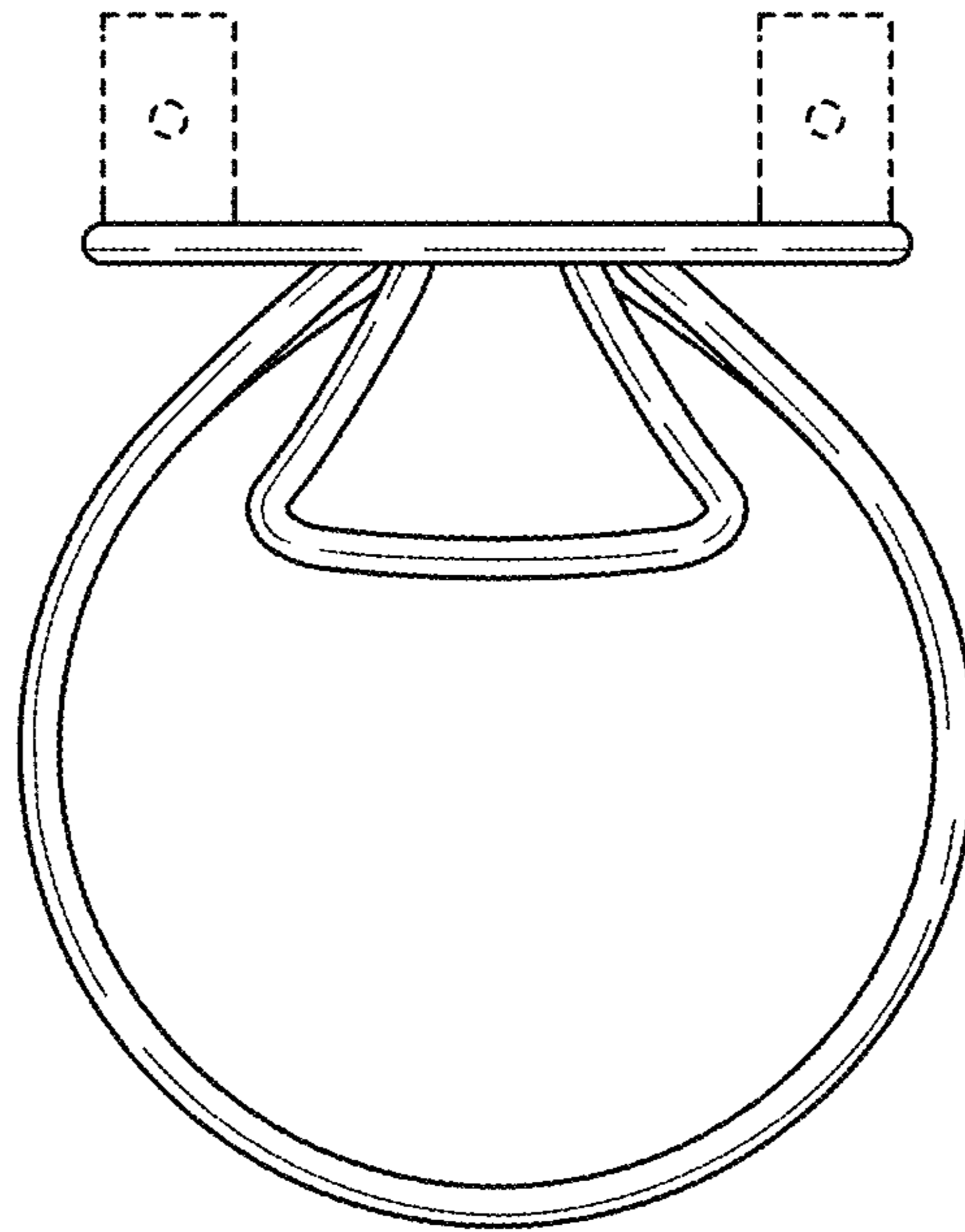

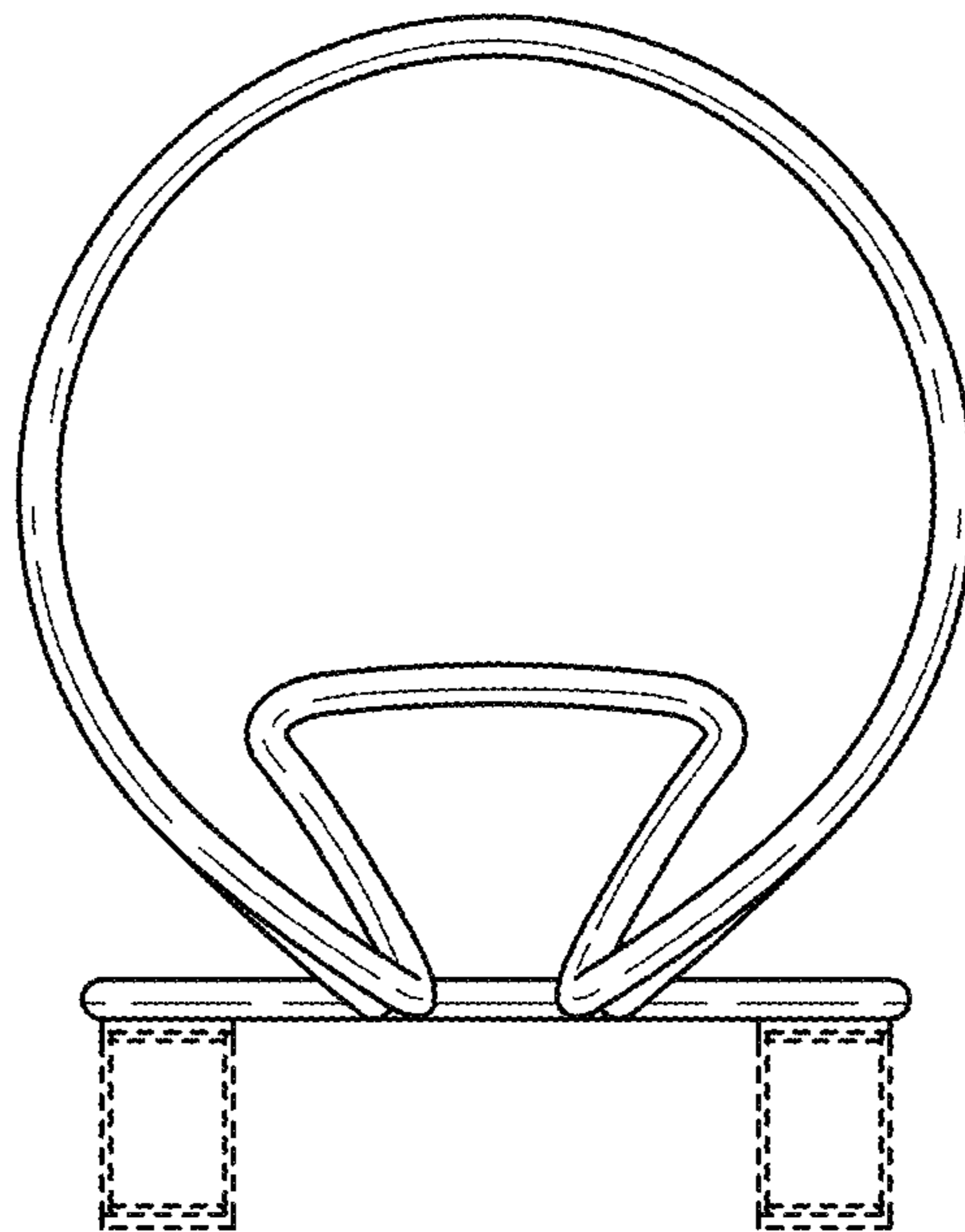
