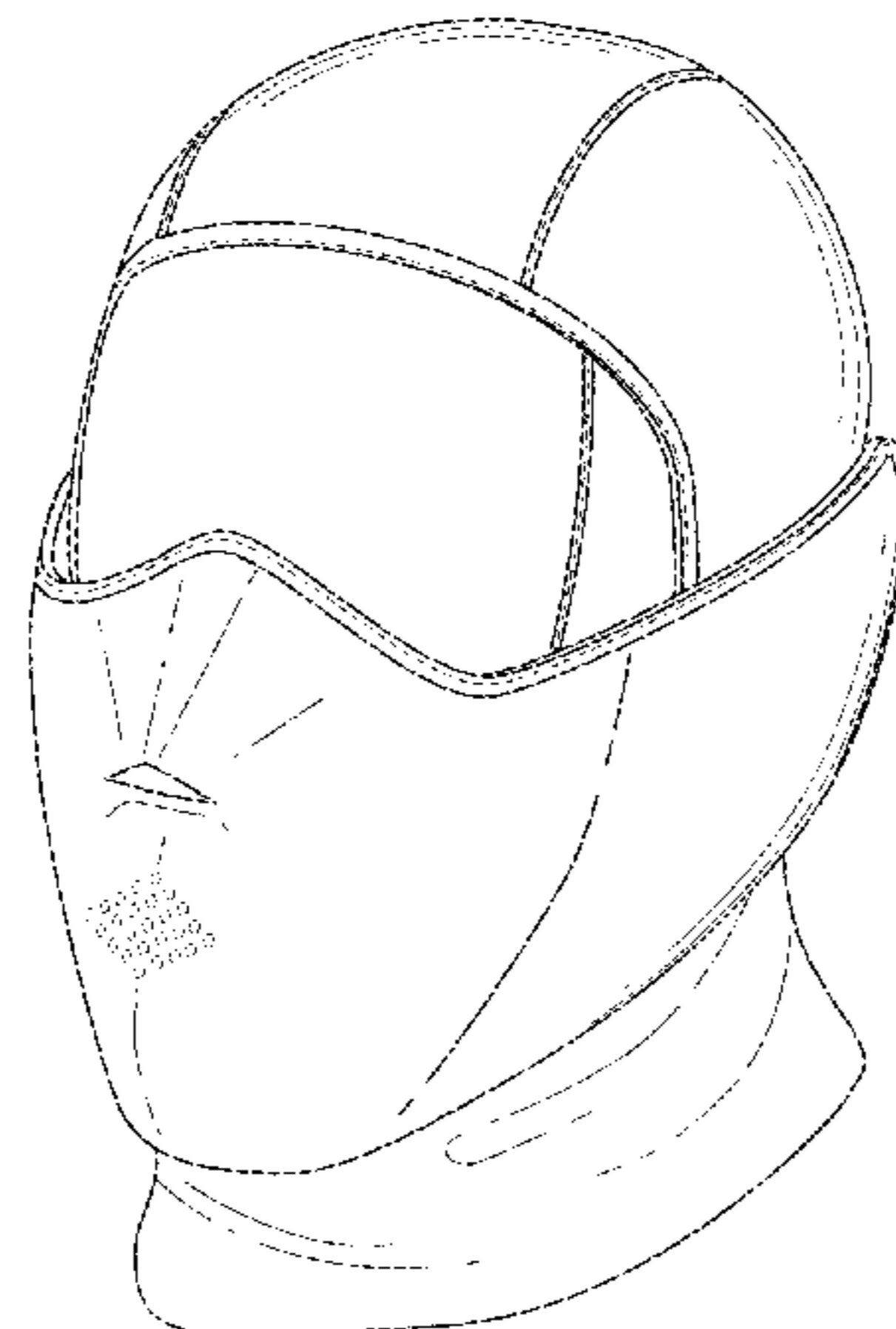
(57) **CLAIM**

FIG. 1 is a perspective view of a winged mask with piping showing my new design;

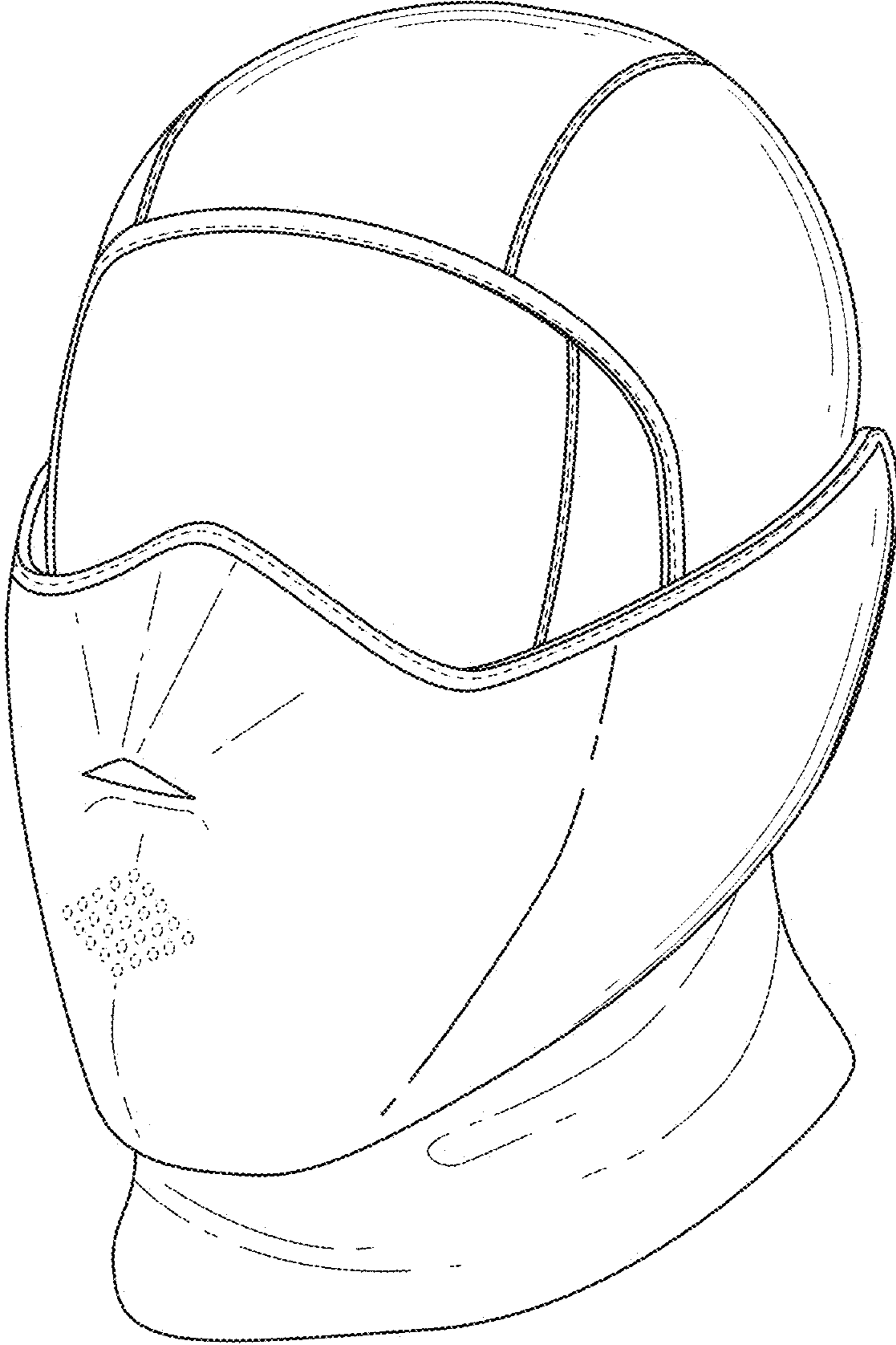

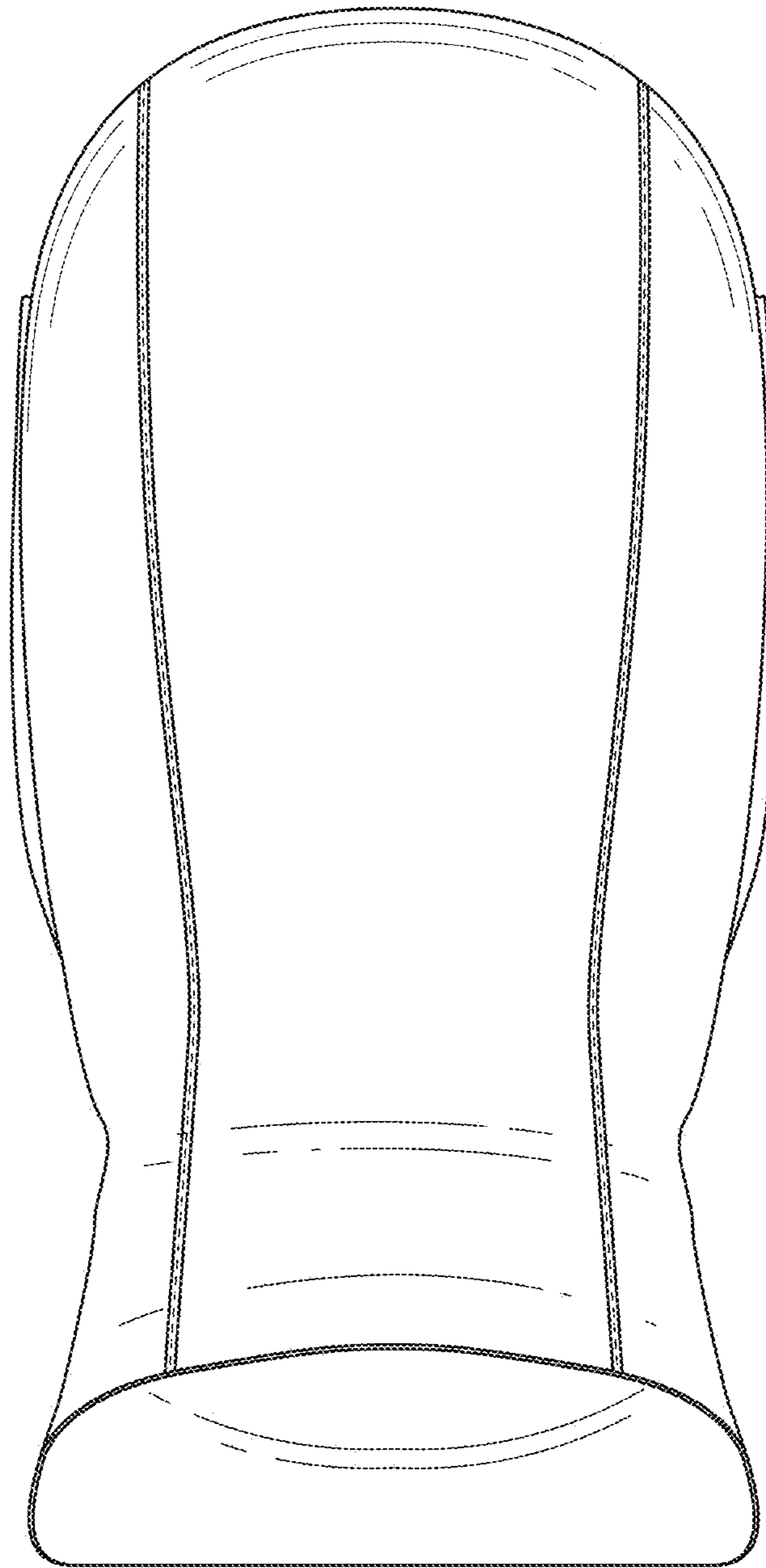

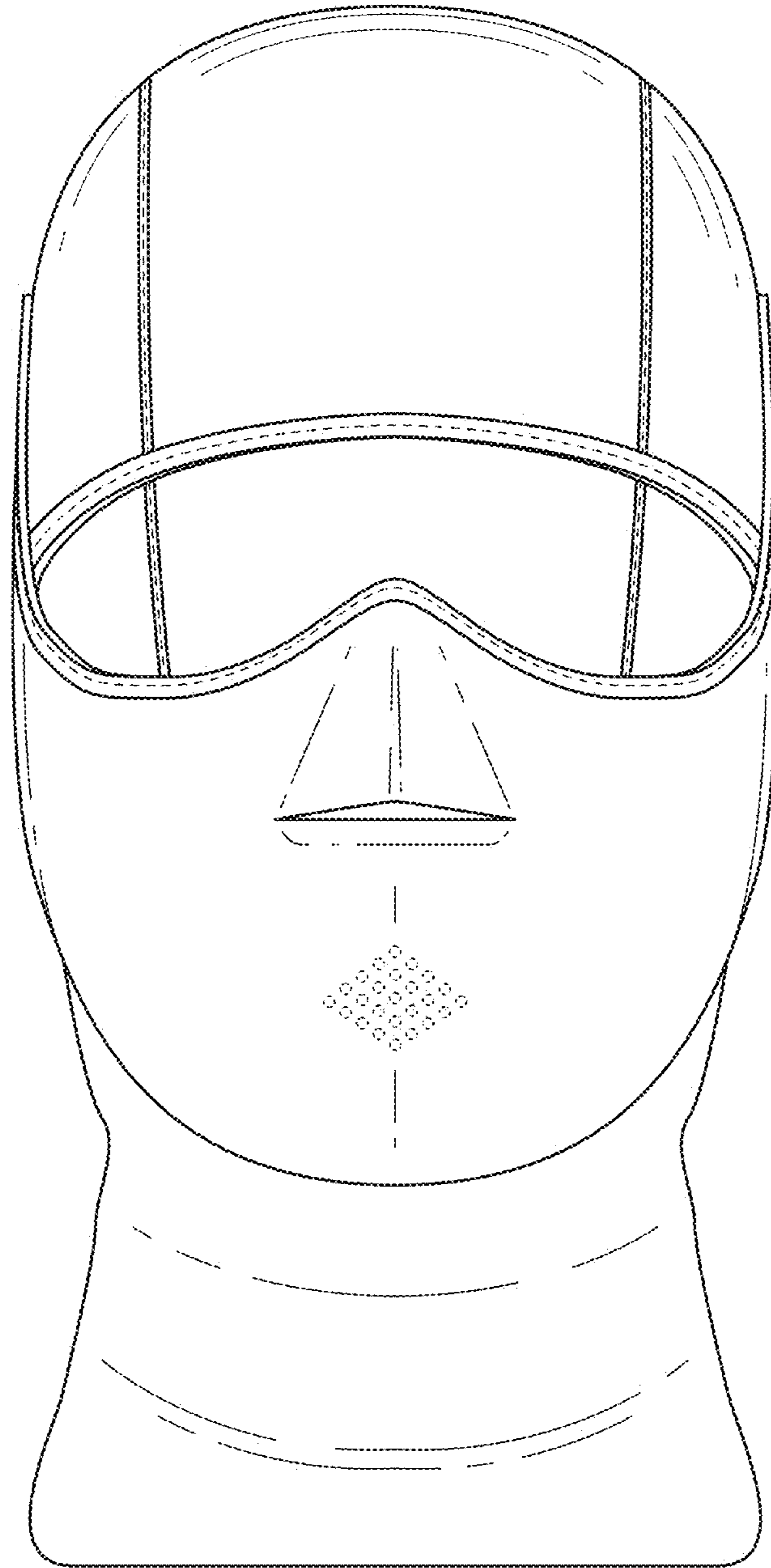

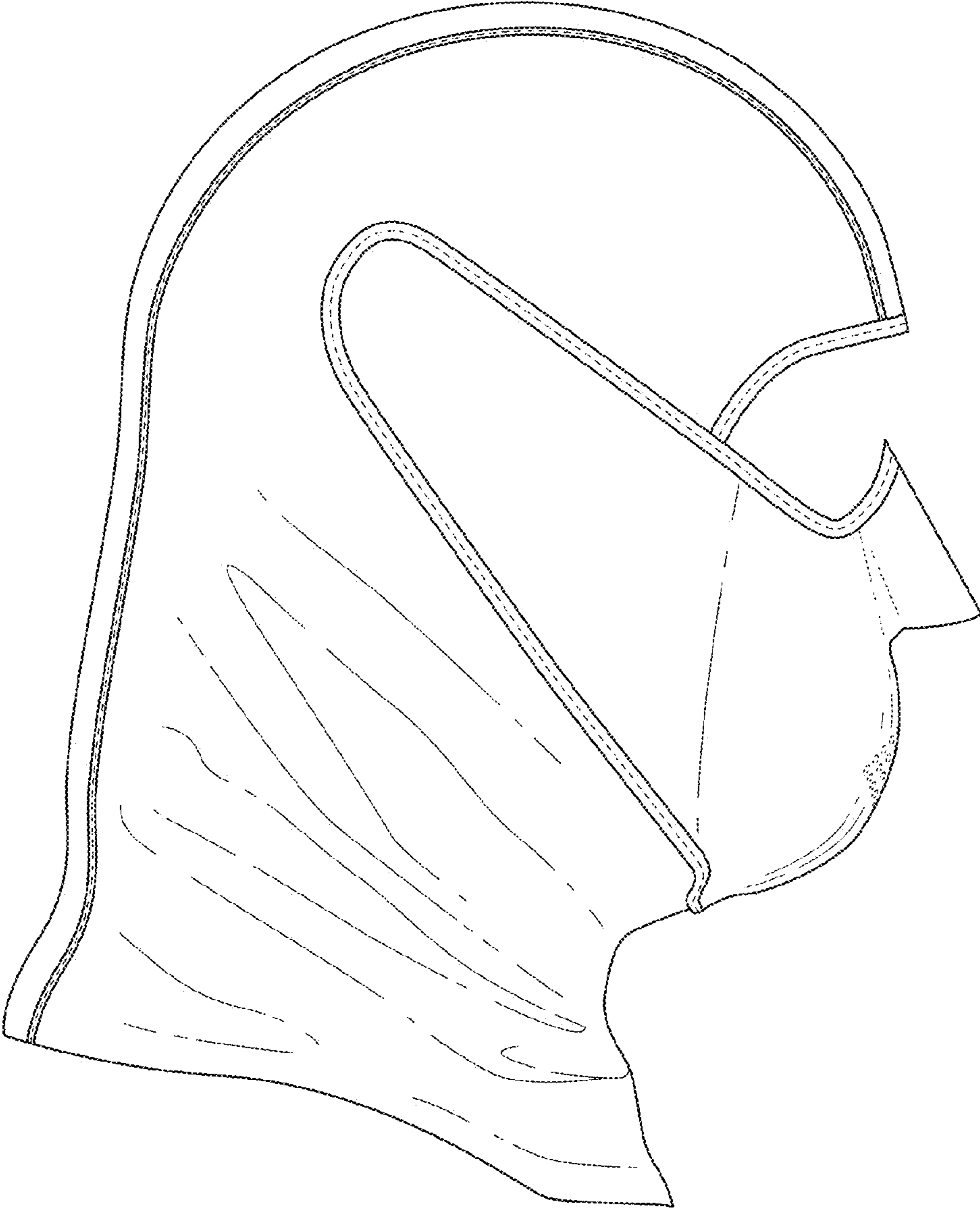

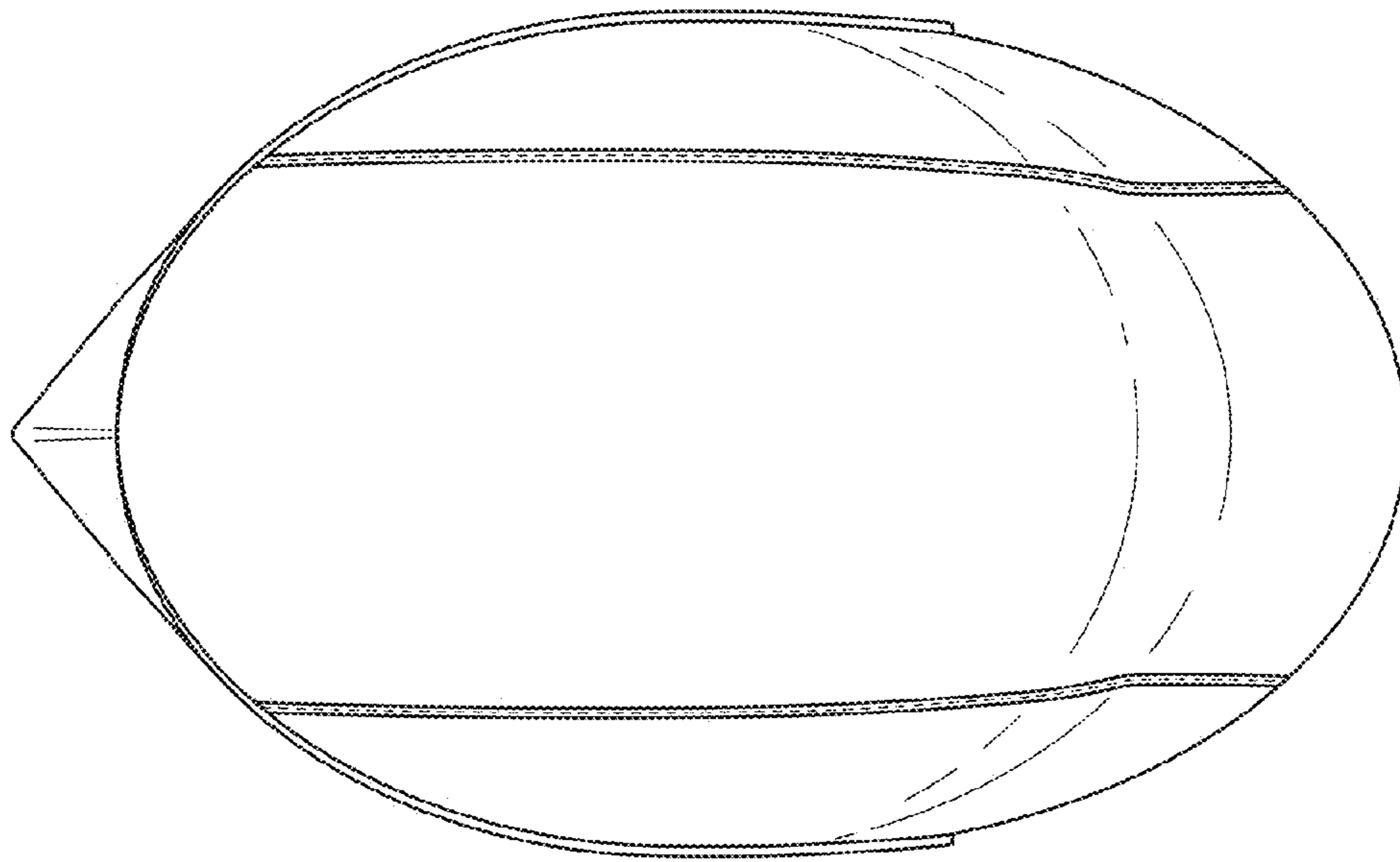
