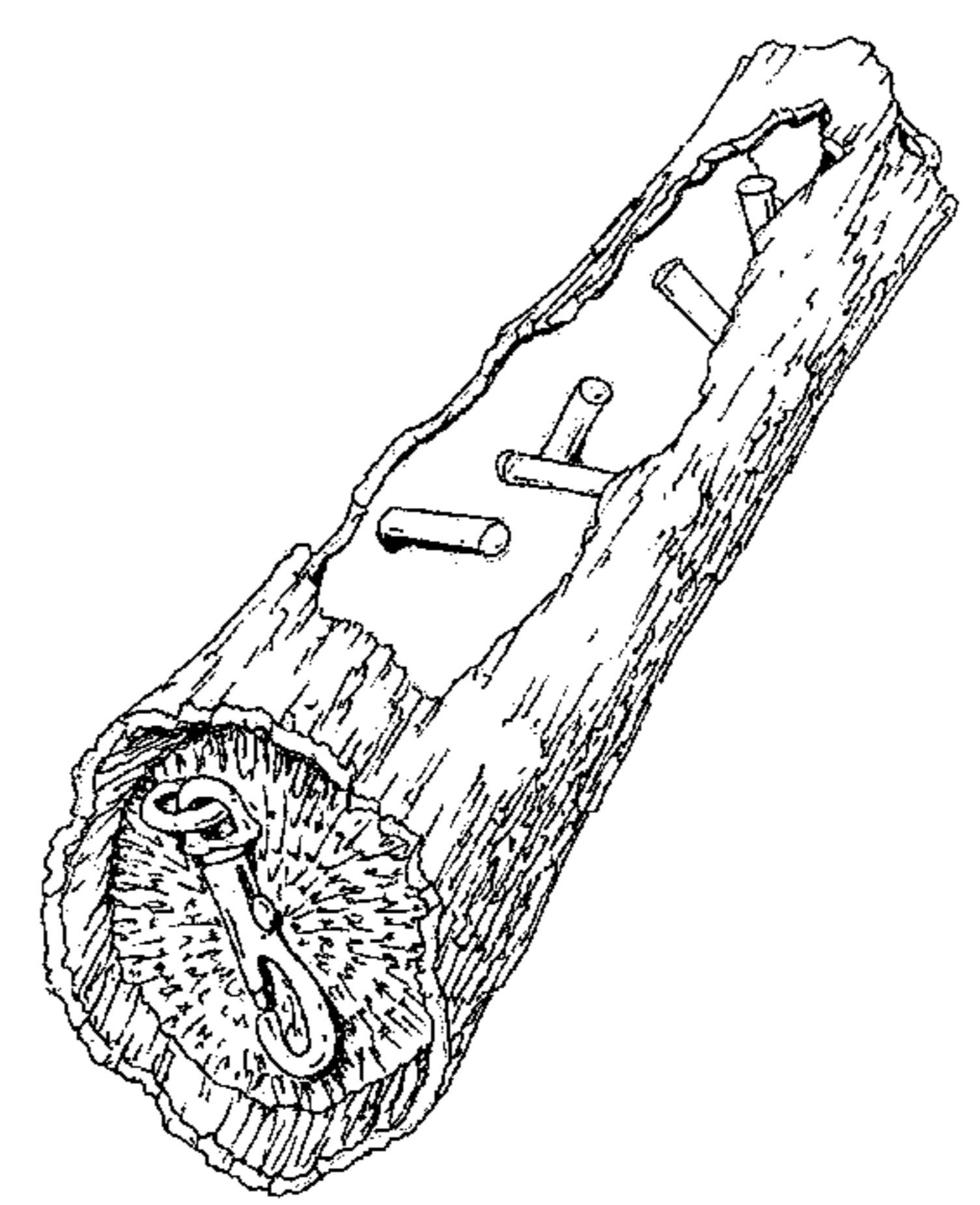

(57) **CLAIM**  
We claim the ornamental design for an animal feeder, sub-  
stantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the animal feeder. This drawing shows the plurality of fingers designed to slow feeding times of animals.  
FIG. 2 is a top view of the animal feeder of FIG. 1.  
FIG. 3 is a side view of the animal feeder of FIG. 1.  
FIG. 4 is an end view of the animal feeder of FIG. 1; and,  
FIG. 5 is an opposite end view of the animal feeder of FIG. 1.

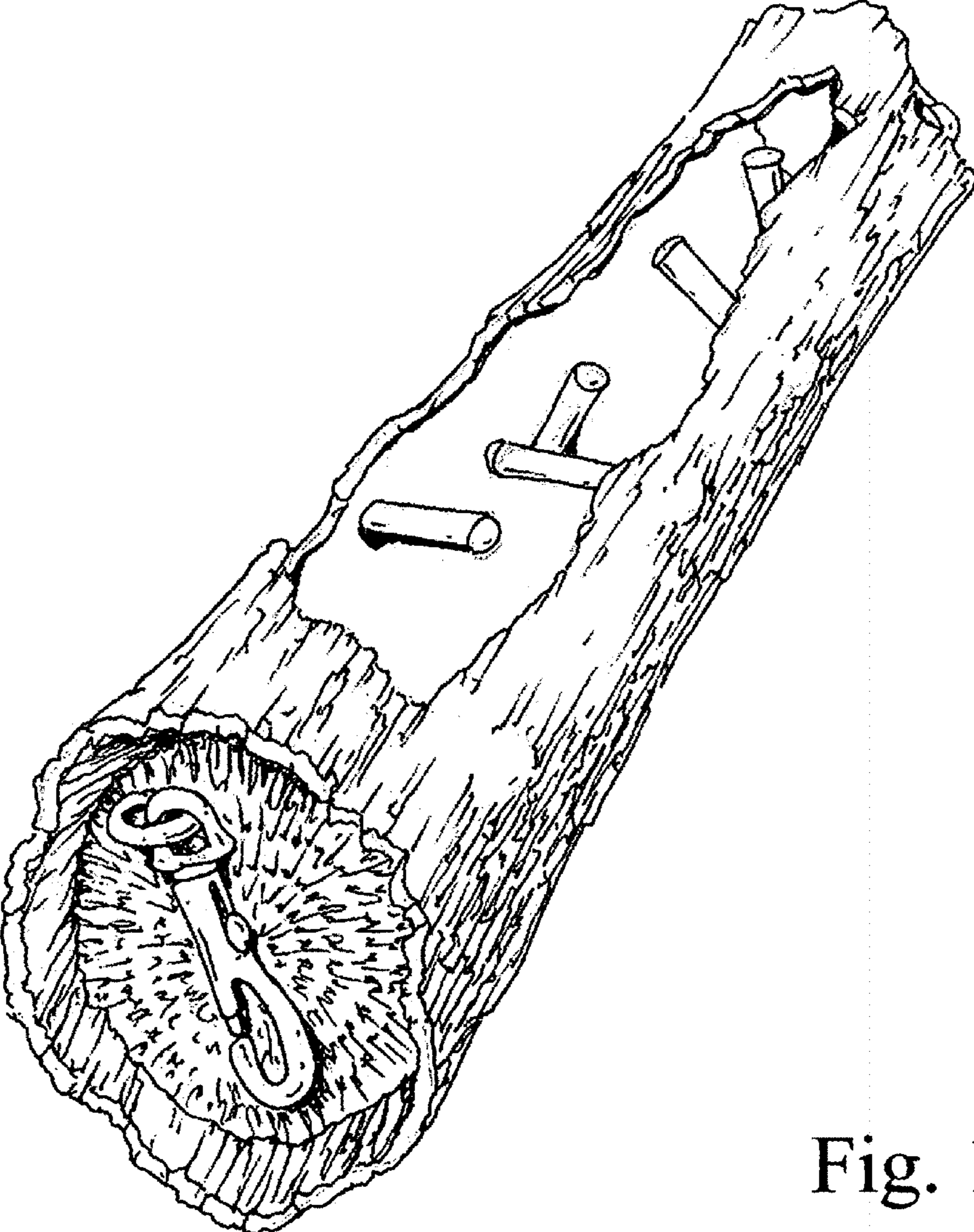

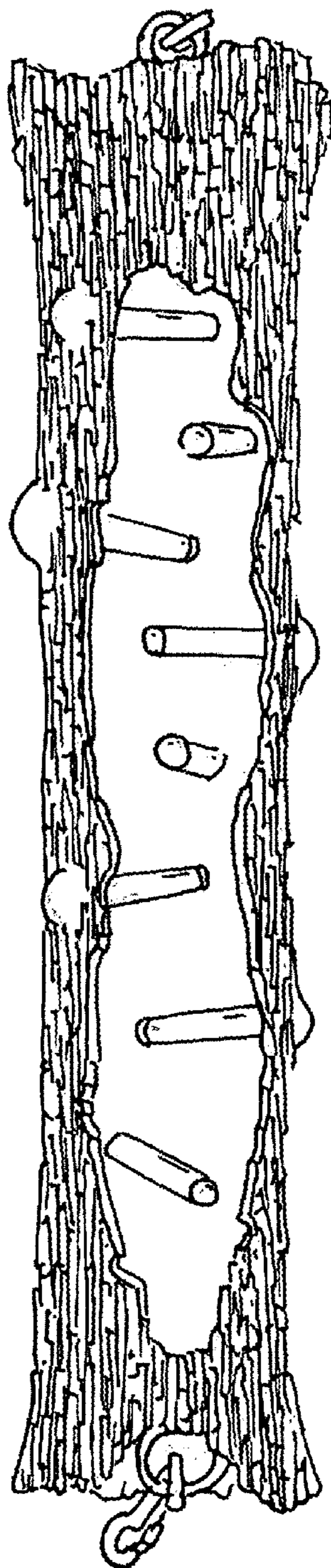

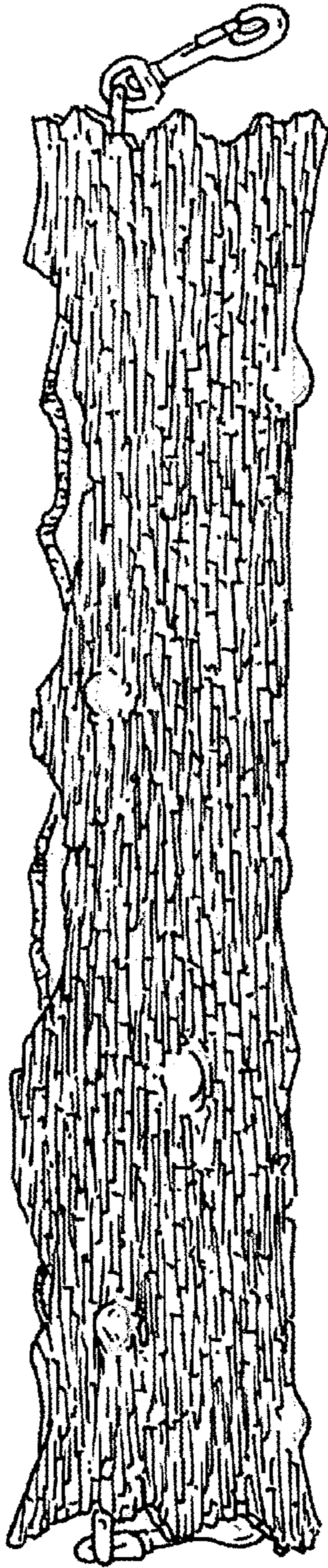

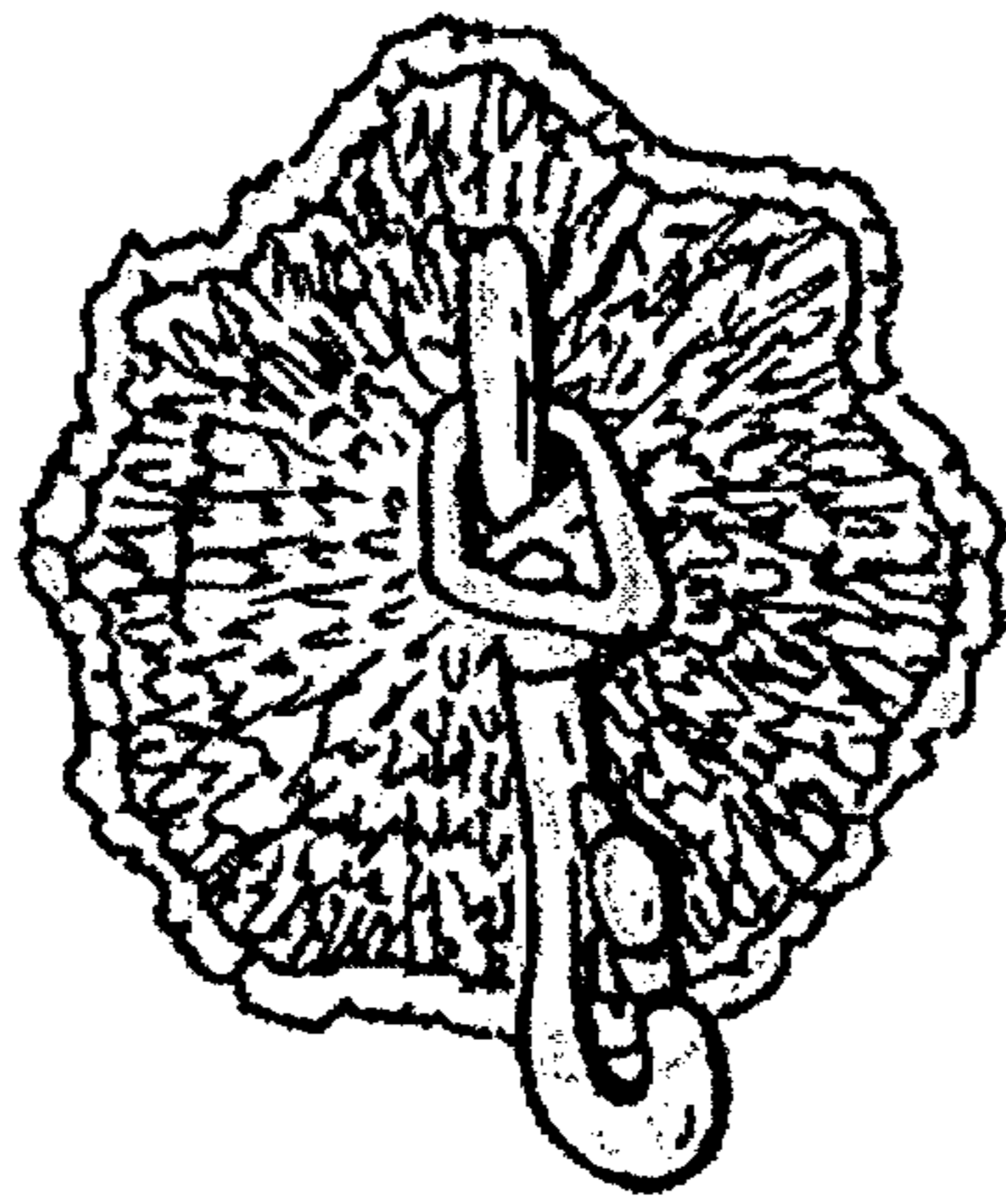

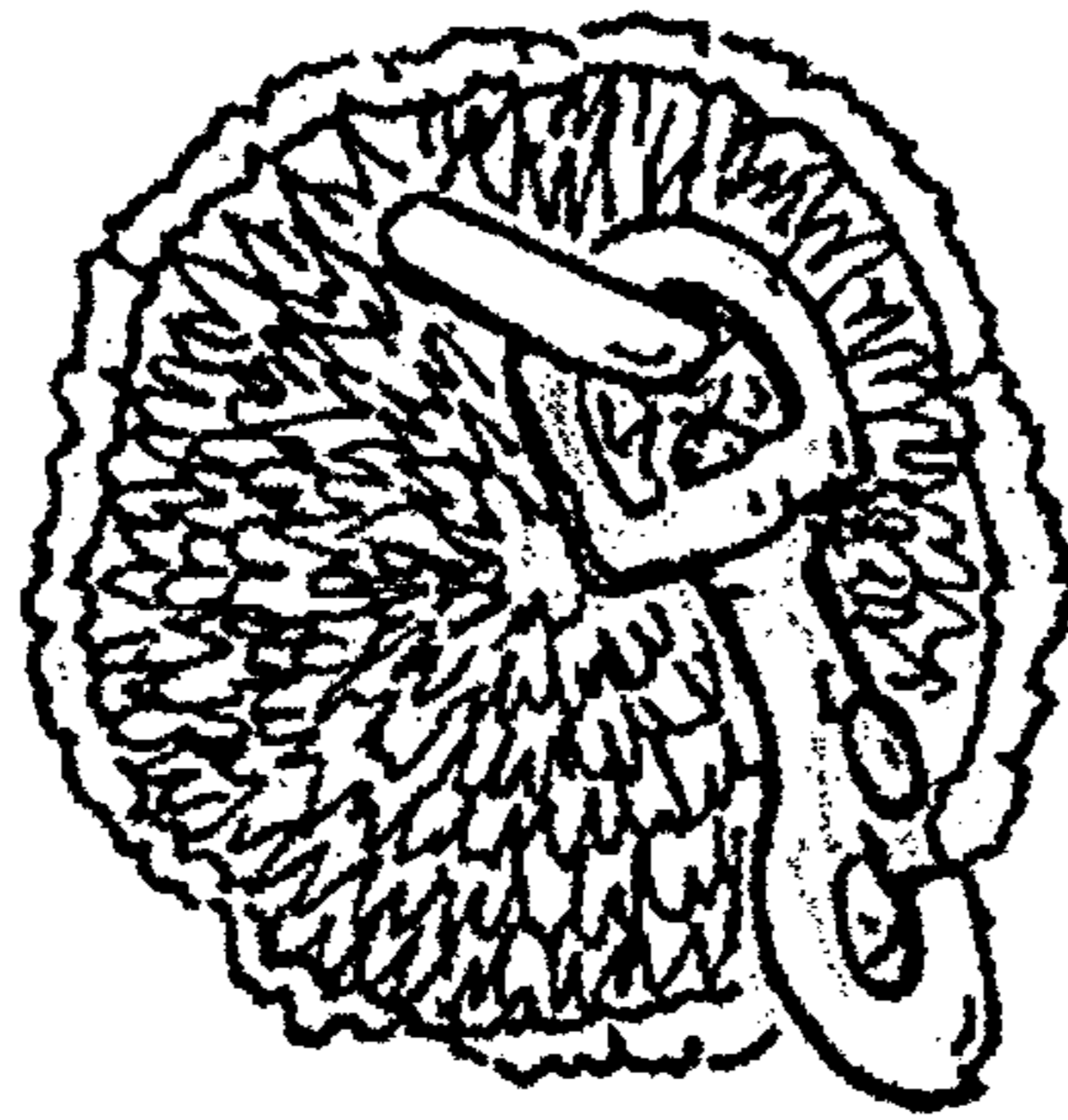
