(57) **CLAIM**

The ornamental design for a workbench, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side perspective view from above of a workbench;

FIG. 2 is a right side elevation view of the workbench seen in FIG. 1;

FIG. 3 is a left side elevation view of the workbench seen in FIG. 1;

FIG. 4 is a back elevation view of the workbench seen in FIG. 1;

FIG. 5 is a front elevation view of the workbench seen in FIG. 1;

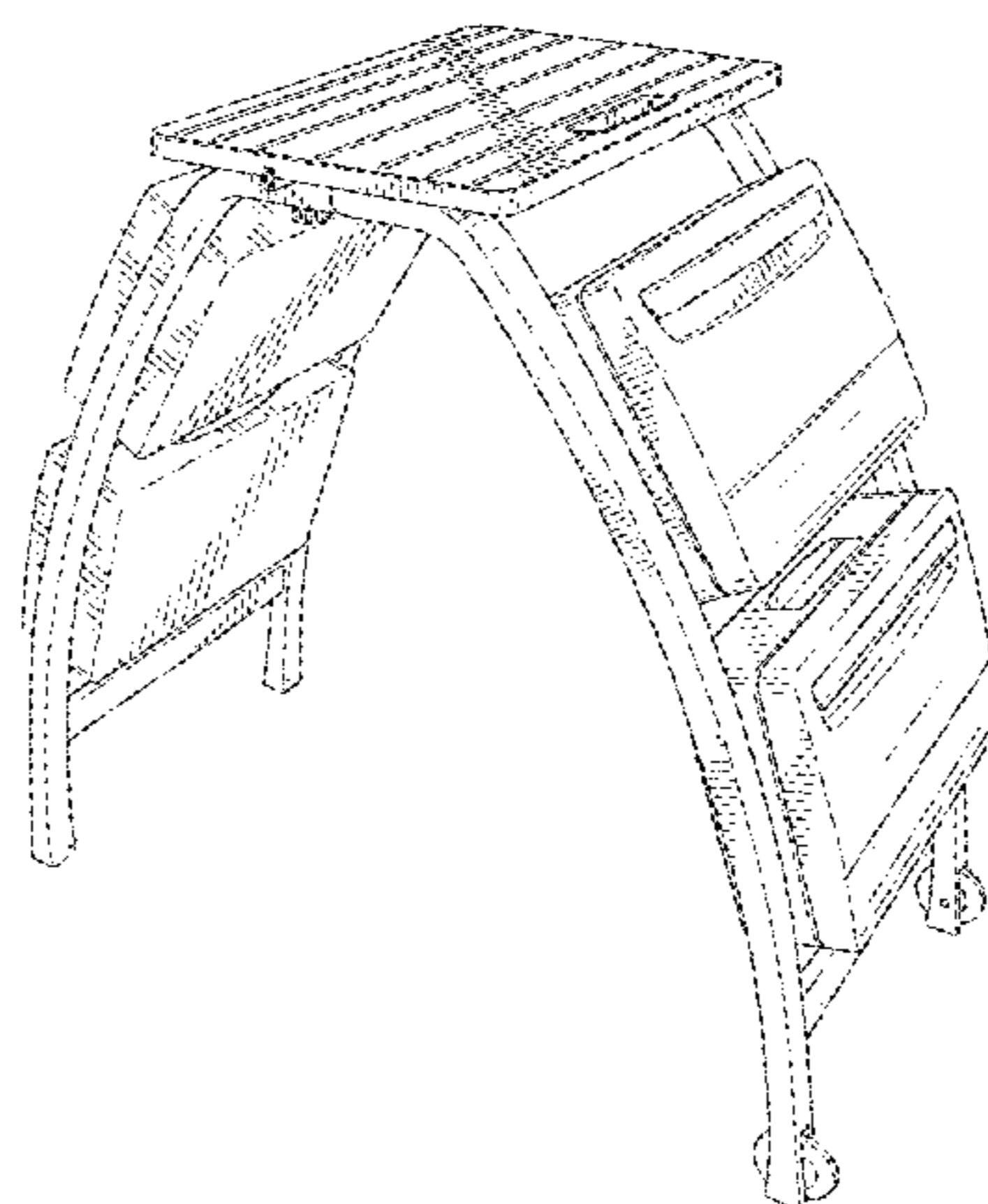
FIG. 6 is a top view of the workbench seen in FIG. 1; and,

FIG. 7 is a right side perspective view from above of the workbench seen in FIG. 1 with the top door panels open, the left side perspective view being substantially a mirror image except the rotary clamp is omitted.

A bottom plan view is not shown as it forms no part of the claimed ornamental design.

The broken lines shown in FIG. 7 illustrate portions of the workbench that form no part of the claimed design.

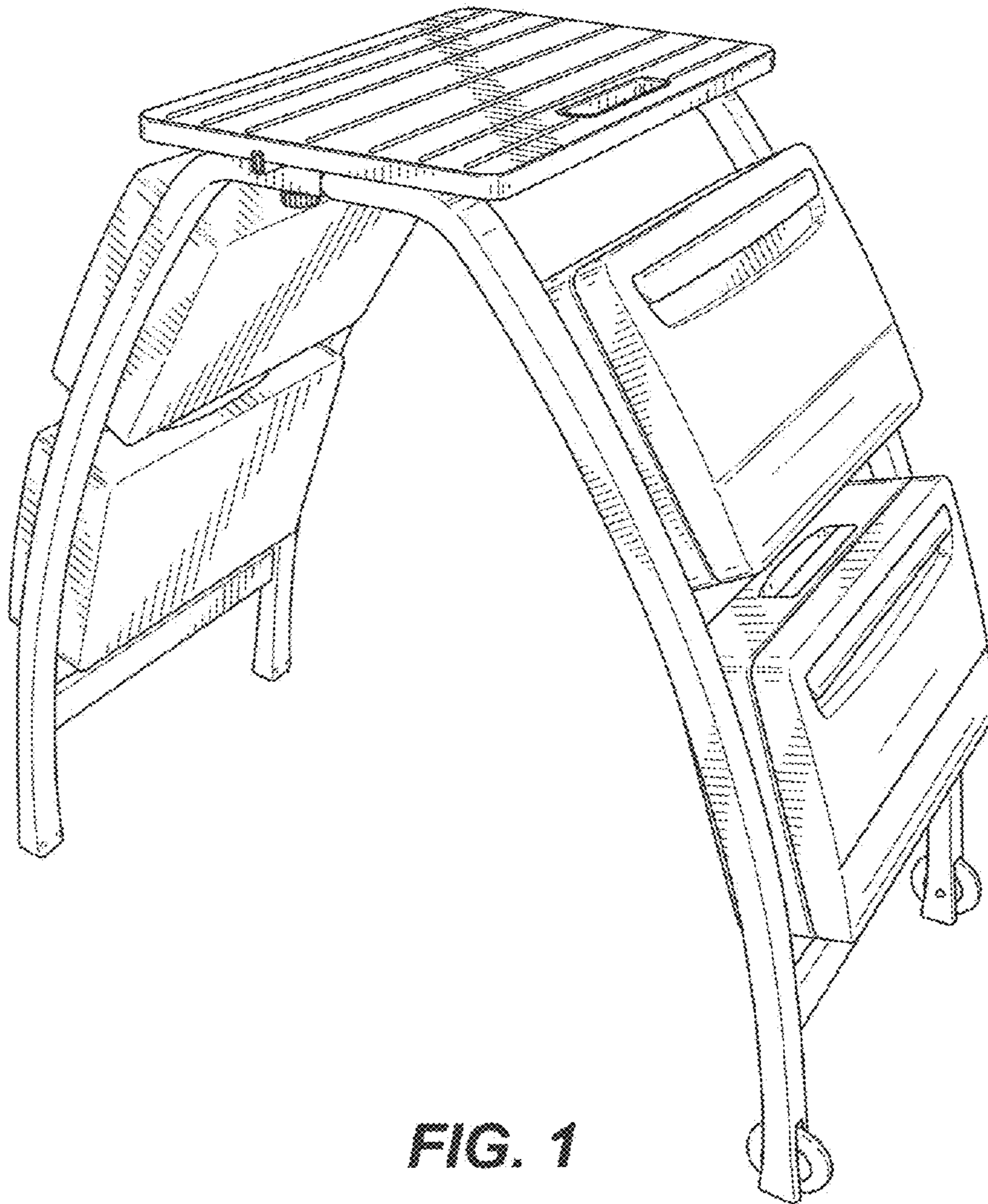

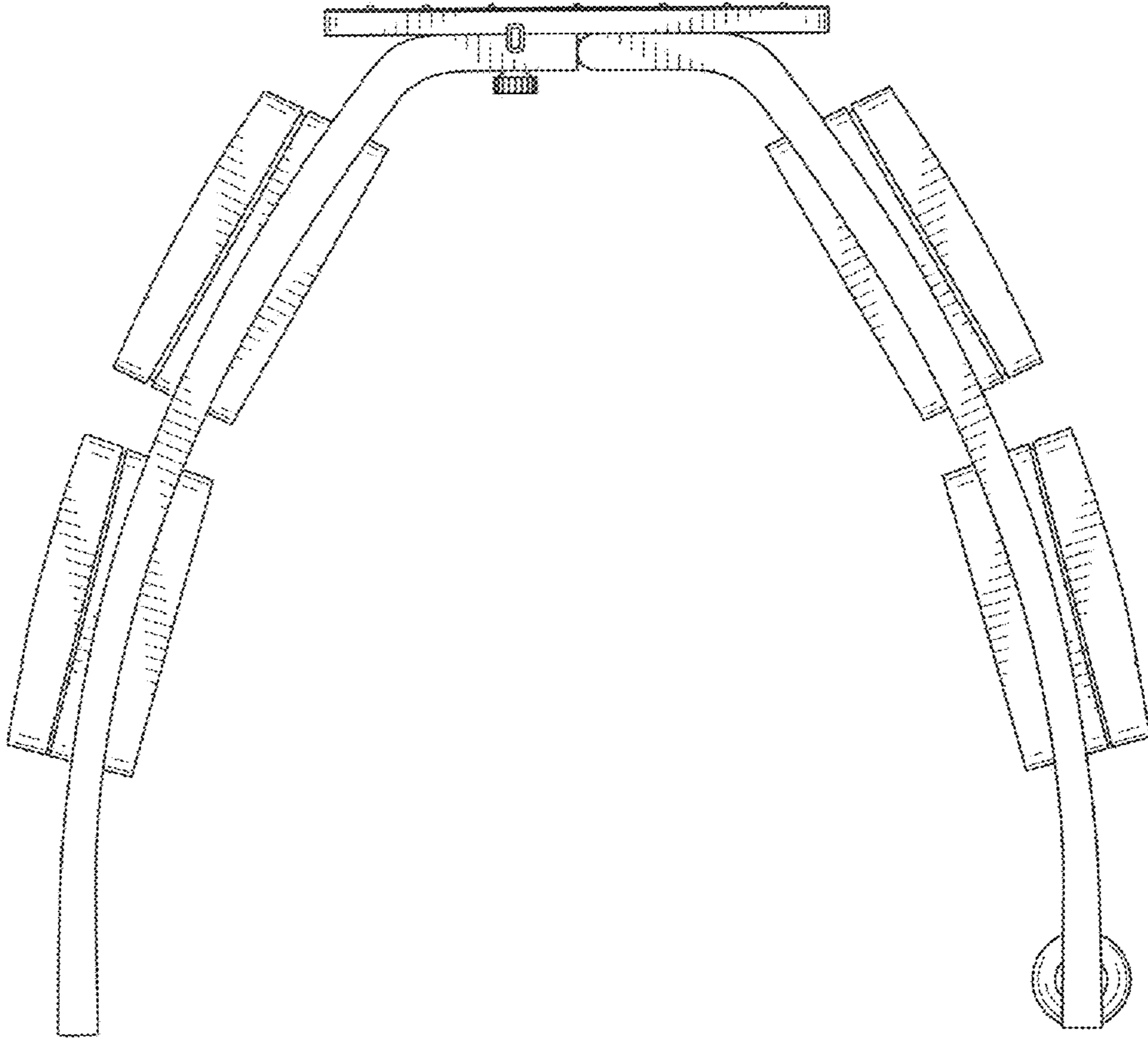

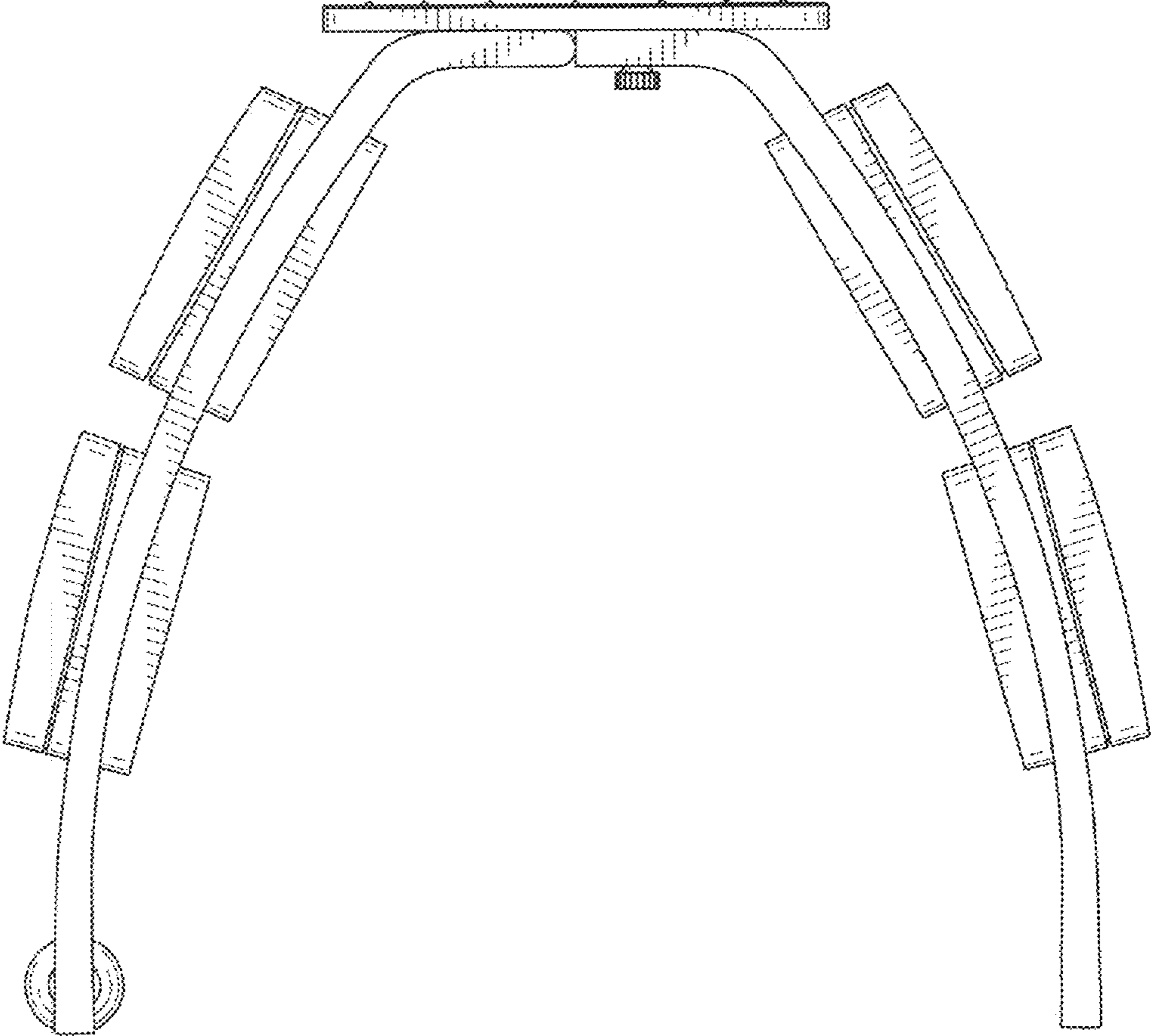

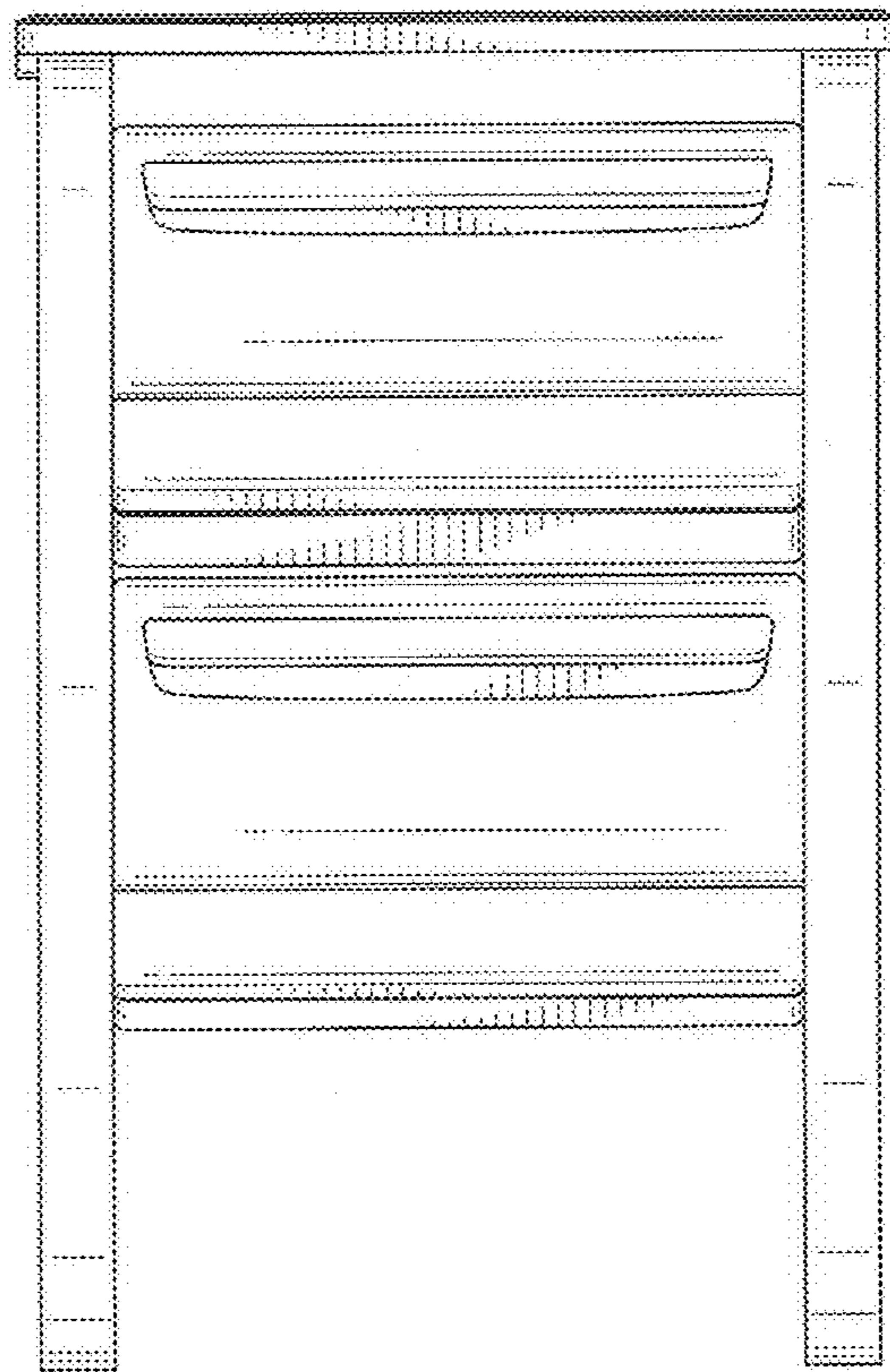

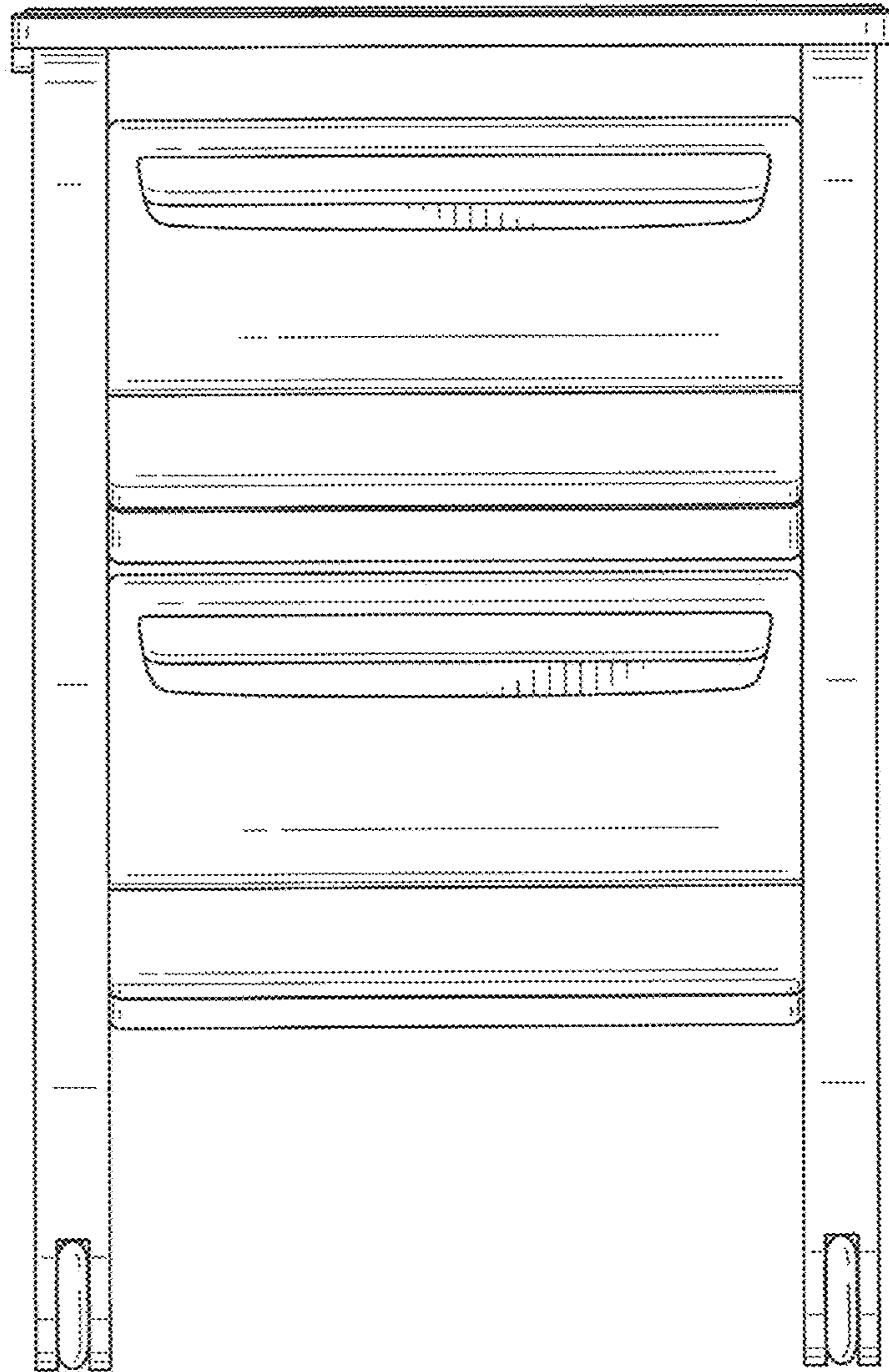

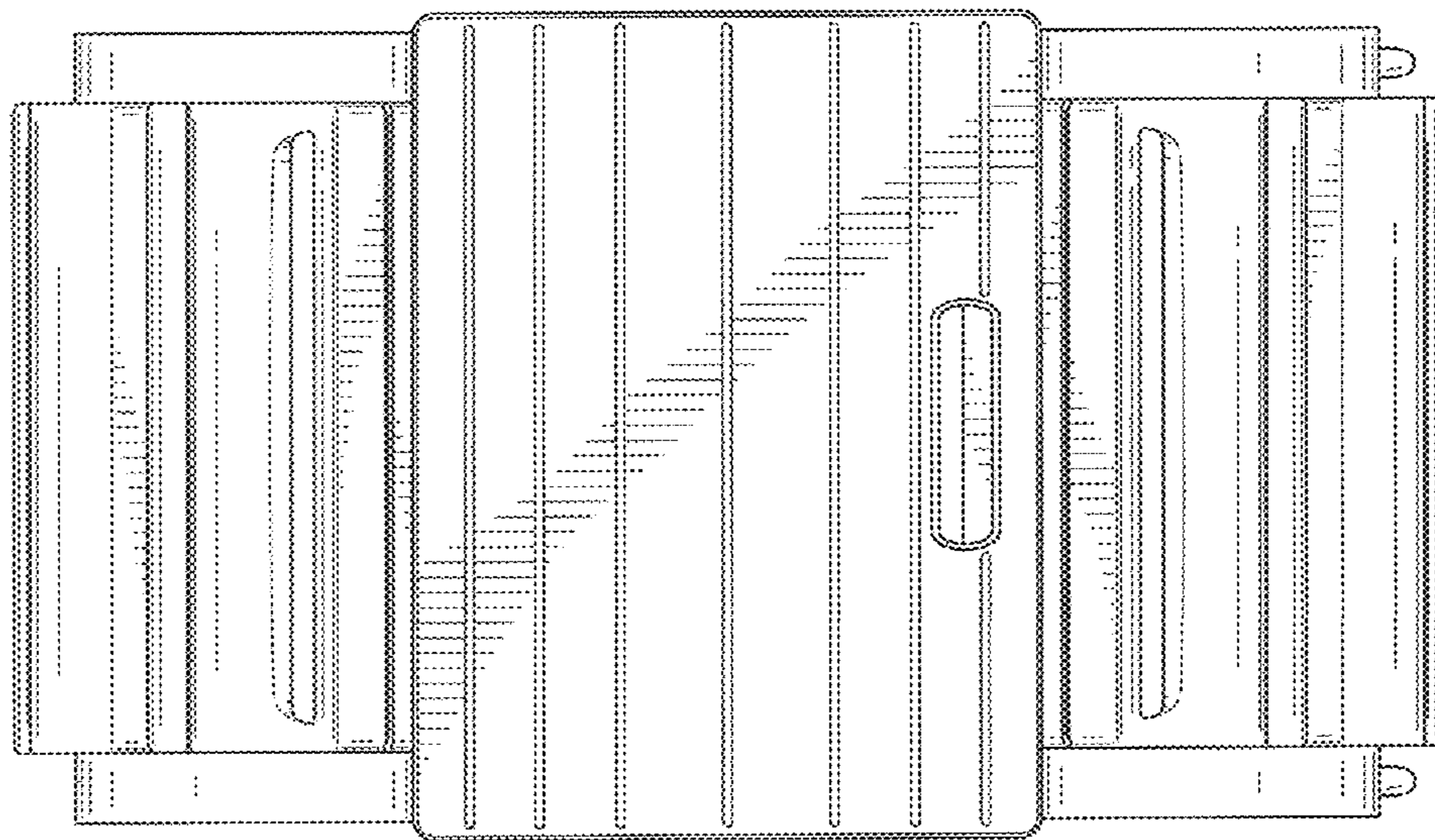

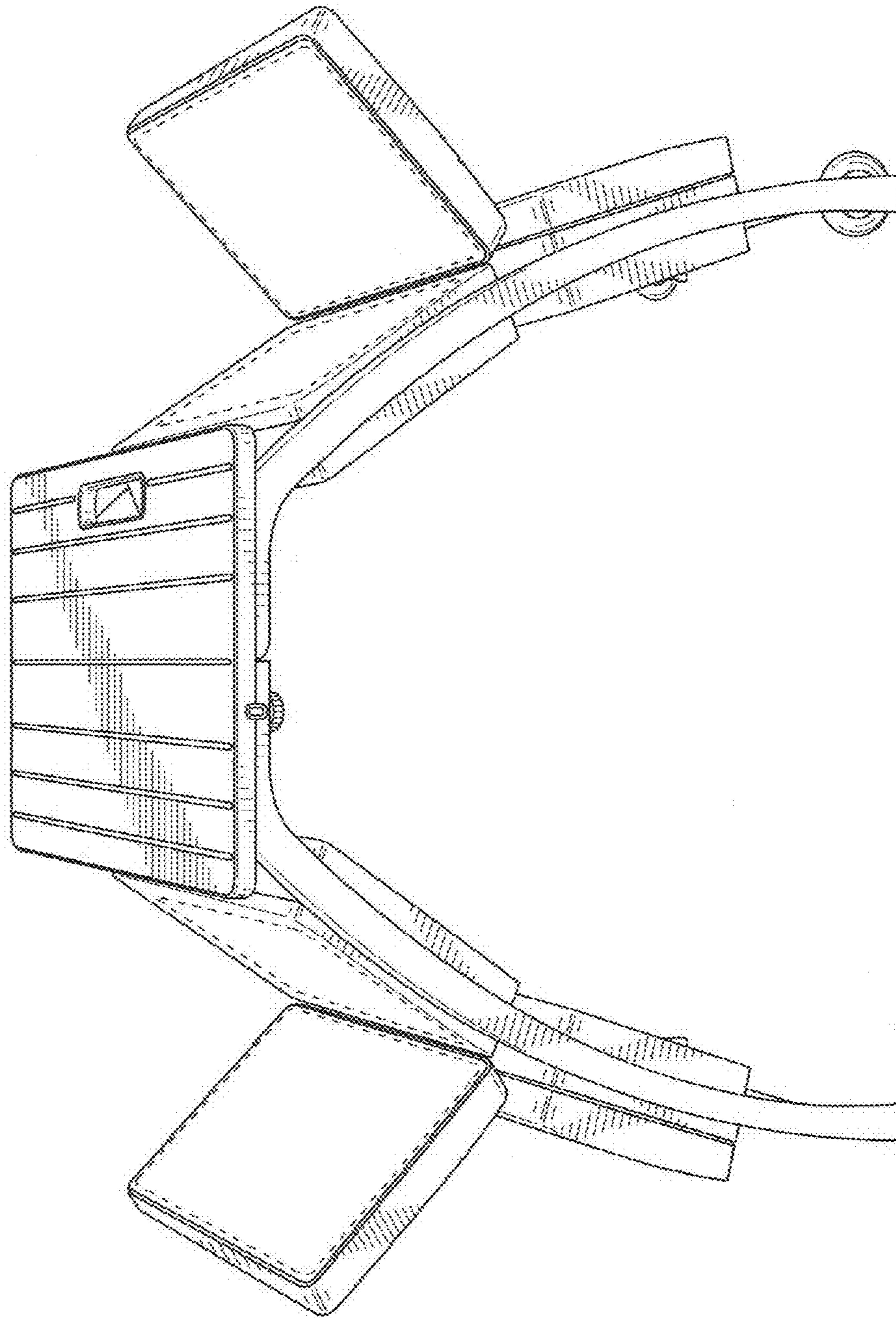
