(57) **CLAIM**

The ornamental design for a specialty tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the specialty tool of my new design.

FIG. 2. is a perspective view thereof showing the stud portion of it projecting through a hole in the finger of a glove.

FIG. 3 is an elevational view of the front thereof.

FIG. 4 is an elevational view of the rear thereof.

FIG. 5 is an elevational view of the left side thereof.

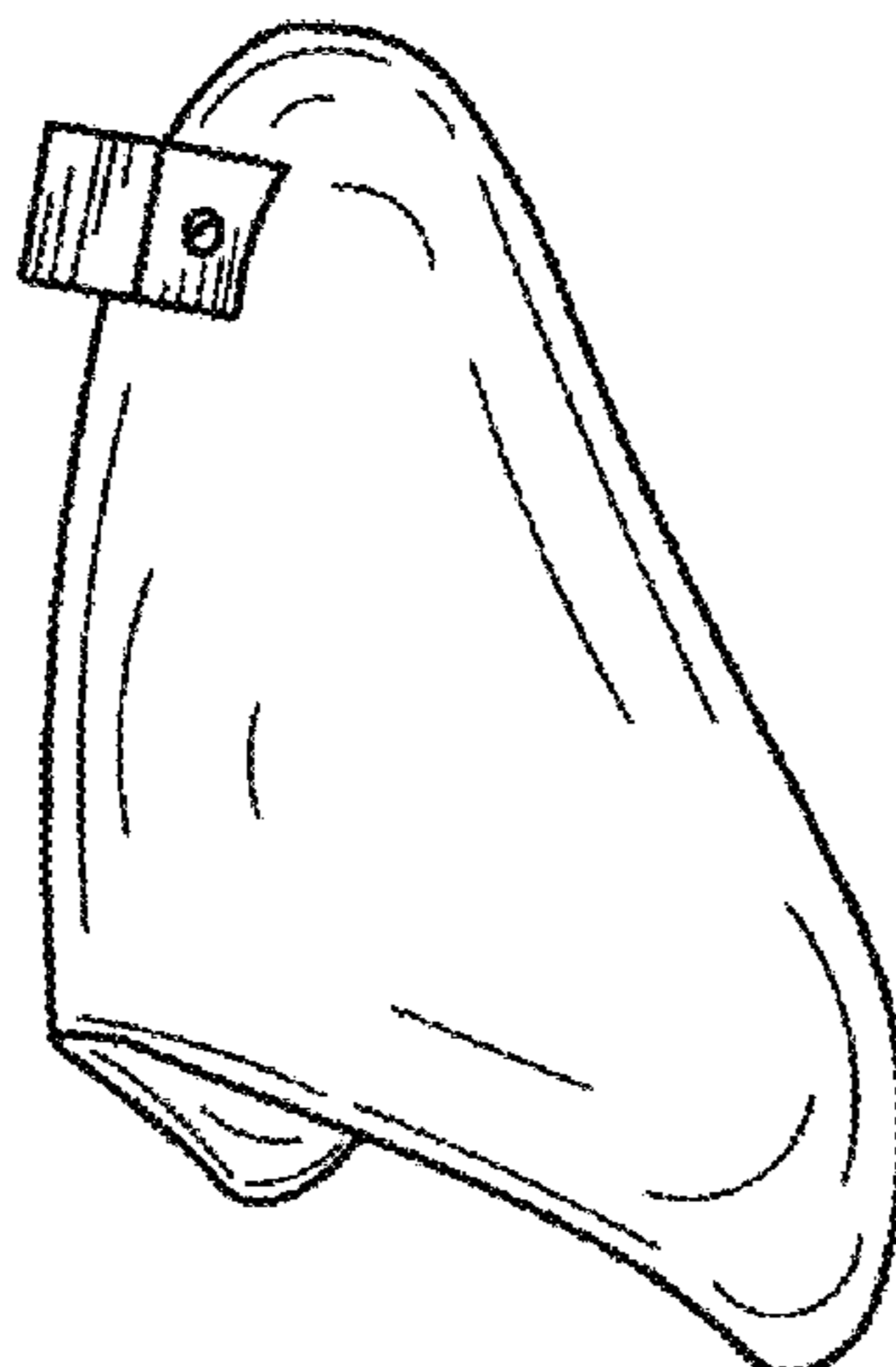
FIG. 6 is an elevational view of the right side thereof.

FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

The broken line figure in FIG. 2, outlining a glove, with the stud portion of the specialty tool of my new design projecting through the distal end of the finger of the glove, forms no part of my new design.

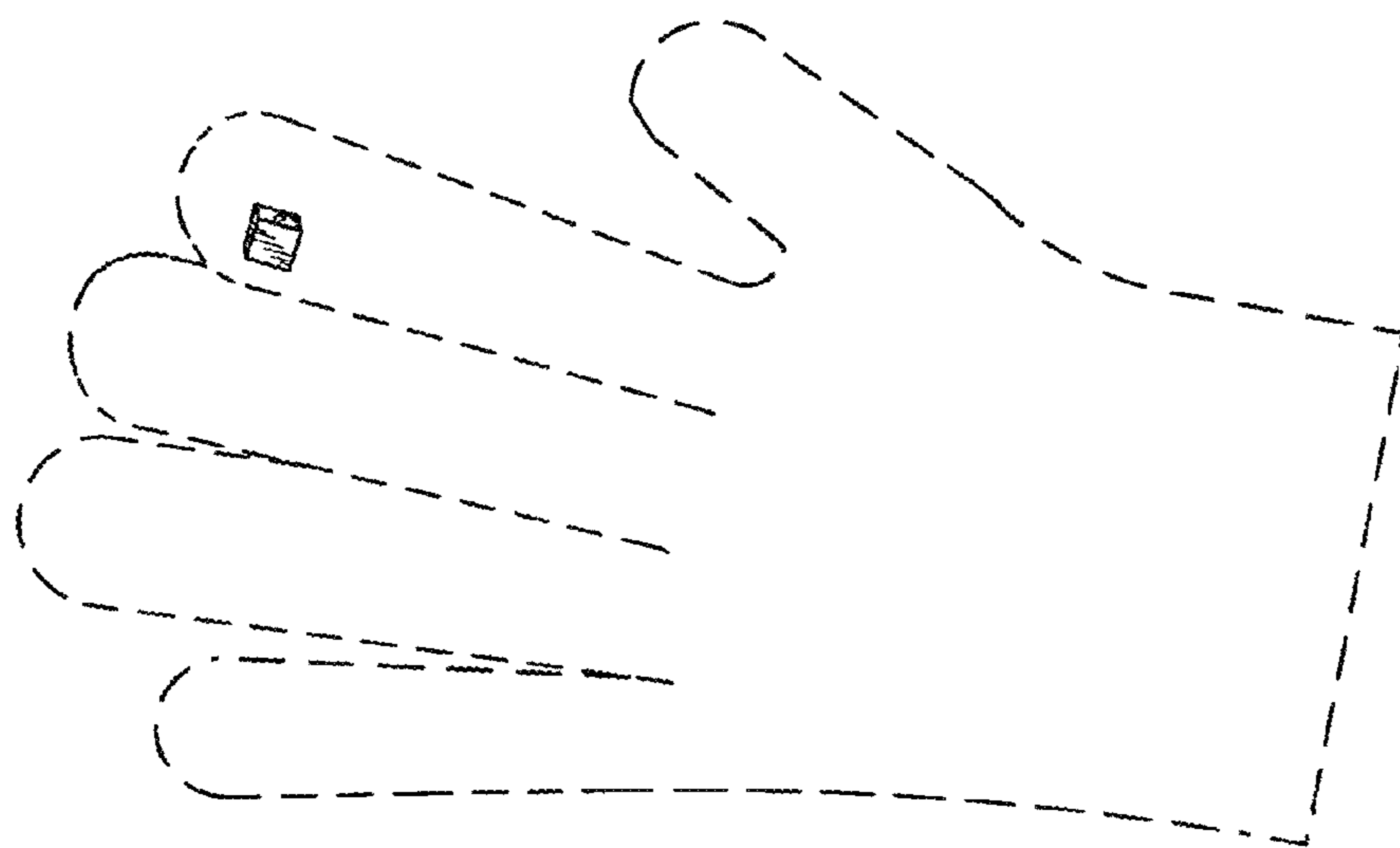

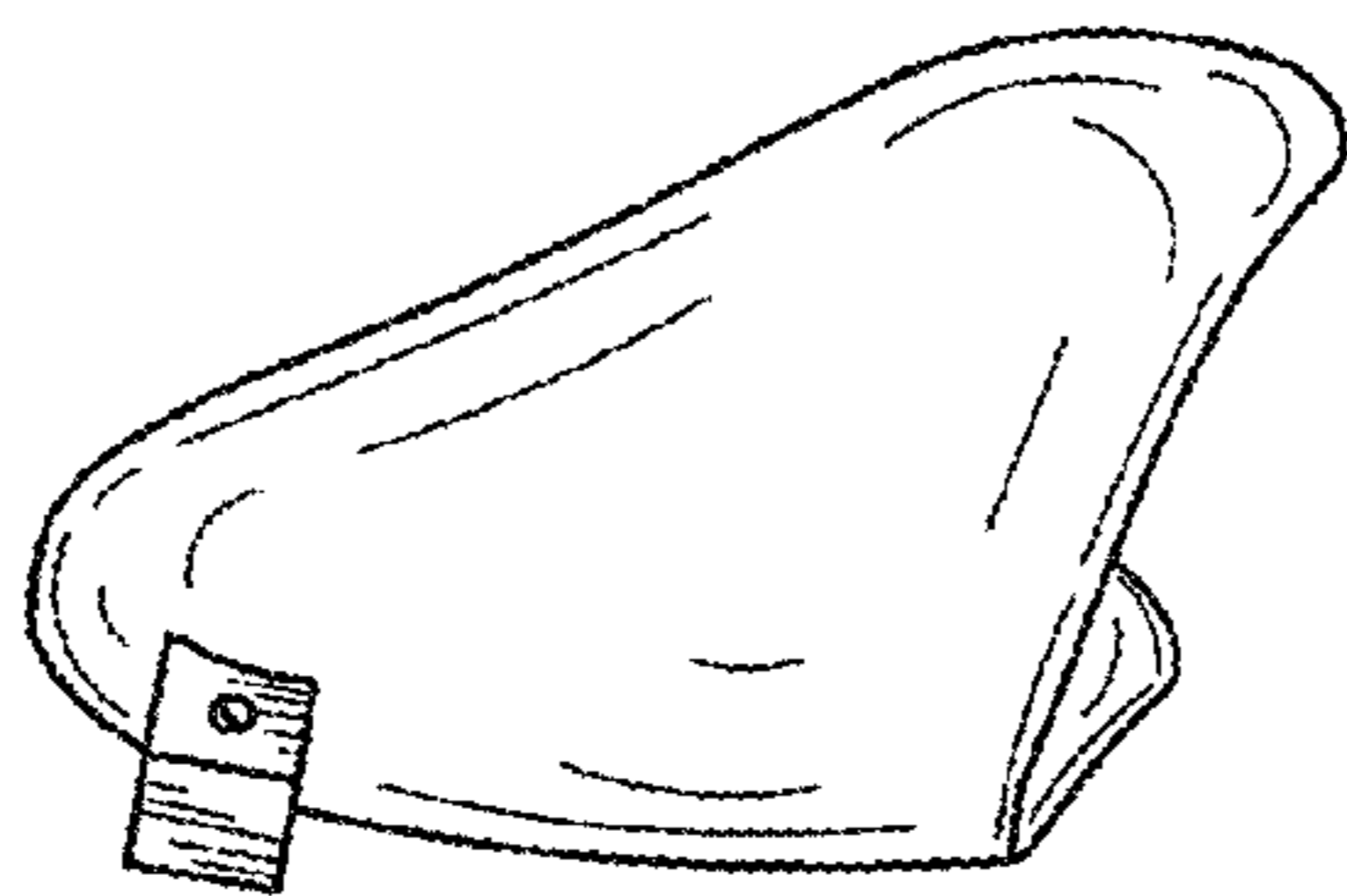

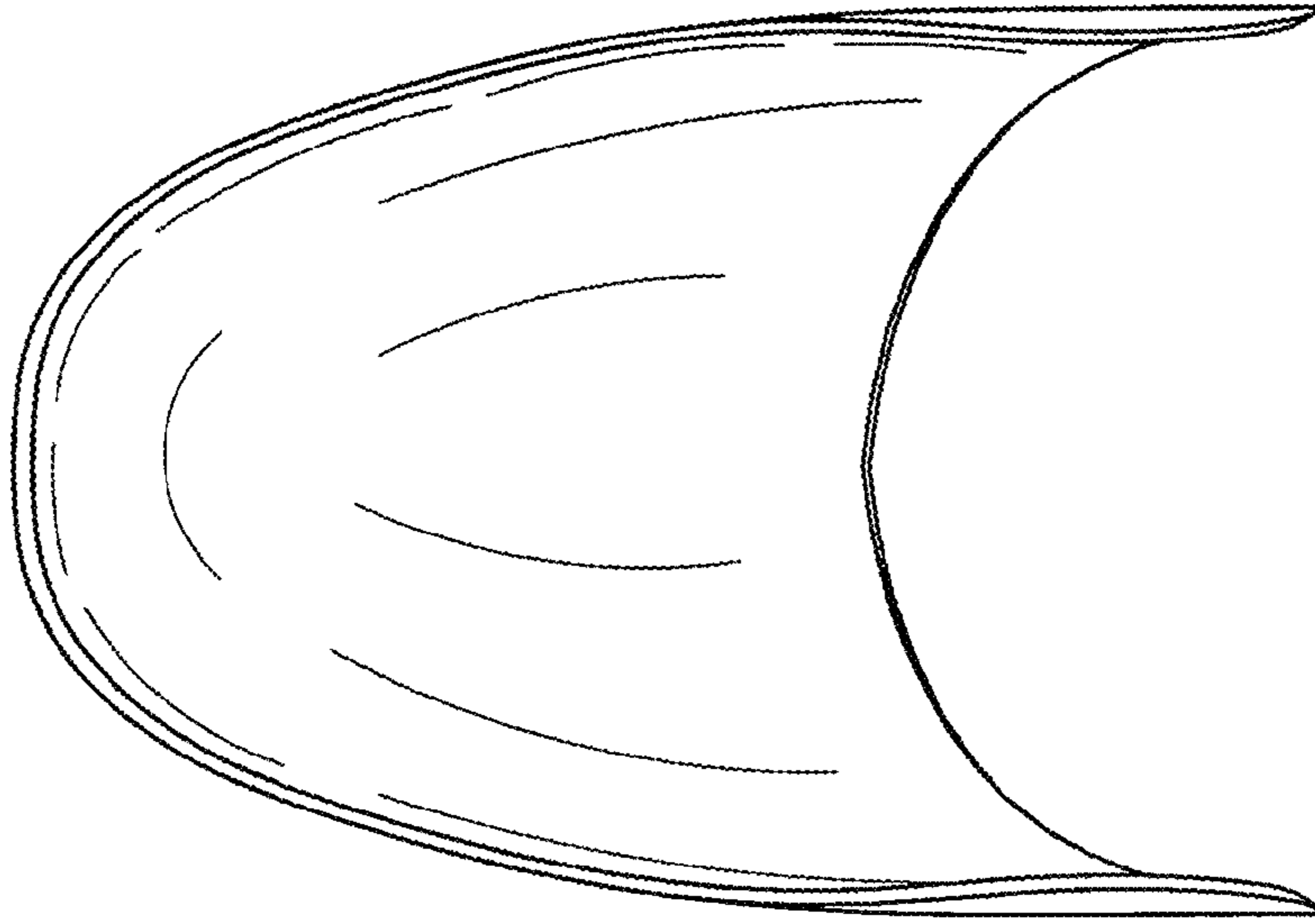

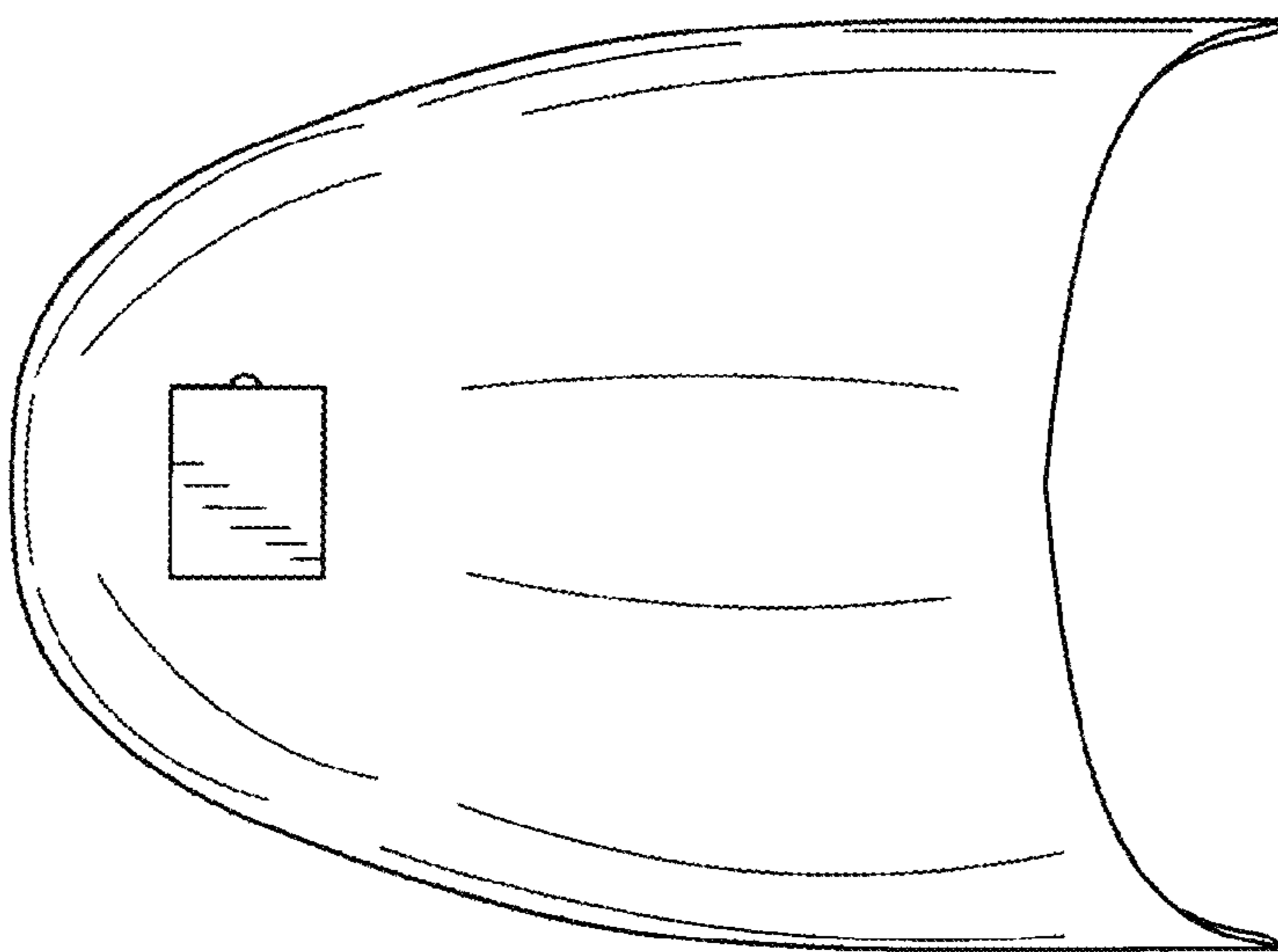

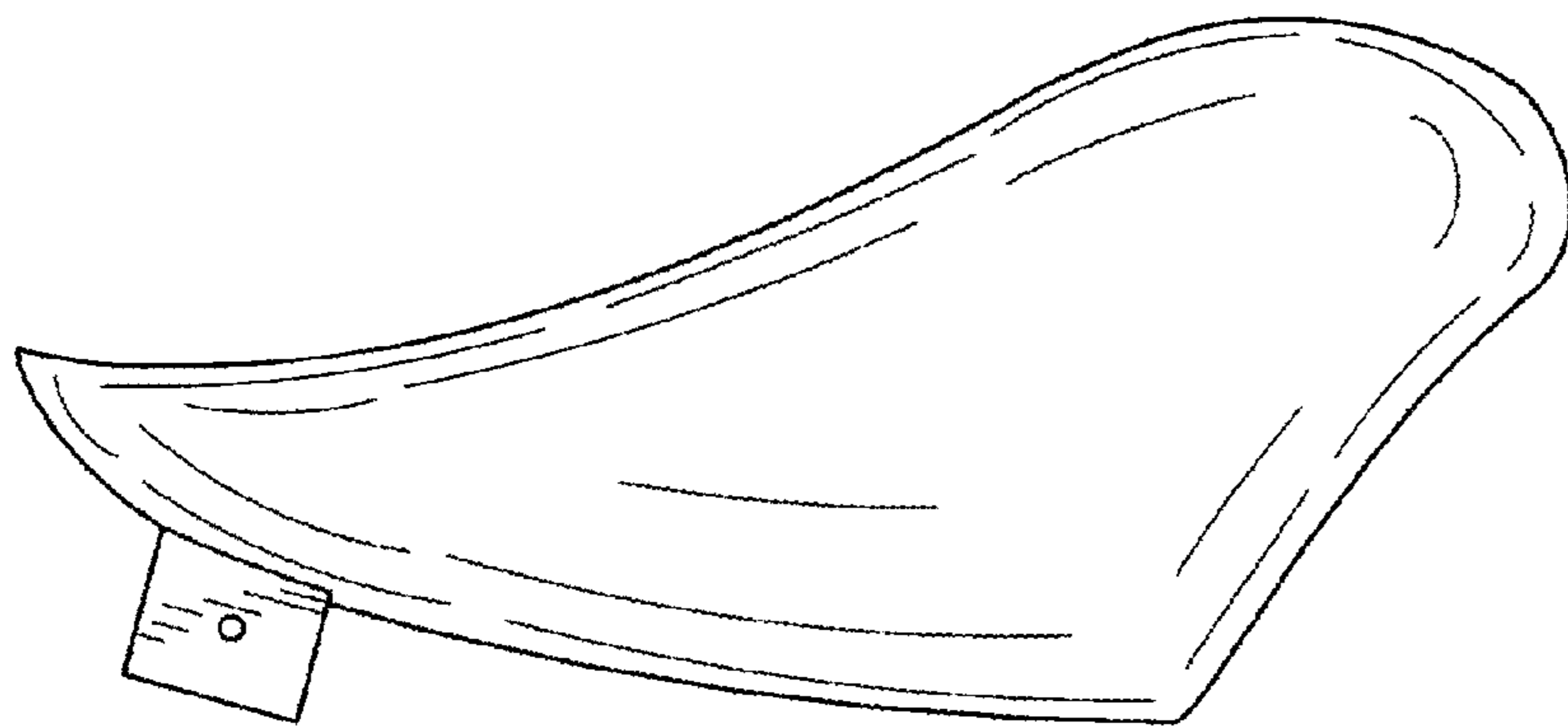

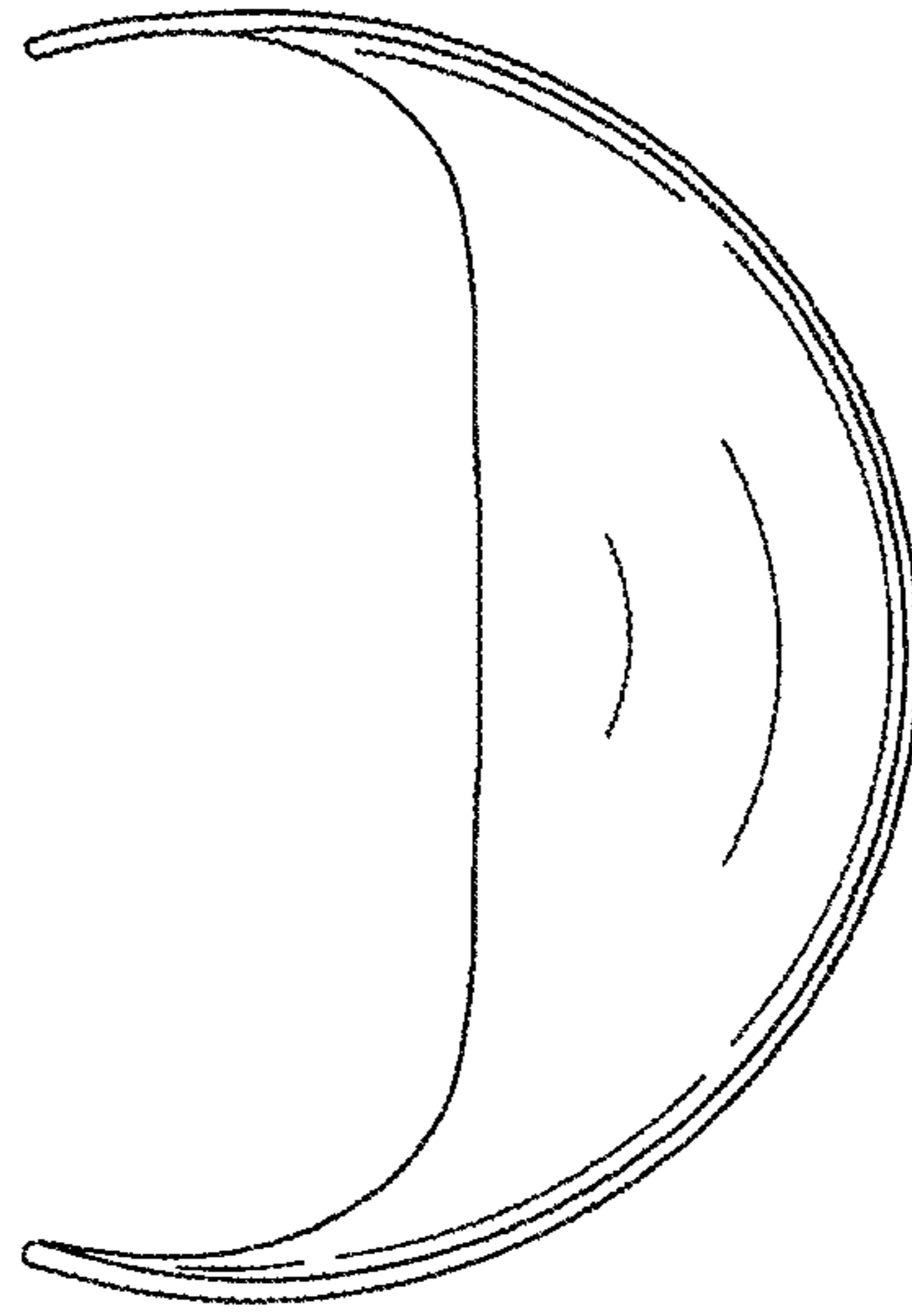

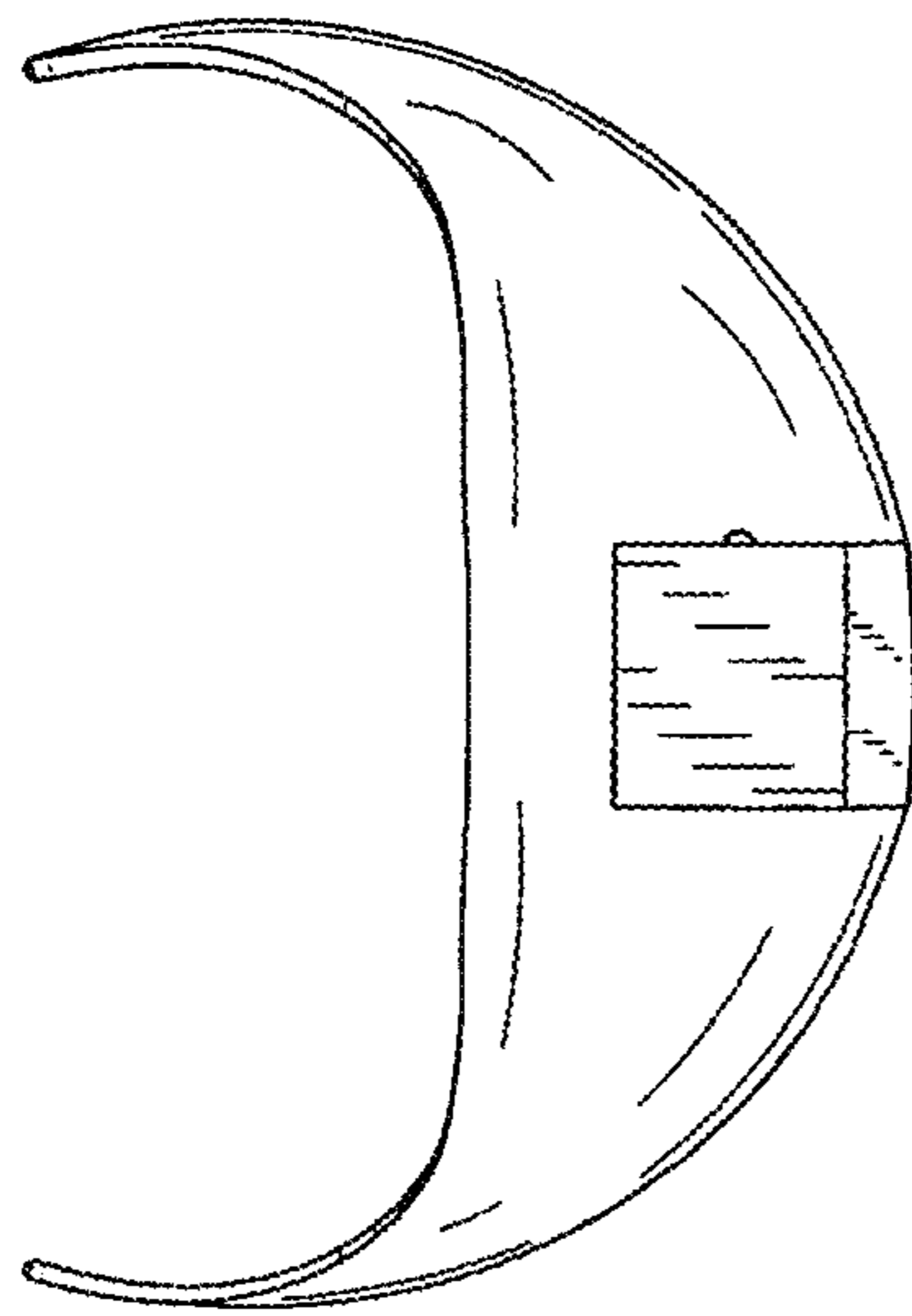
