DESCRIPTION

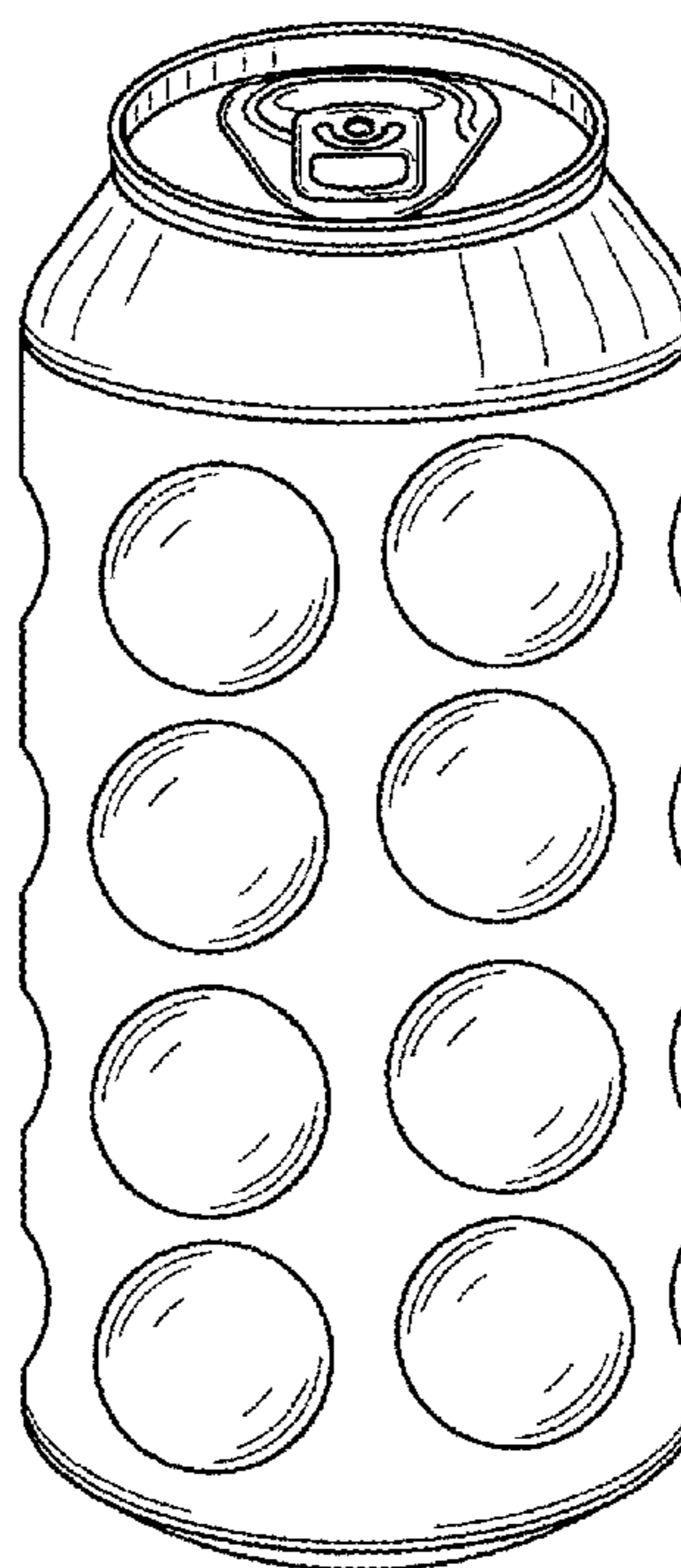
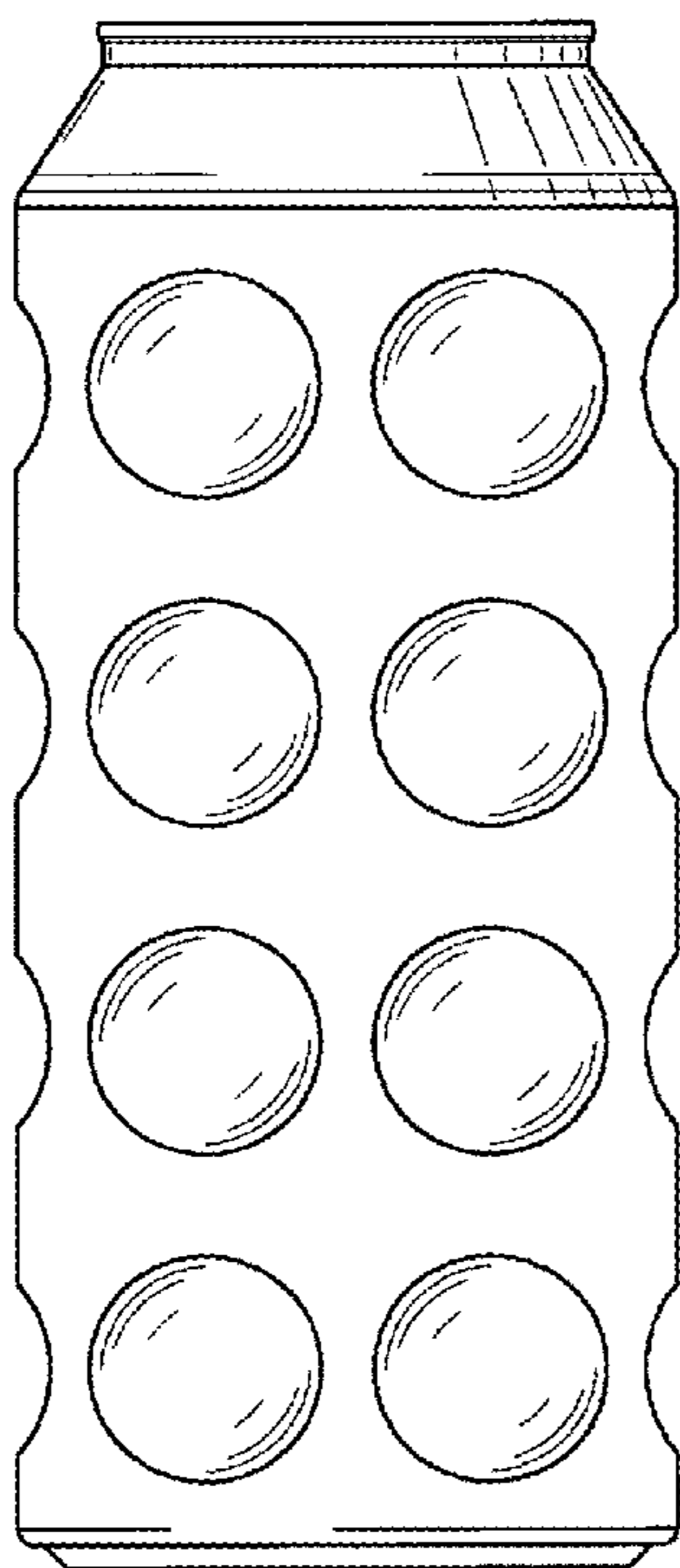
FIG. 1 is a front elevation view of a beverage can showing new design, the rear left and right elevational views being identical thereto;

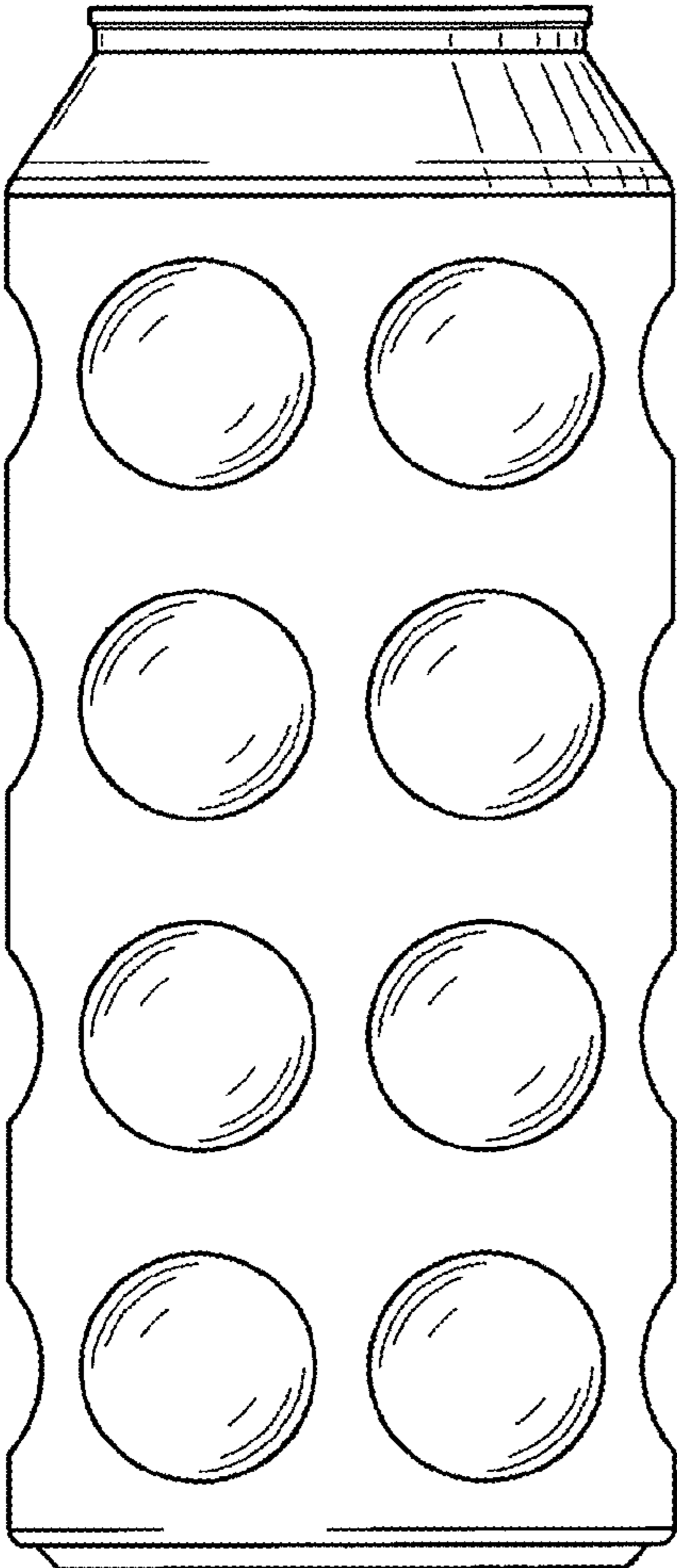

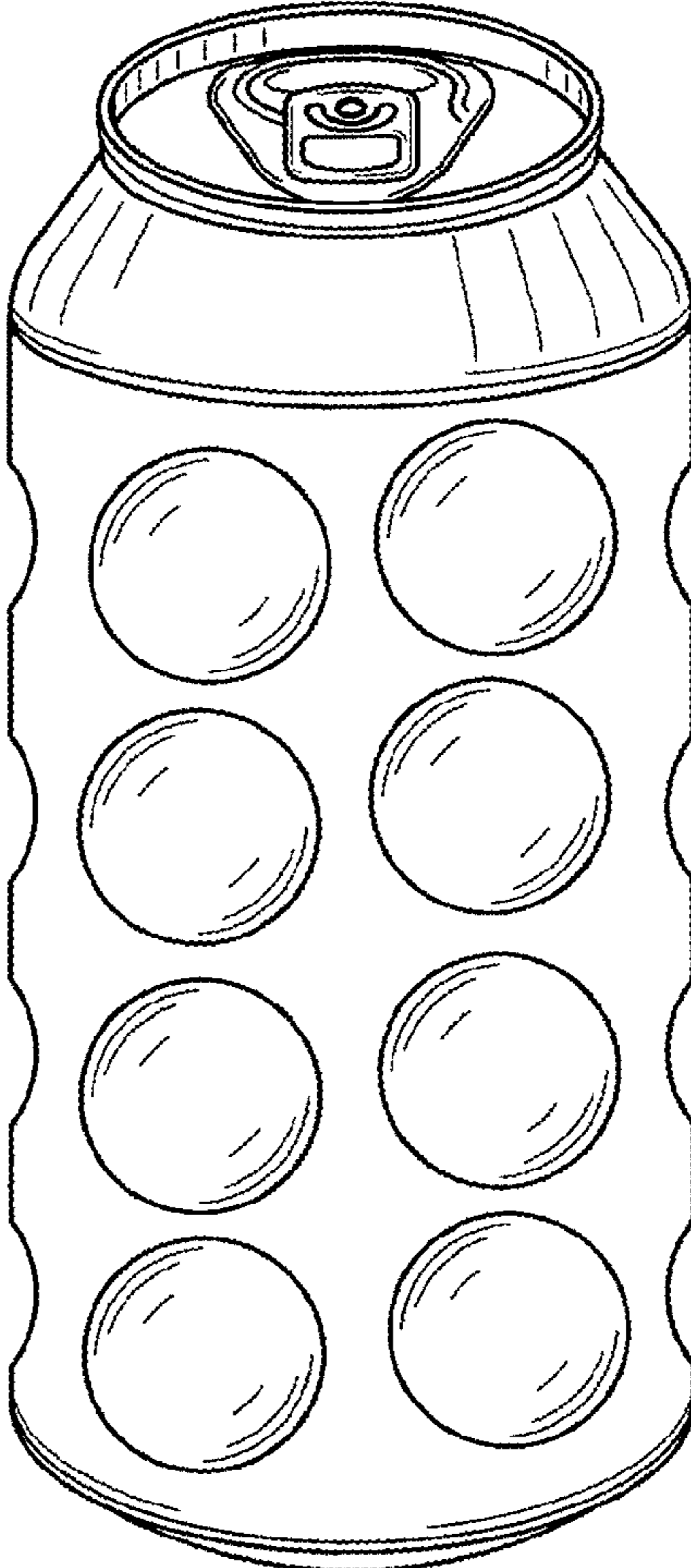

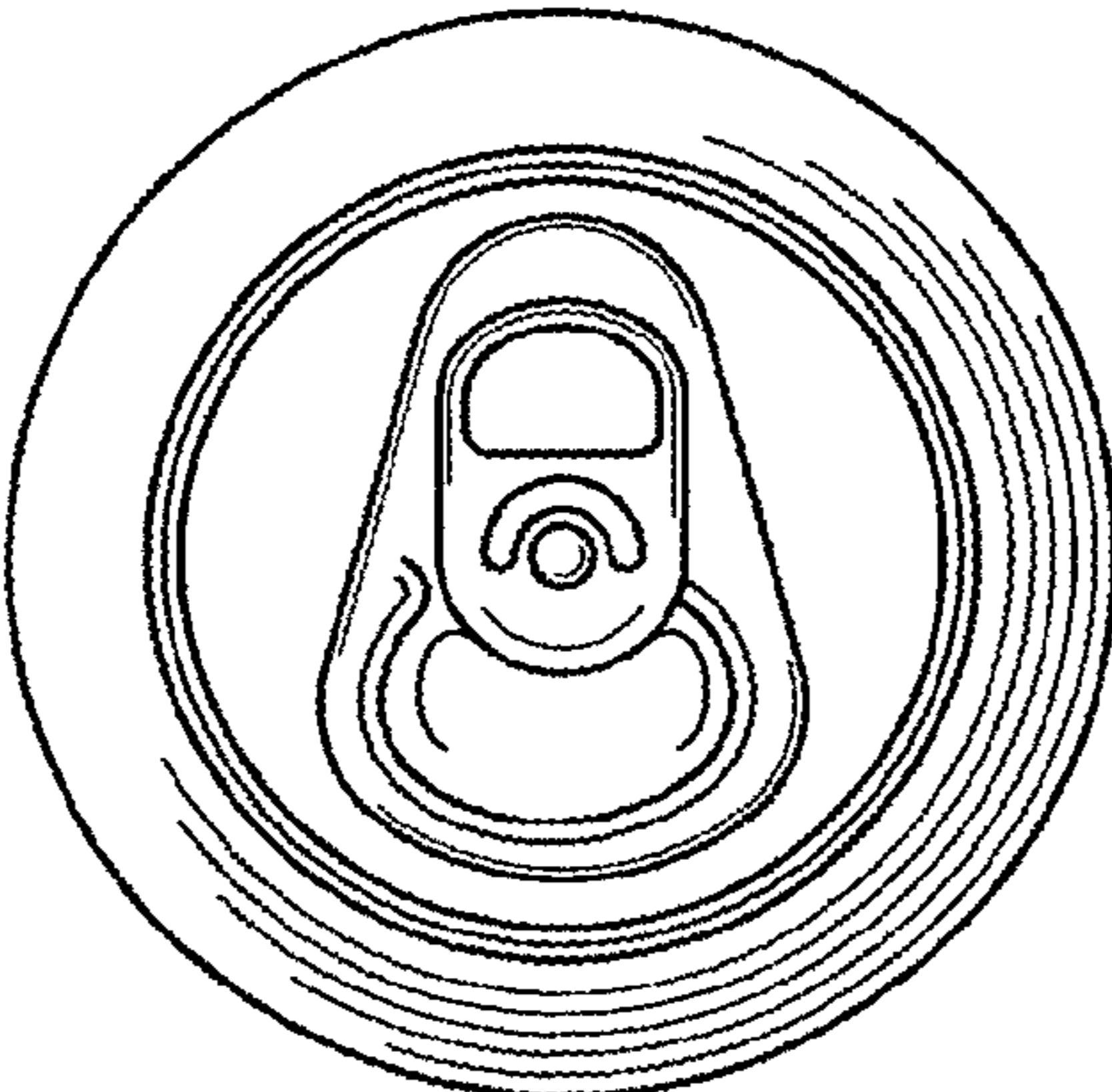
