The ornamental design for a front bumper cover for automobiles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front bumper cover for automobiles according to the present invention.

FIG. 2 is a front view of the front bumper cover for automobiles of FIG. 1.

FIG. 3 is a rear view of the front bumper cover for automobiles of FIG. 1.

FIG. 4 is a left side view of the front bumper cover for automobiles of FIG. 1.

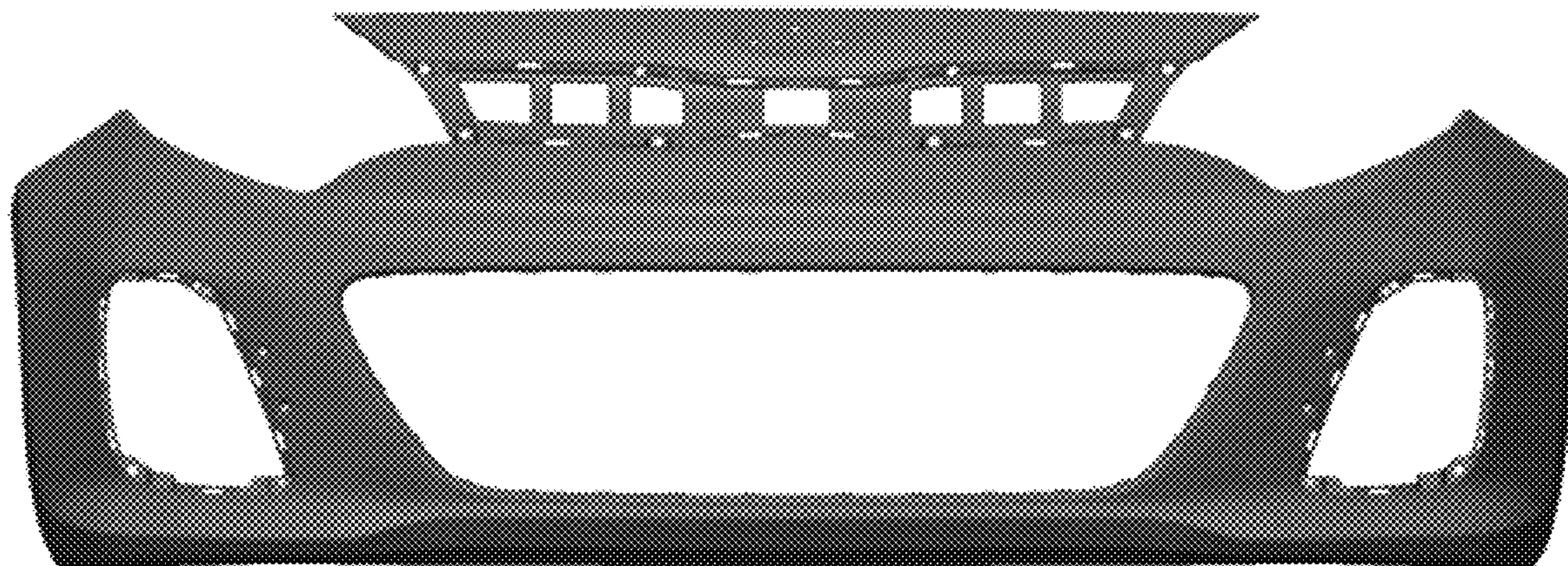

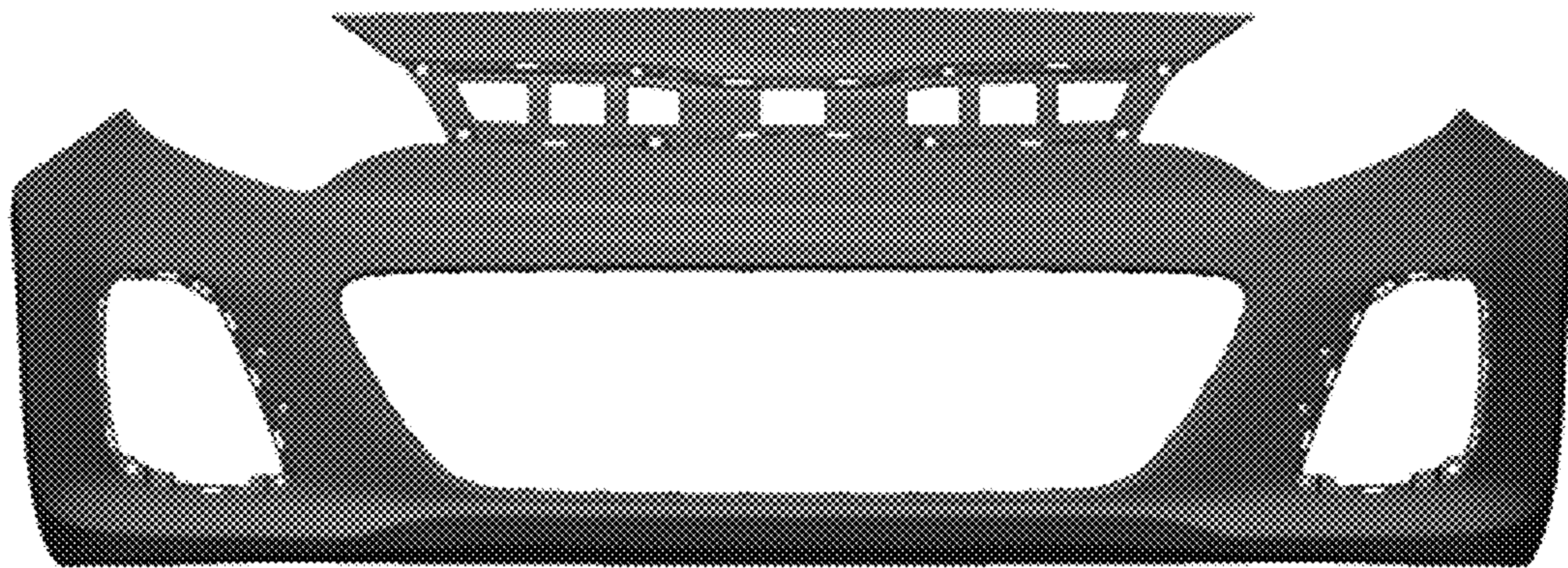

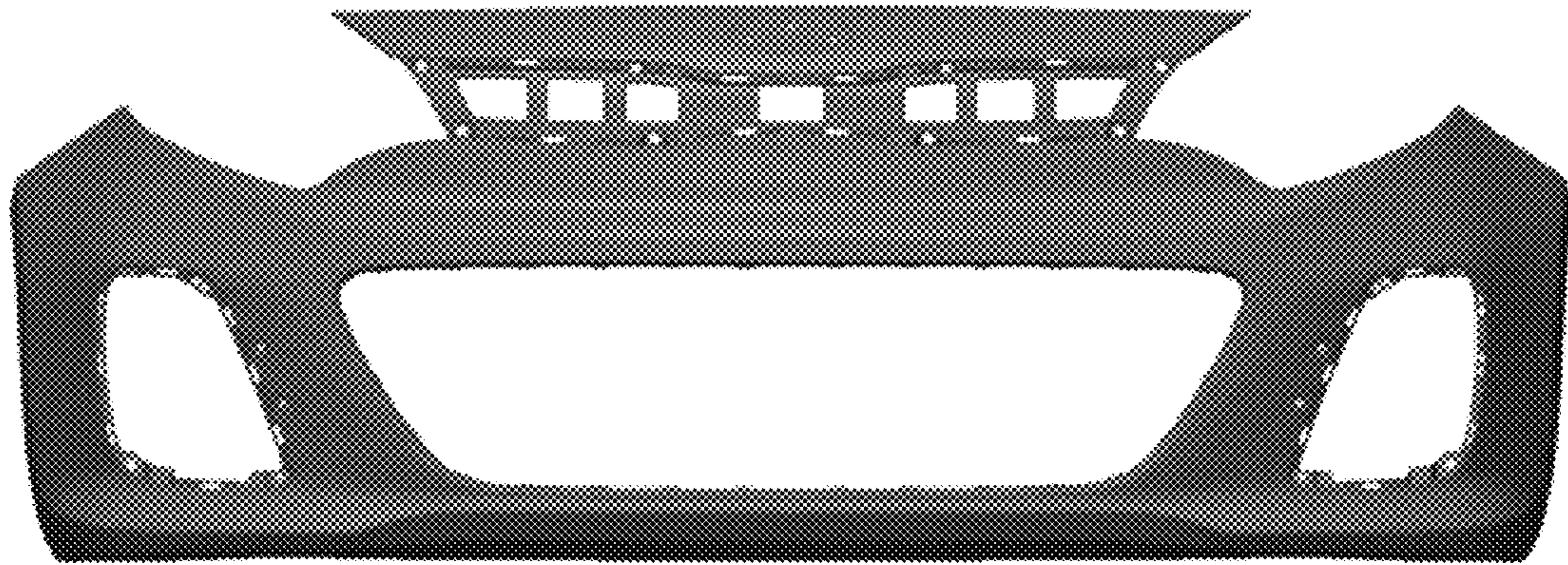

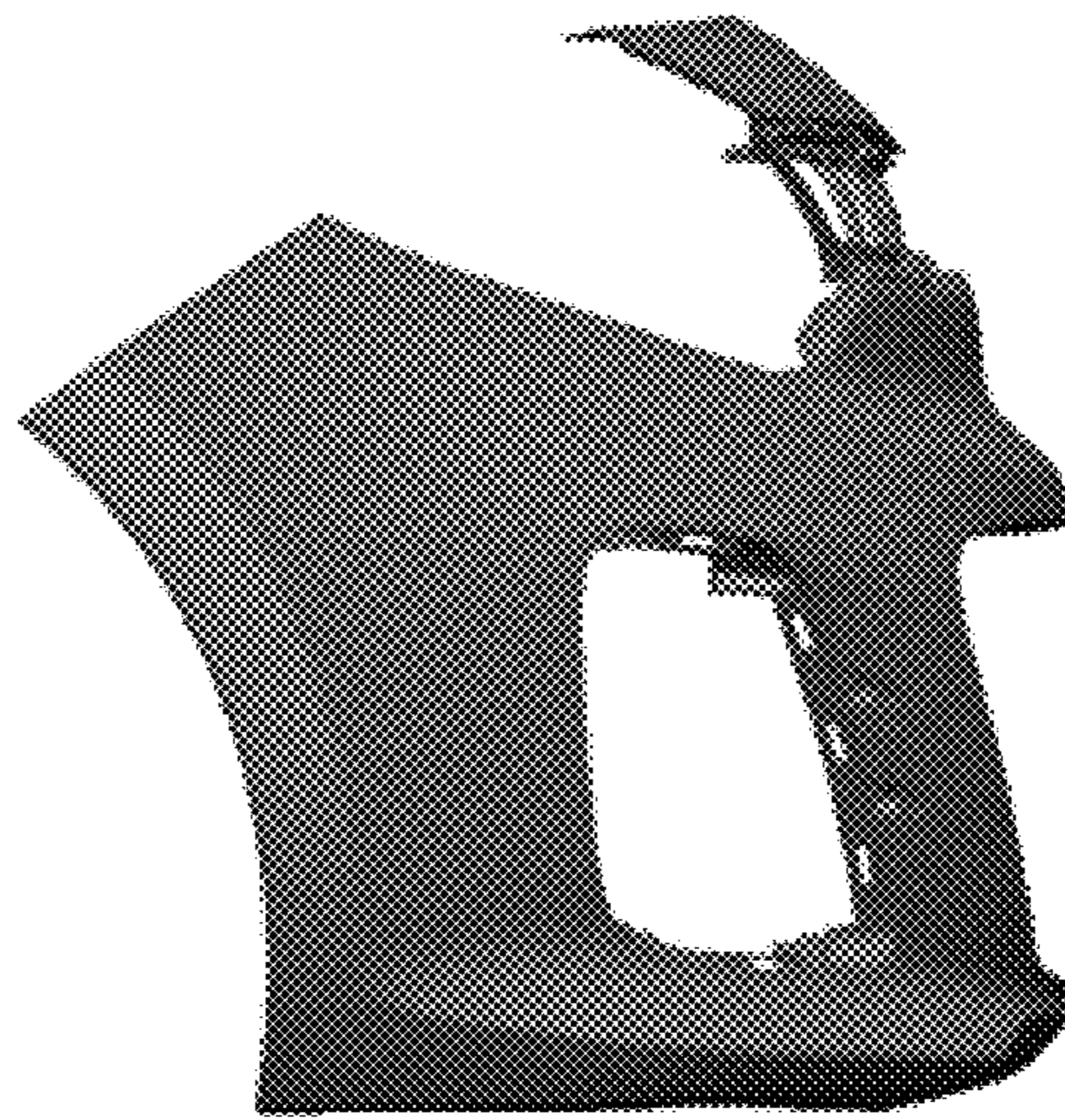

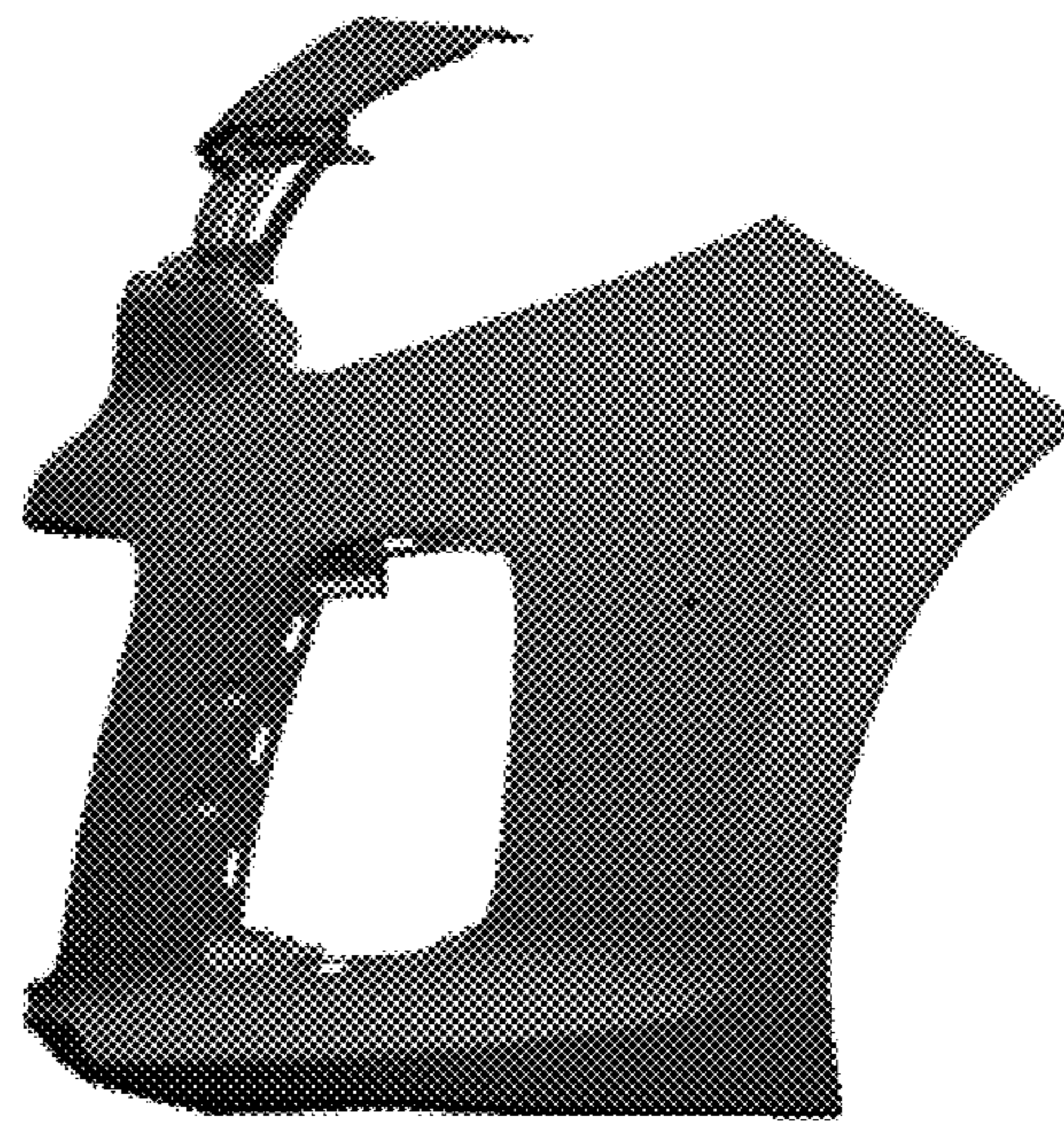

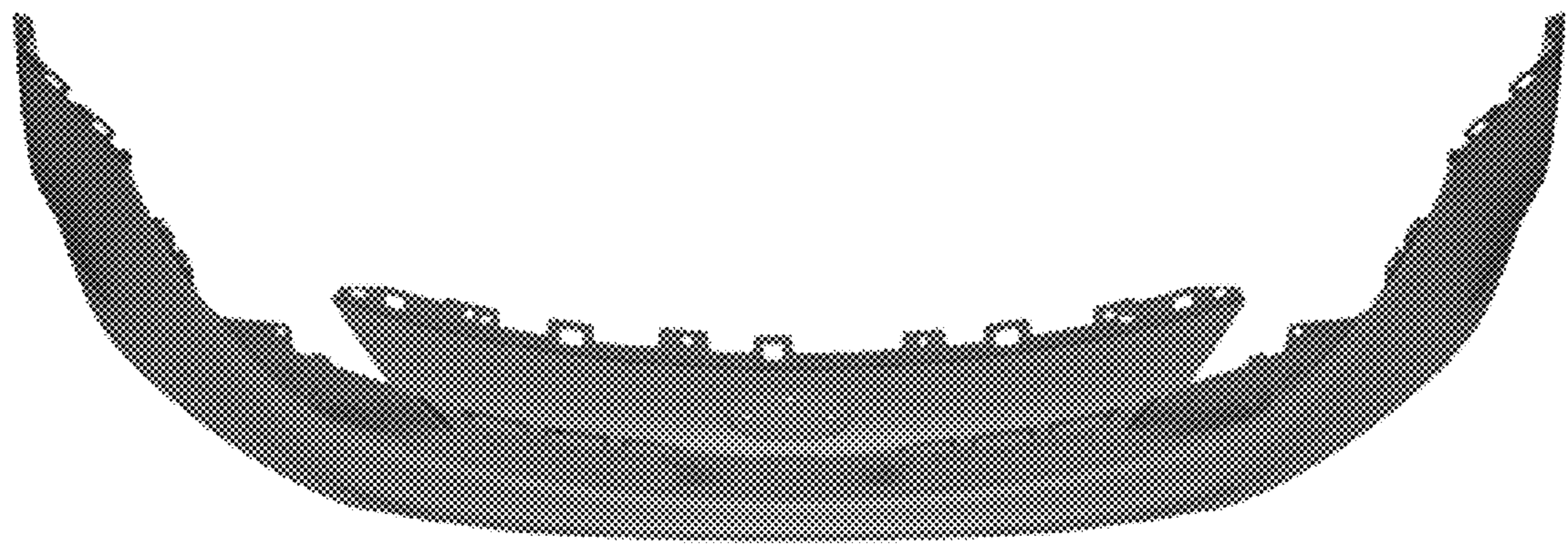
