(57) **CLAIM**

The ornamental design for a housing for an electronic device, substantially as shown and described.

**DESCRIPTION**

FIG. 13 is a left side view thereof;

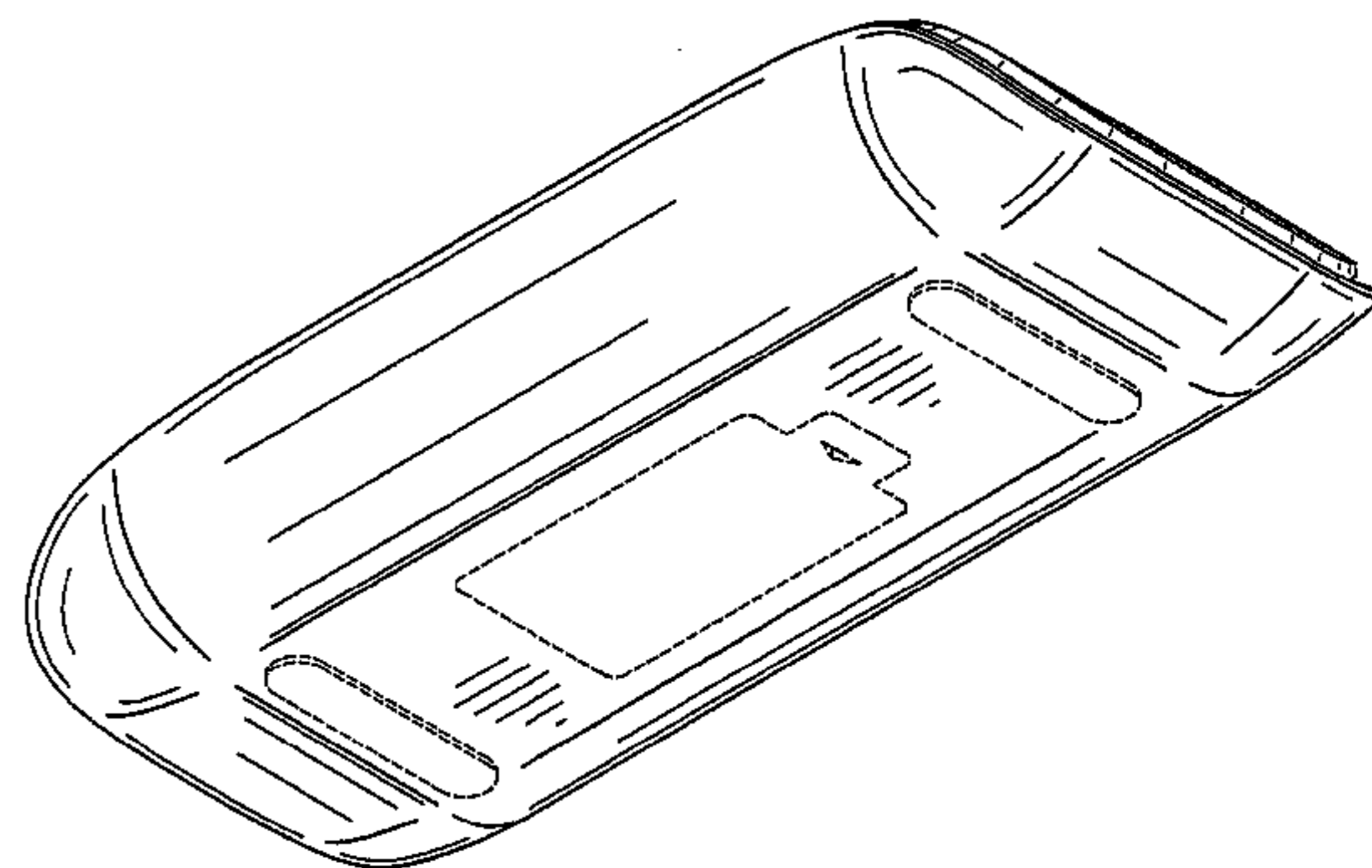
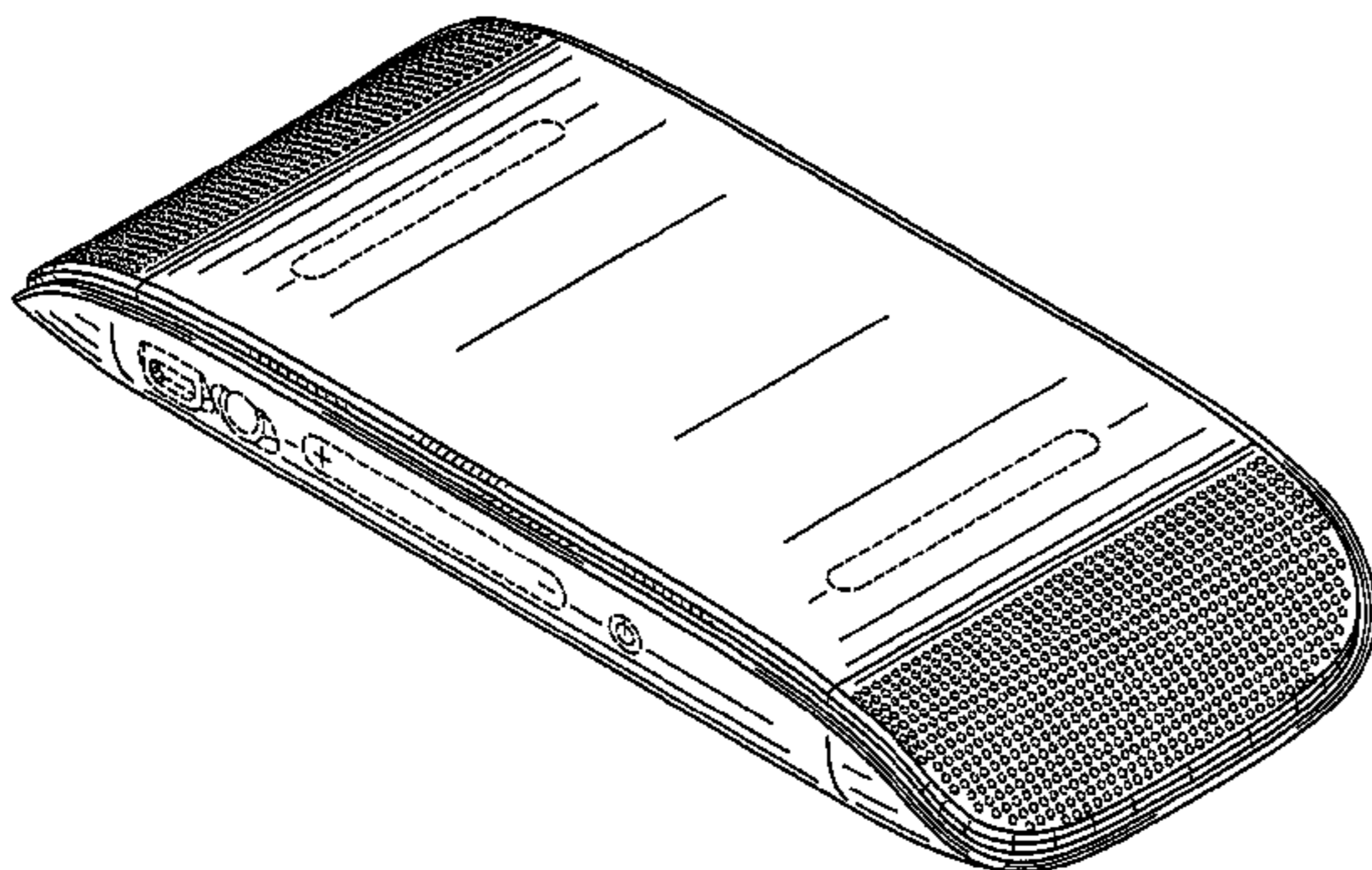
FIG. 14 is a right side view thereof;

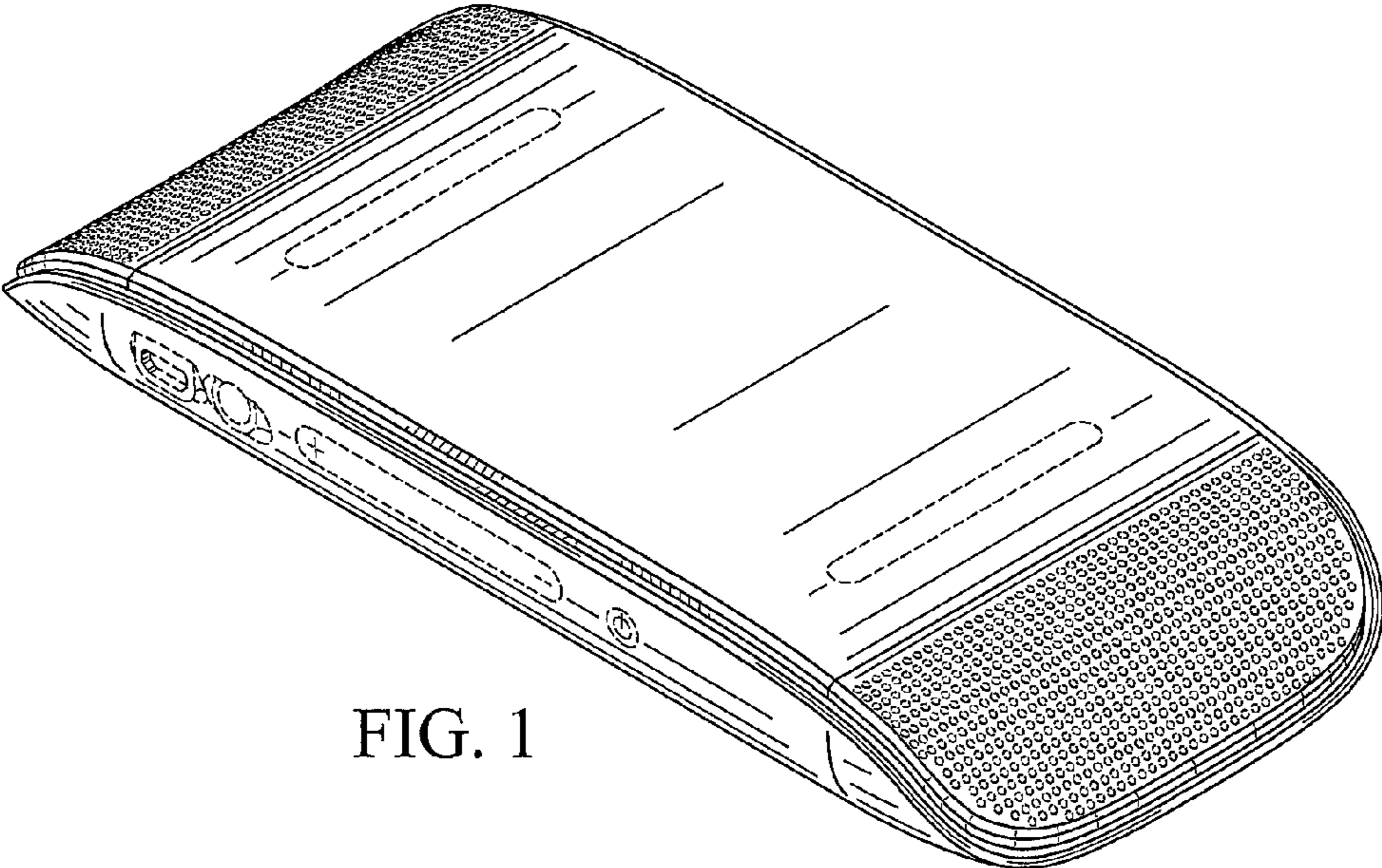

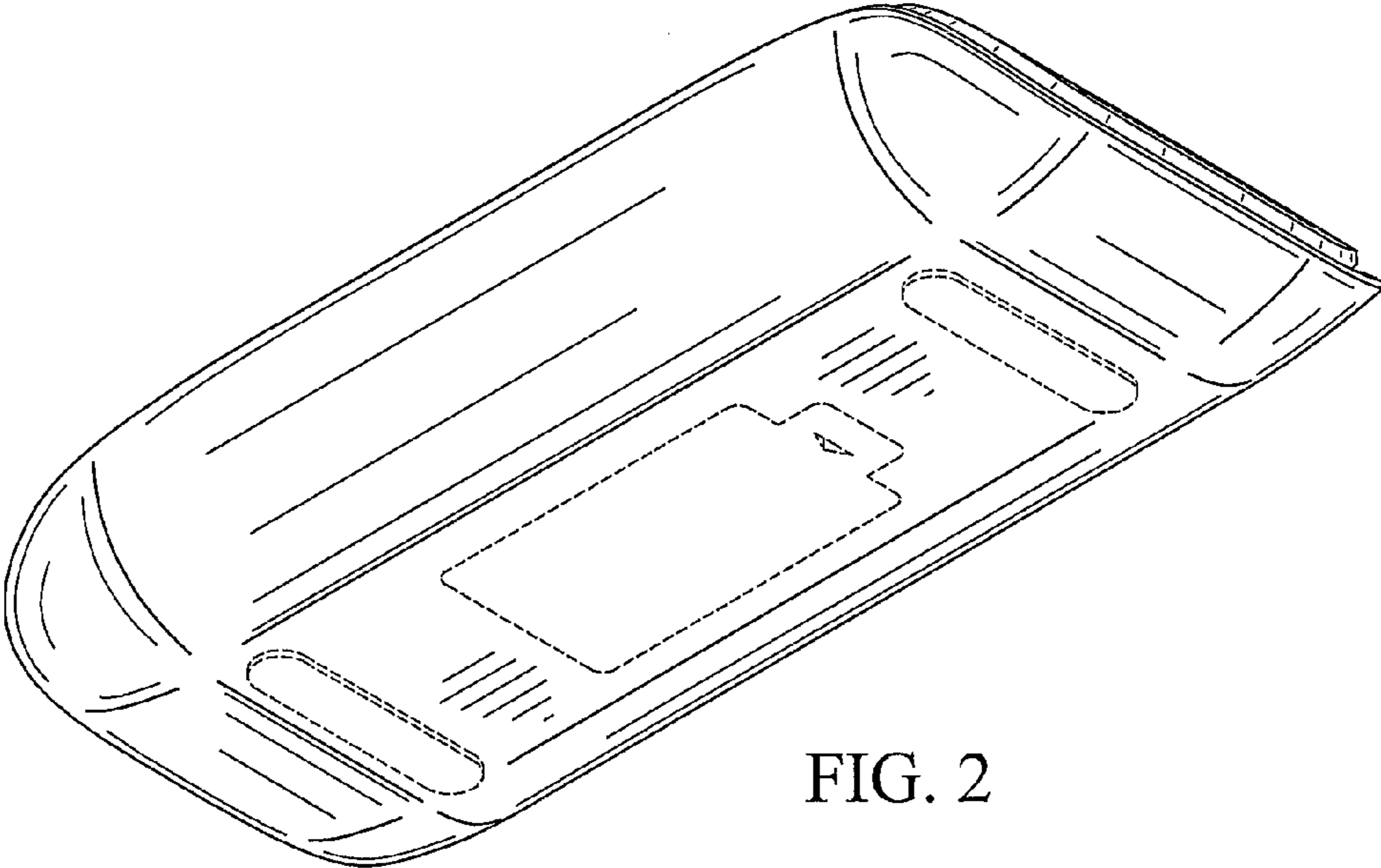

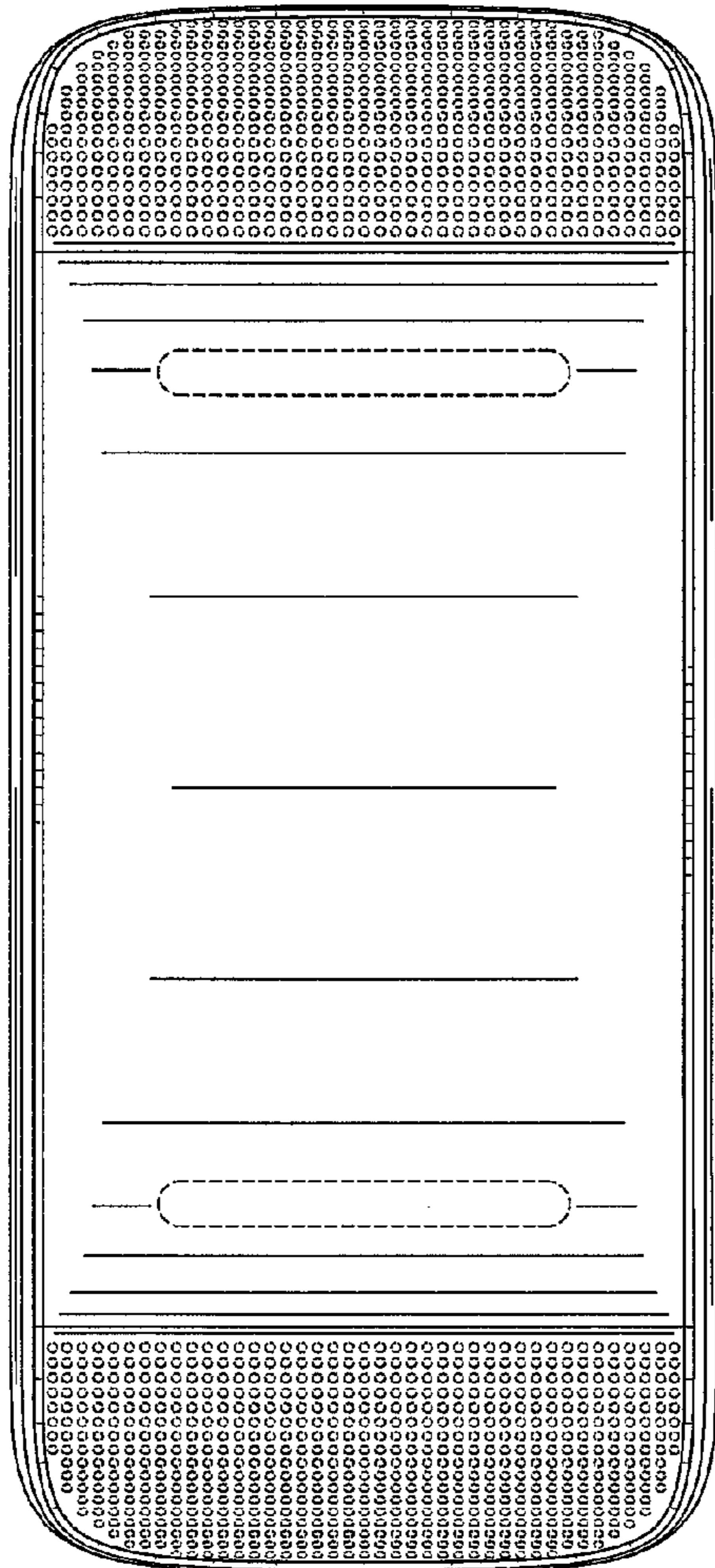

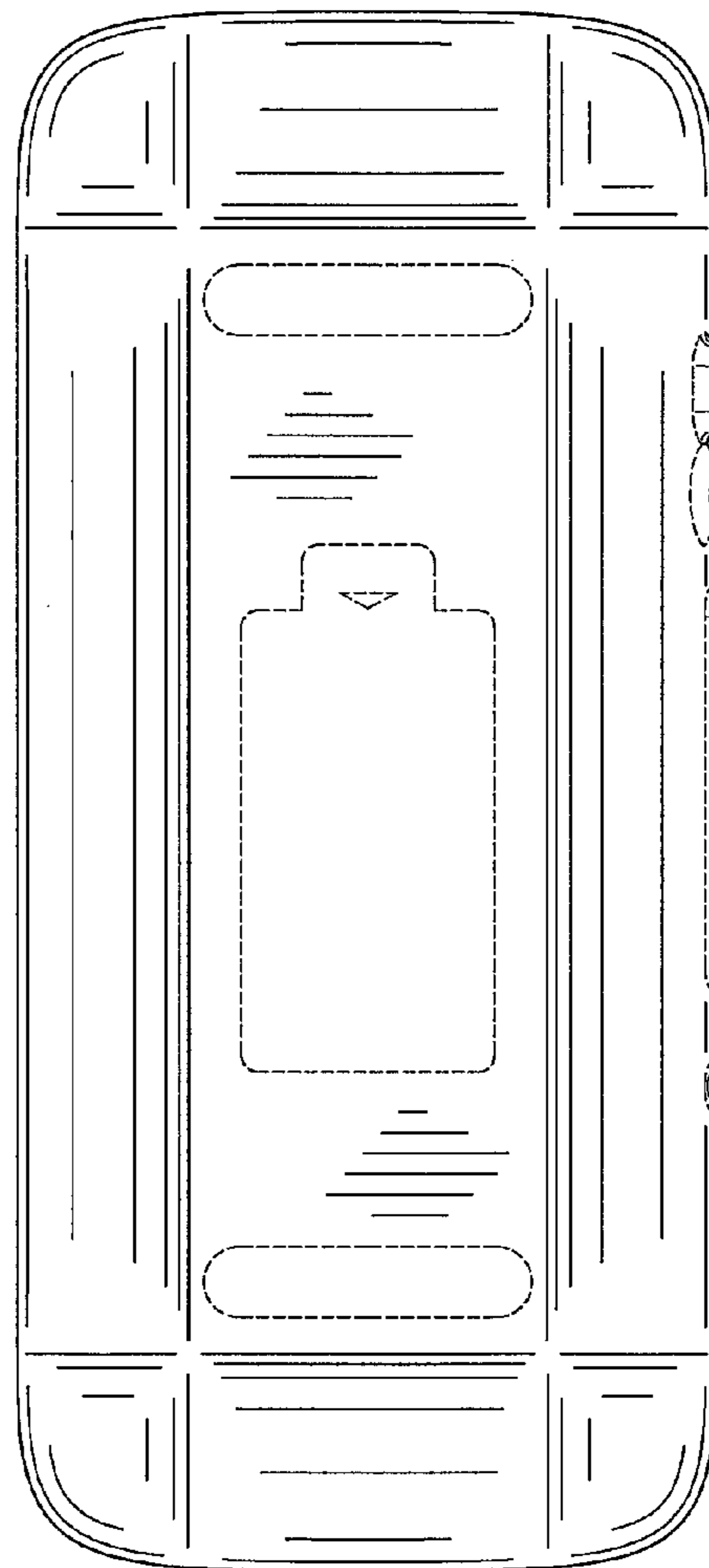

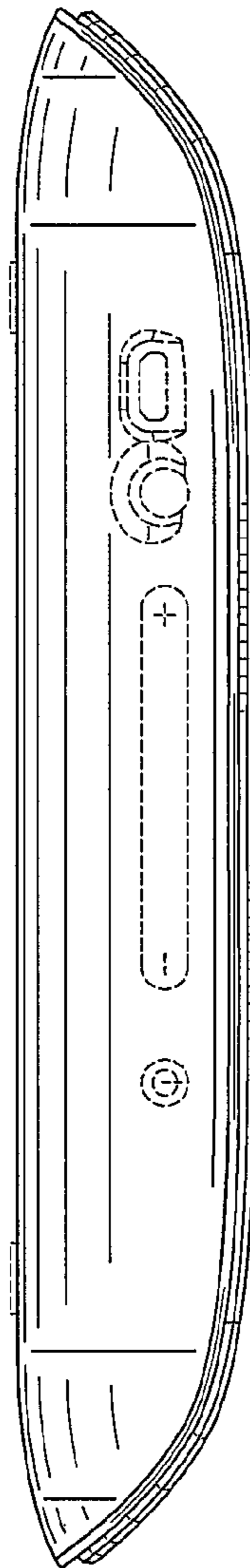

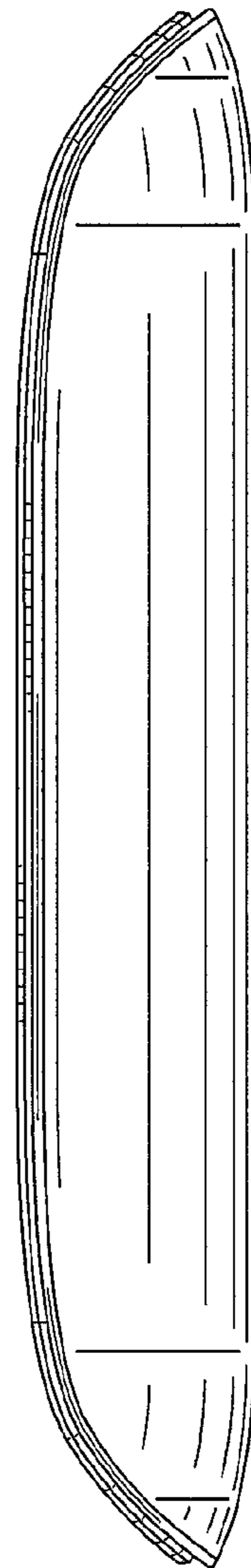

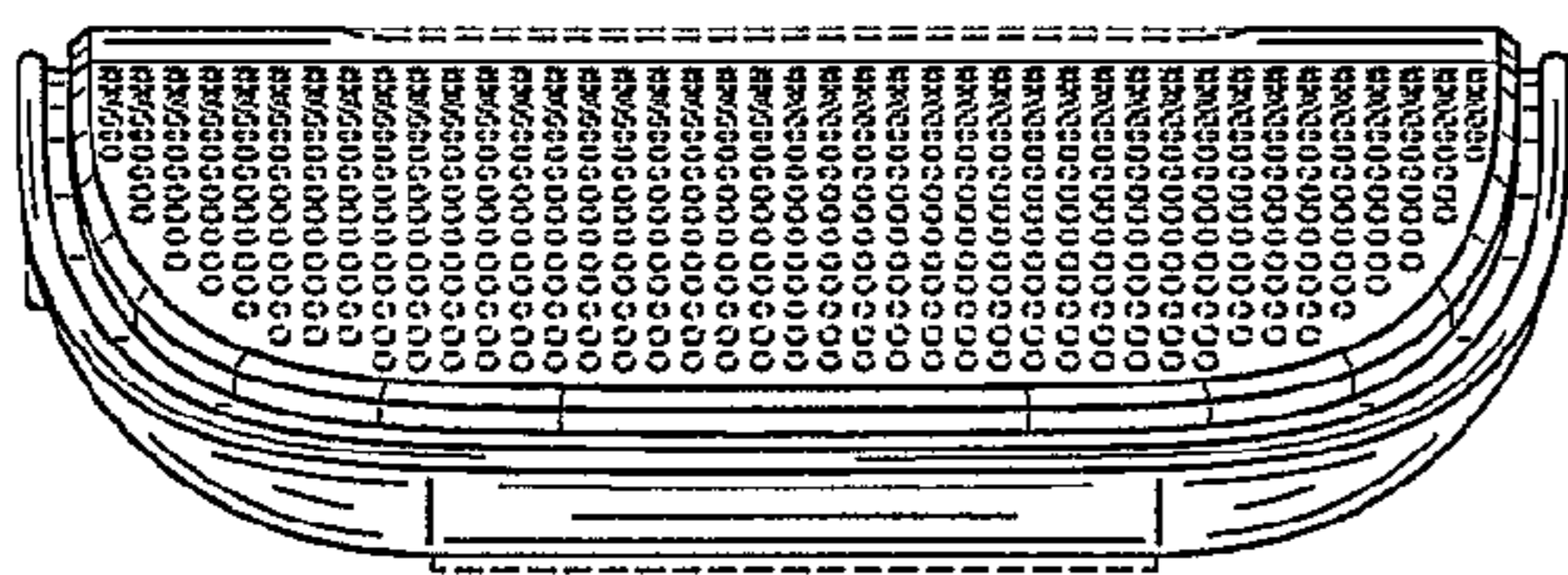

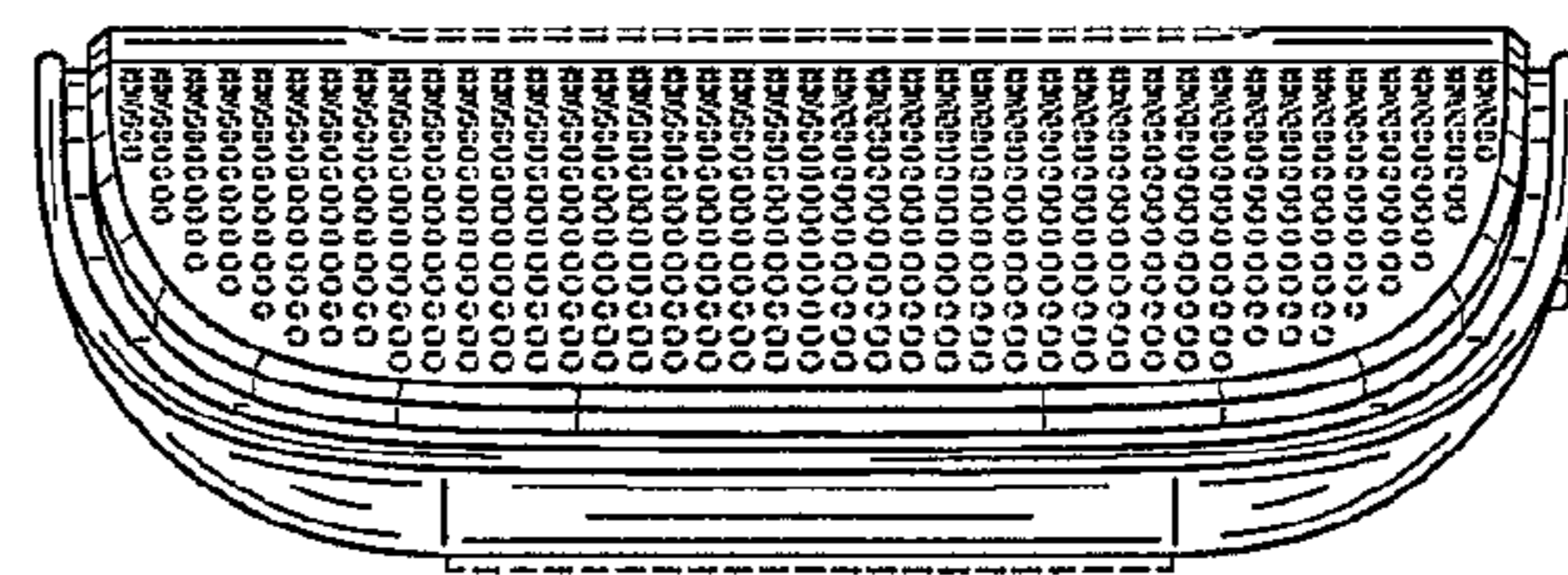

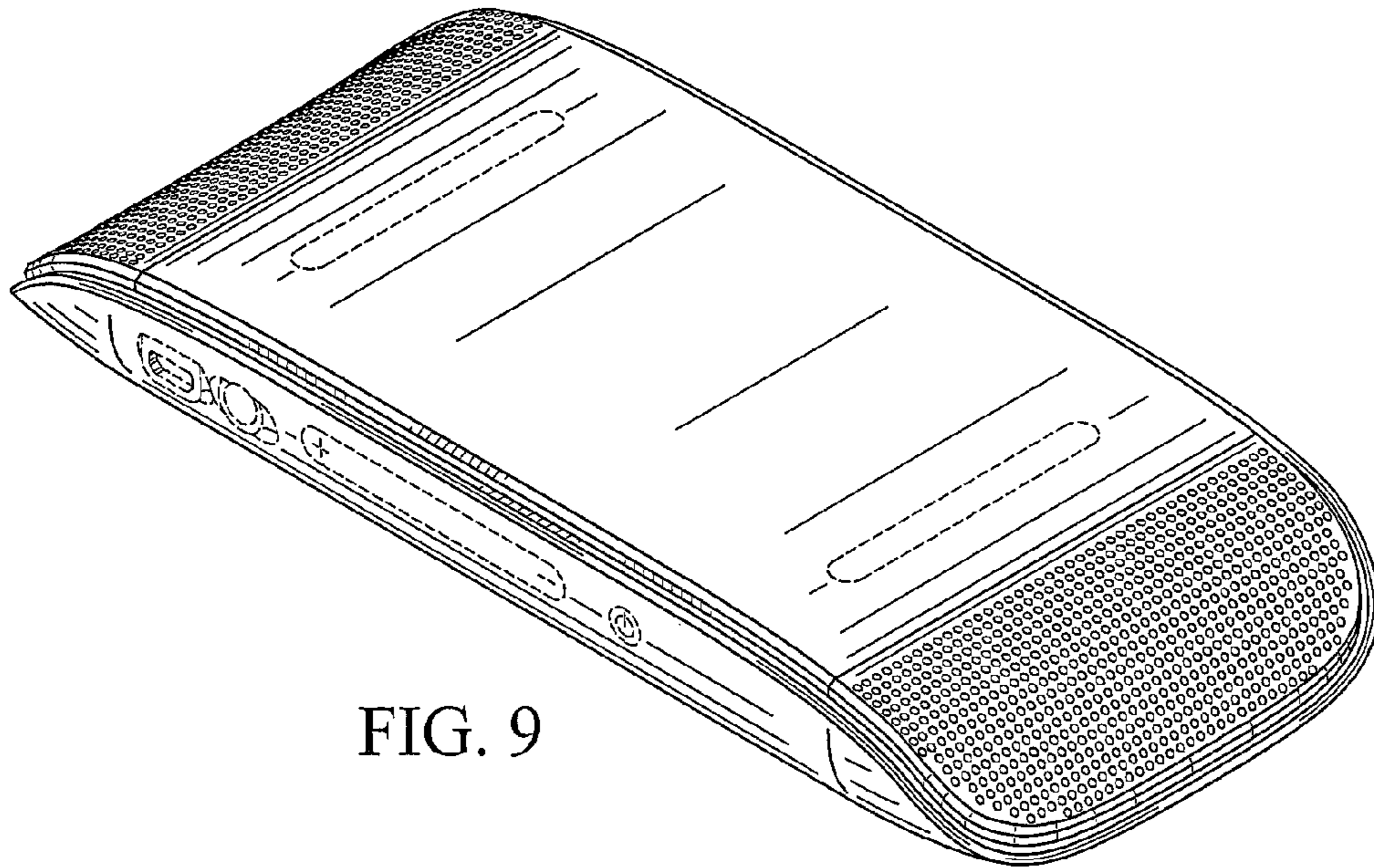

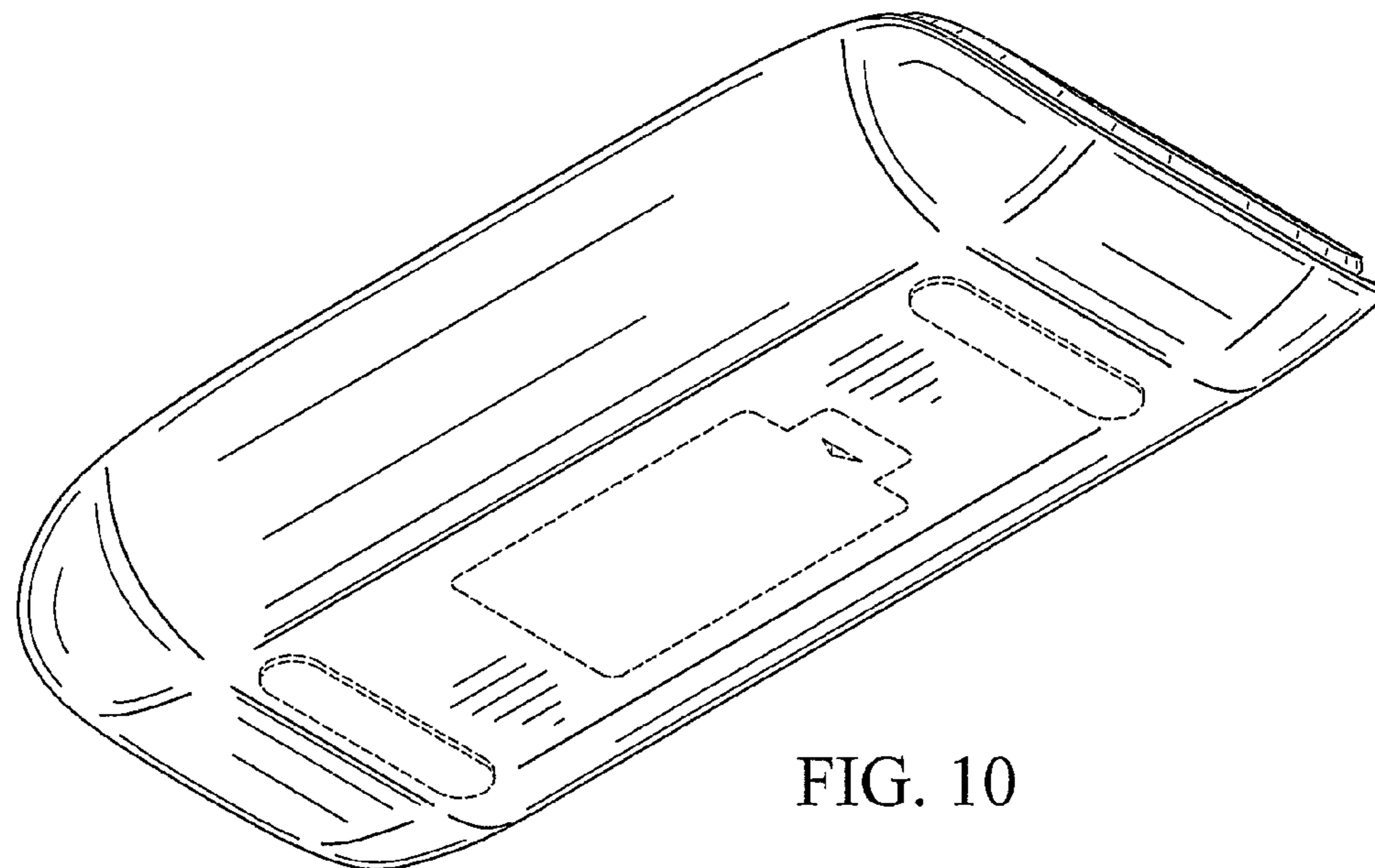

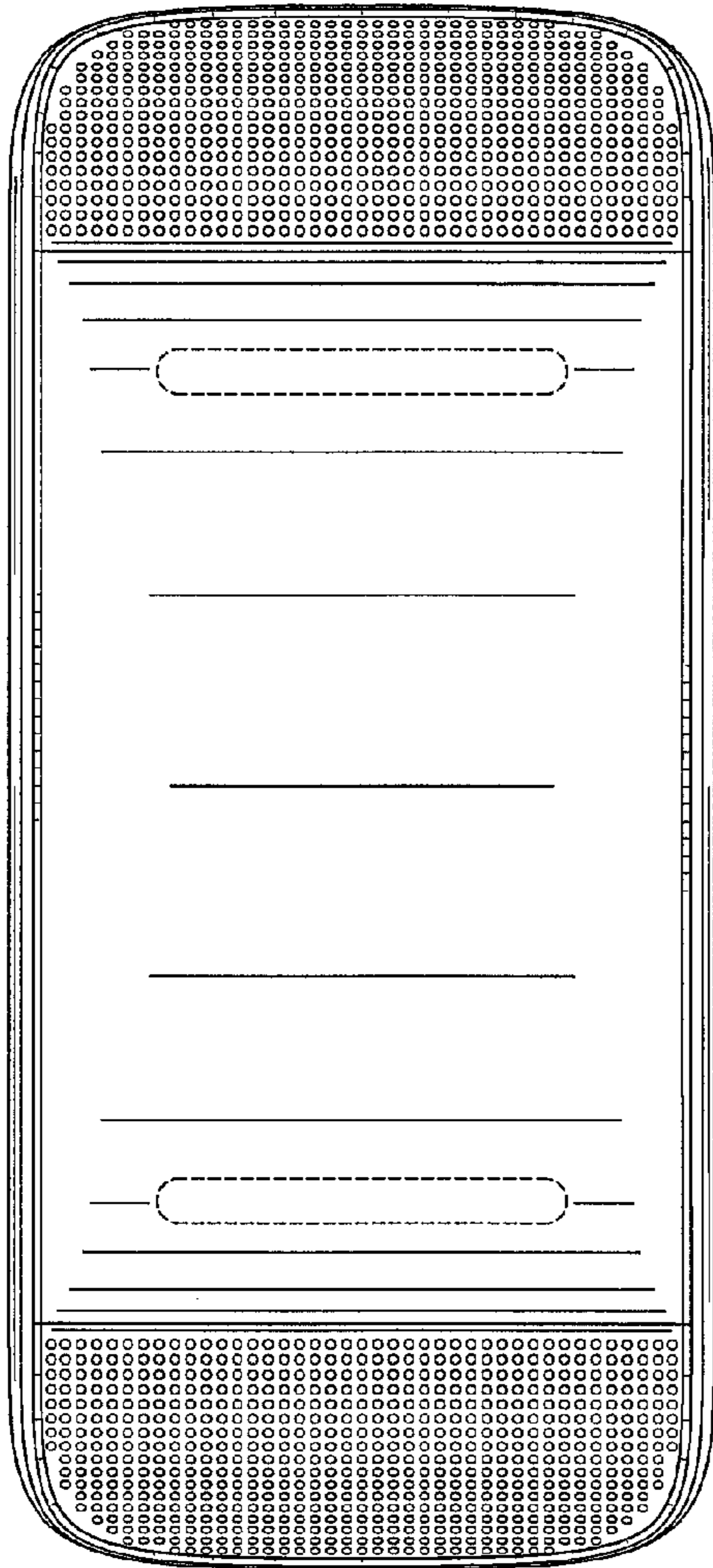

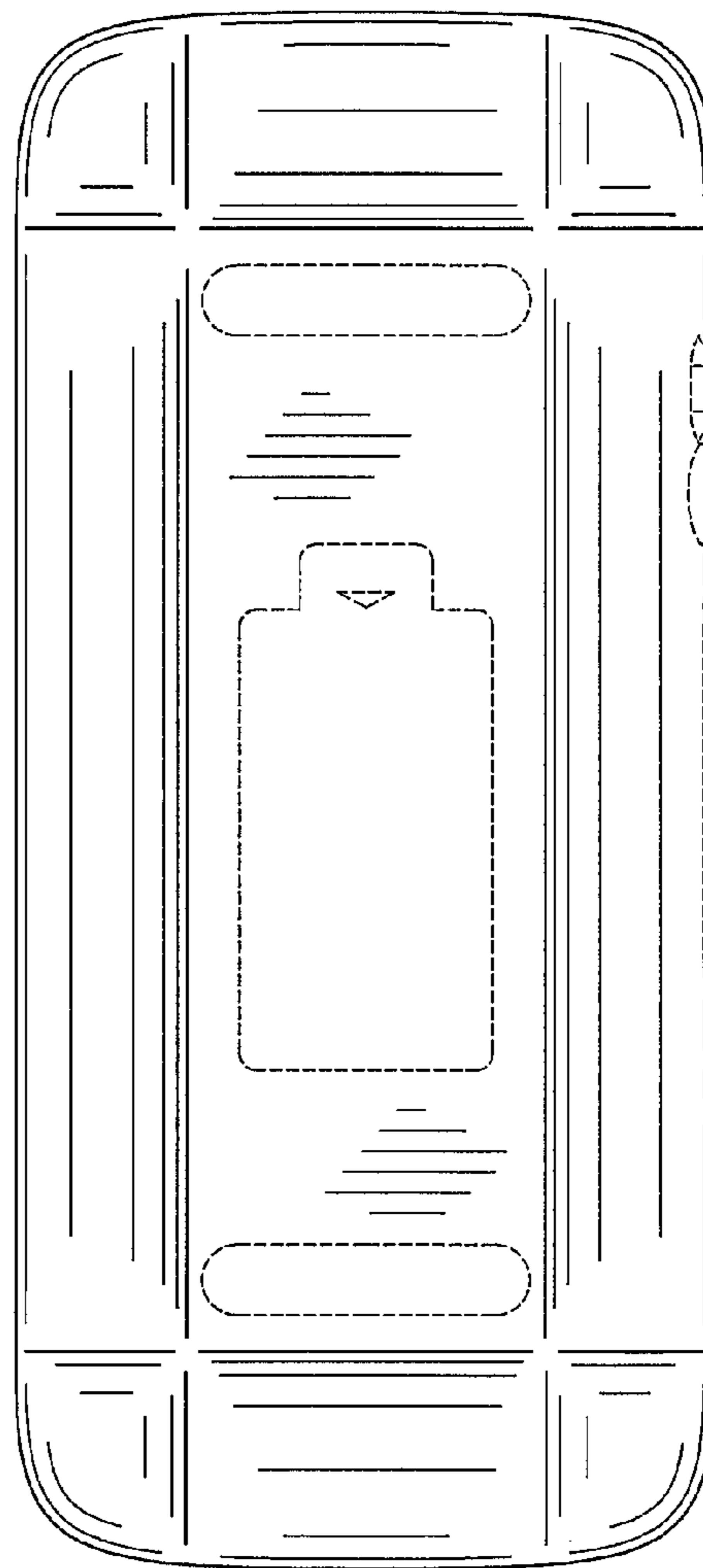

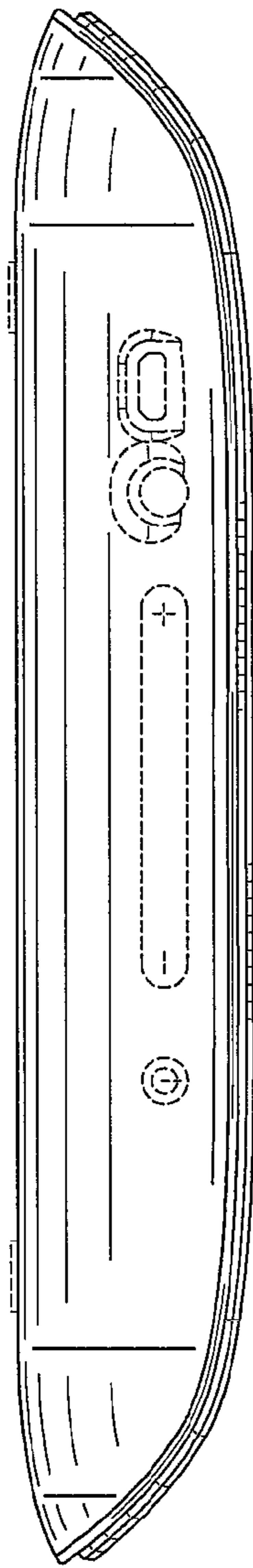

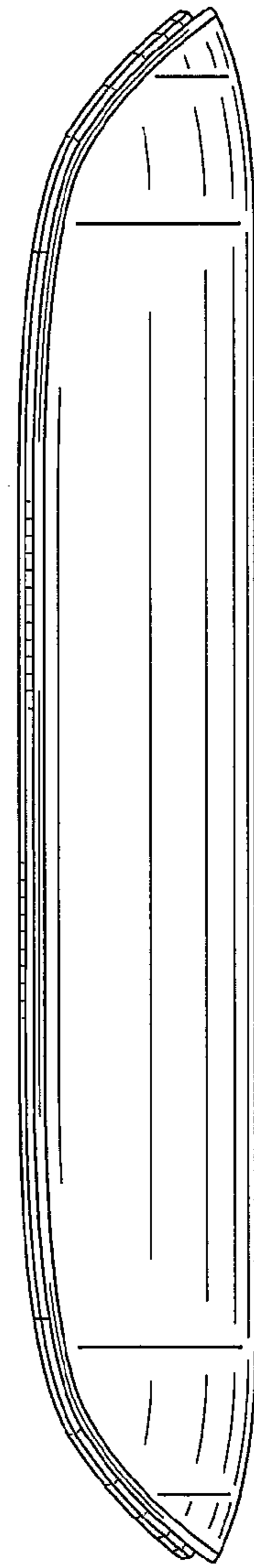

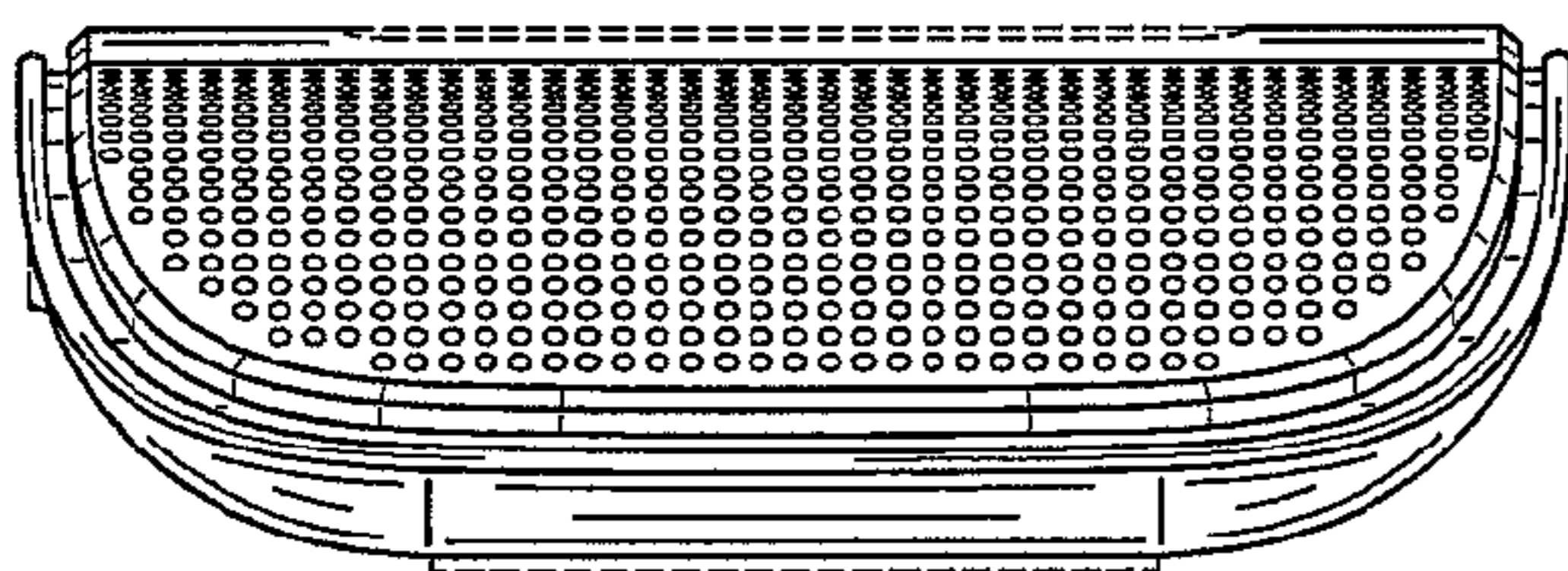

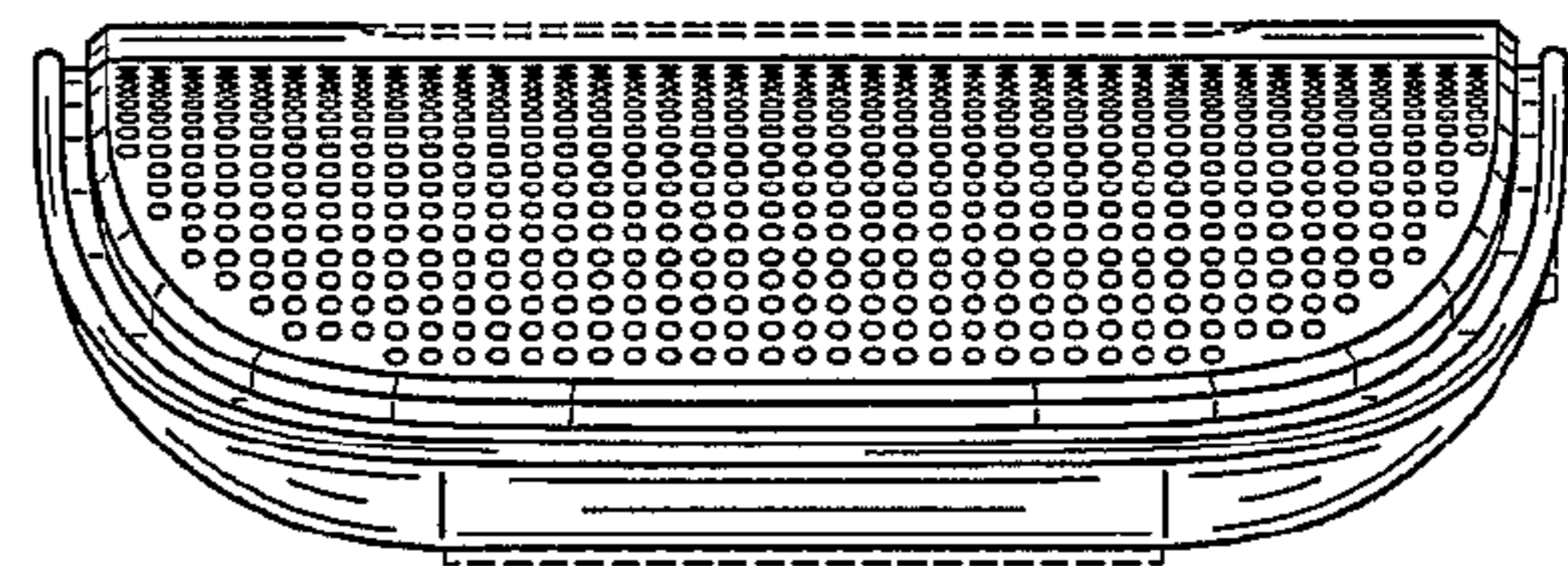
