(57) **CLAIM**

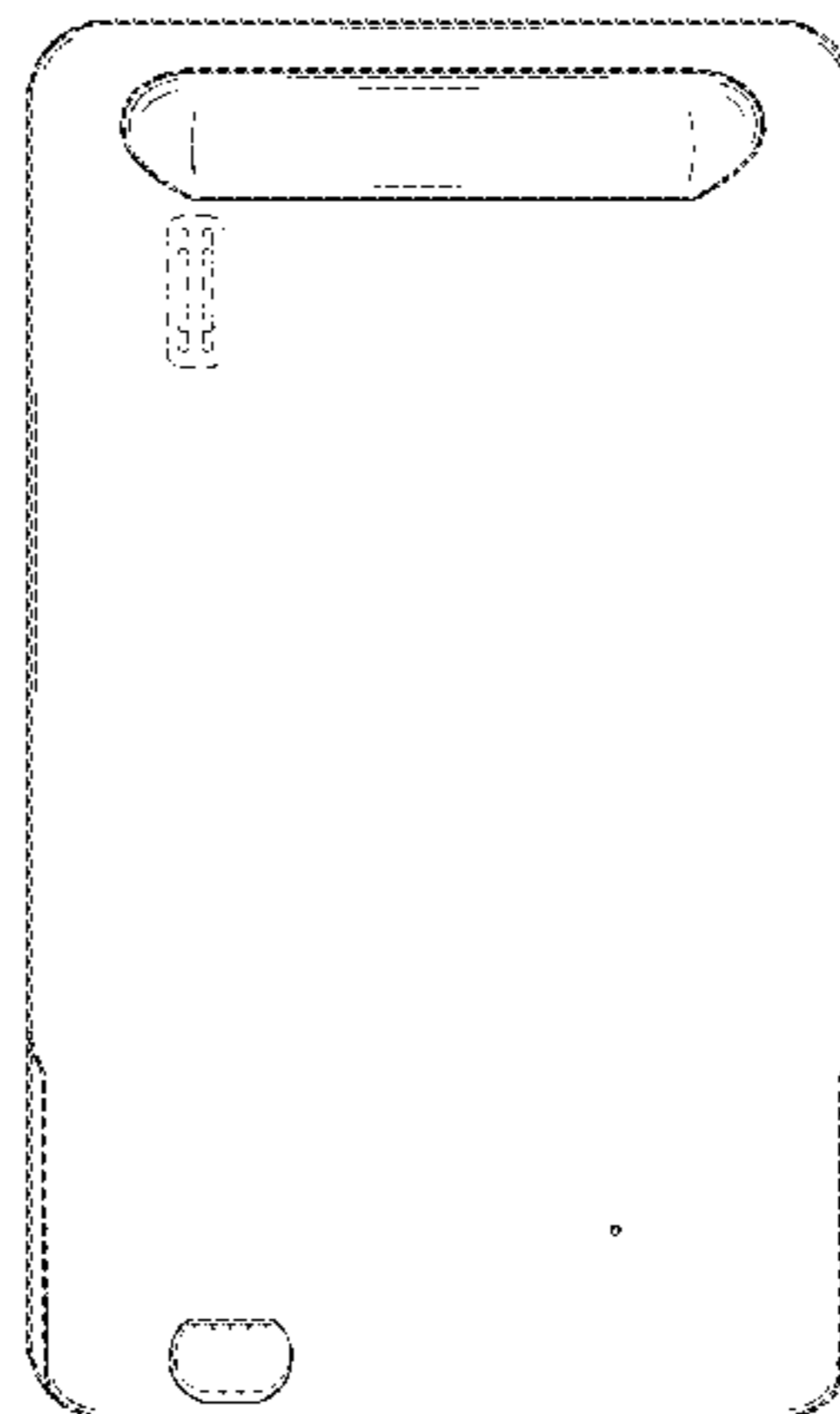
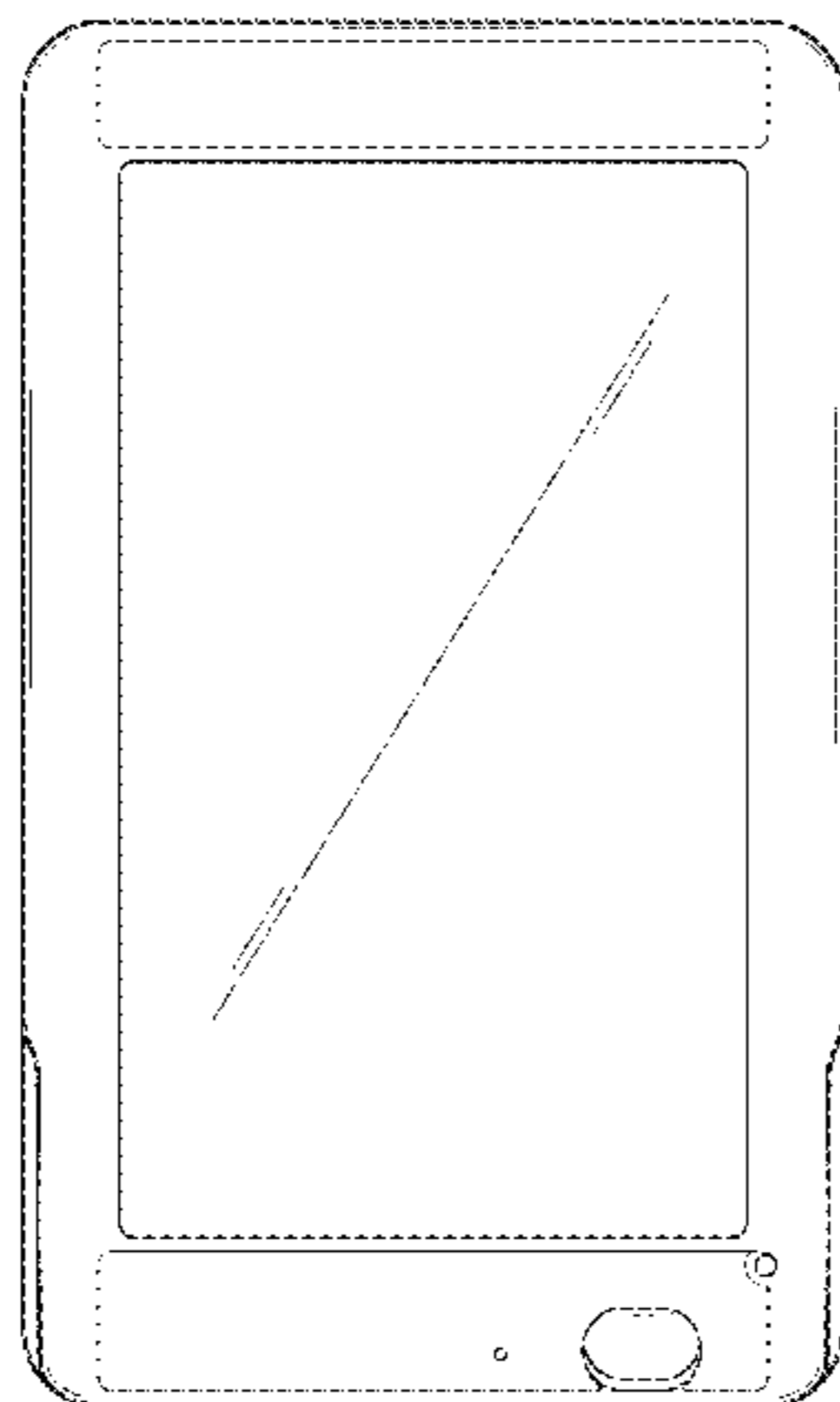
The ornamental design for a tablet PC, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front and right side of a tablet PC showing our new design;
FIG. 2 is a front view of the tablet PC of FIG. 1, rotated 90 degrees in the clockwise direction;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The broken lines shown in the drawings represent portions of the tablet PC that form no part of the claimed design.

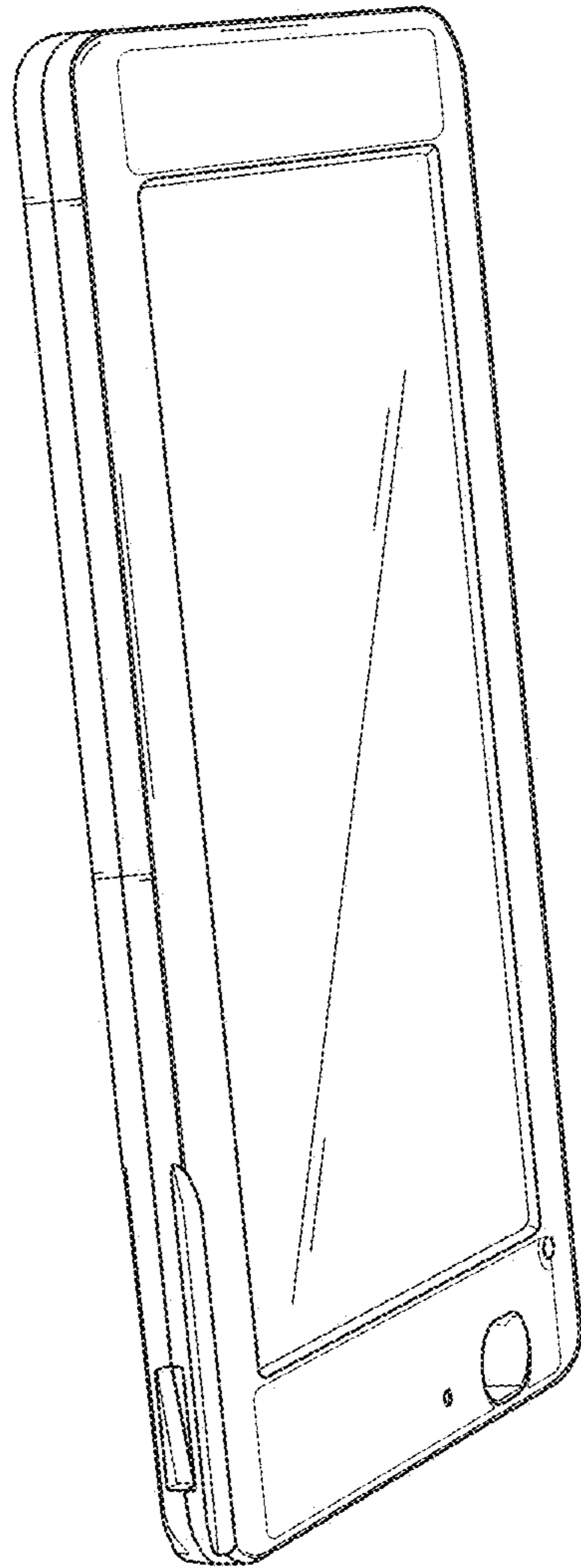

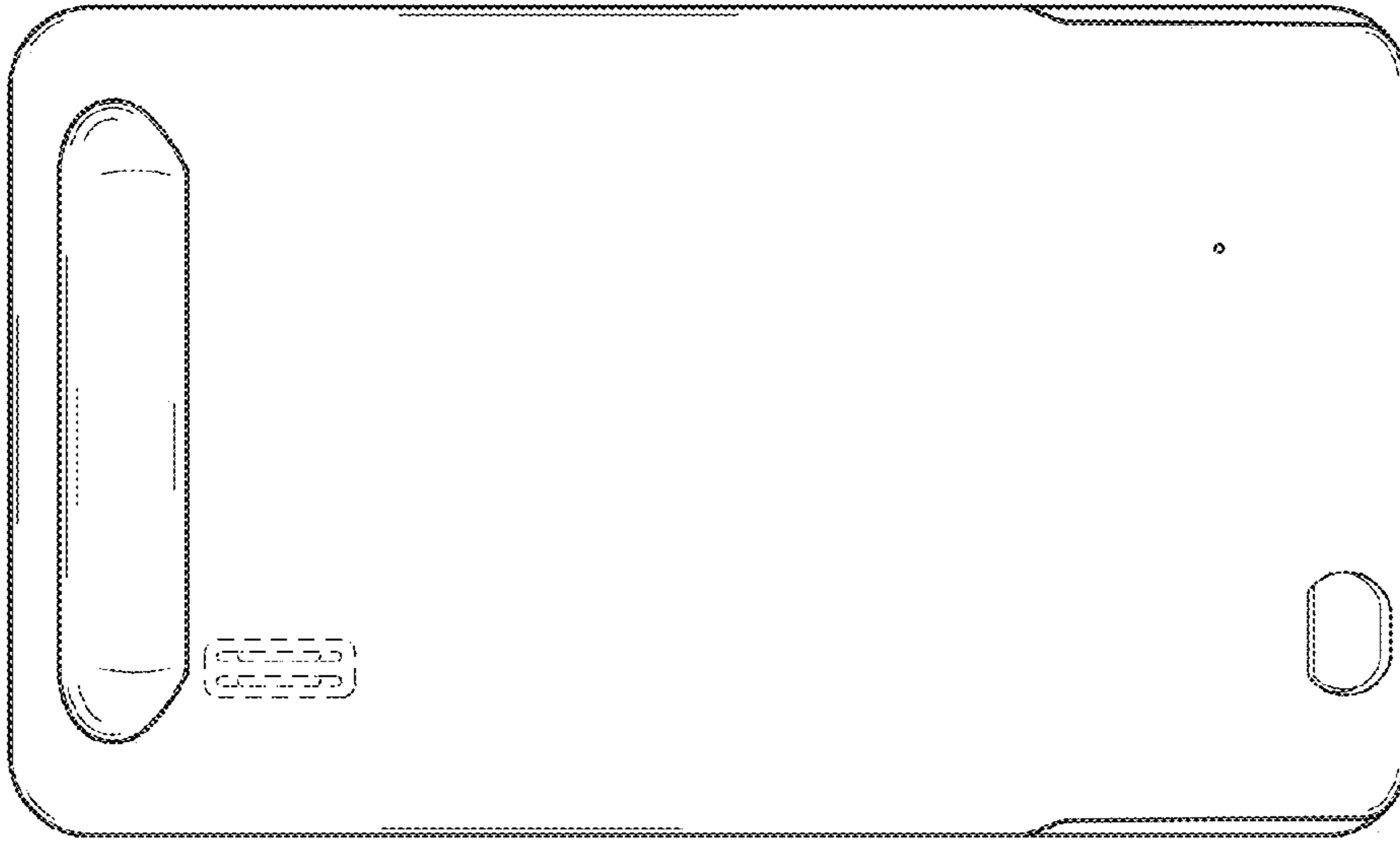

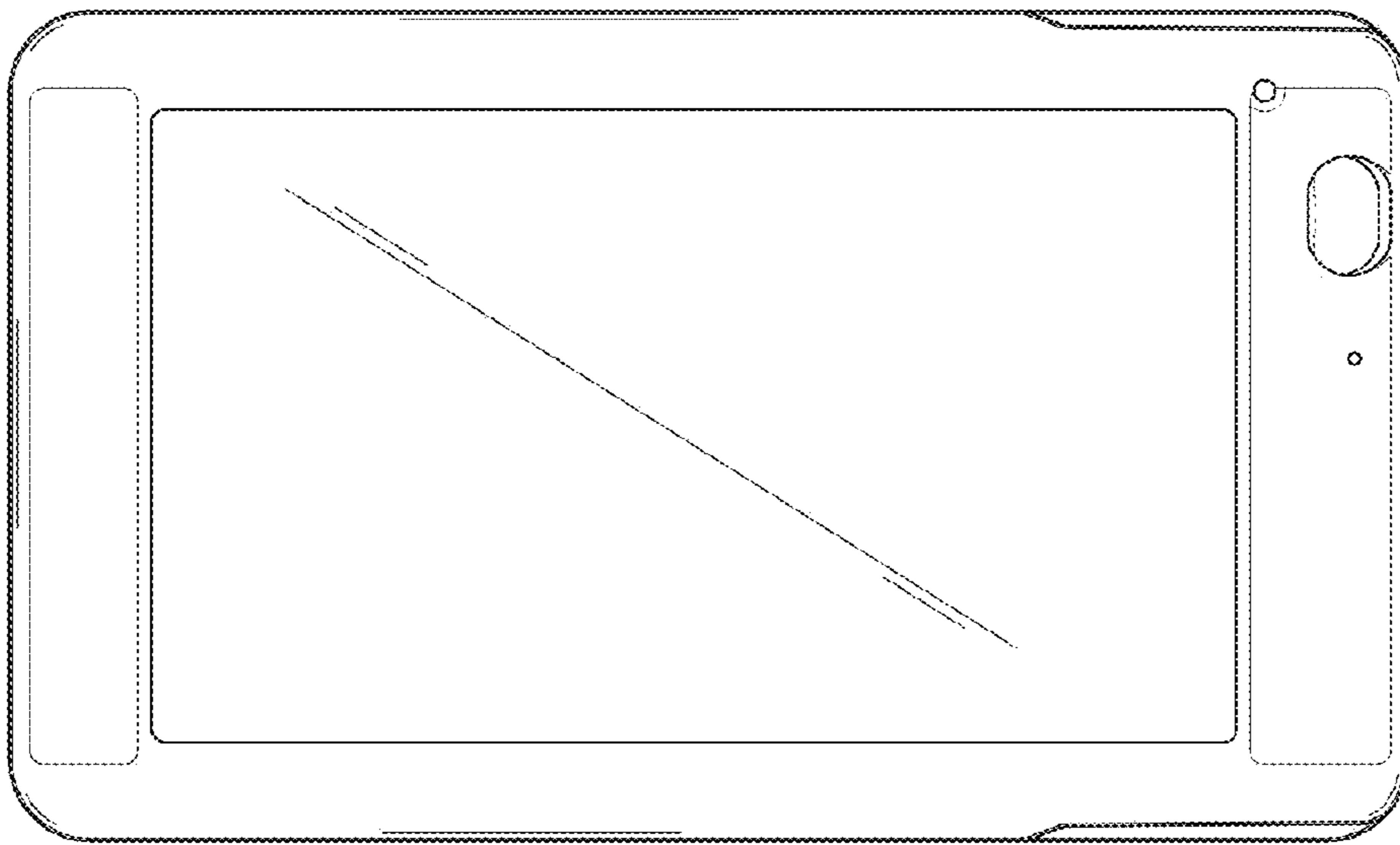

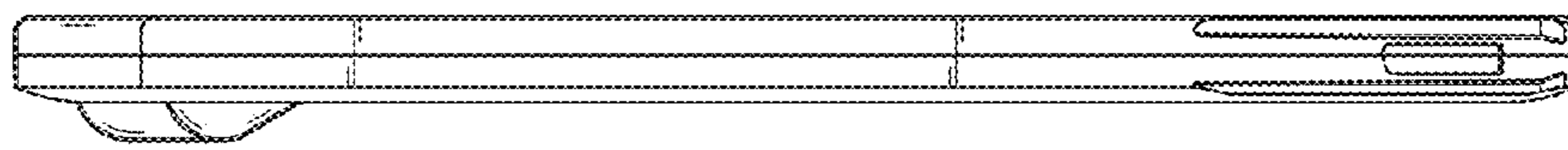

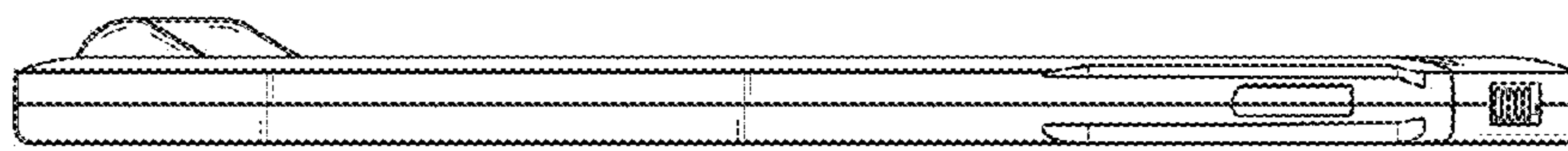

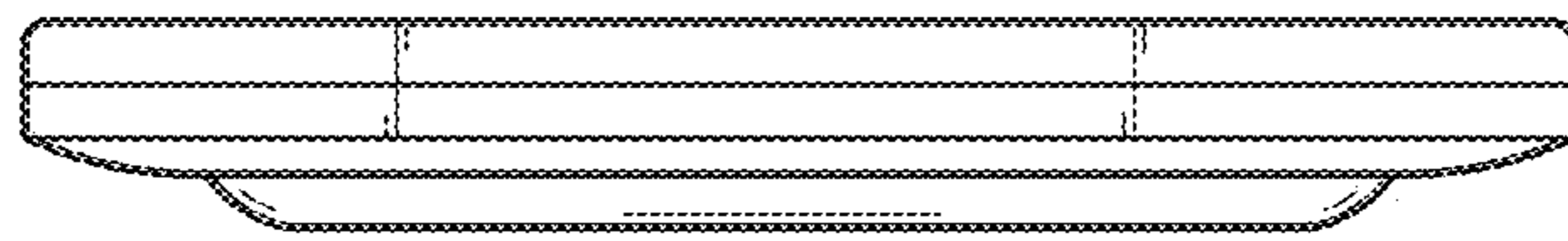
