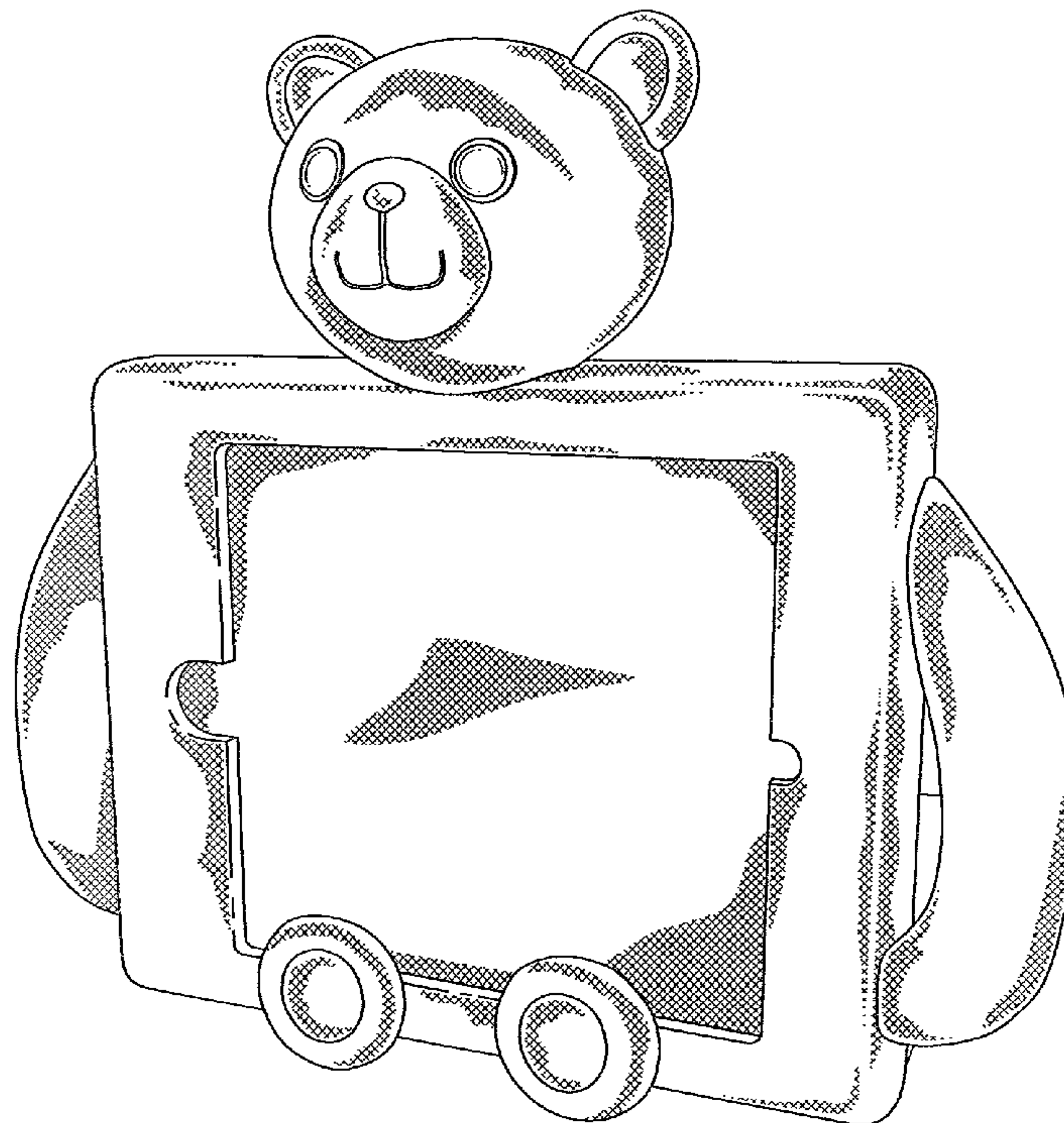
(57) **CLAIM**

I claim the ornamental design for a tablet holder, as shown and described.

DESCRIPTION

FIG. 1 is a front ¾ perspective view of a tablet holder showing my new design;
FIG. 2 is a rear ¾ perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;

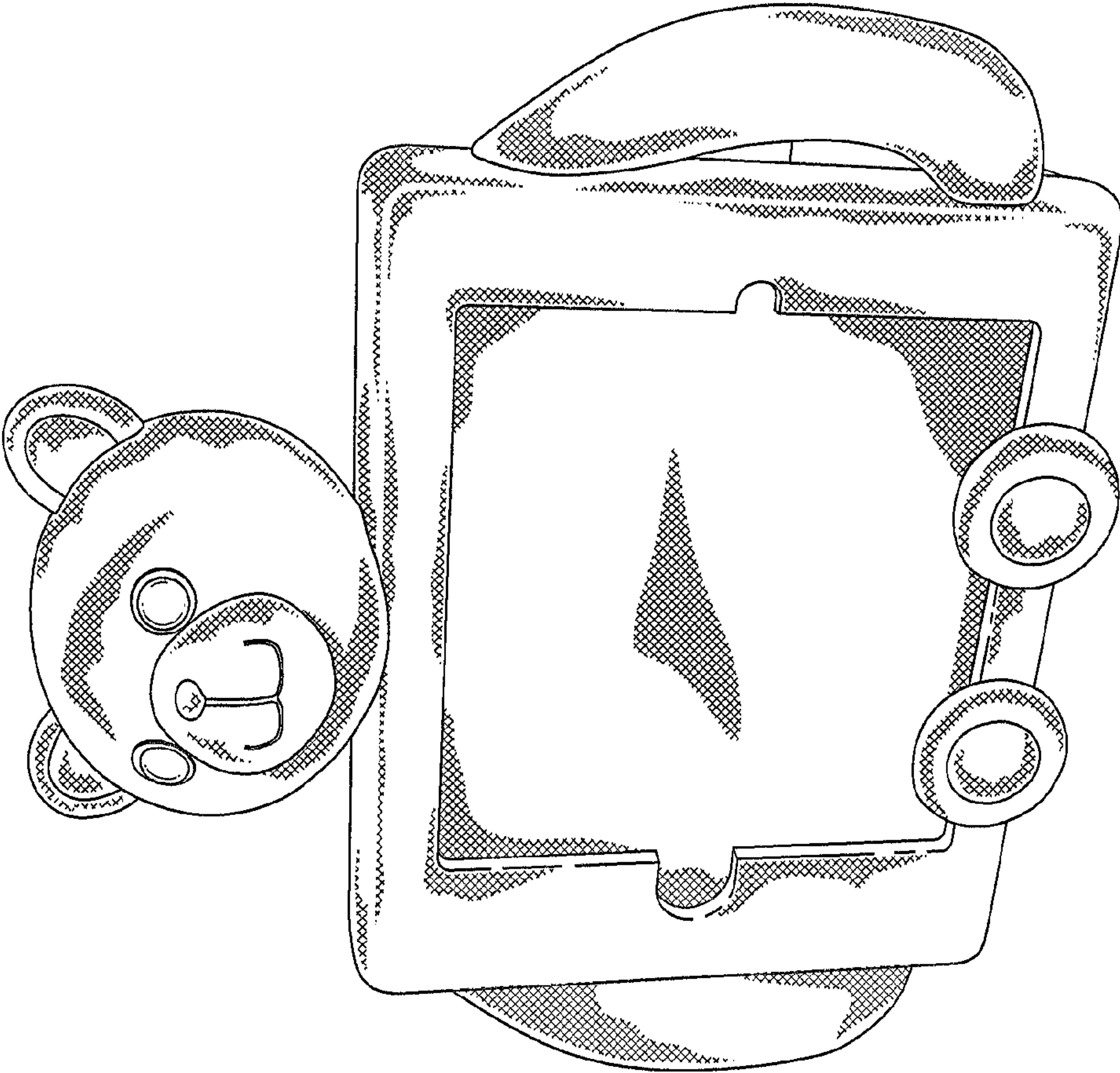

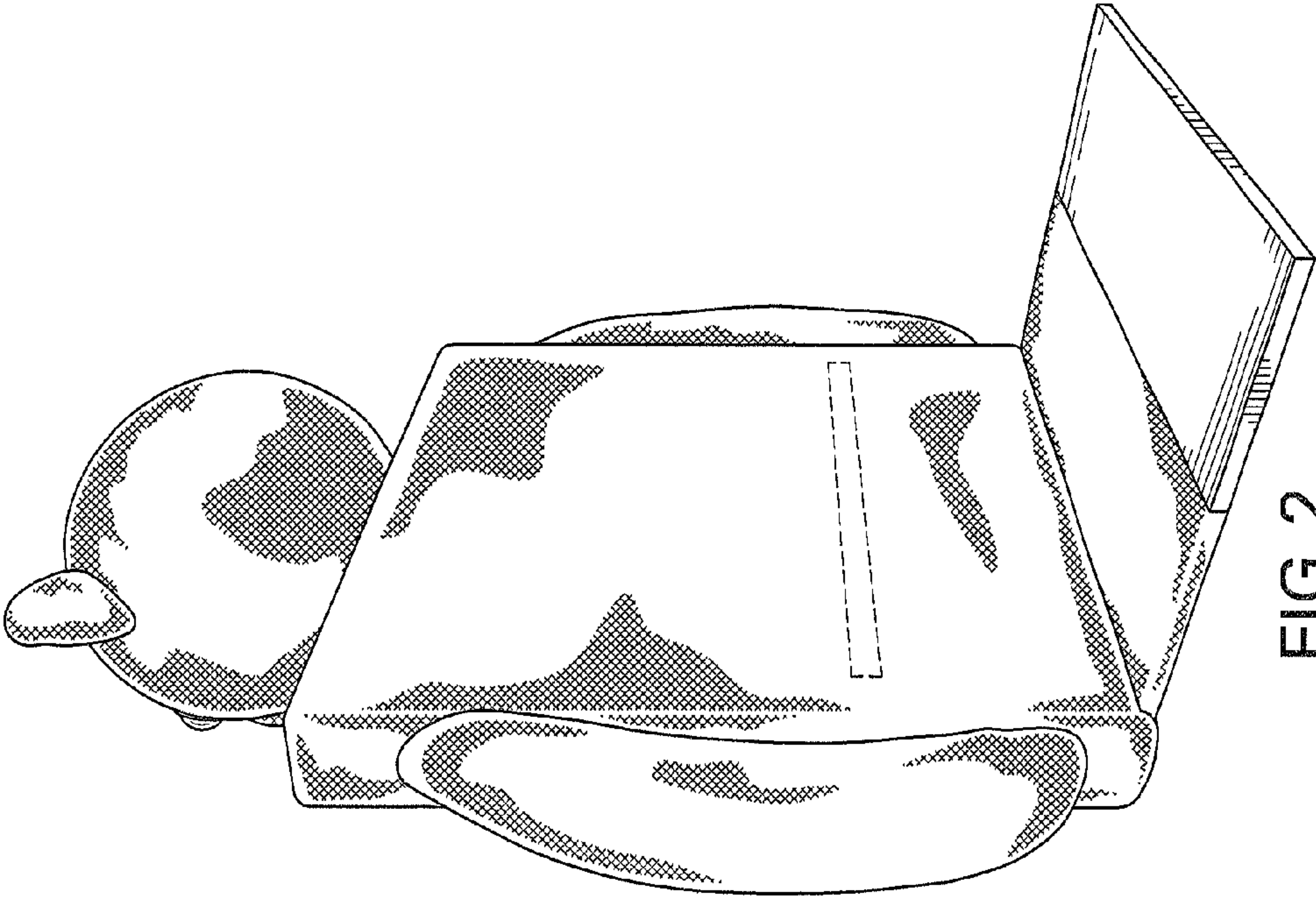

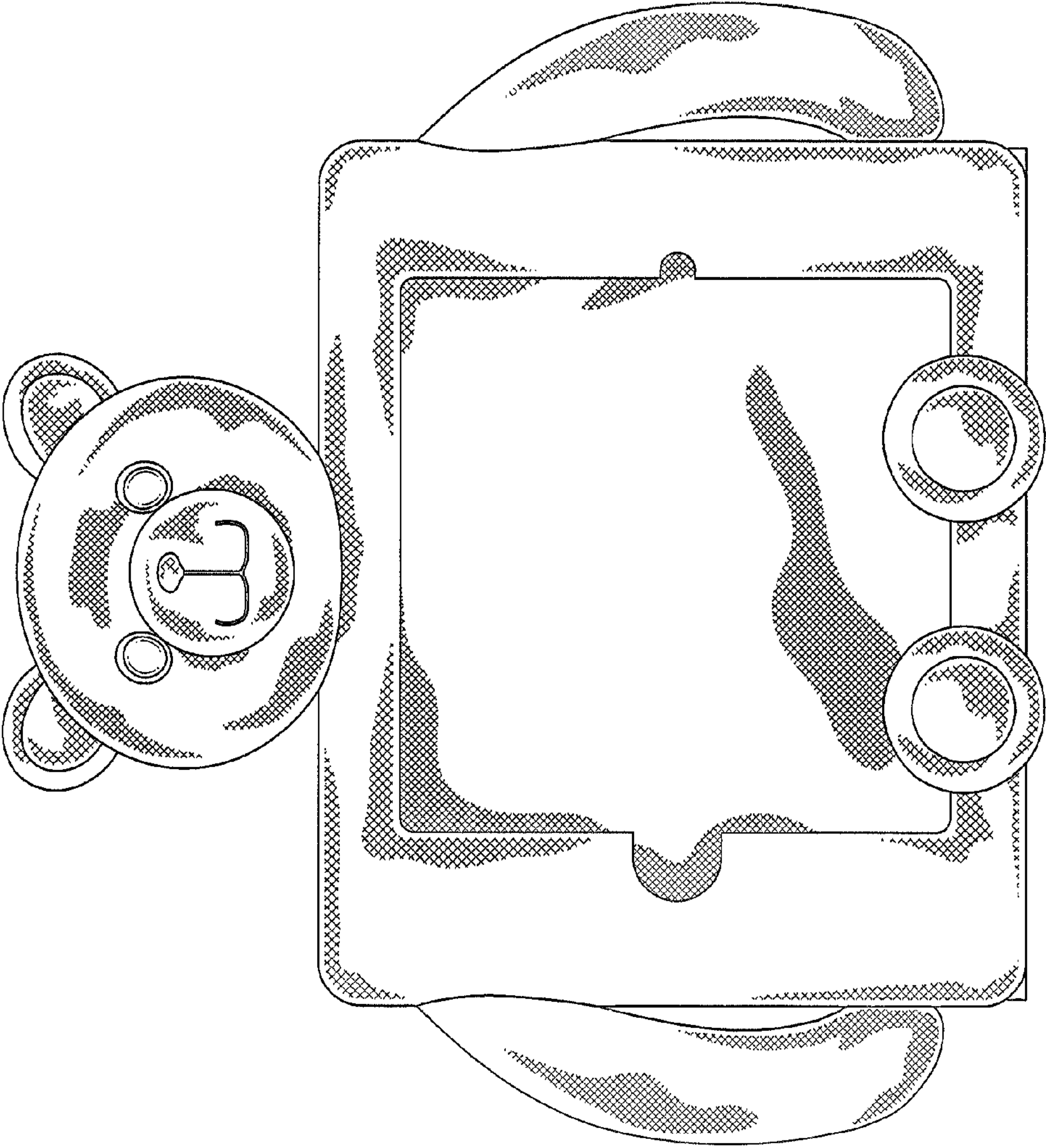

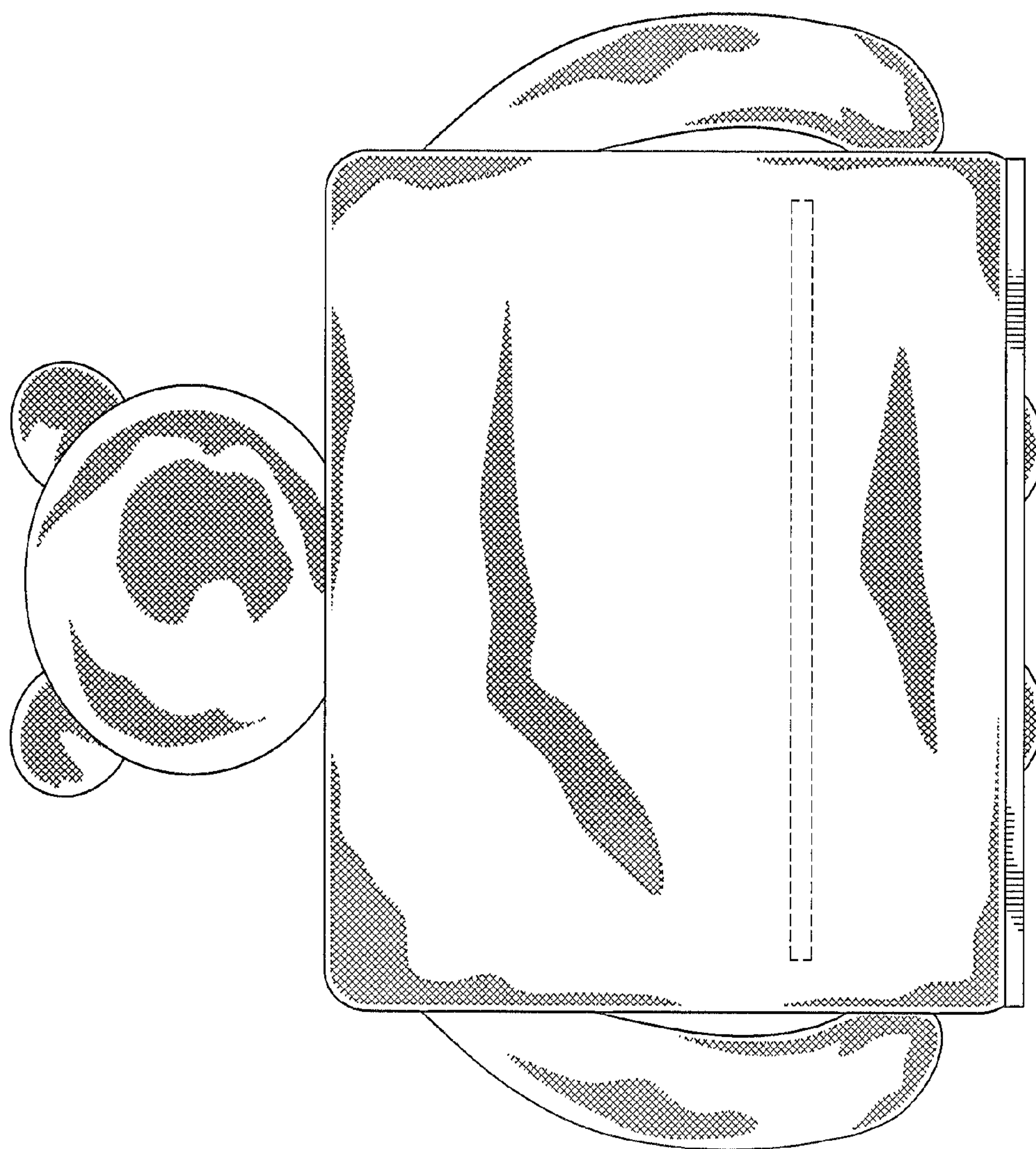

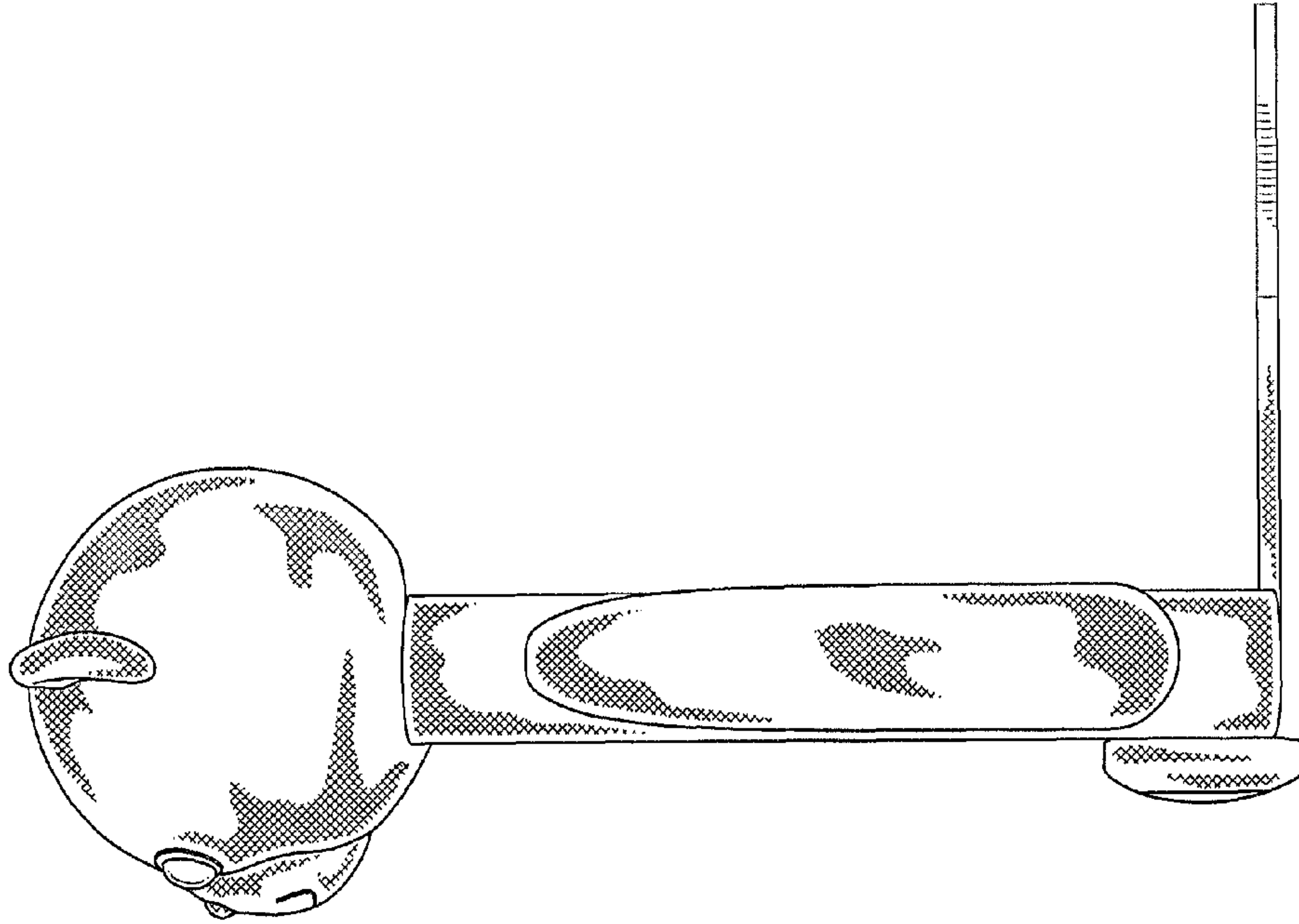

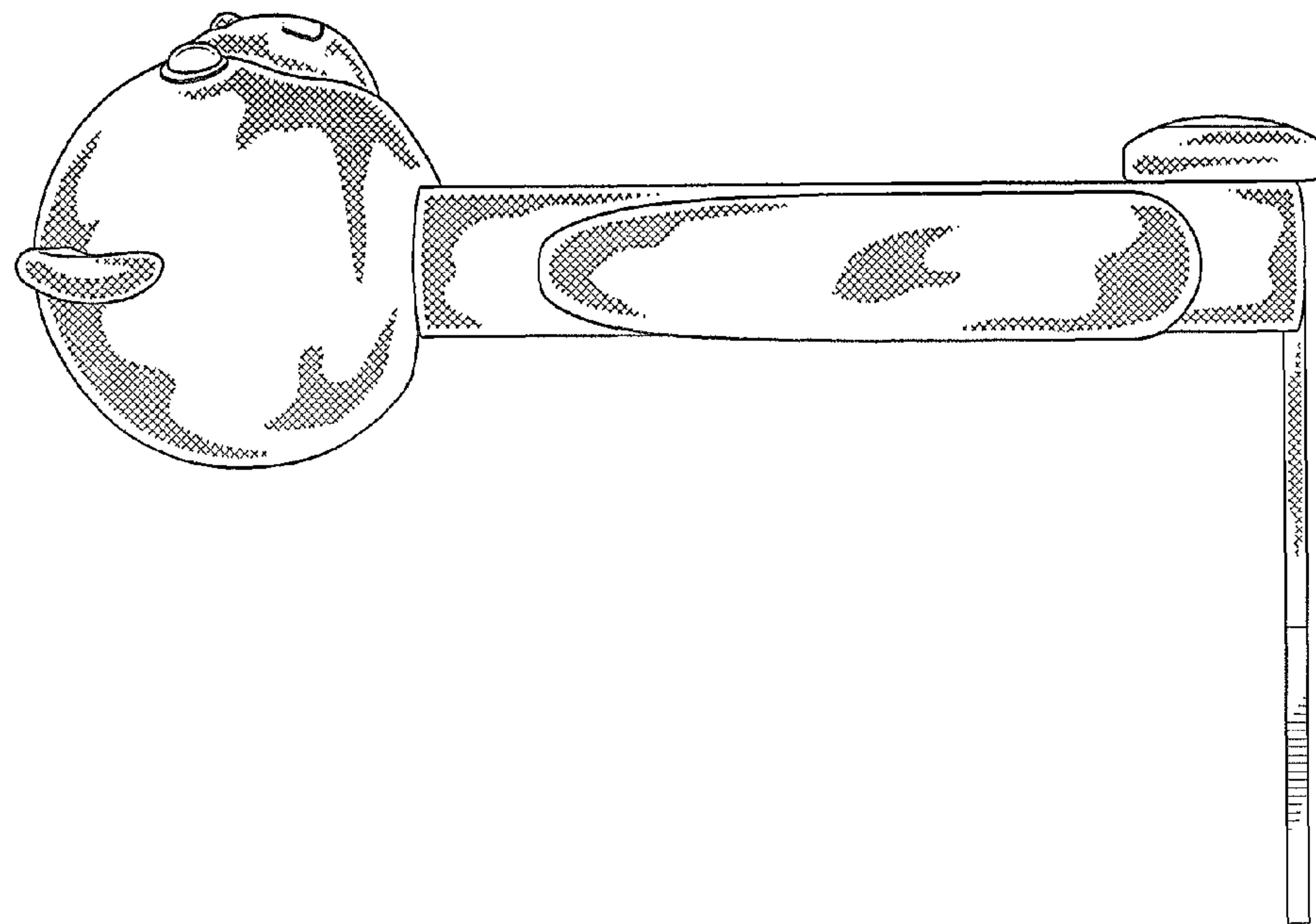

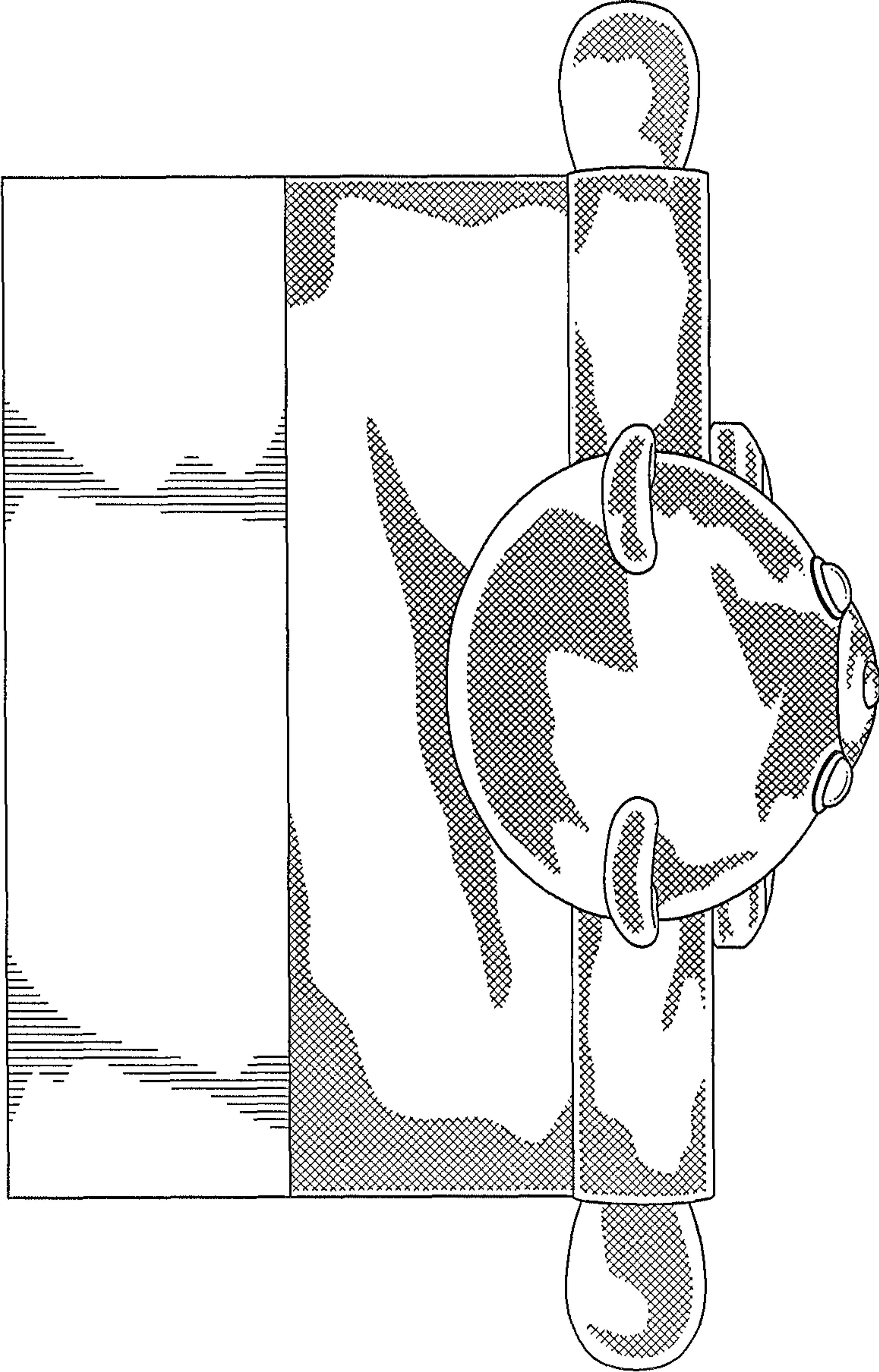

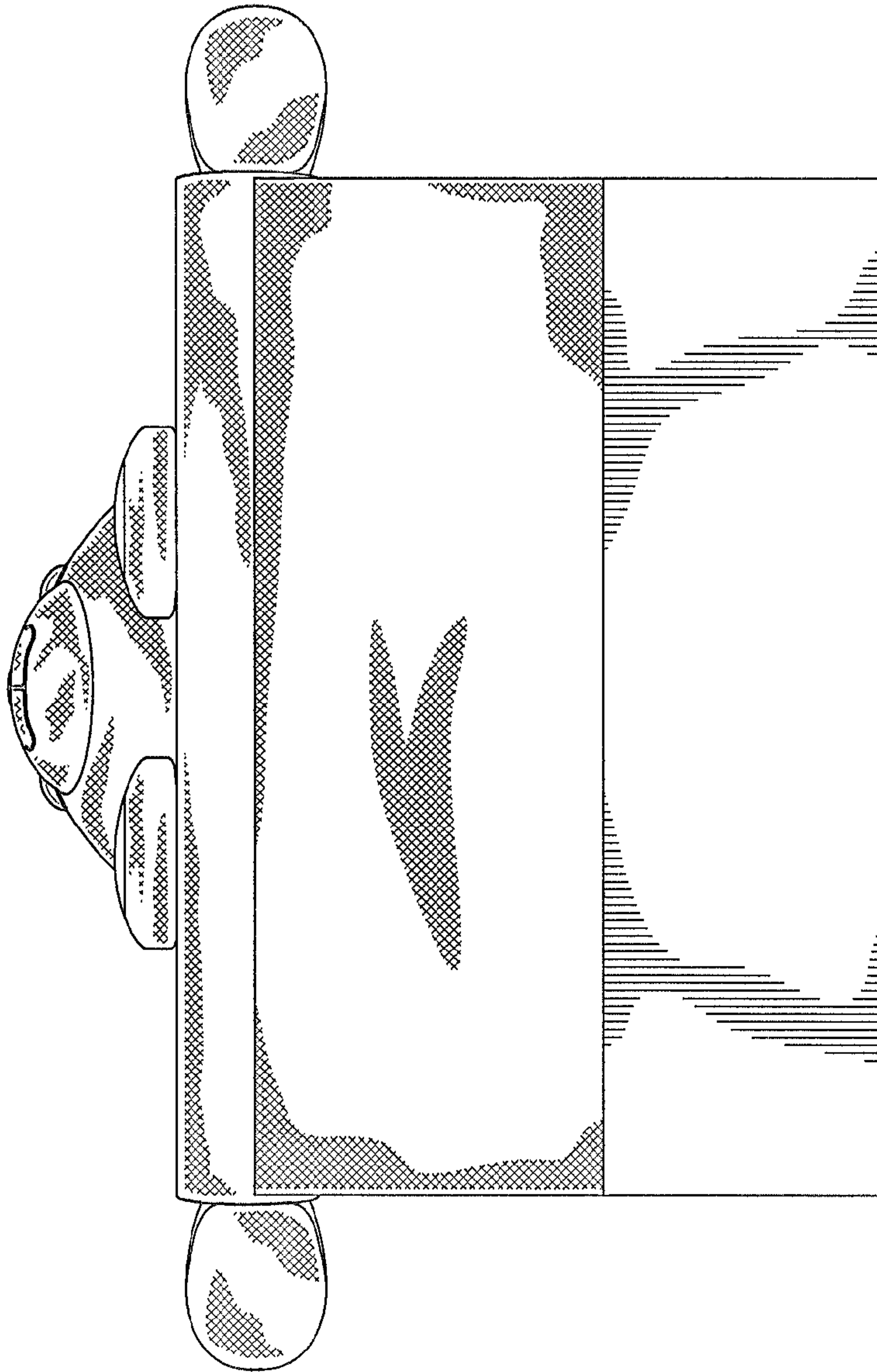

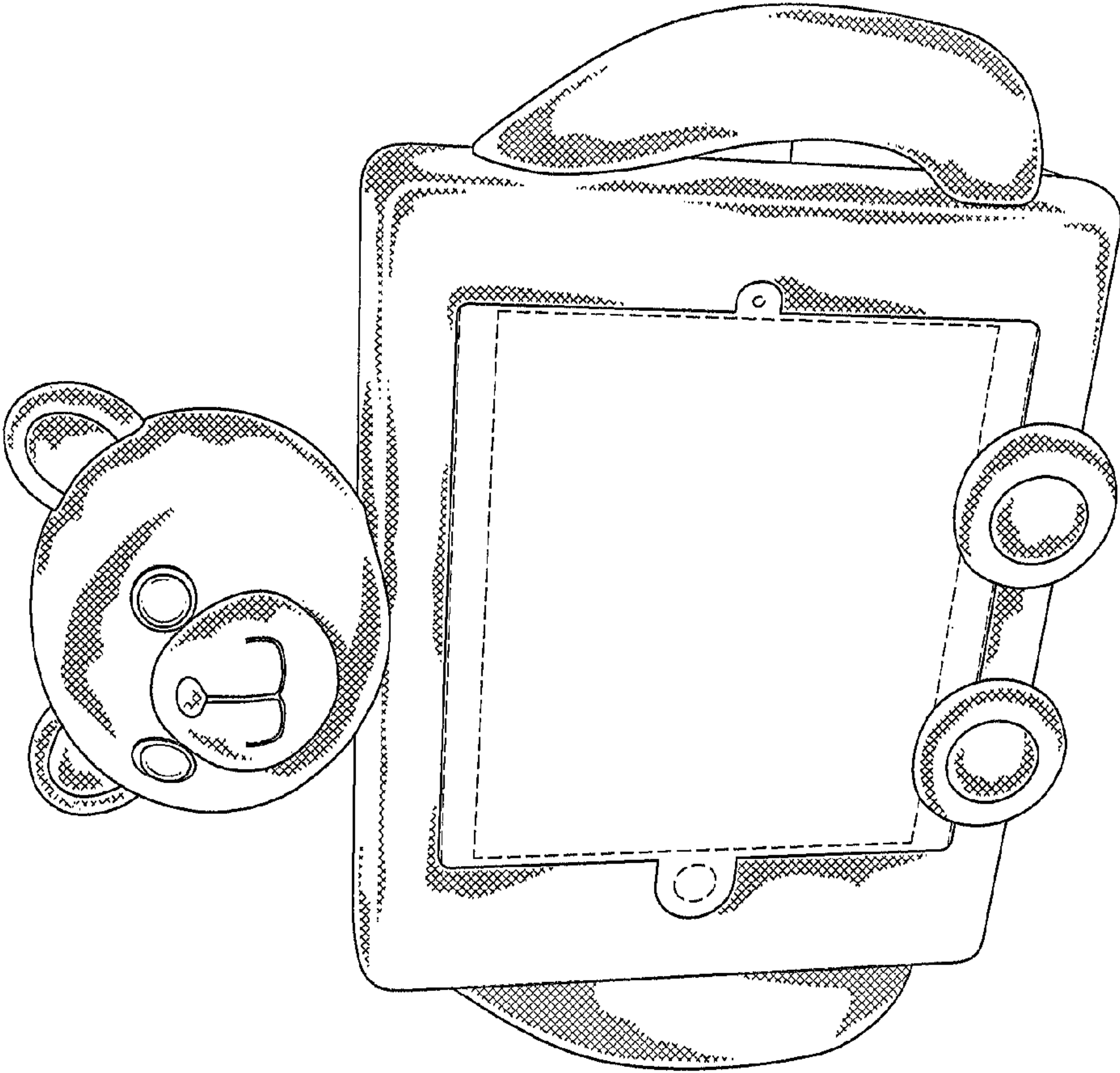
