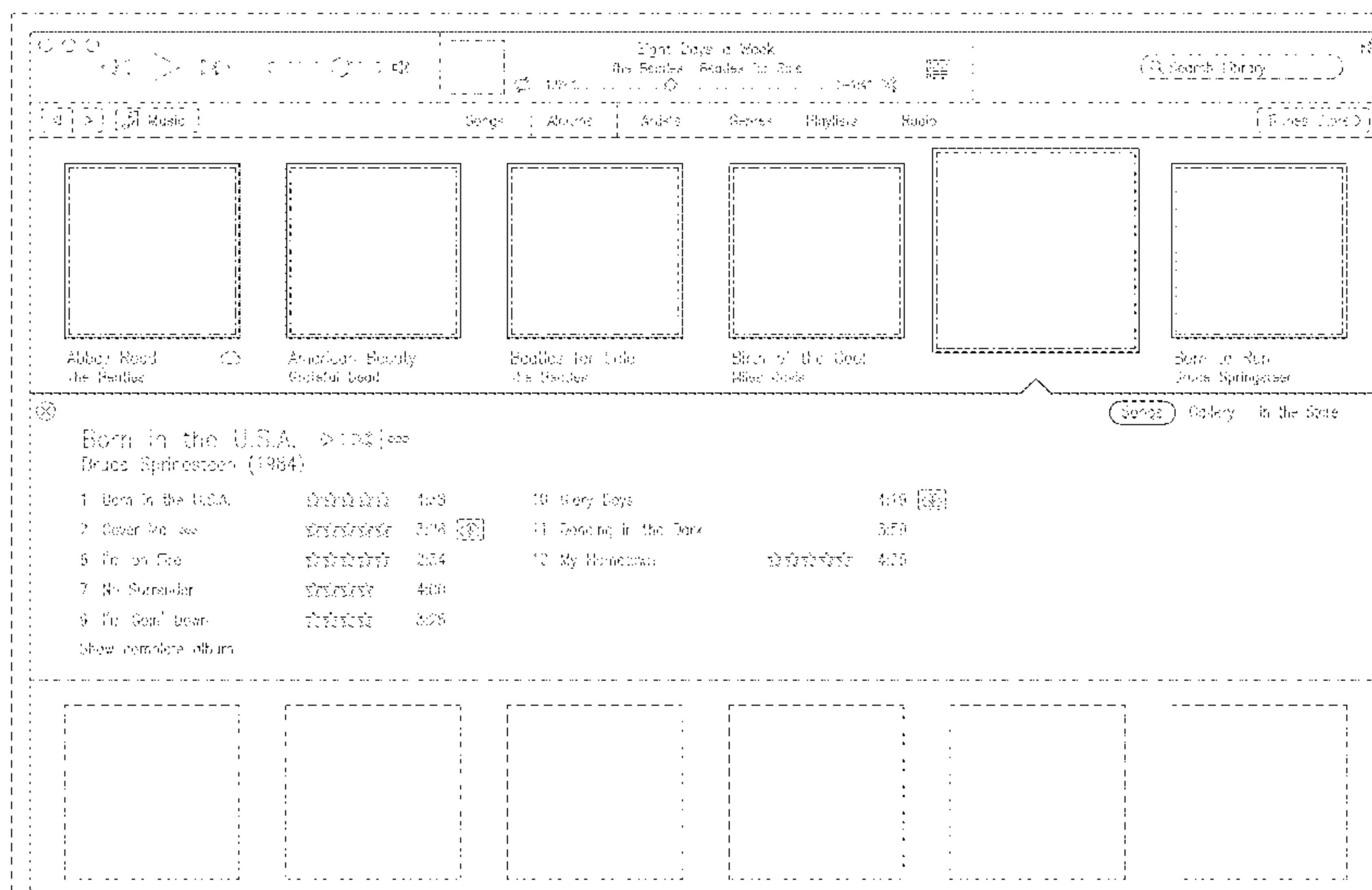
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

The FIGURE is a front view of a display screen or portion thereof with graphical user interface showing our new design. The outermost dashed broken lines in the FIGURE show a display screen or portion thereof, and form no part of the claimed design. The outer dashed broken lines in the FIGURE show portions of the graphical user interface that form no part of the claimed design.
