(57) **CLAIM**

I claim the ornamental design for a cigarette smoke sanitizing spray dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a cigarette smoke sanitizing spray dispenser, with environmental structure in the form of a cigarette box;

FIG. 2 is a side view of FIG. 1;

FIG. 3 is a perspective view of the cigarette smoke sanitizing spray dispenser of the invention;

FIG. 4 is a front view thereof;

FIG. 5 is a back view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a left side view thereof;

FIG. 8 is a top view thereof; and,

FIG. 9 is a bottom view thereof.

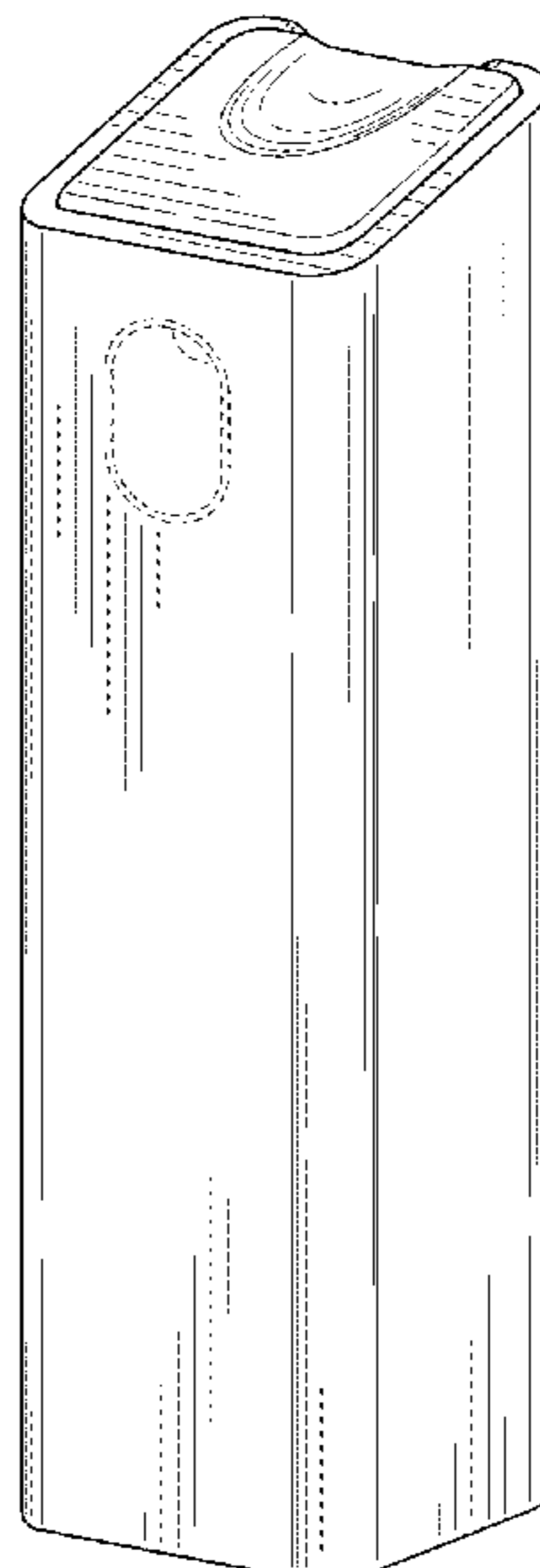

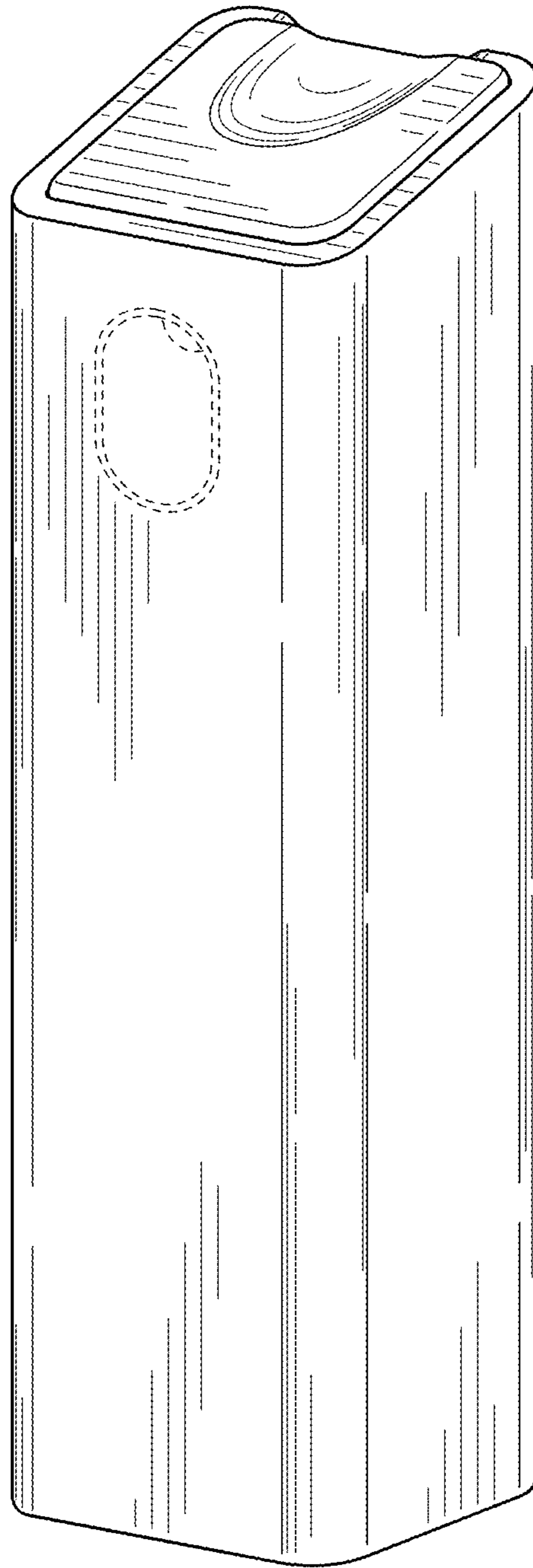

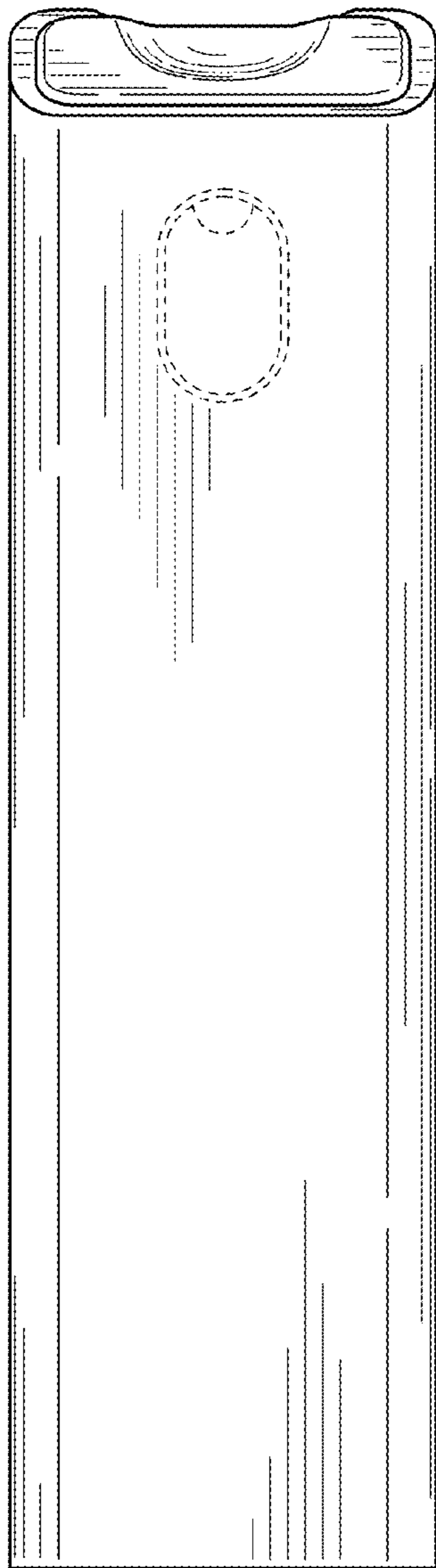

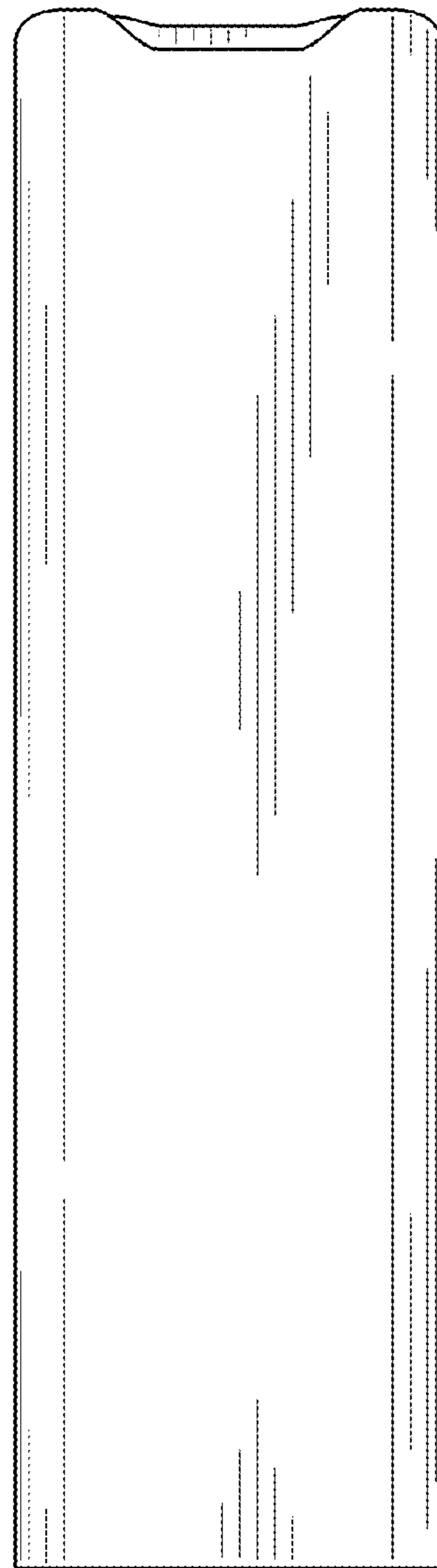

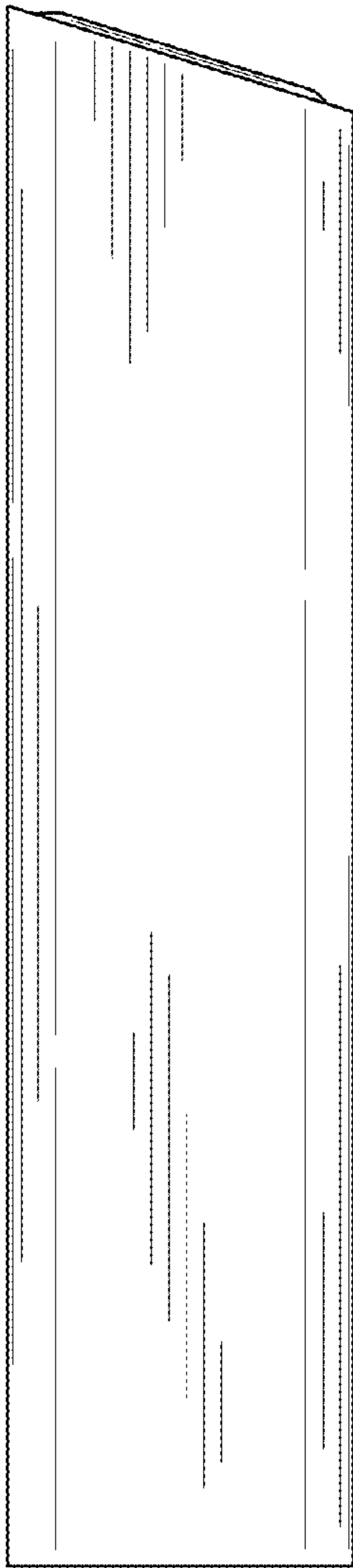

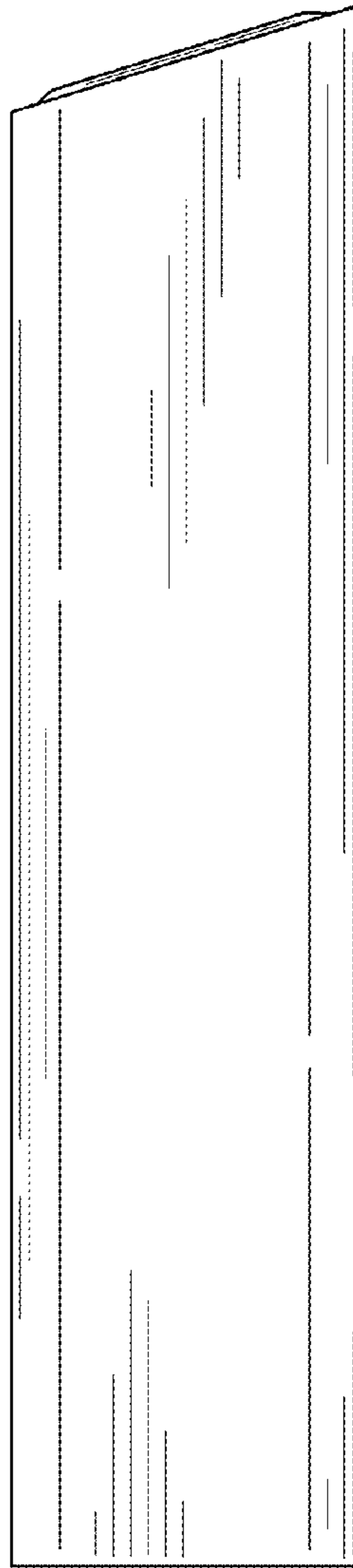

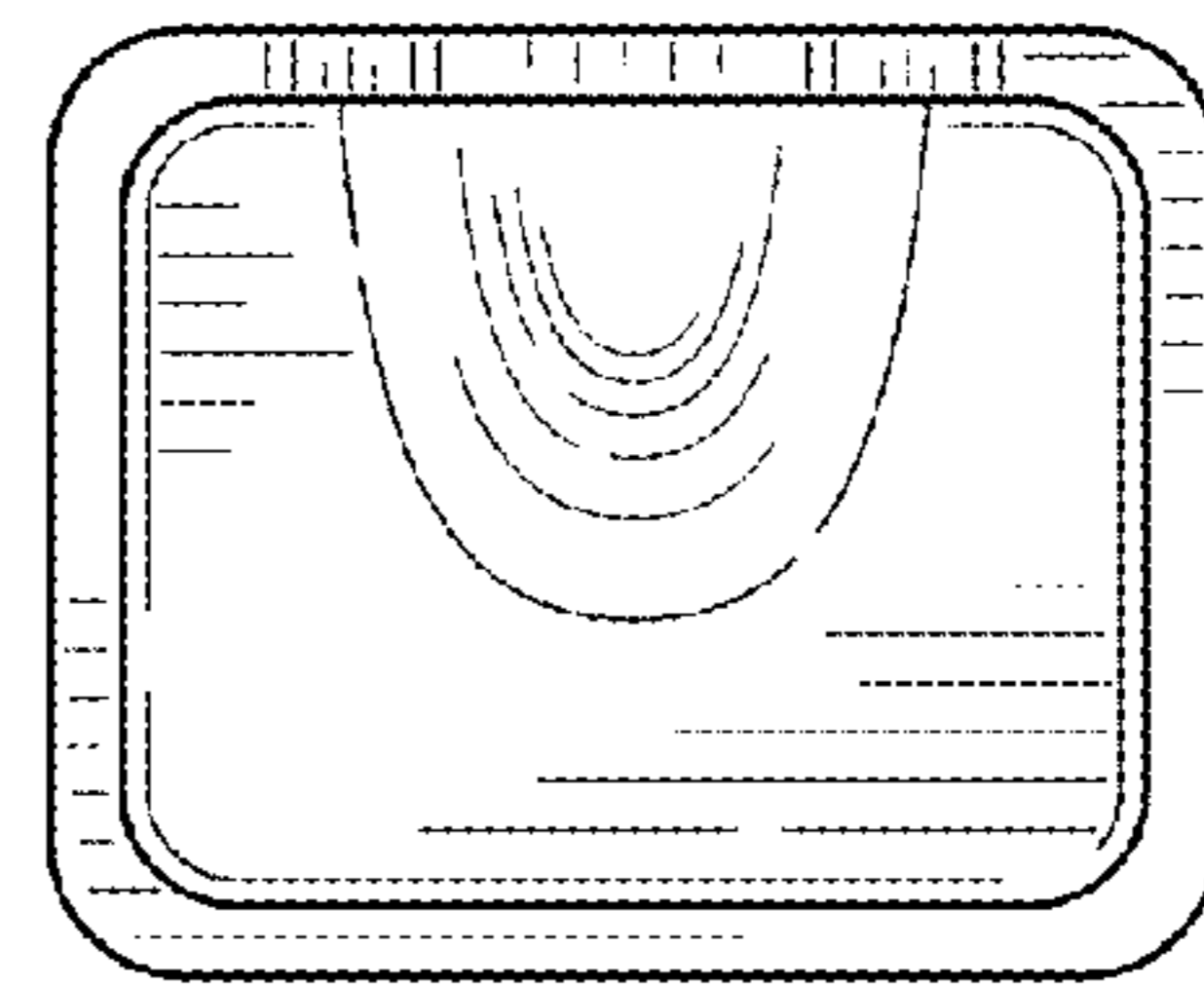

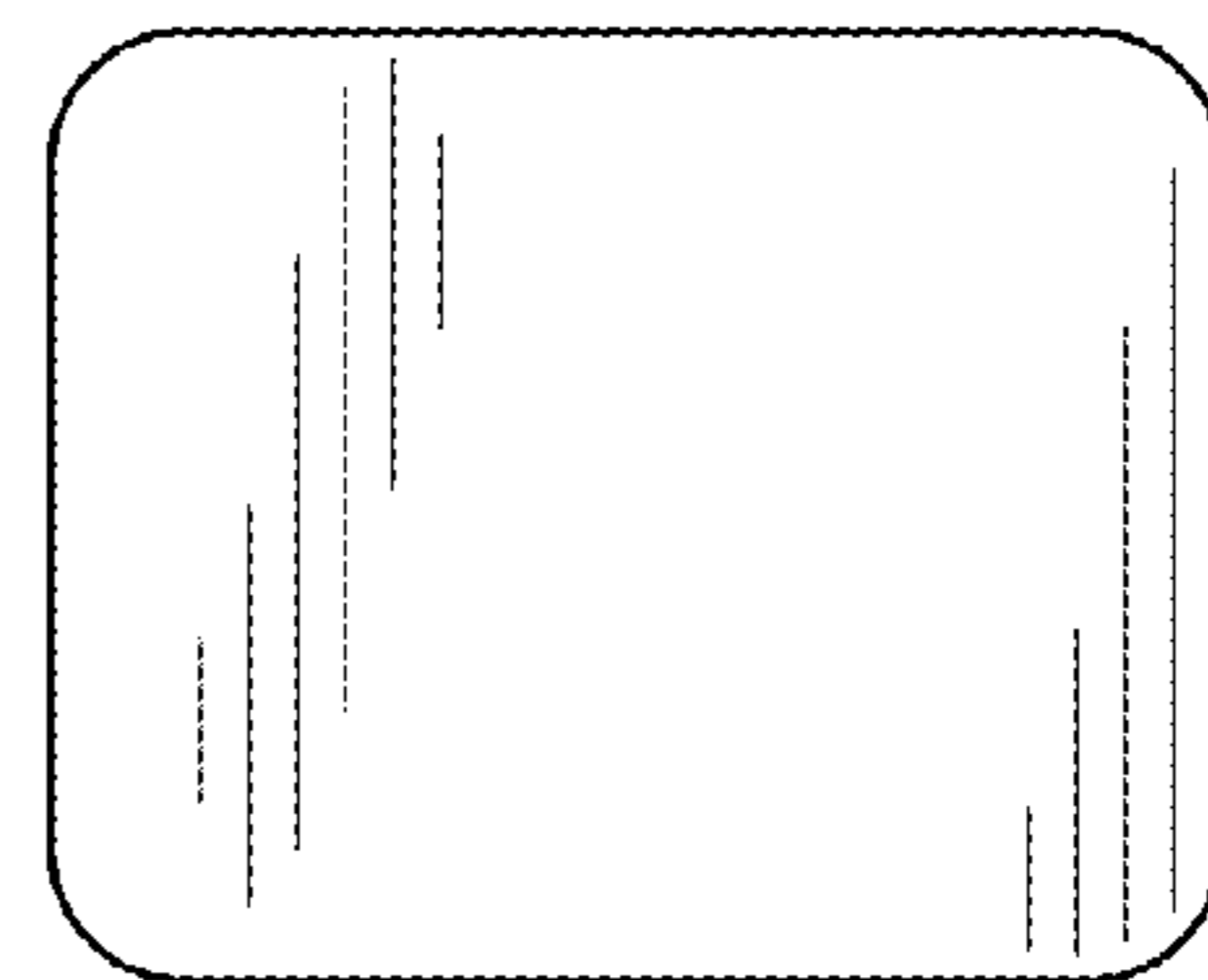
