FIG. 2 is a front view of the postpartum abdominal support.

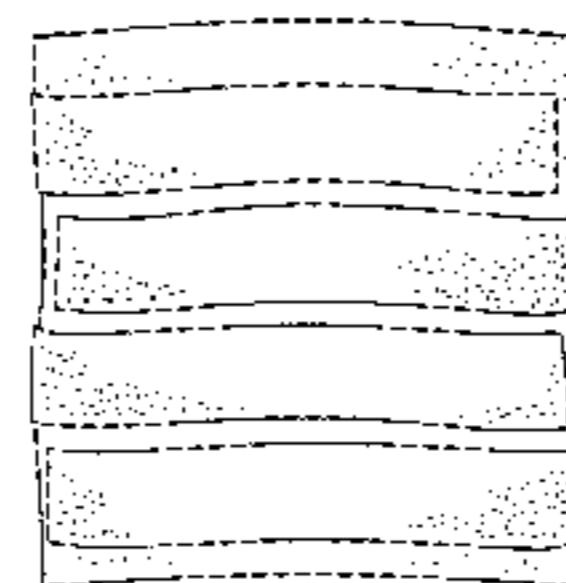
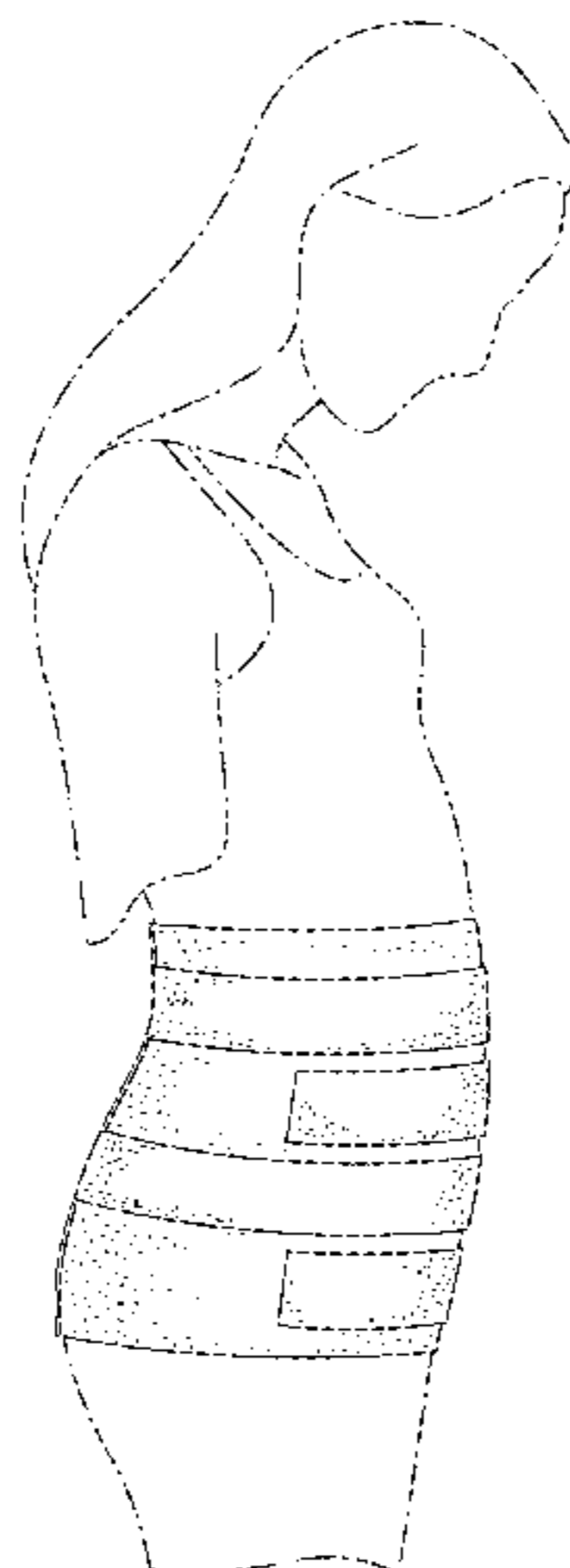
FIG. 3 is a rear view thereof.

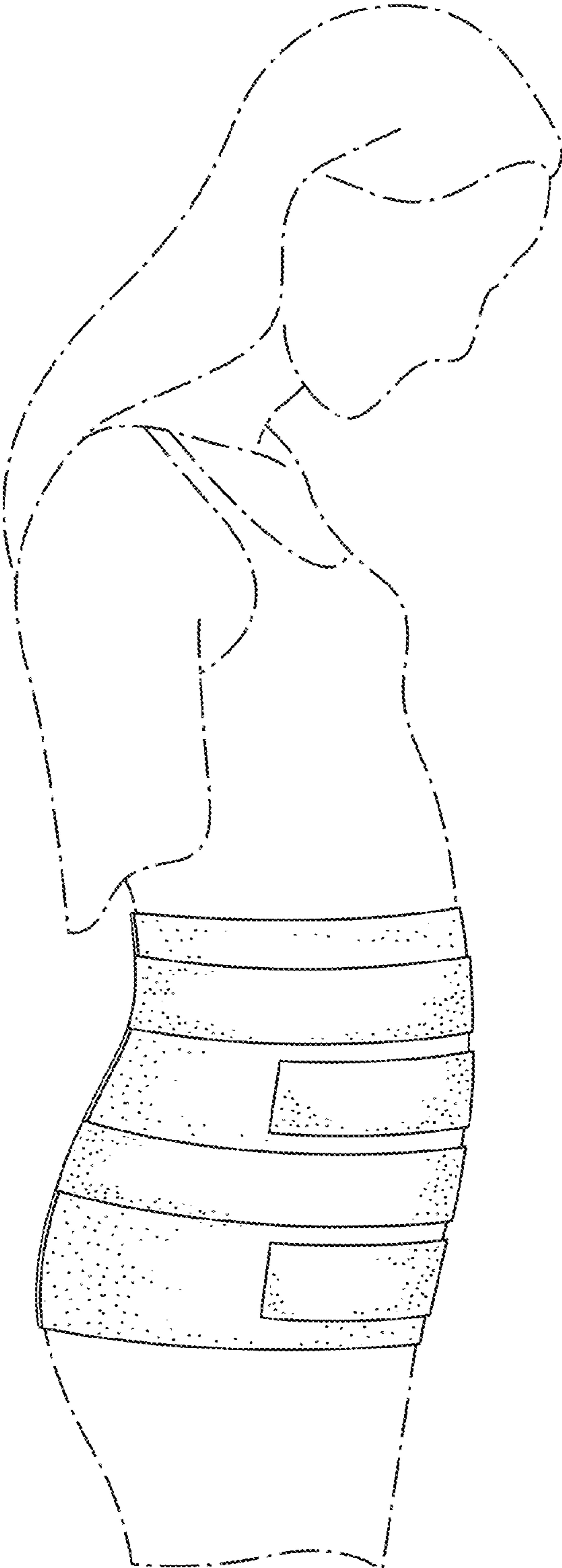

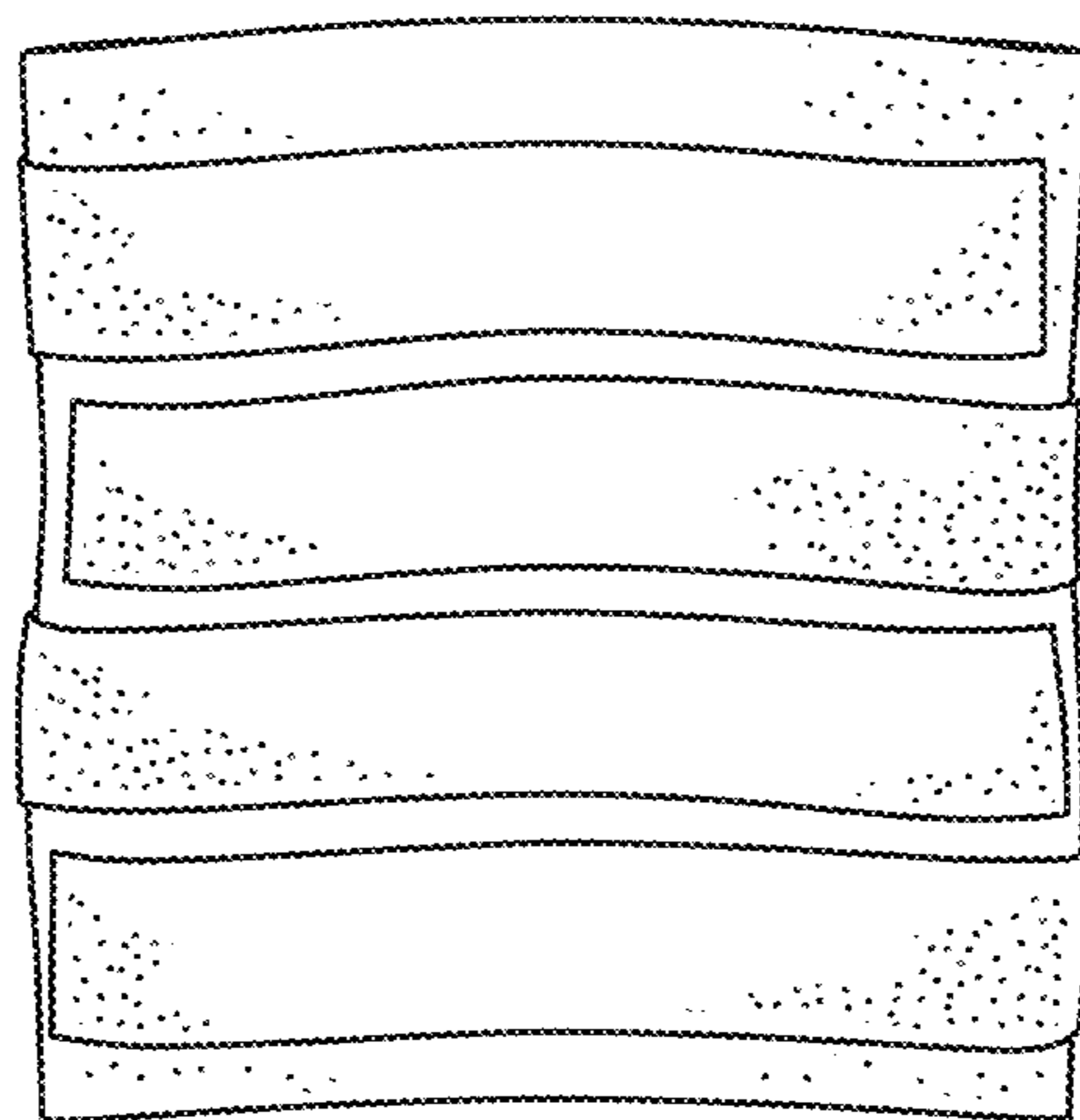

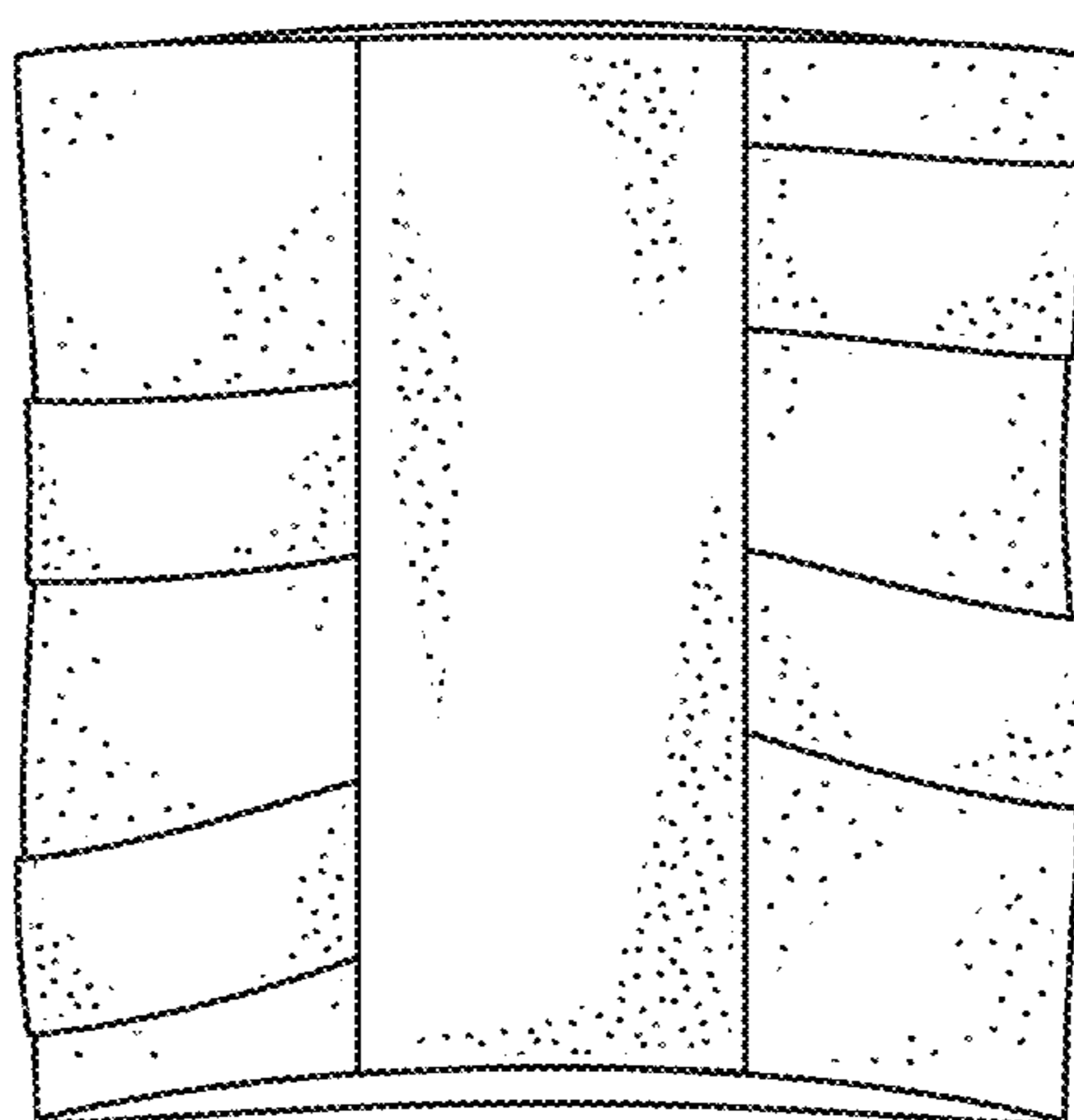

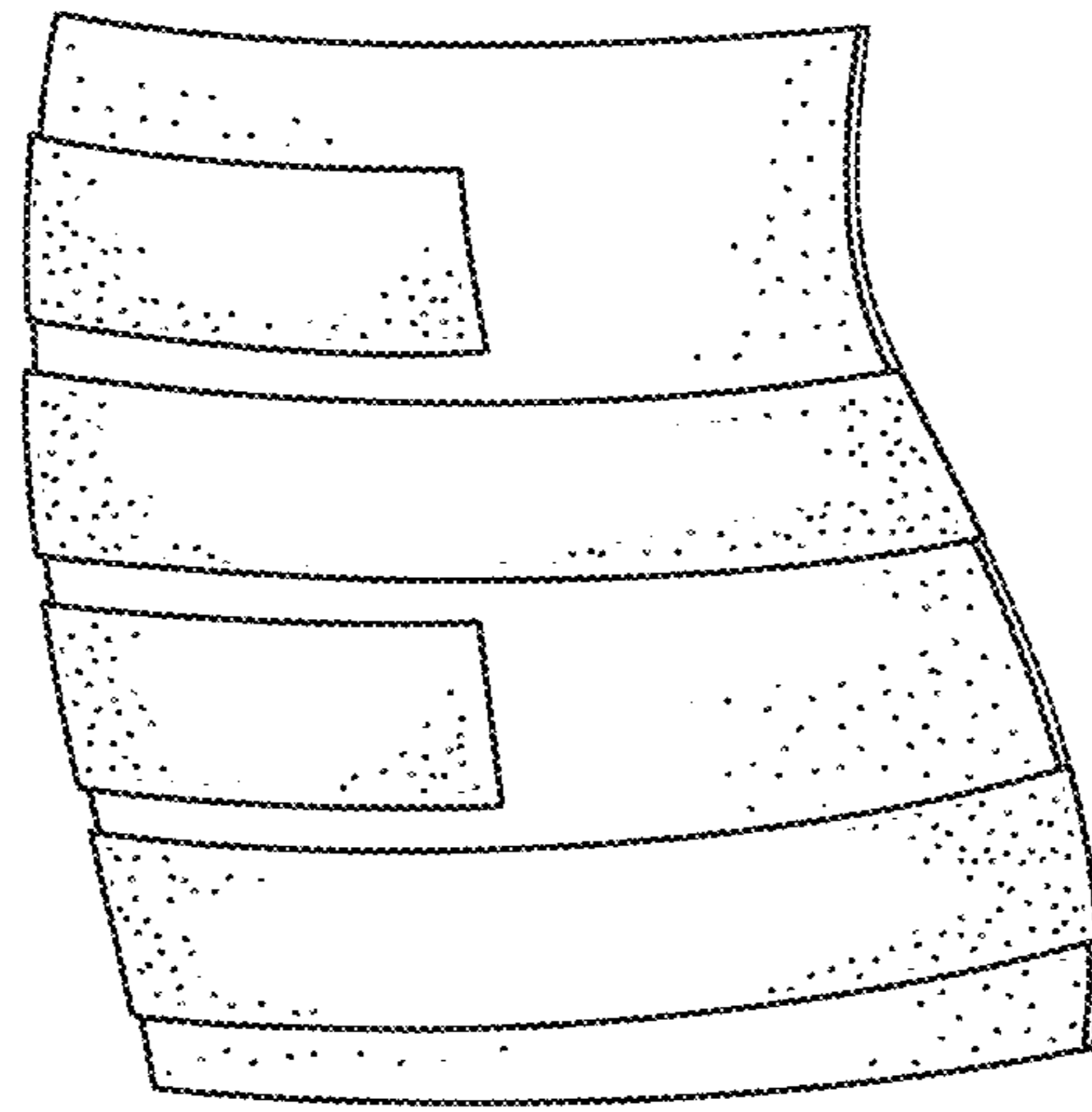

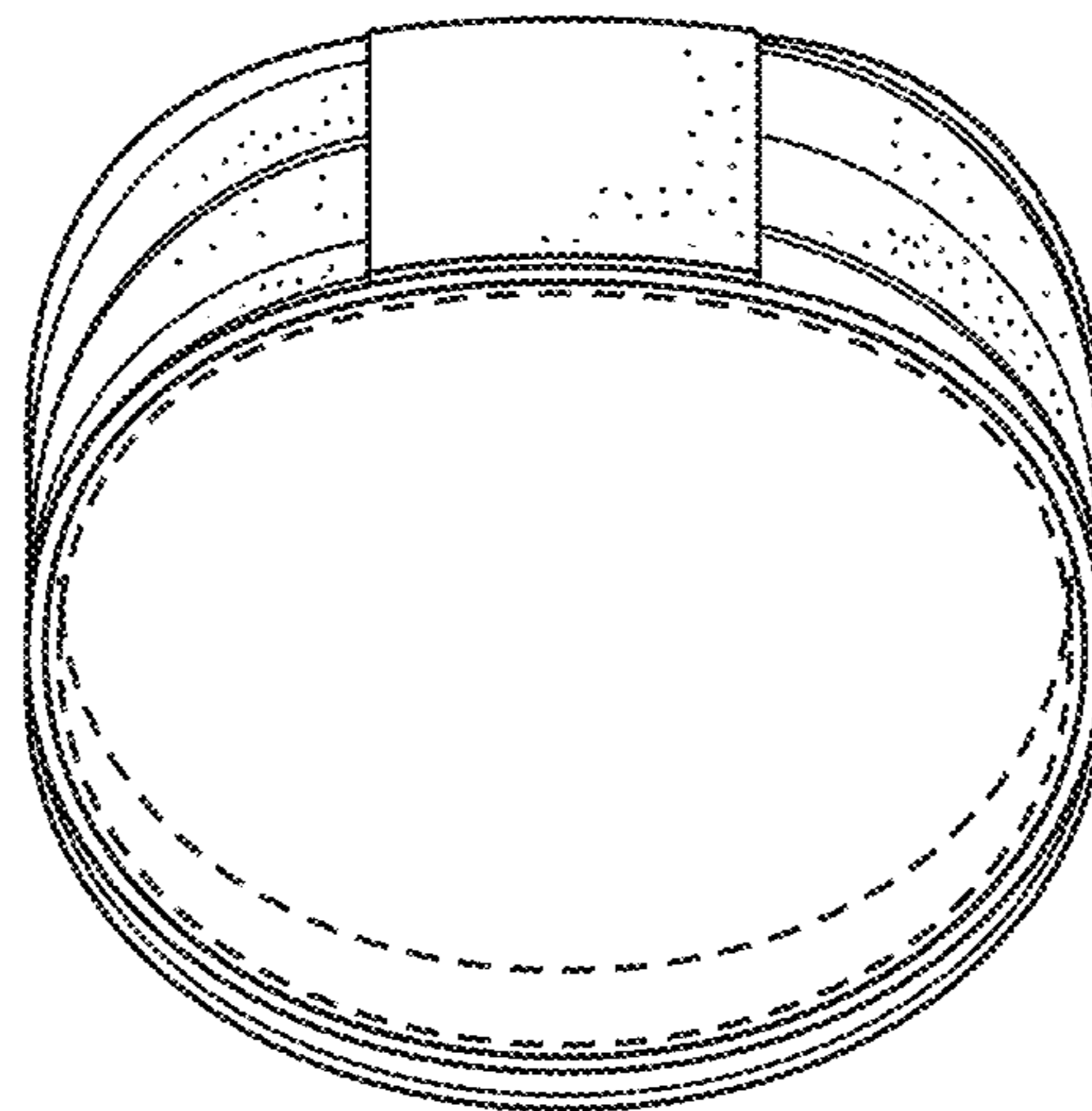
