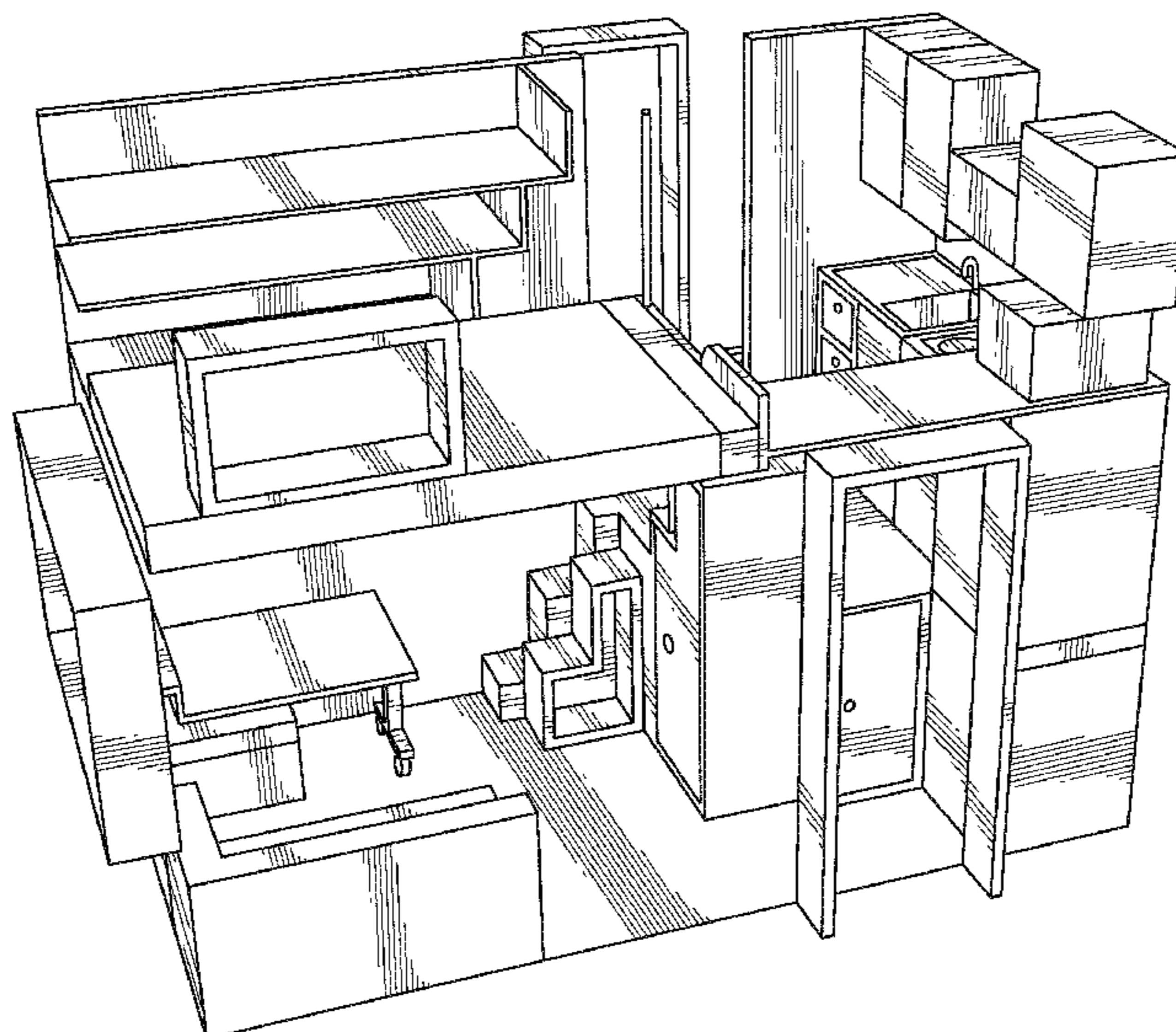
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right side elevation view of a room arrangement showing my new design;
FIG. 2 is a rear elevation view thereof;

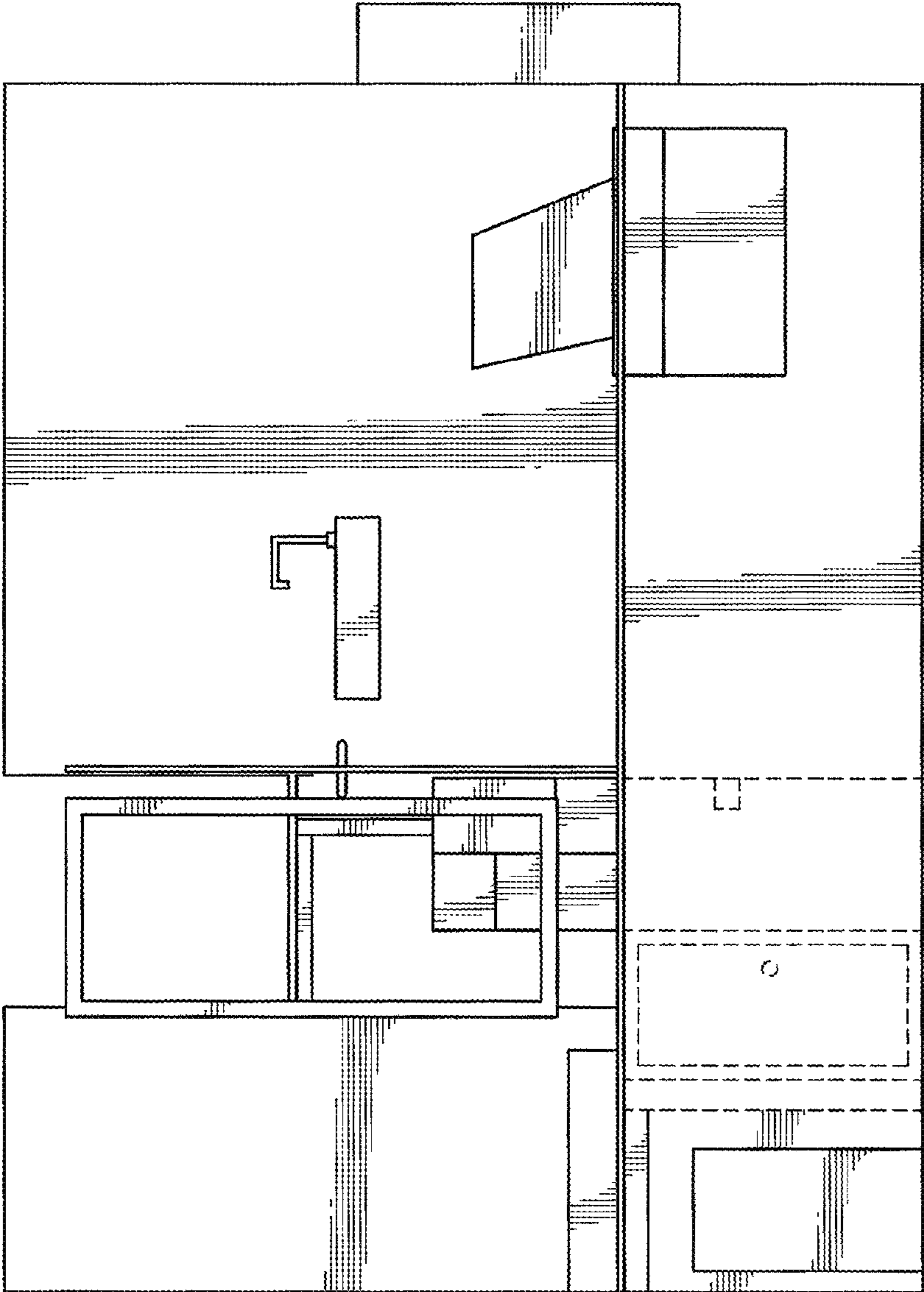

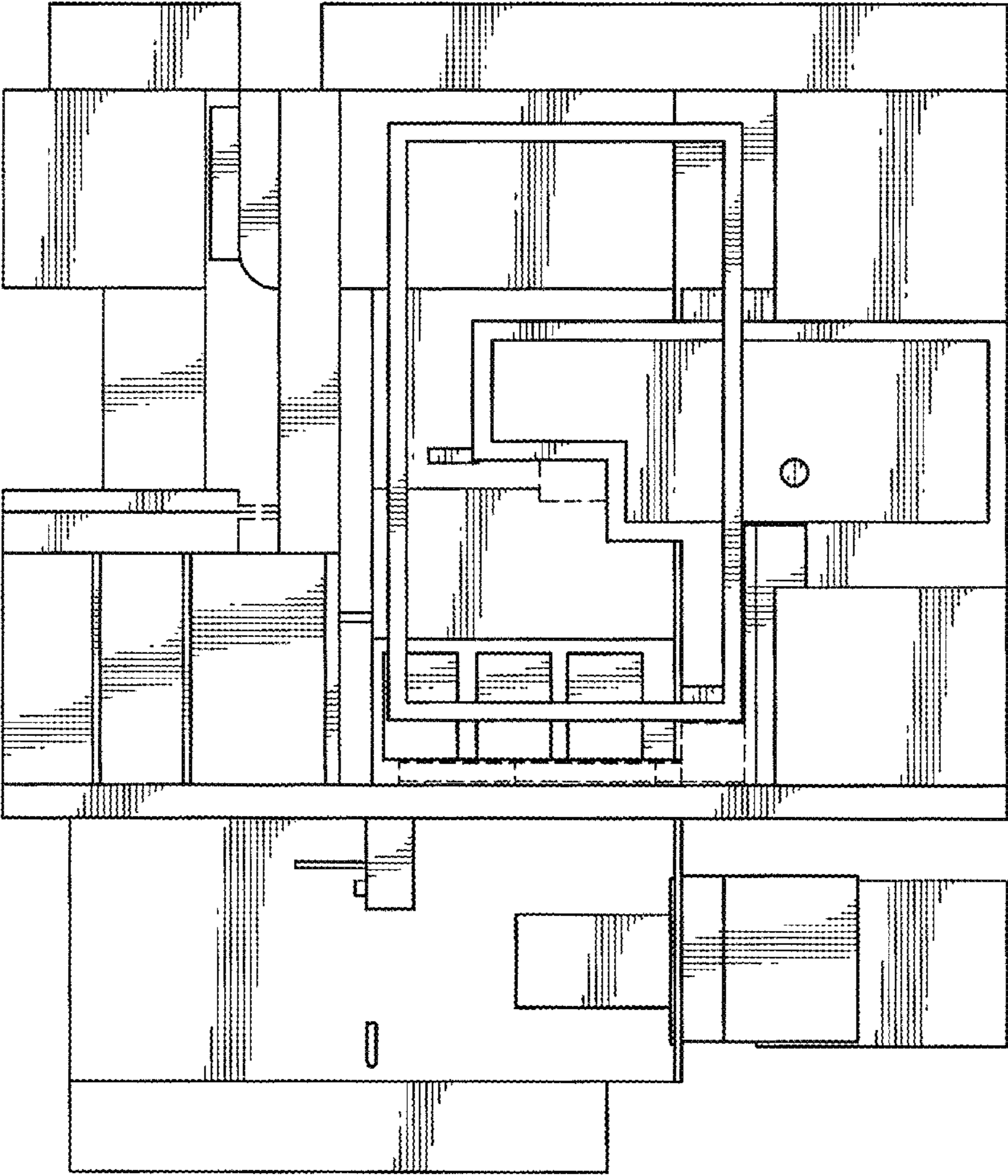

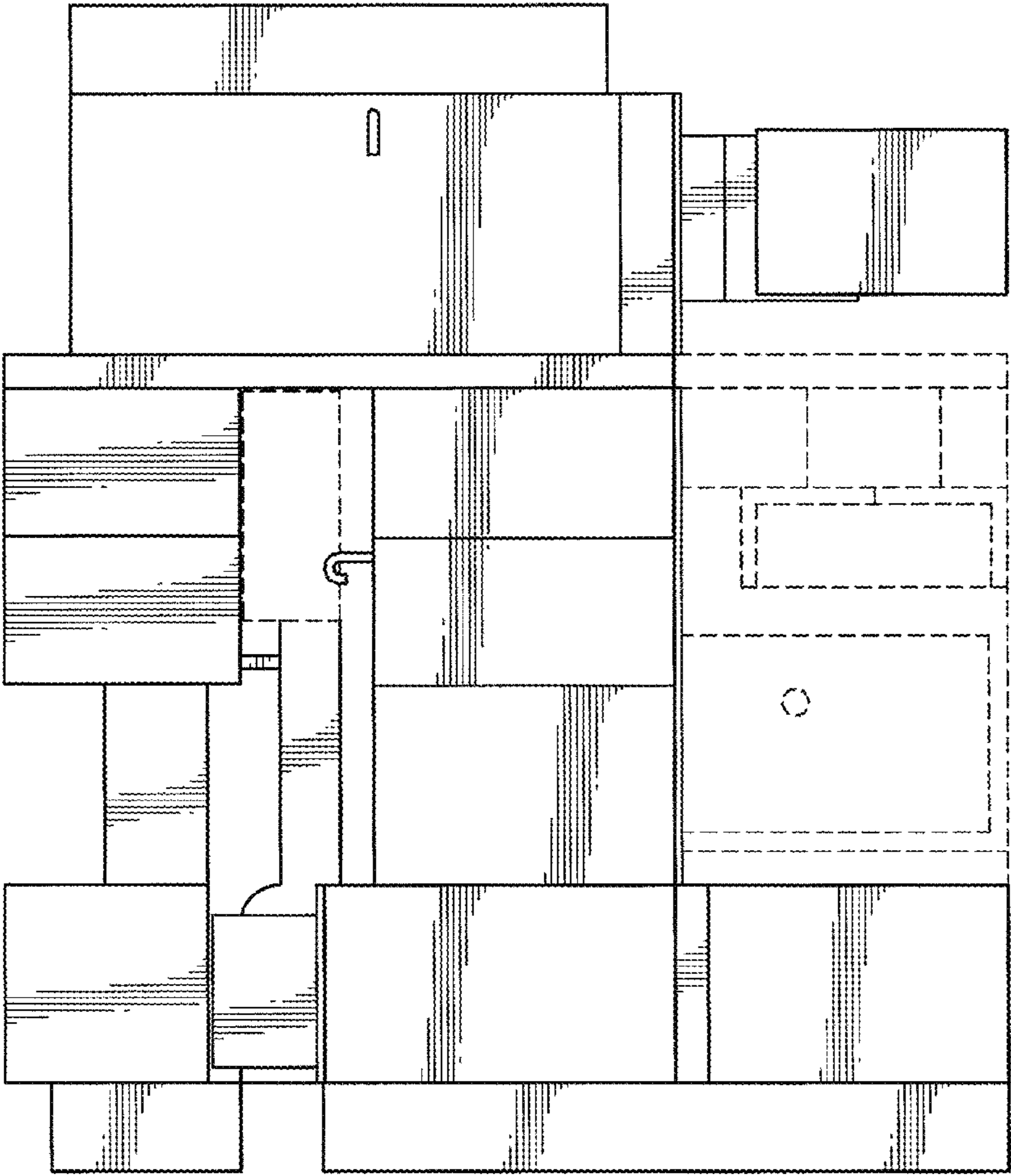

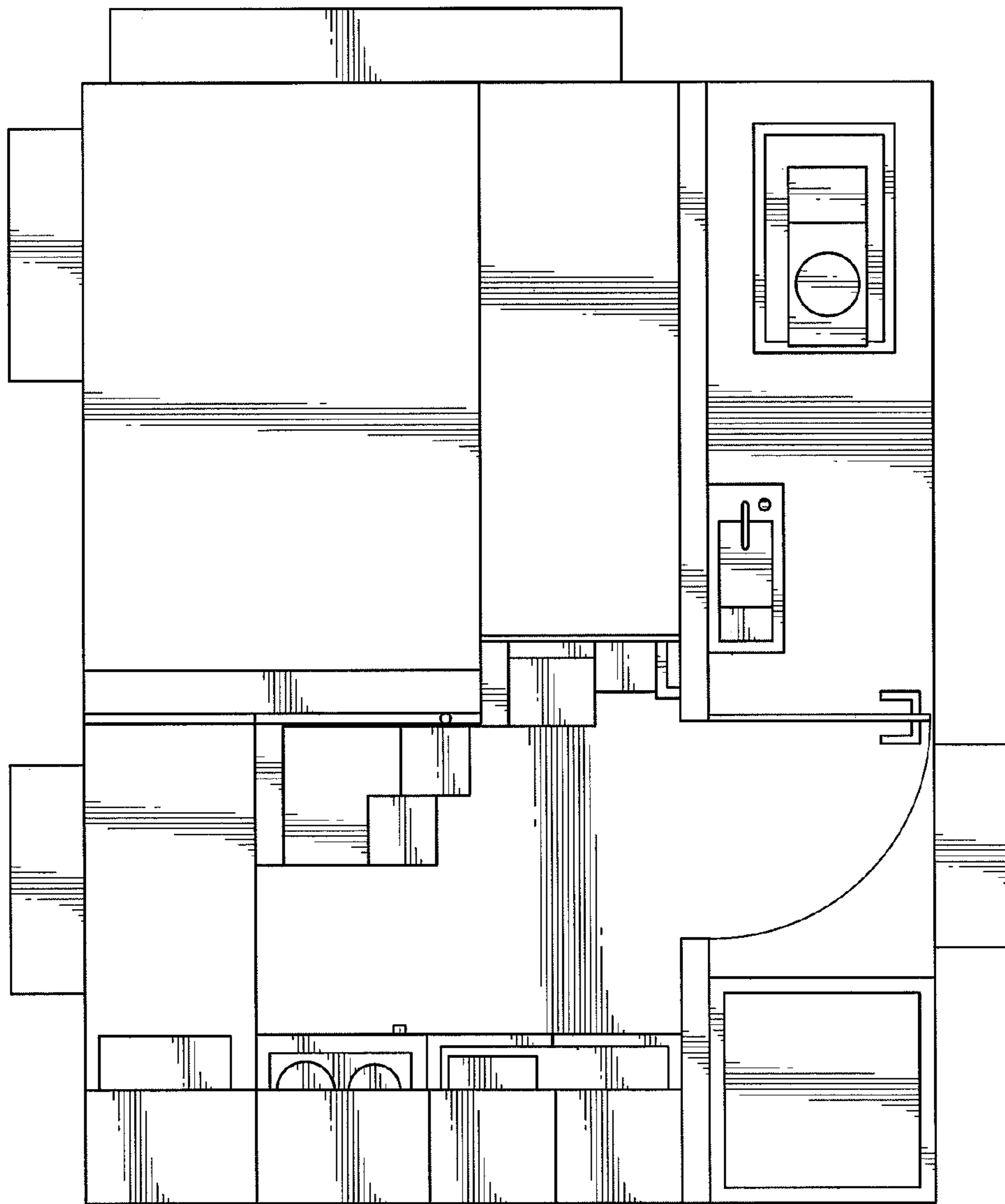

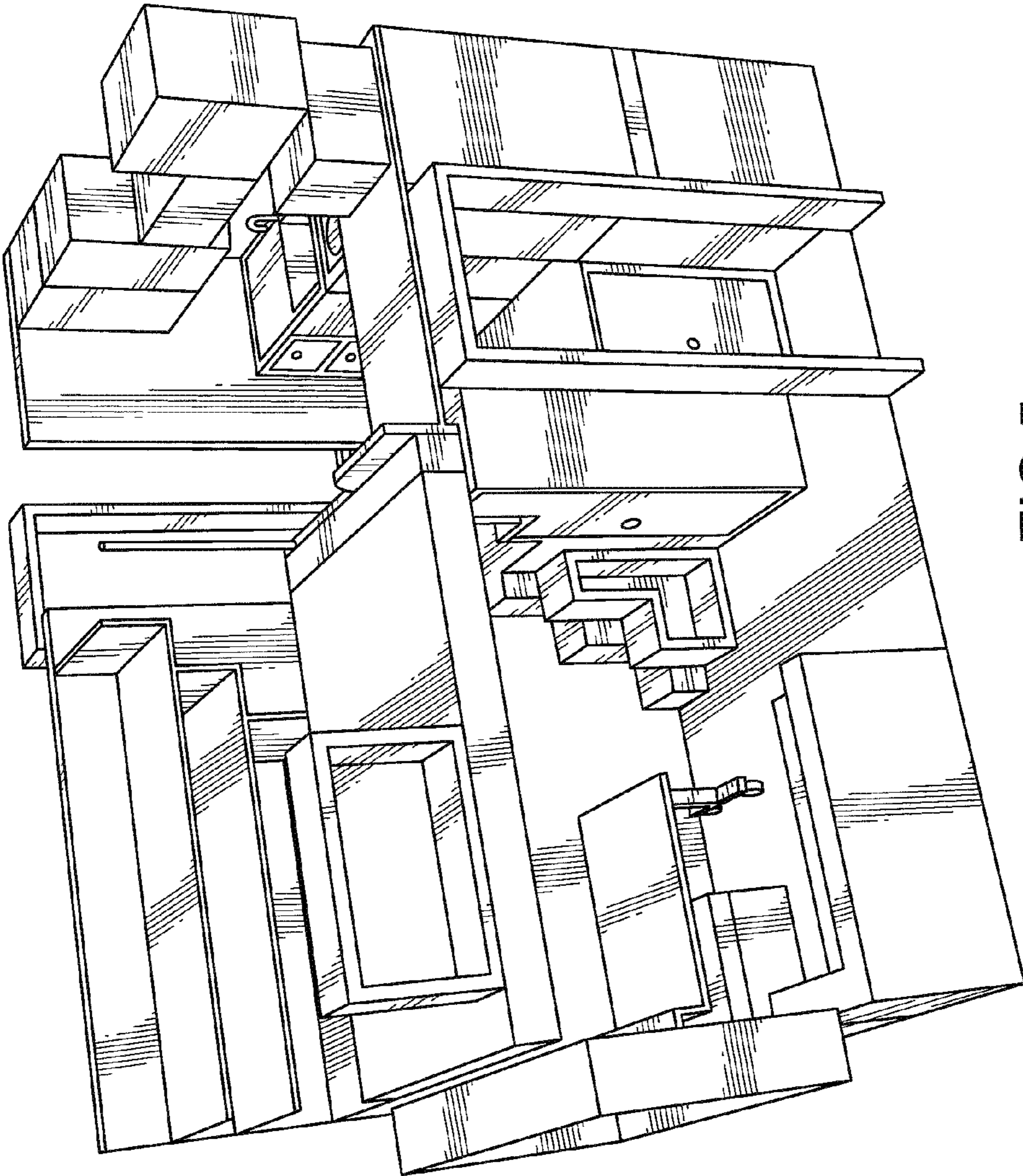

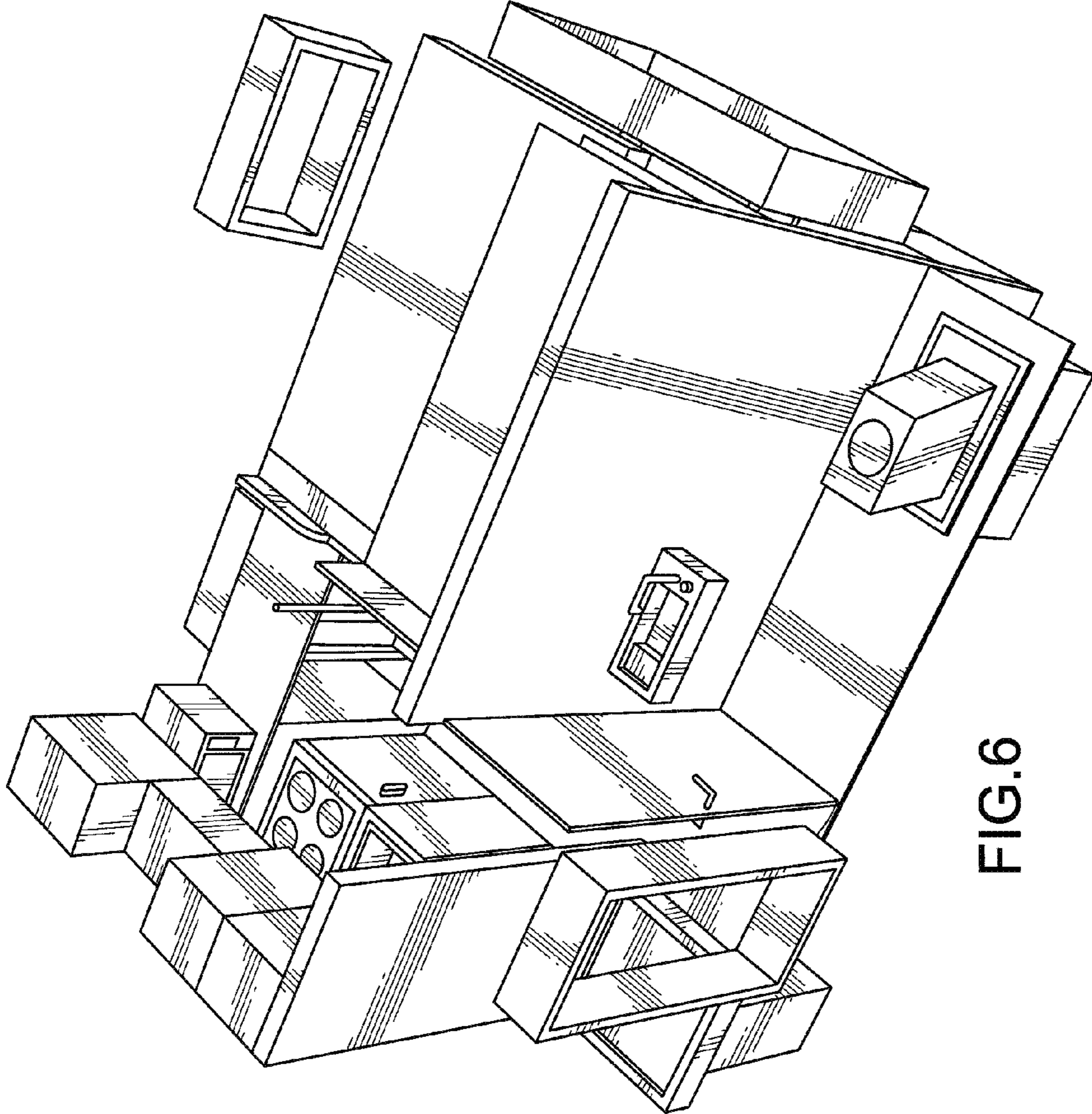

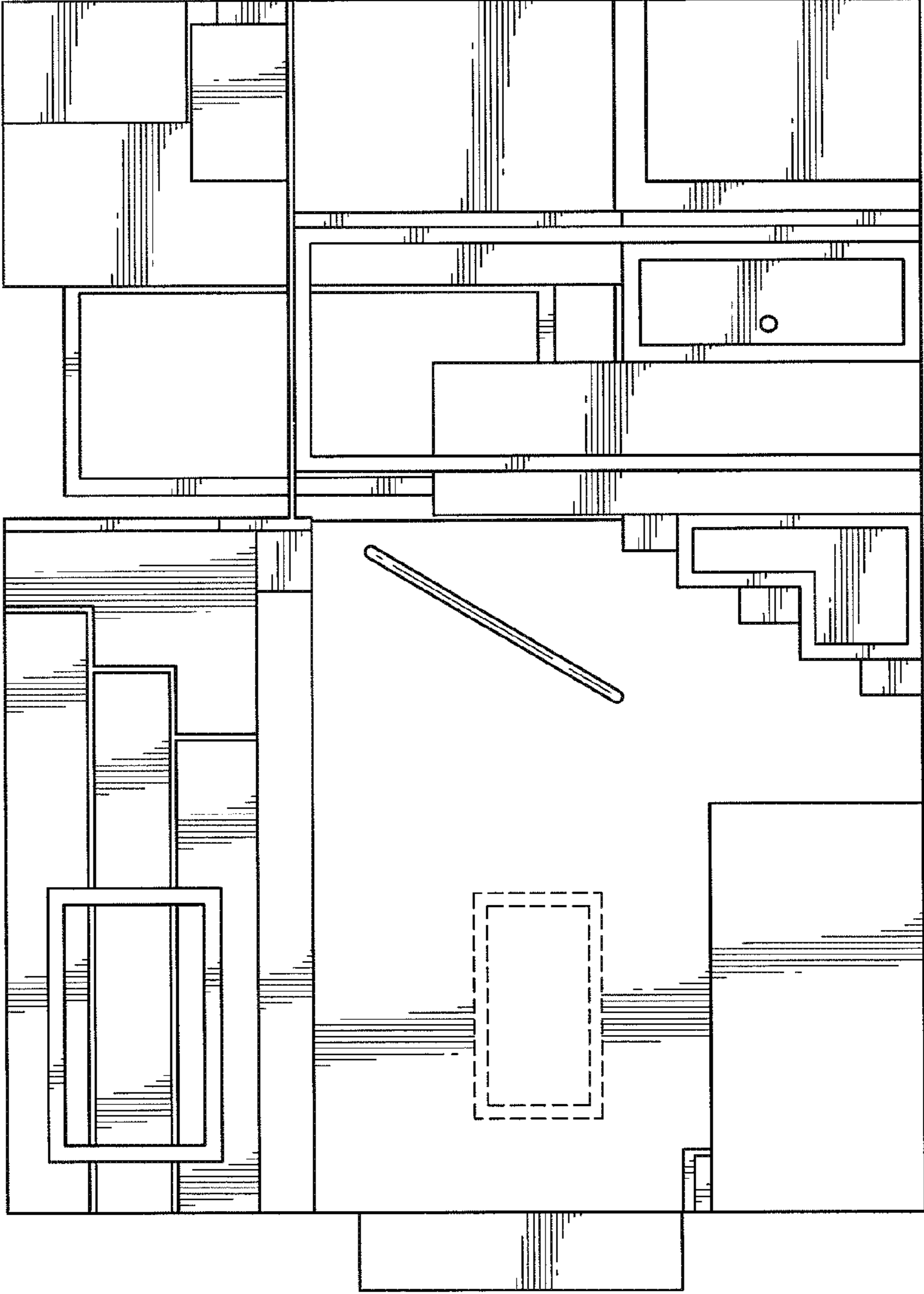
