The ornamental design for an electronic cigarette casing, as shown and described.

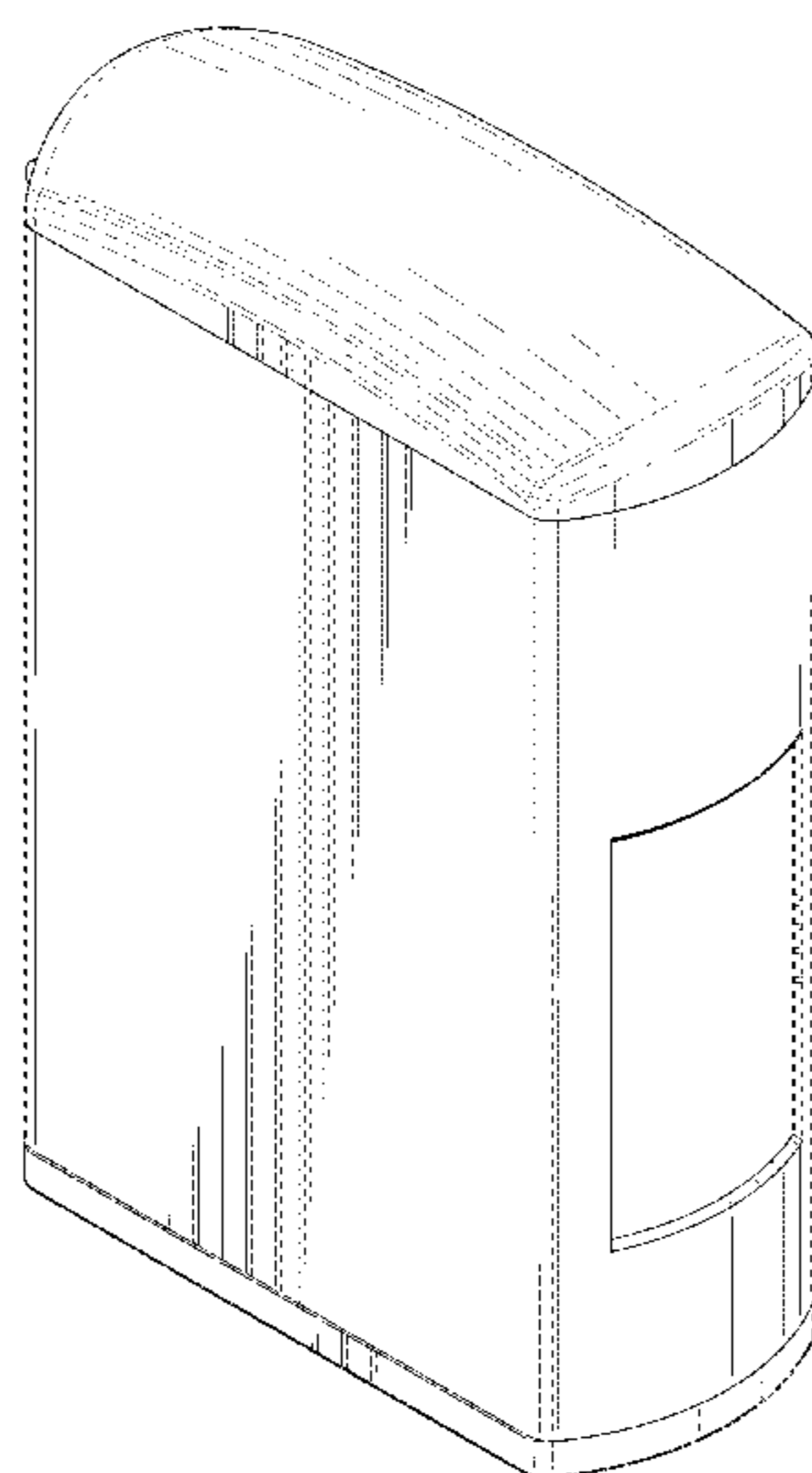
**DESCRIPTION**

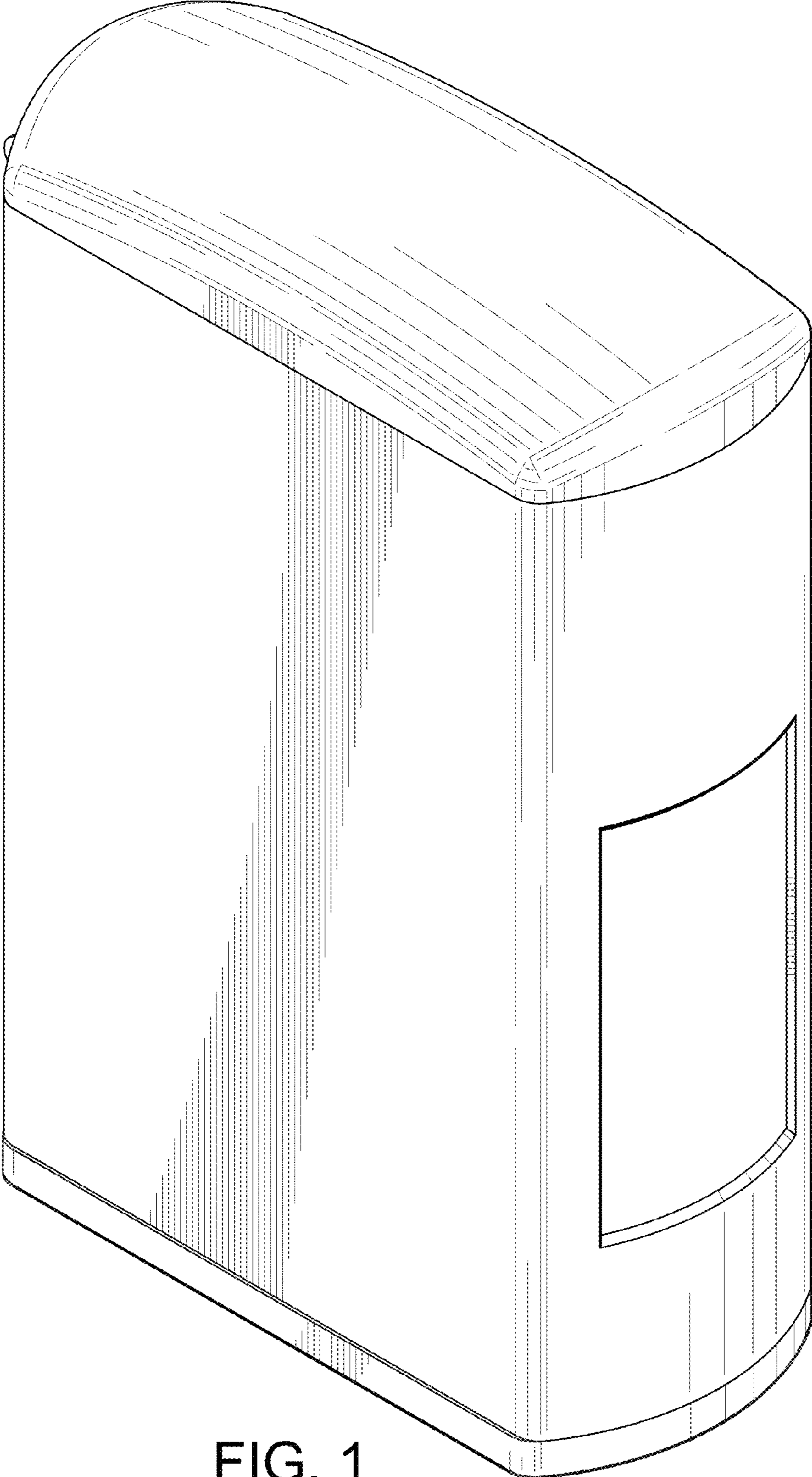

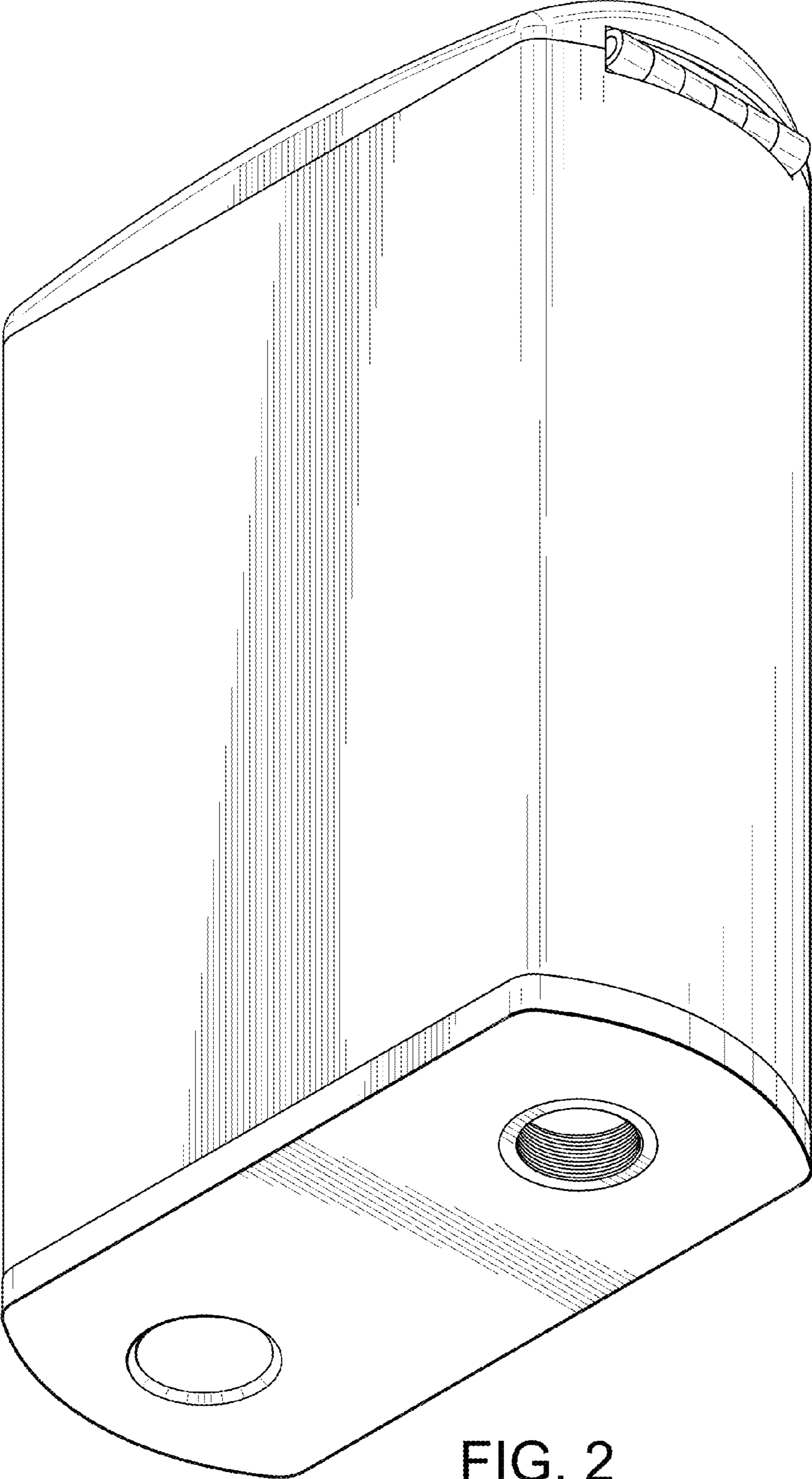

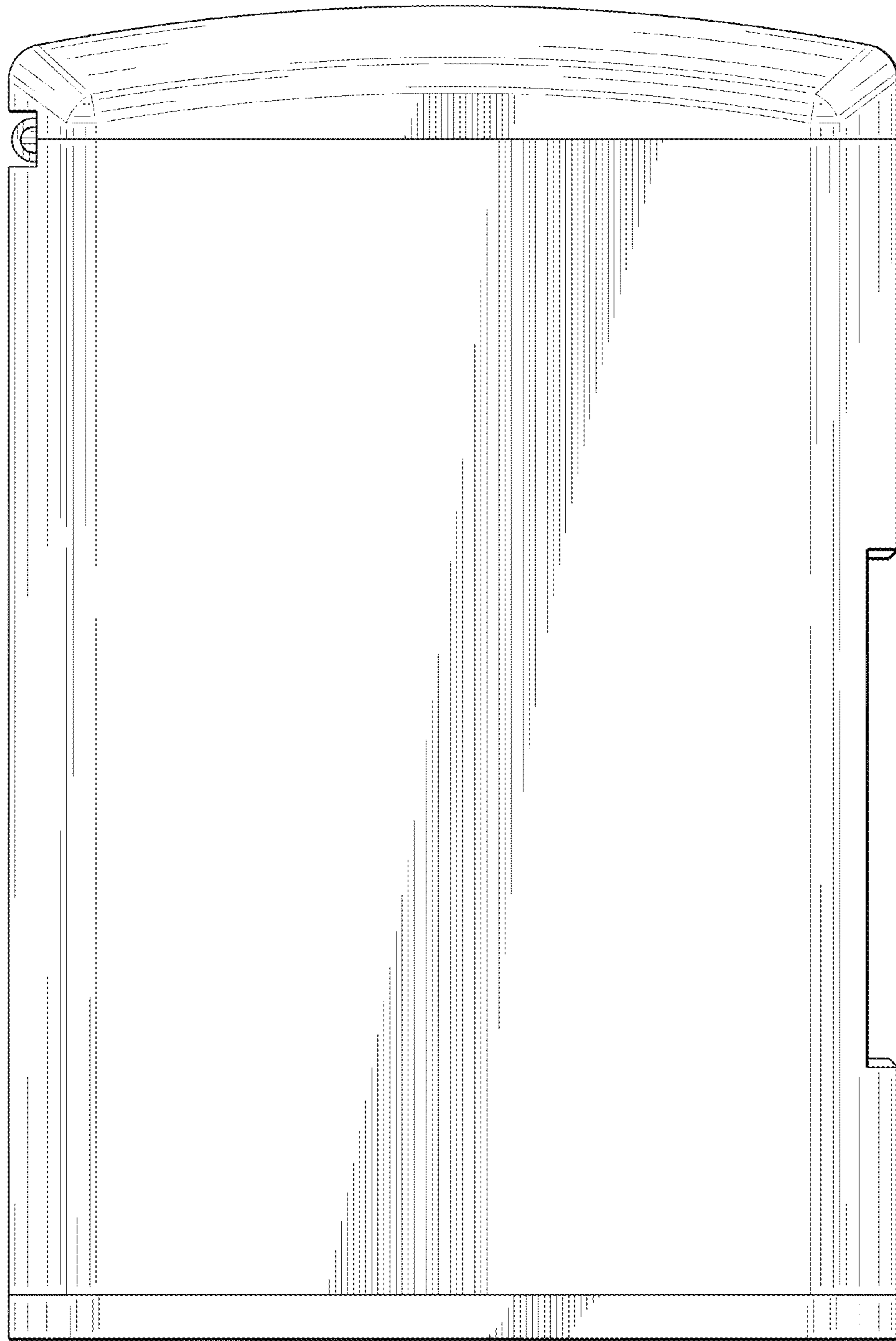

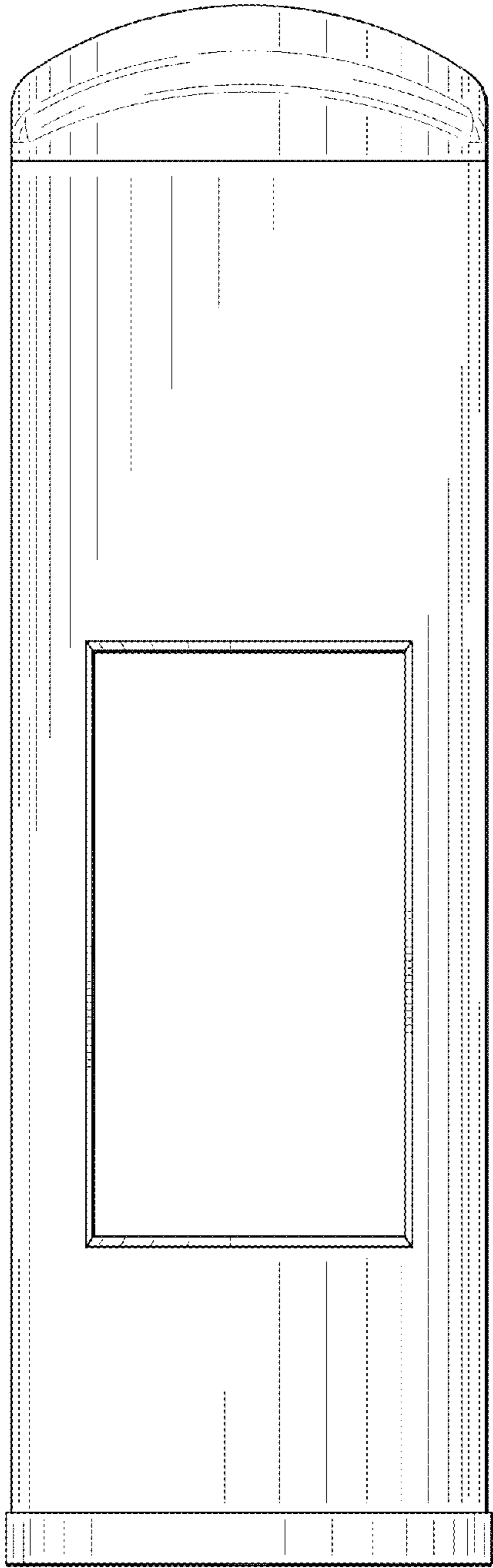

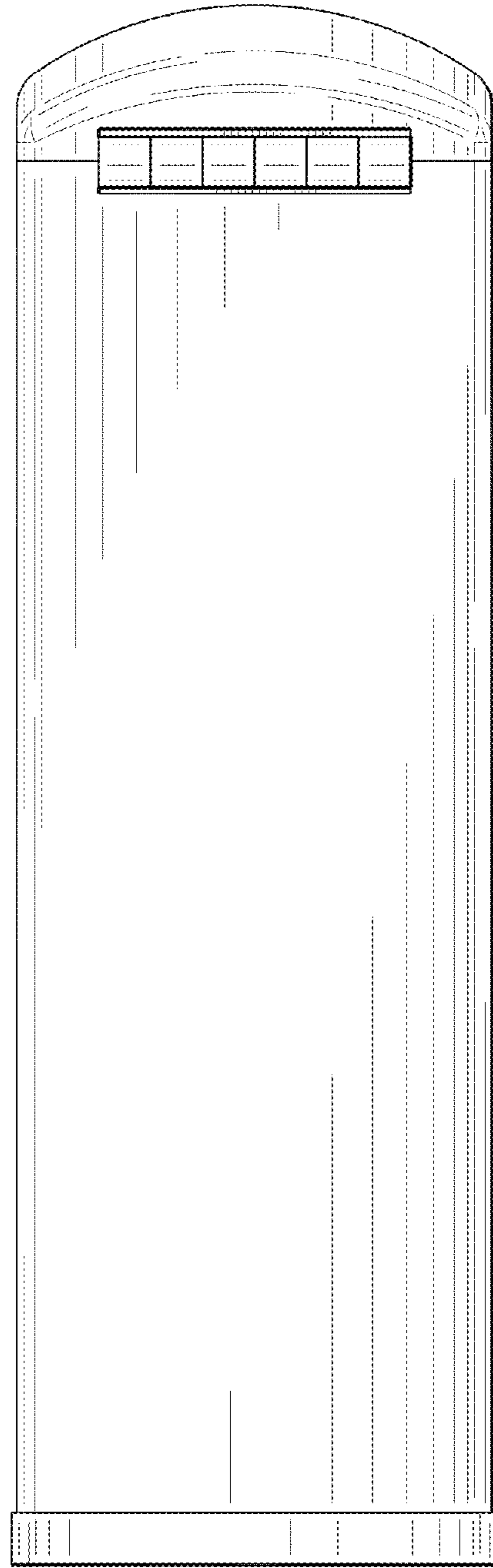

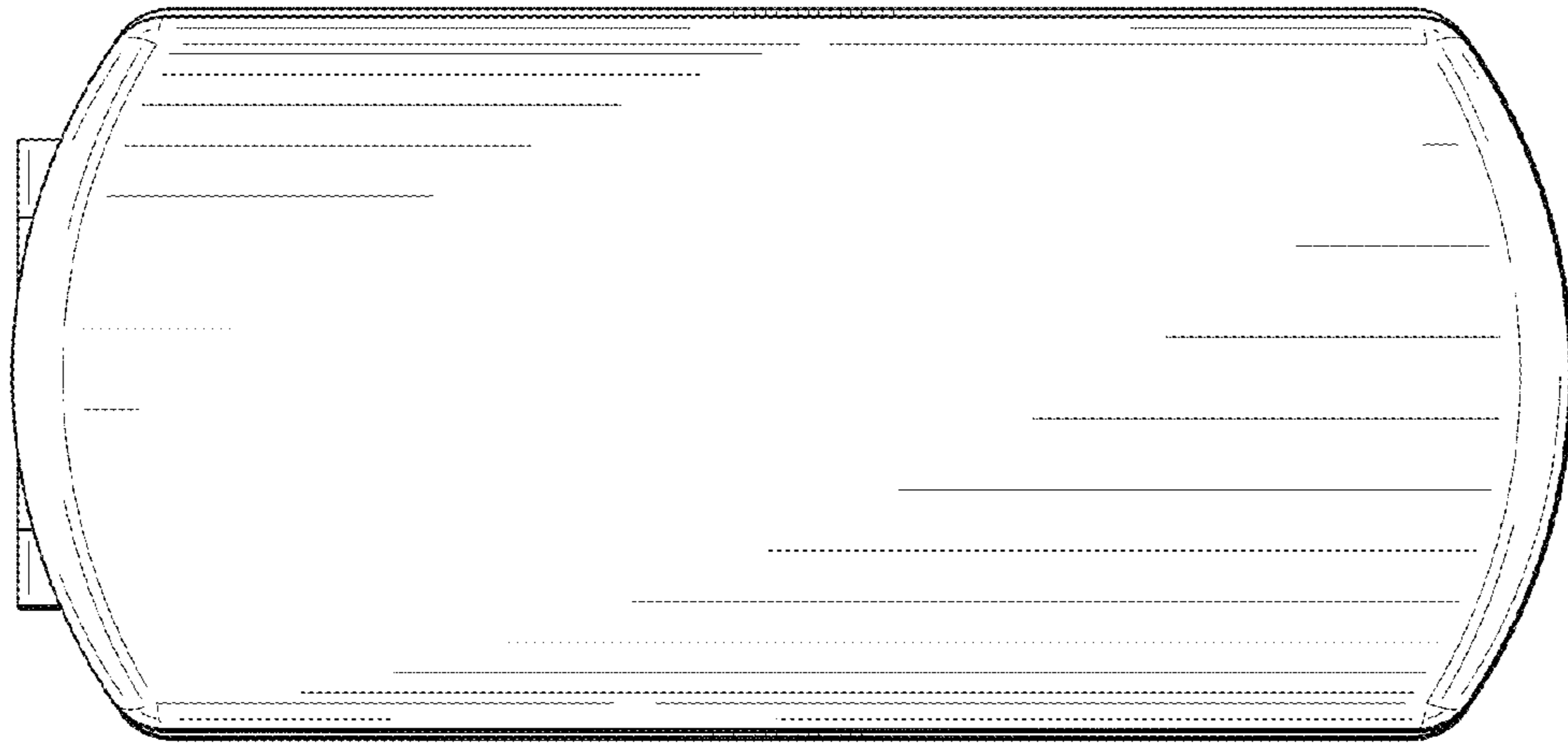

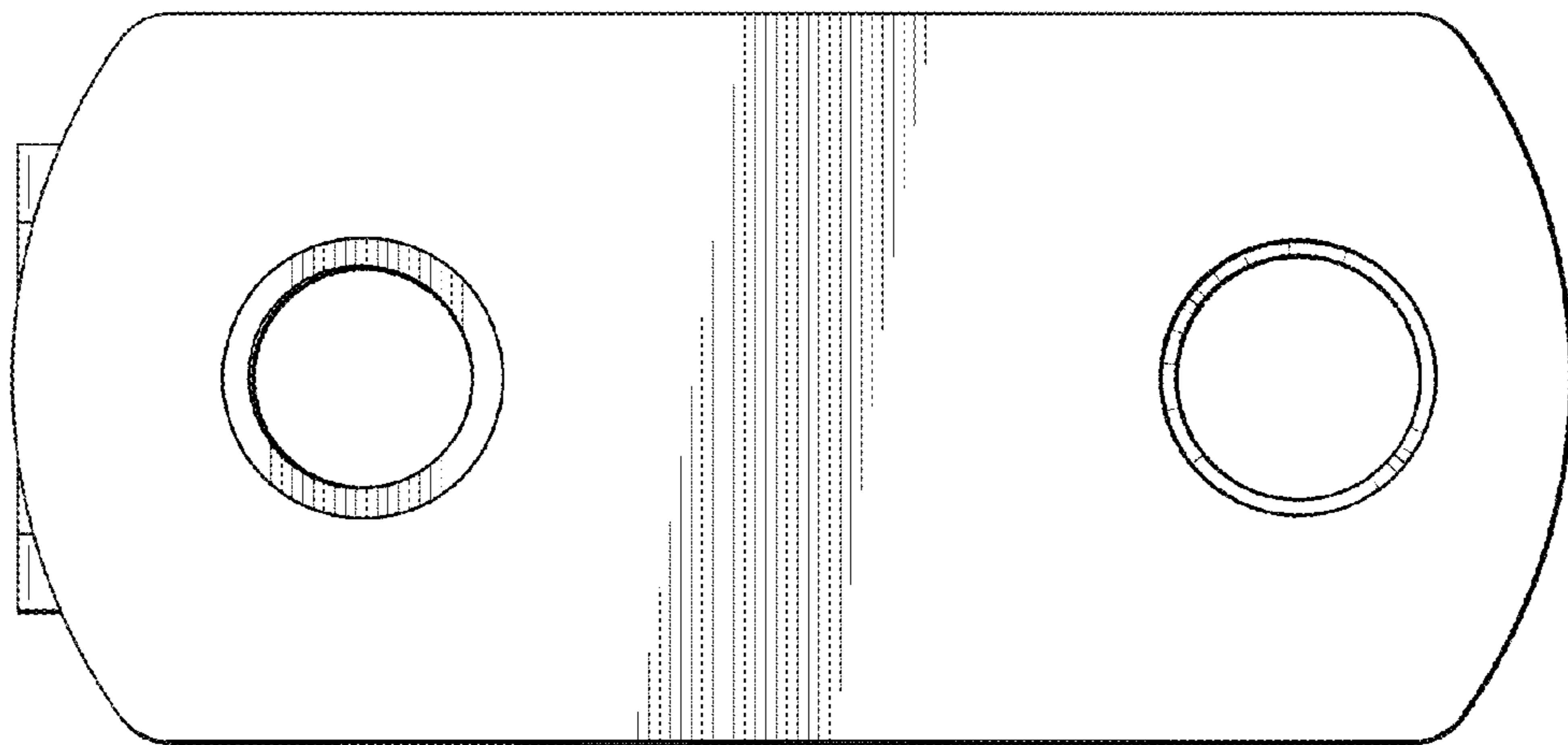
