(57) **CLAIM**

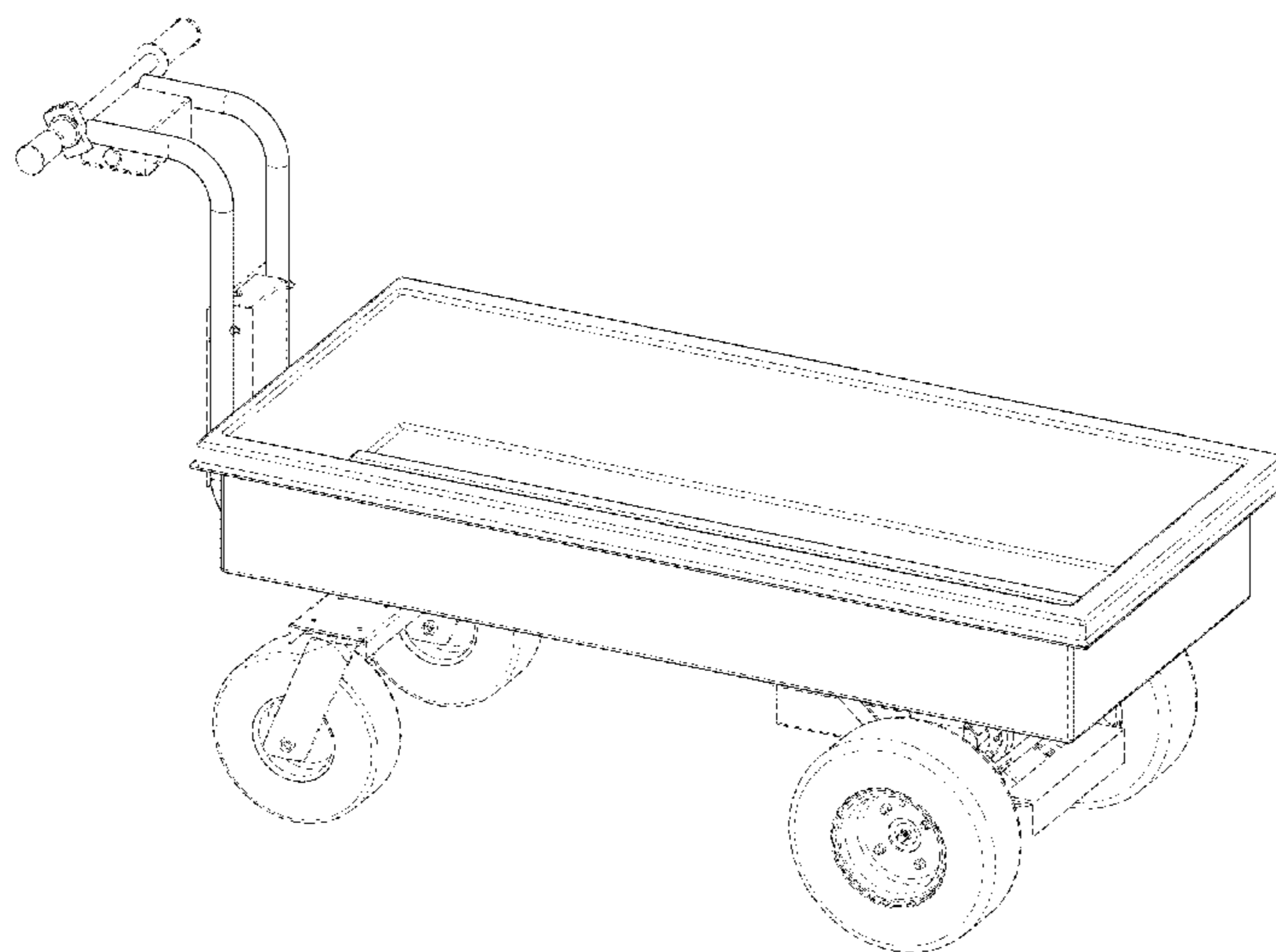
The ornamental design for a powered wagon, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a powered wagon embodying our design;
FIG. 2 is a rear perspective view of the powered wagon shown in FIG. 1;
FIG. 3 is a front elevational view of the powered wagon shown in FIGS. 1 and 2;
FIG. 4 is a left side elevational view of the powered wagon depicted in FIGS. 1-3;
FIG. 5 is a rear elevational view of the powered wagon depicted in FIGS. 1-4;
FIG. 6 is a right side elevational view of the powered wagon depicted in FIGS. 1-5; and,
FIG. 7 is a top plan view of the powered wagon shown in FIGS. 1-6.

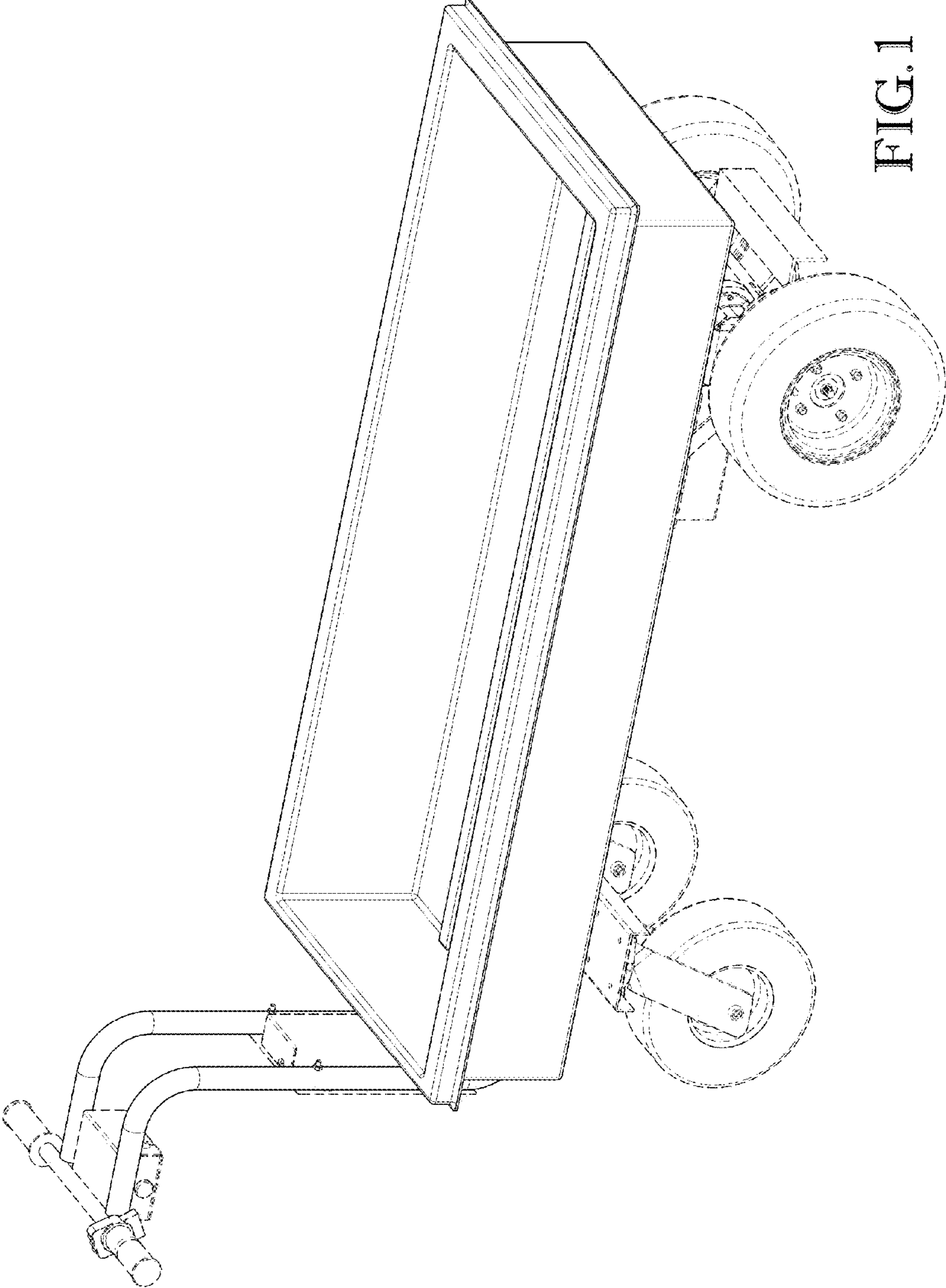

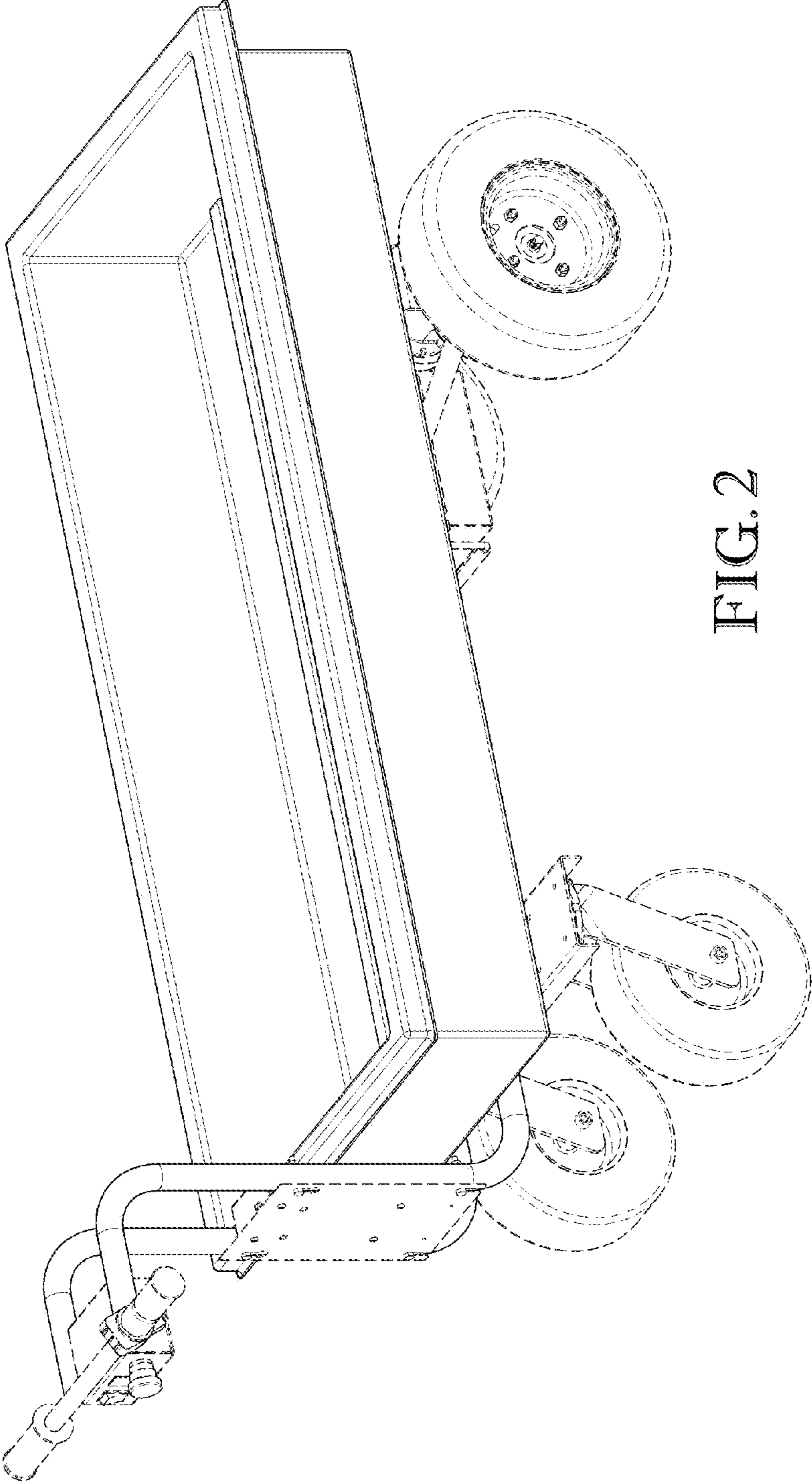

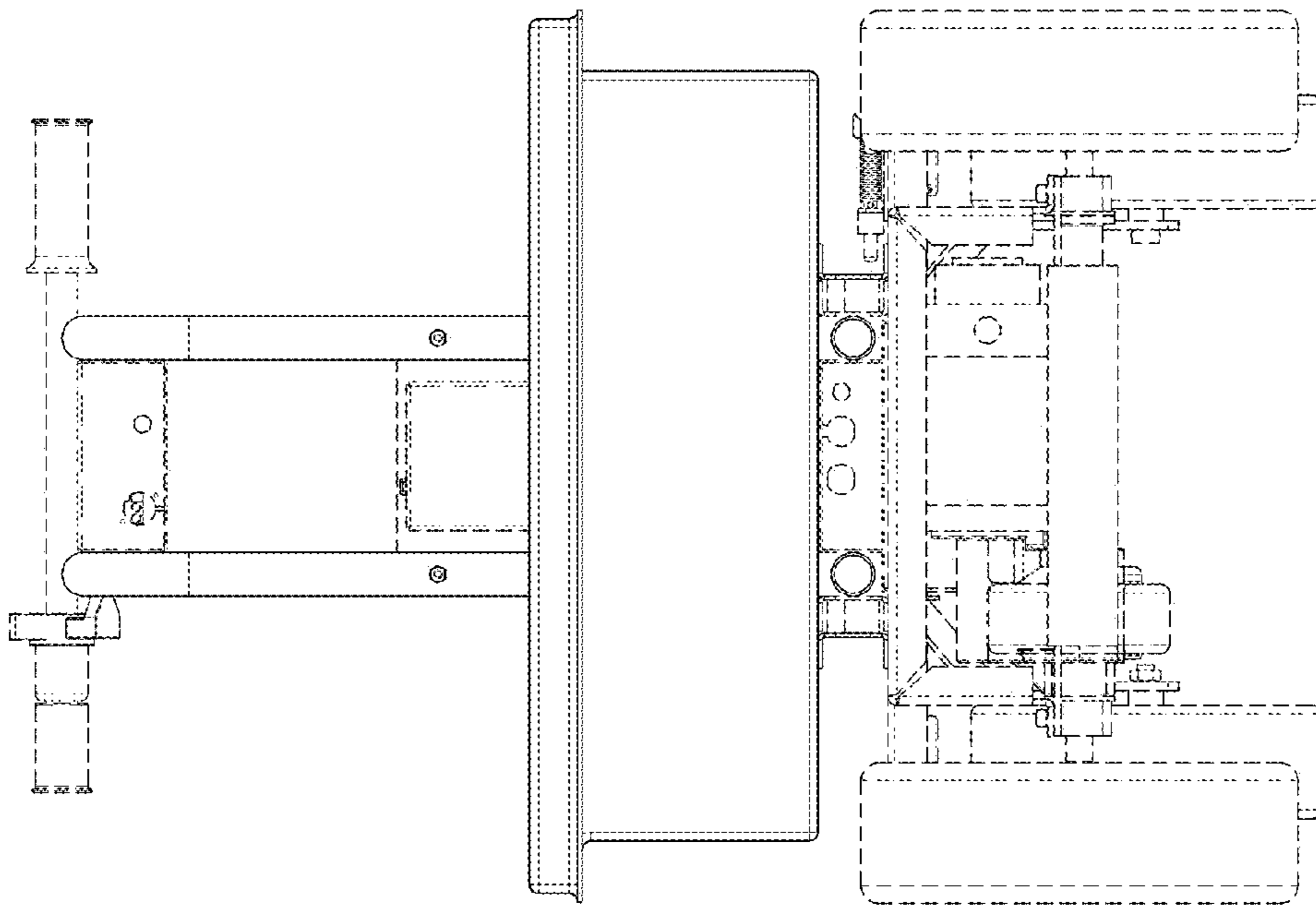

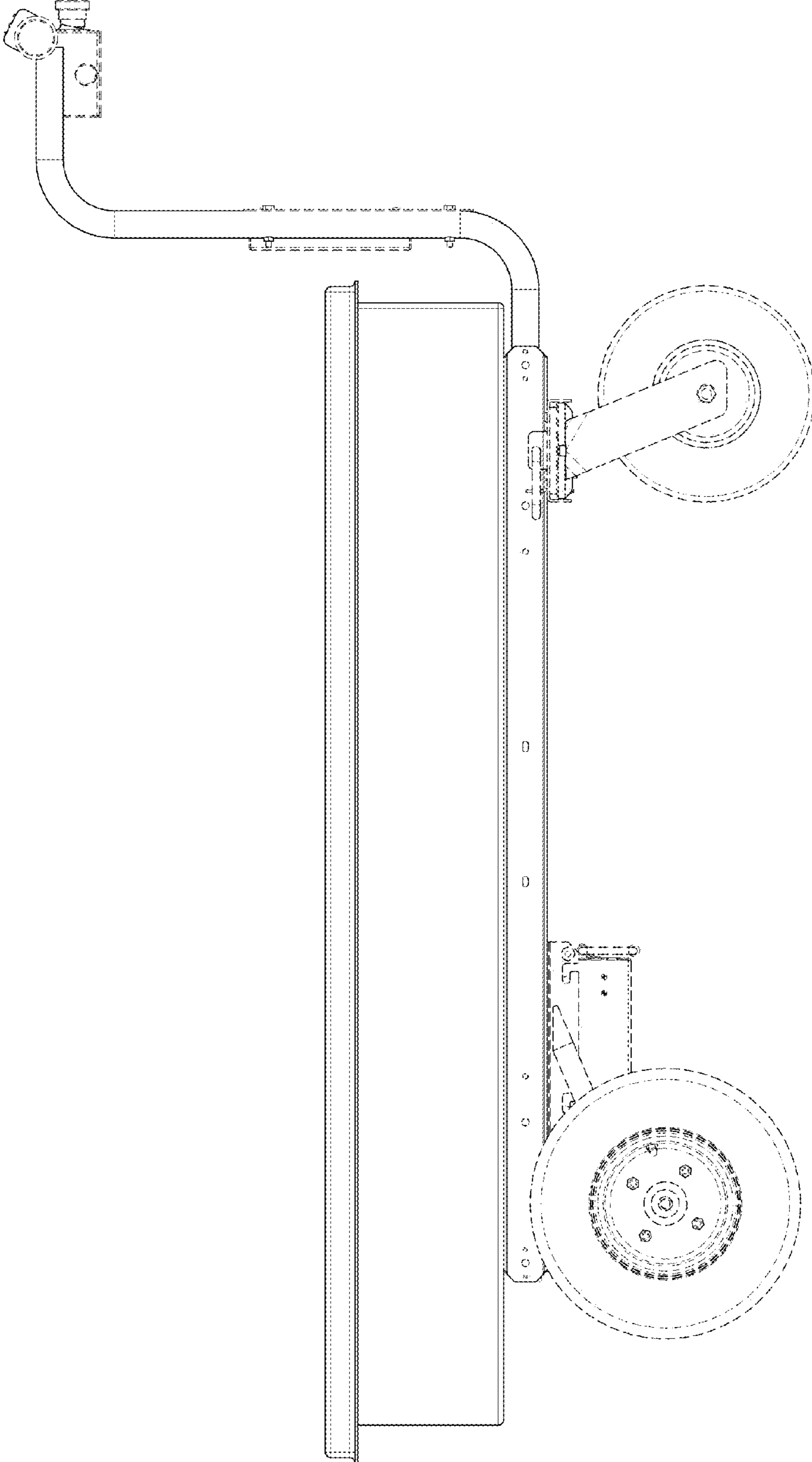

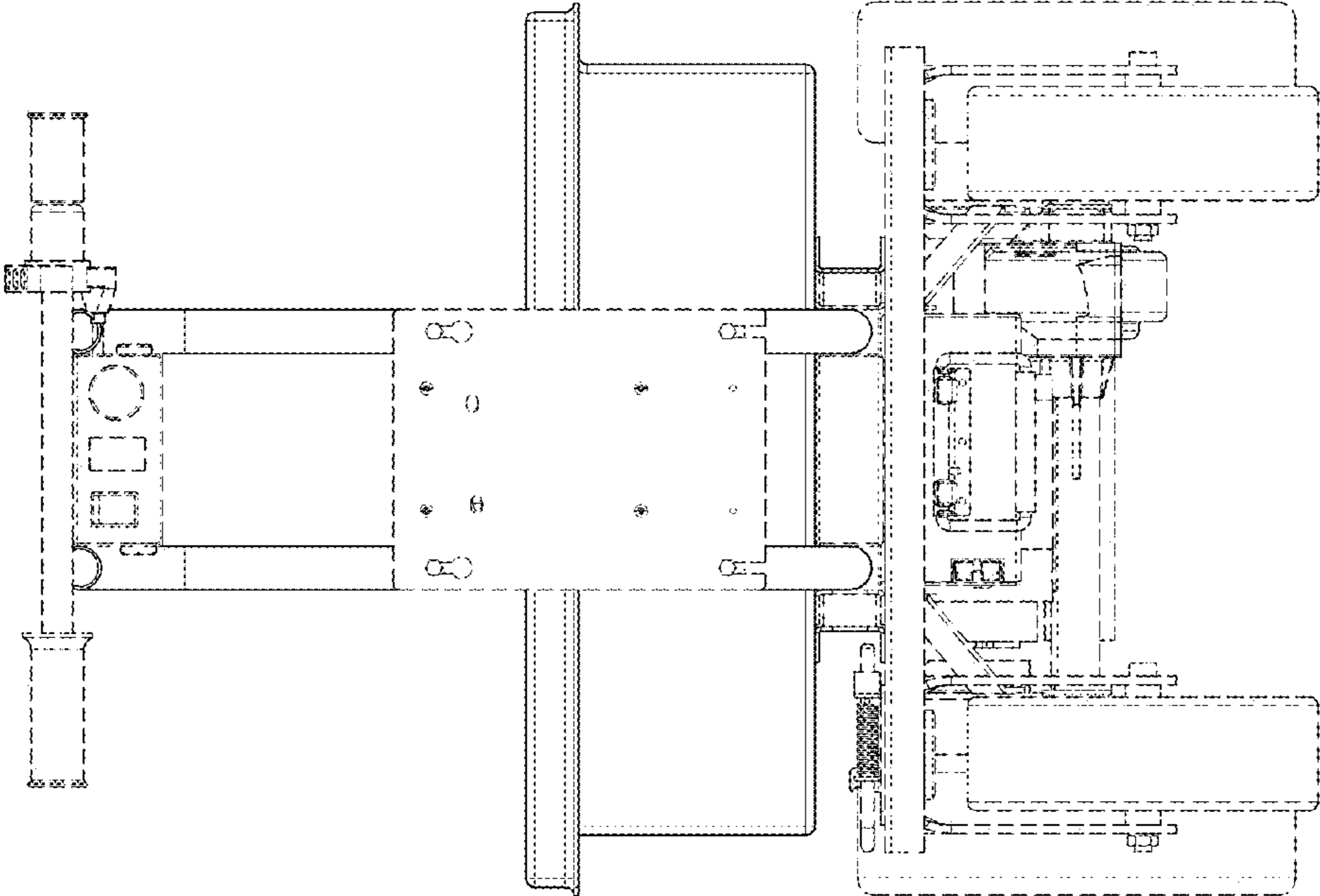

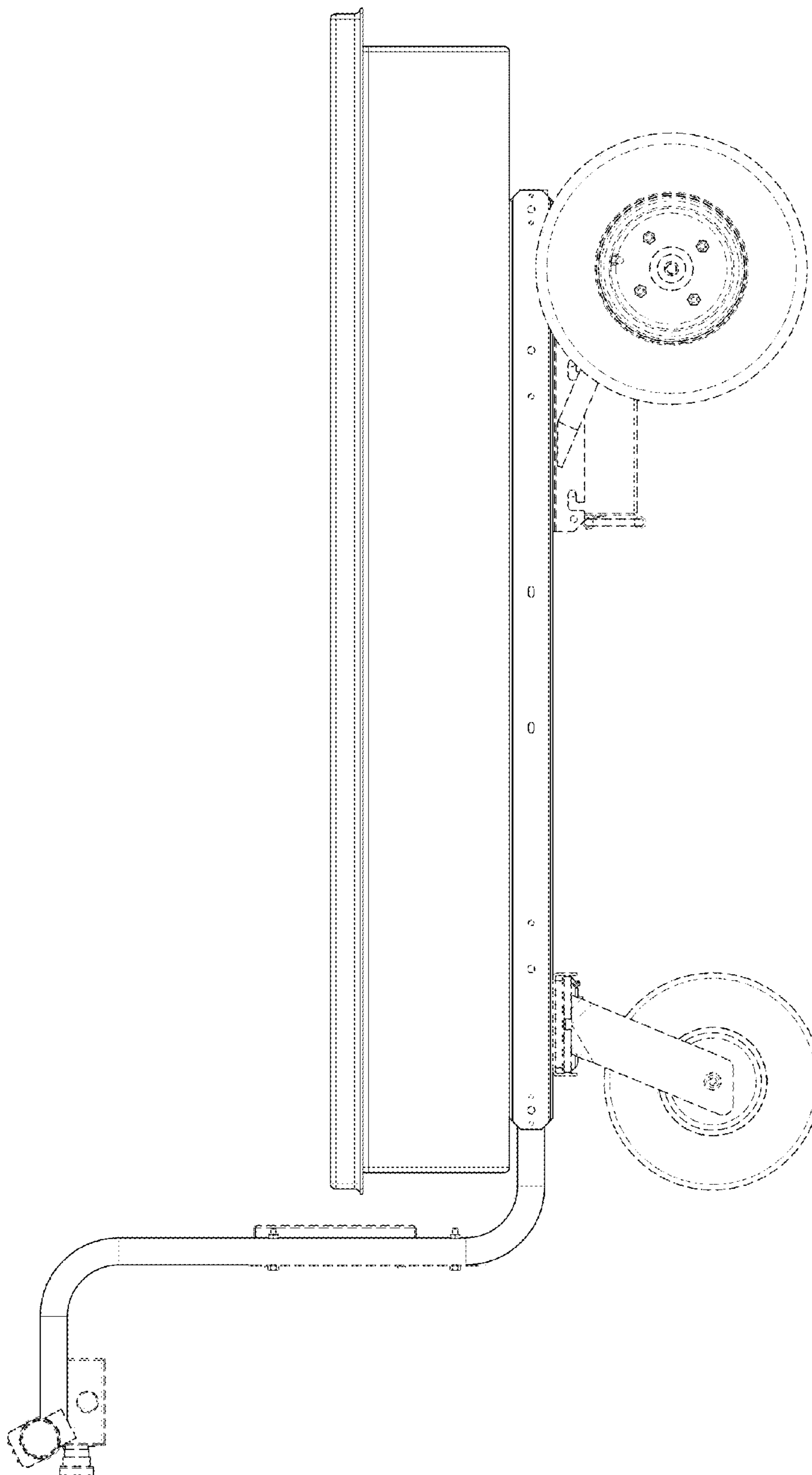

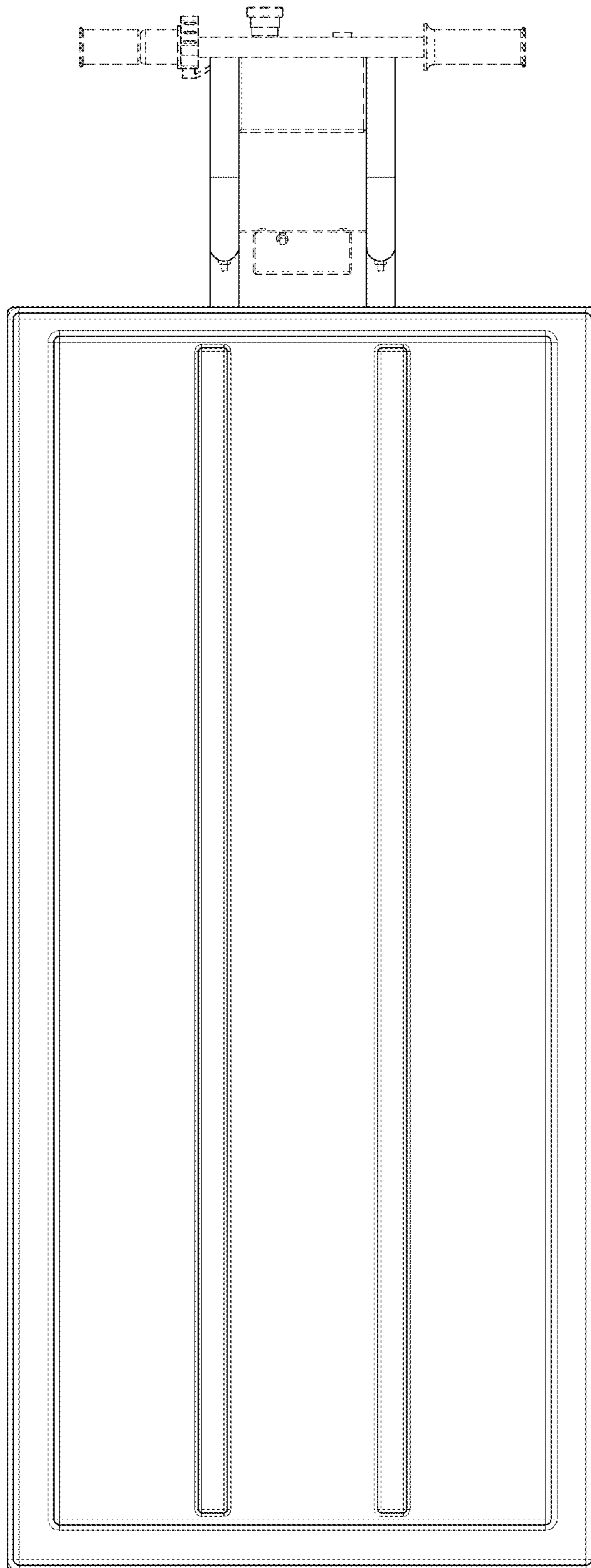
