(57) **CLAIM**

The ornamental design for luggage, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side view of the luggage with the handle and wheels retracted.

FIG. 2 is a back side thereof, with the handle and wheels retracted.

FIG. 3 is a left side view thereof, with the handle and wheels retracted.

FIG. 4 is a right side view thereof, with the handle and wheels retracted.

FIG. 5 is a top view thereof, with the handle and wheels retracted.

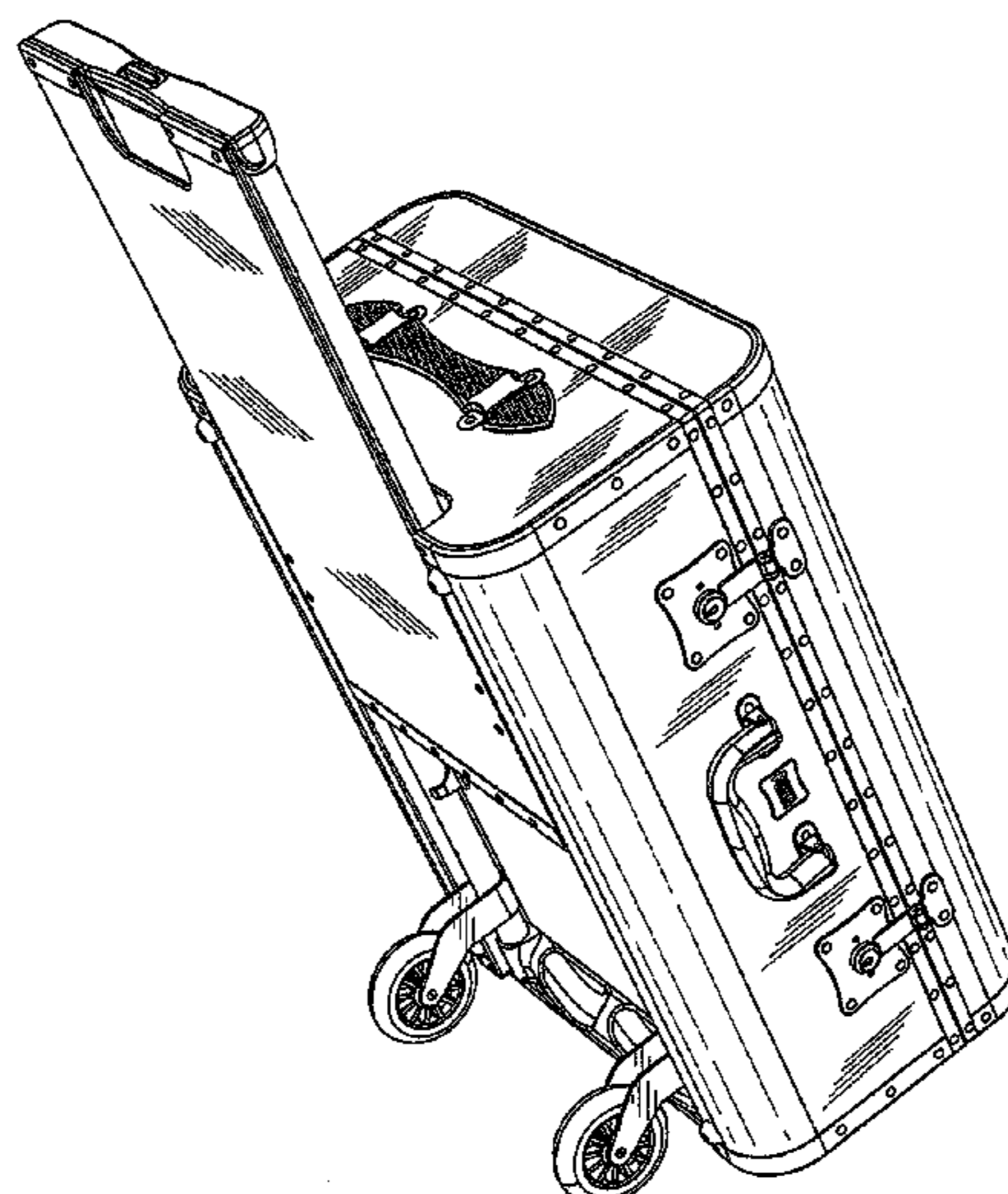
FIG. 6 is a bottom view thereof, with the handle and wheels retracted.

FIG. 7 is a perspective view thereof, with the handle and wheels retracted; and,

FIG. 8 is a perspective view thereof, with the handle and wheels extended.

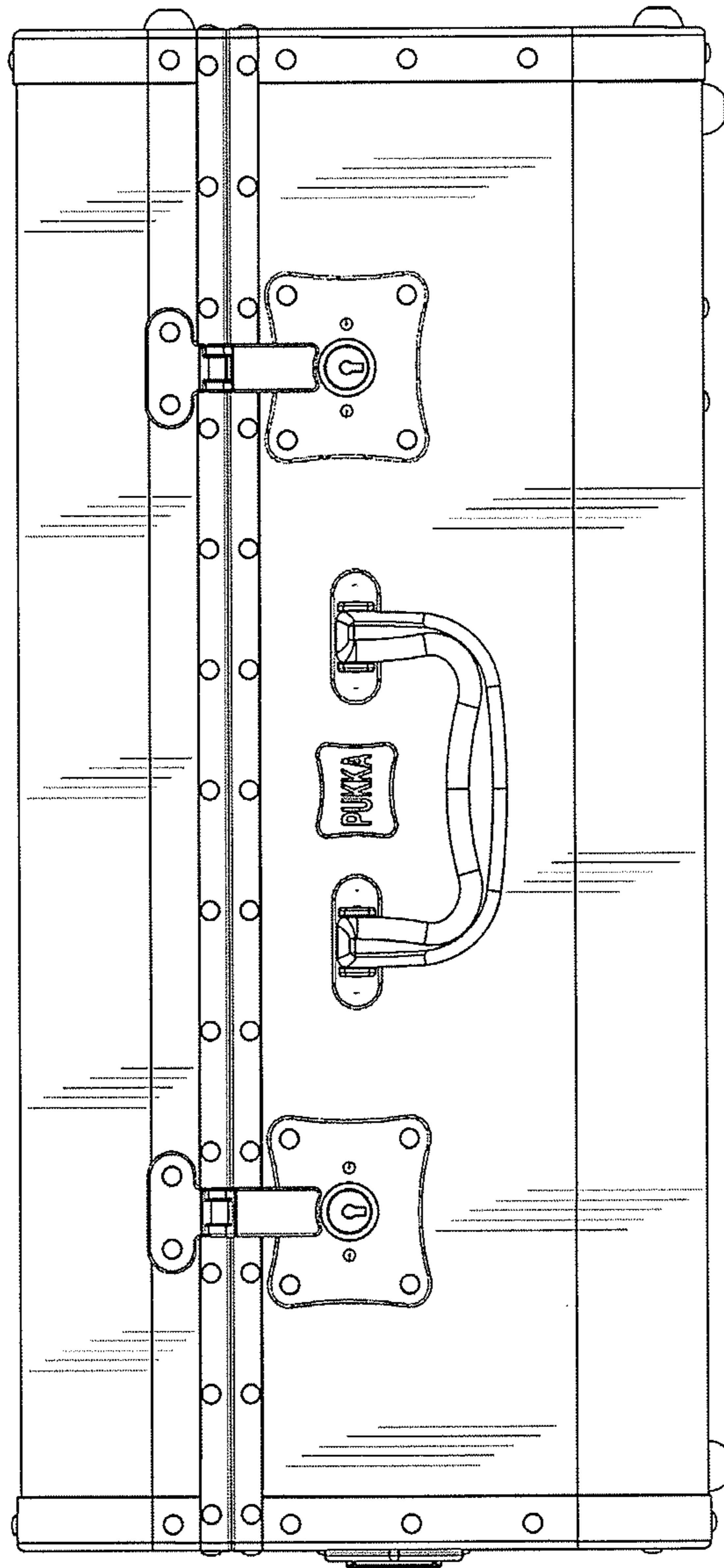

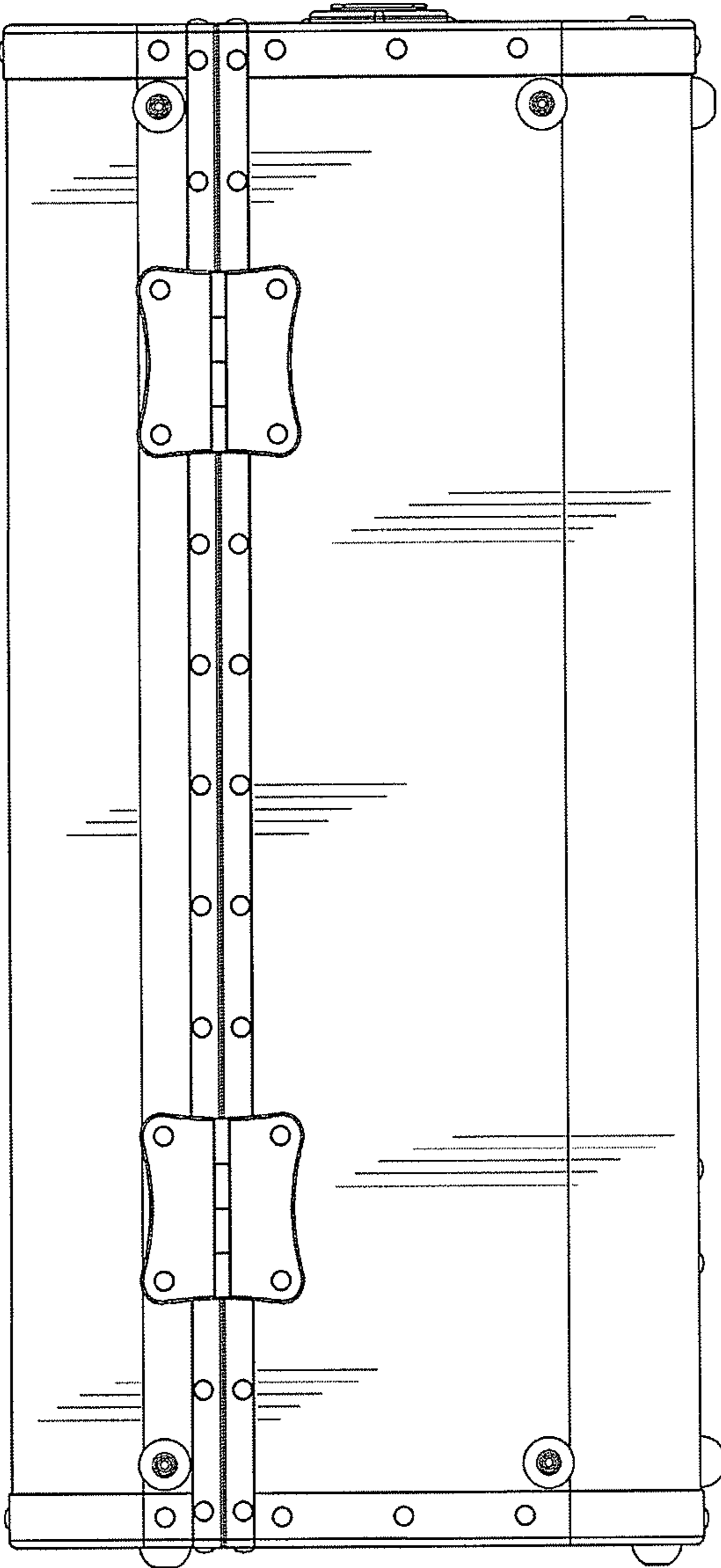

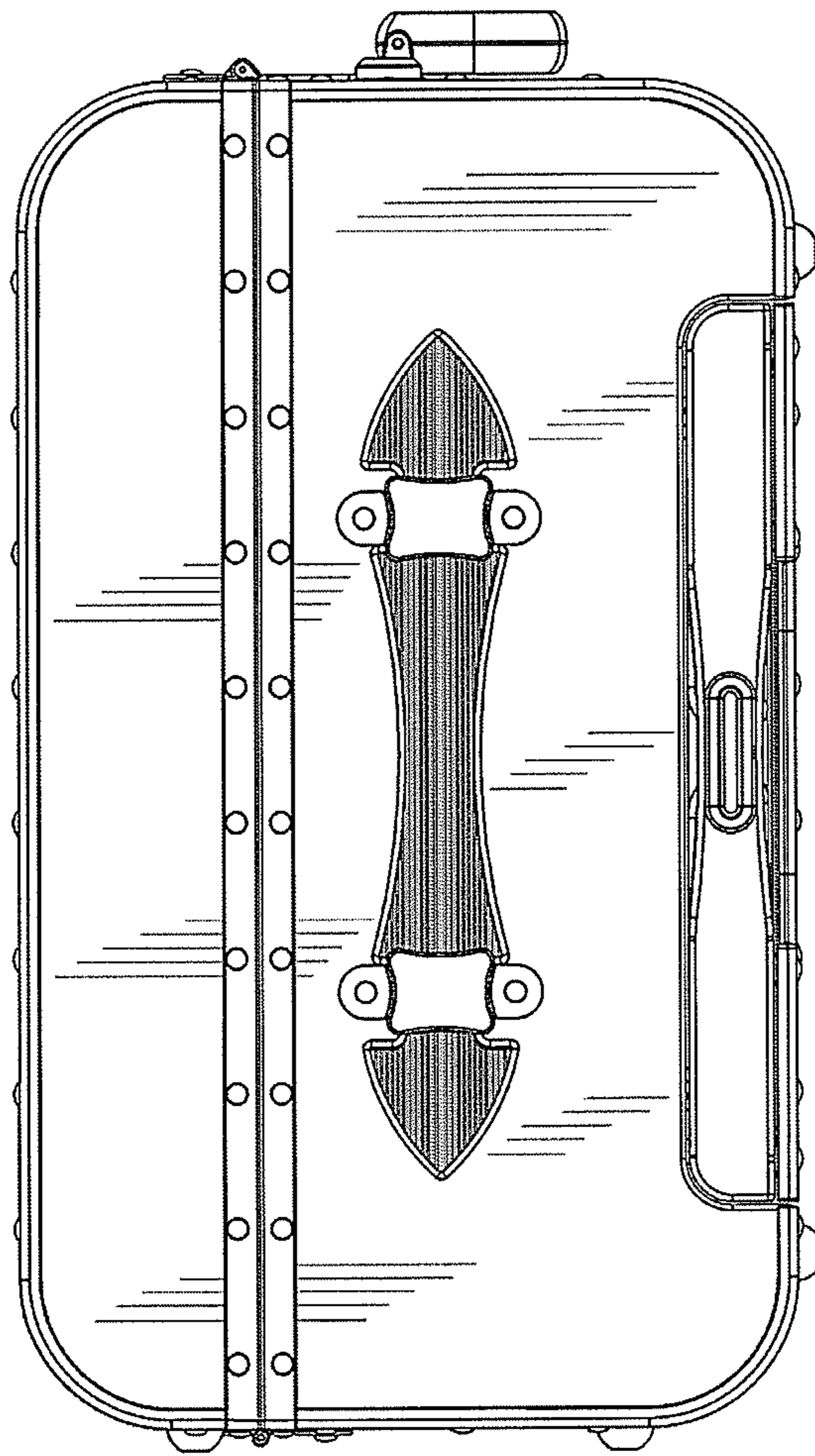

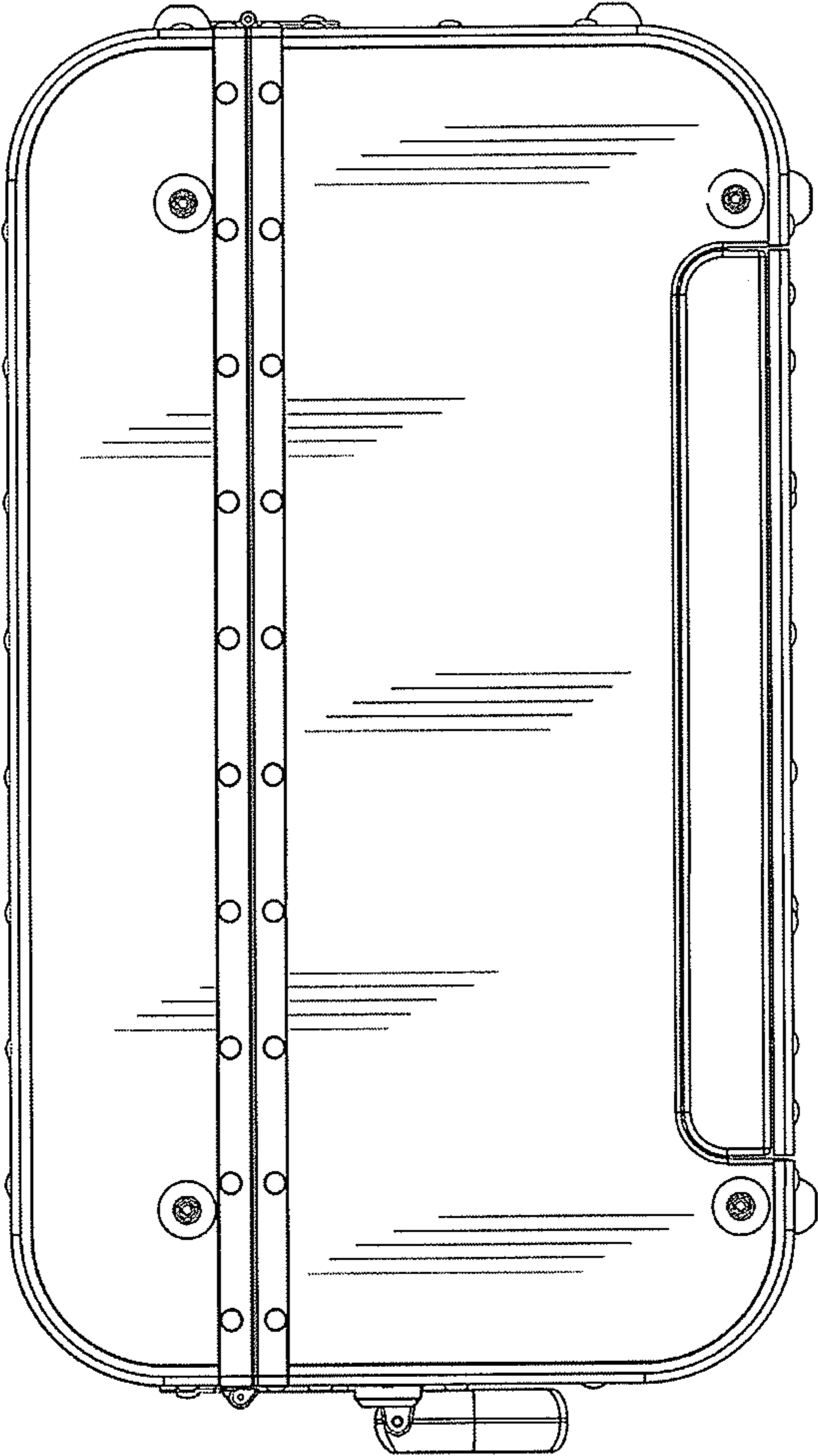

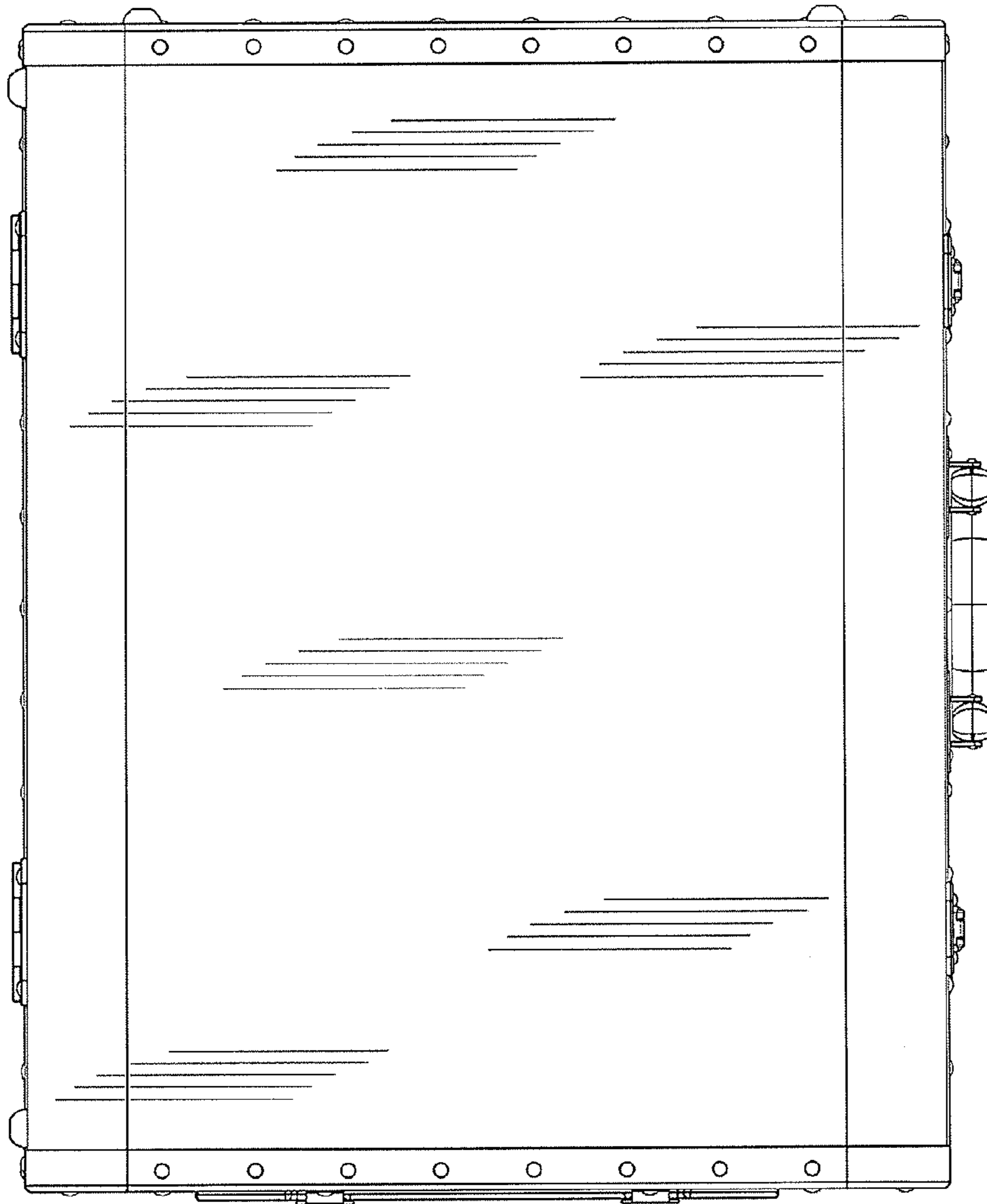

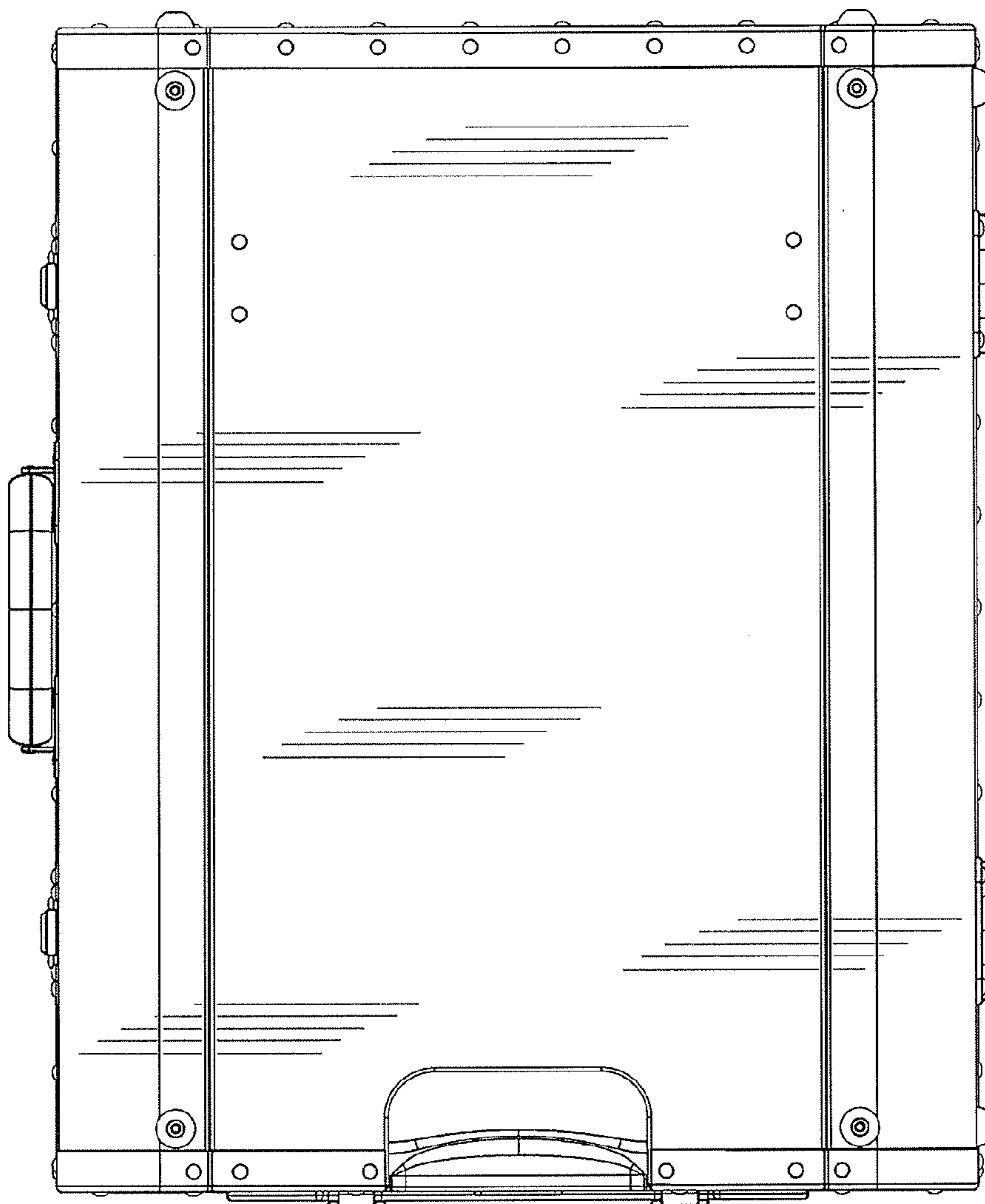

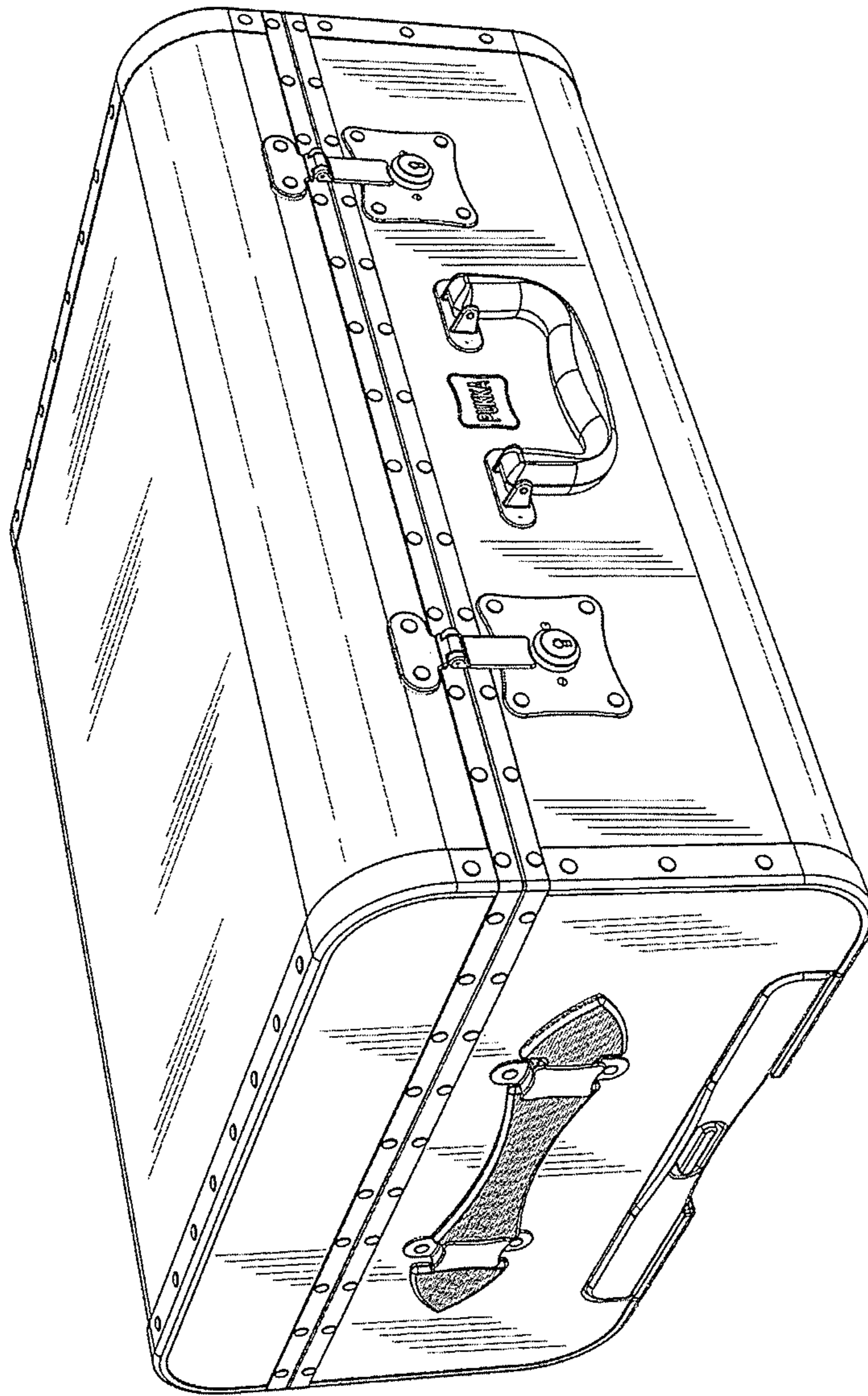

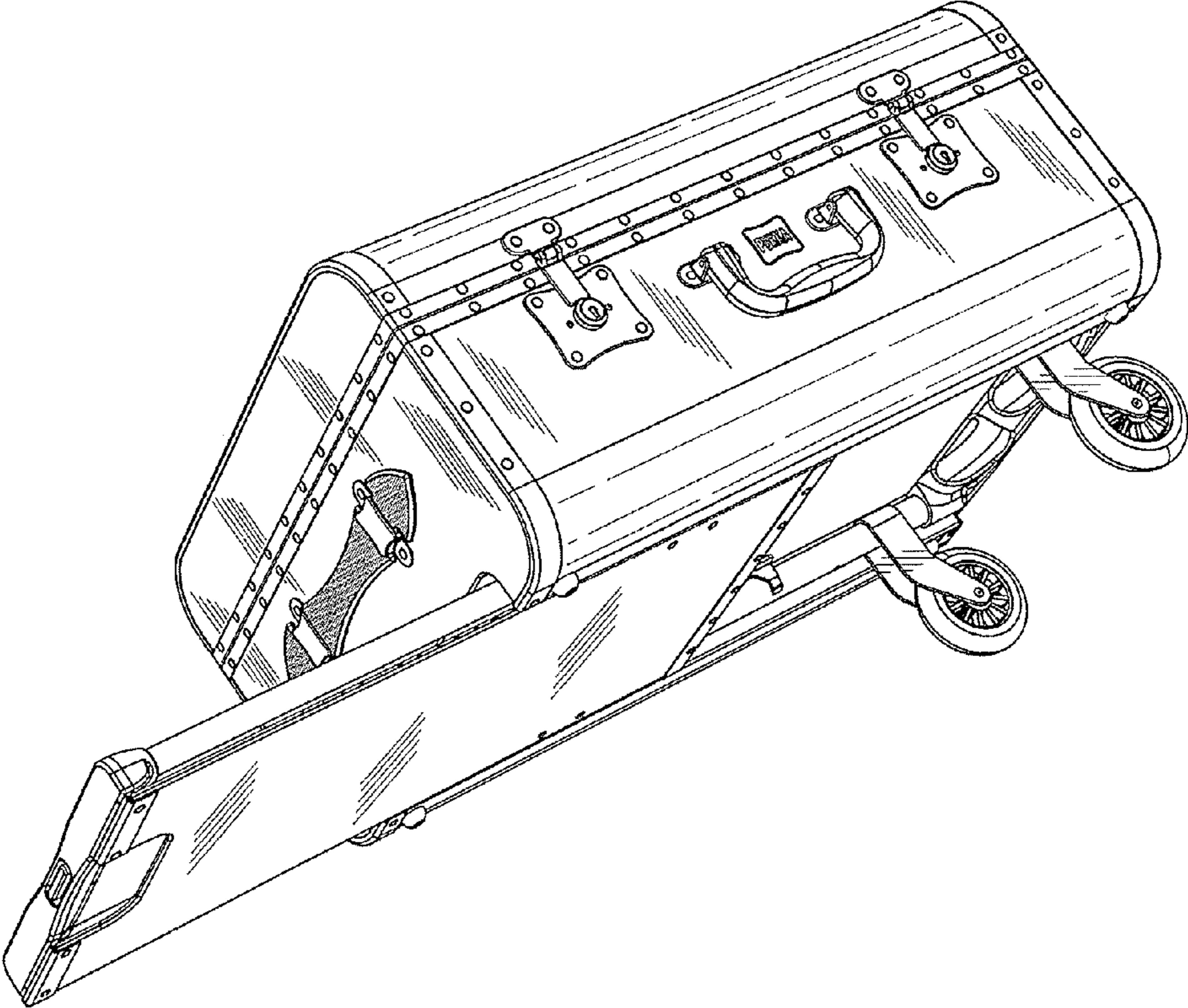
