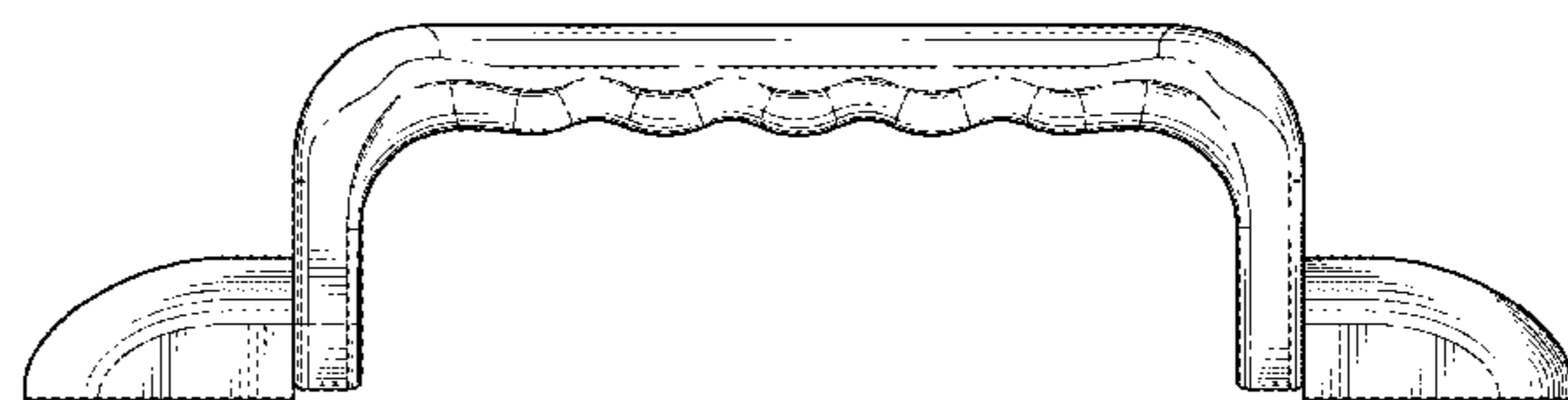
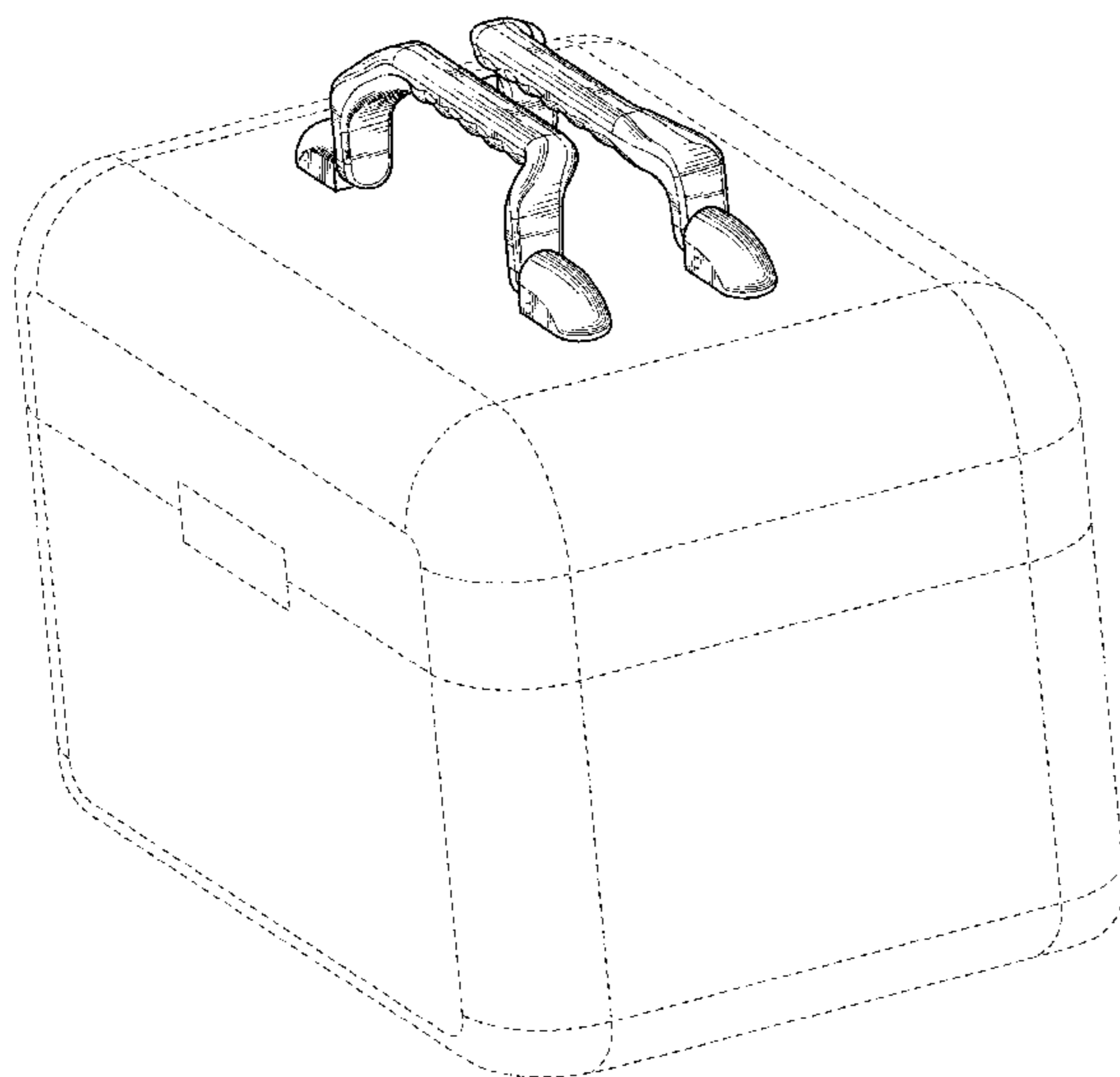

The ornamental design for a suitcase handle, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of the suitcase handle;
FIG. 2 is a right side view, the left side being a mirror image;
FIG. 3 is a front view, the back view being a mirror image;
FIG. 4 is a top view; and,
FIG. 5 is a bottom view.
The broken line shows environmental structure on which the
suitcase handle is located and forms no part of the claimed
design.

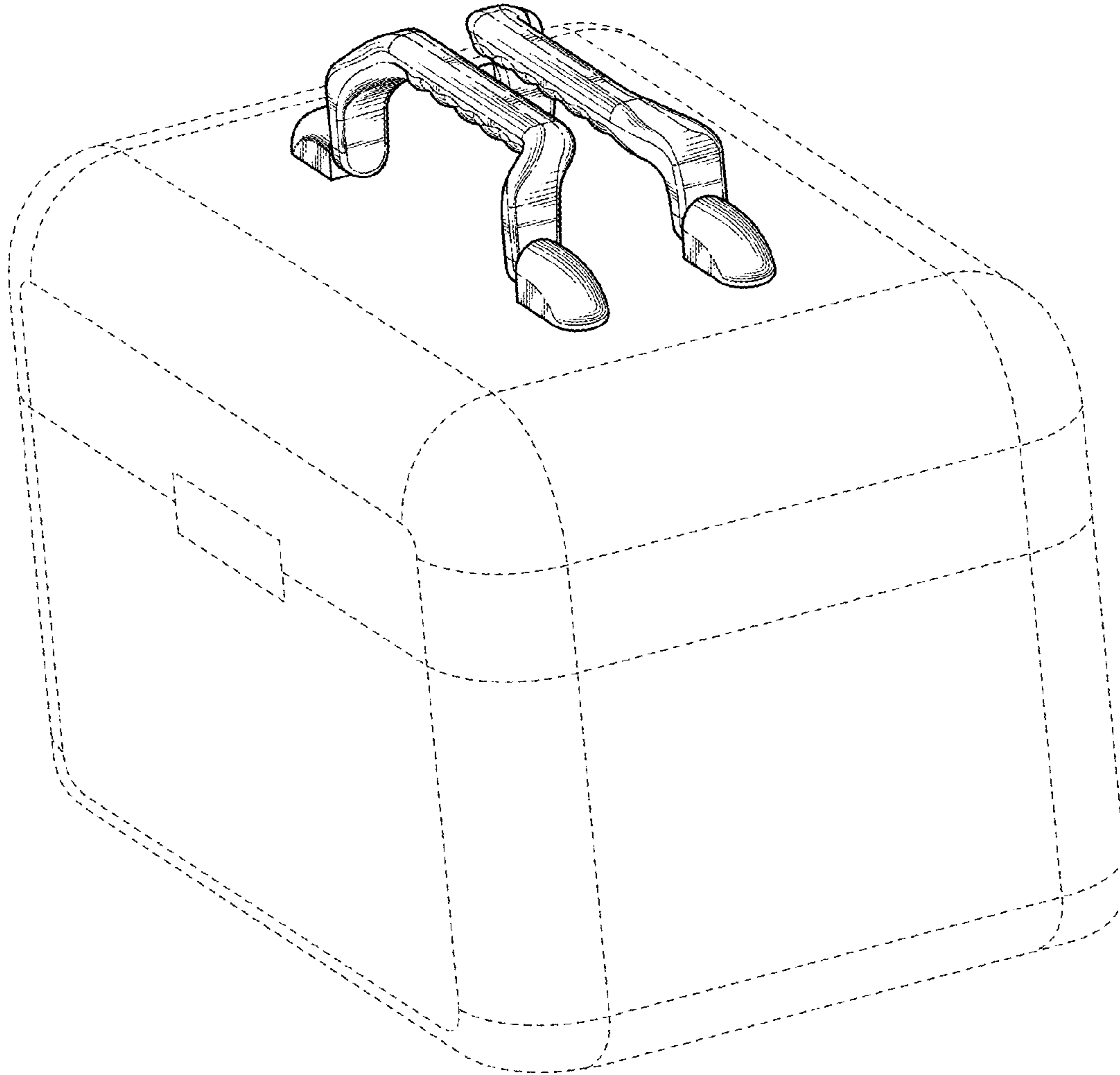

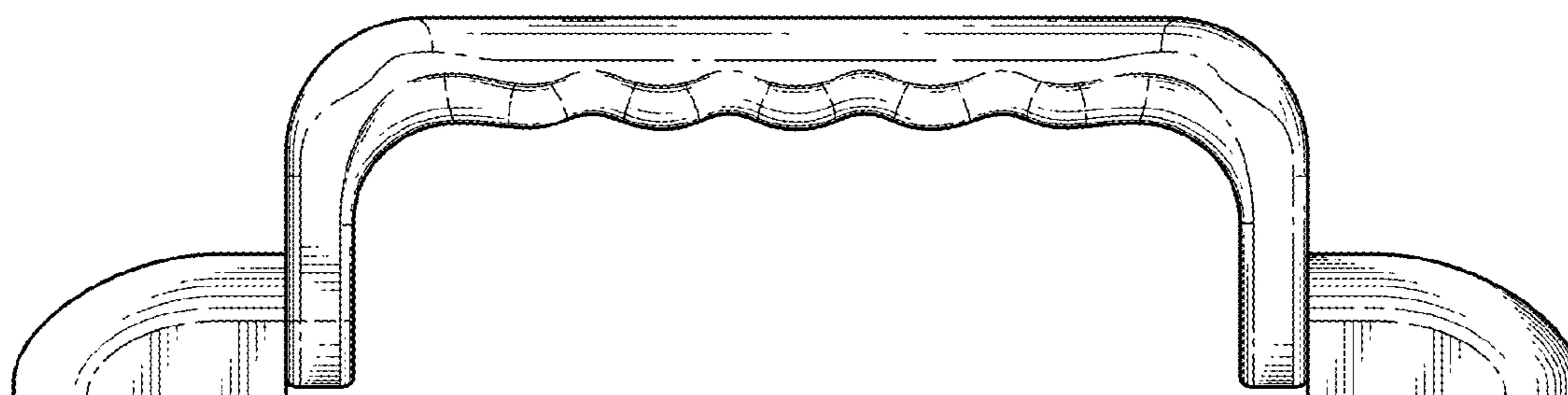

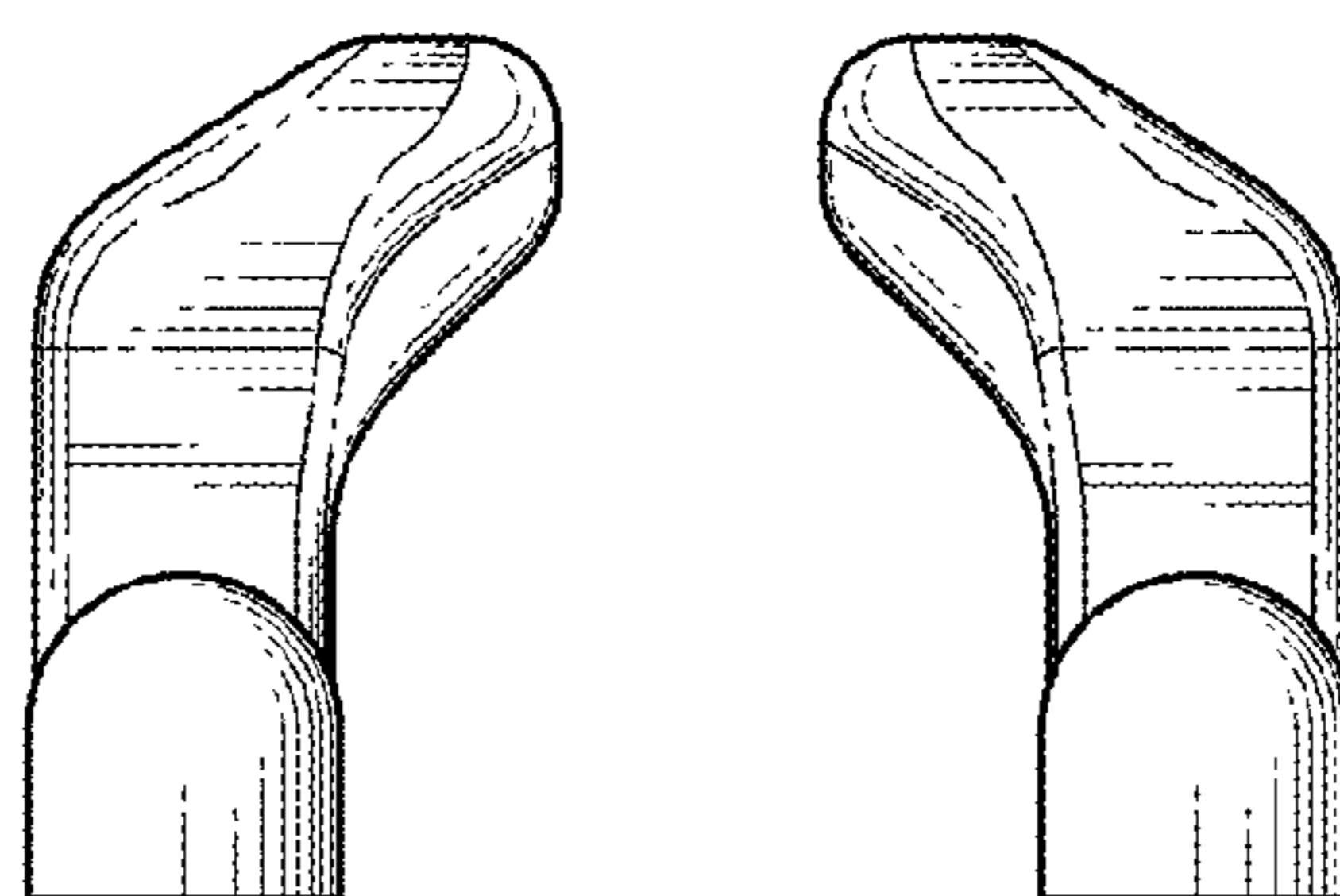

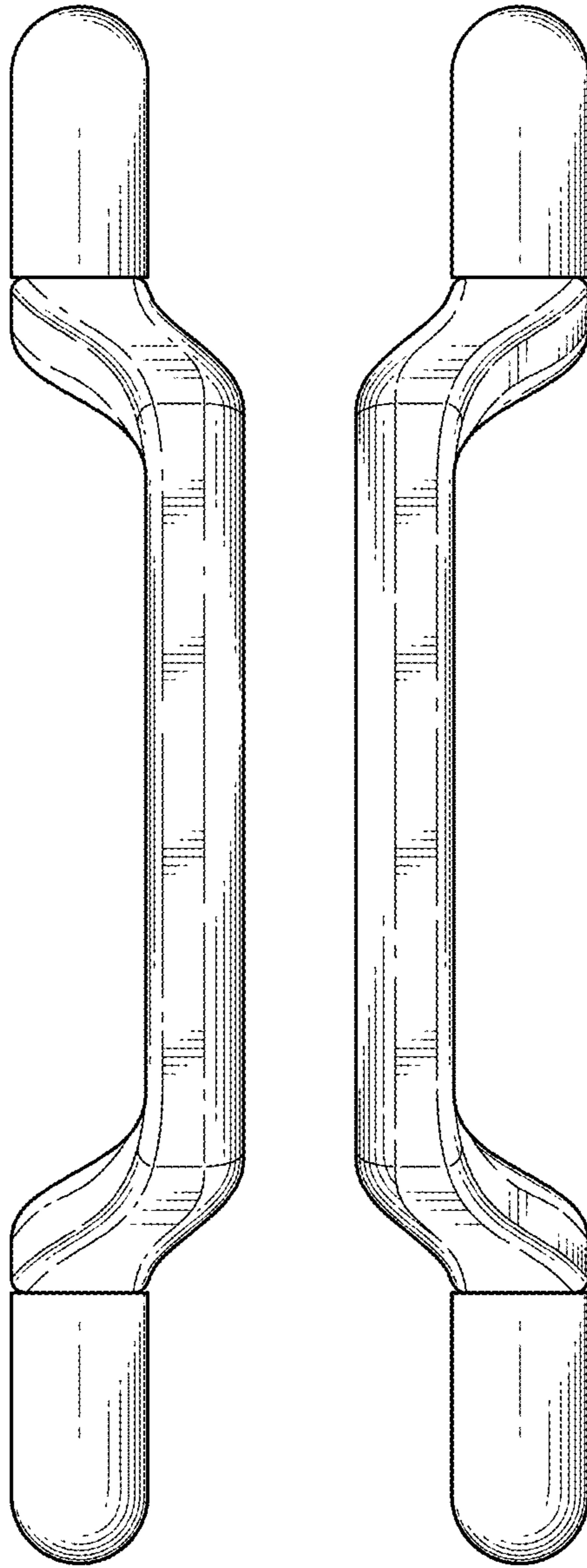

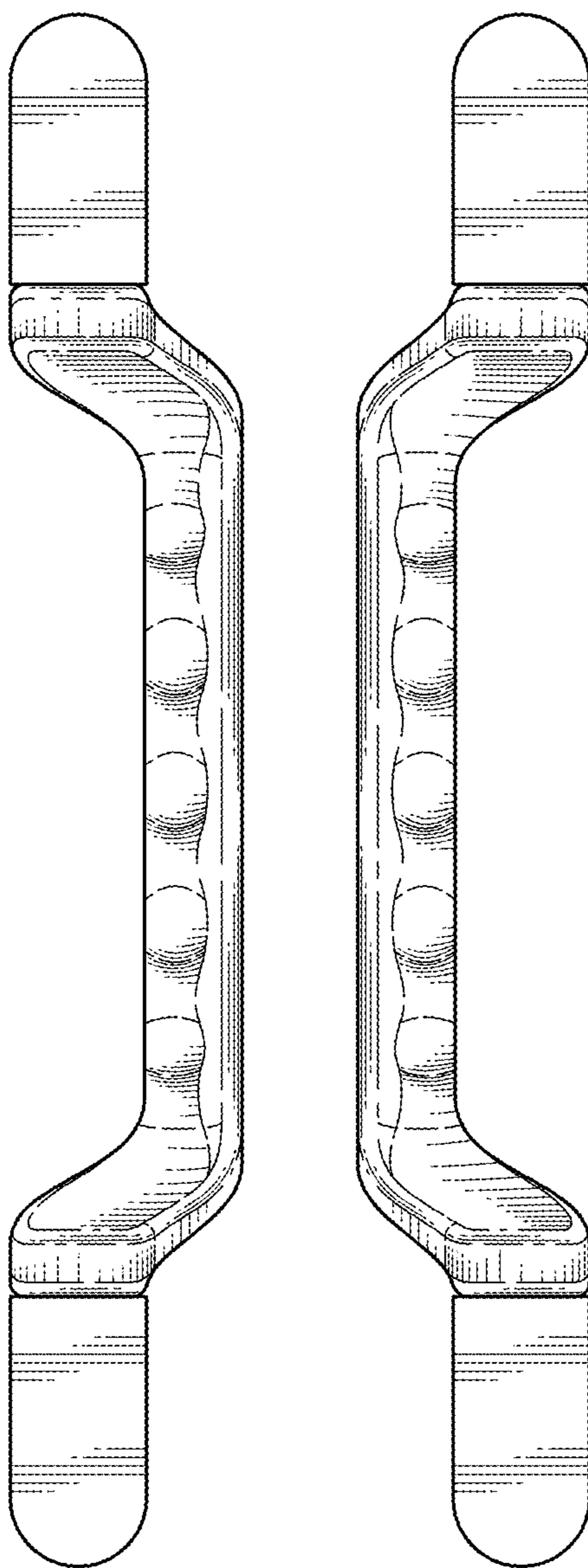
