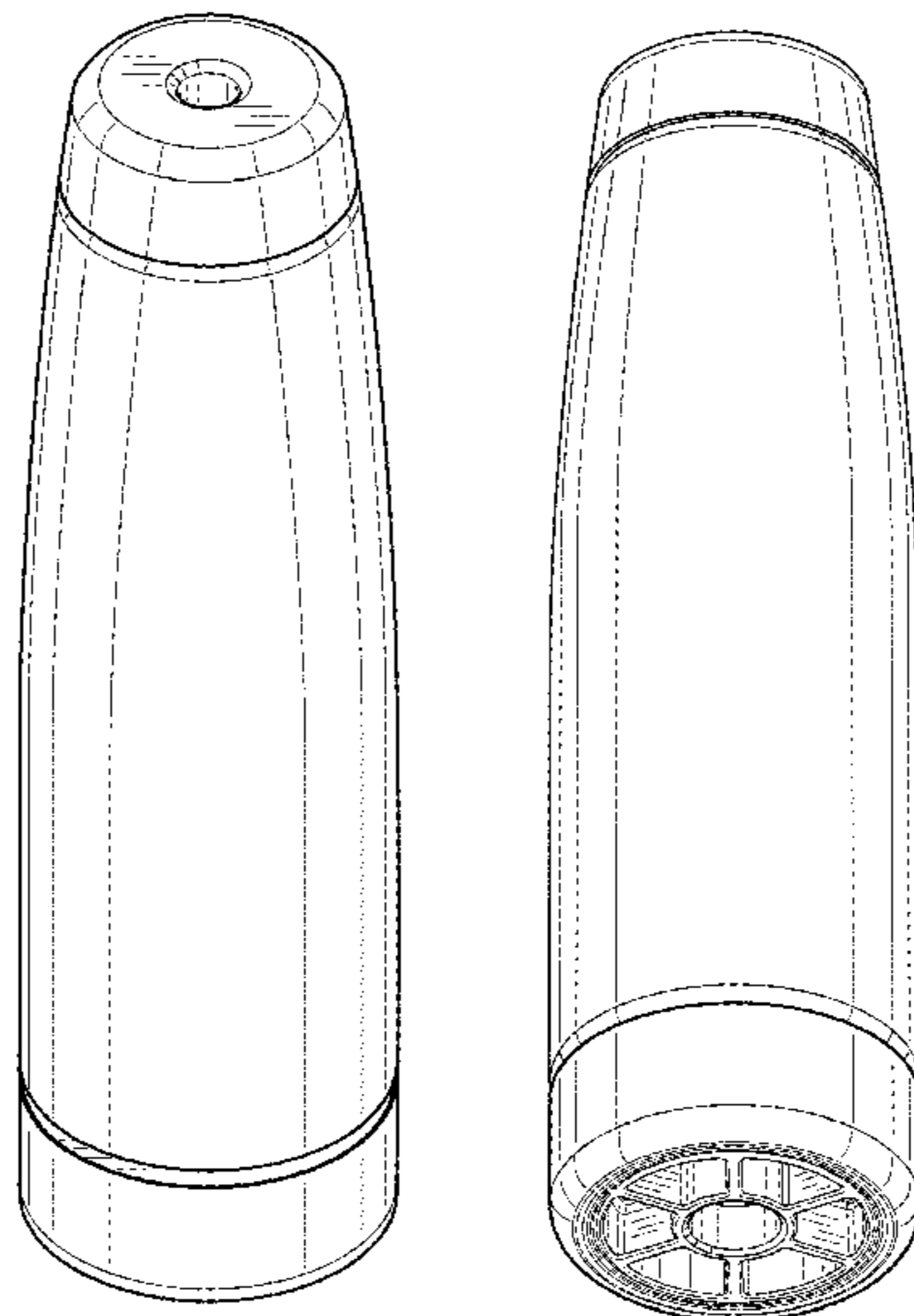
(57) **CLAIM**

The ornamental design for a beverage carbonation system bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a beverage carbonation system bottle in its closed position showing my new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is an exploded top perspective view of a beverage carbonation system bottle in its open position; FIG. 7 is an exploded bottom perspective view thereof; and, FIG. 8 is an exploded front elevational view thereof.

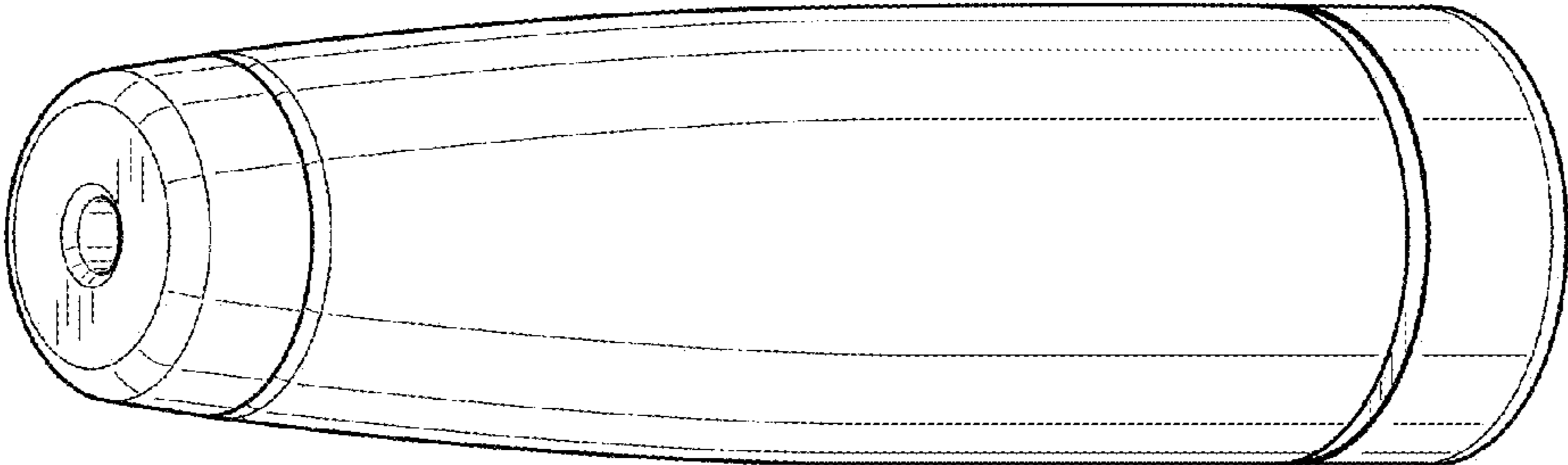

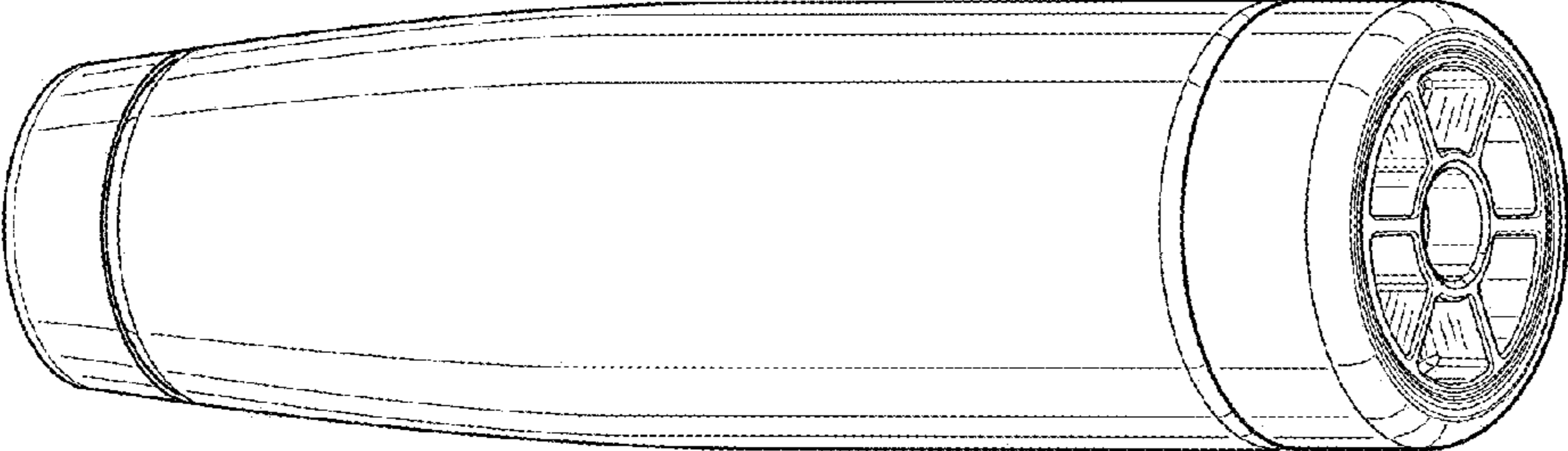

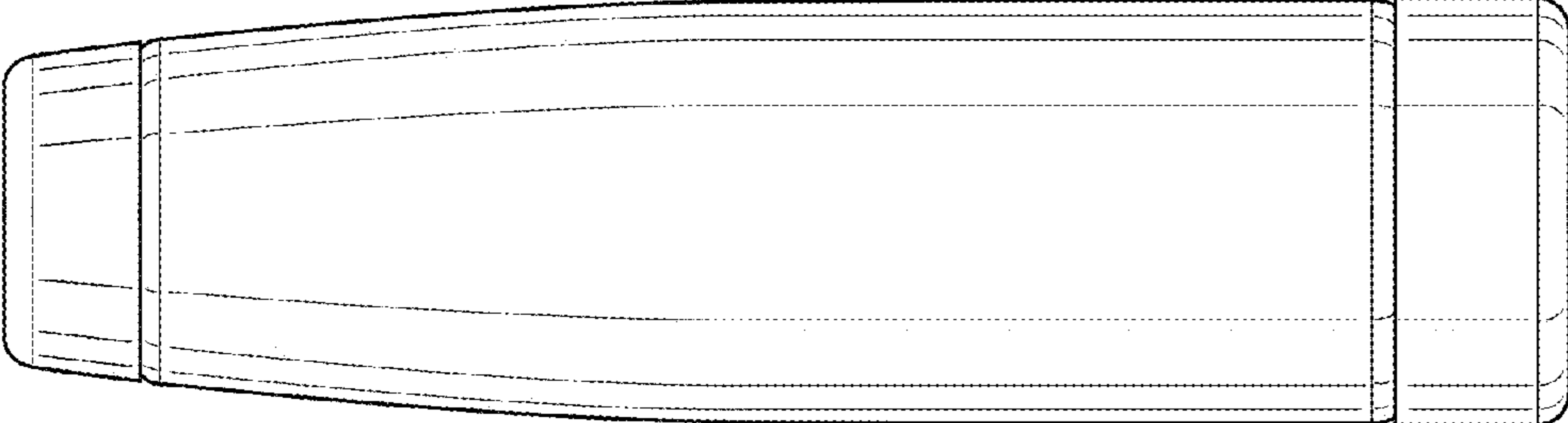

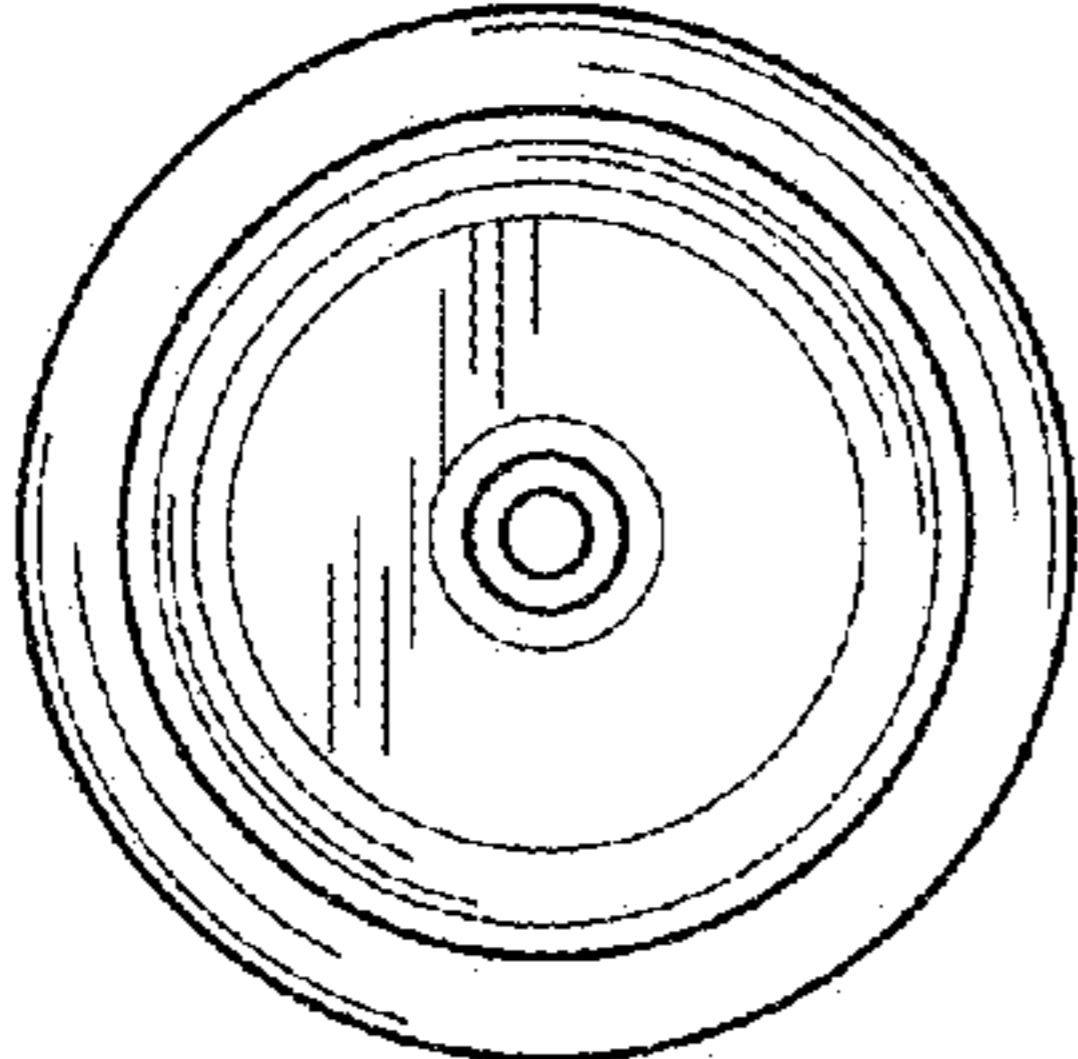

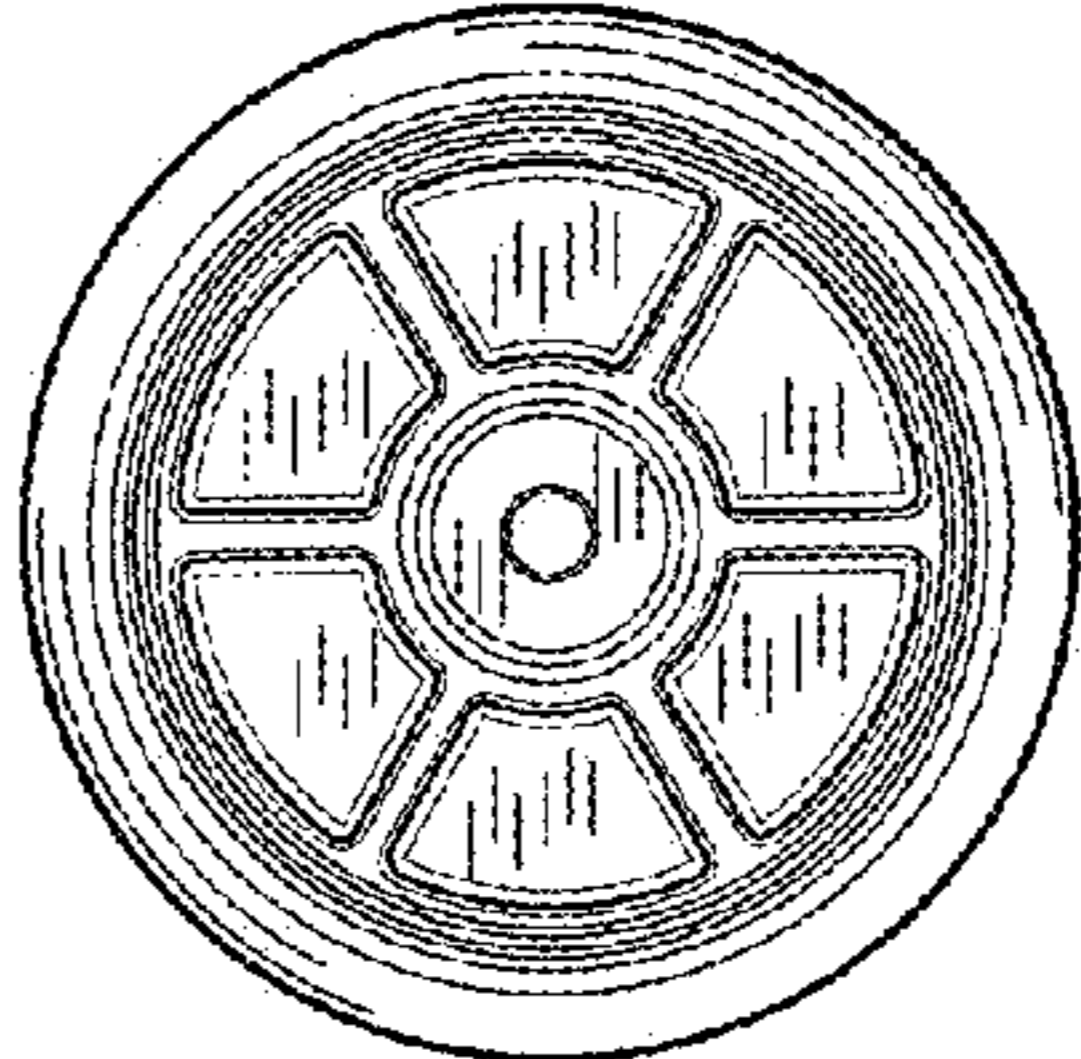
