DESCRIPTION

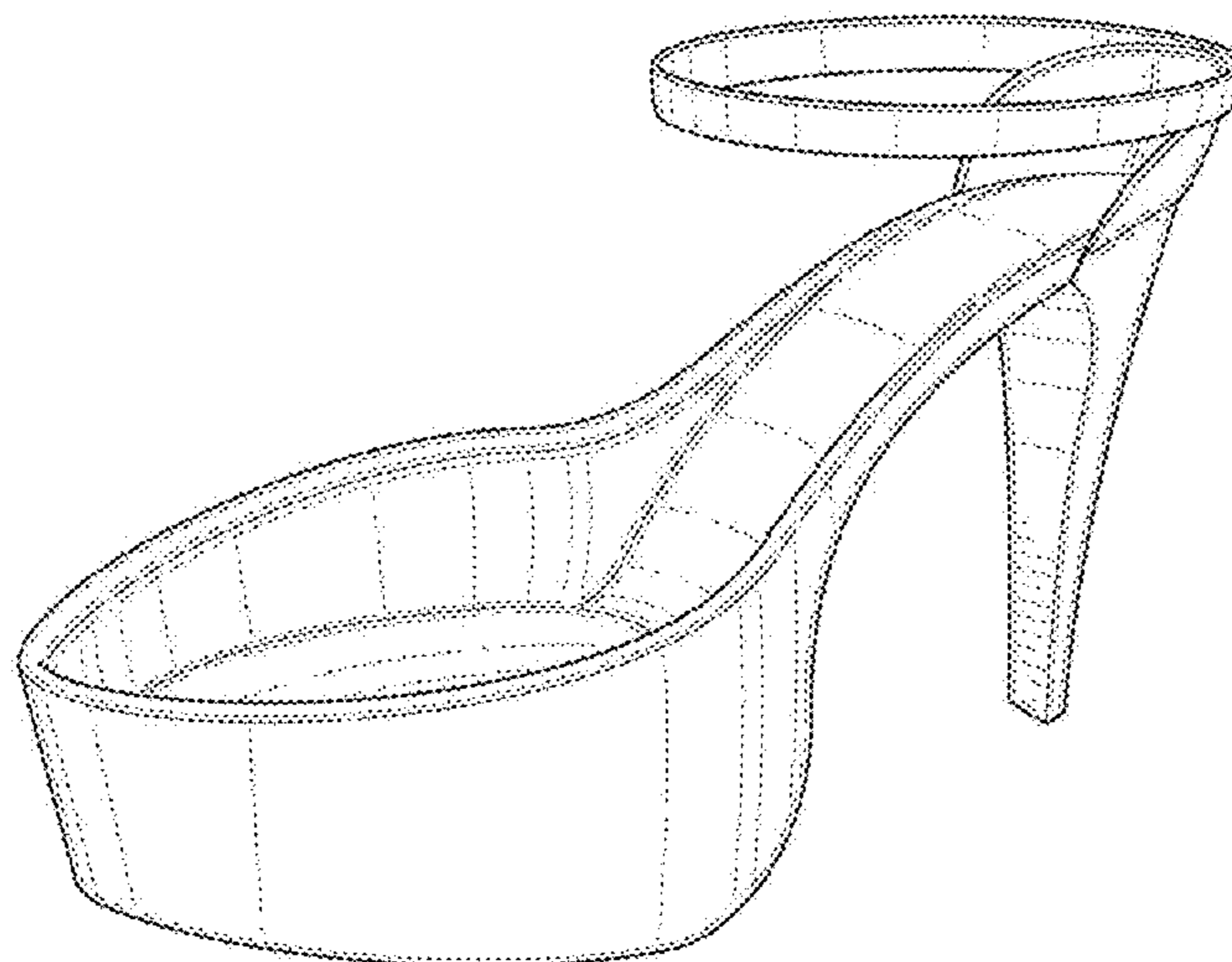
FIG. 1 is a perspective view of a bowl in accordance with the present invention;

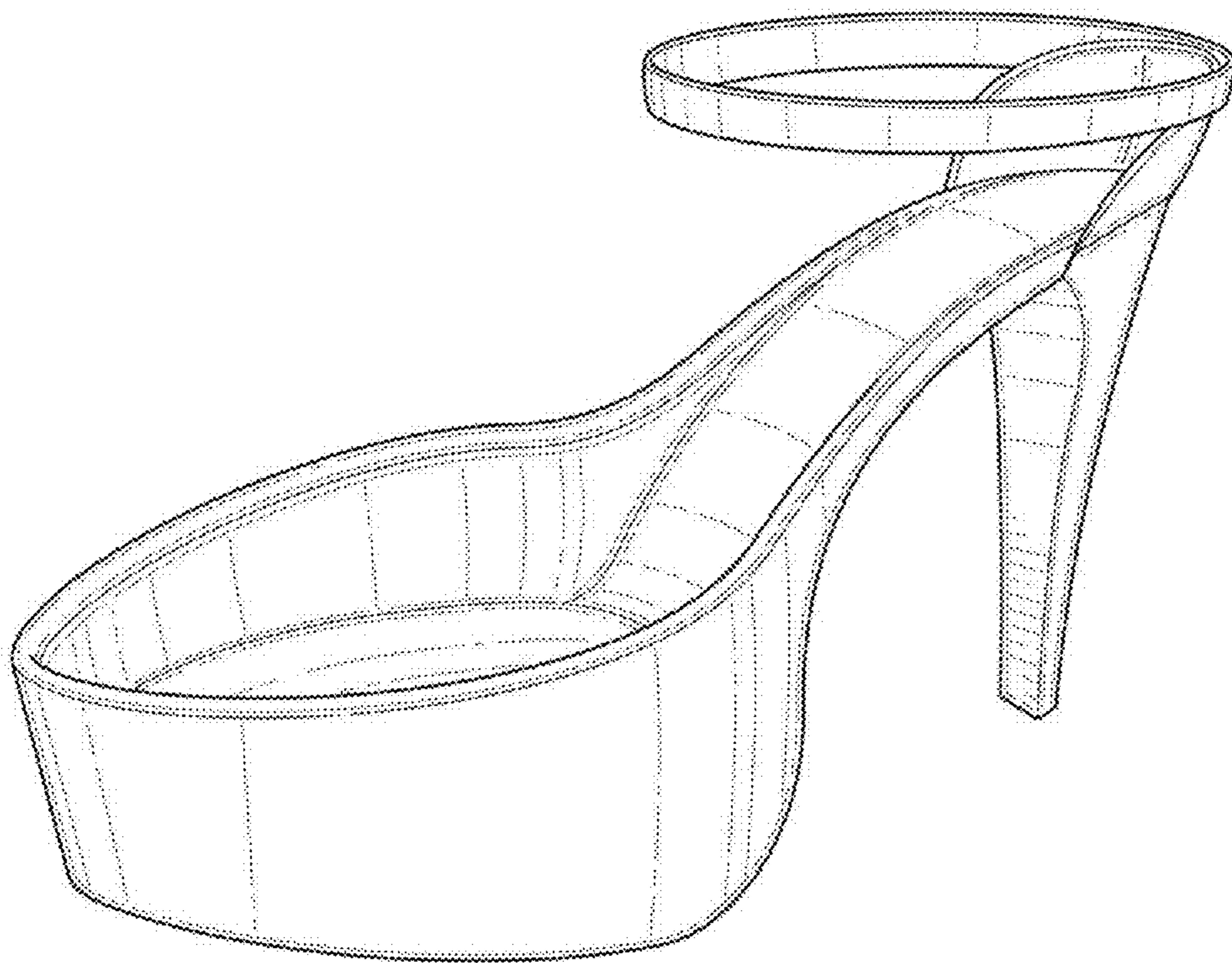

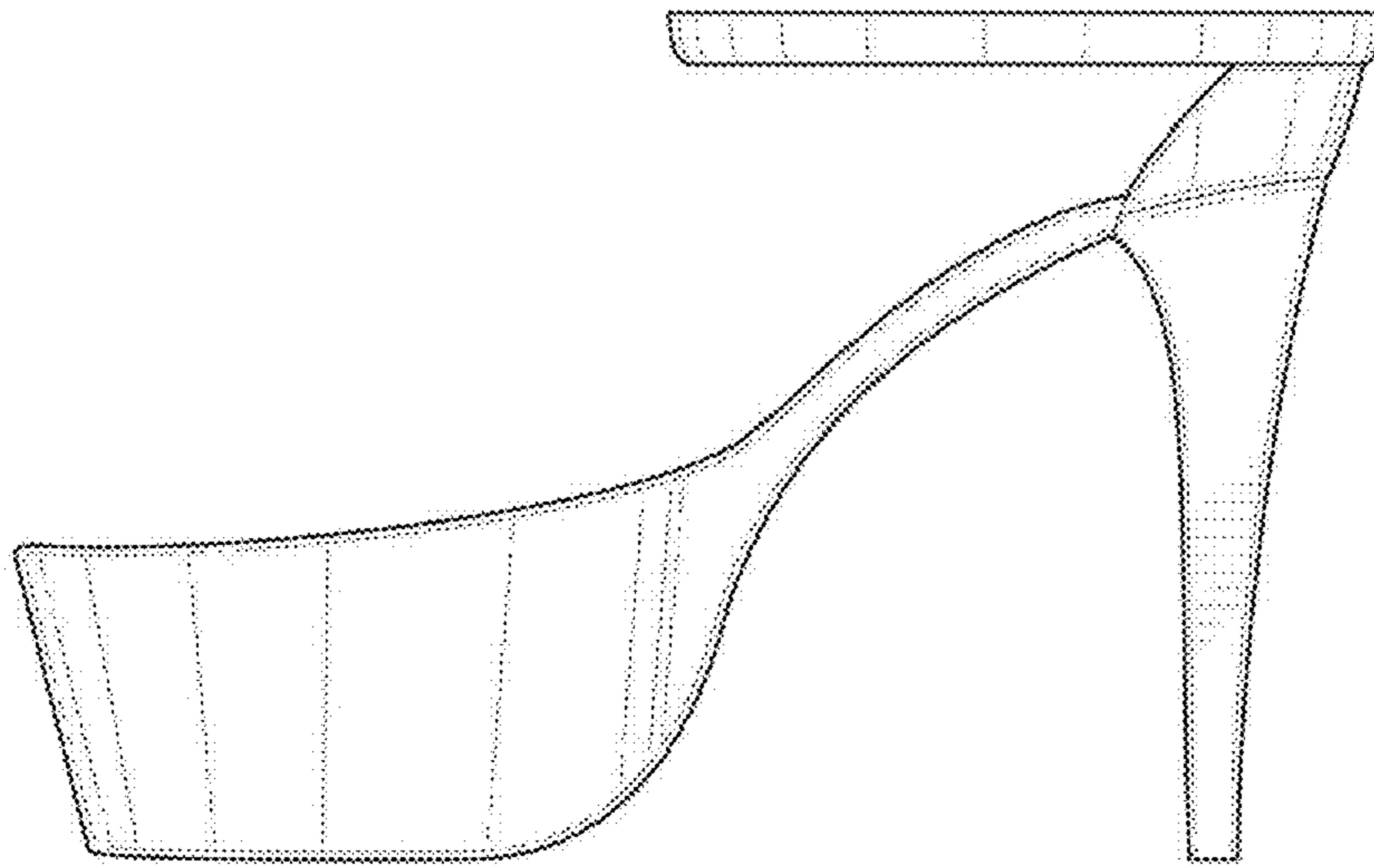

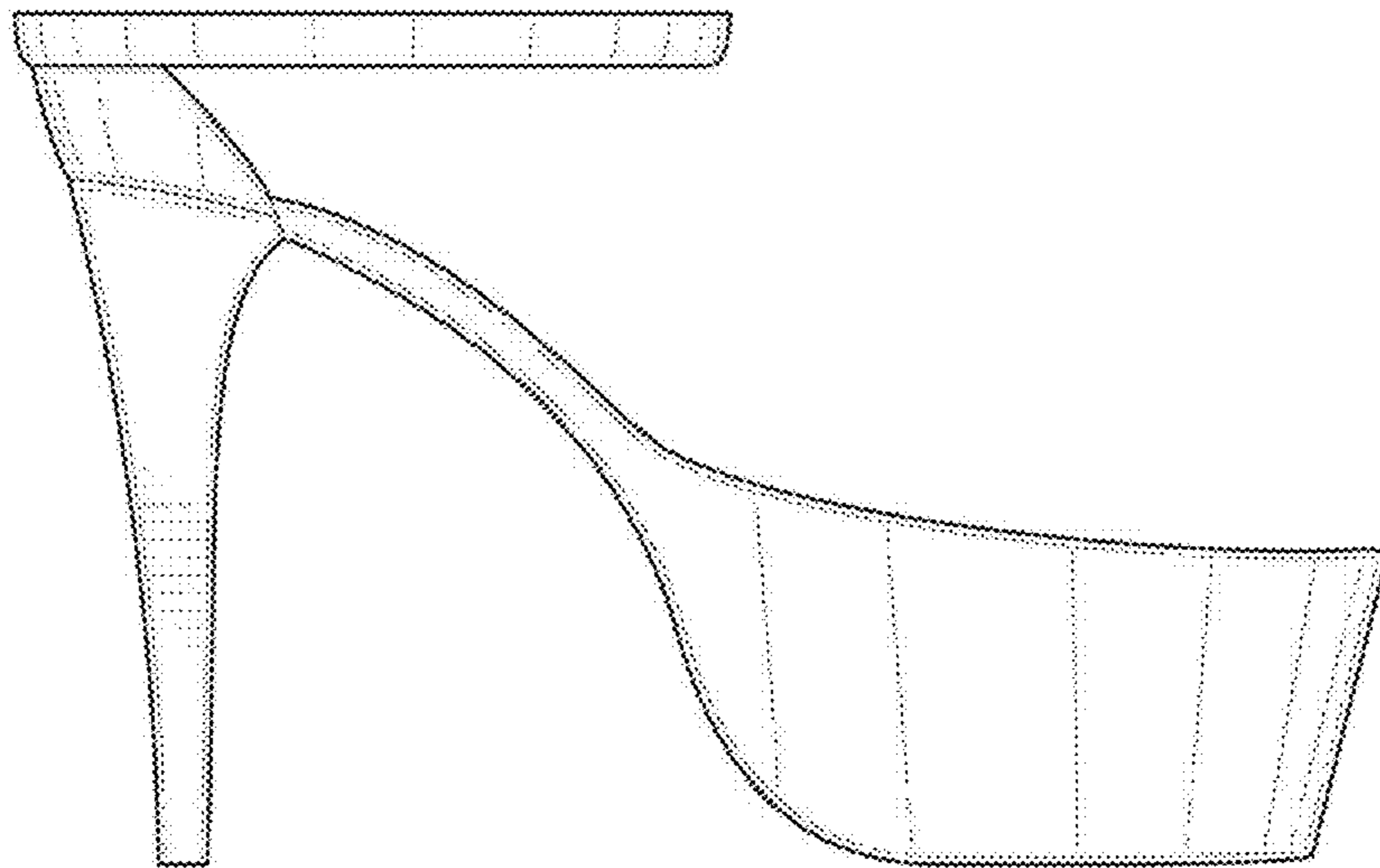

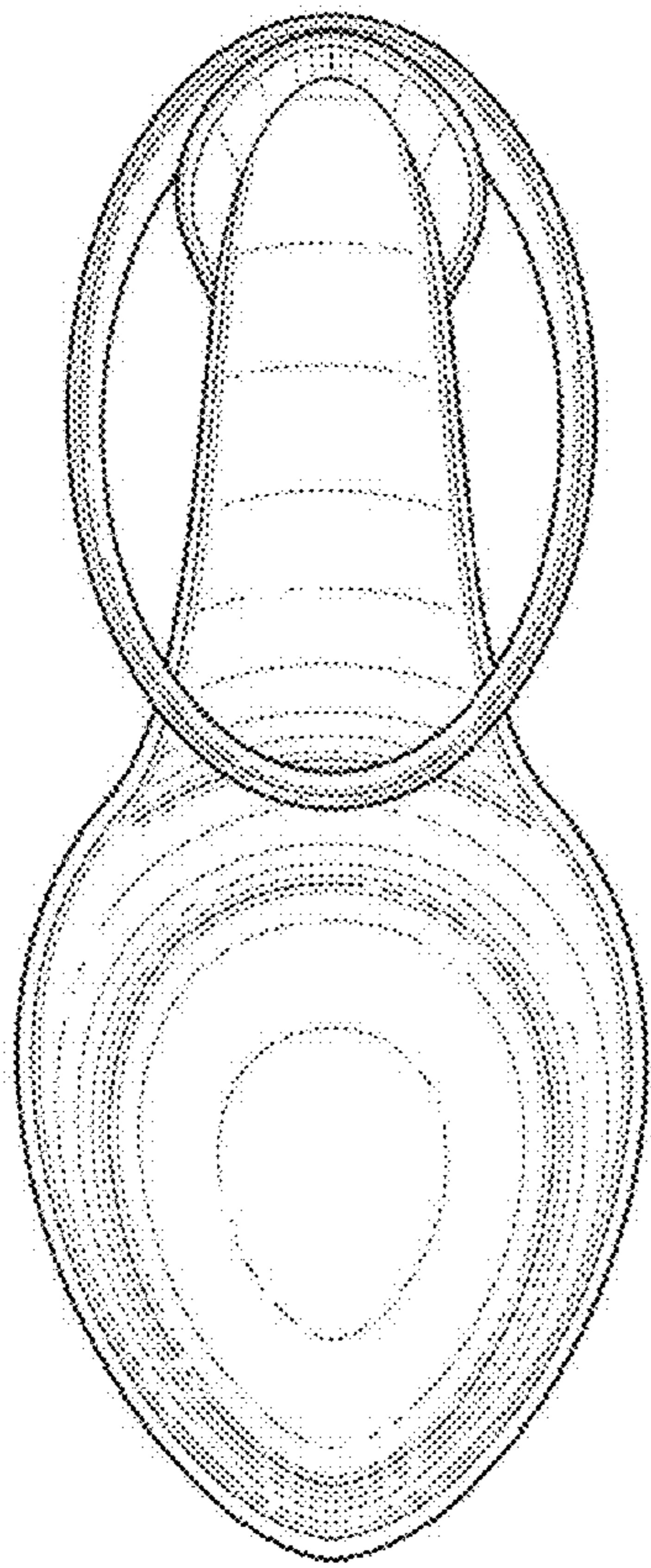

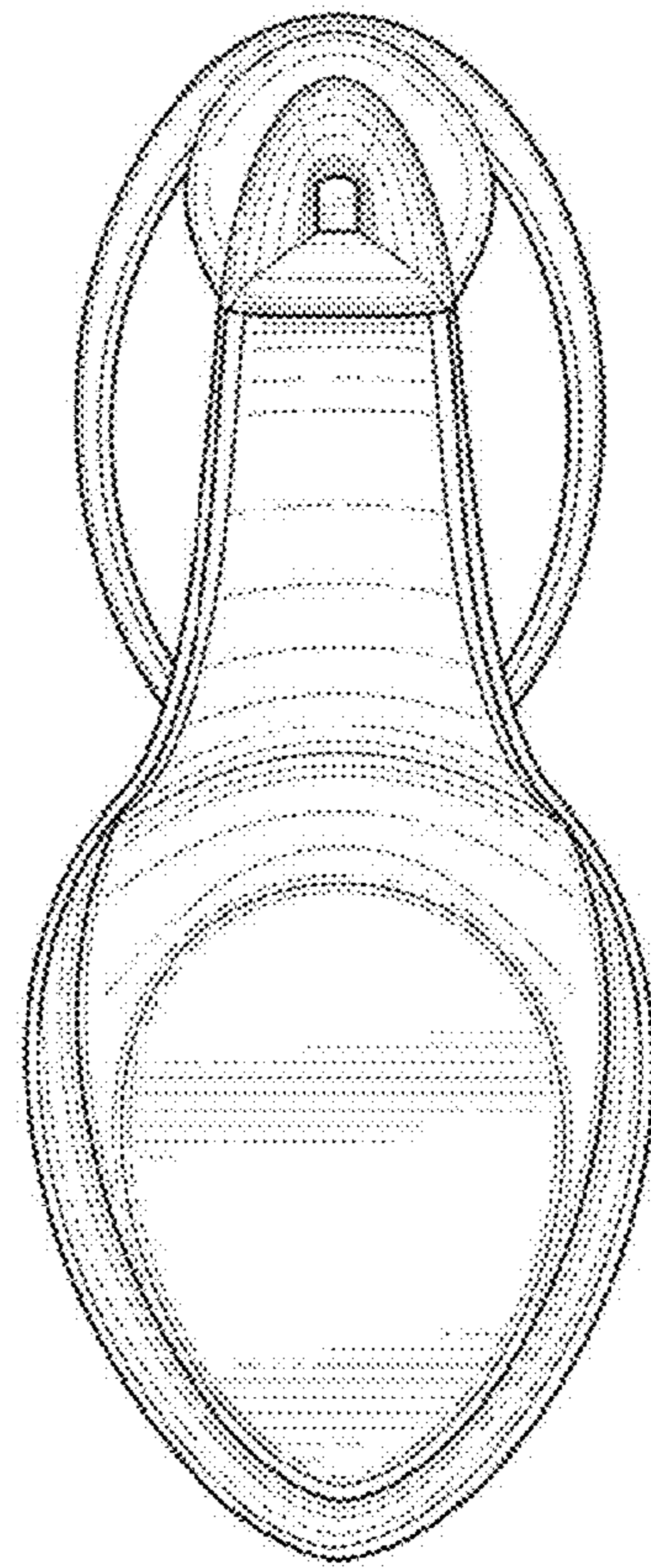

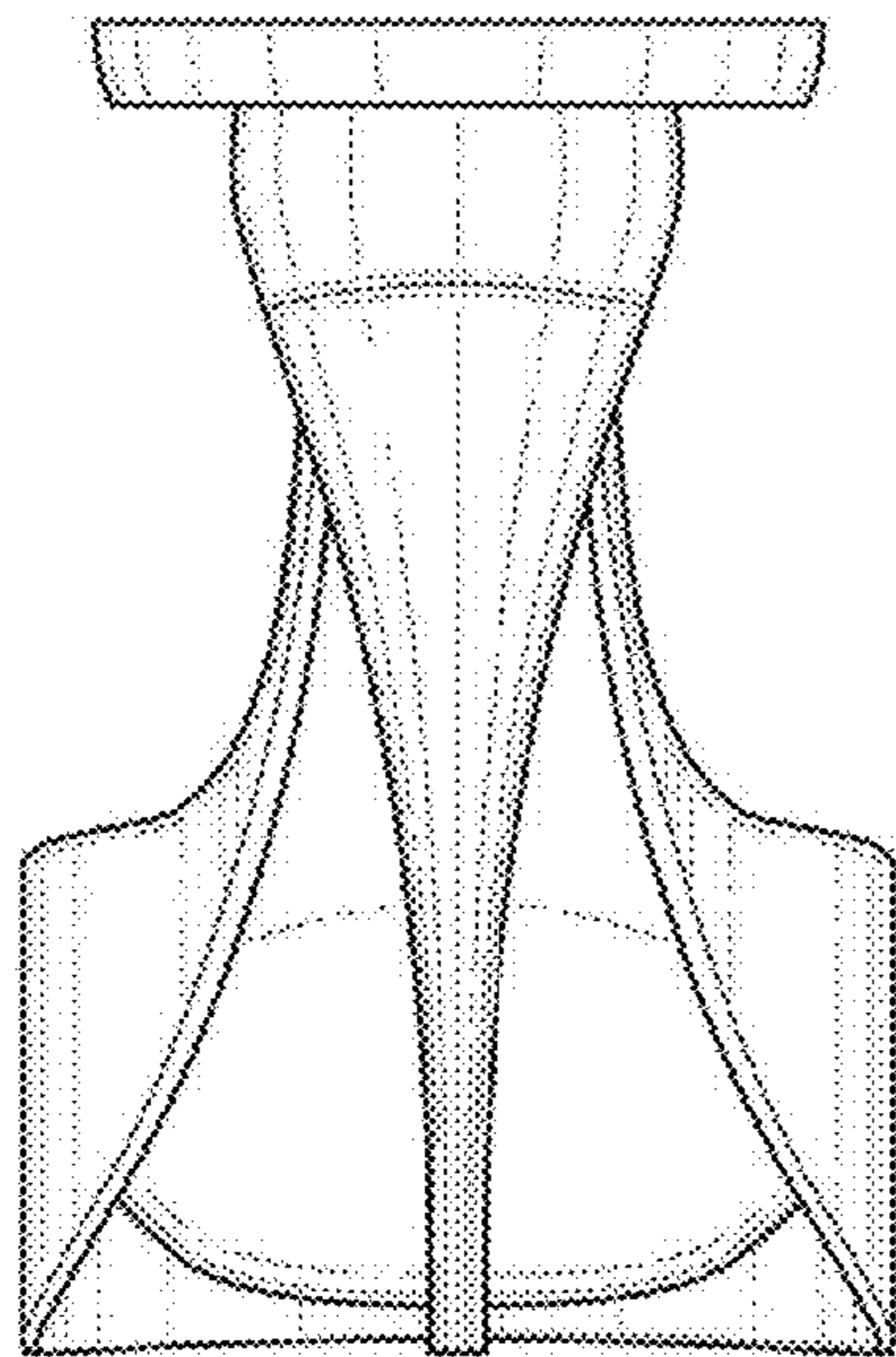

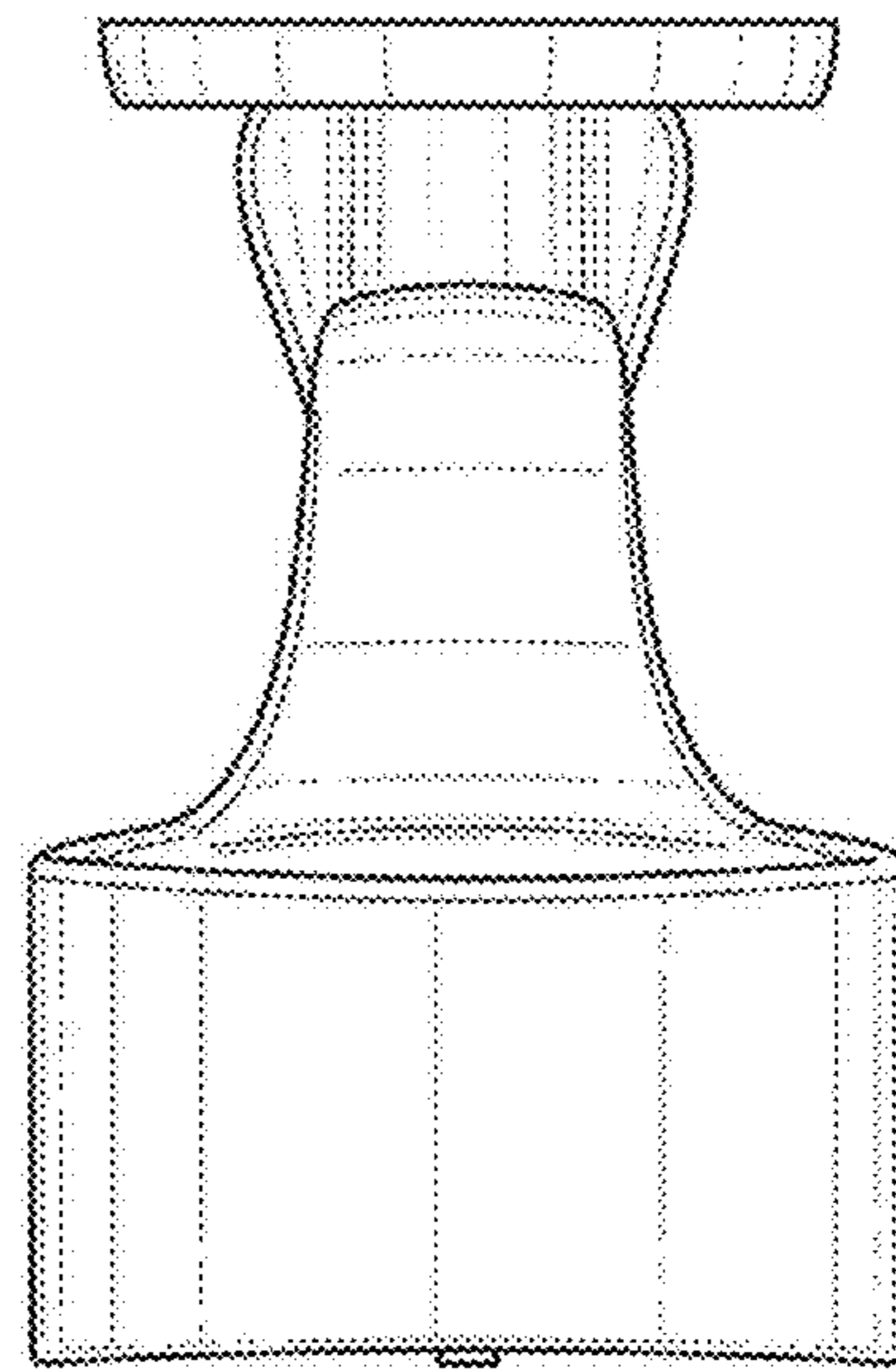
