(57) **CLAIM**

I claim the ornamental design for a food package, as shown and described.

DESCRIPTION

FIG. 1 is top, front and right perspective view of the food package according to the new design;
FIG. 2 is a bottom, rear and right perspective view of the food package shown in FIG. 1;
FIG. 3 is a front elevation view of the food package shown in FIG. 1;
FIG. 4 is a rear elevation view of the food package shown in FIG. 1;
FIG. 5 is a top plan view of the food package shown in FIG. 1;
FIG. 6 is a bottom plan view of the food package shown in FIG. 1;
FIG. 7 is a right side elevation view of the food package shown in FIG. 1; and,
FIG. 8 is a left side elevation view of the food package shown in FIG. 1.

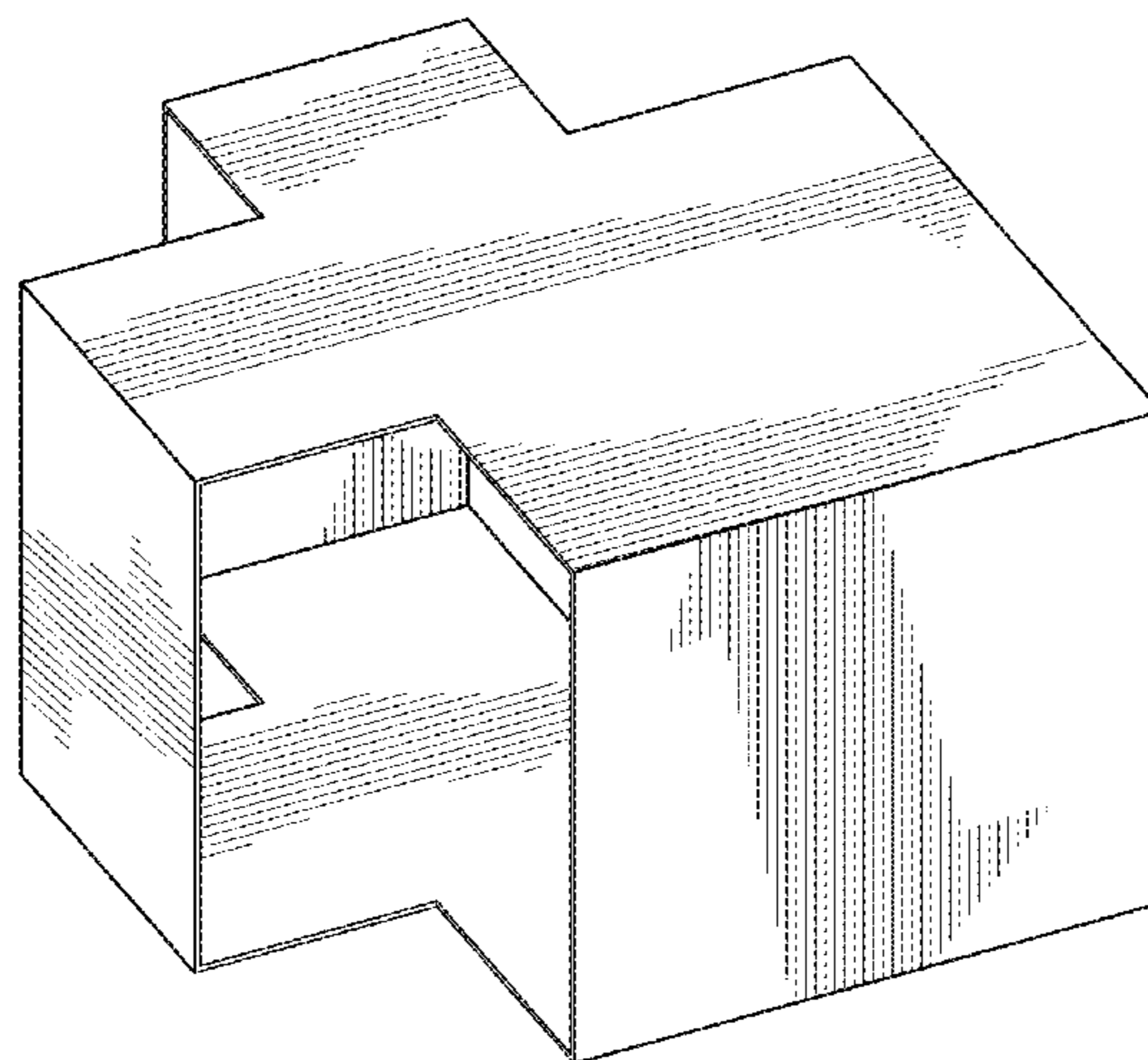

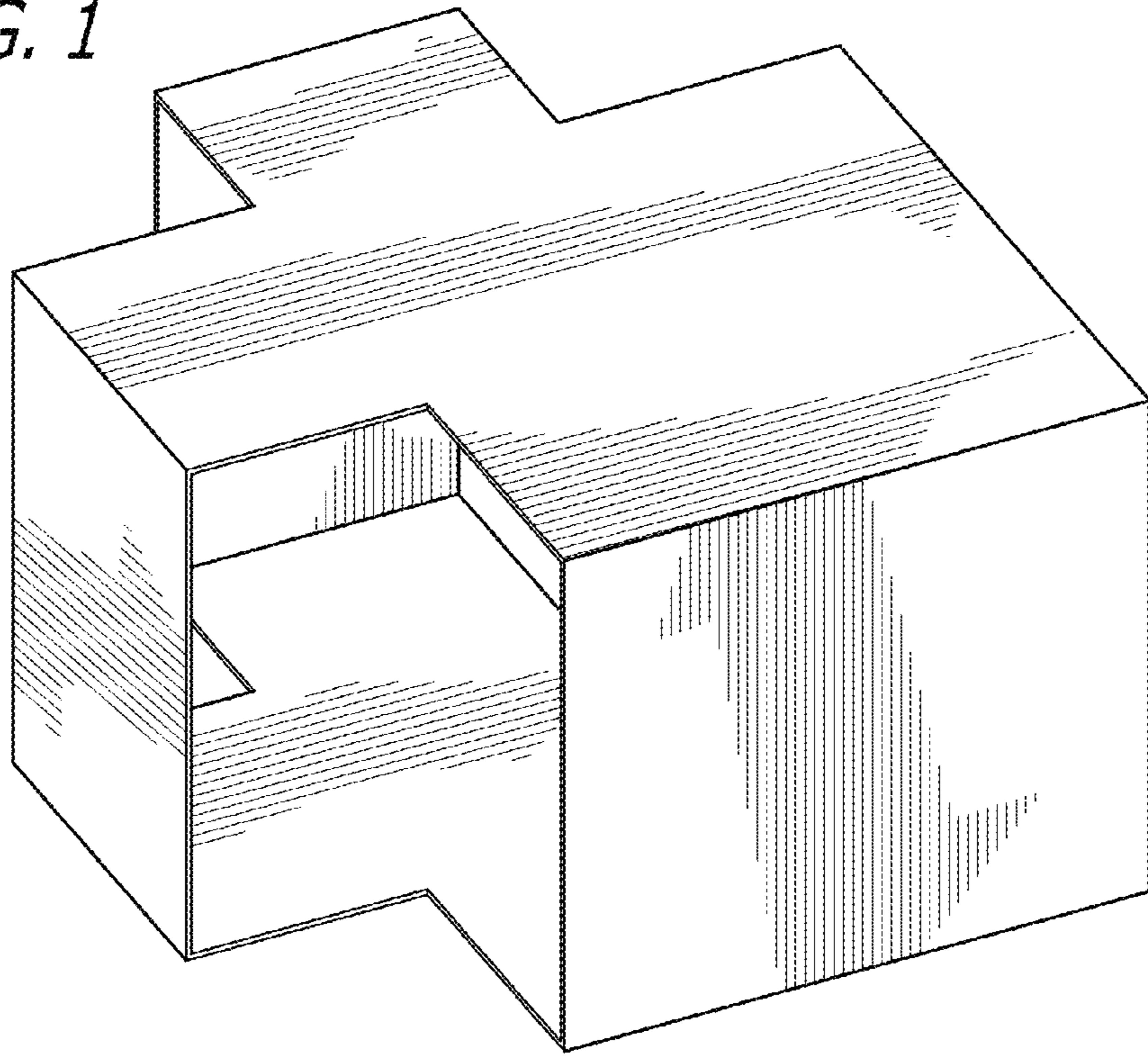
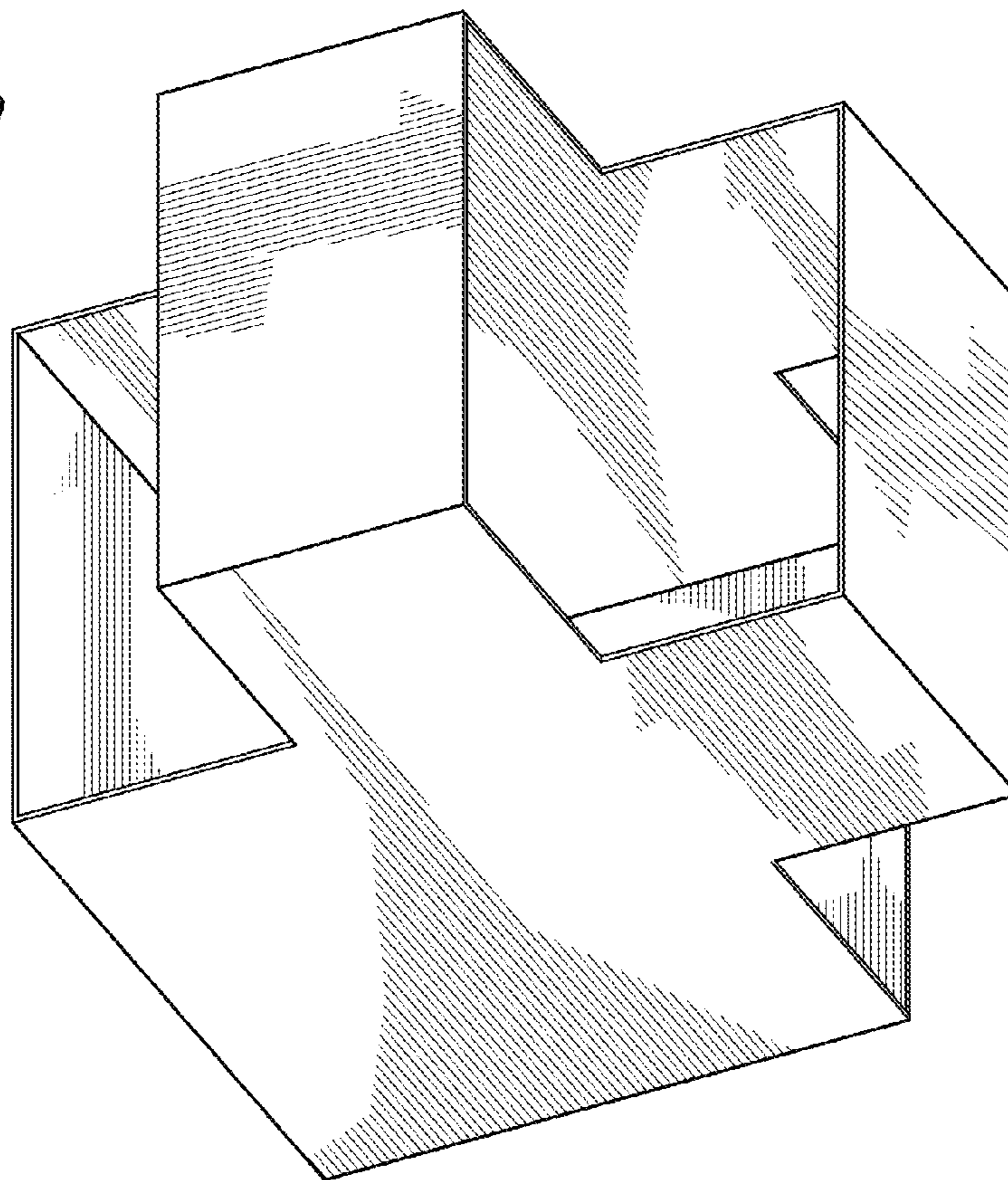

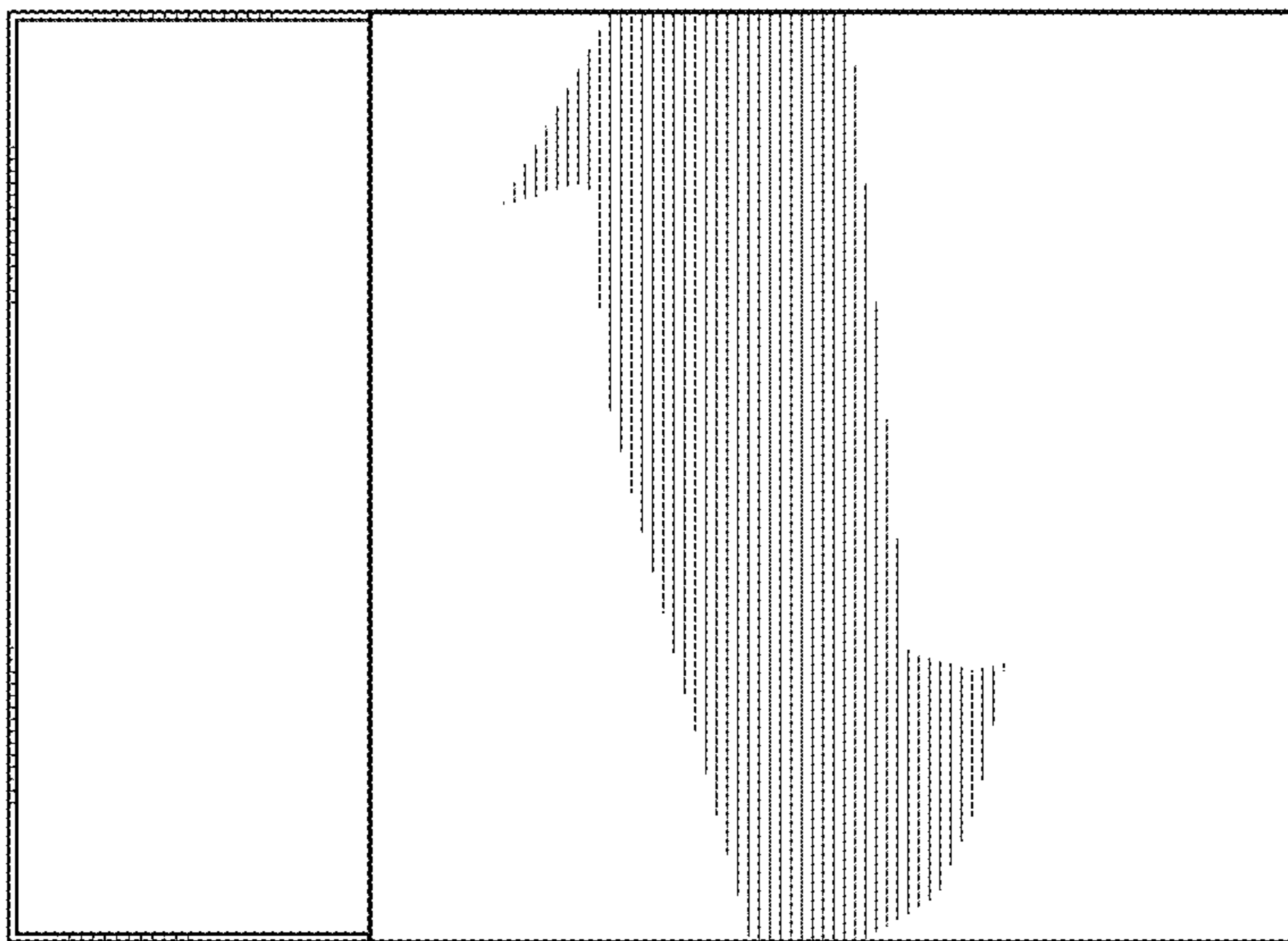

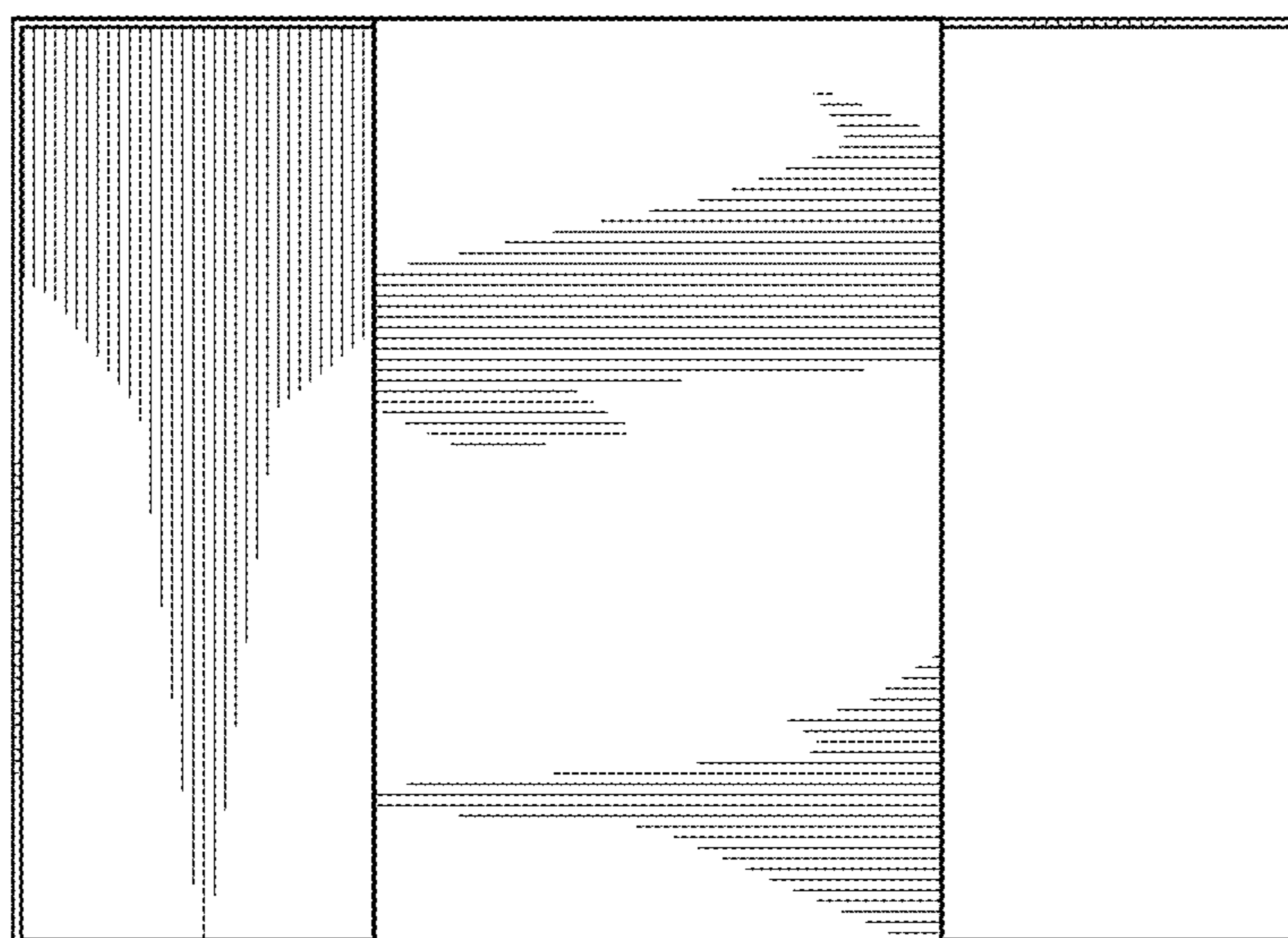

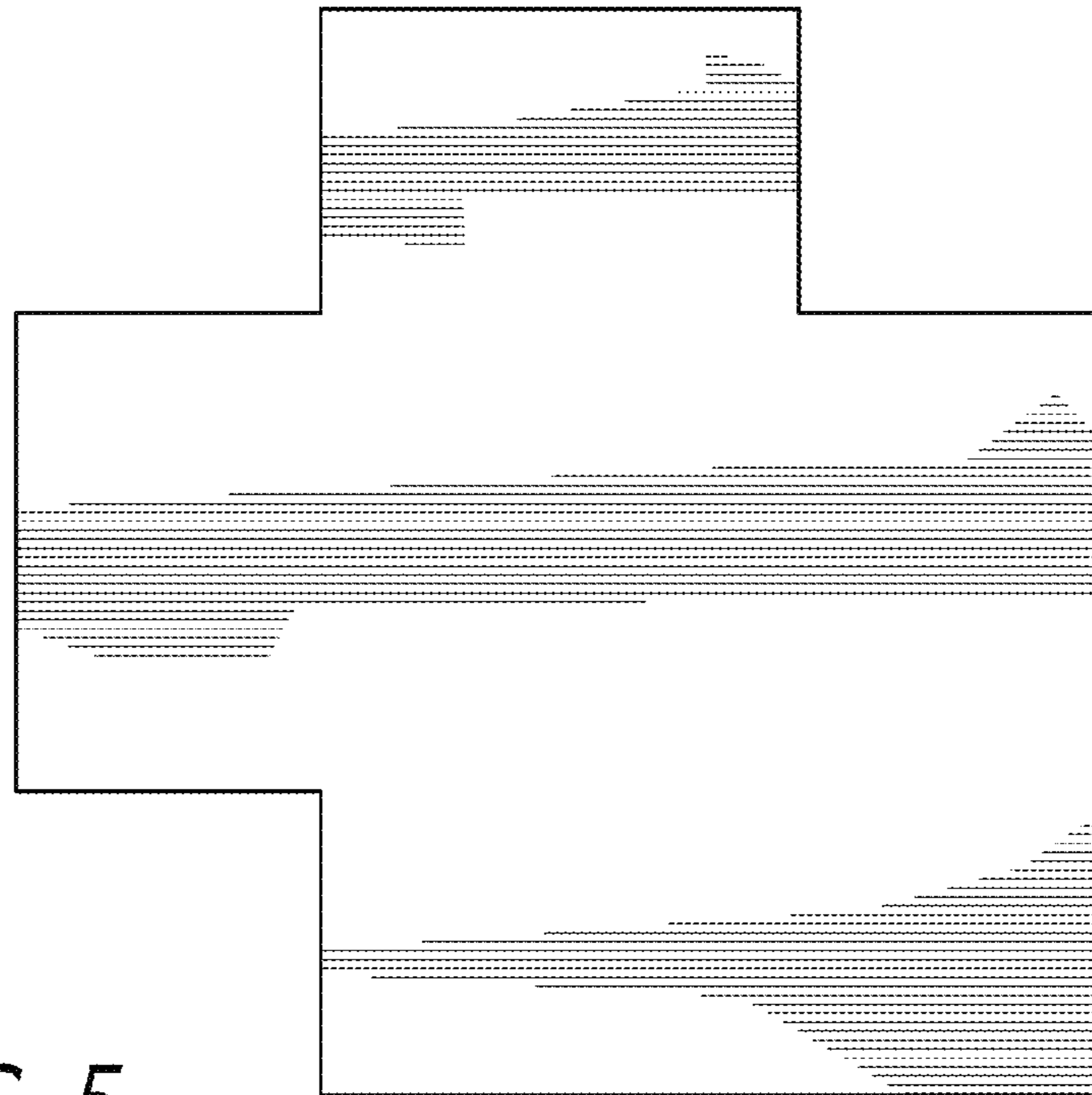

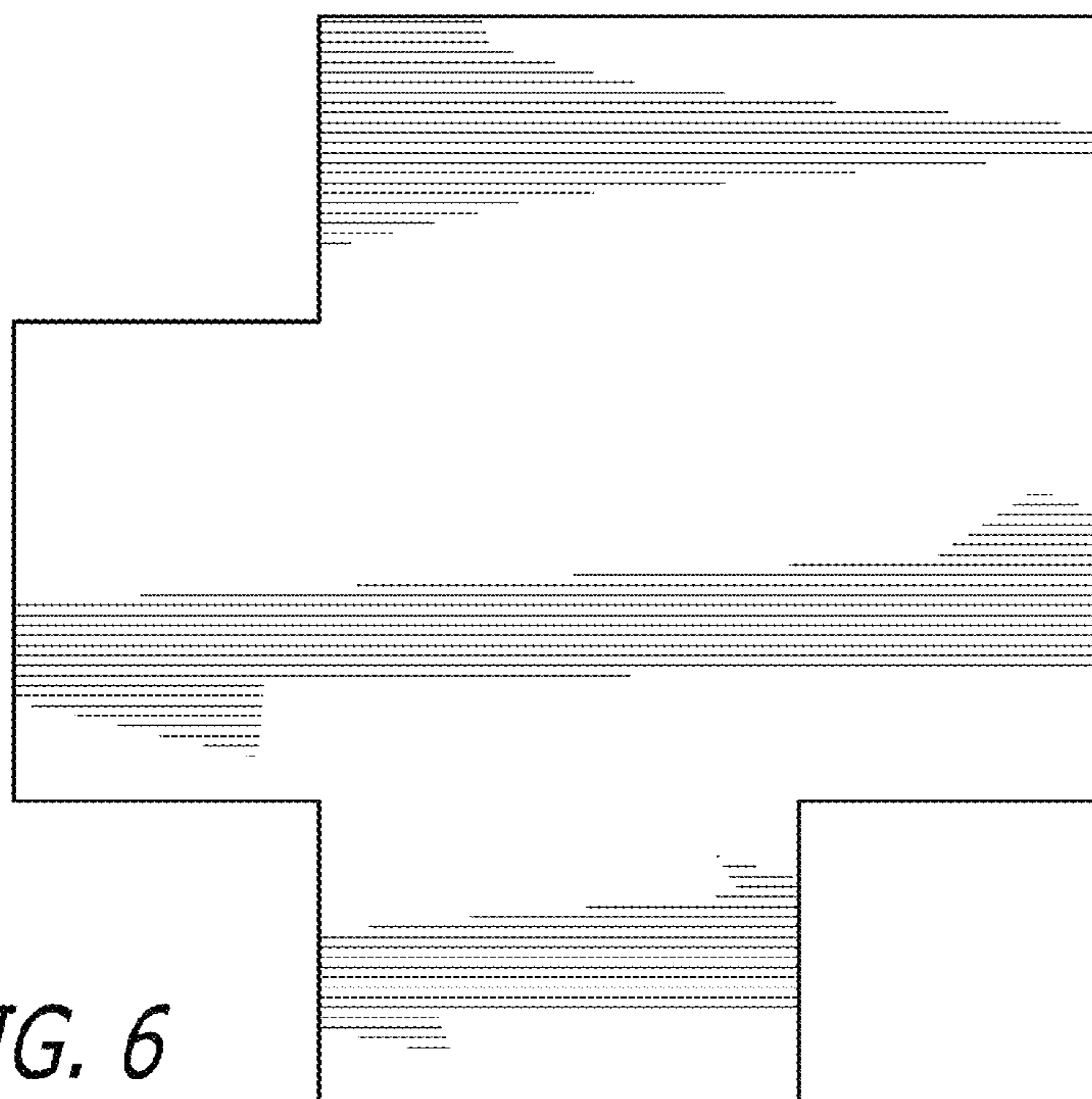

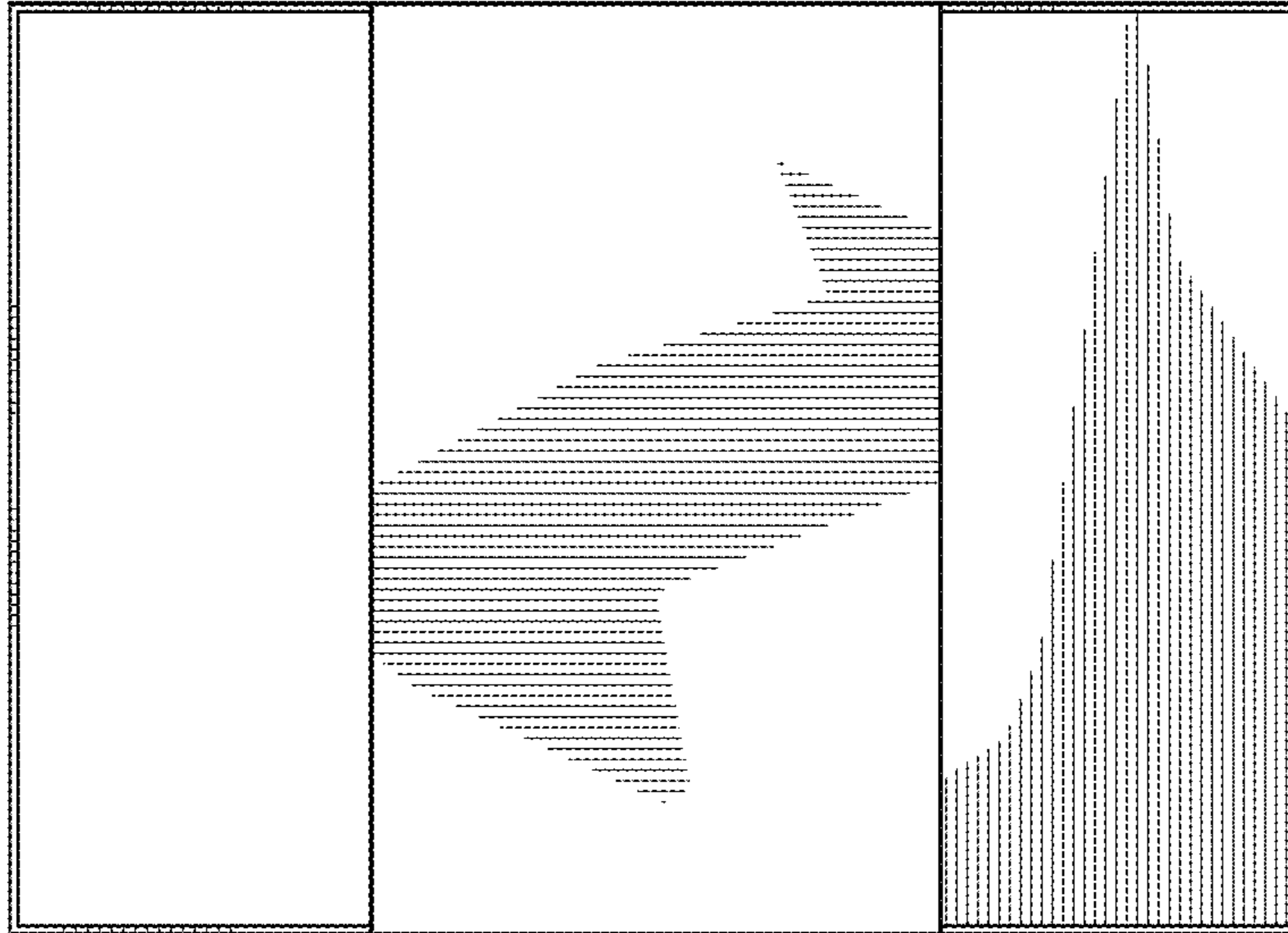

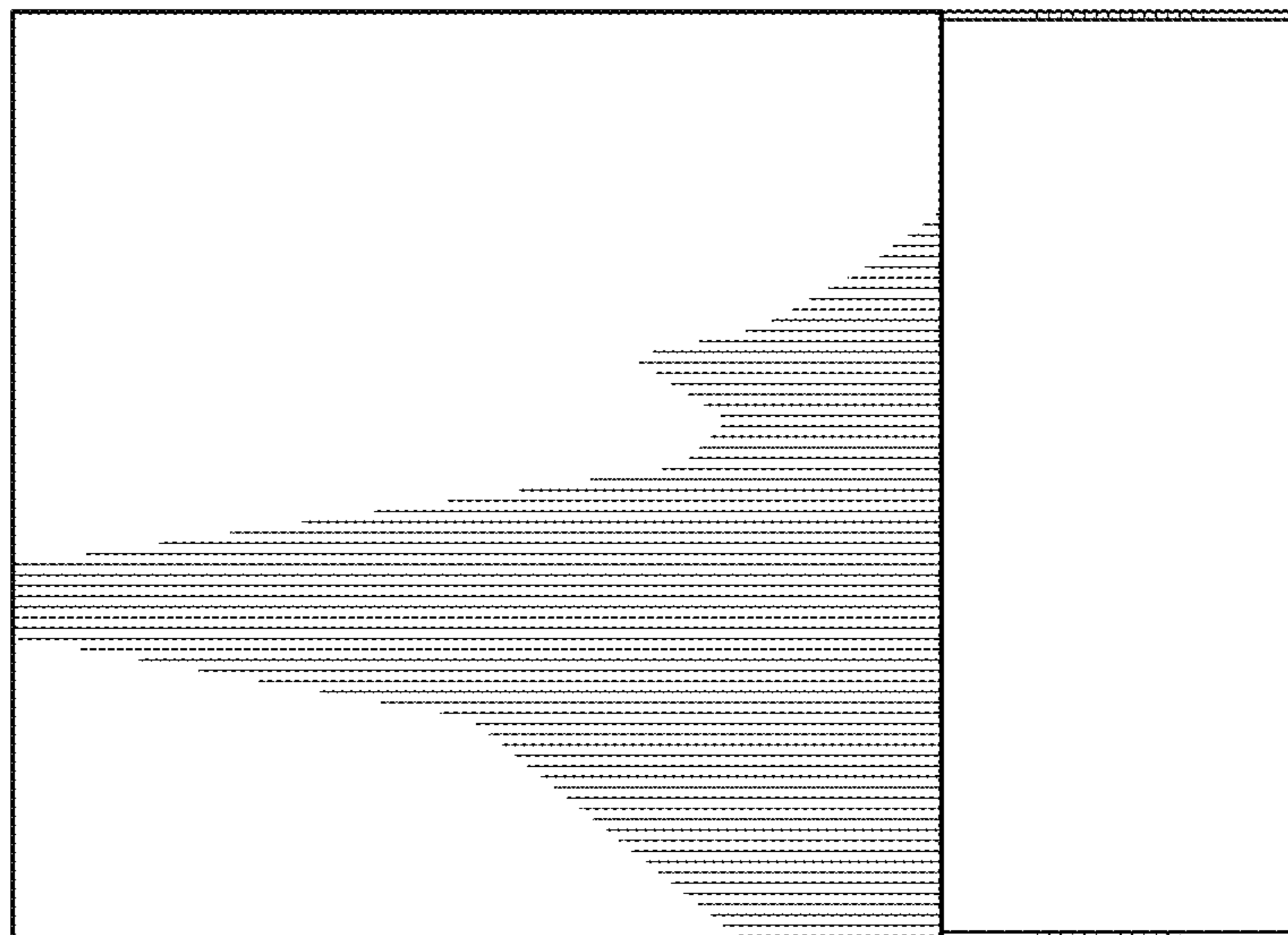
