described.

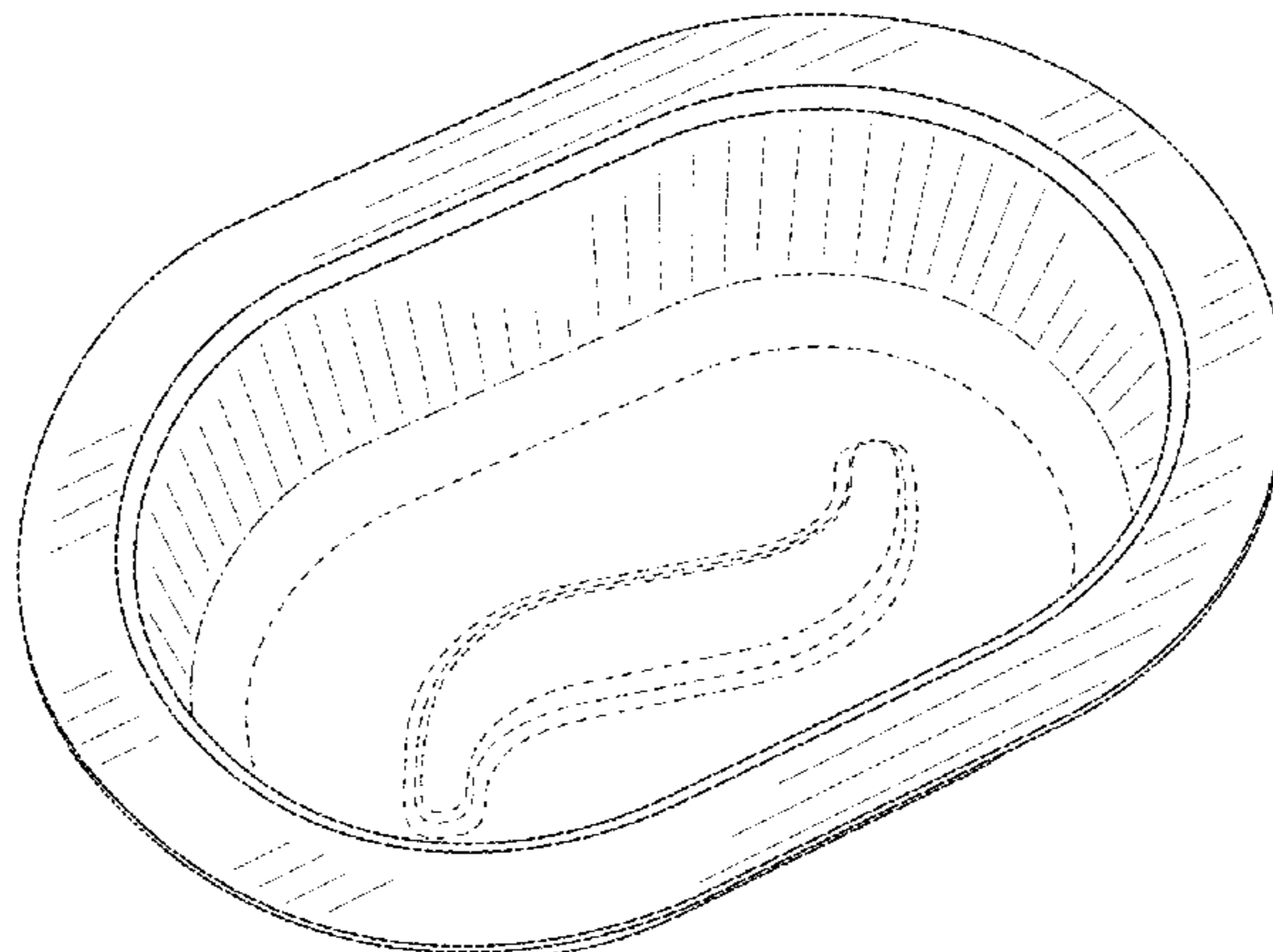
**DESCRIPTION**

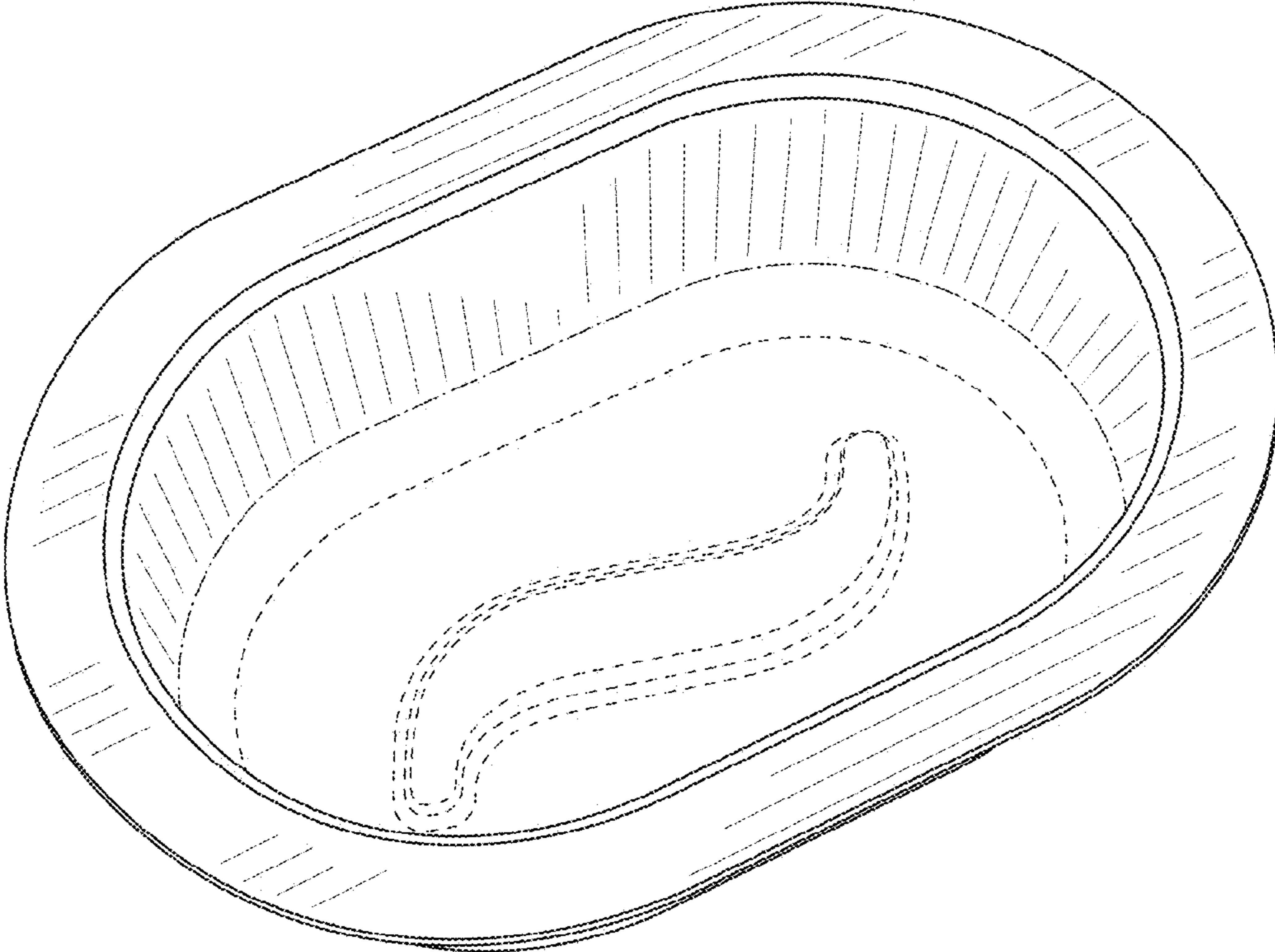

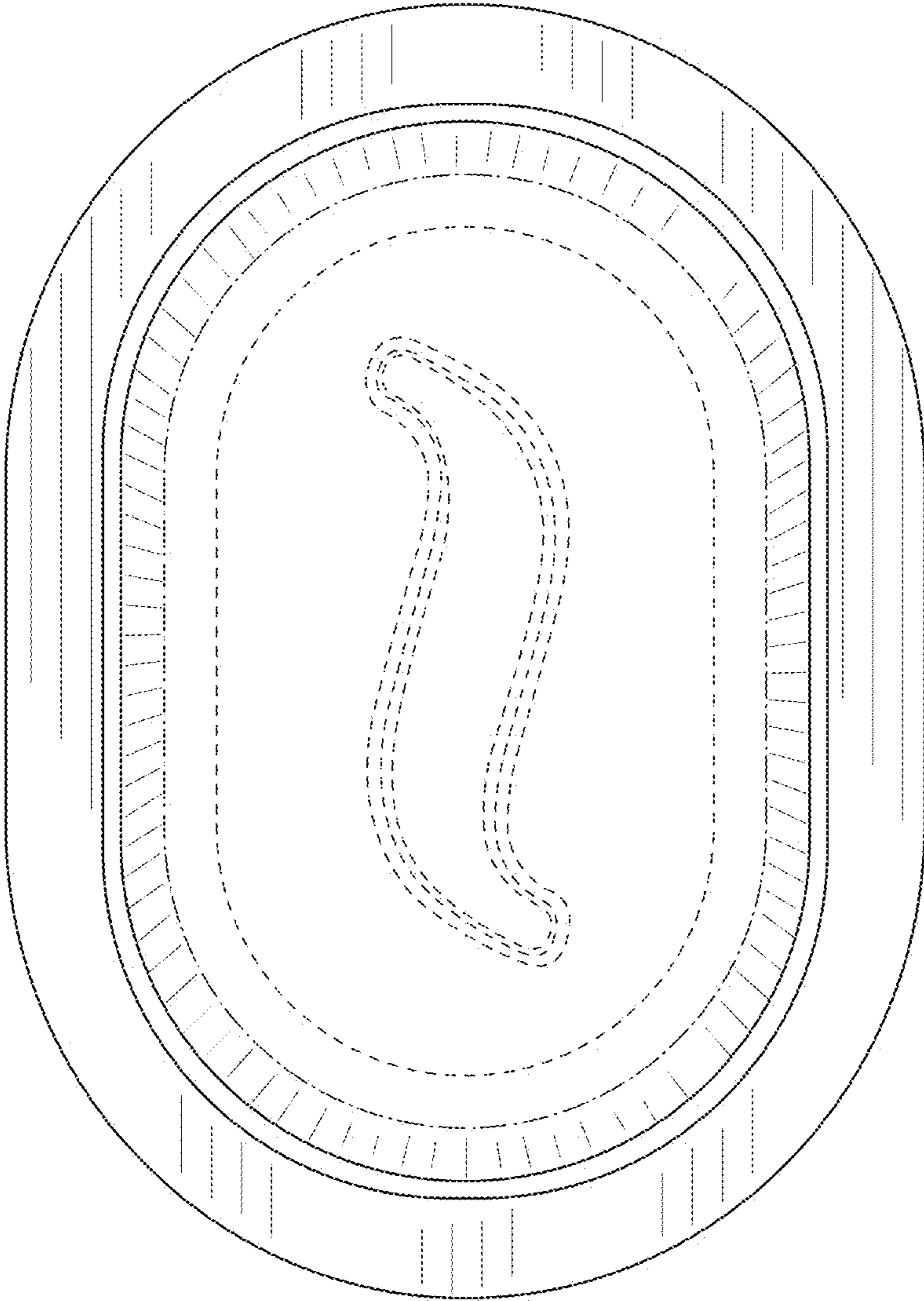
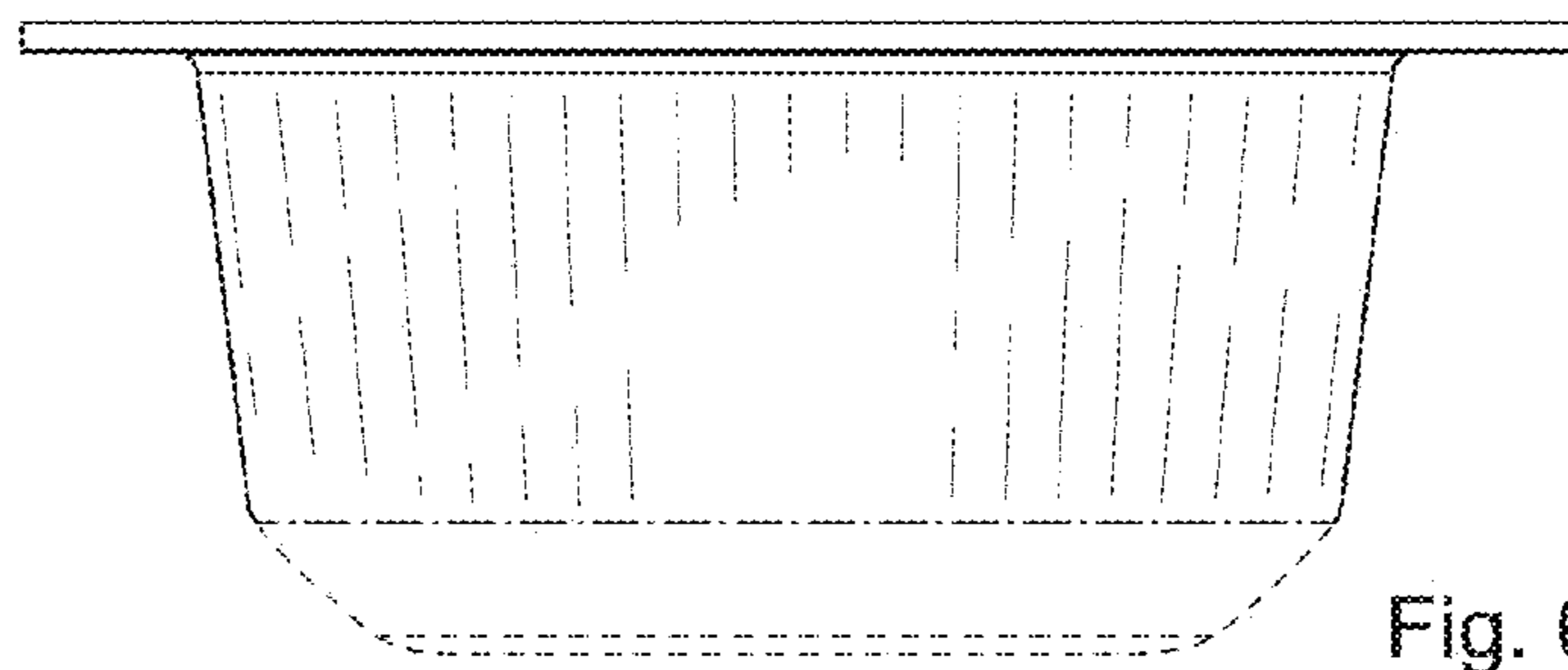
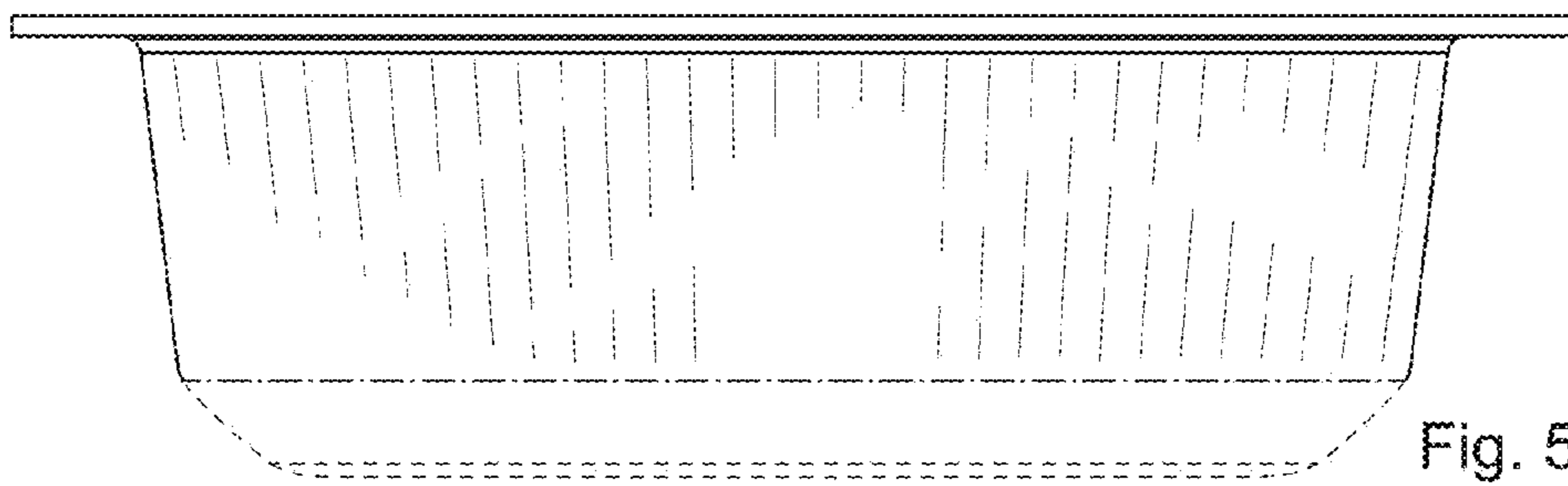
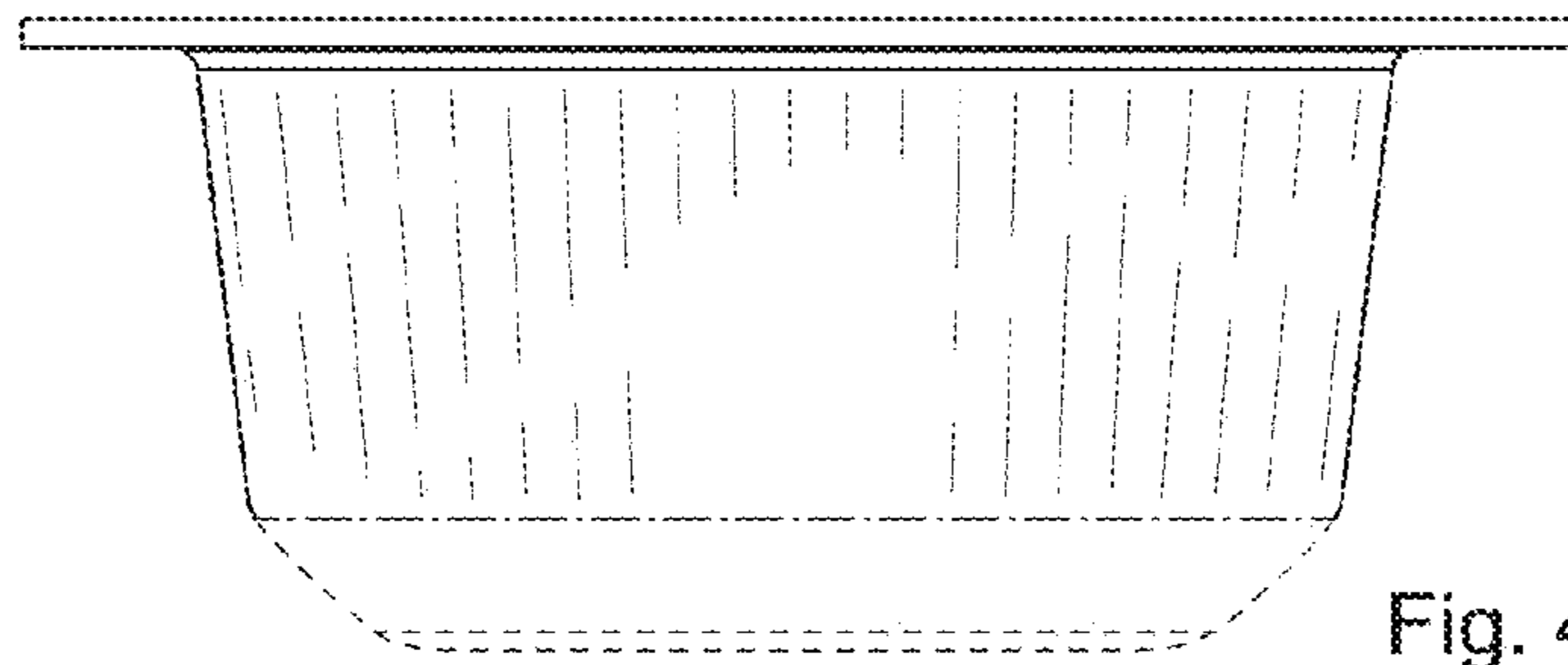
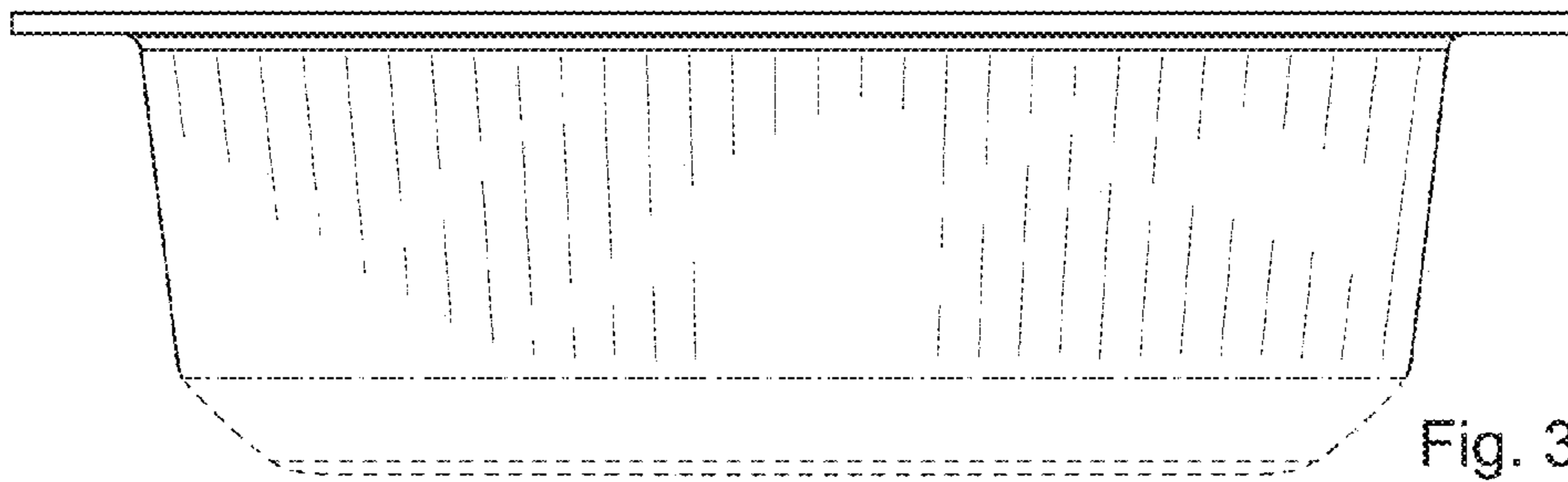

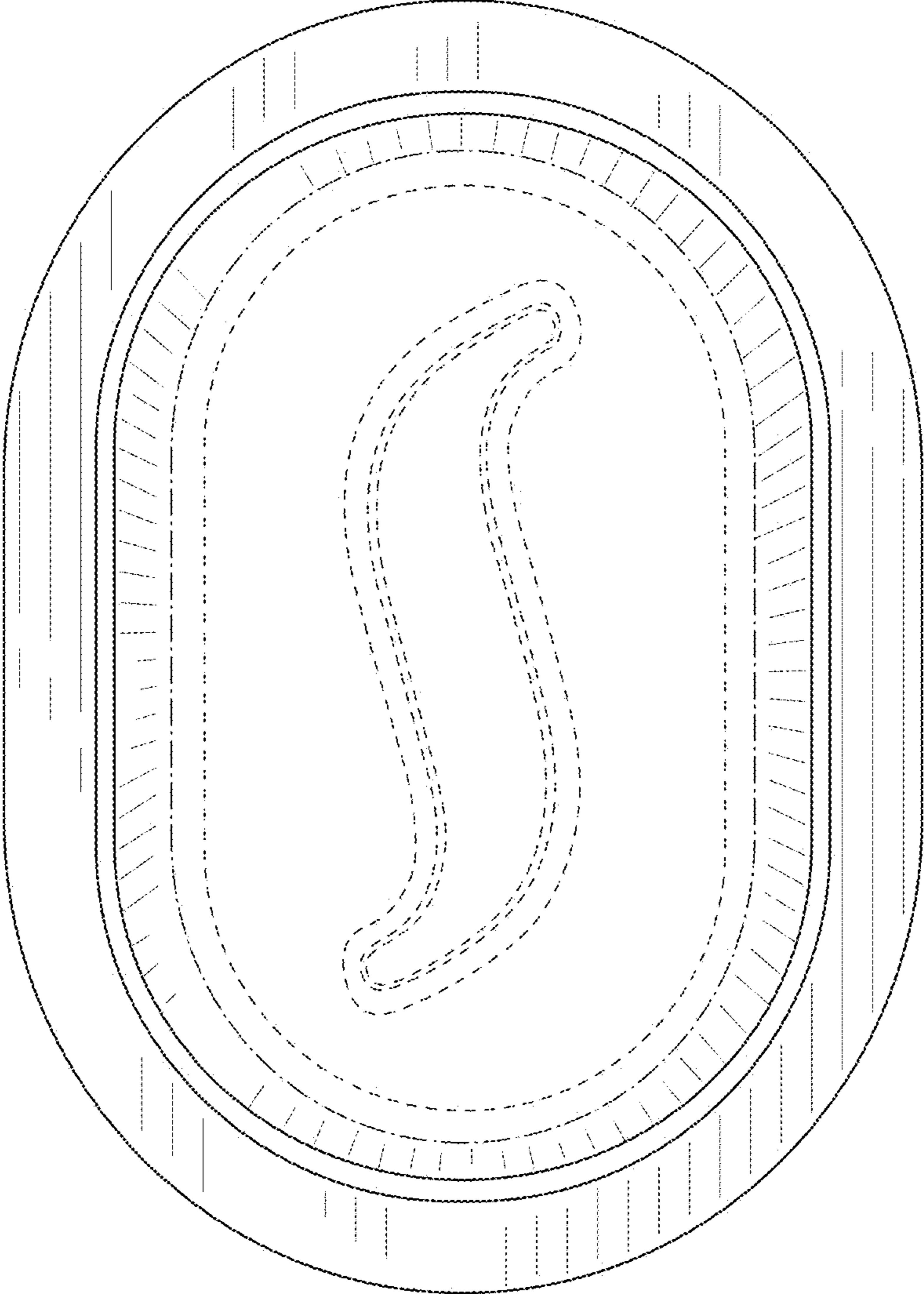
