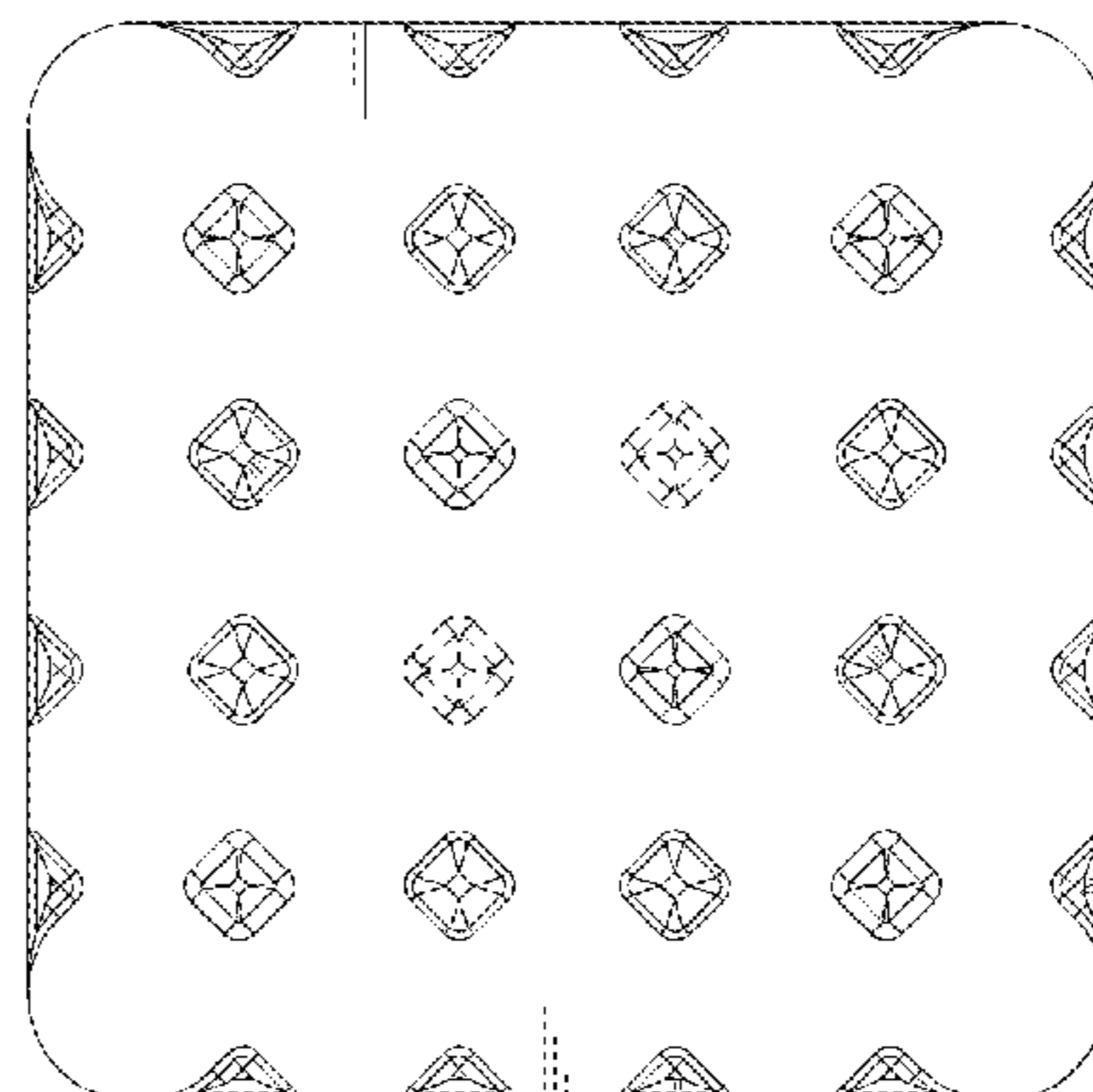
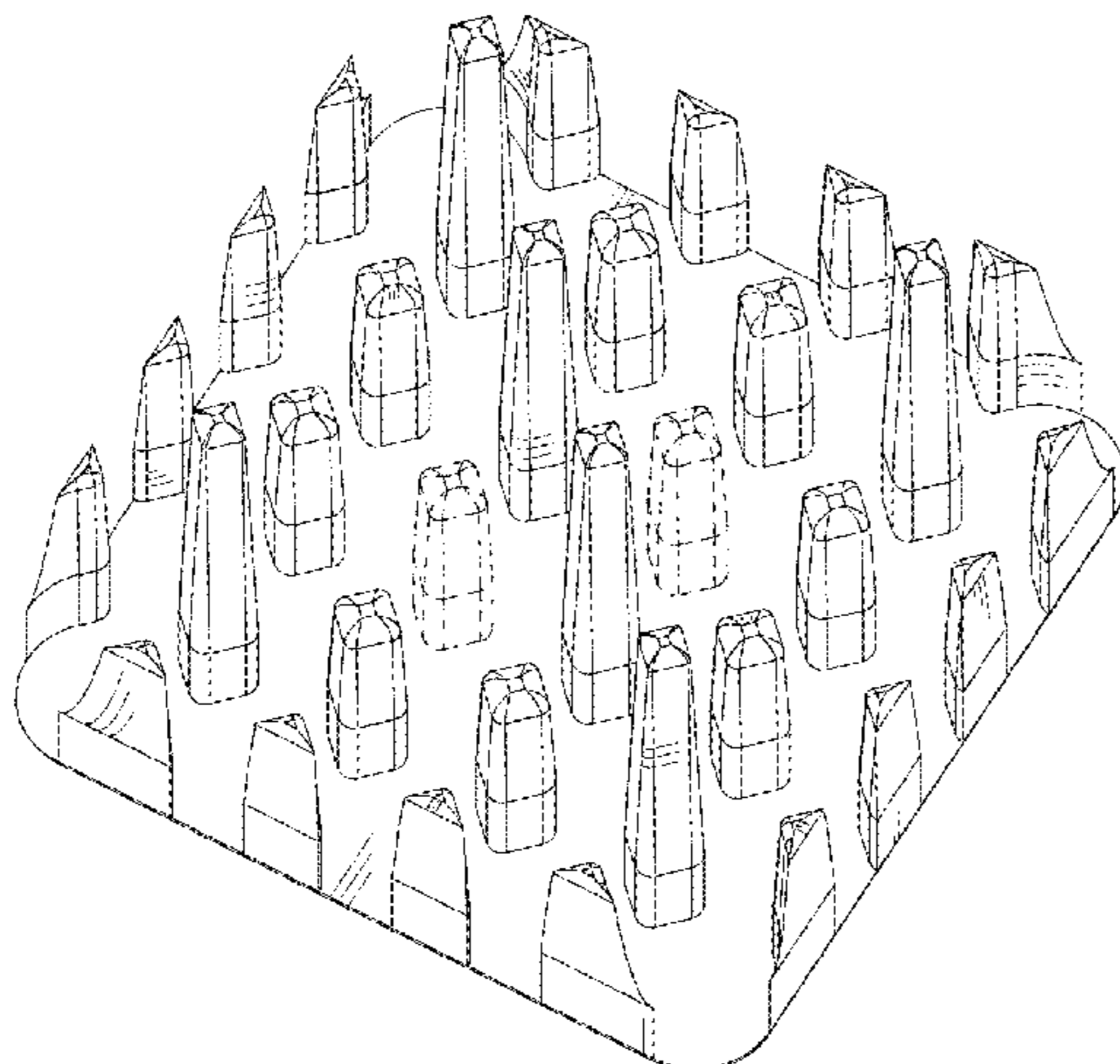
(57) **CLAIM**

The ornamental design for a packaging insert, as shown and described.

DESCRIPTION

FIG. 1 is a top-right-front perspective view of a packaging insert;
FIG. 2 is a top-left-rear perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevation view thereof, the rear elevation view, right side elevation view, and left side elevation view being identical thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines are shown for the purpose of illustrating parts of the packaging insert that form no part of the claimed design.

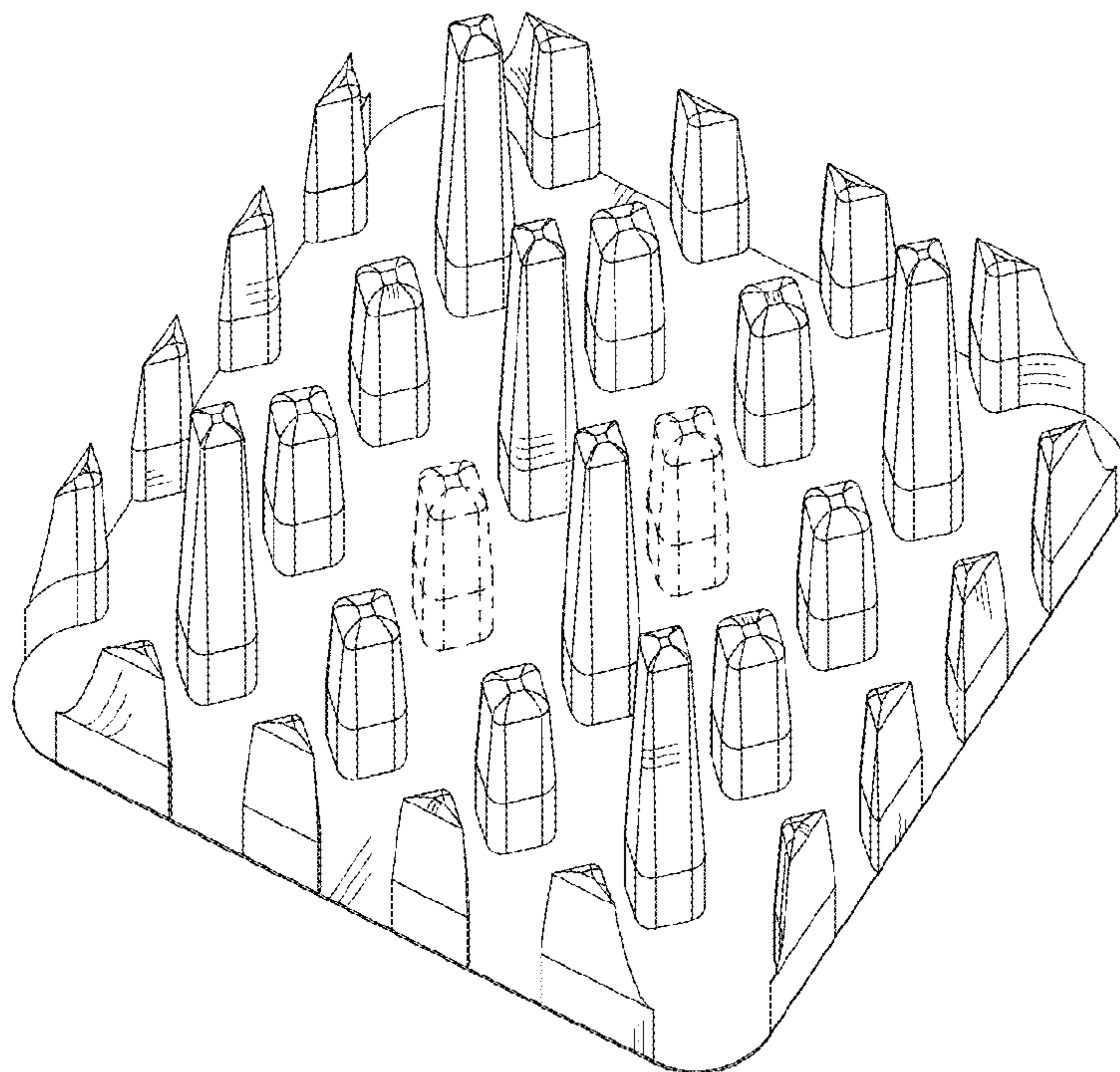

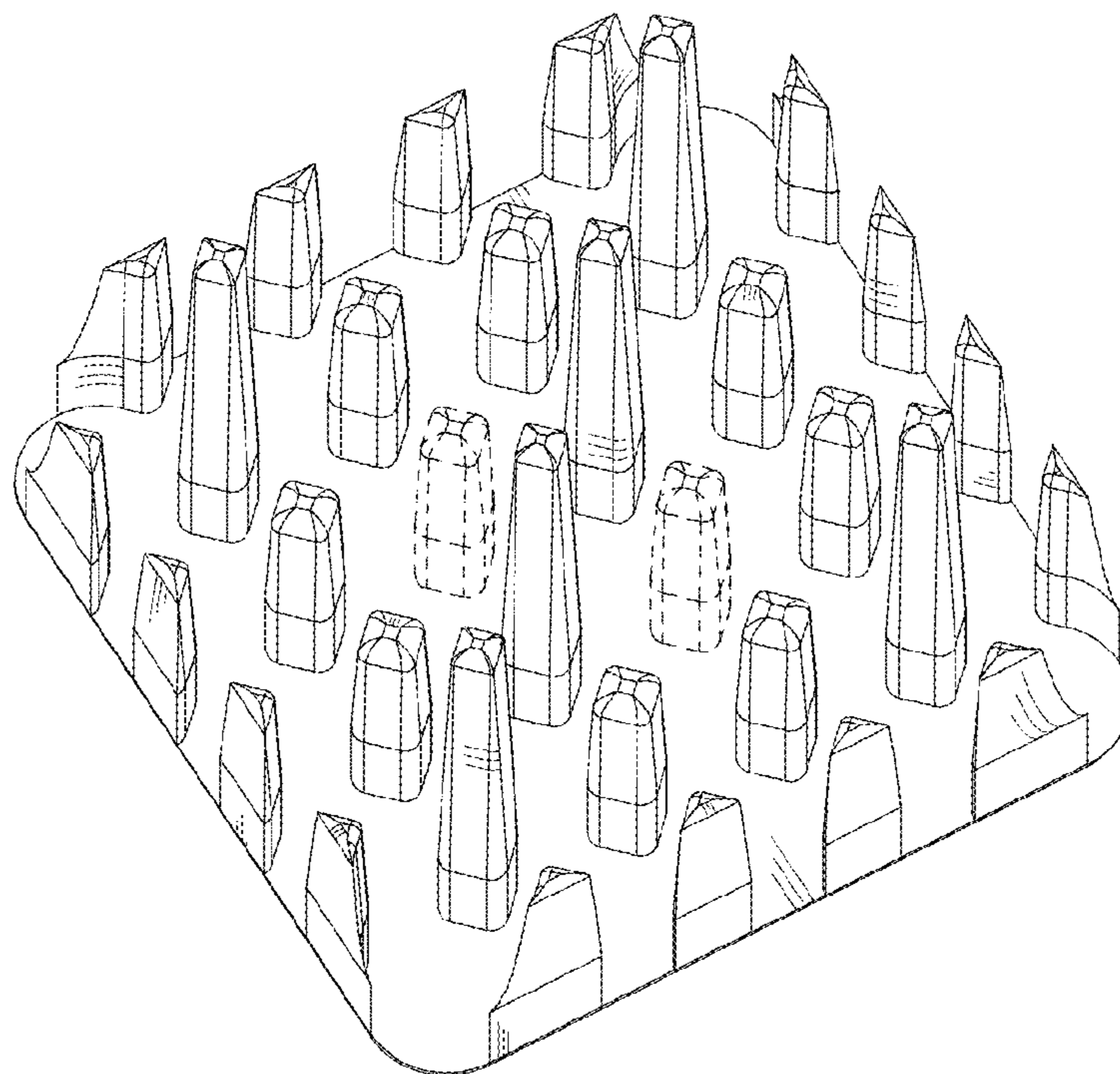

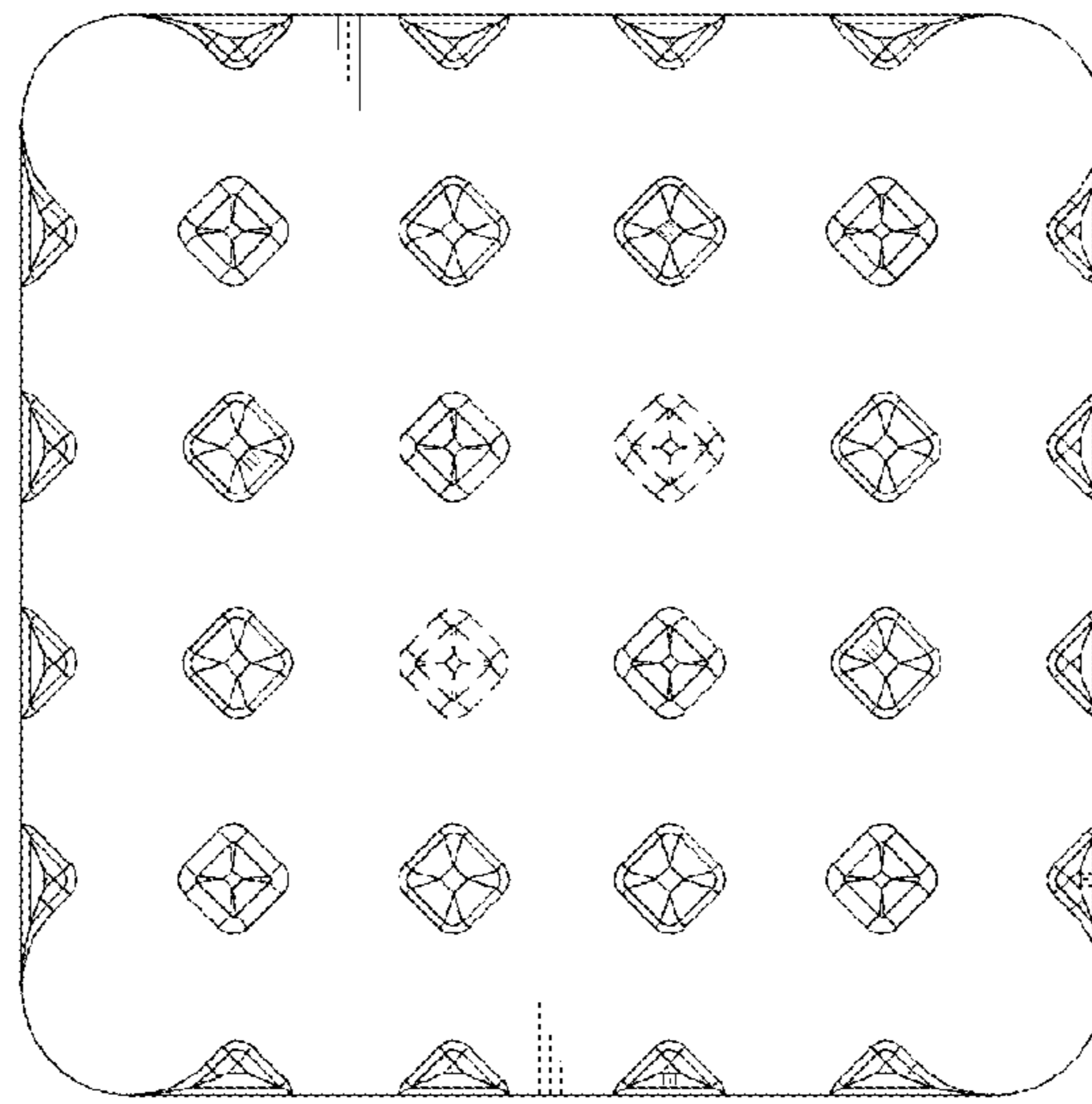

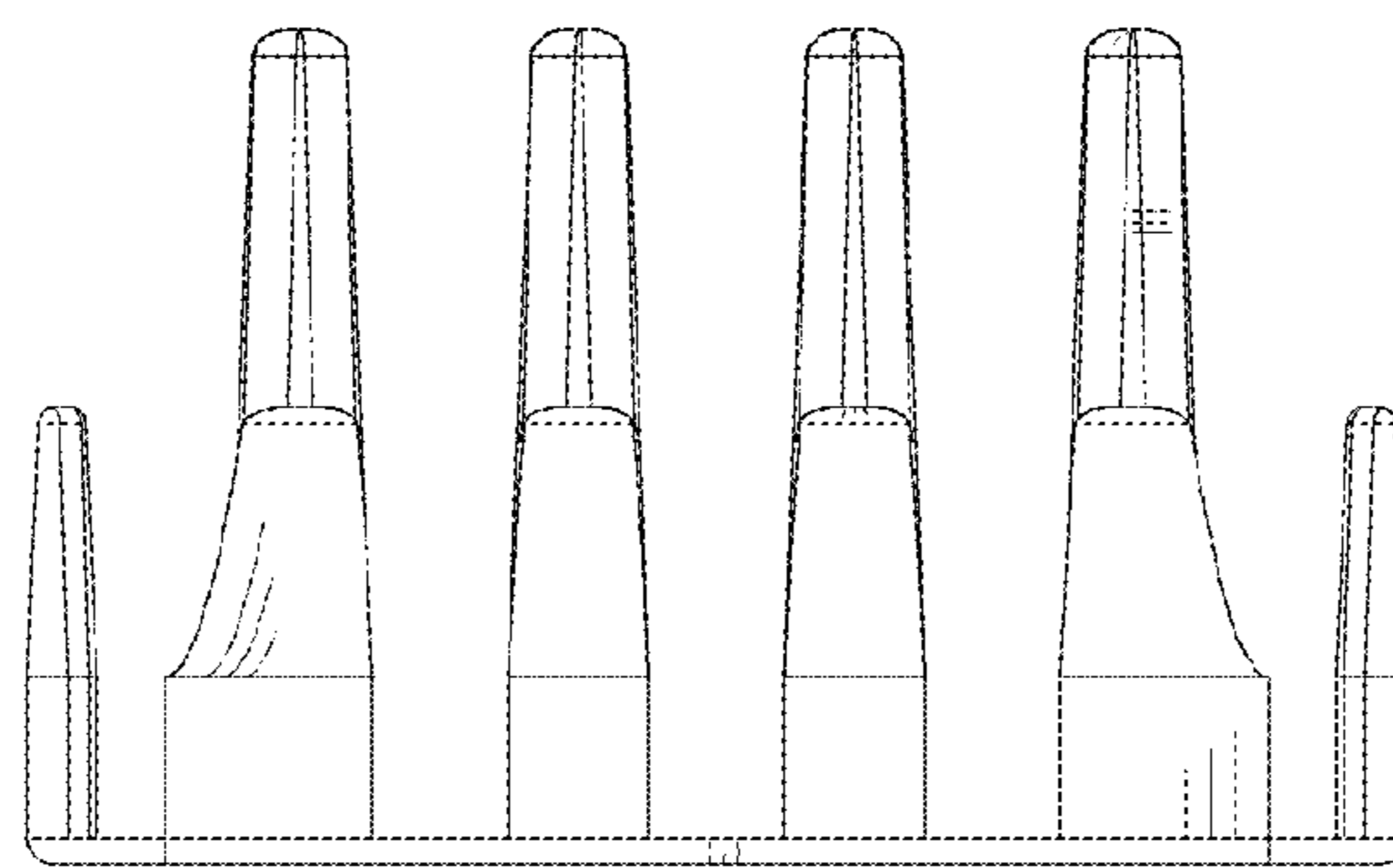

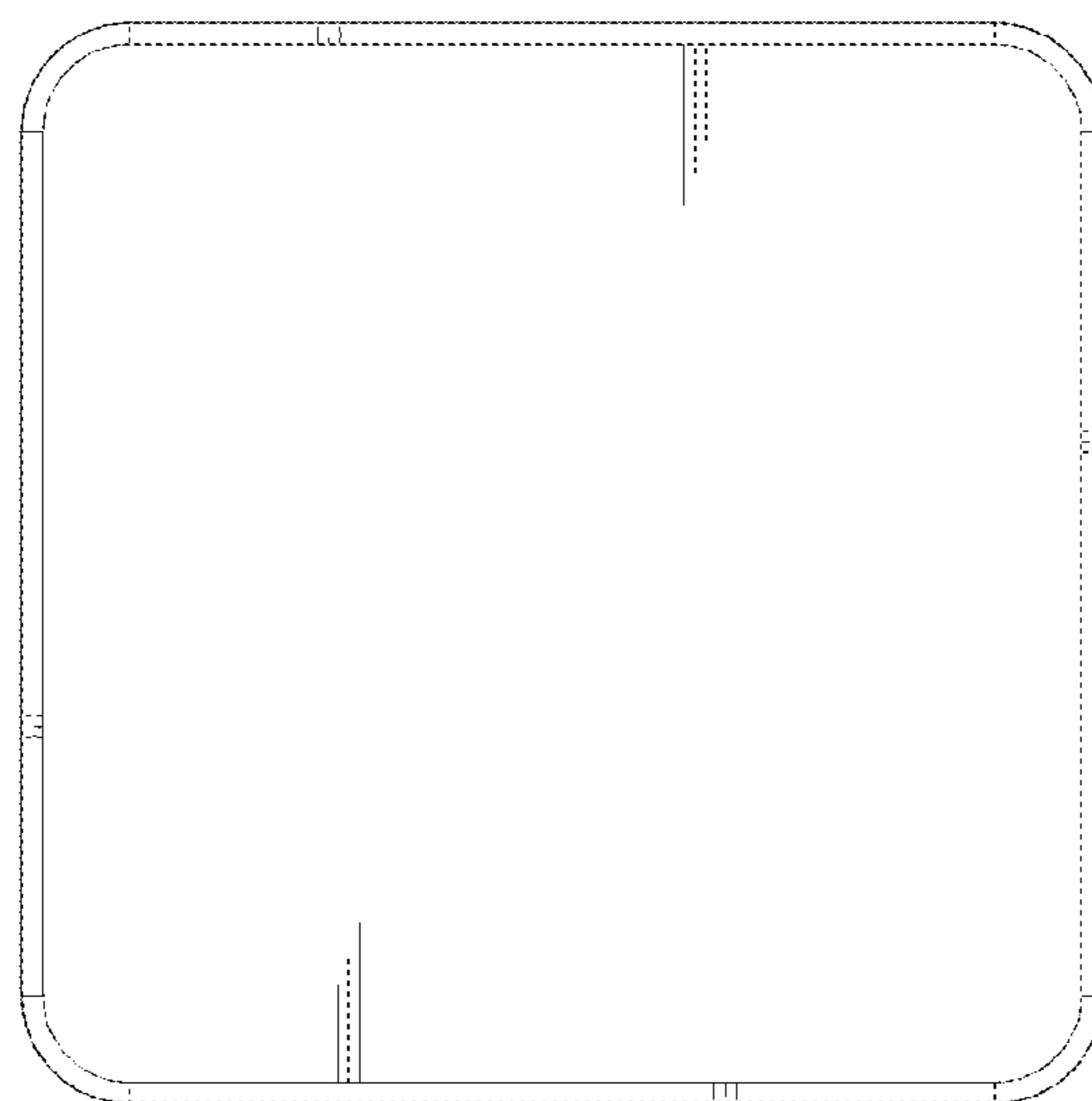
