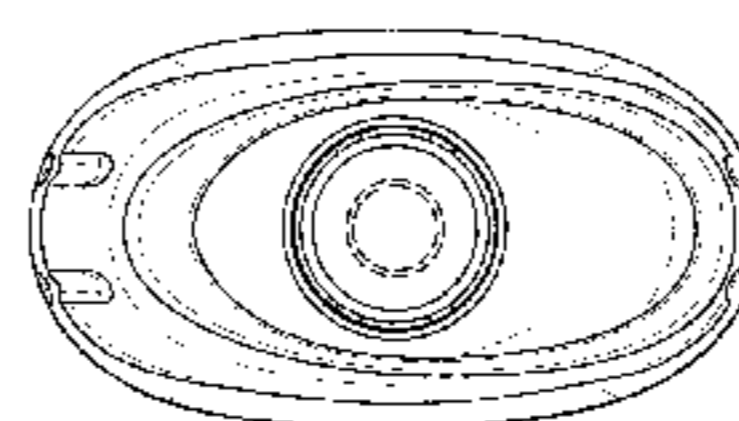
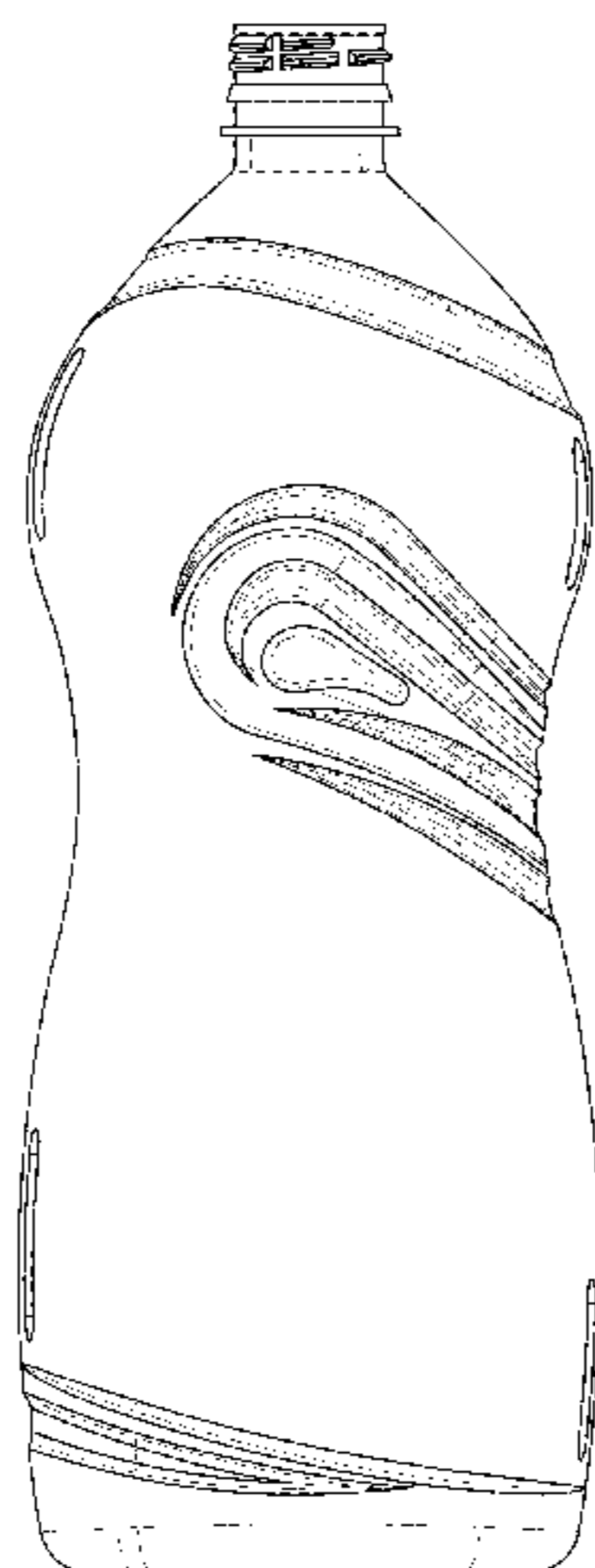
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a container; FIG. 2 is a front elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The evenly-dashed broken lines are included for the purpose of illustrating portions of the container that form no part of the claimed design. The dot-dash broken lines define the bounds of the claim and form no portion thereof.

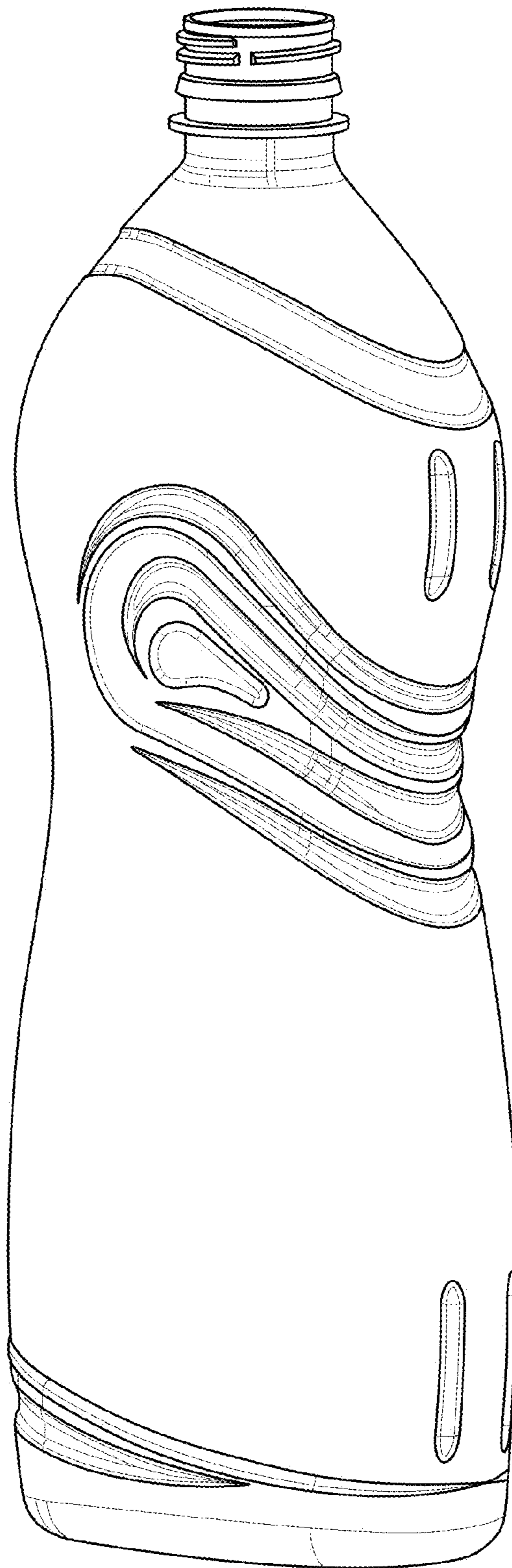

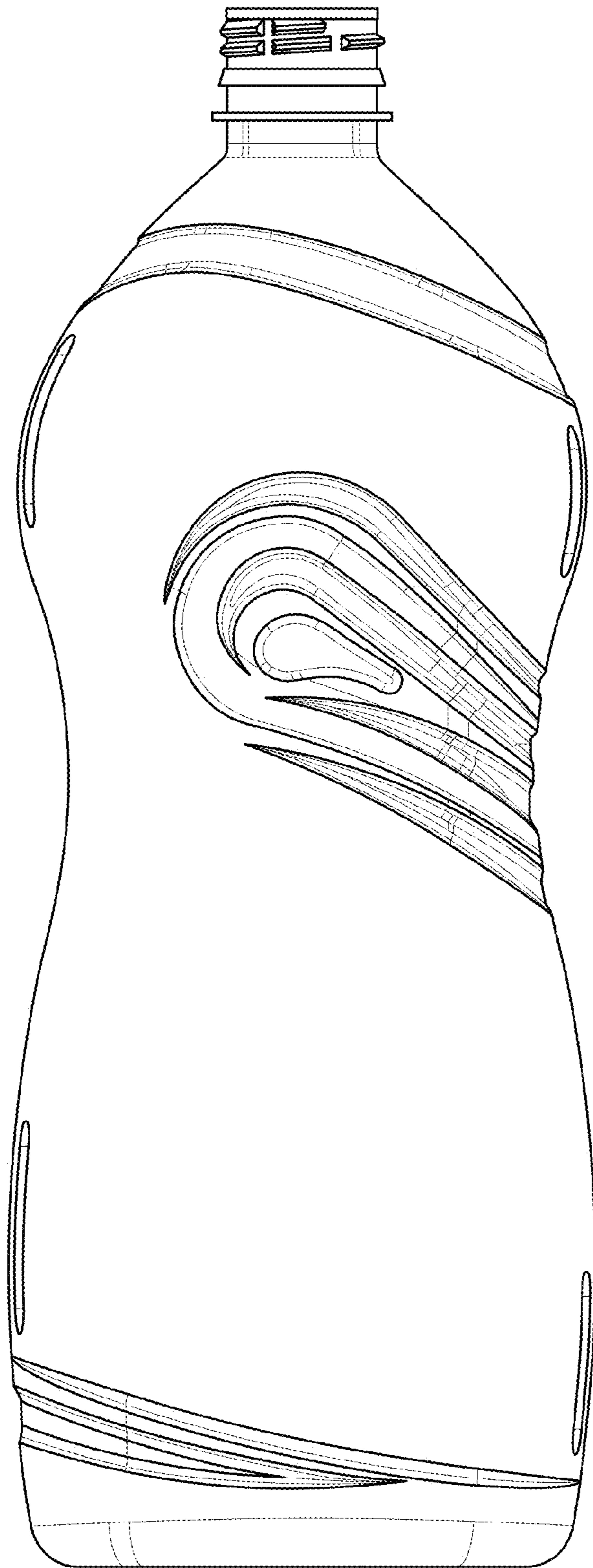

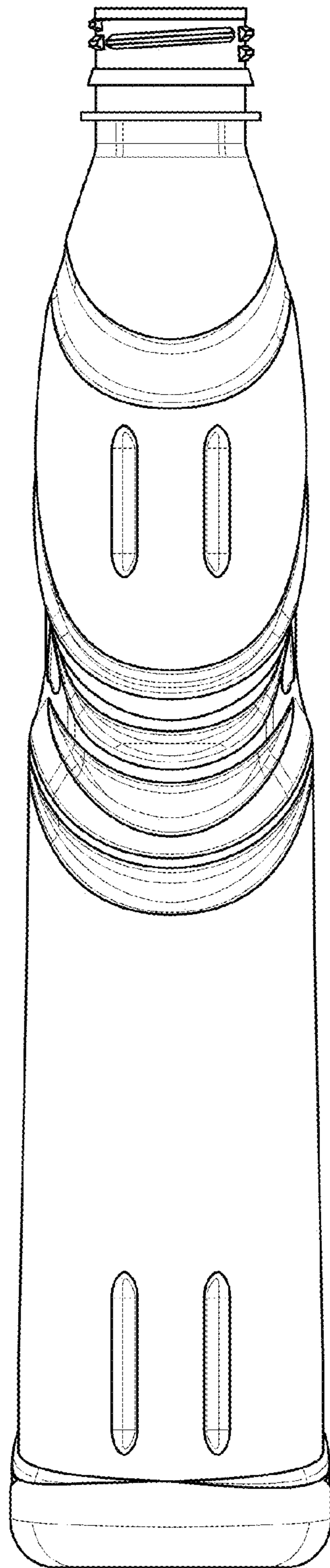

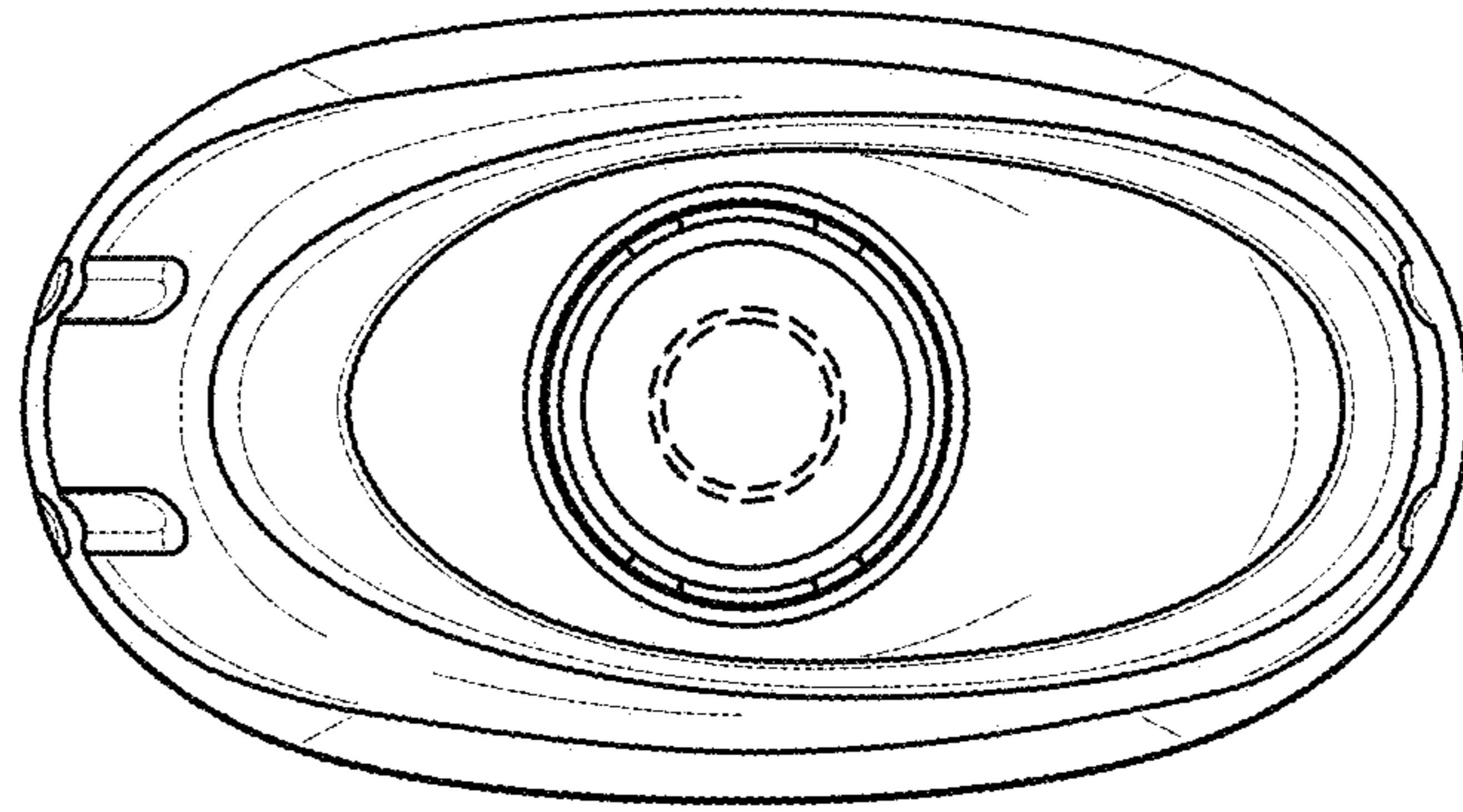

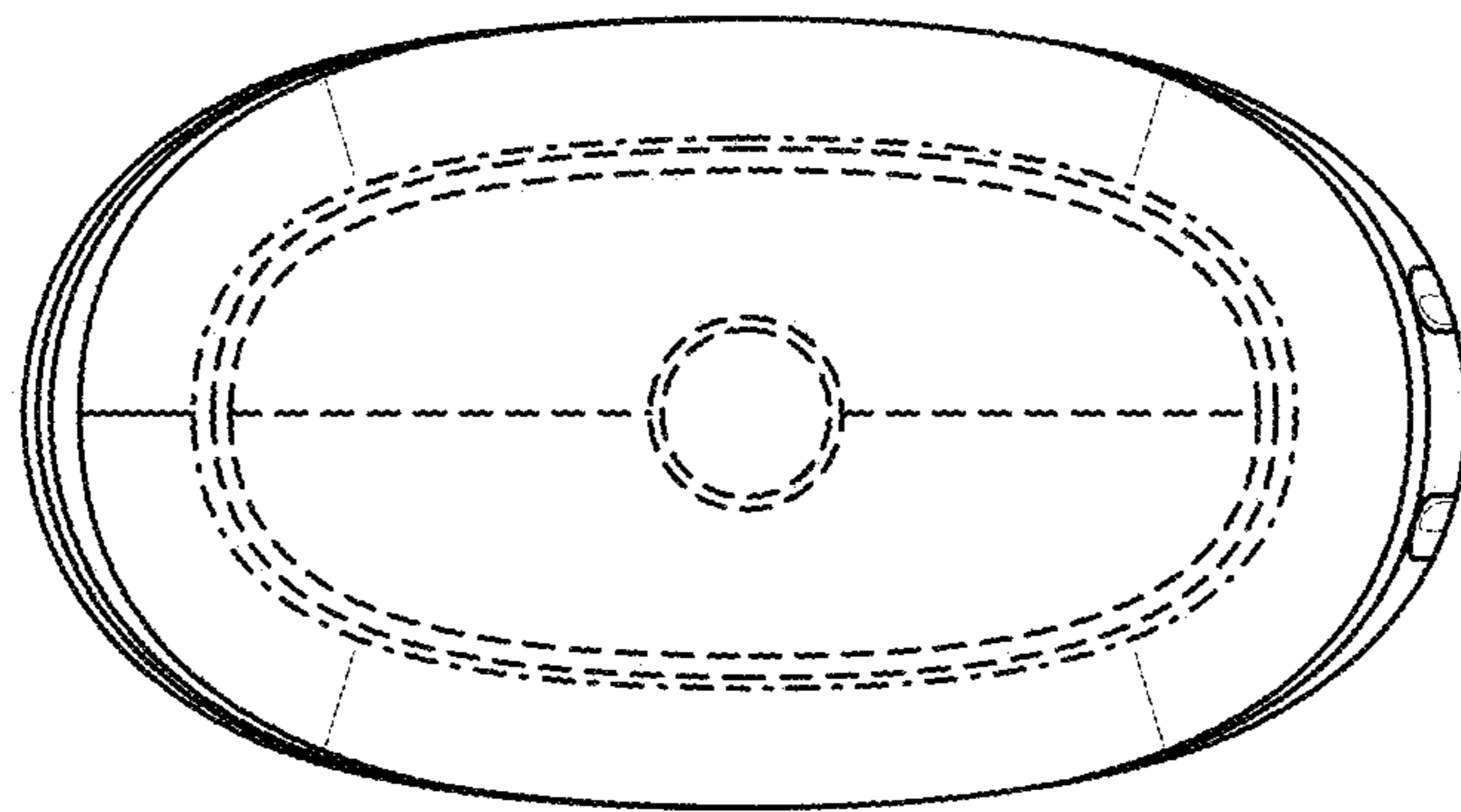
