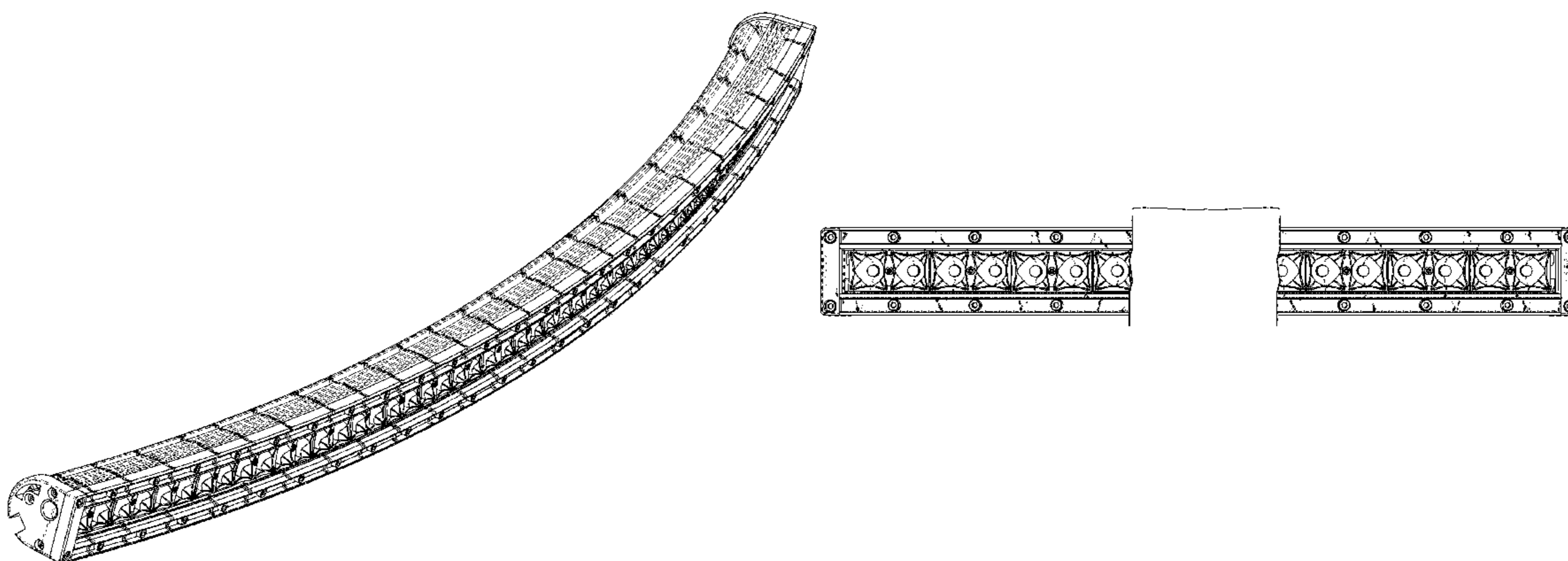
(57) **CLAIM**

The ornamental design for a curved light bar, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the curved light bar in accordance with the present design.

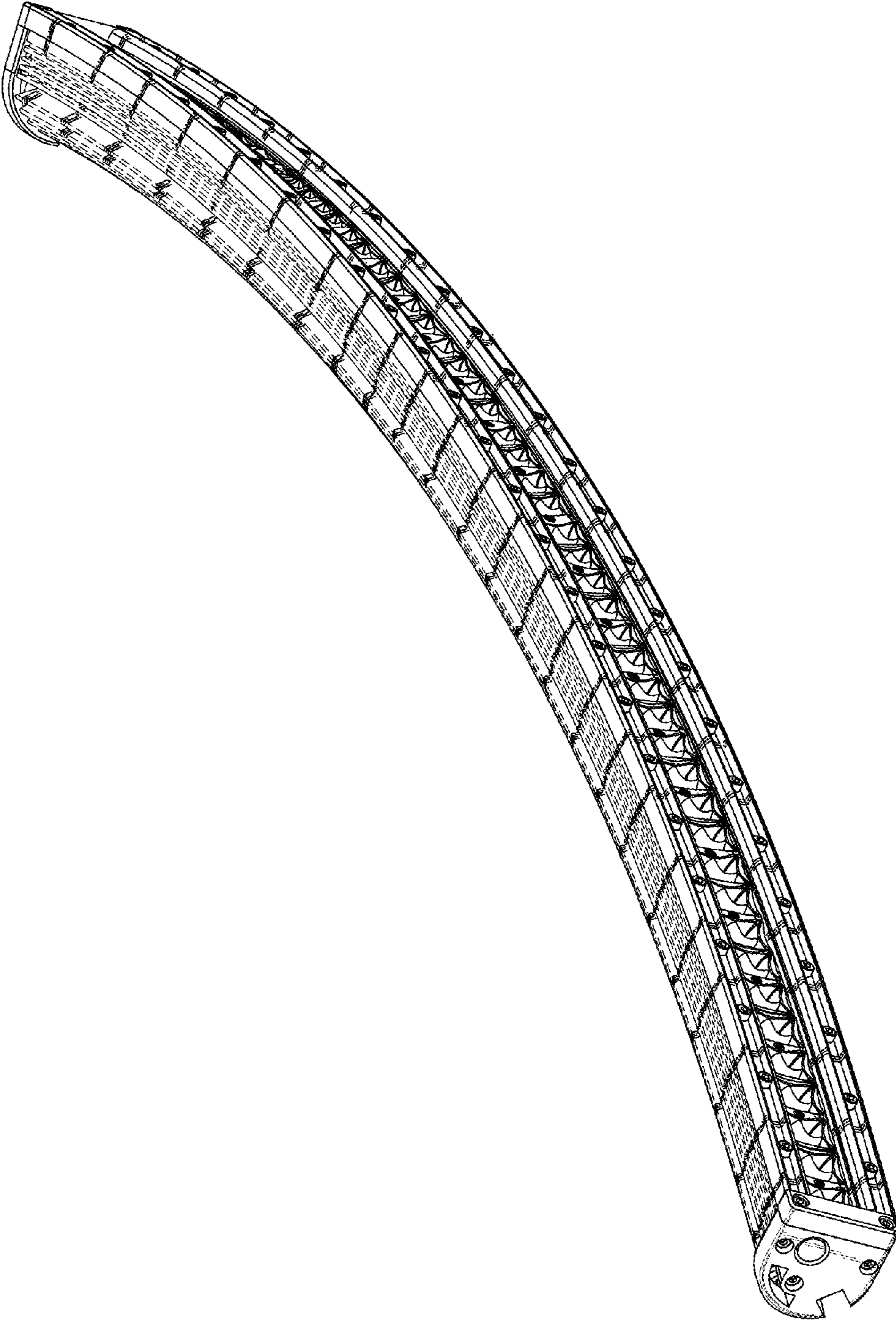

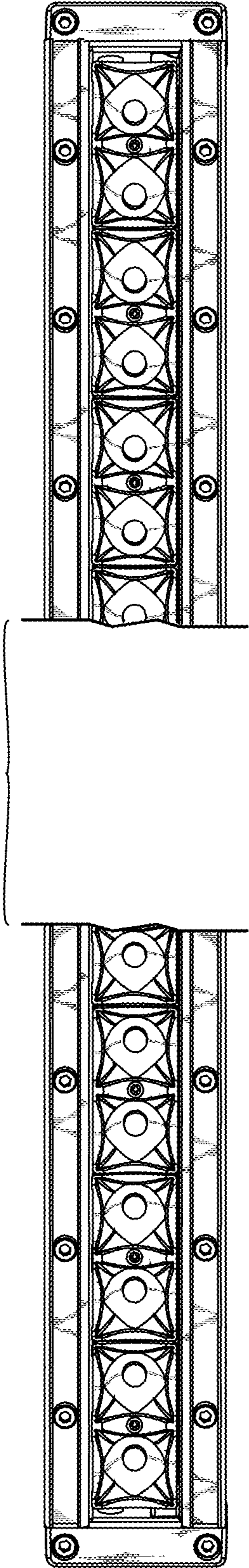

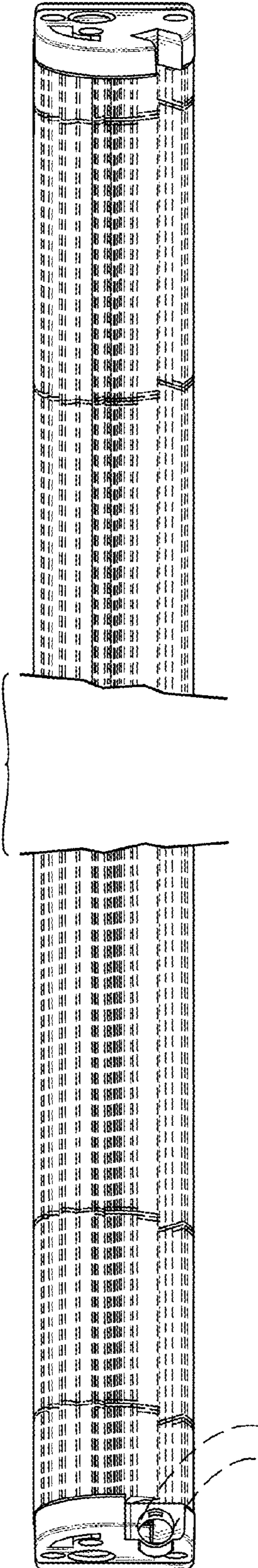

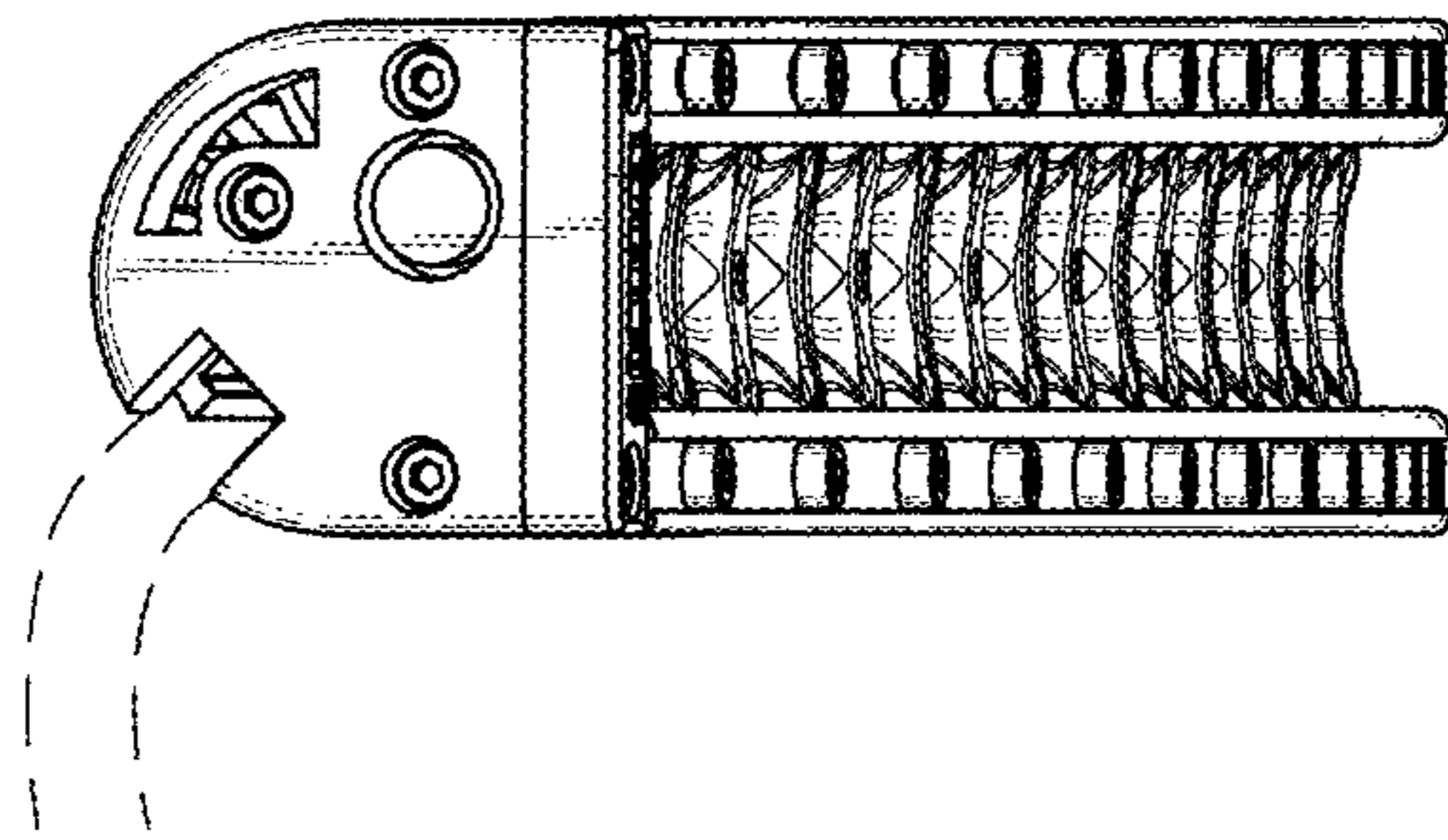

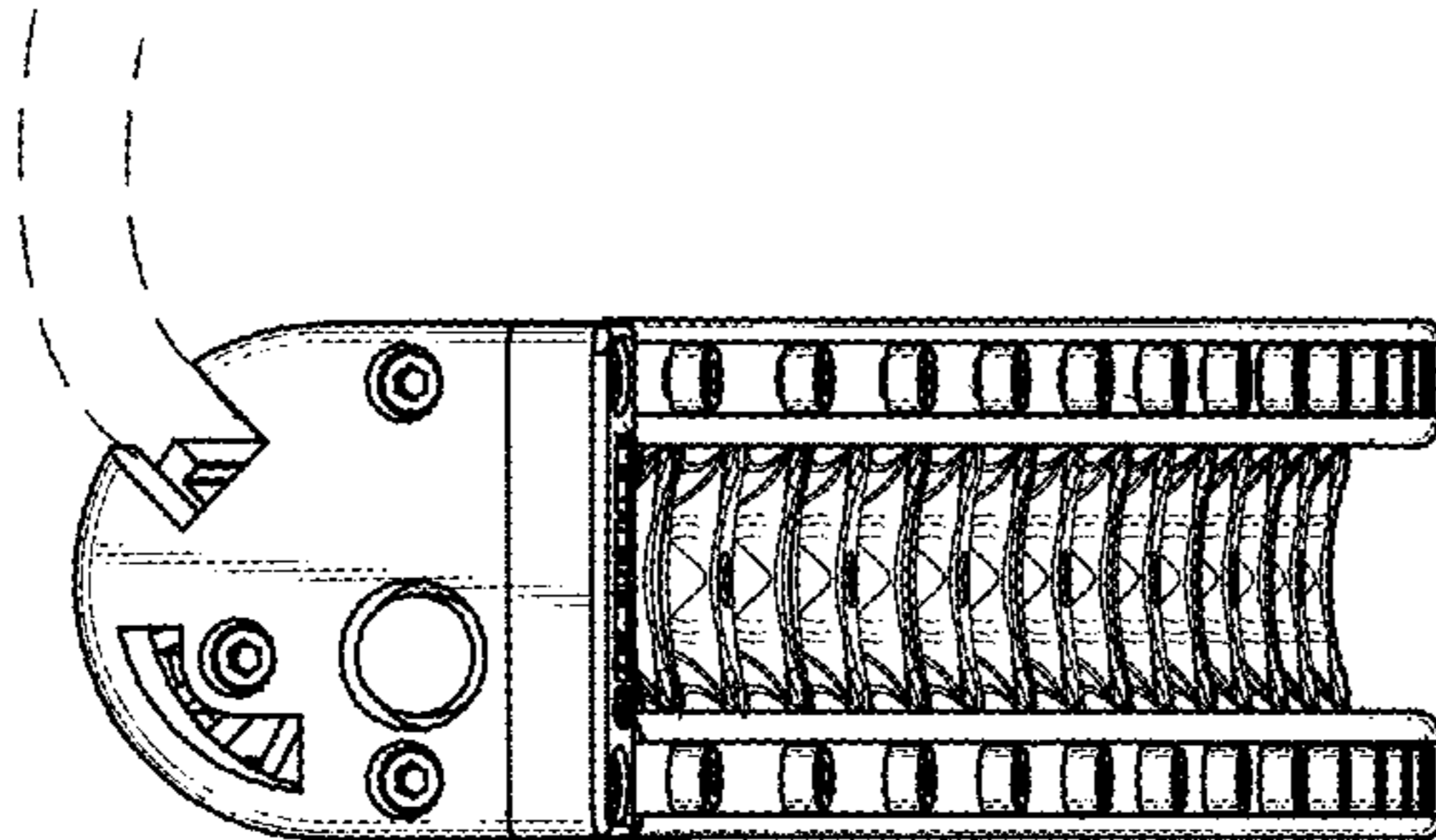

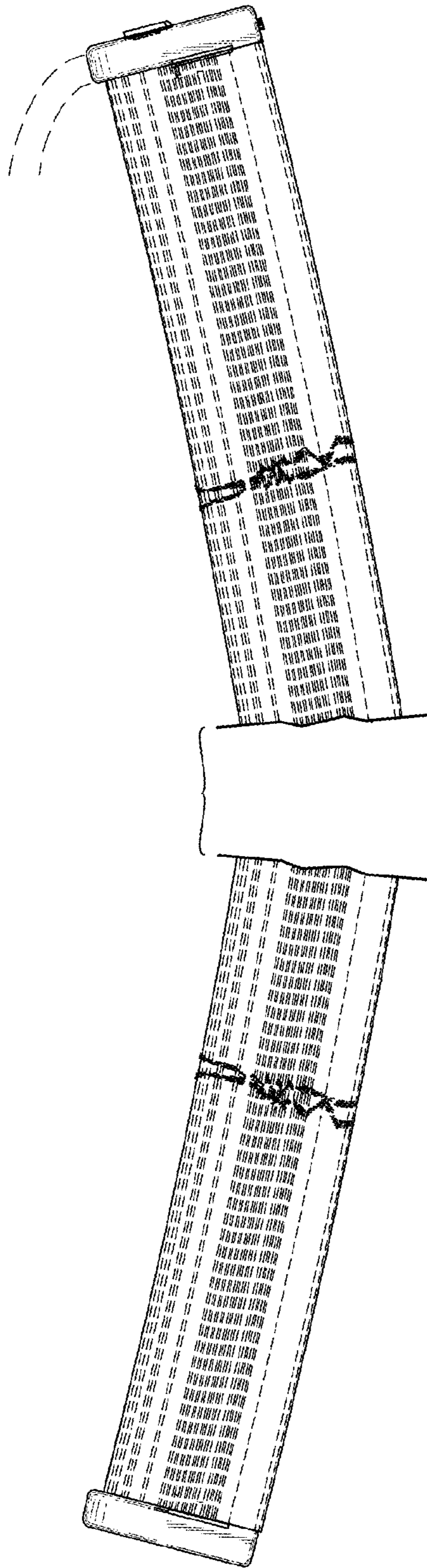

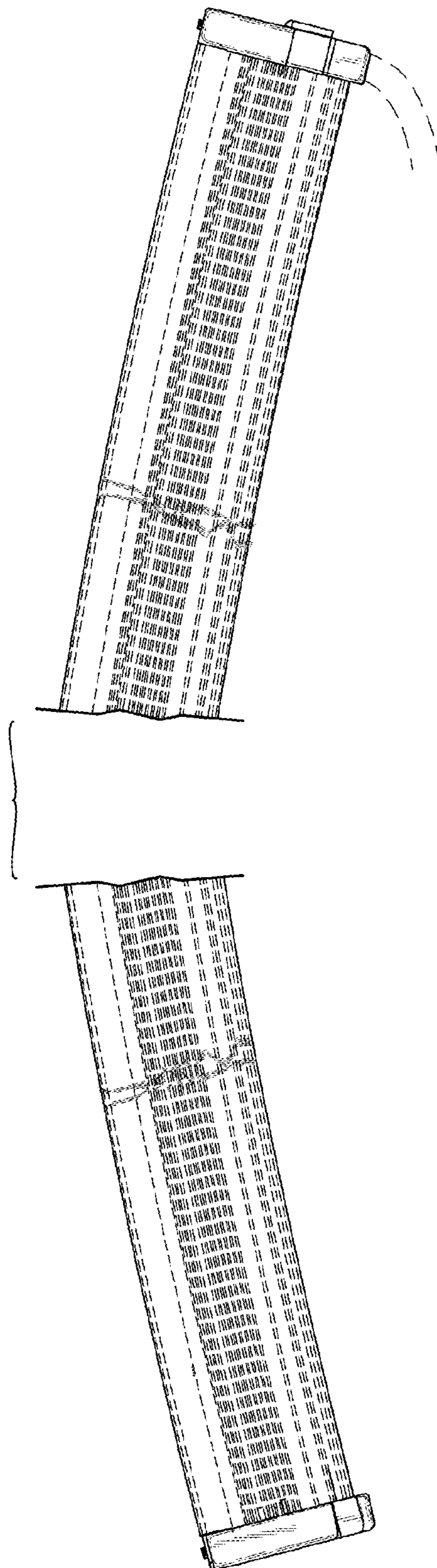
