FIG. 29 is a bottom, left, front perspective view thereof;

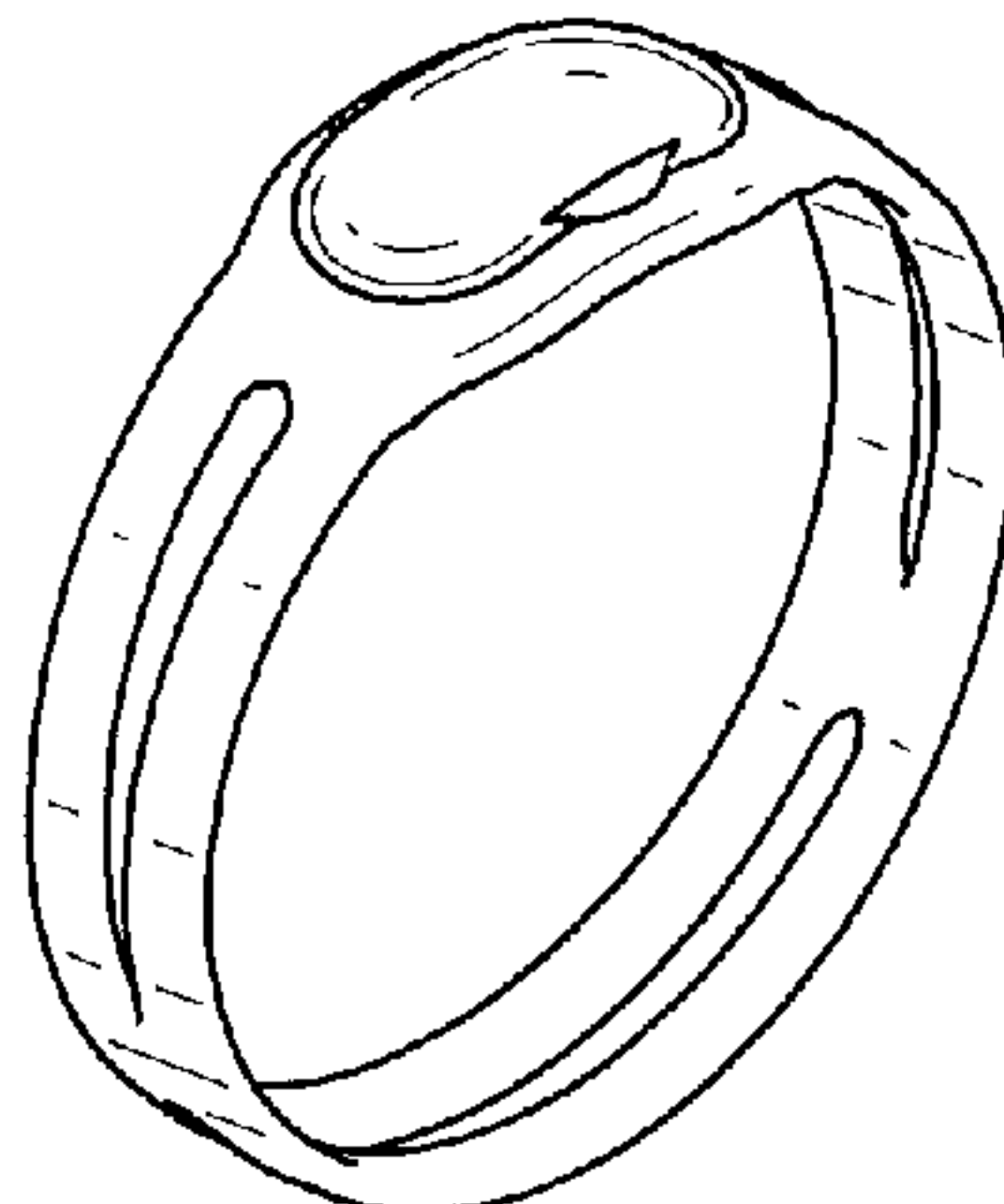


FIG. 30 is a top plan view of the removable container, with the lid in an open position;

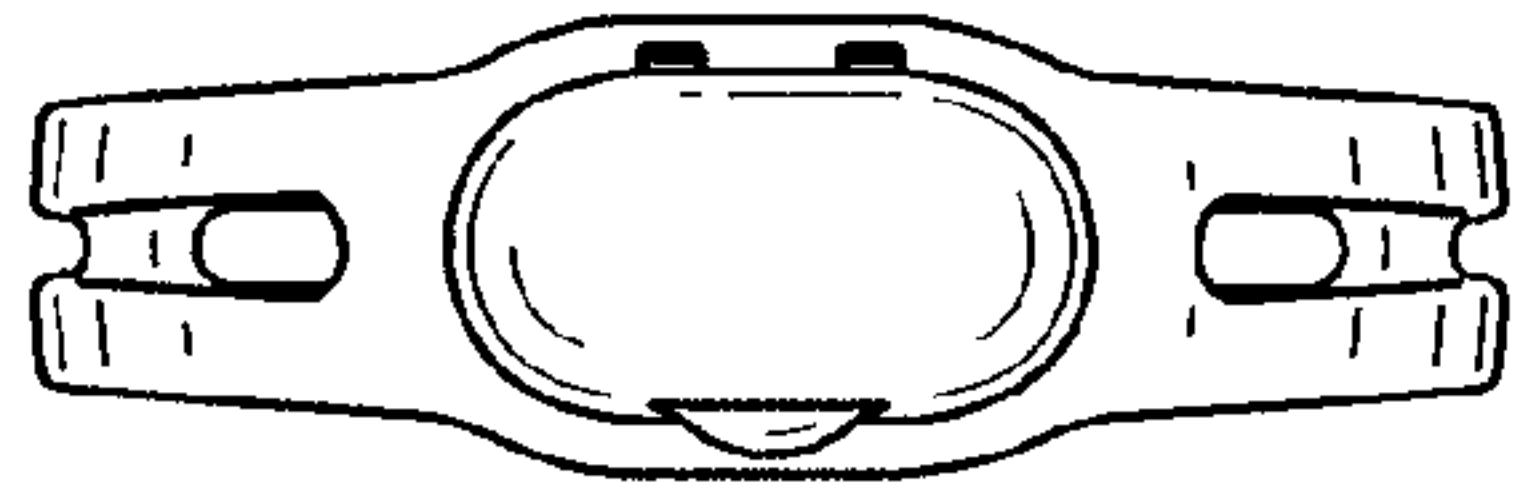

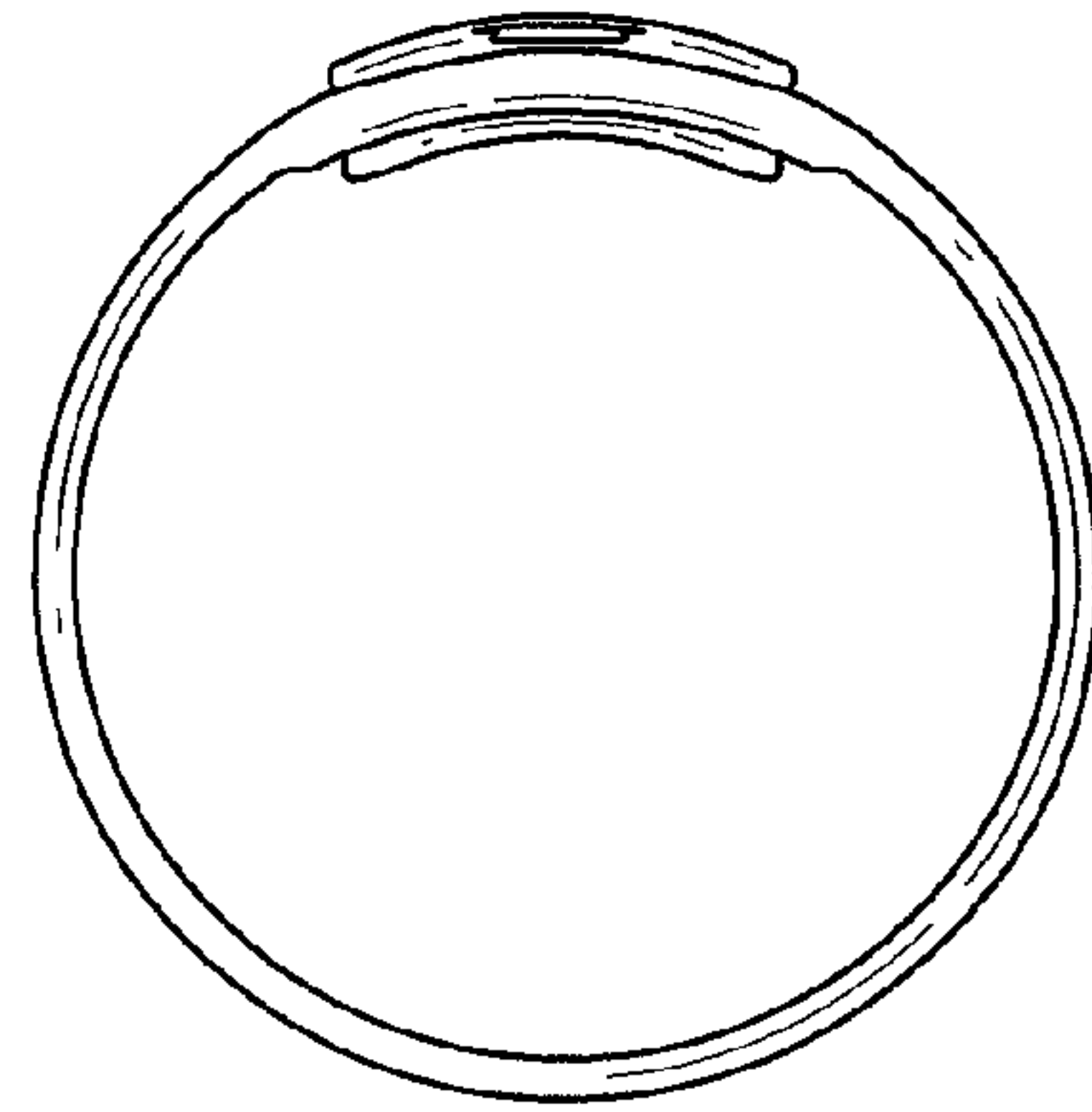

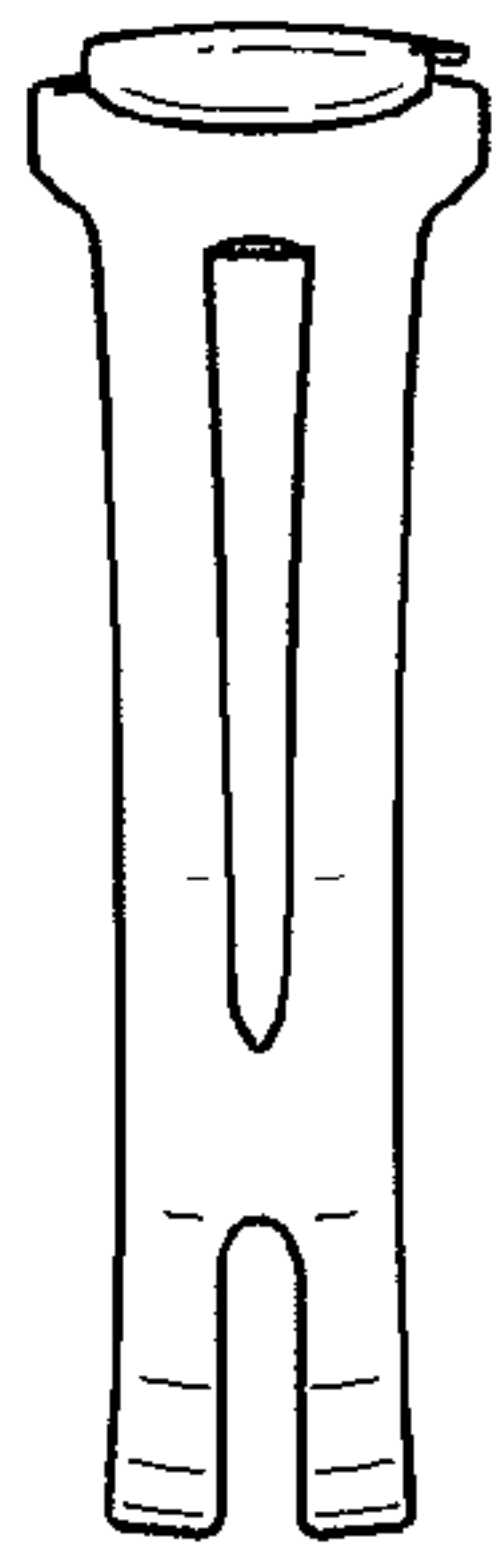

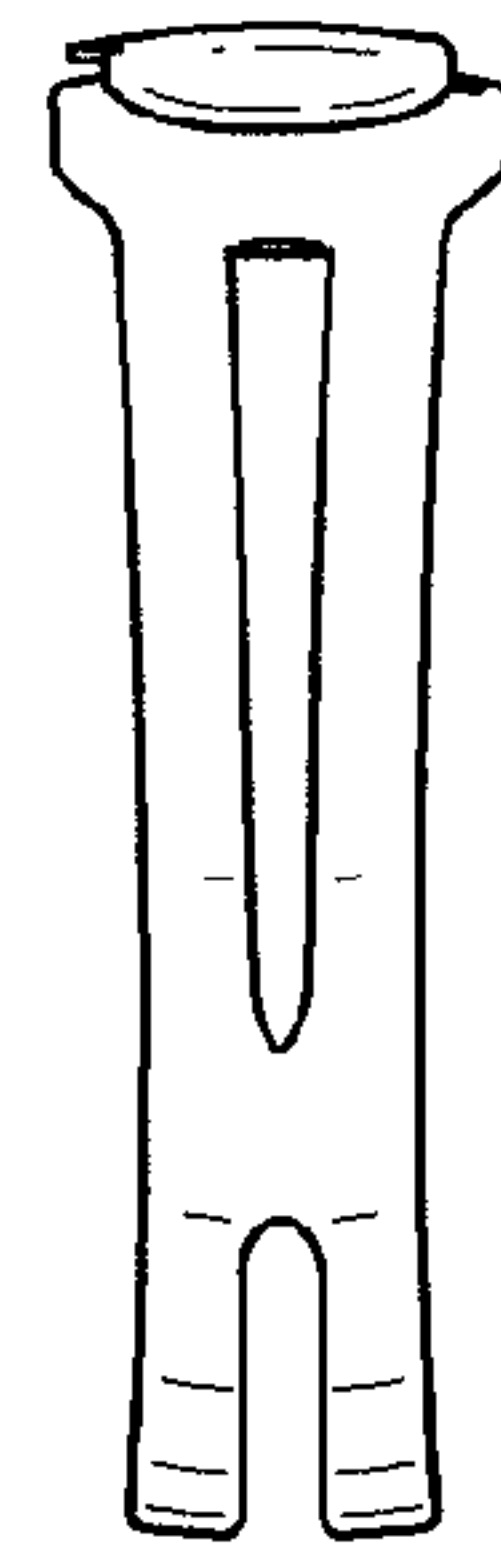

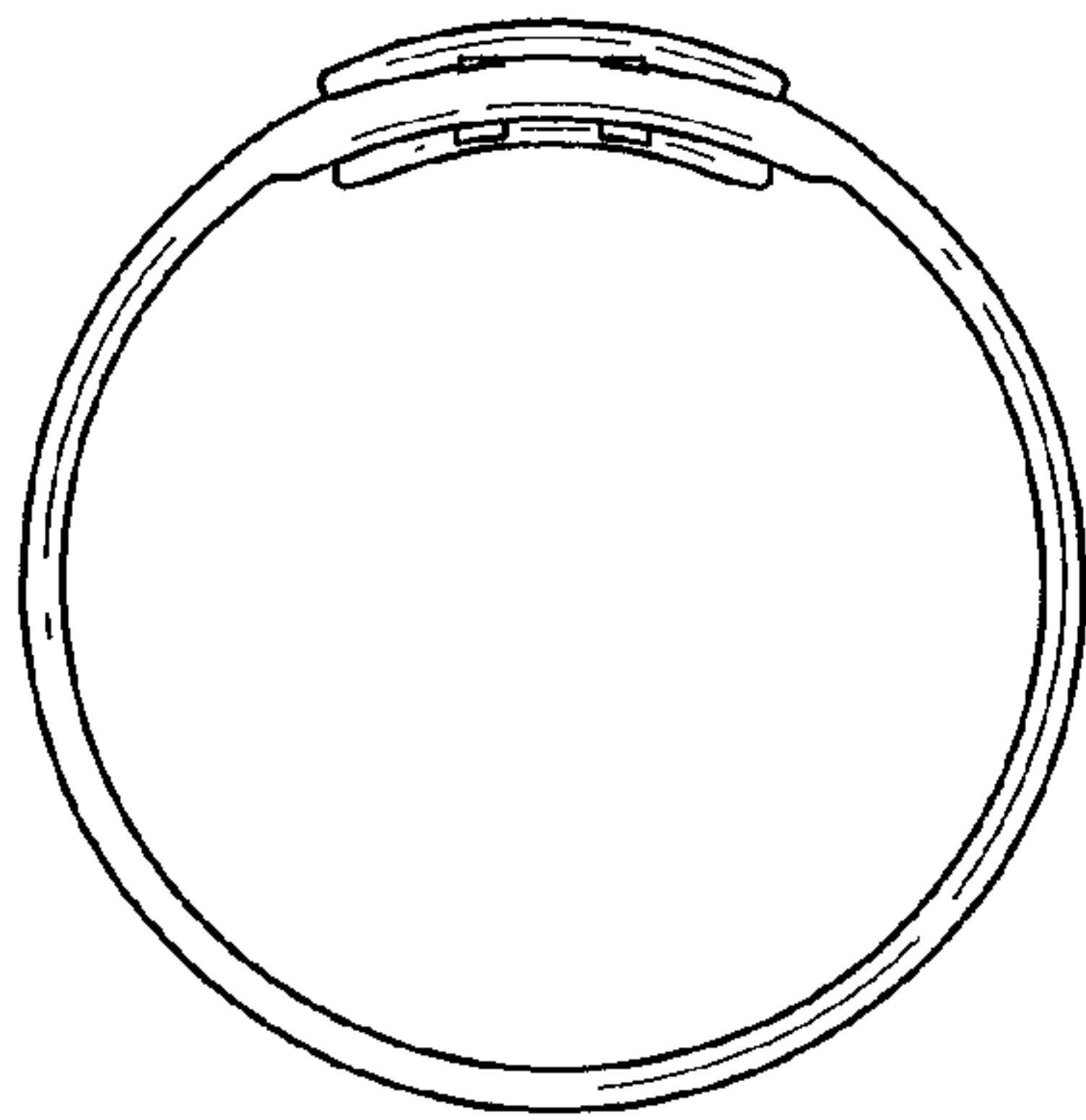

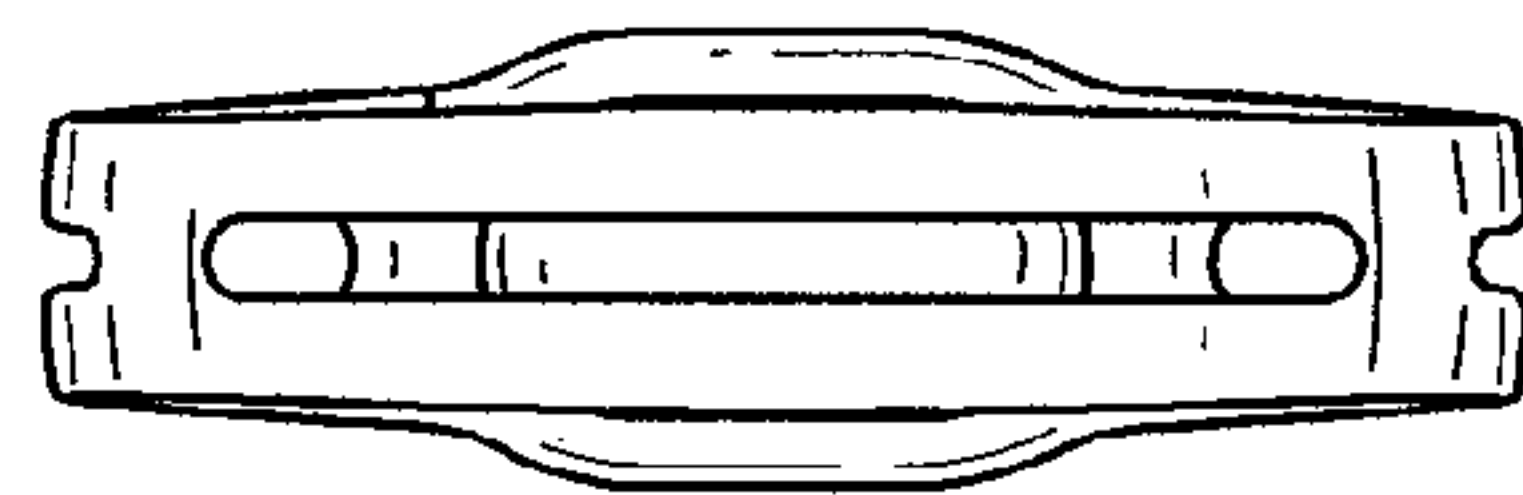

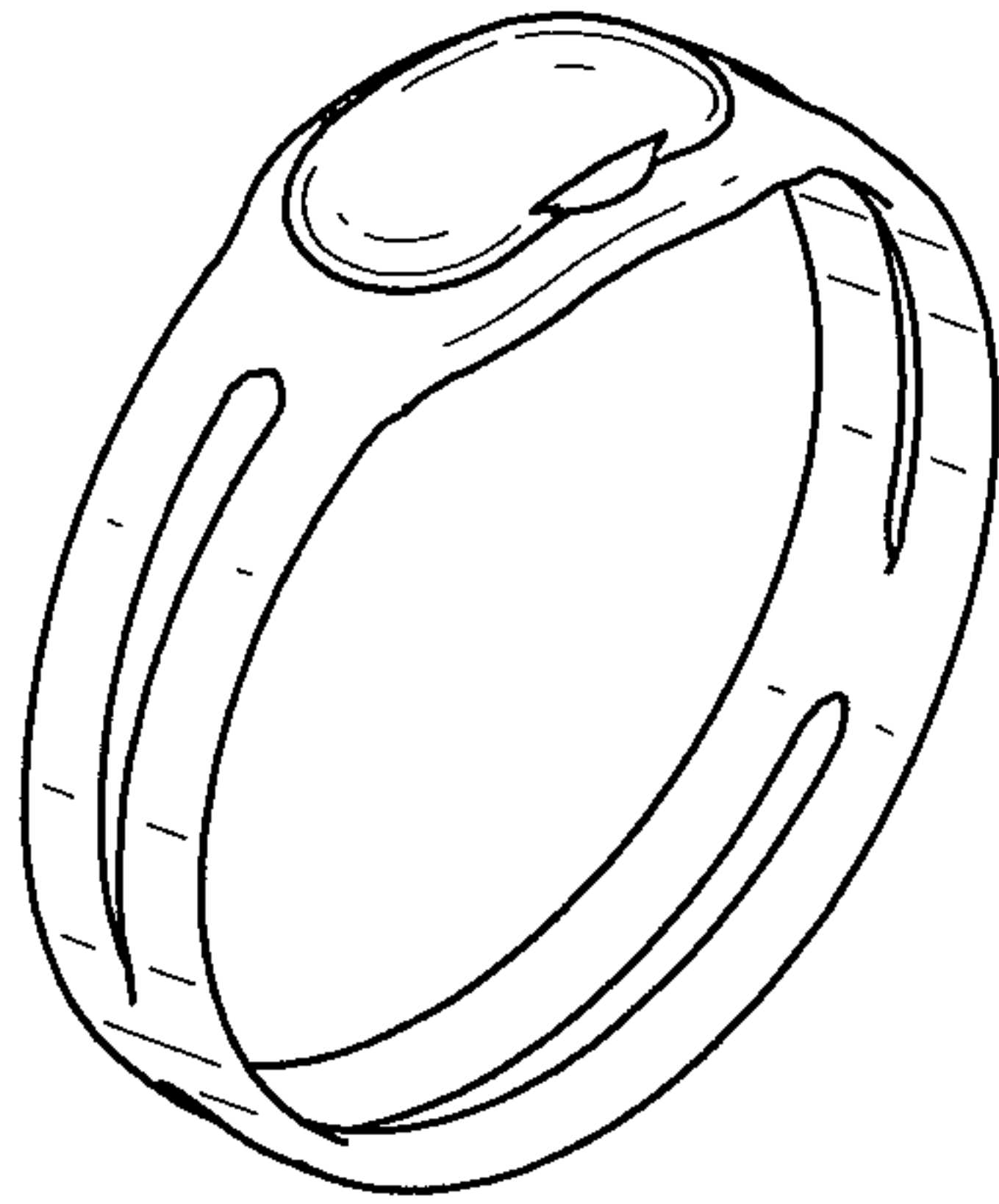

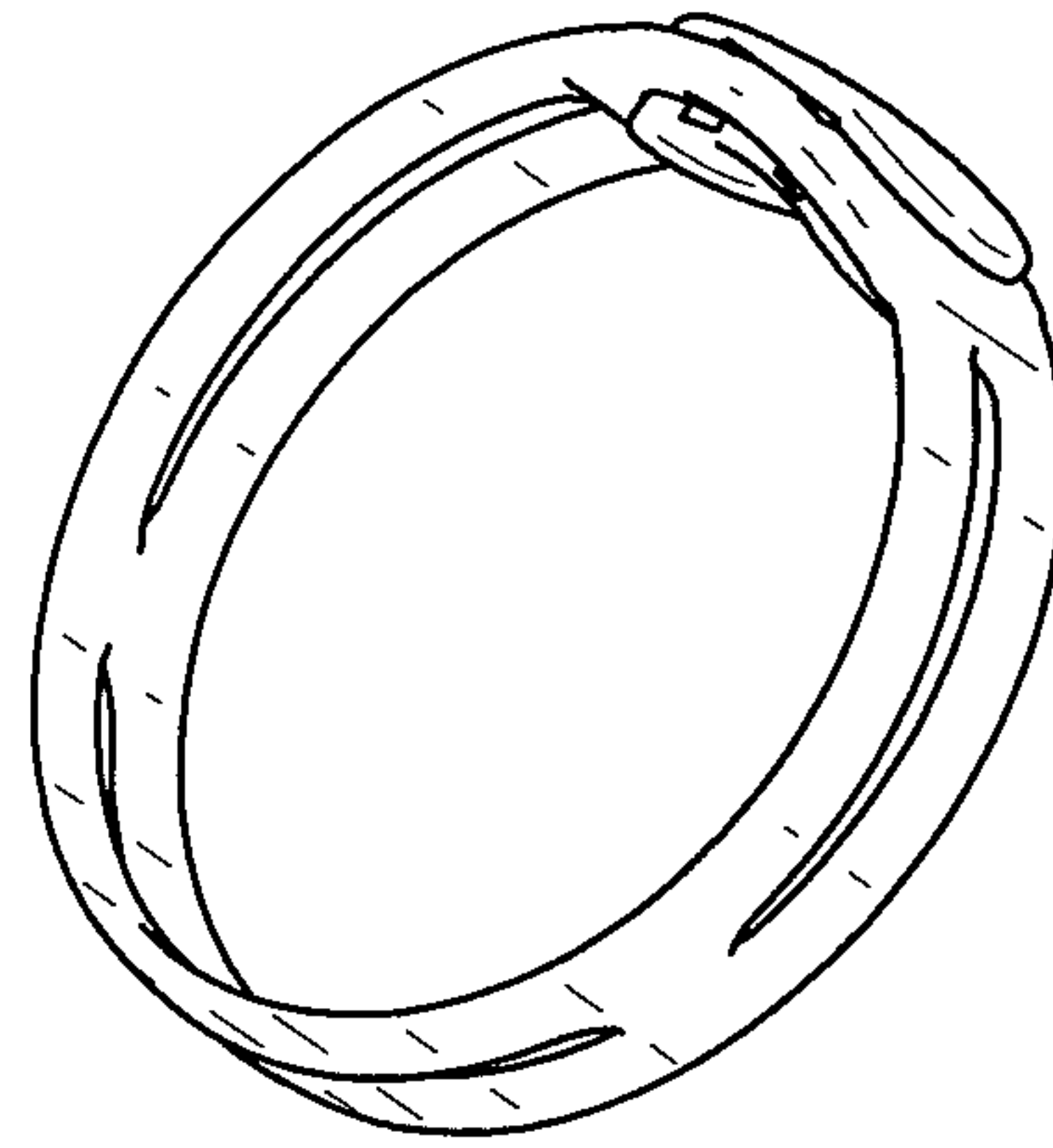

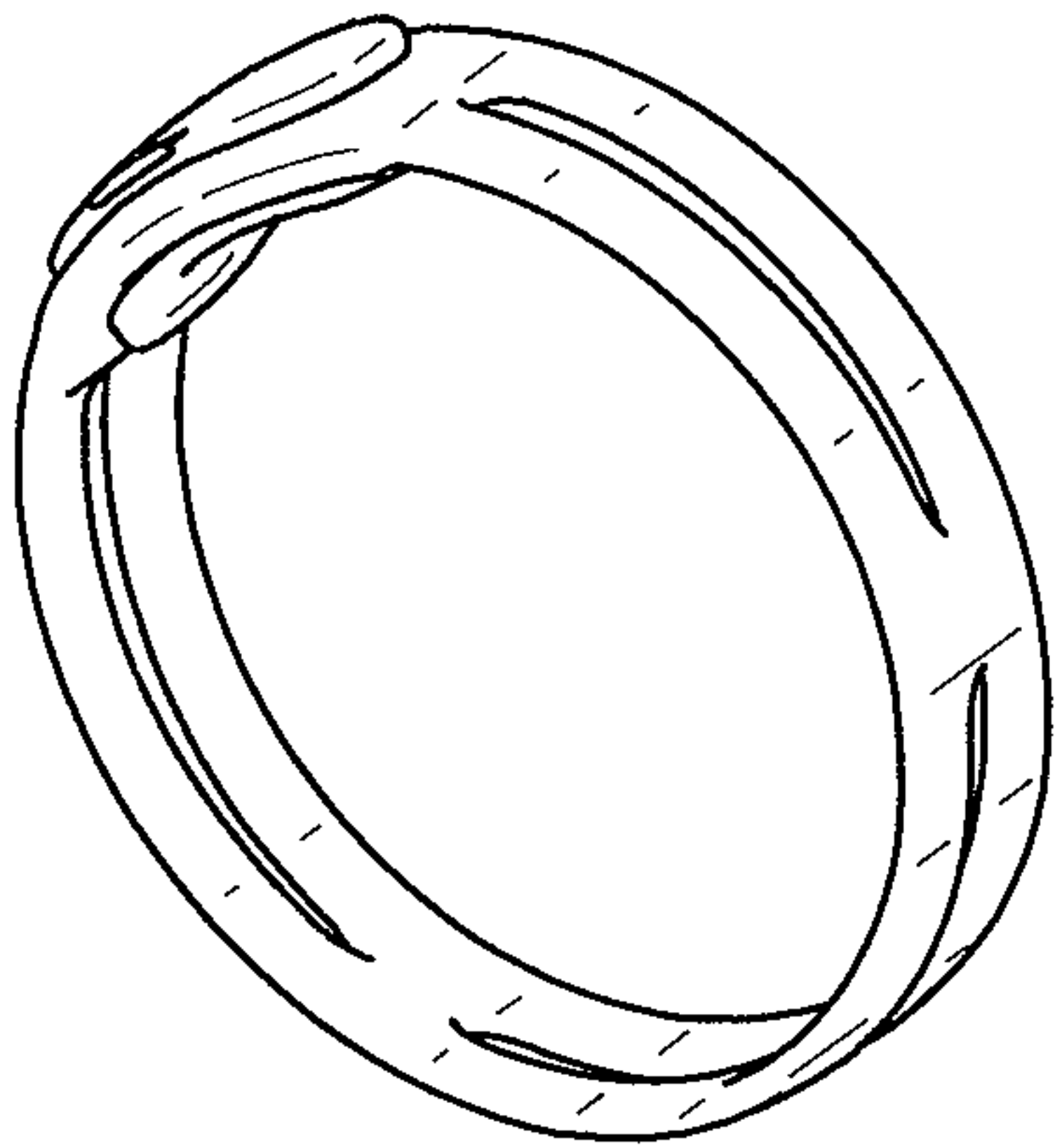

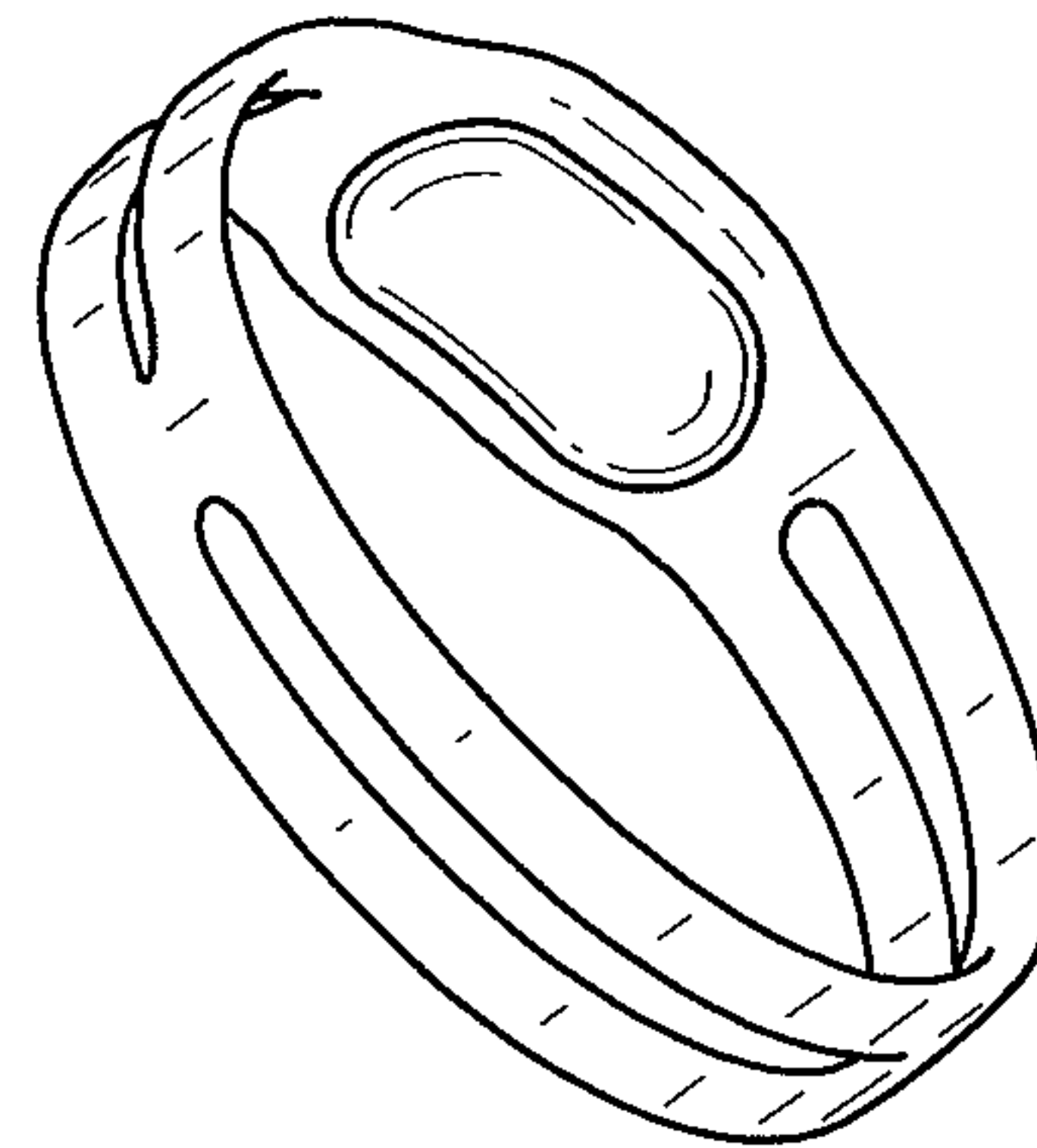

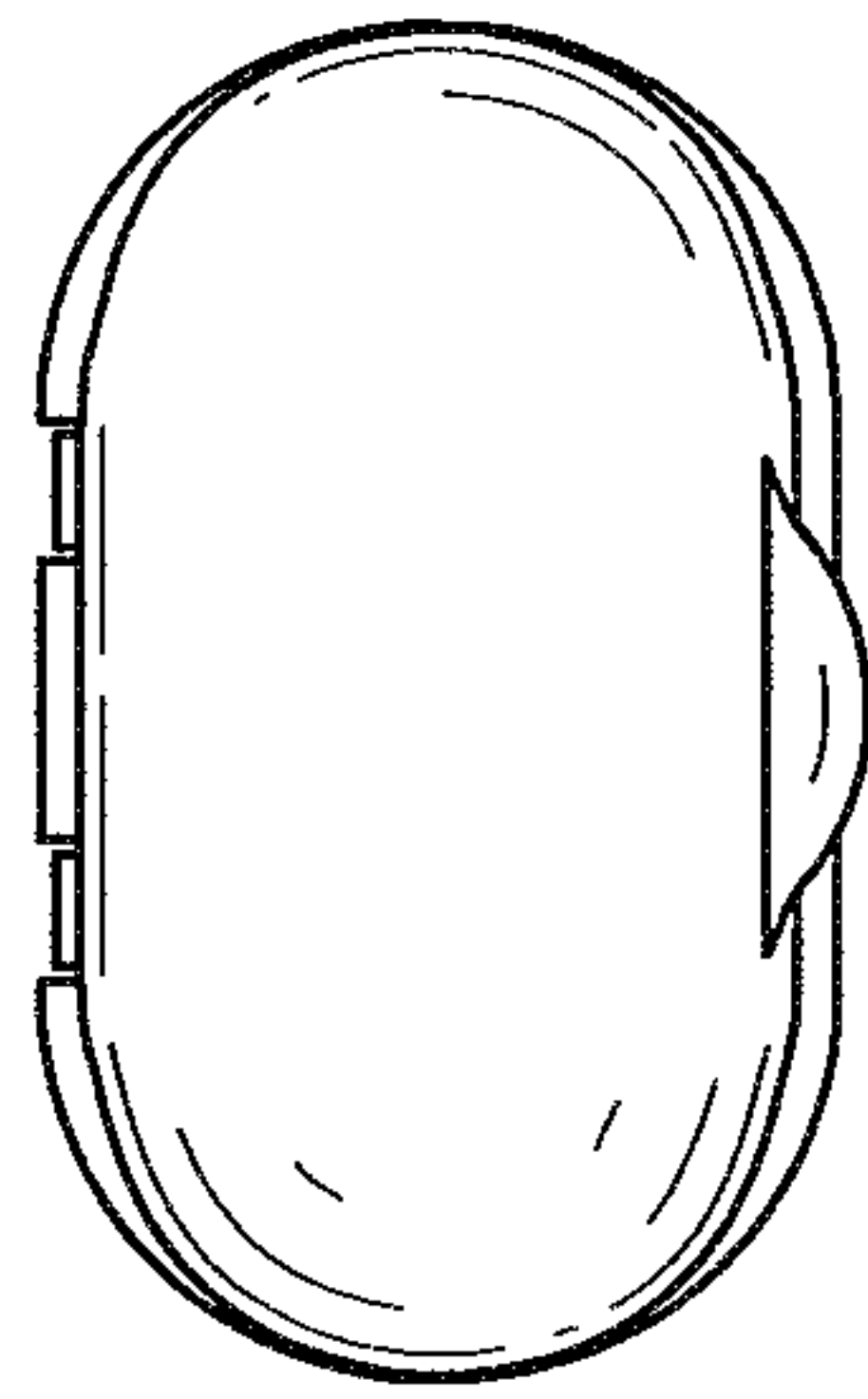

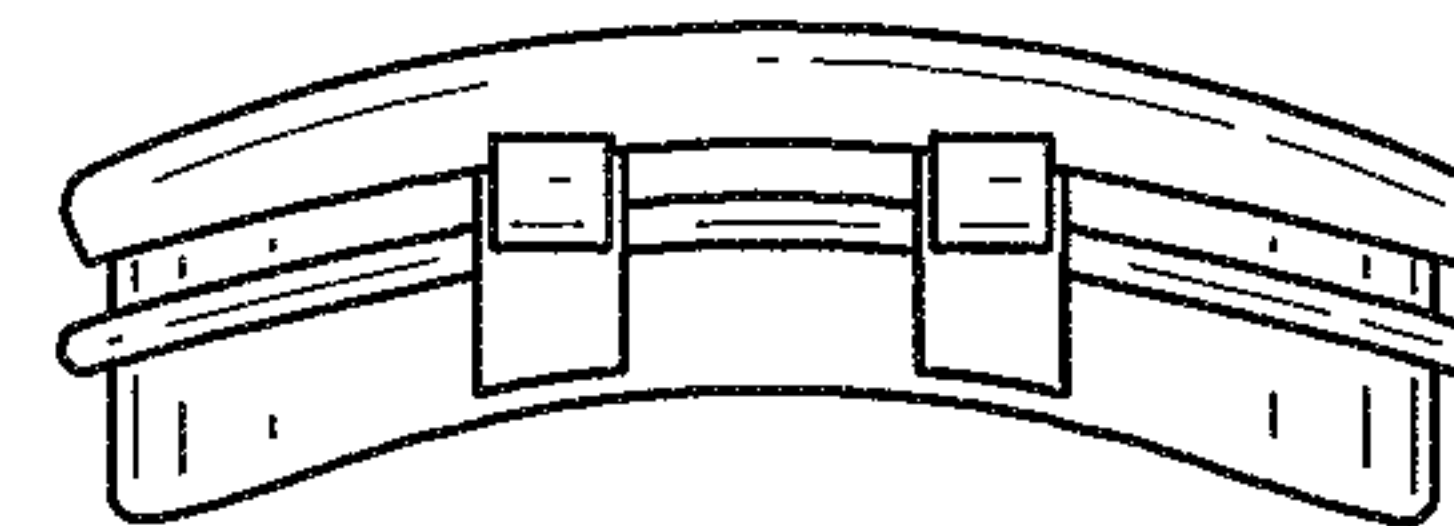

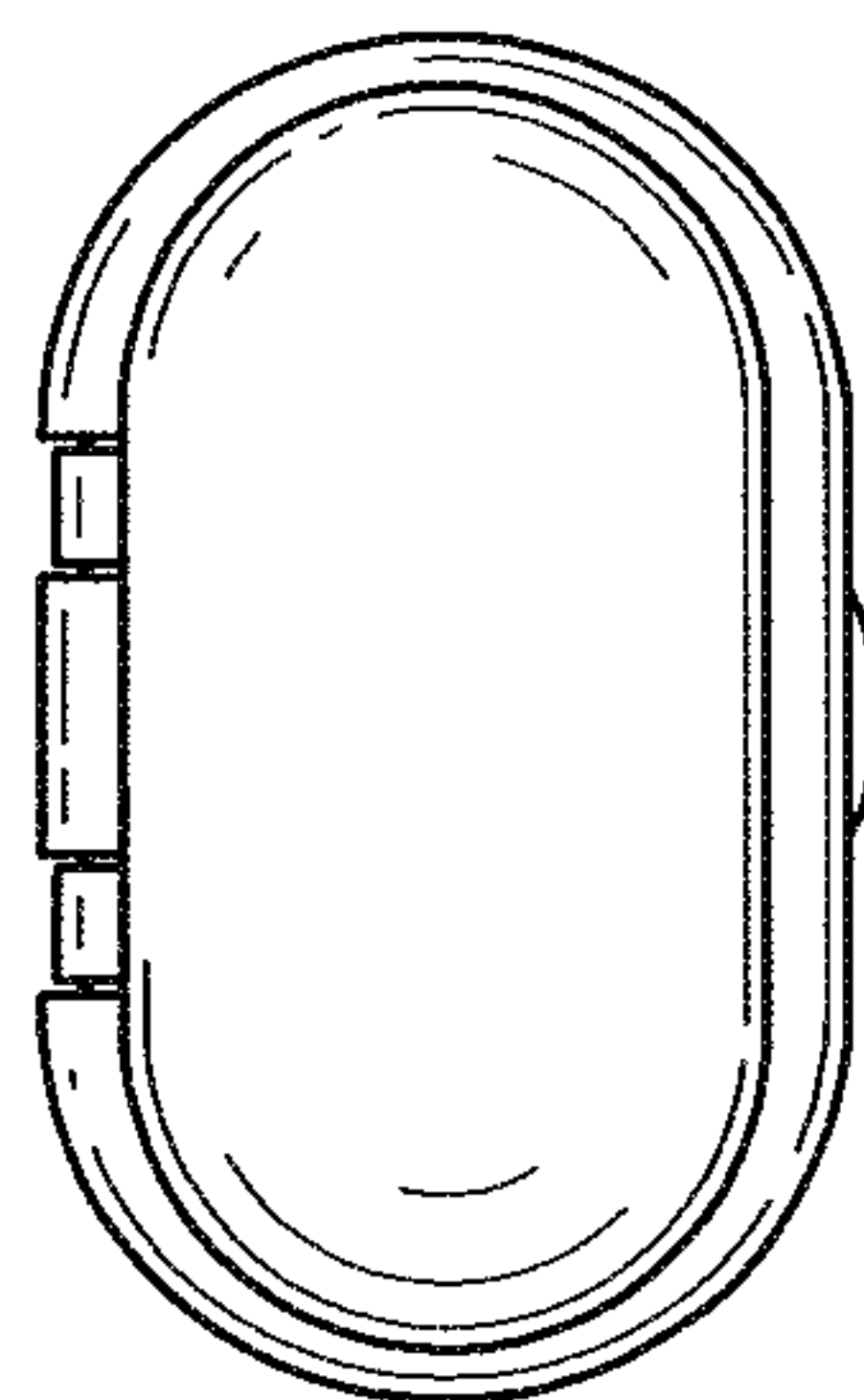

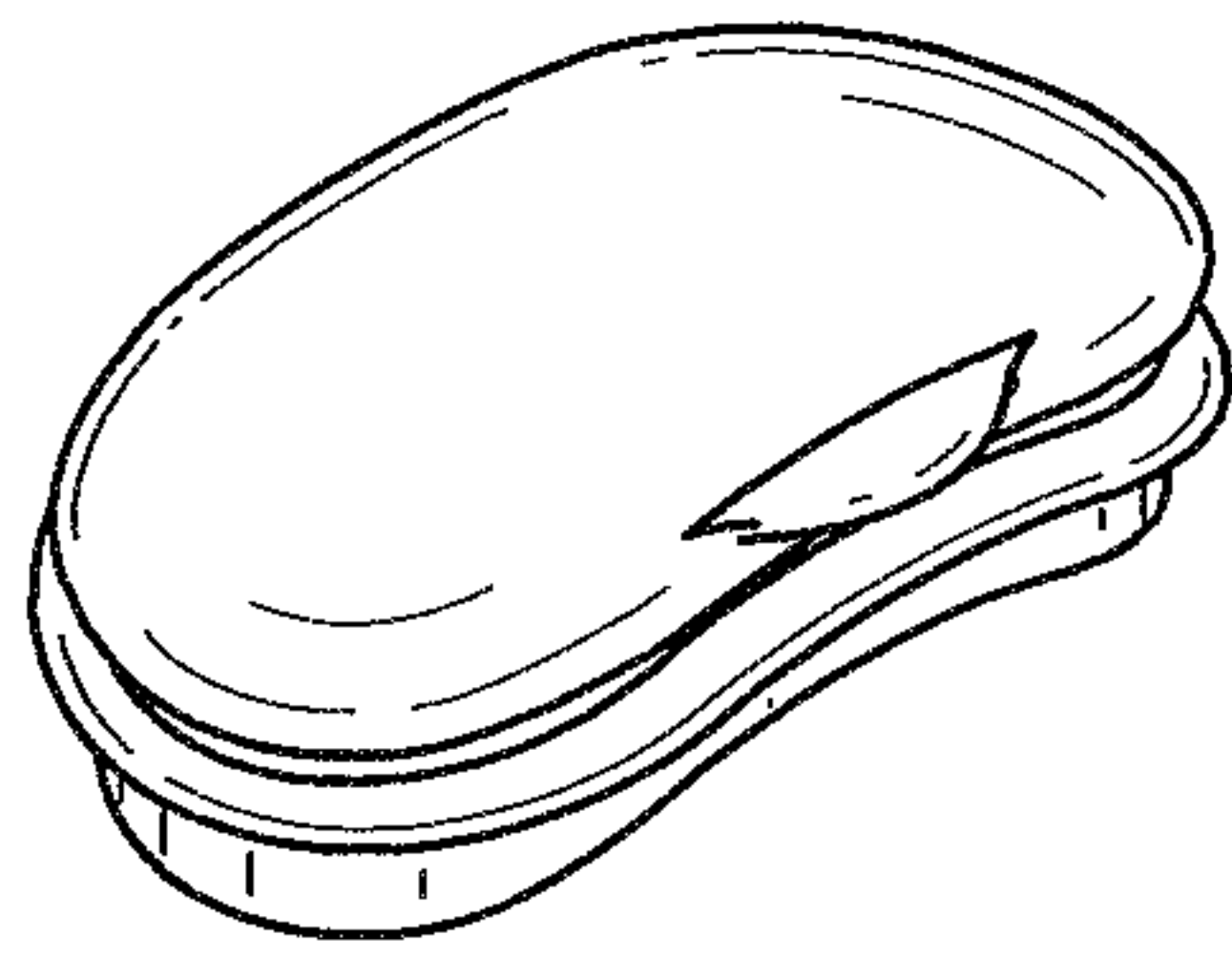

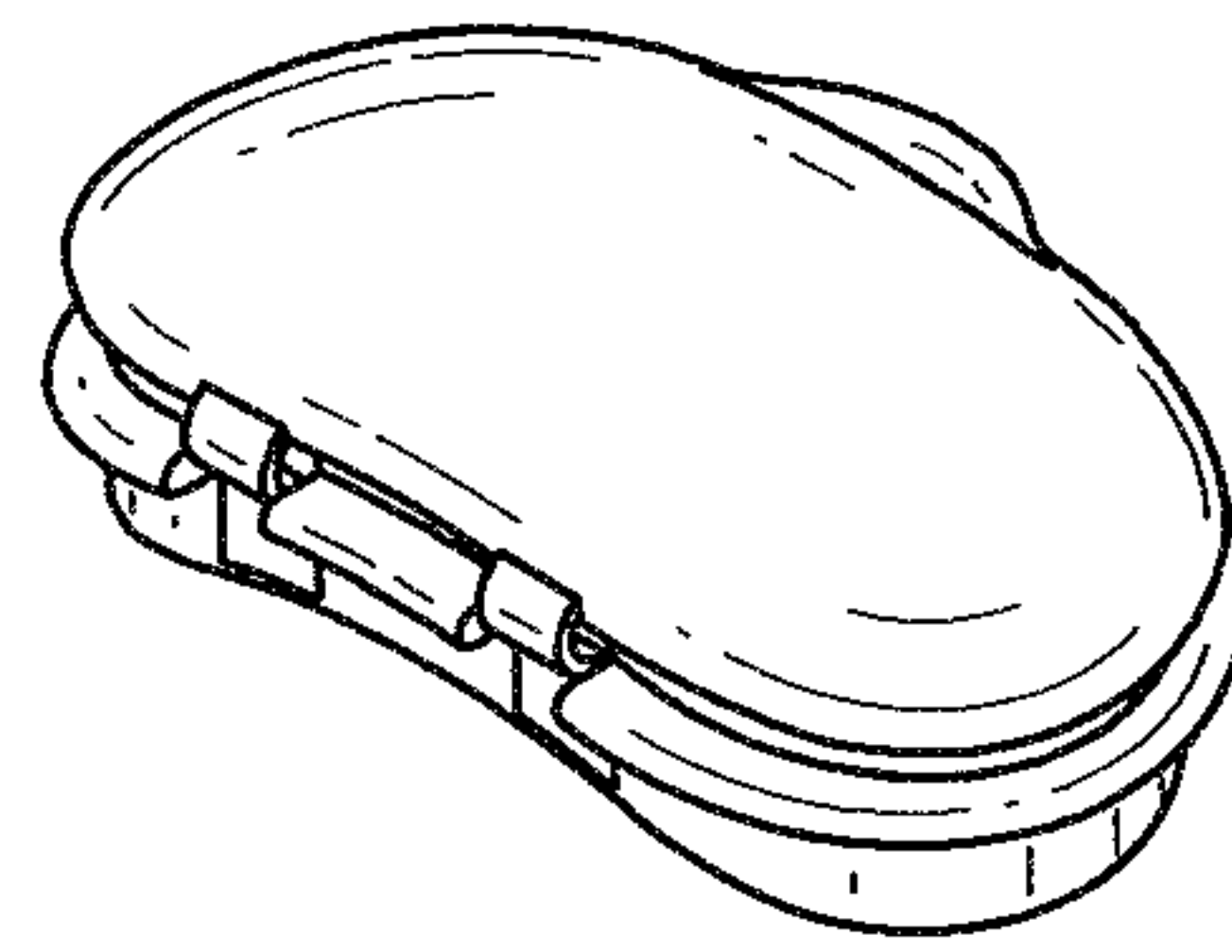

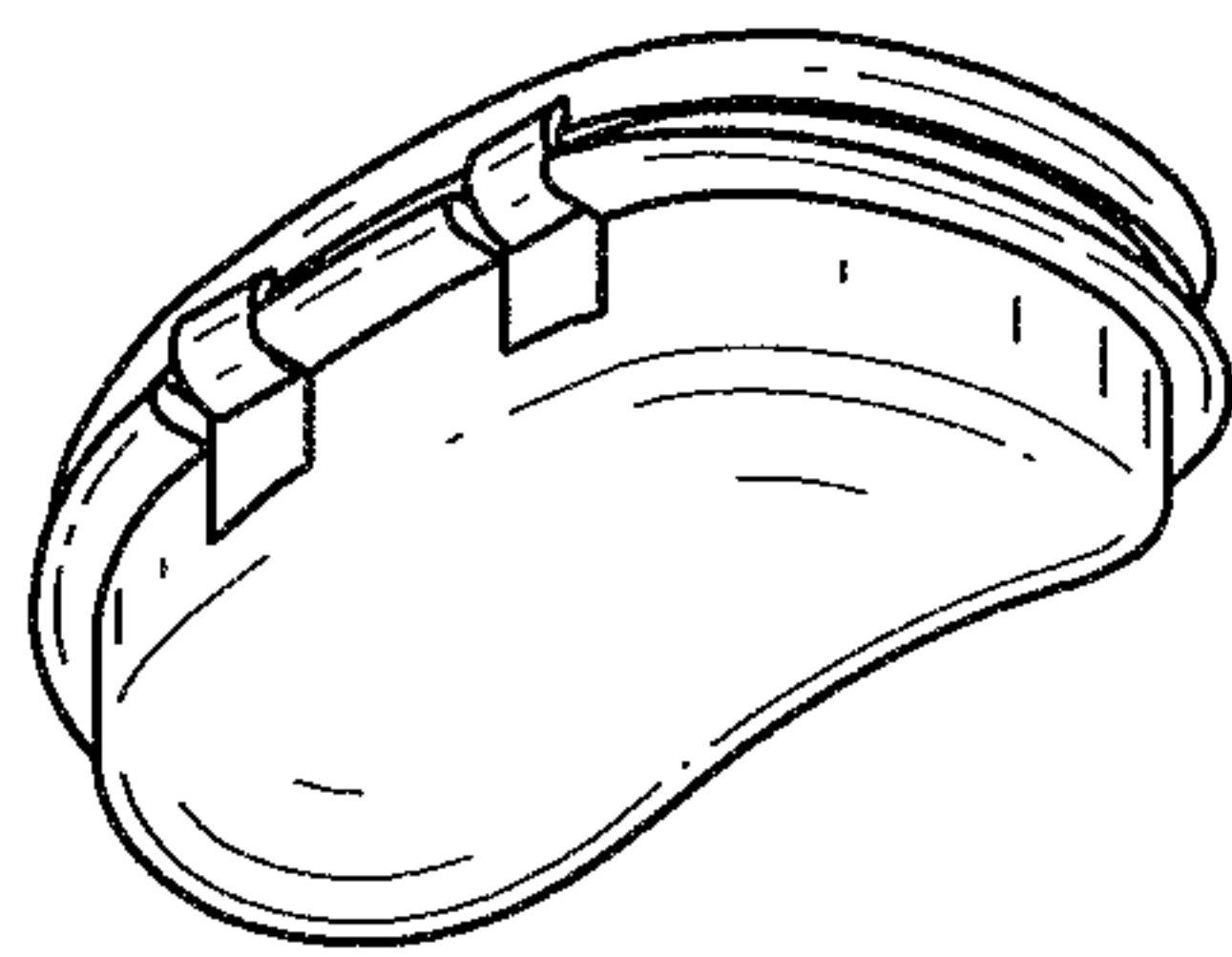

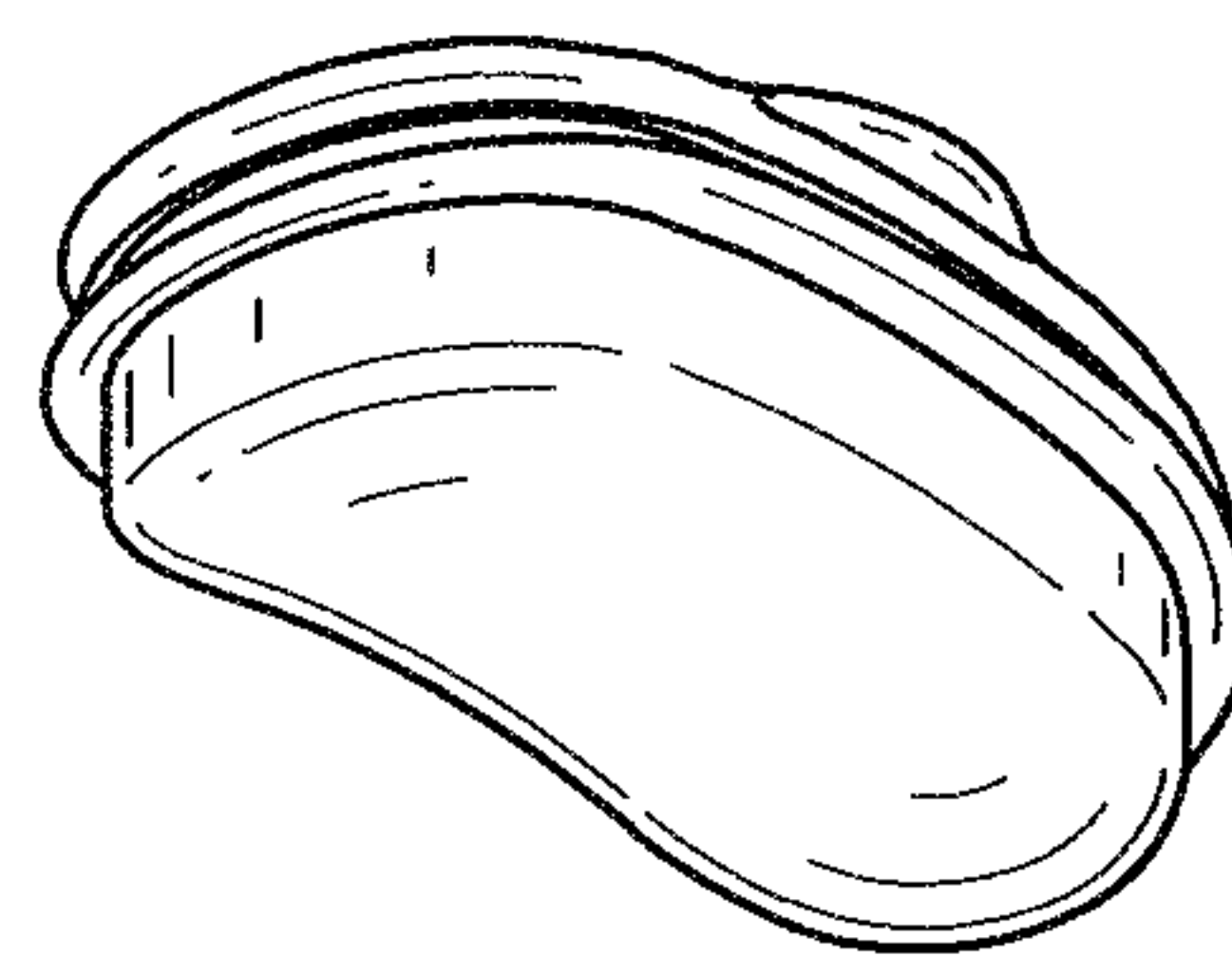

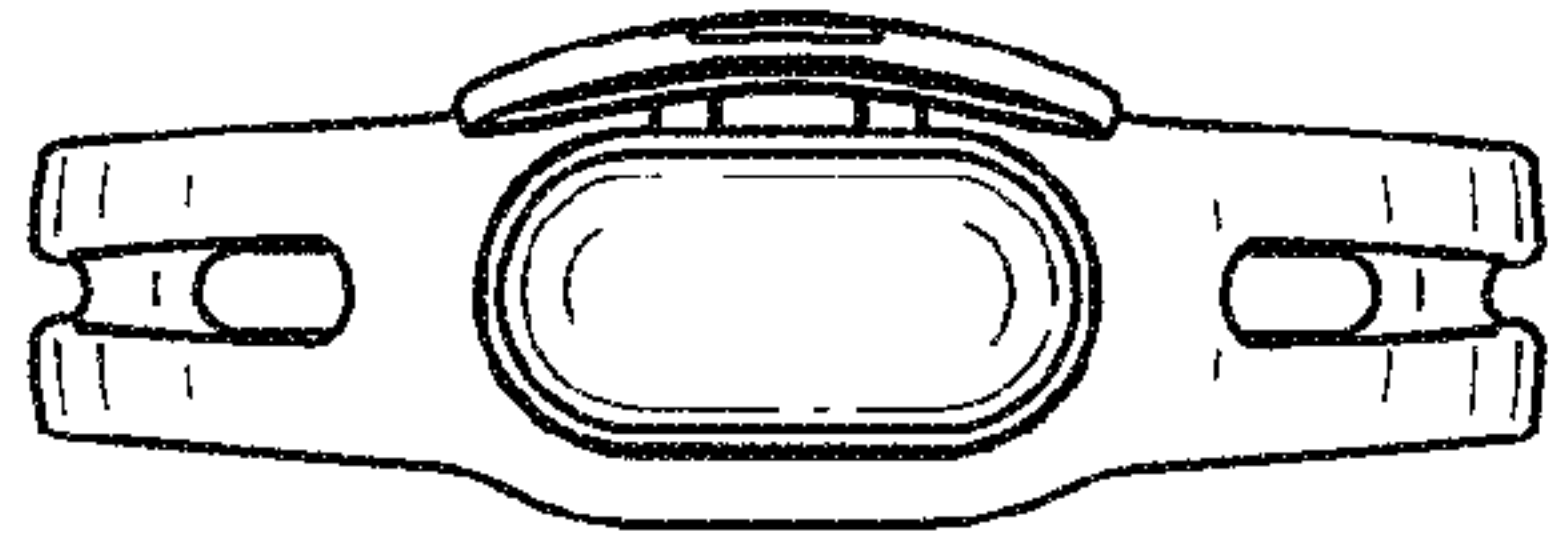

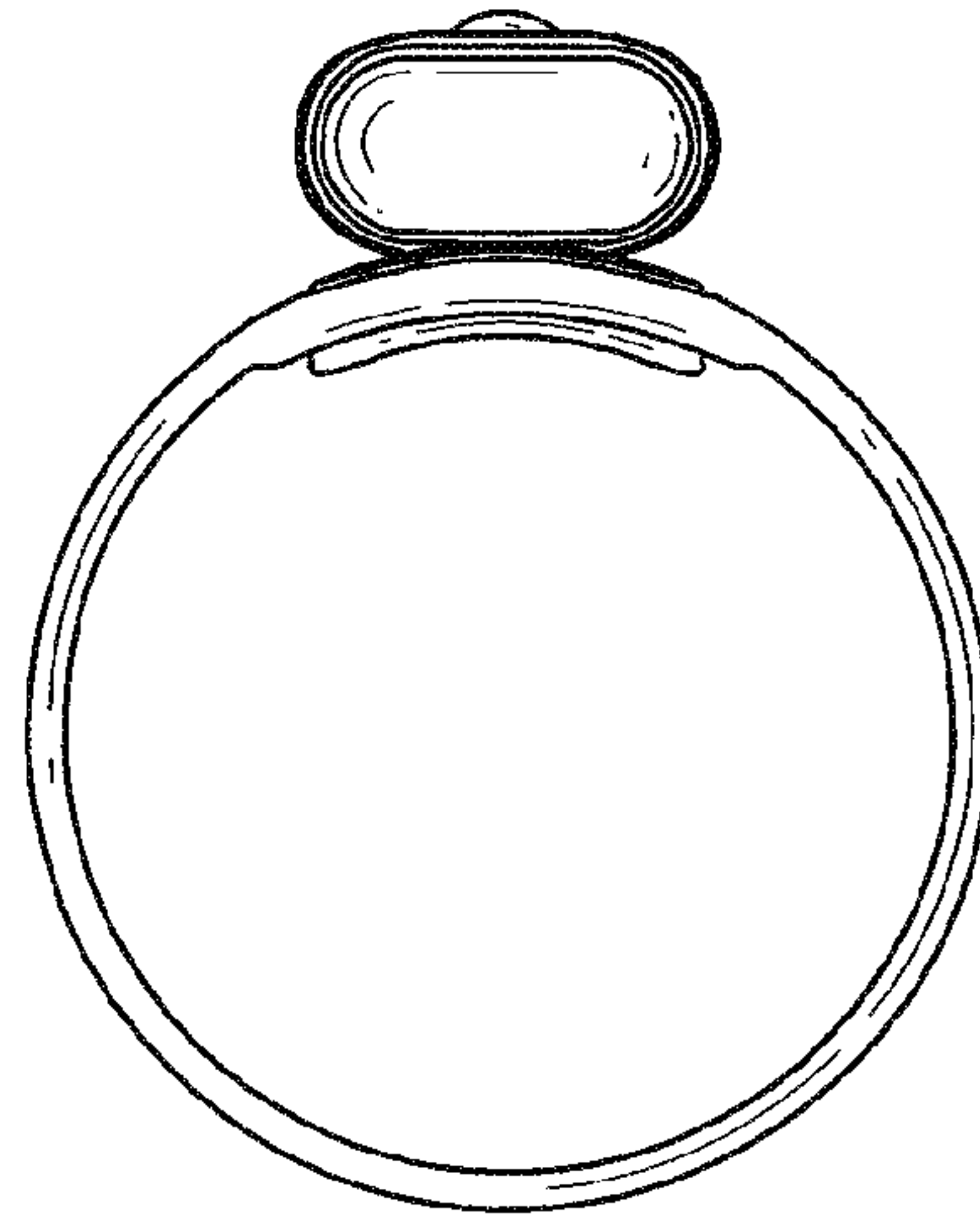

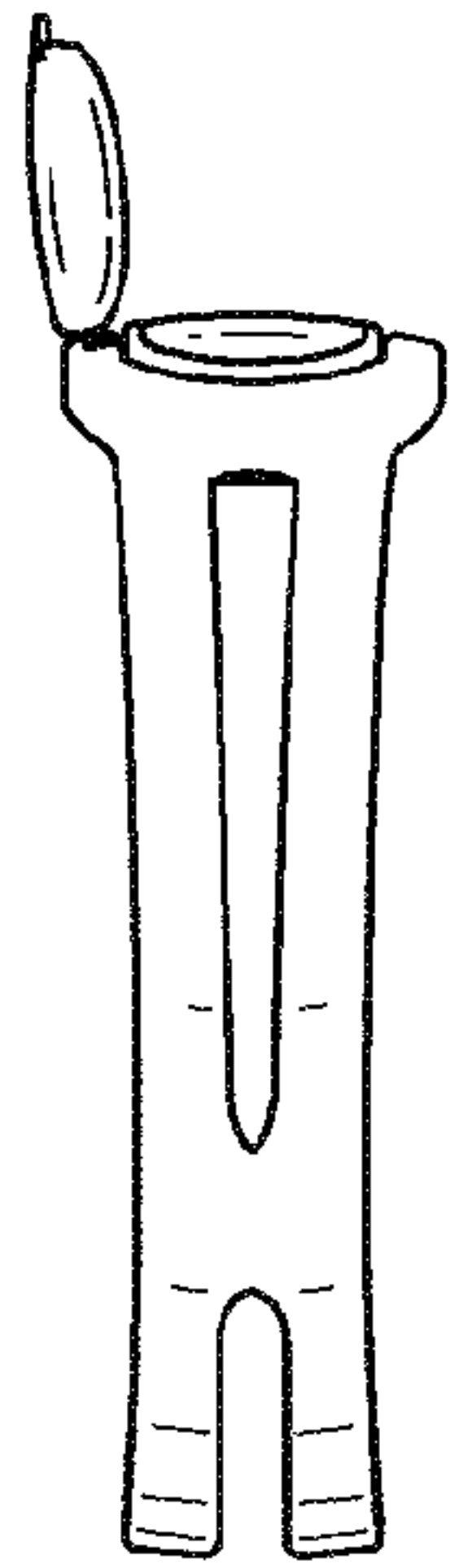

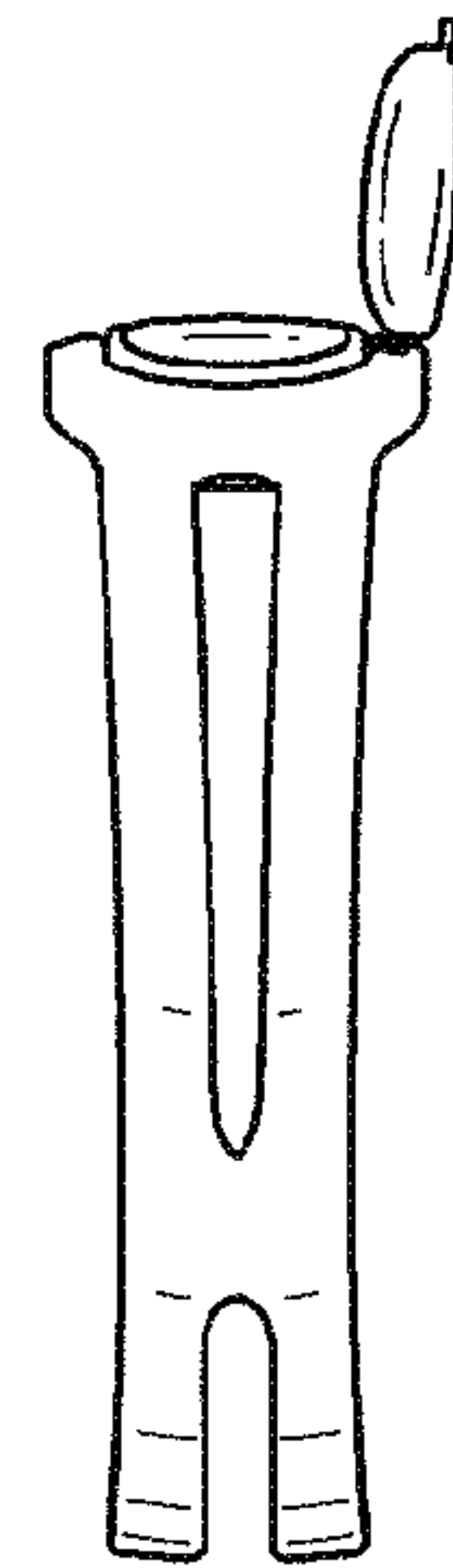

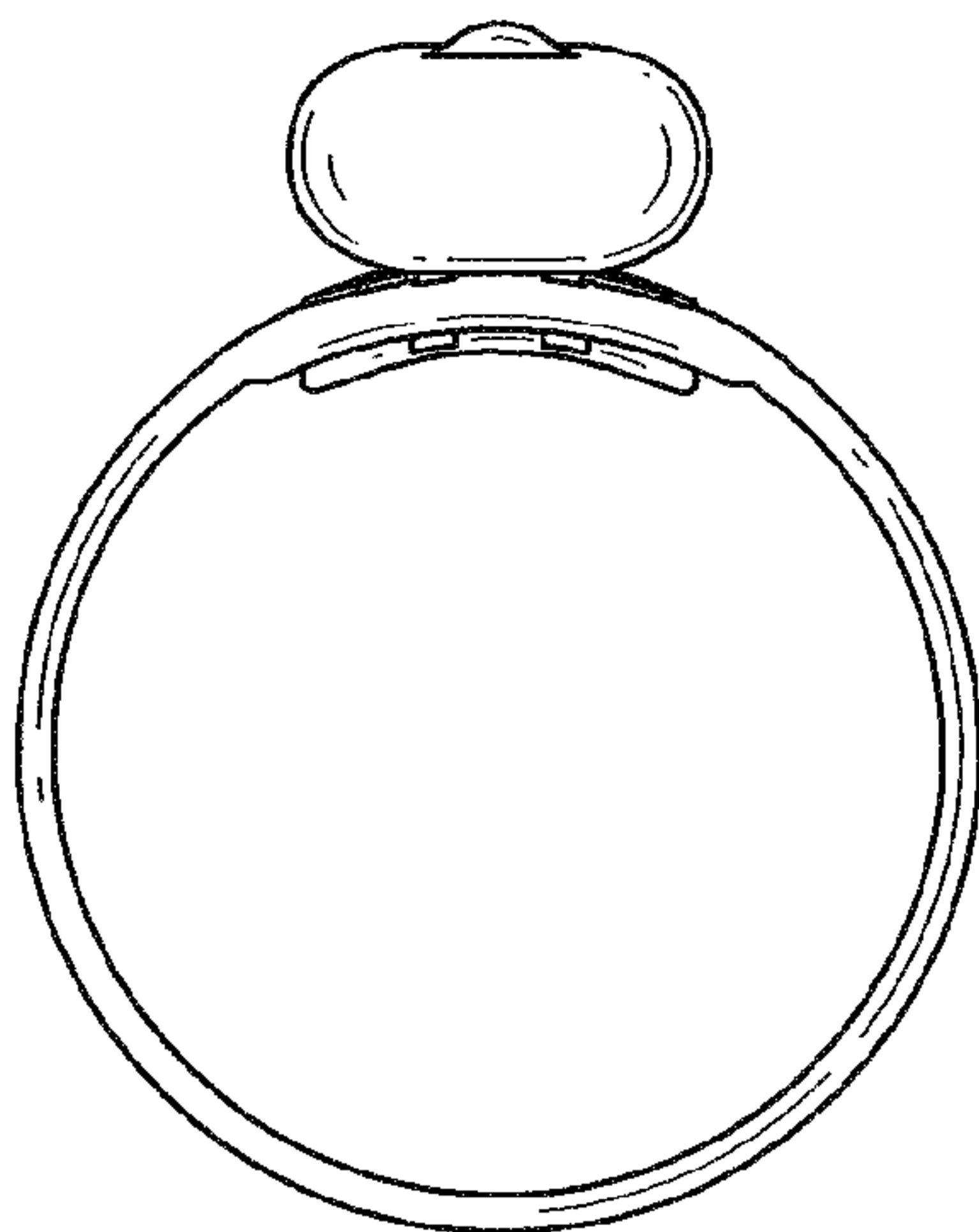

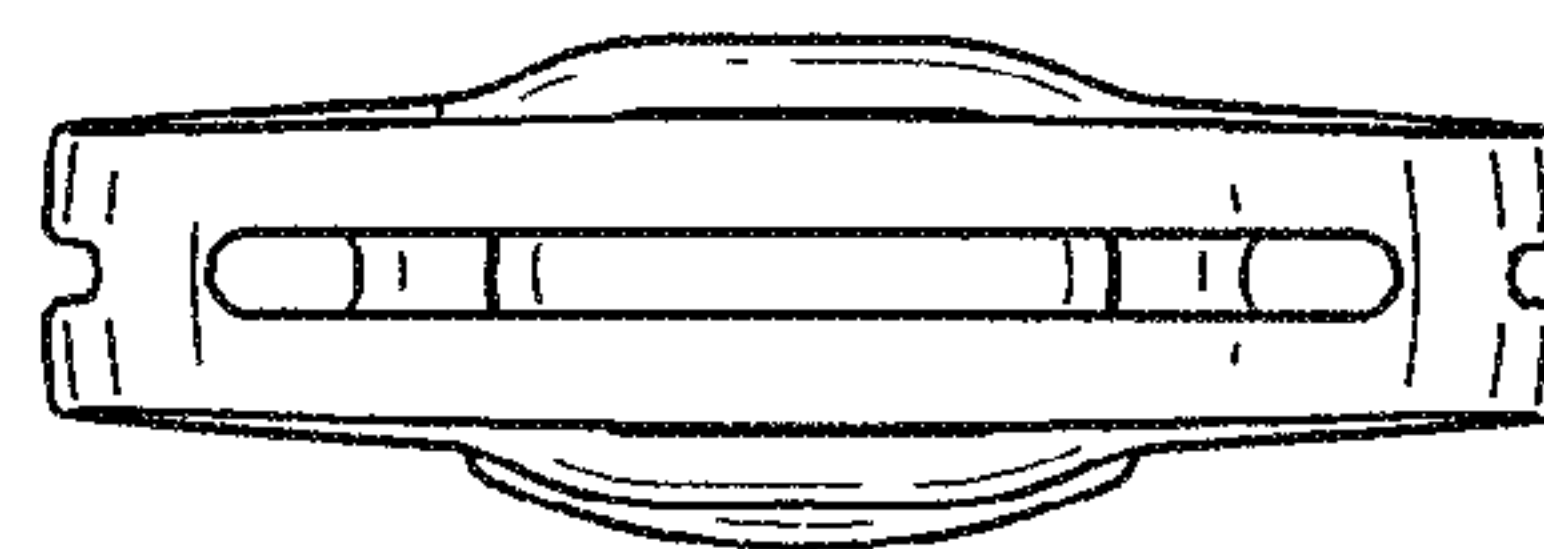

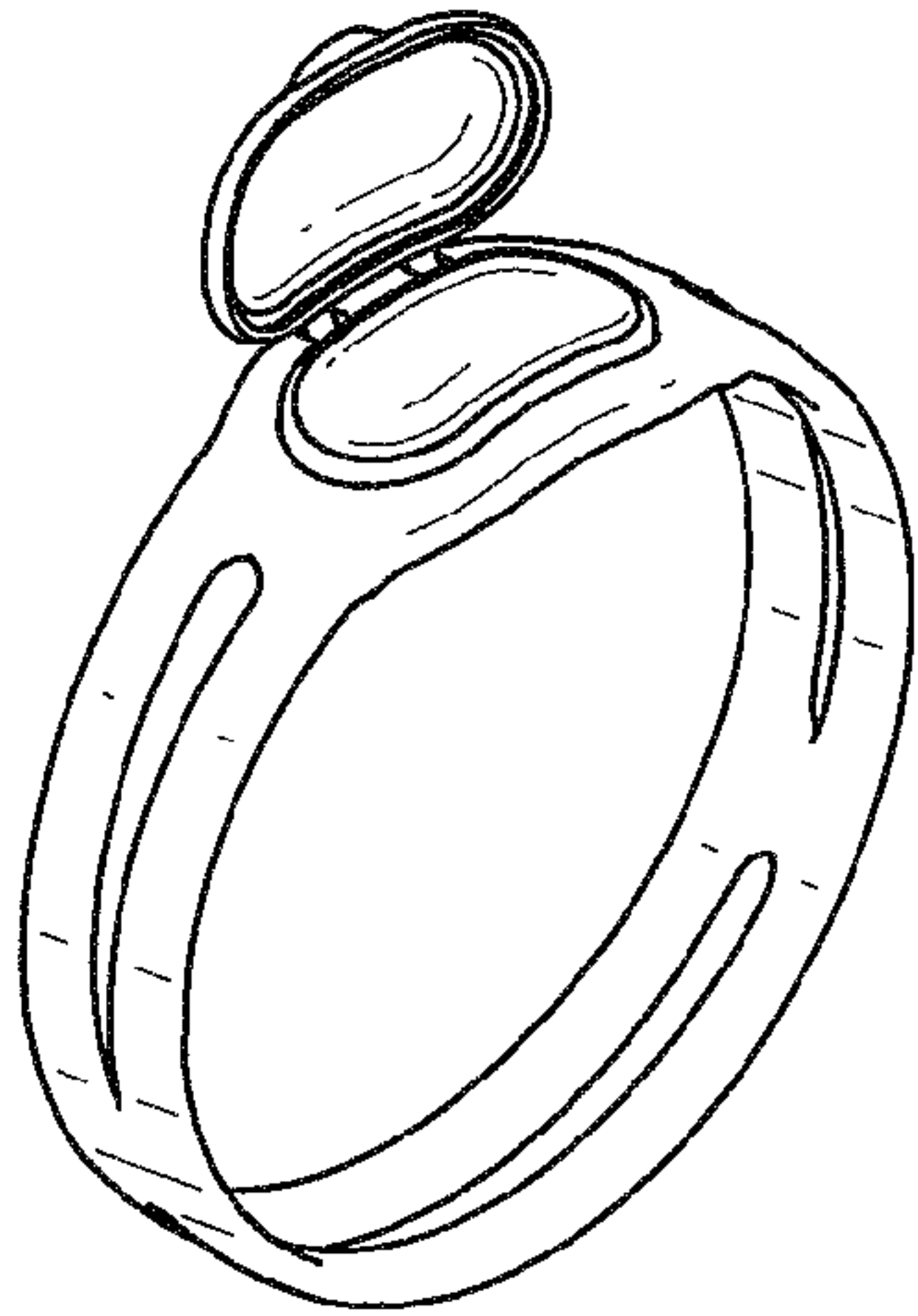

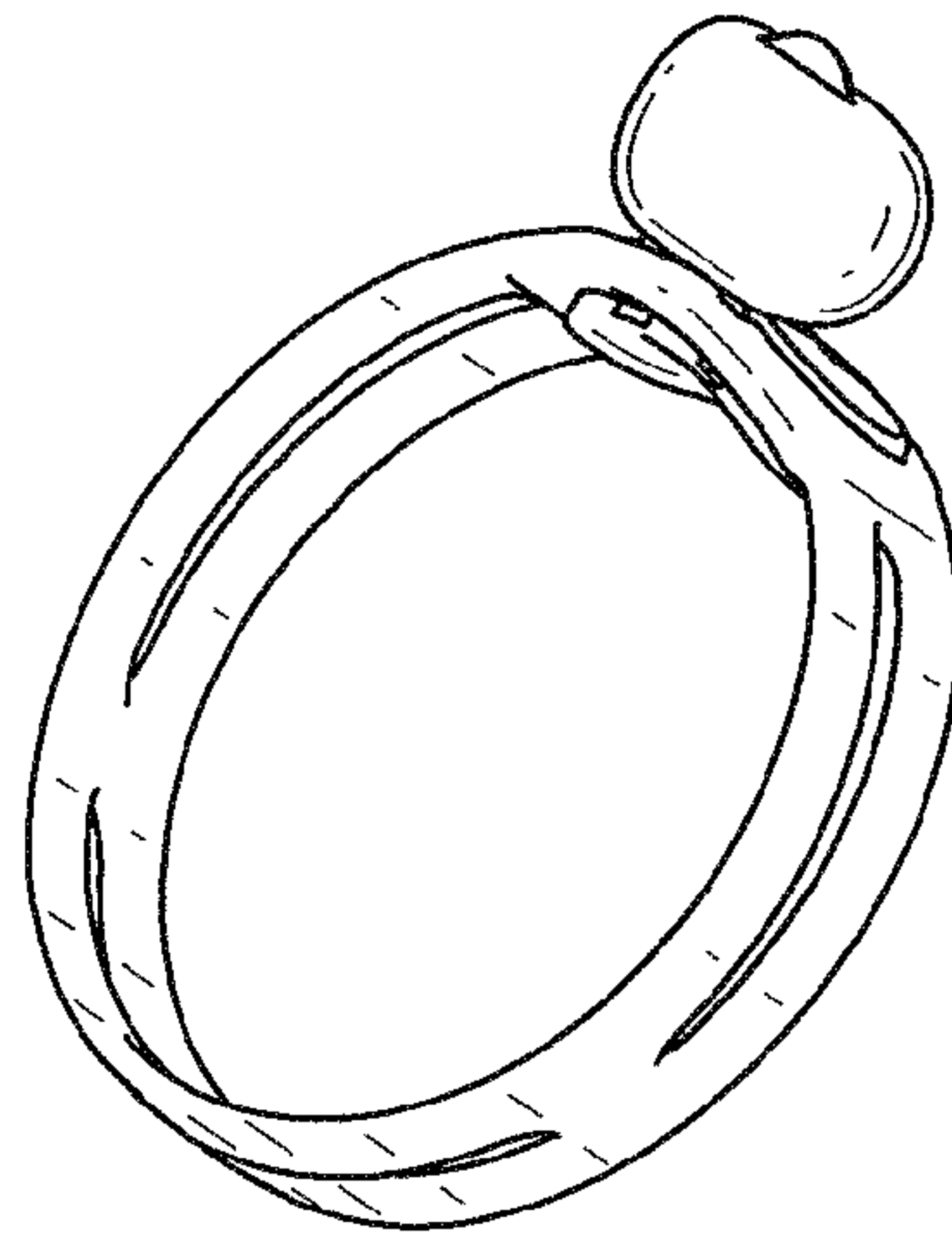

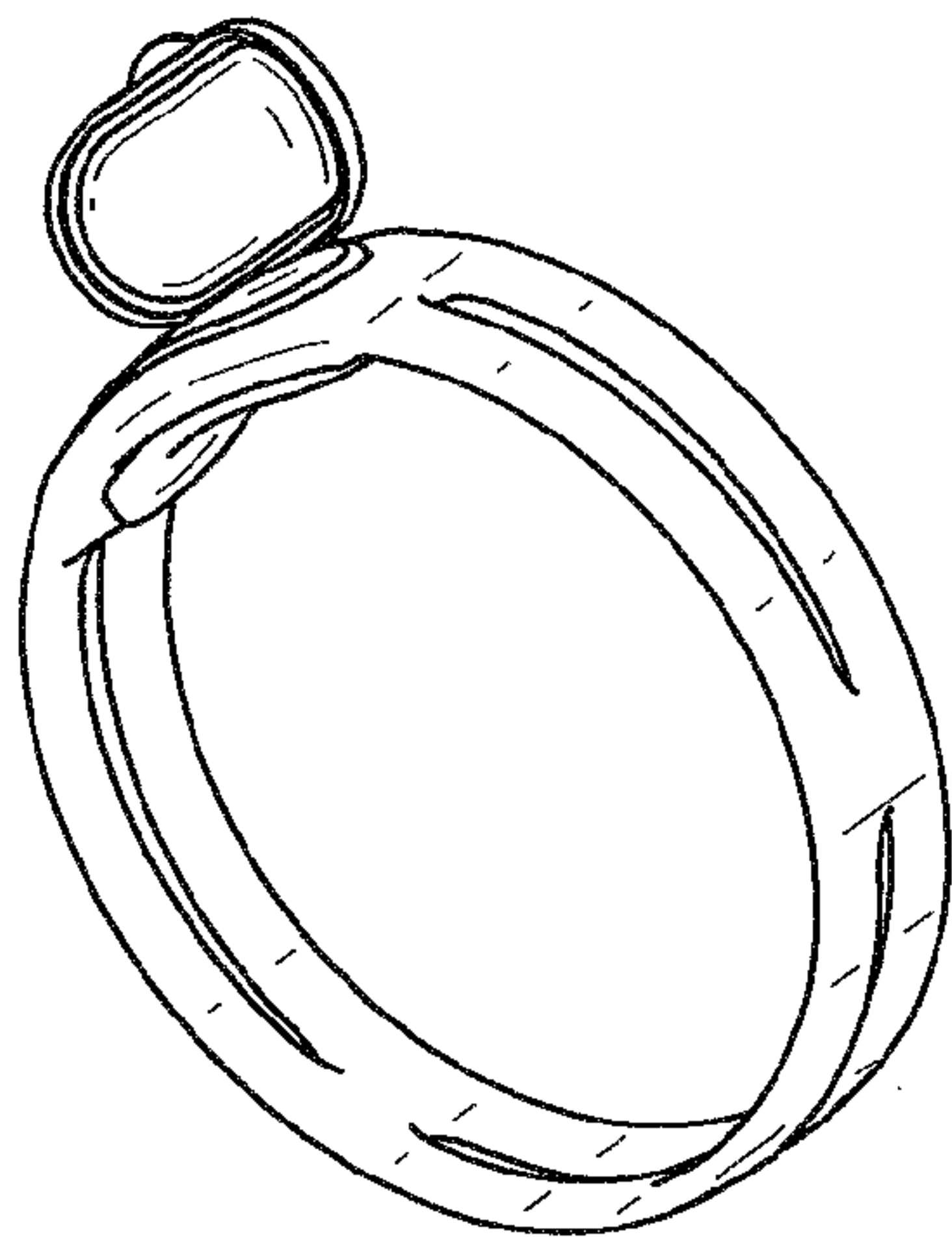

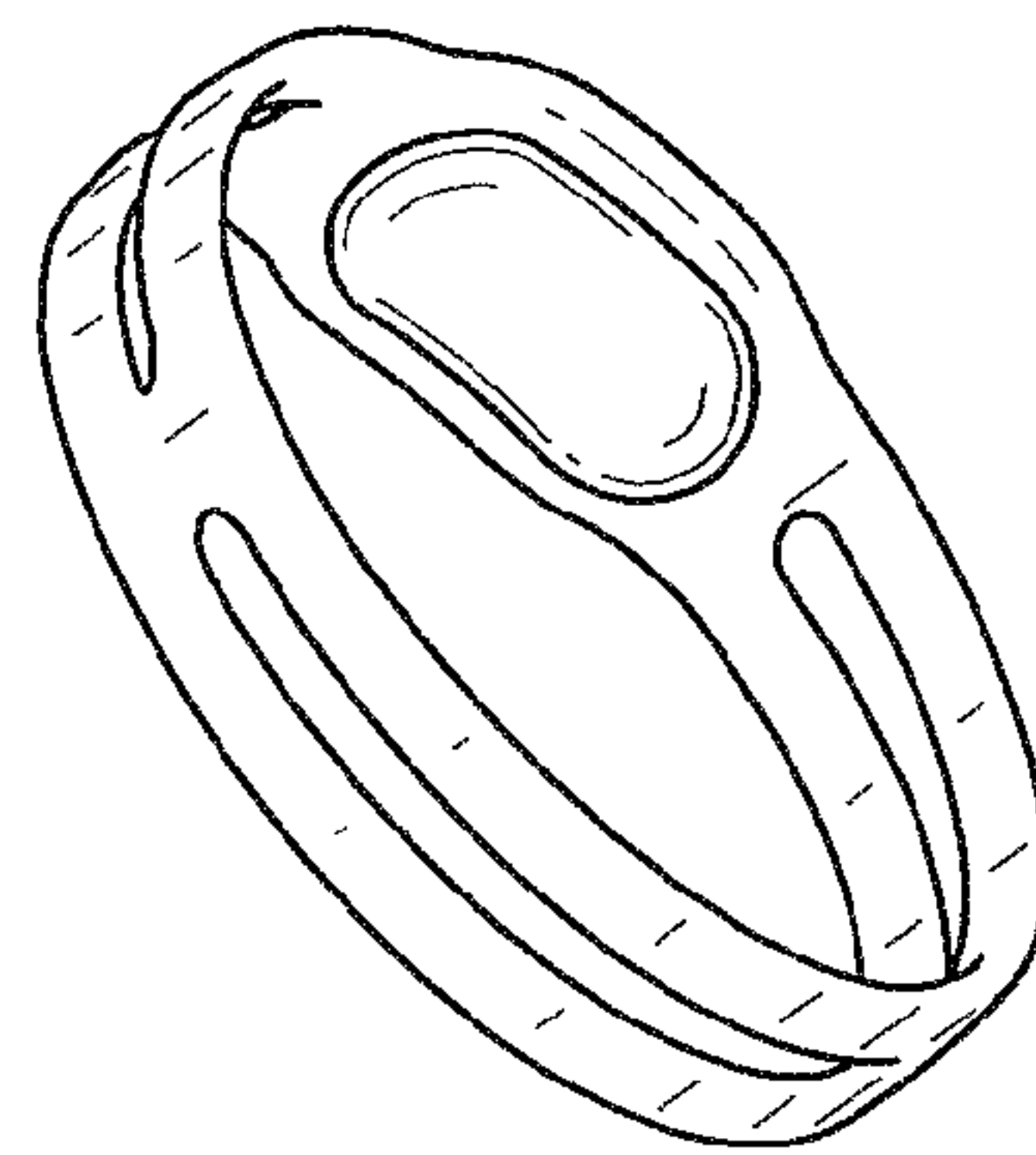

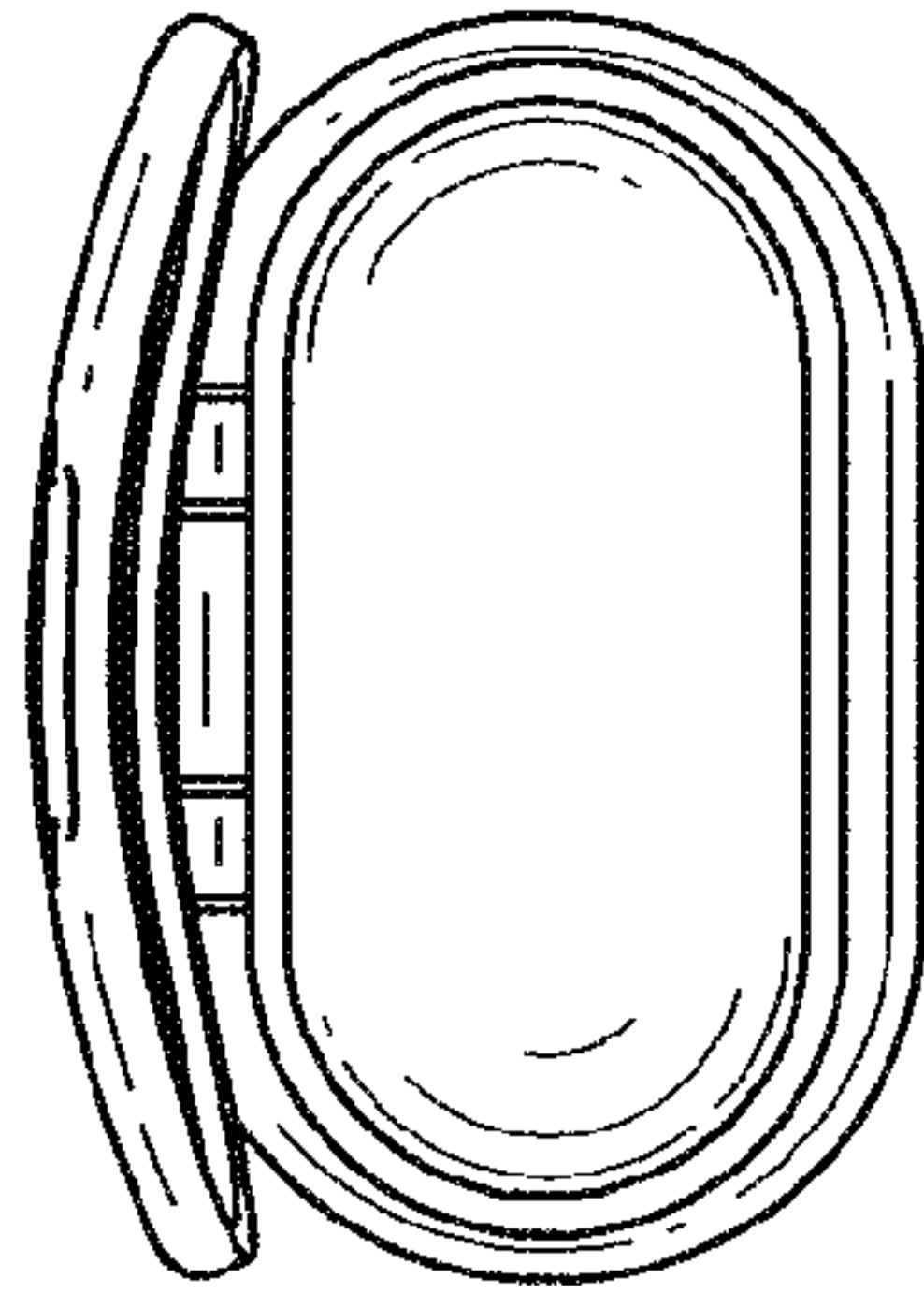

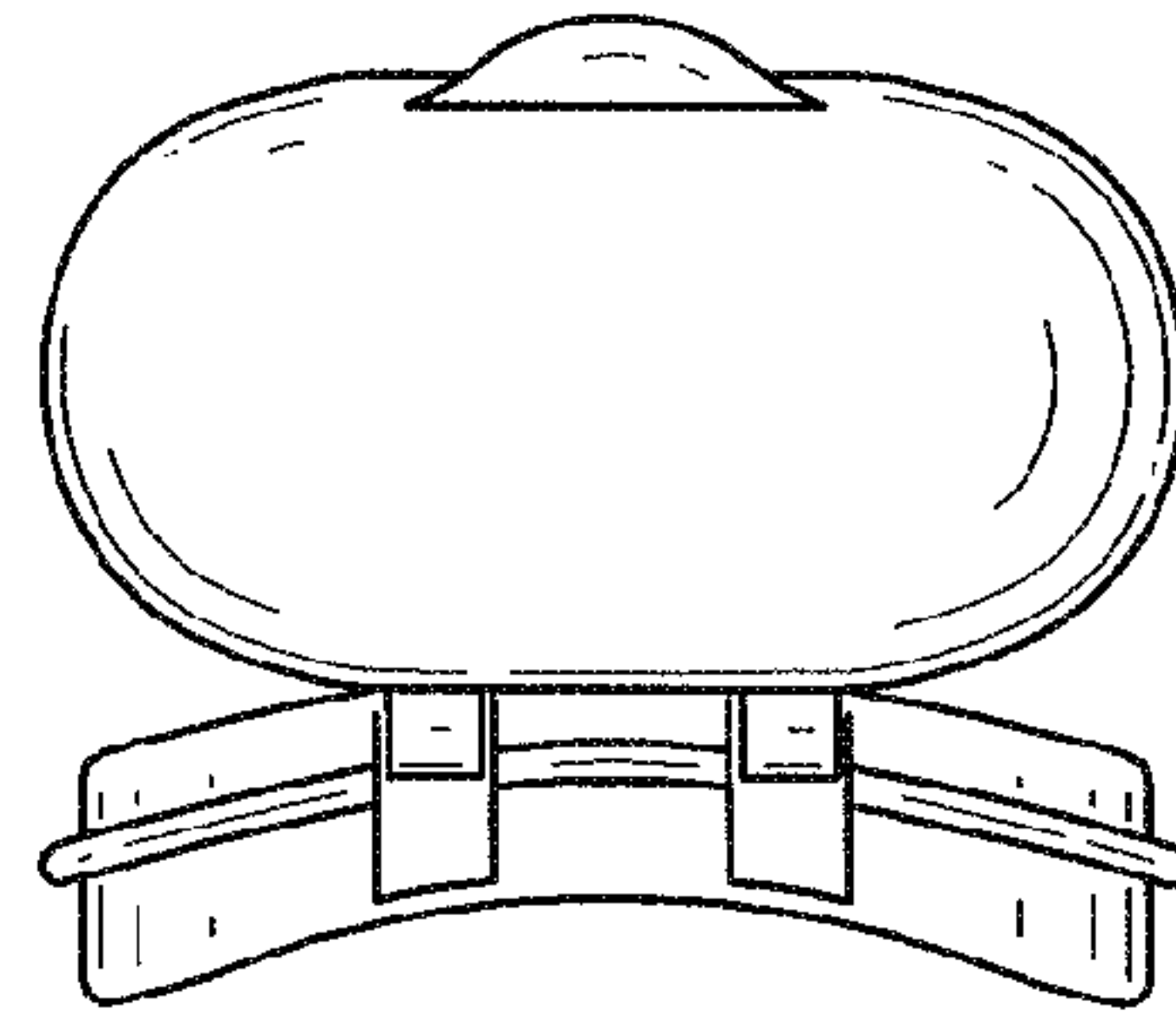

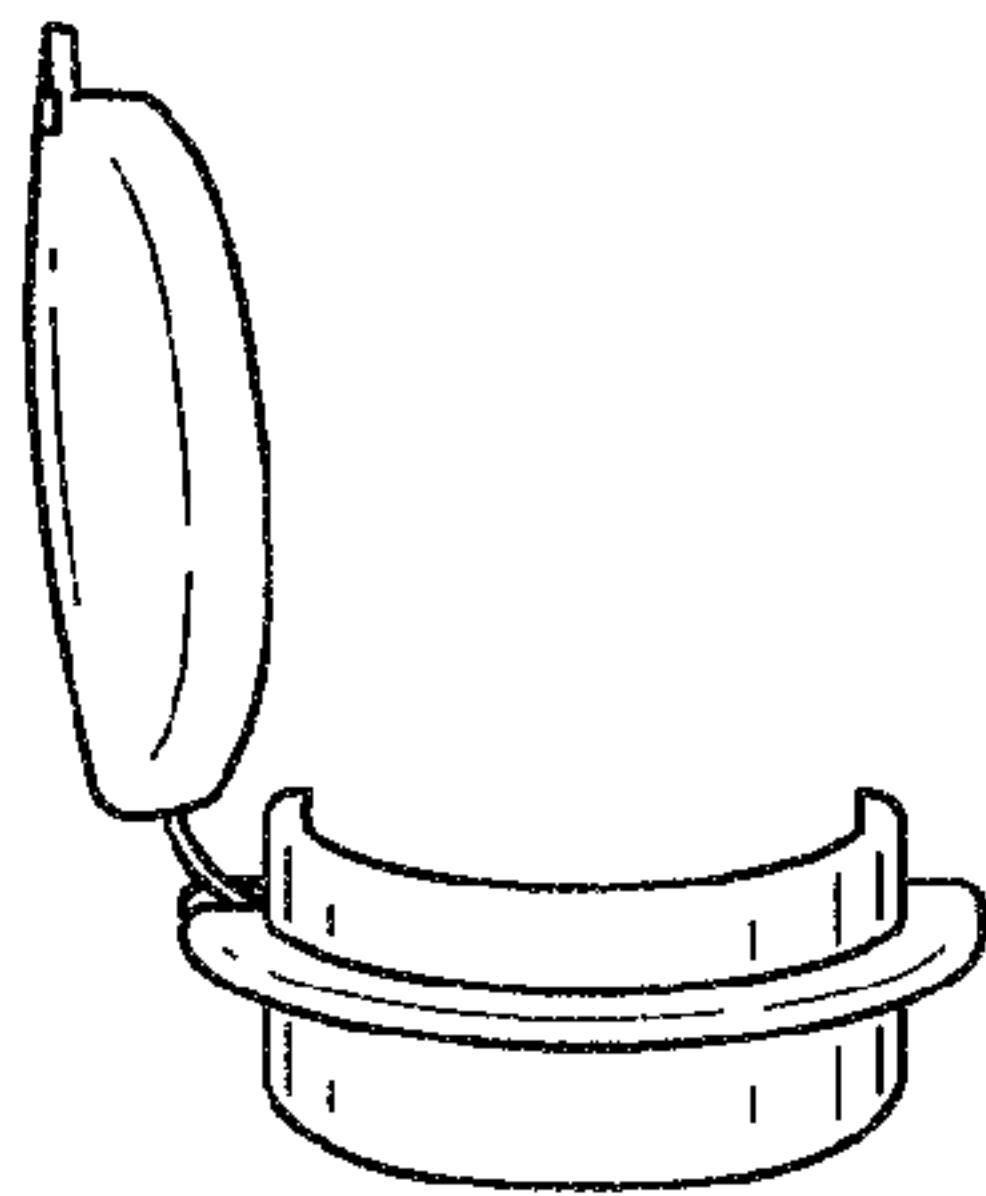

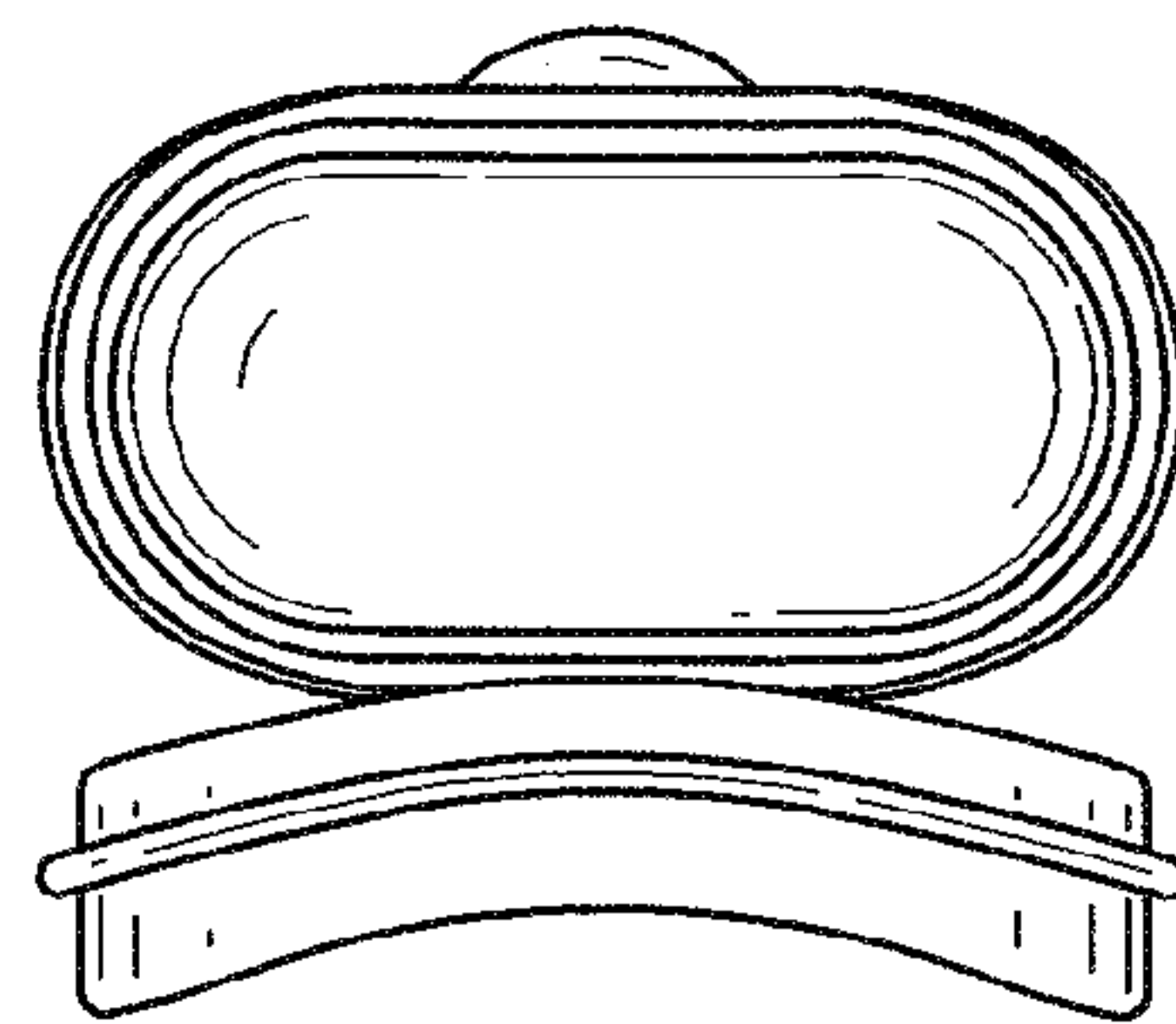

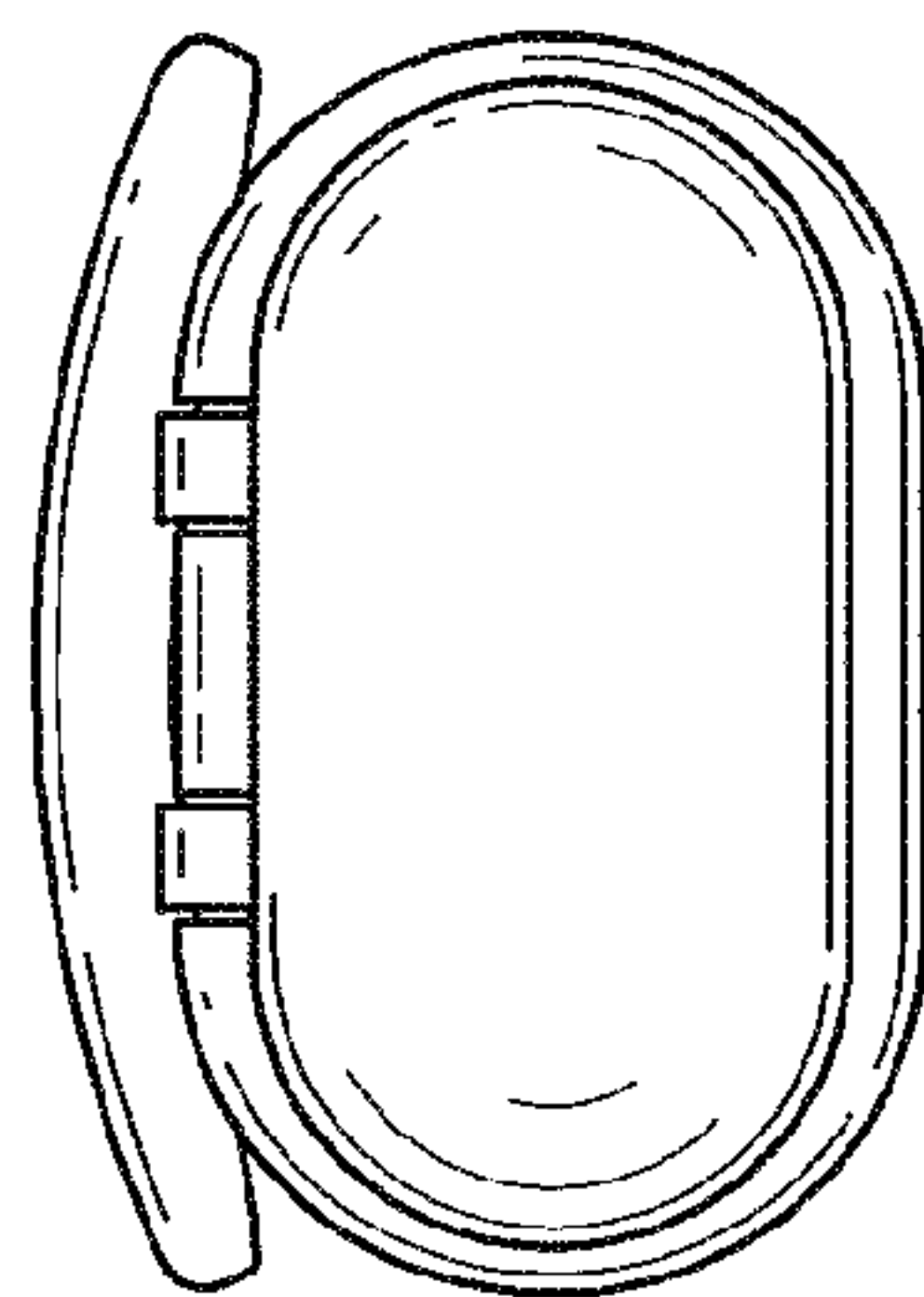

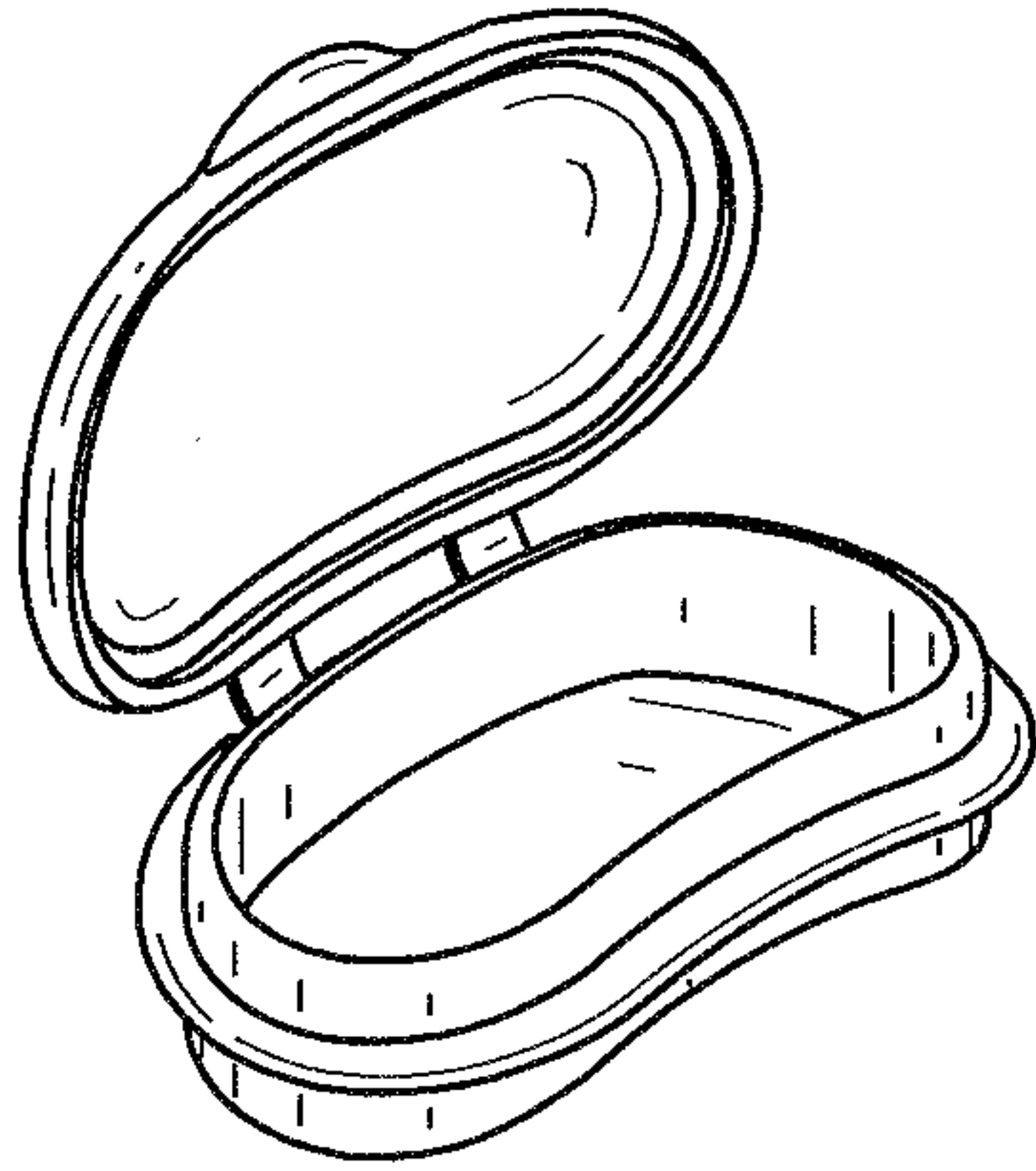

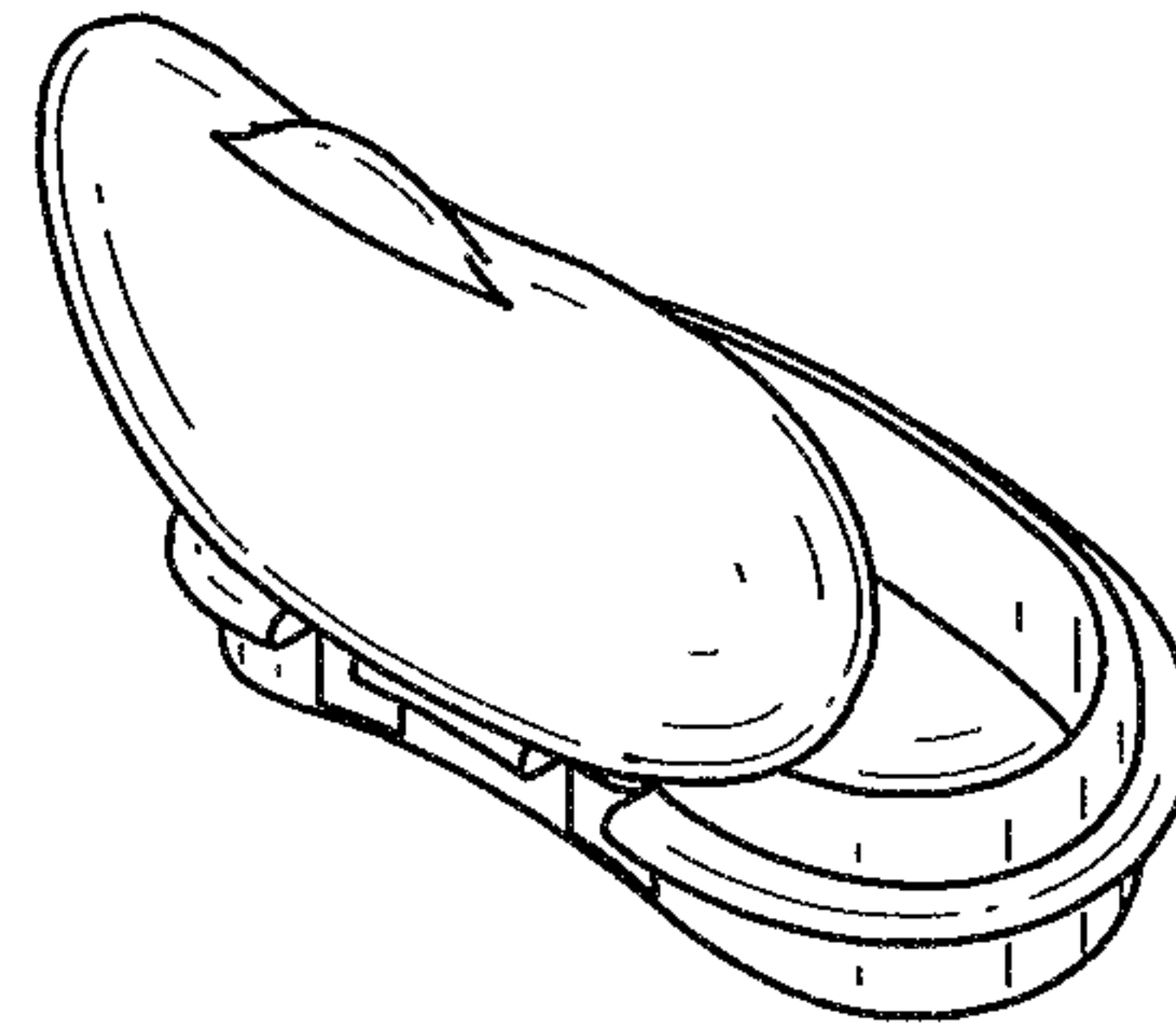

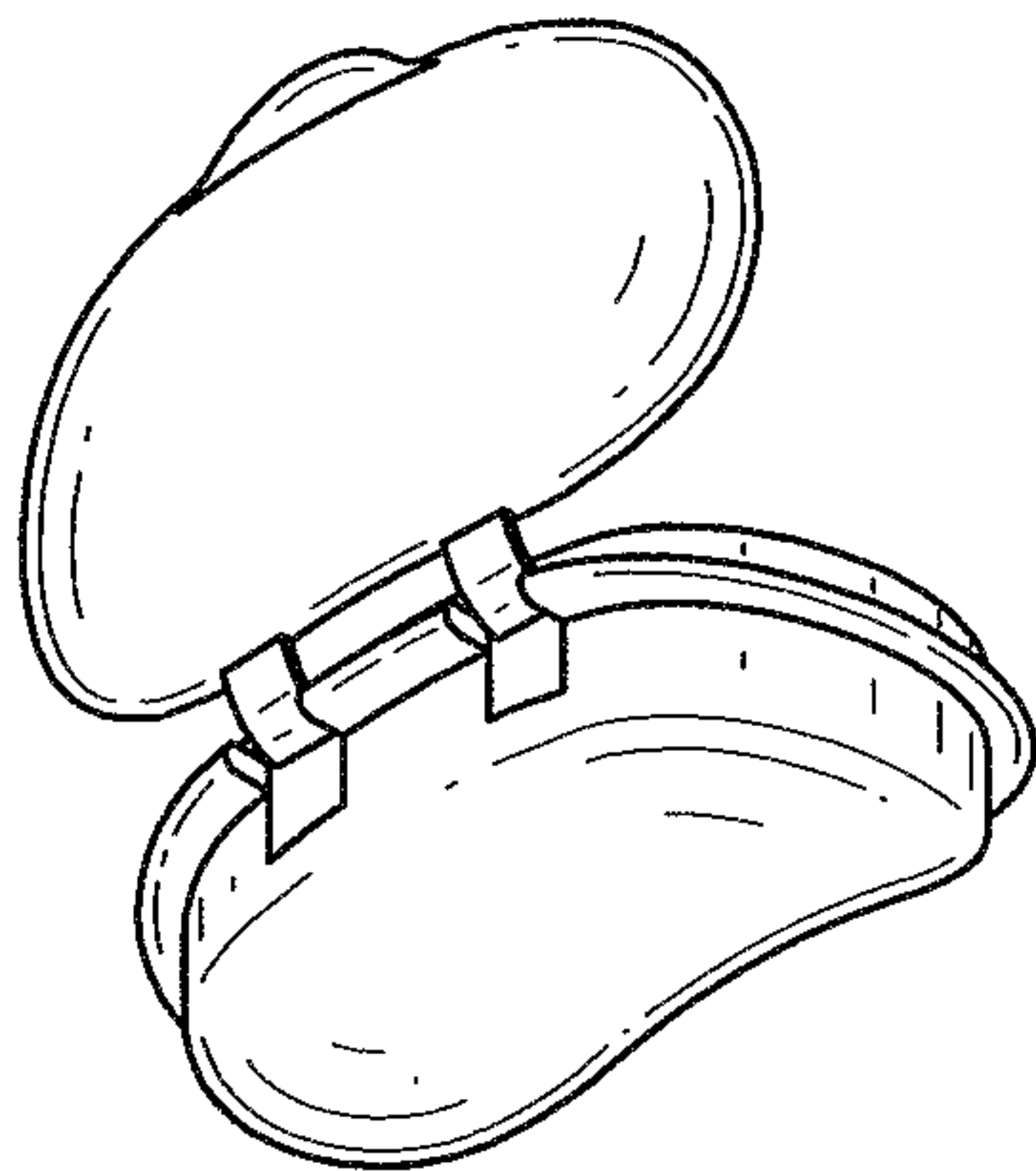

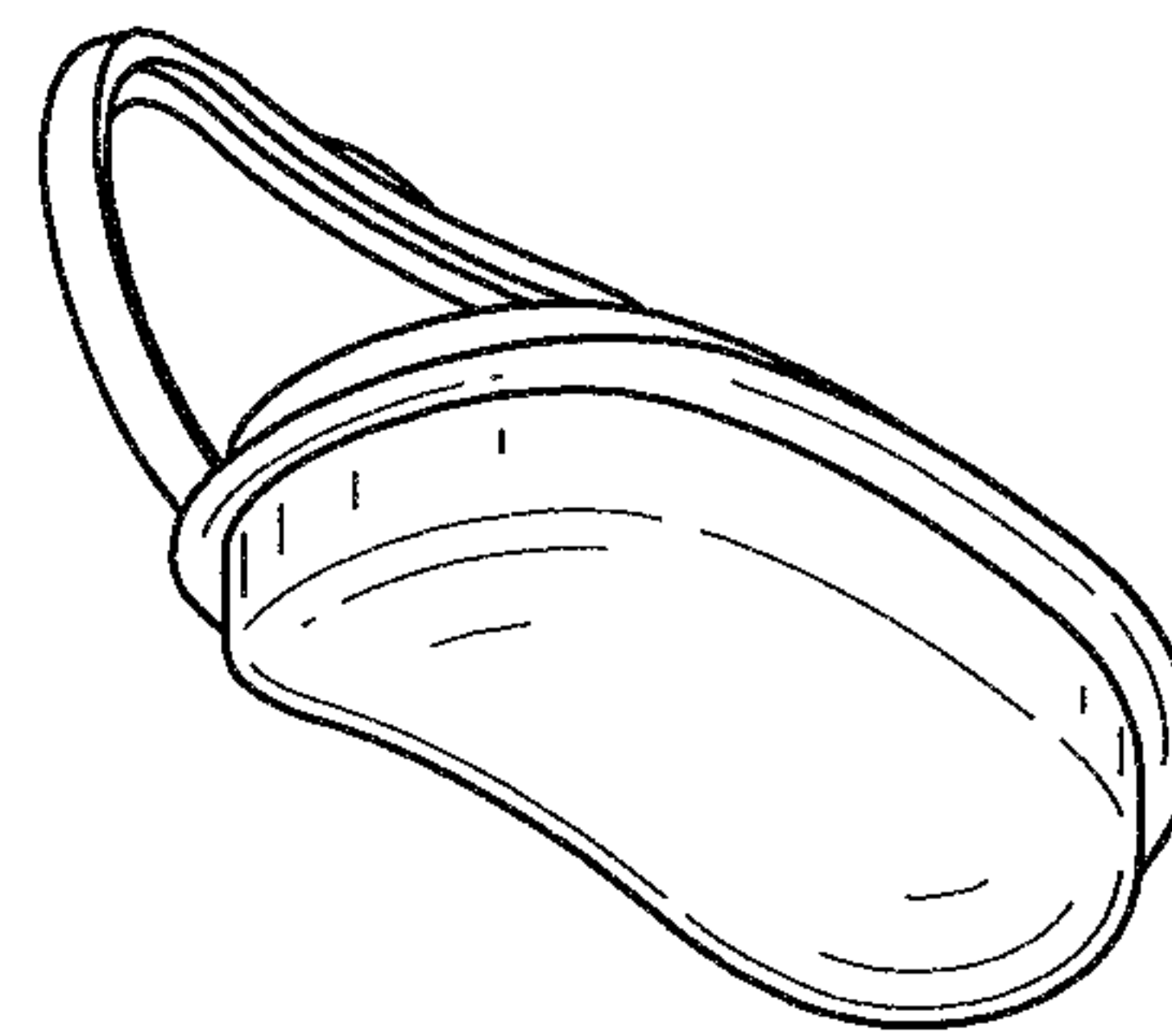

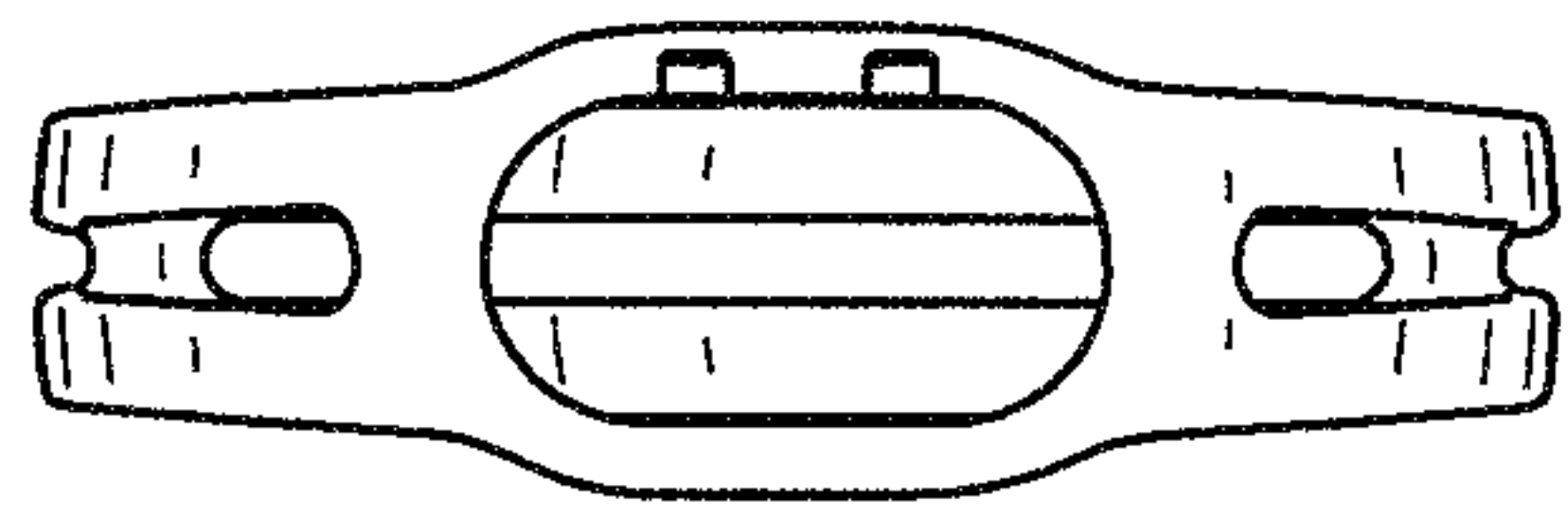

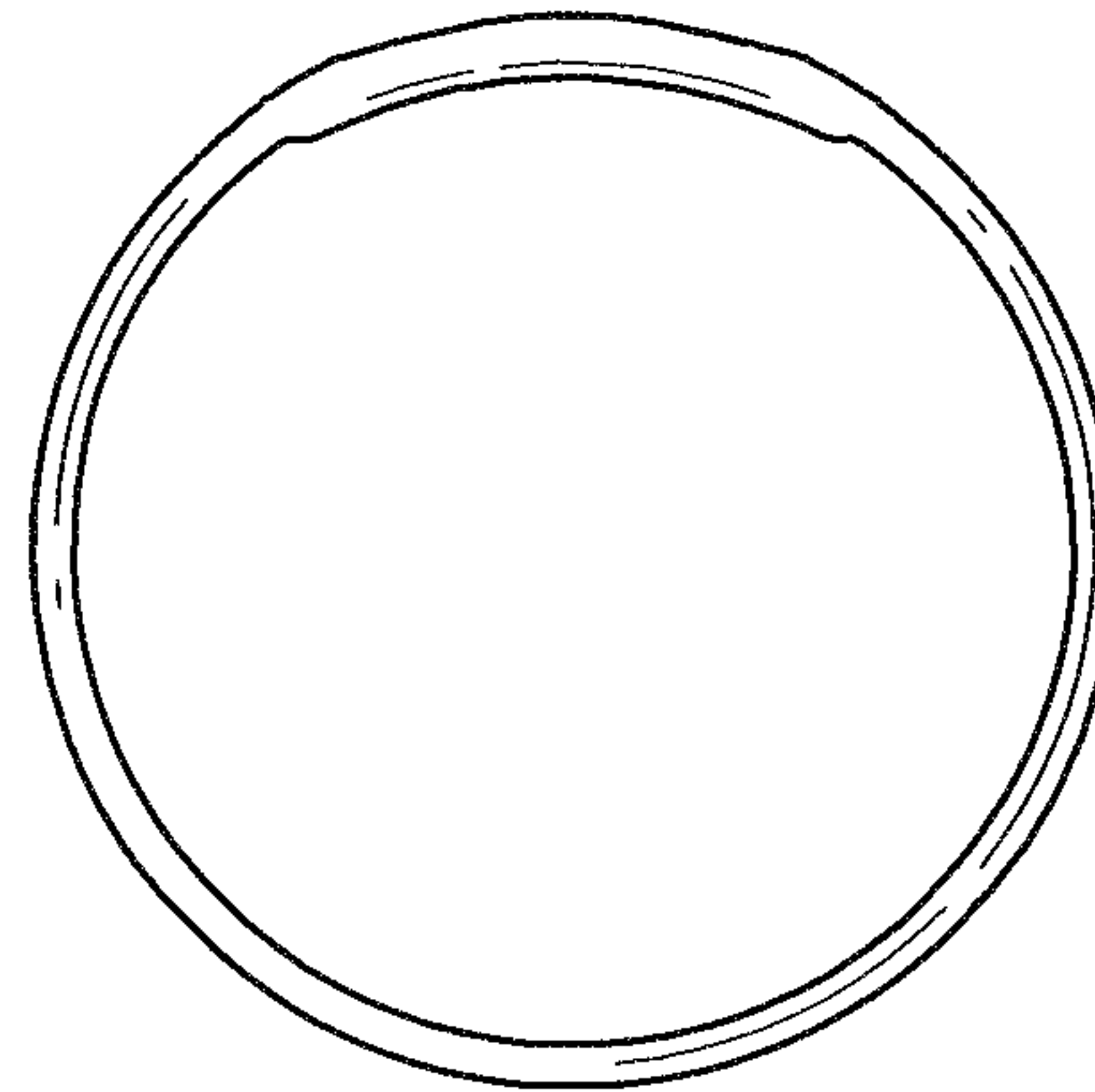

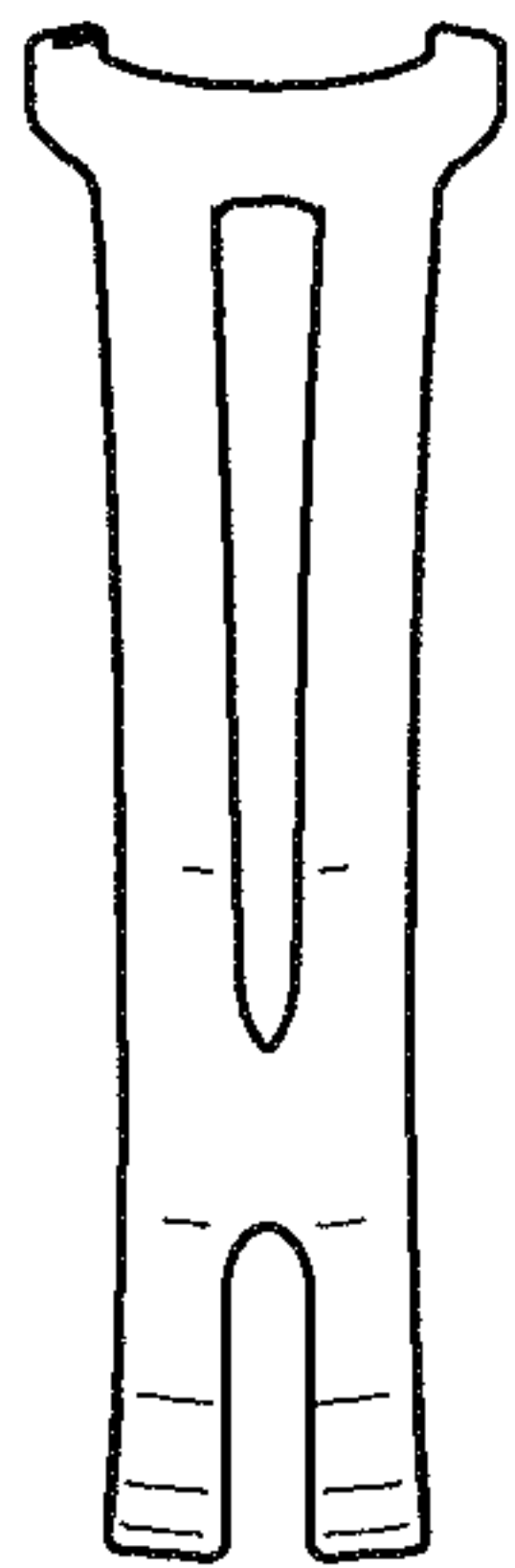

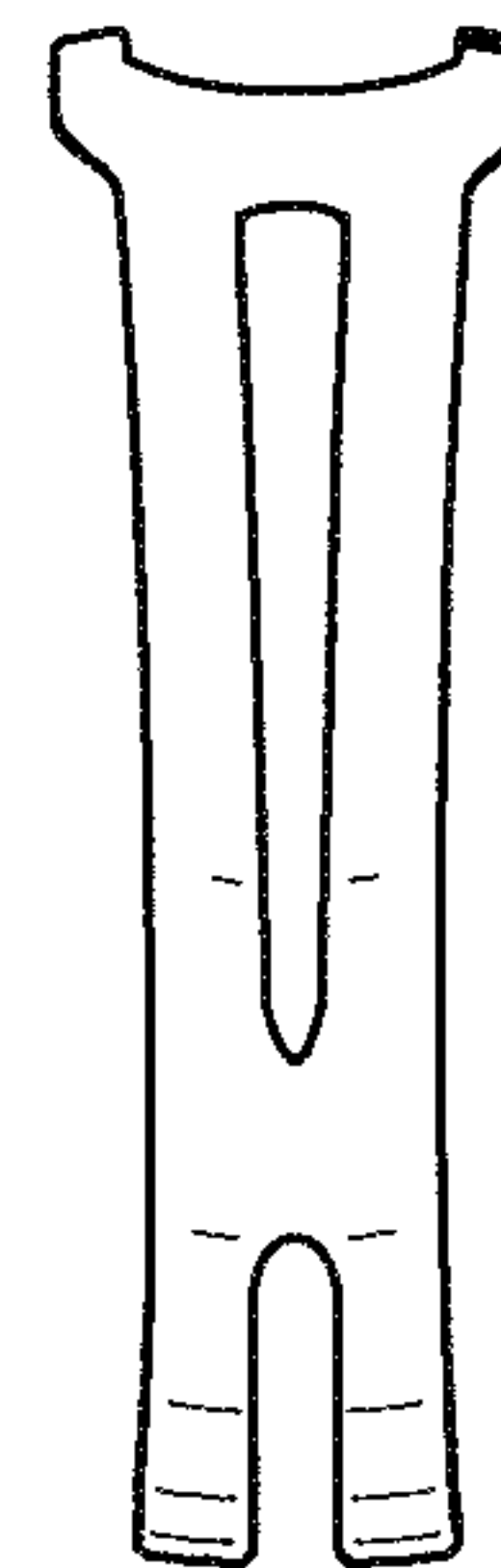

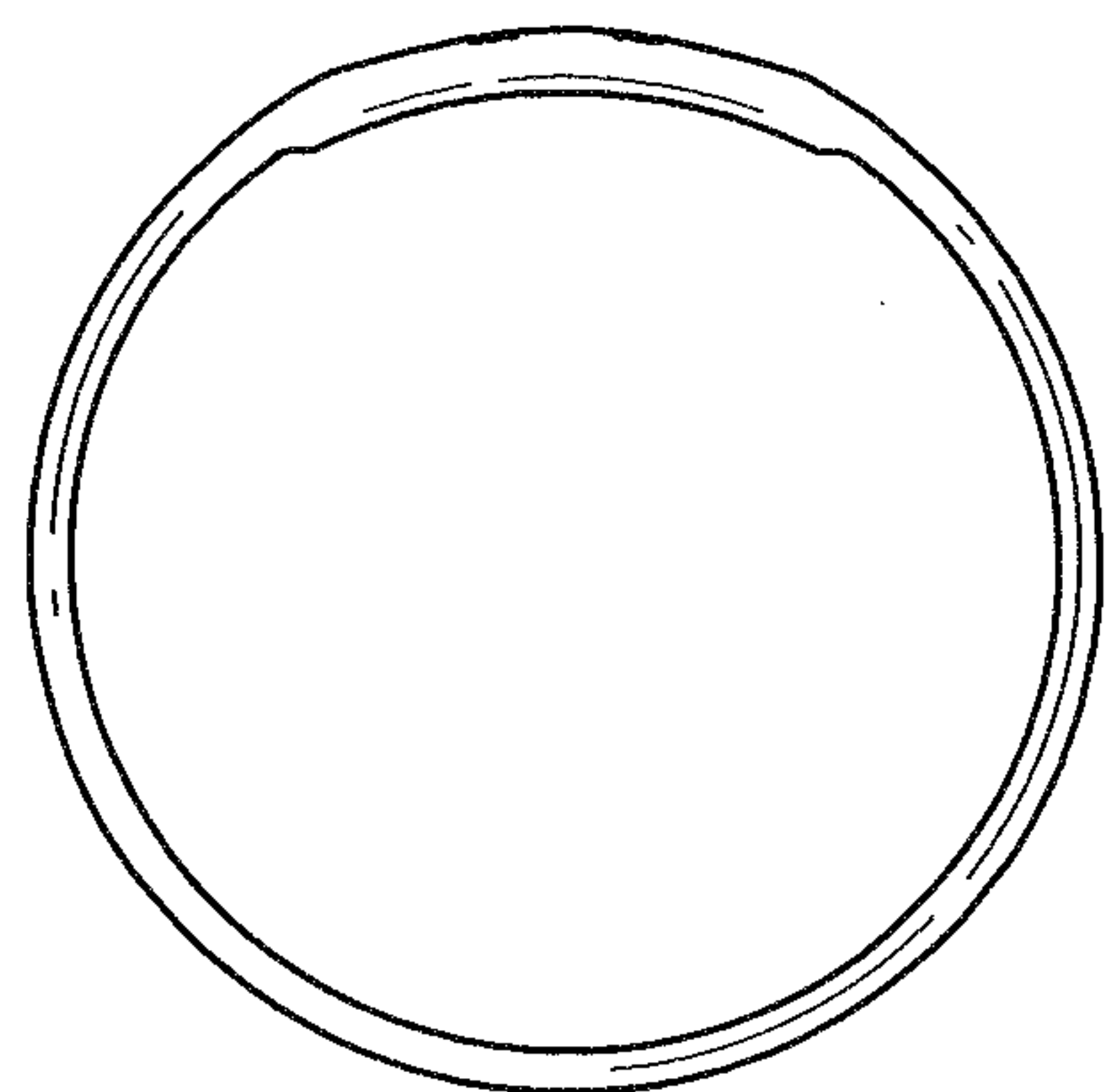

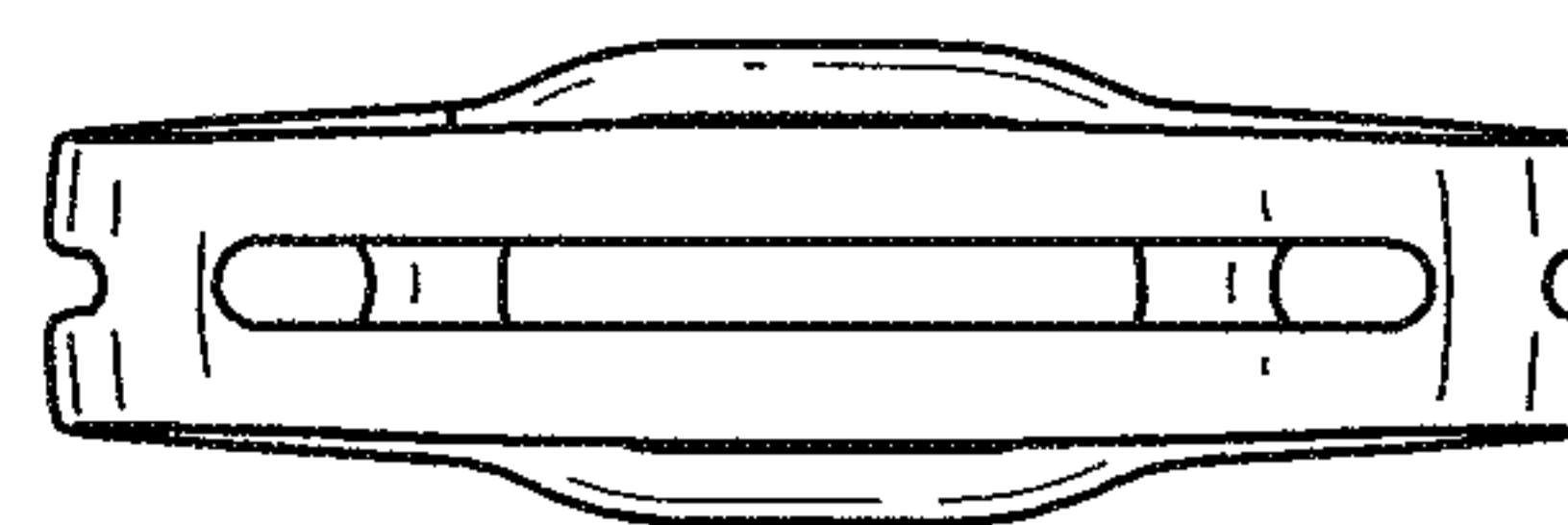

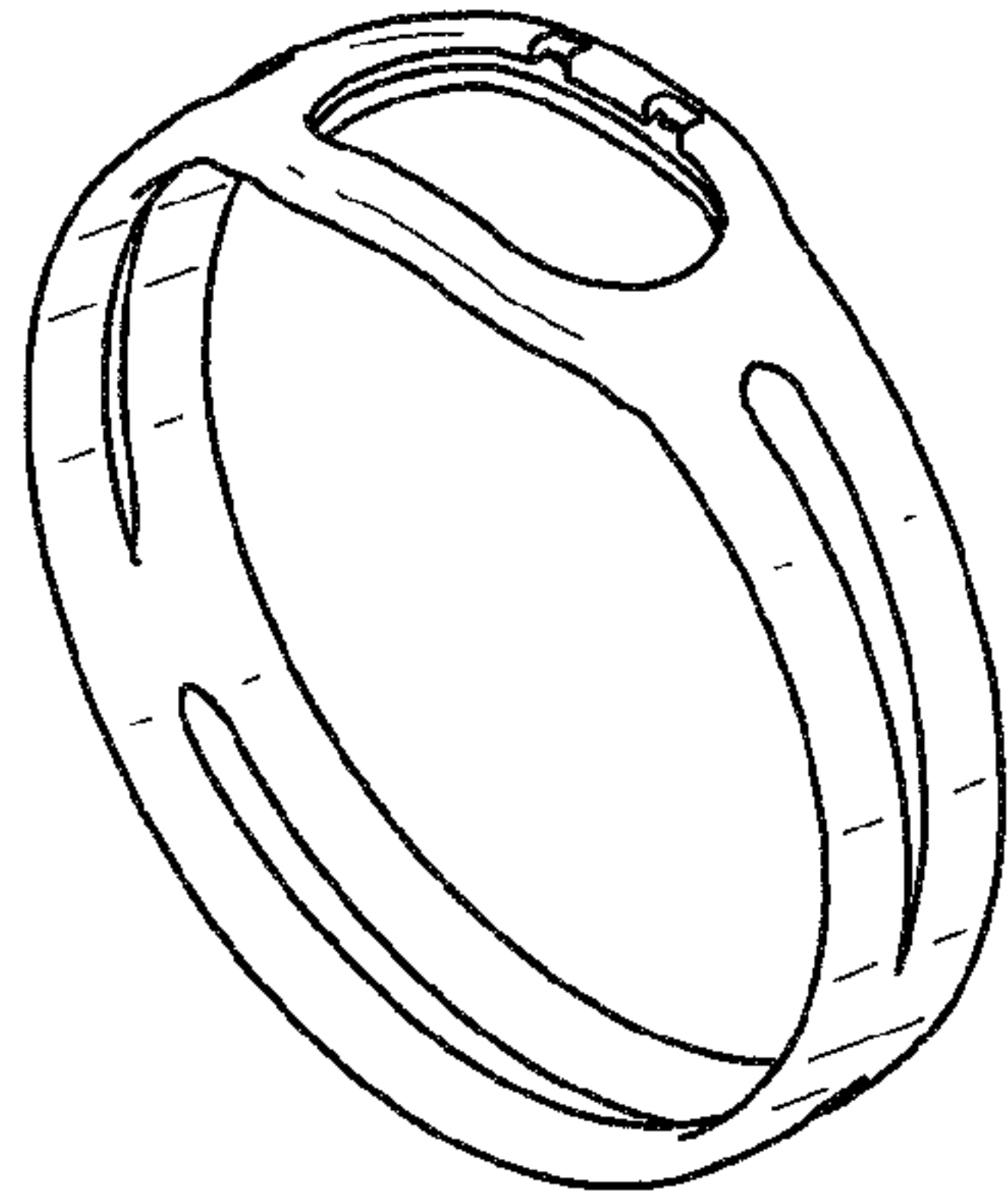

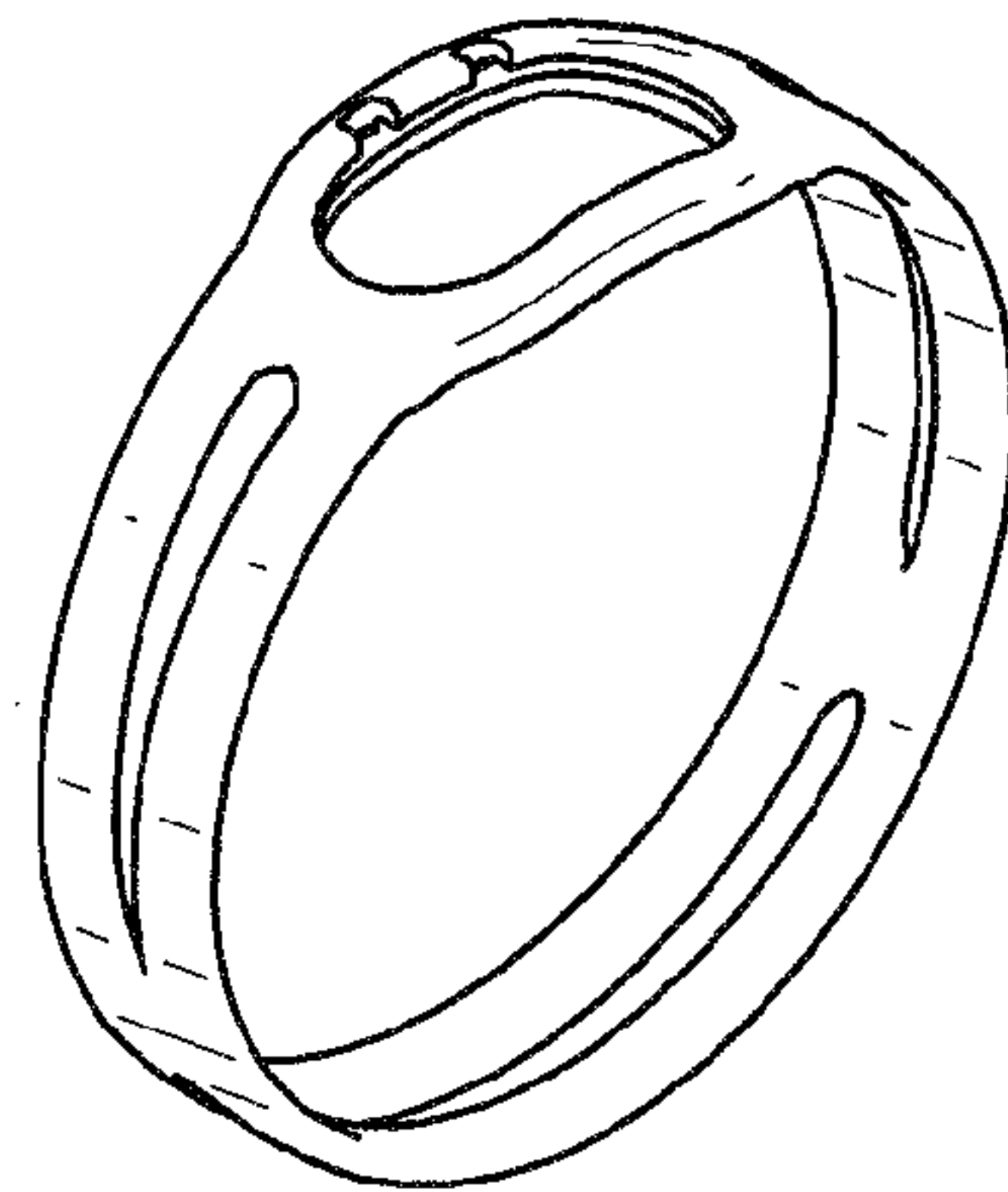

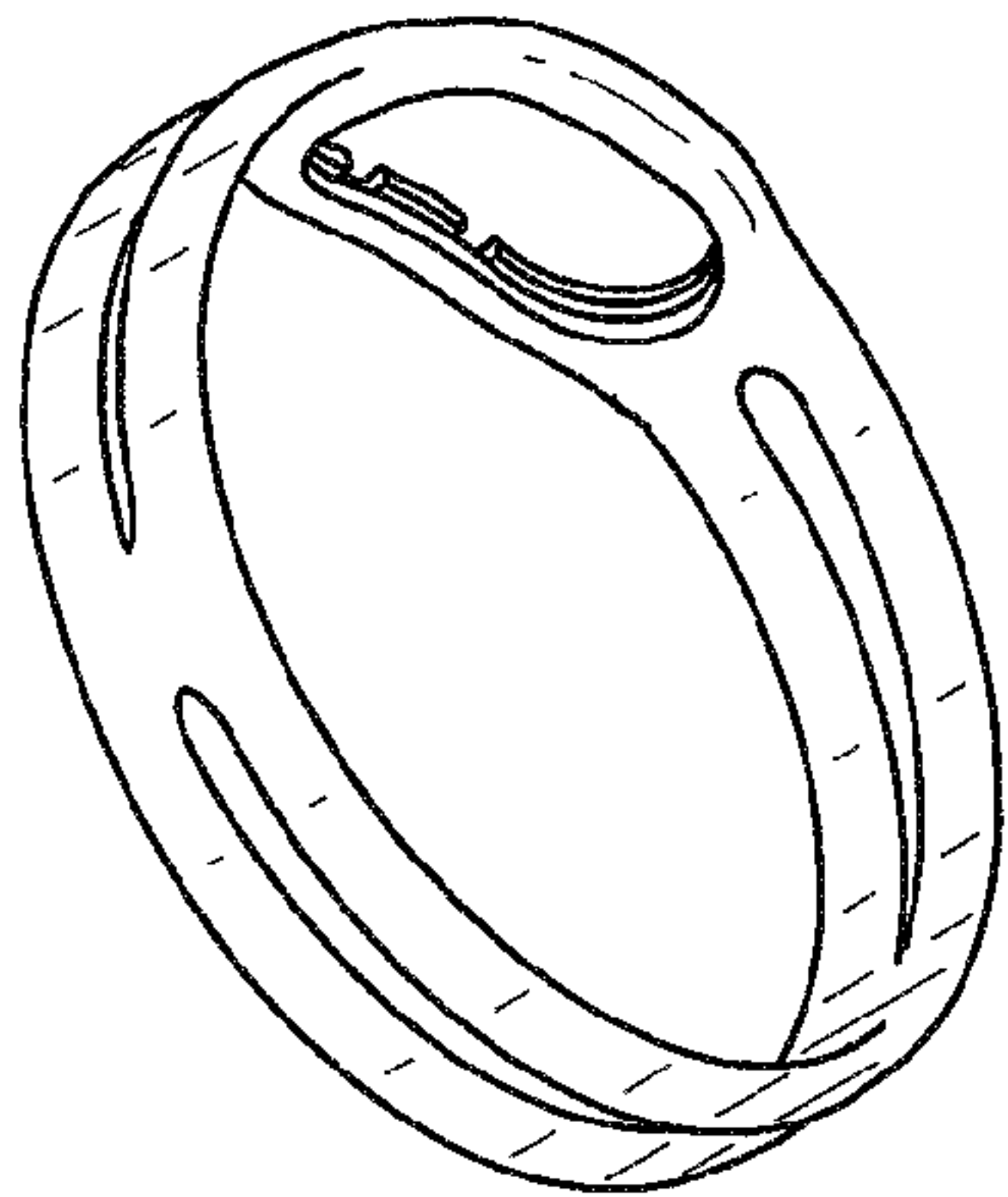

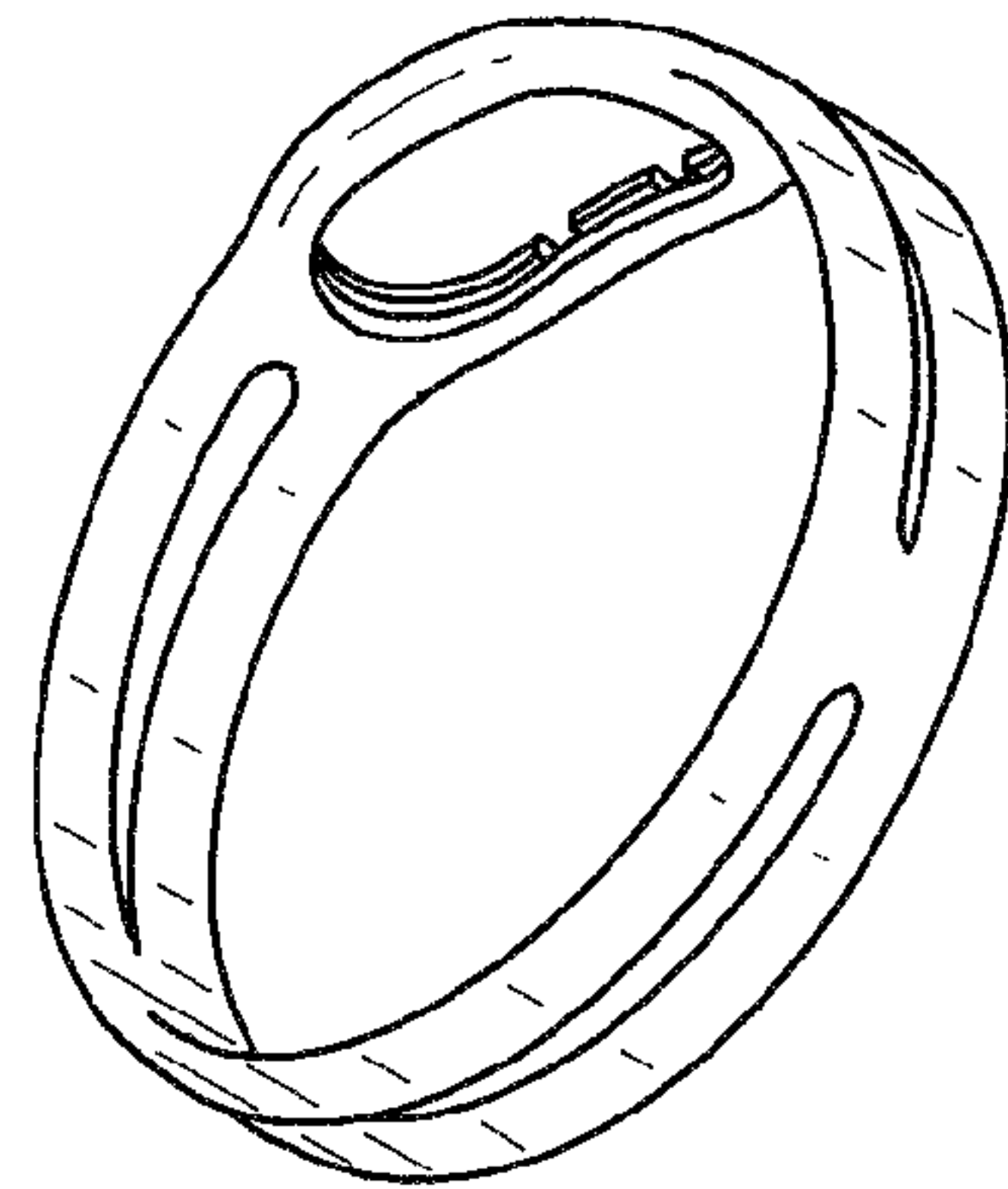
