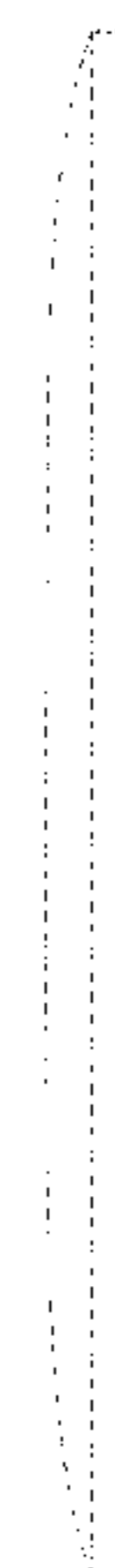
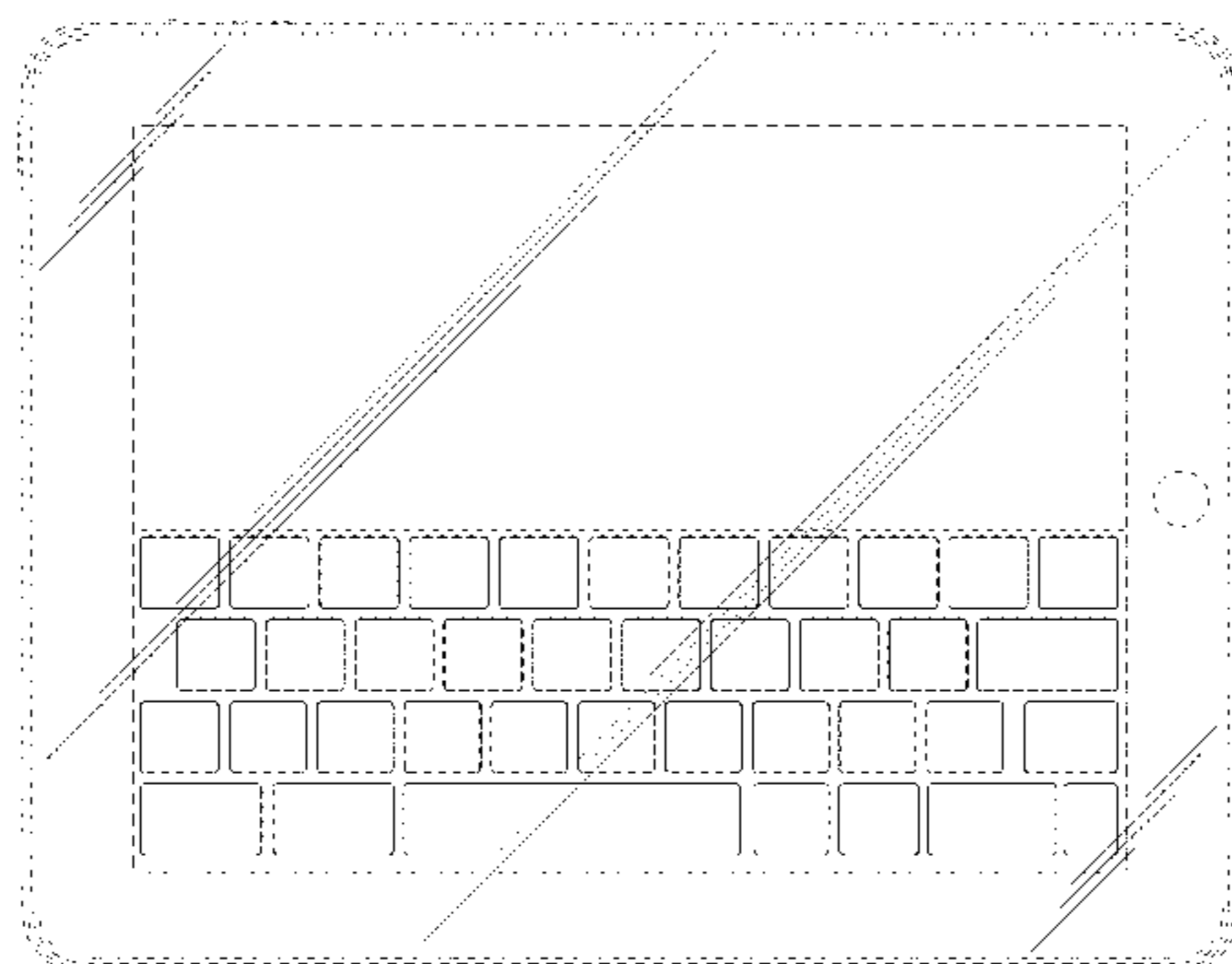

DESCRIPTION

FIG. 1 is a front view of a portable display device with graphical user interface showing our new design;

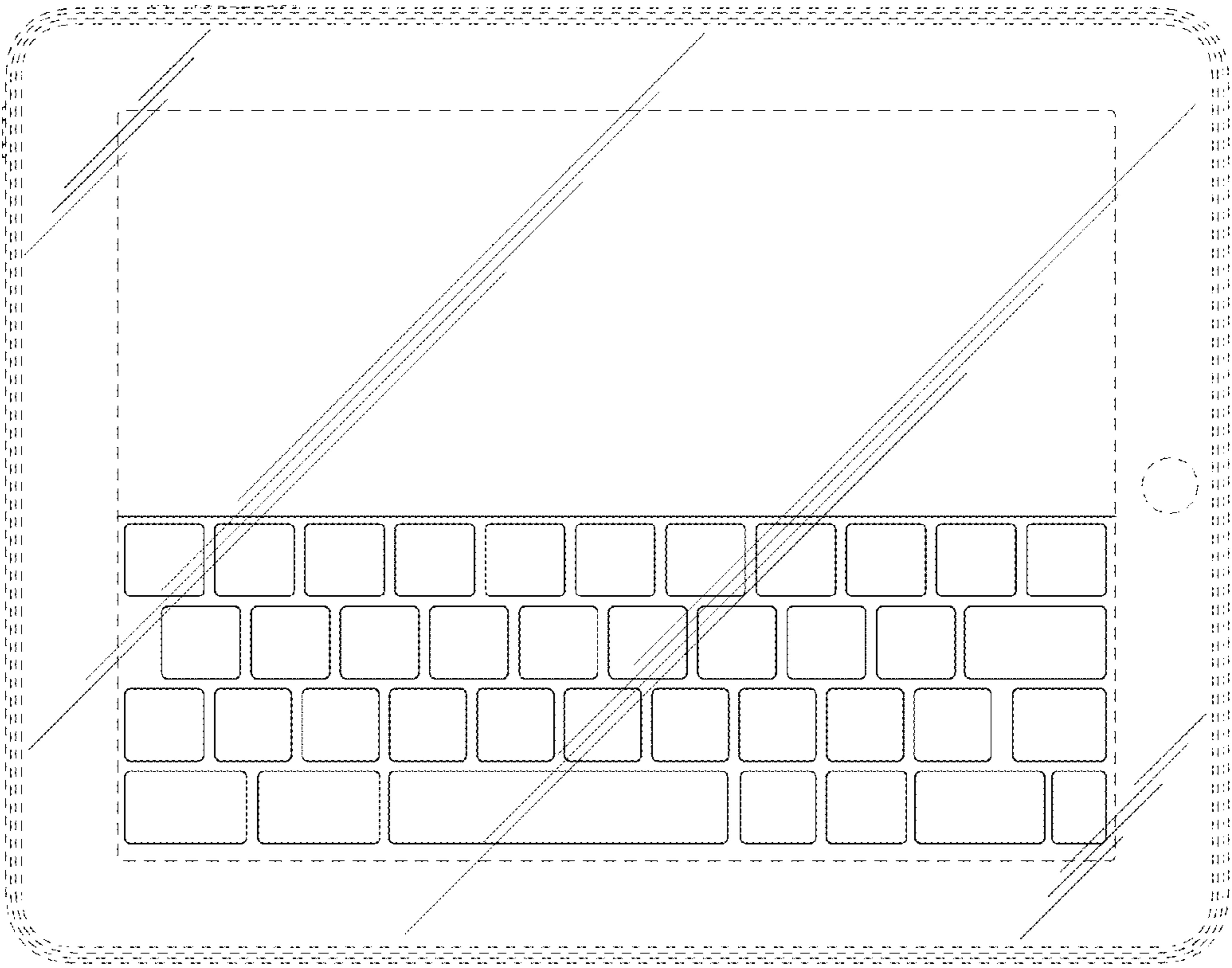

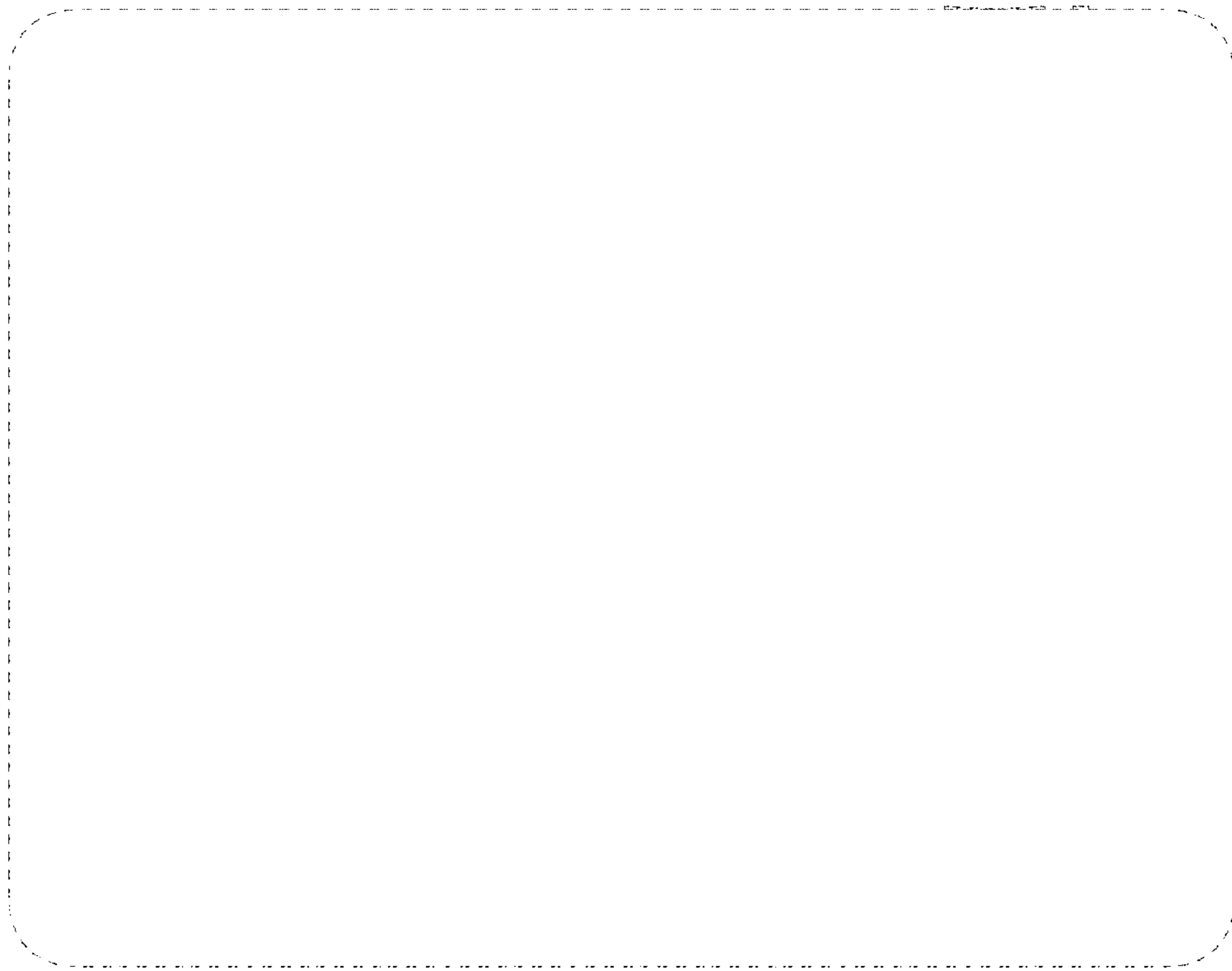

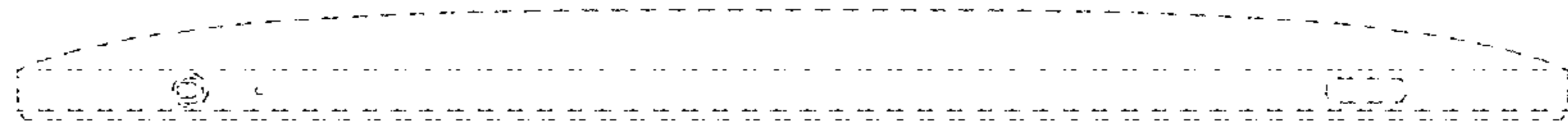

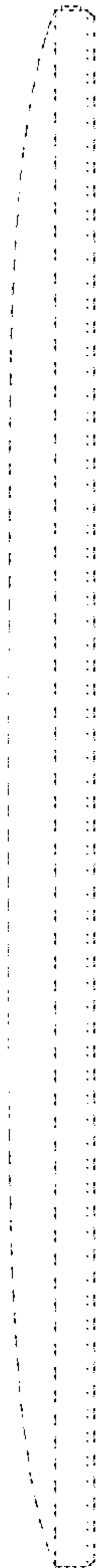

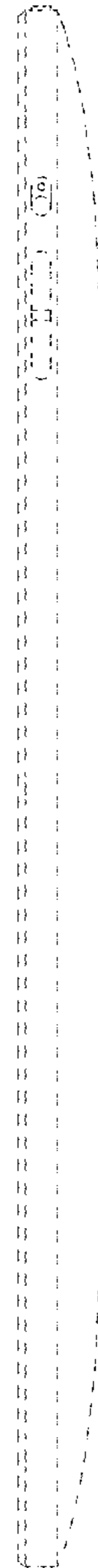

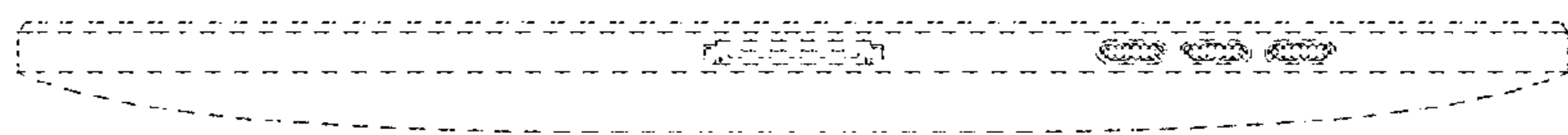

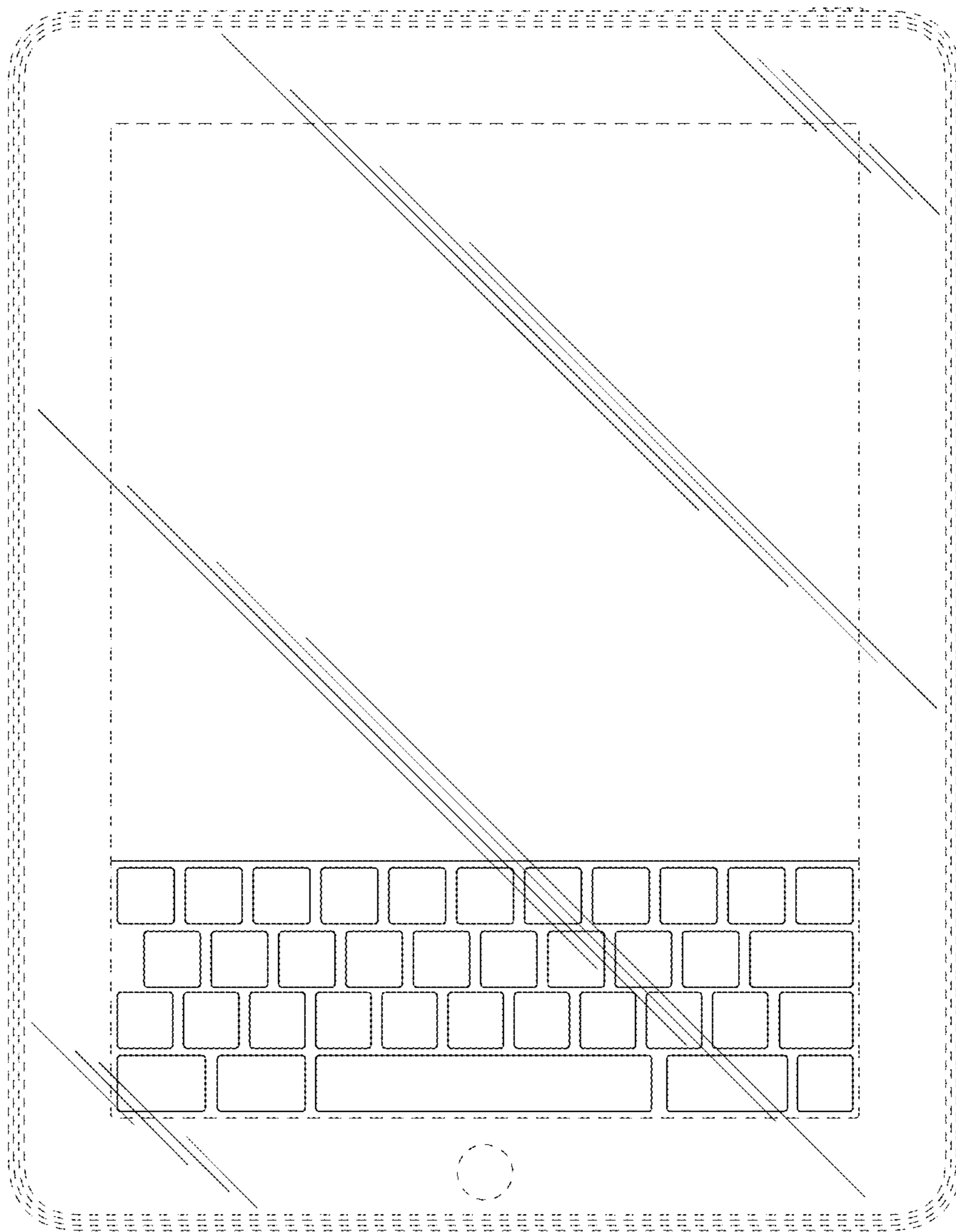

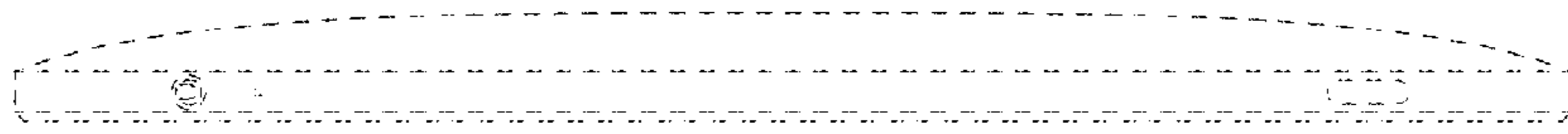

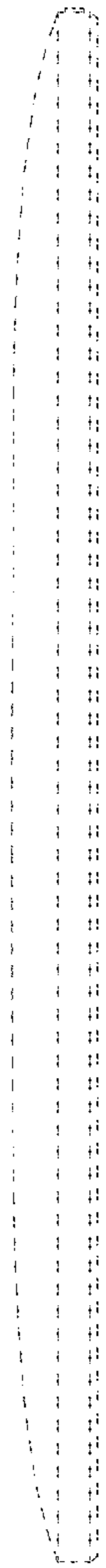

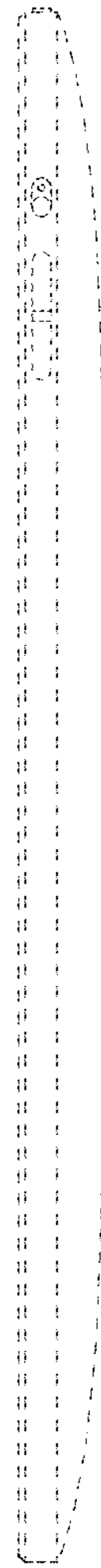

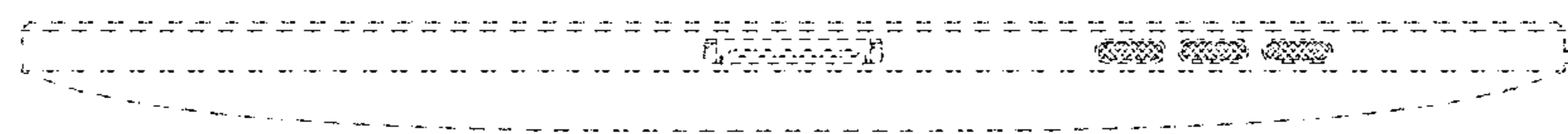
