FIG. 1 is a front view of a first embodiment of a portion of a display screen with a graphical user interface showing my new design;

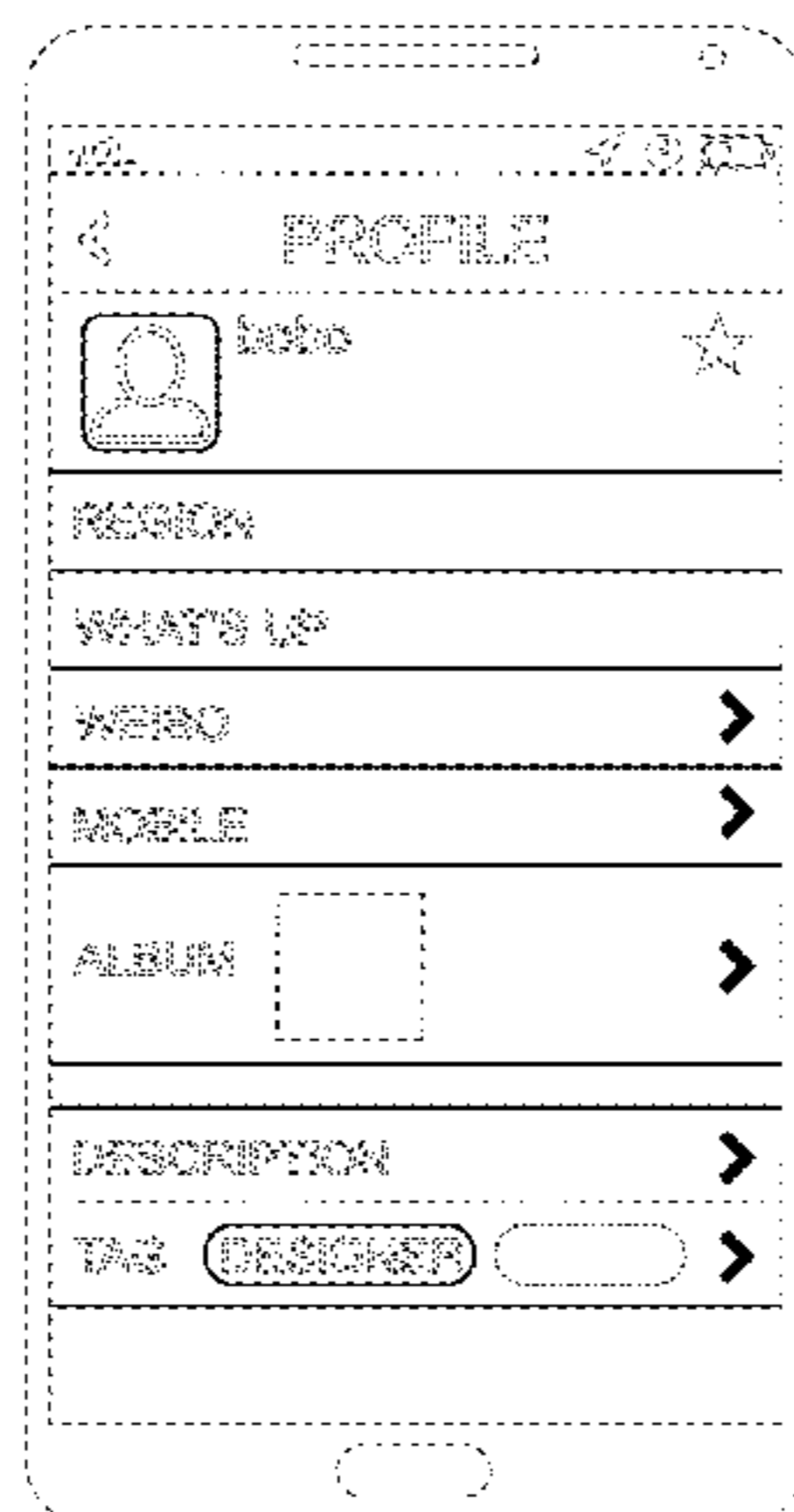
FIG. 2 is a front view of a second embodiment of a portion of a display screen with a graphical user interface showing my new design;

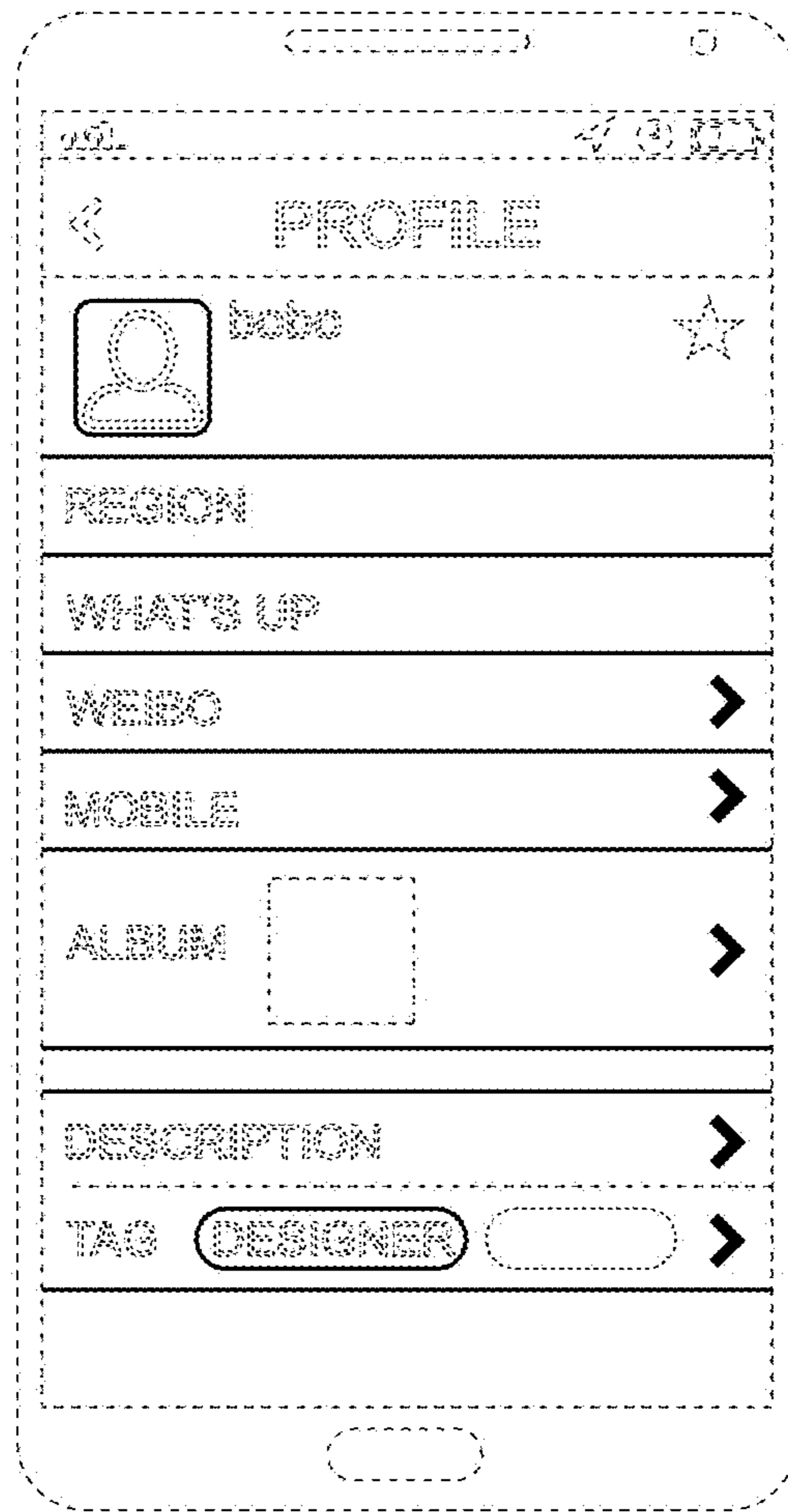

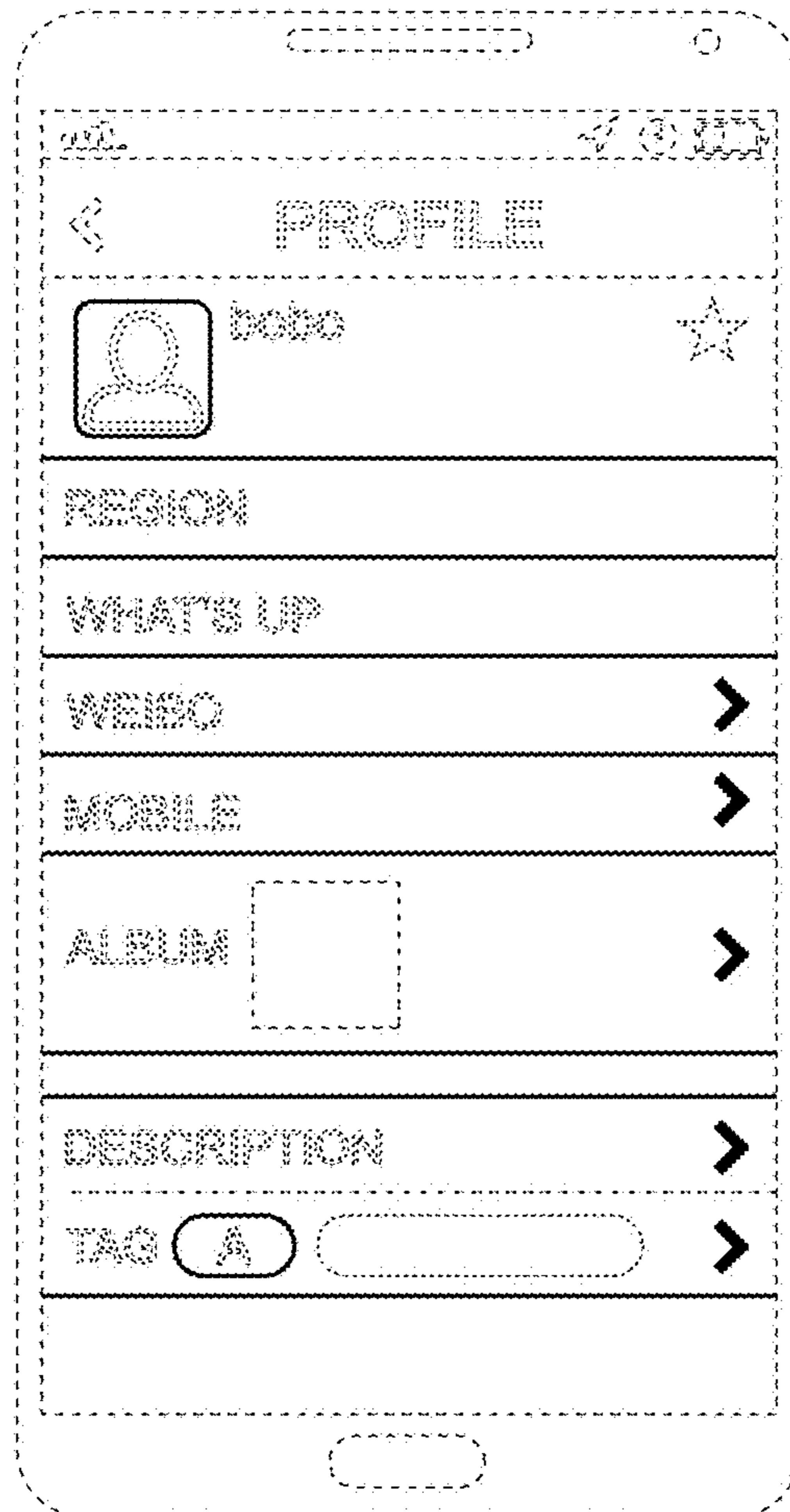

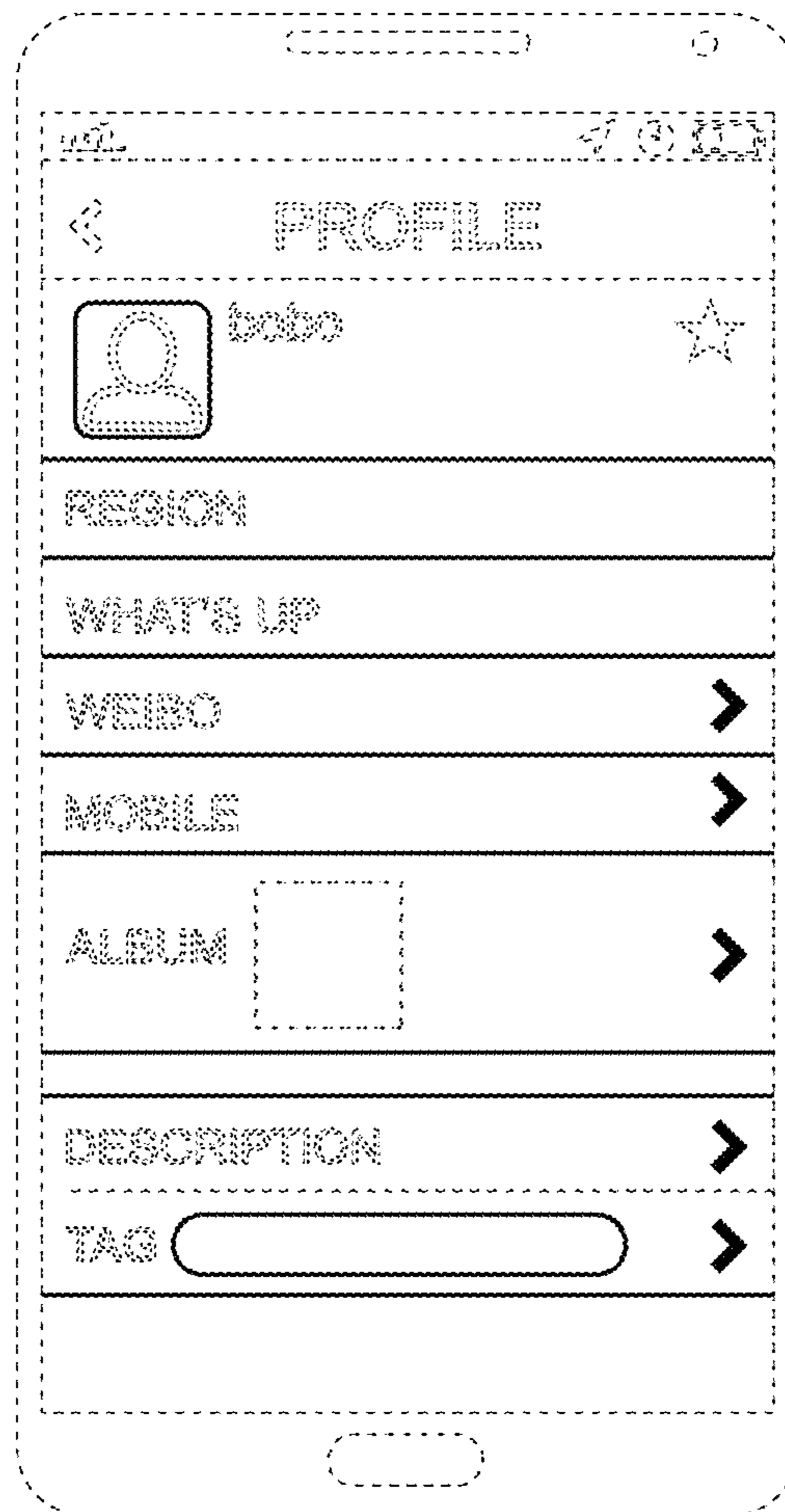

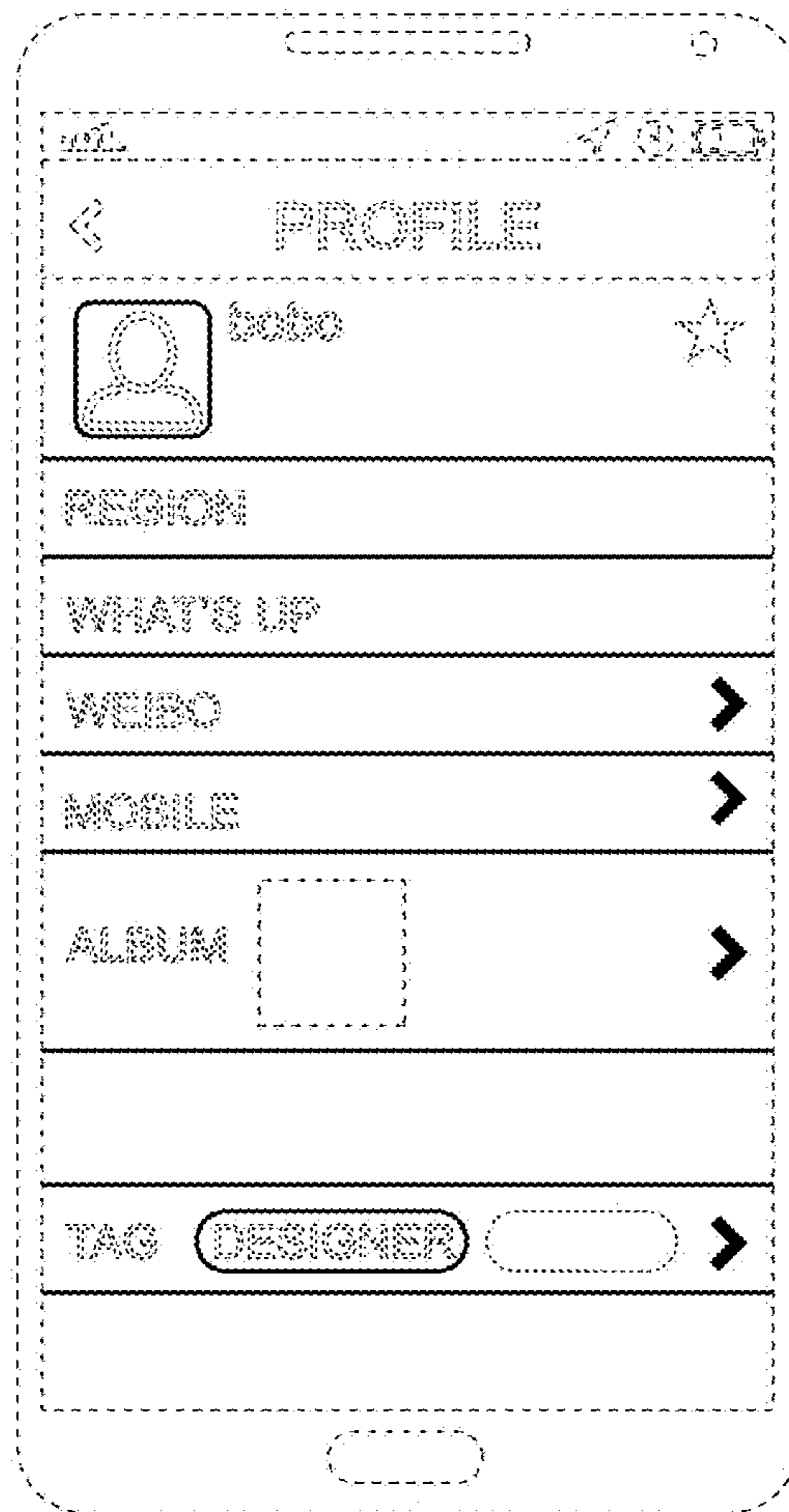
