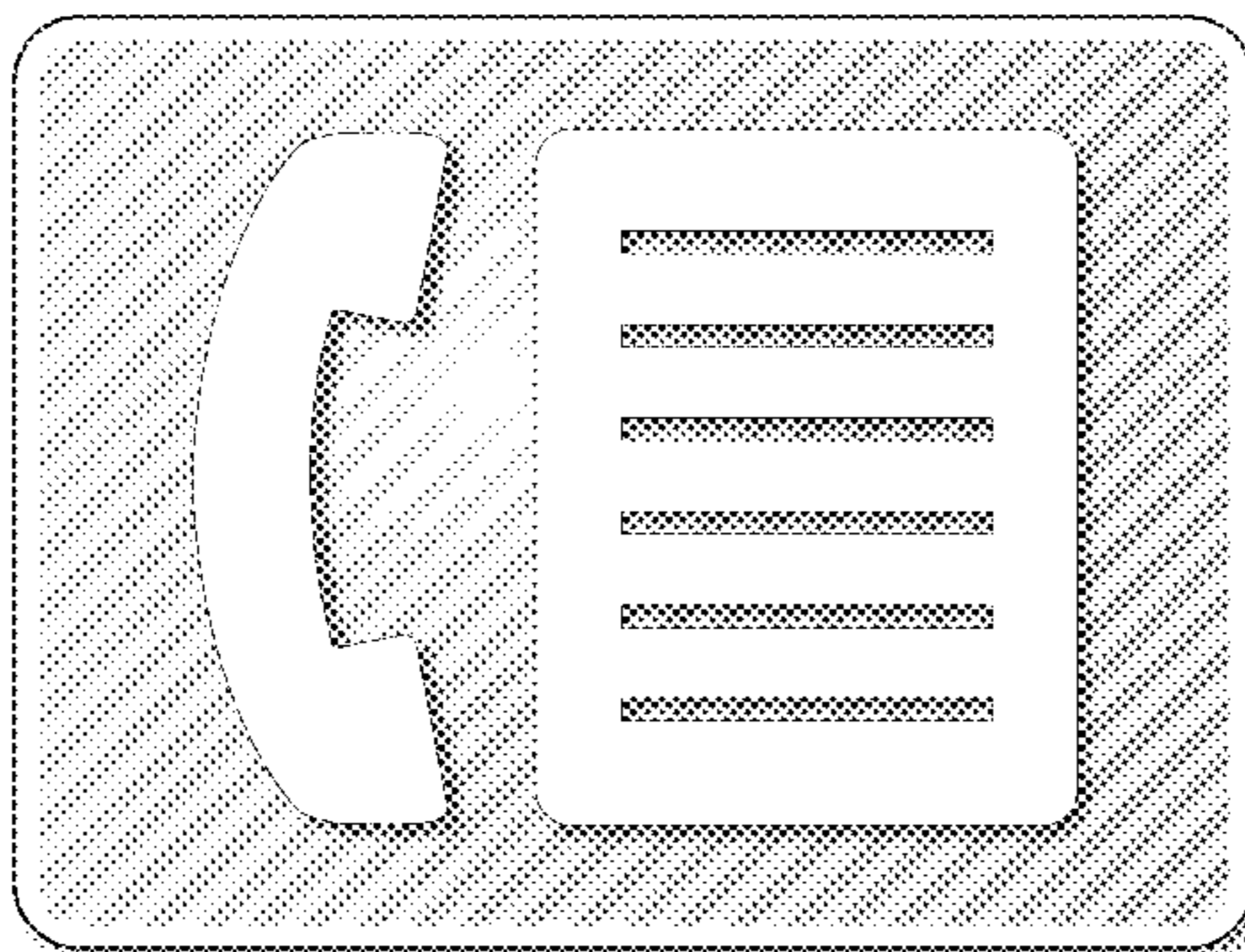
(57) **CLAIM**

The ornamental design for a screen with fax function icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the screen with fax function icon showing the fax function icon enlarged and separate for clarity of illustration; and,
FIG. 2 is a front view of a screen with fax function icon showing the new design.
The broken lines showing the screen and portions of the graphical user interface in FIG. 2 are included for the purpose of illustrating portions of the article and form no part of the claimed design.

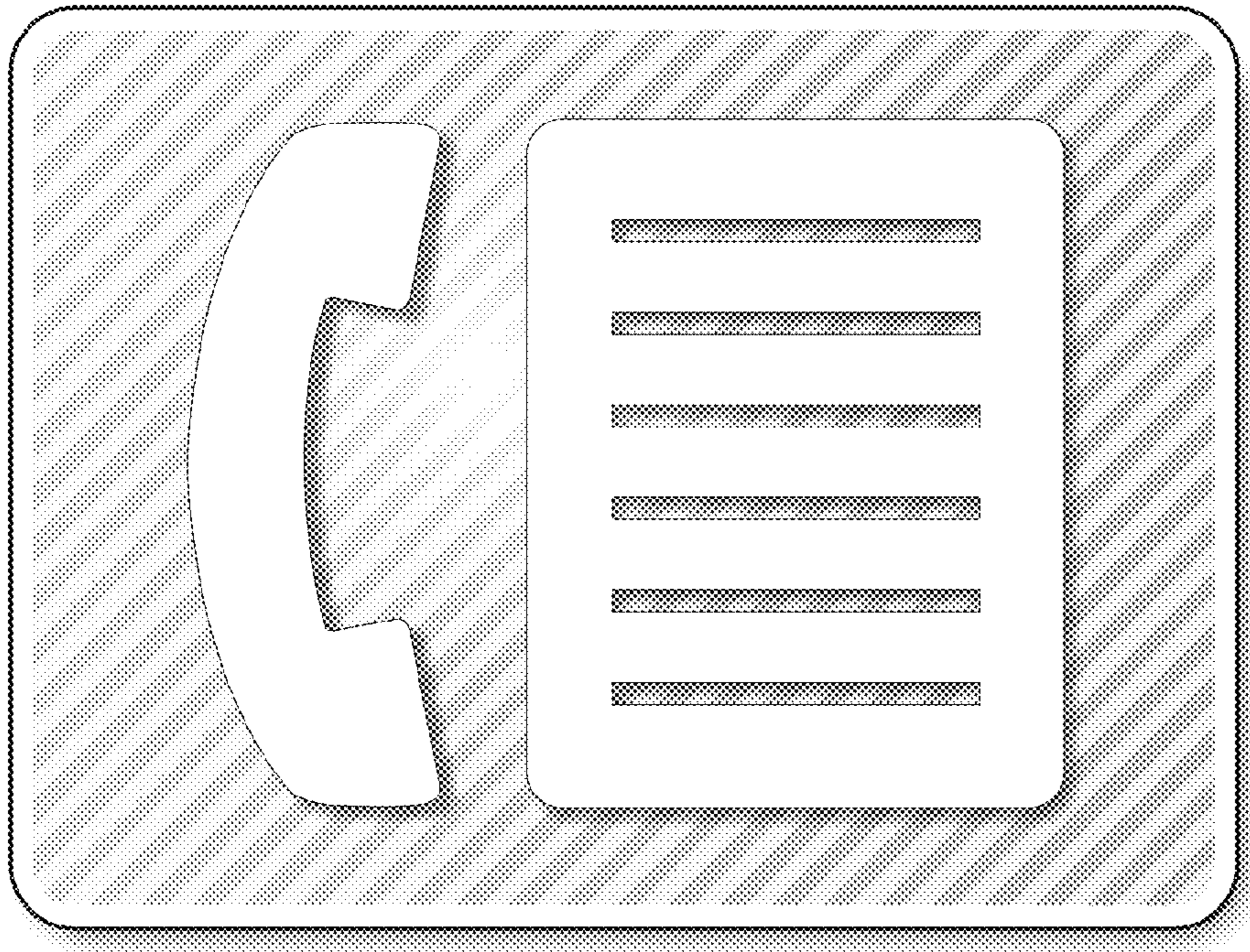

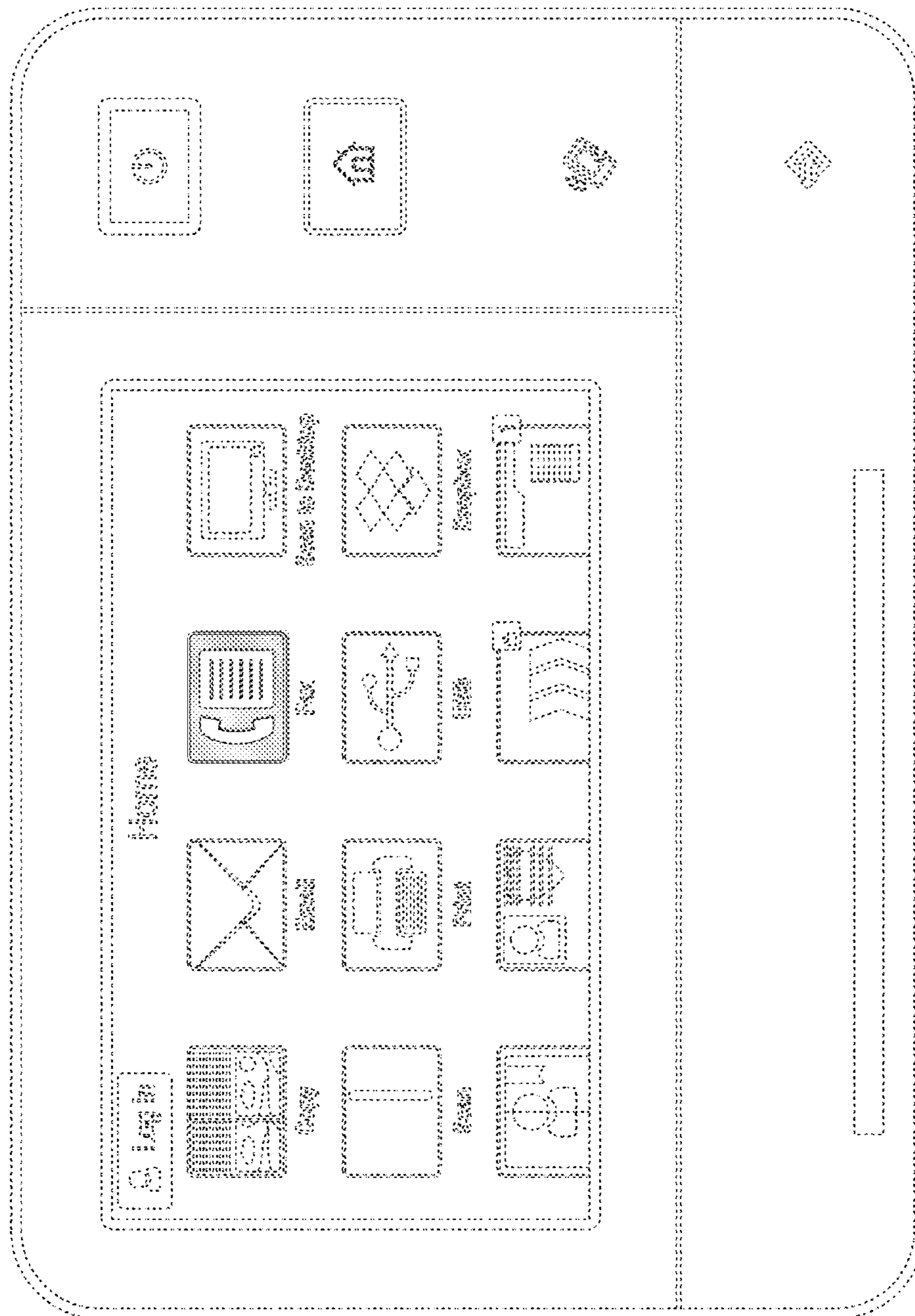
