(57) **CLAIM**

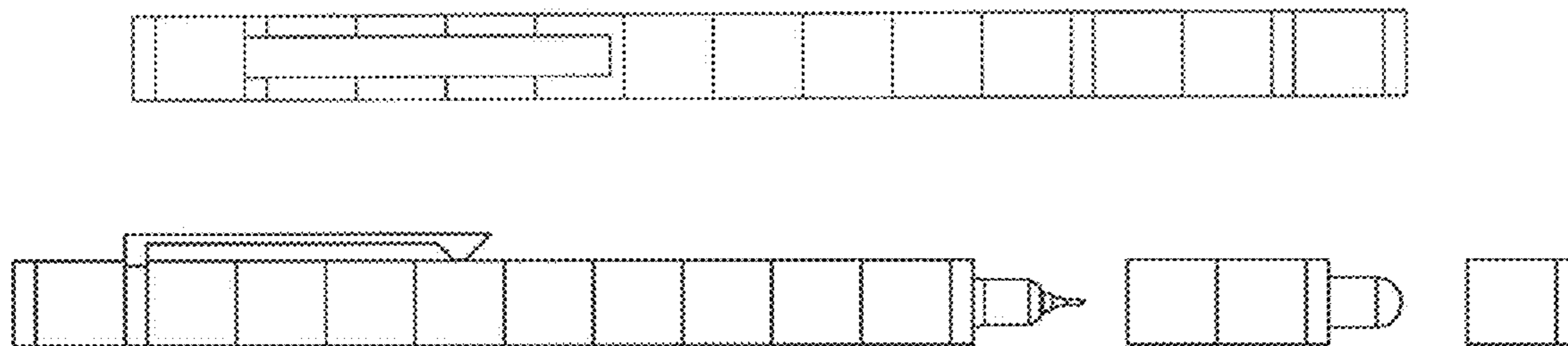
The ornamental design for the pen, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of the pen of the present design; FIG. 2 is an alternate side elevation view of the pen of FIG. 1; FIG. 3 is a top plan view of the pen of FIG. 1; FIG. 4 is an exploded side elevation view of the pen of FIG. 1; FIG. 5 is a perspective view of the pen of FIG. 1 in closed condition; and, FIG. 6 is an exploded perspective view of the pen of FIG. 1.

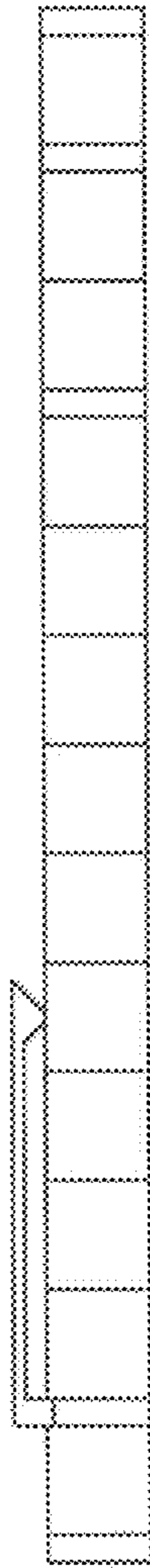

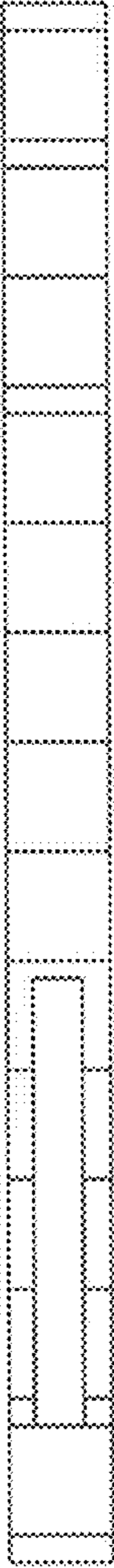

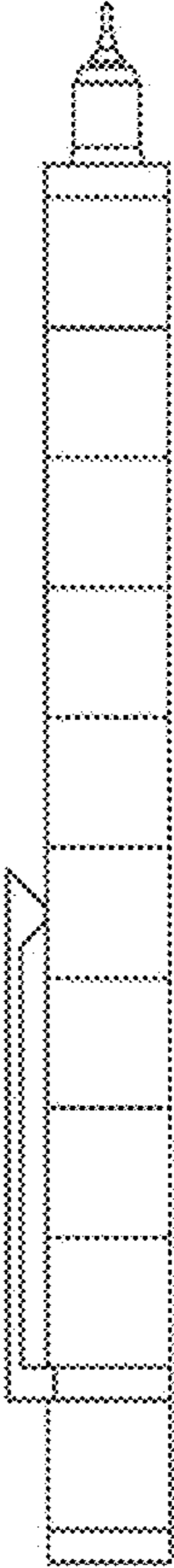

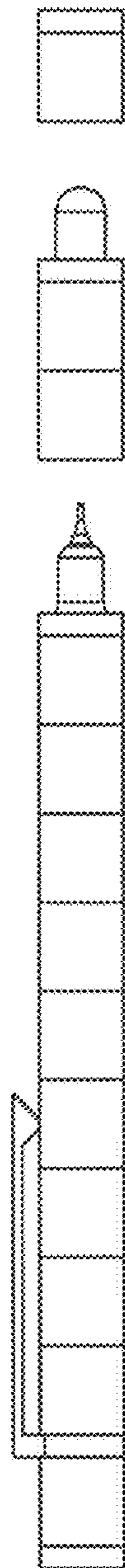
