(57) **CLAIM**

The ornamental design for a taillight for a vehicle, as shown and described.

DESCRIPTION

This application contains subject matter related to the following co-pending U.S. design patent applications: Application Ser. No. 29/507,829, filed herewith and entitled "Vehicle, Toy, and/or Replicas Thereof"; and Application Ser. No. 29/507,831, filed herewith and entitled "Rear Portion of a Vehicle, Toy, and/or Replicas Thereof".

FIG. 1 is a left perspective view of a first embodiment of a taillight for a vehicle according to the design; FIG. 2 is a front view thereof; and FIG. 3 is a left side view thereof.

FIG. 4 is a right perspective view of taillight for a vehicle according to the design, with the taillight for a vehicle for the opposite side of the vehicle being depicted in the first embodiment thereof;

FIG. 5 is a front view thereof; and, FIG. 6 is a right side view thereof.

The broken lines are for illustrative purposes only and form no part of the claimed design. Also enclosed is a set of photographs of an embodiment of the design.

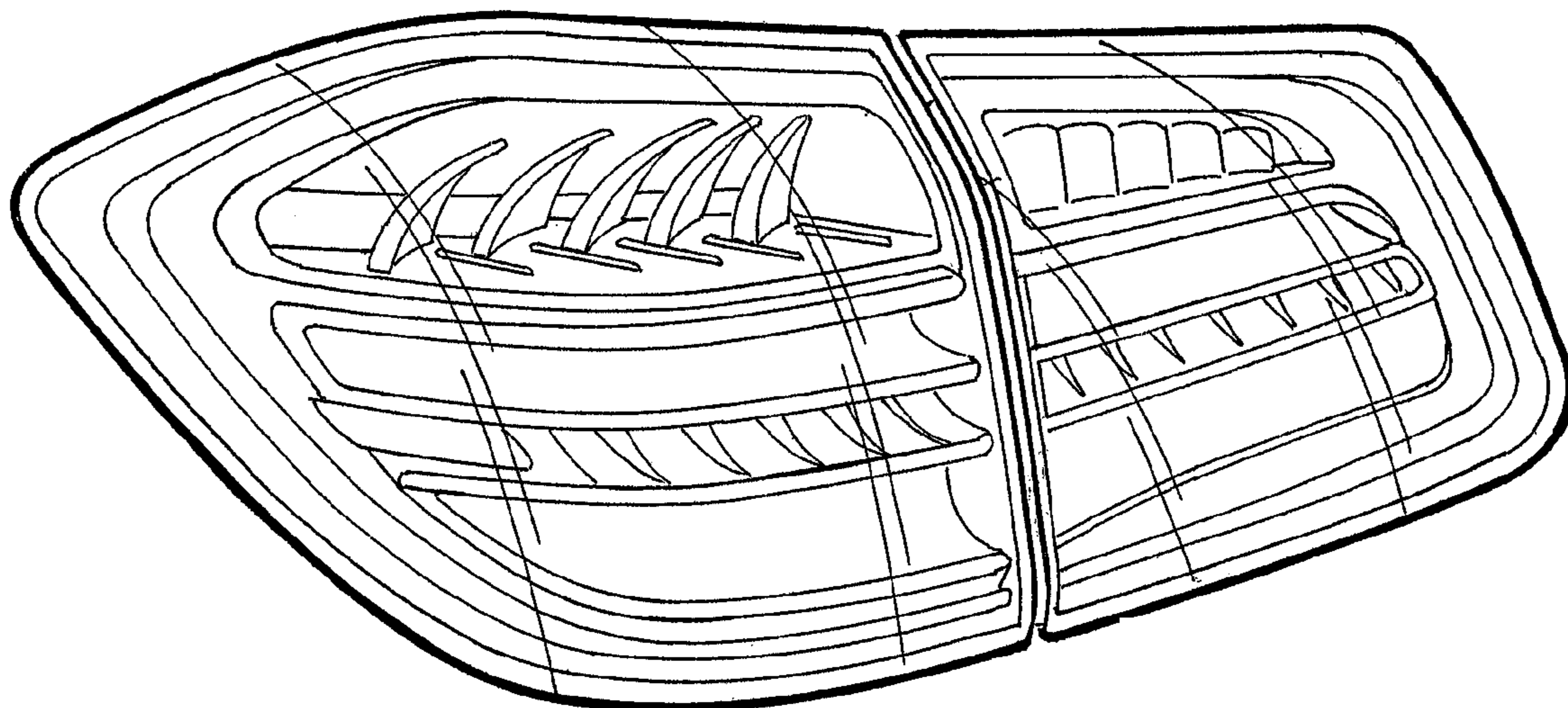

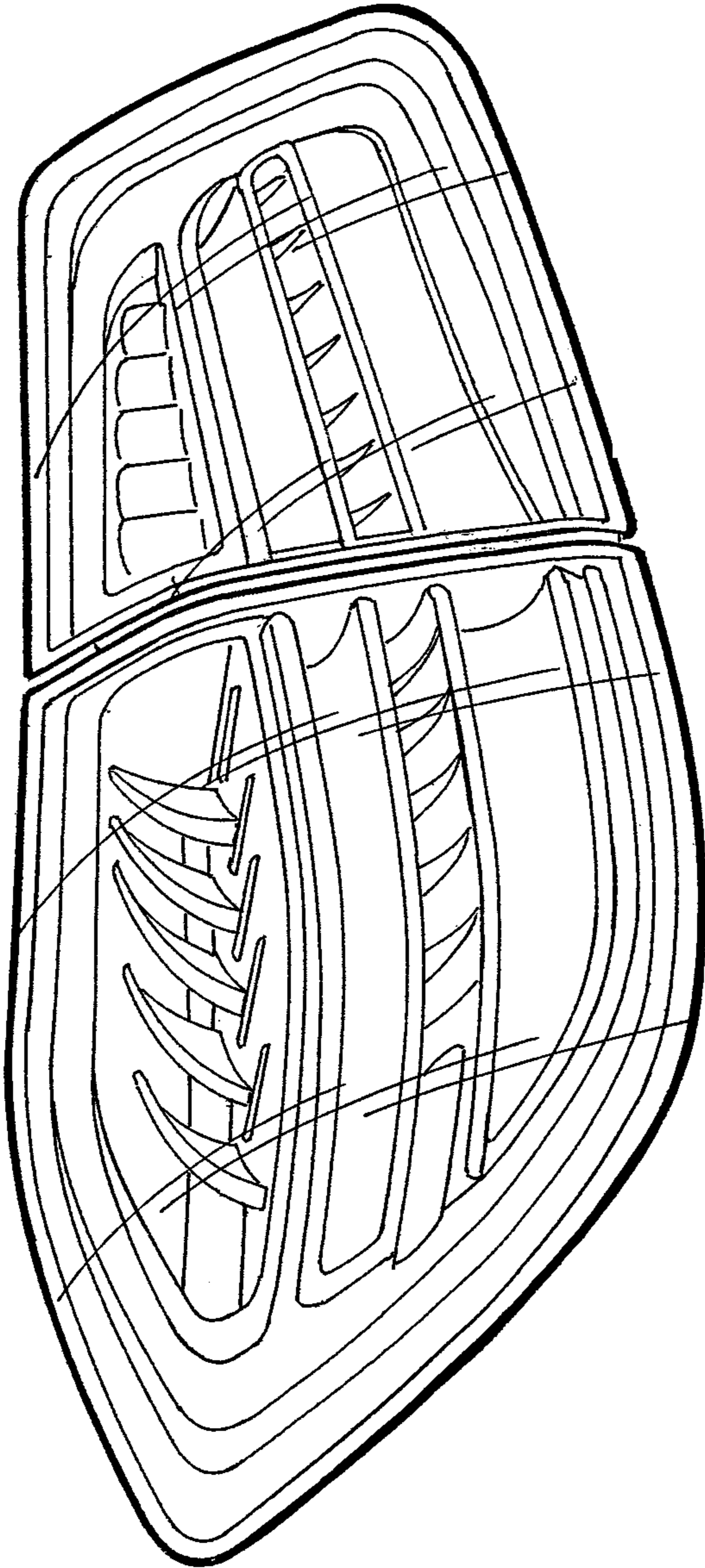

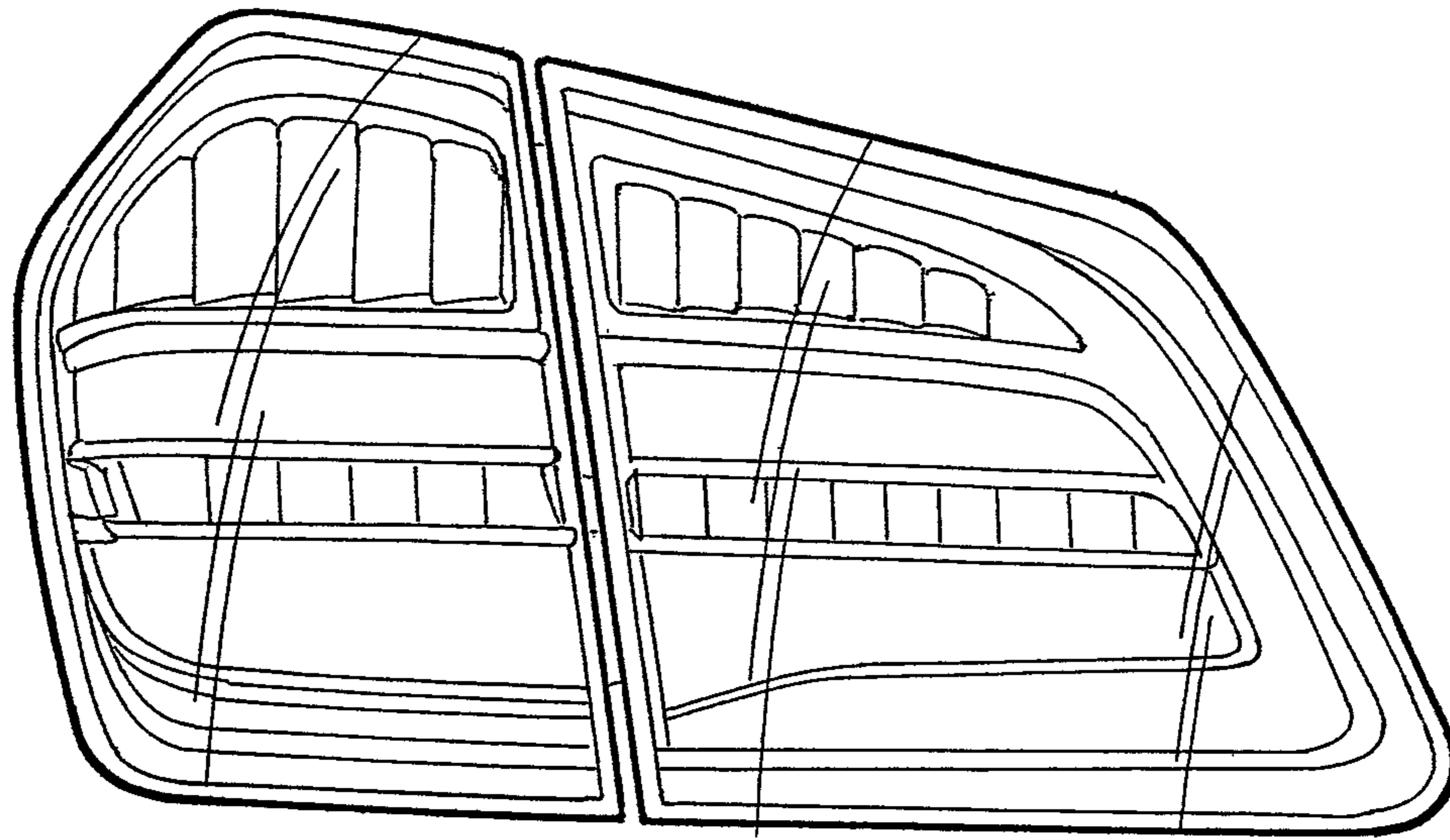

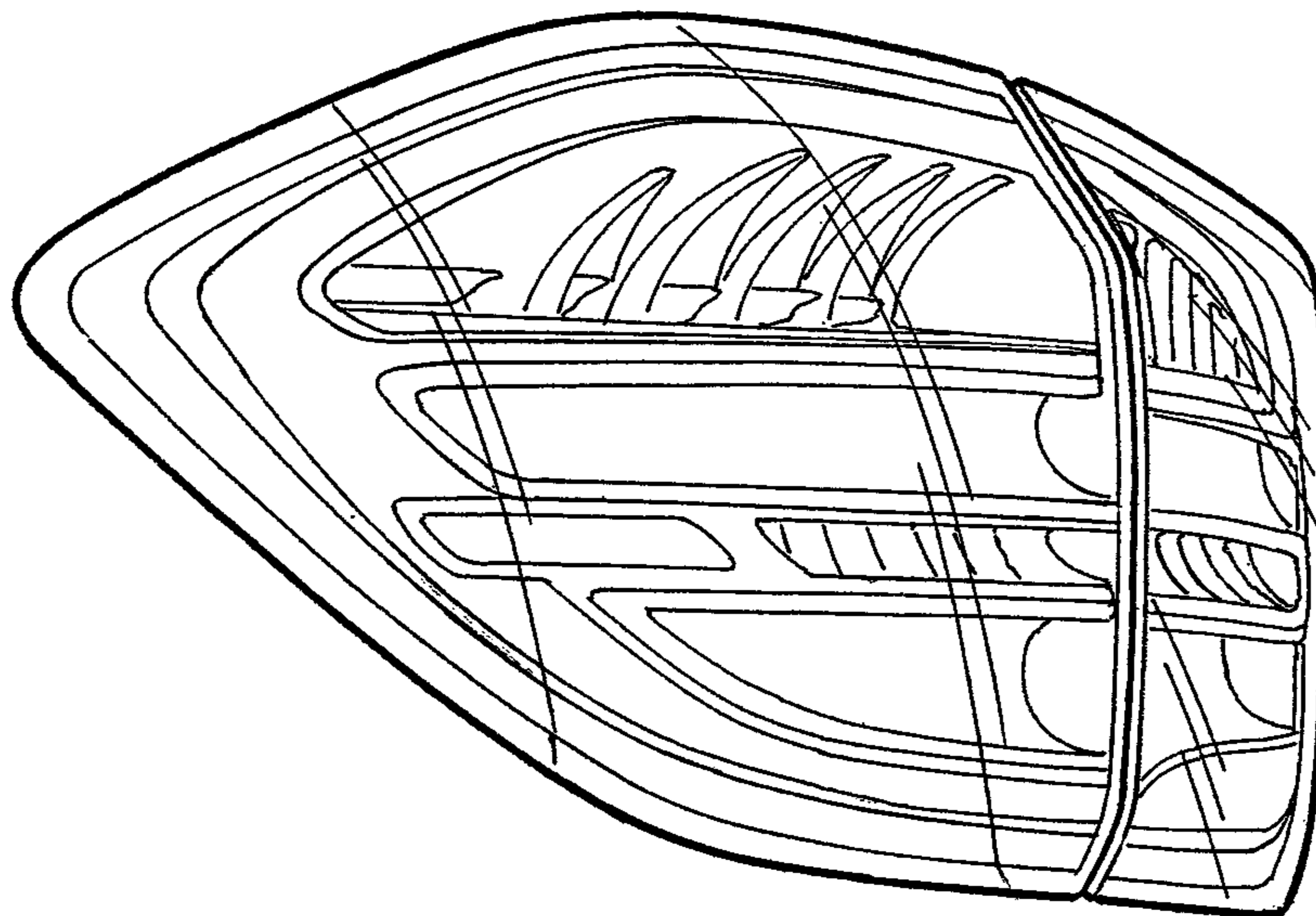

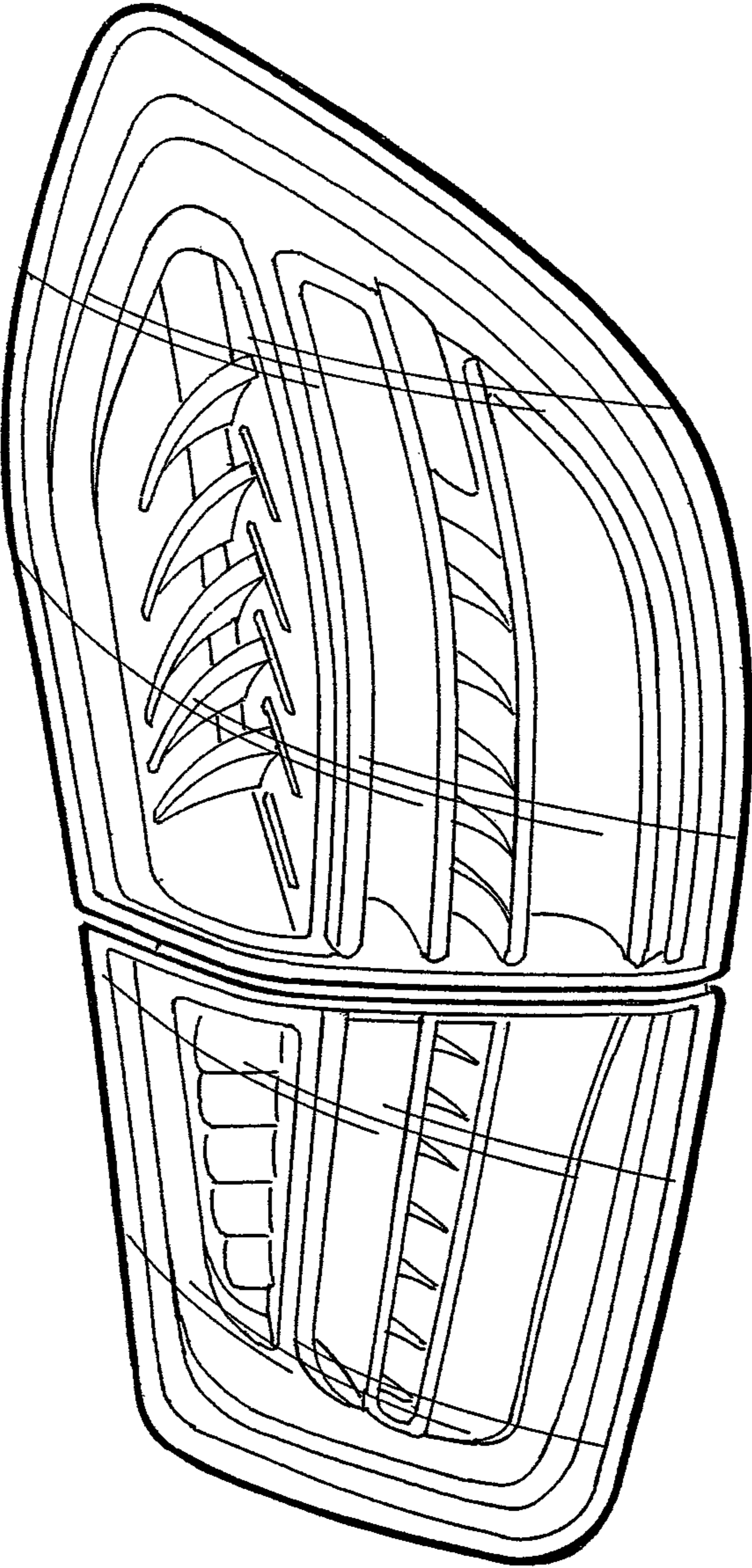

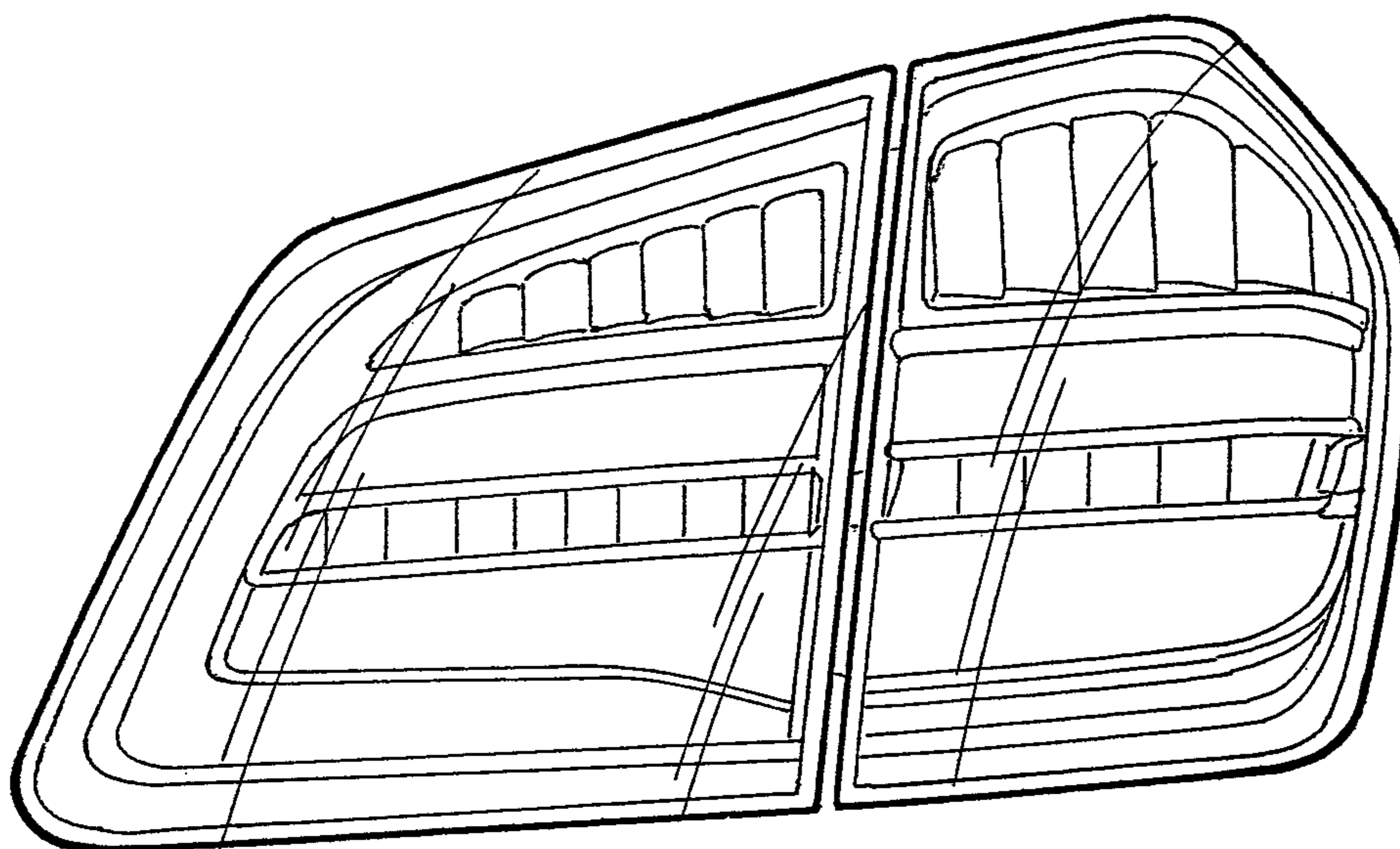

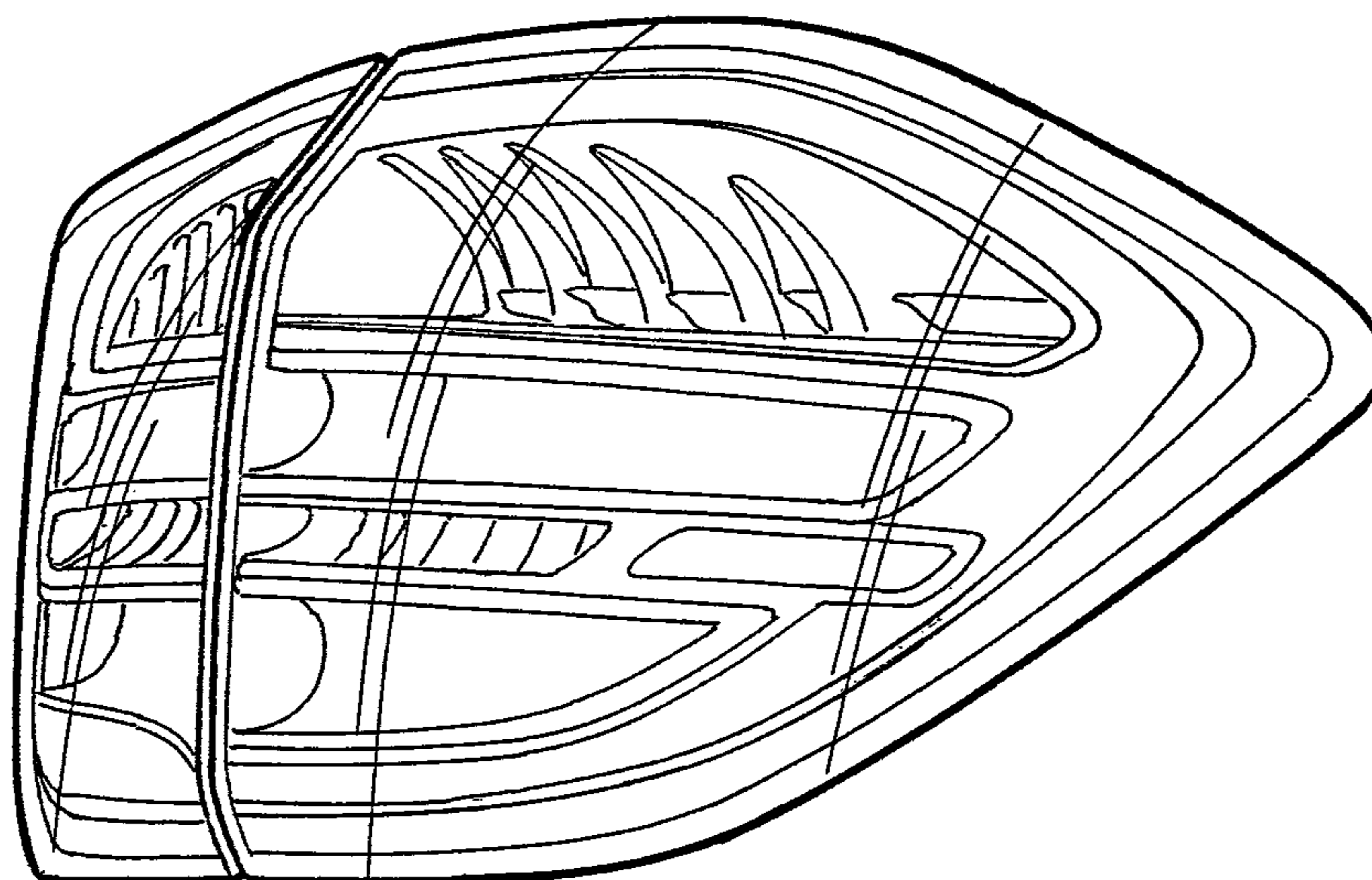
