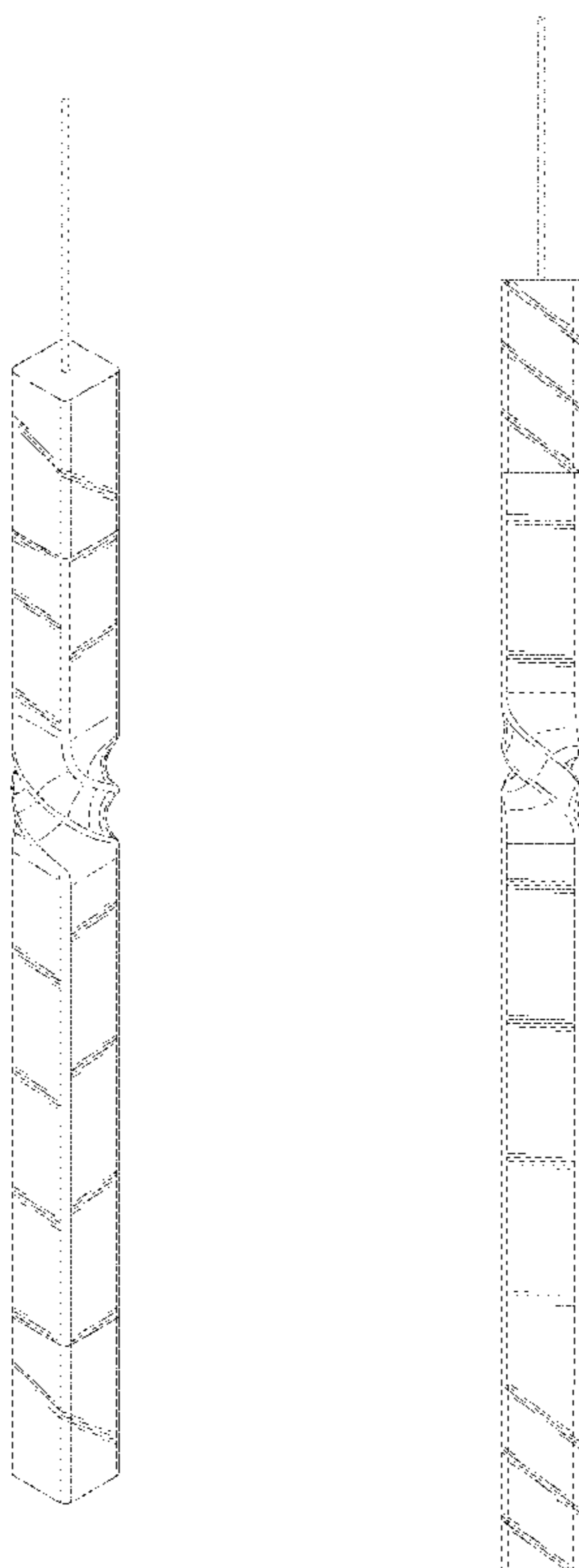

**DESCRIPTION**

FIG. 1 is a perspective view of the lamp according to the present invention;  
FIG. 2 is a front view of the lamp thereof;

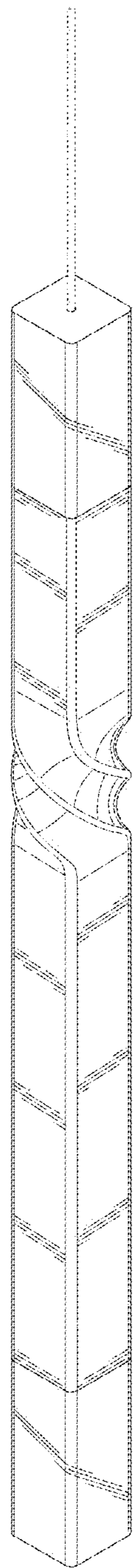

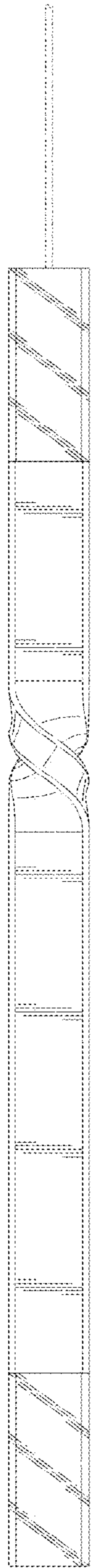

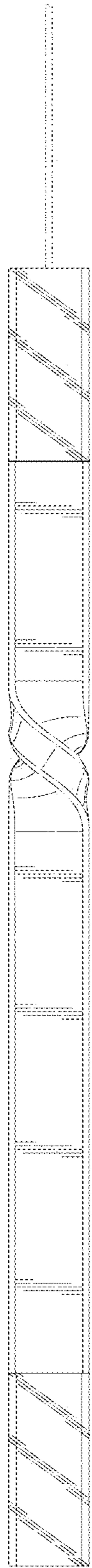

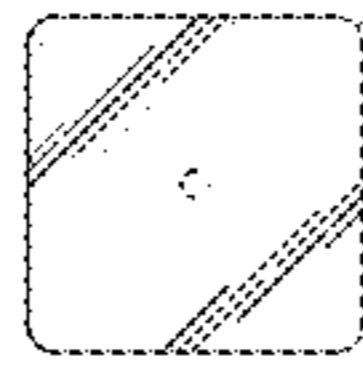

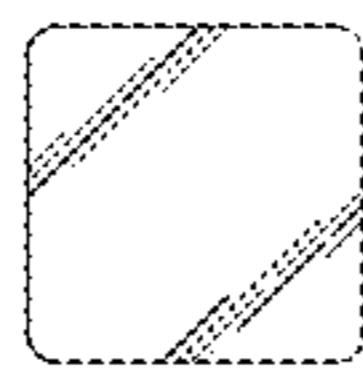
