The broken lines are intended to depict environmental subject matter (such as stitching and a zipper) and form no part of the claimed design. The lining of the center window represents a transparent surface. Any parts of the portable electronic device carrier that are hidden from view or that are not clearly disclosed in the drawings are not part of the claimed design.

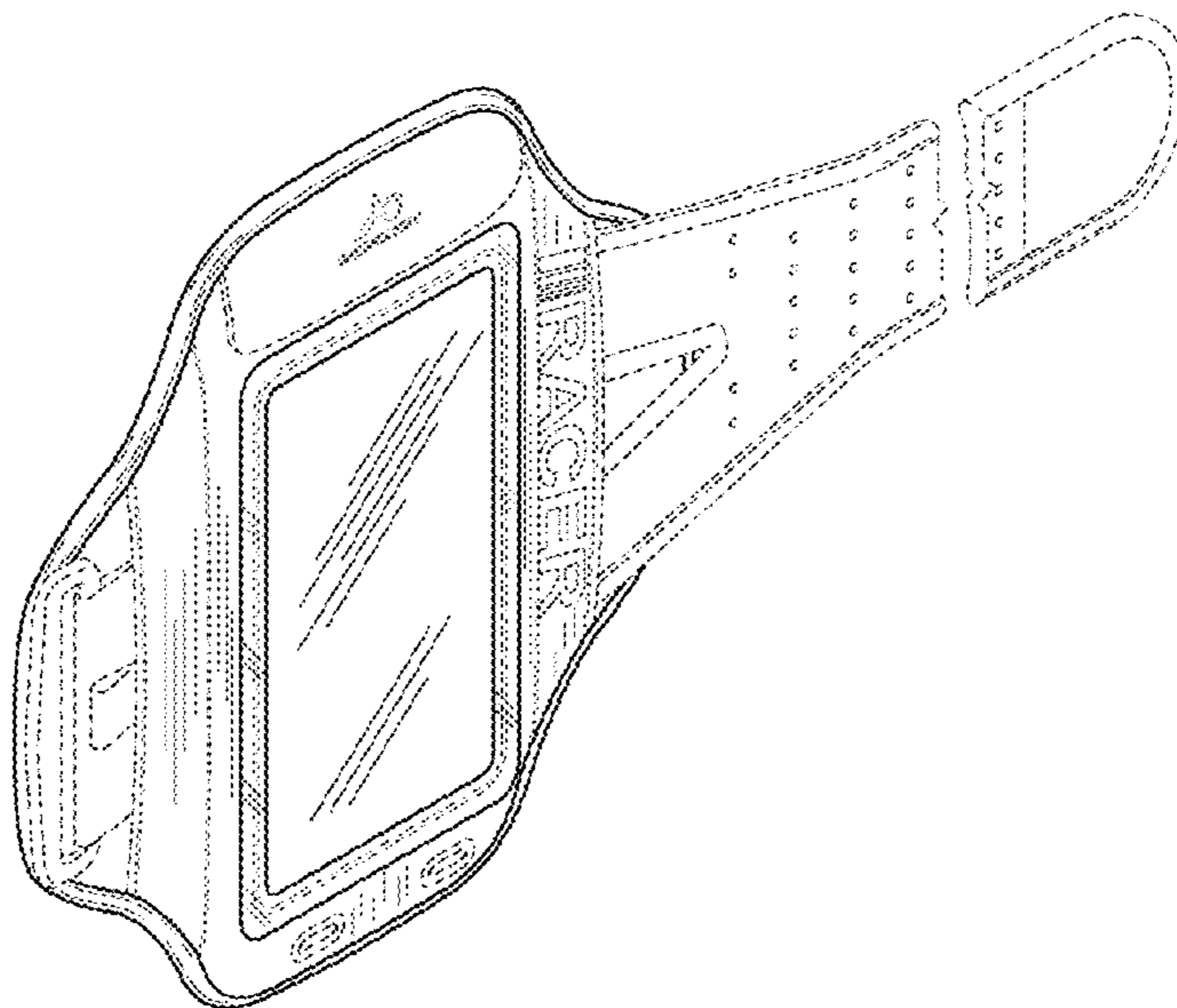

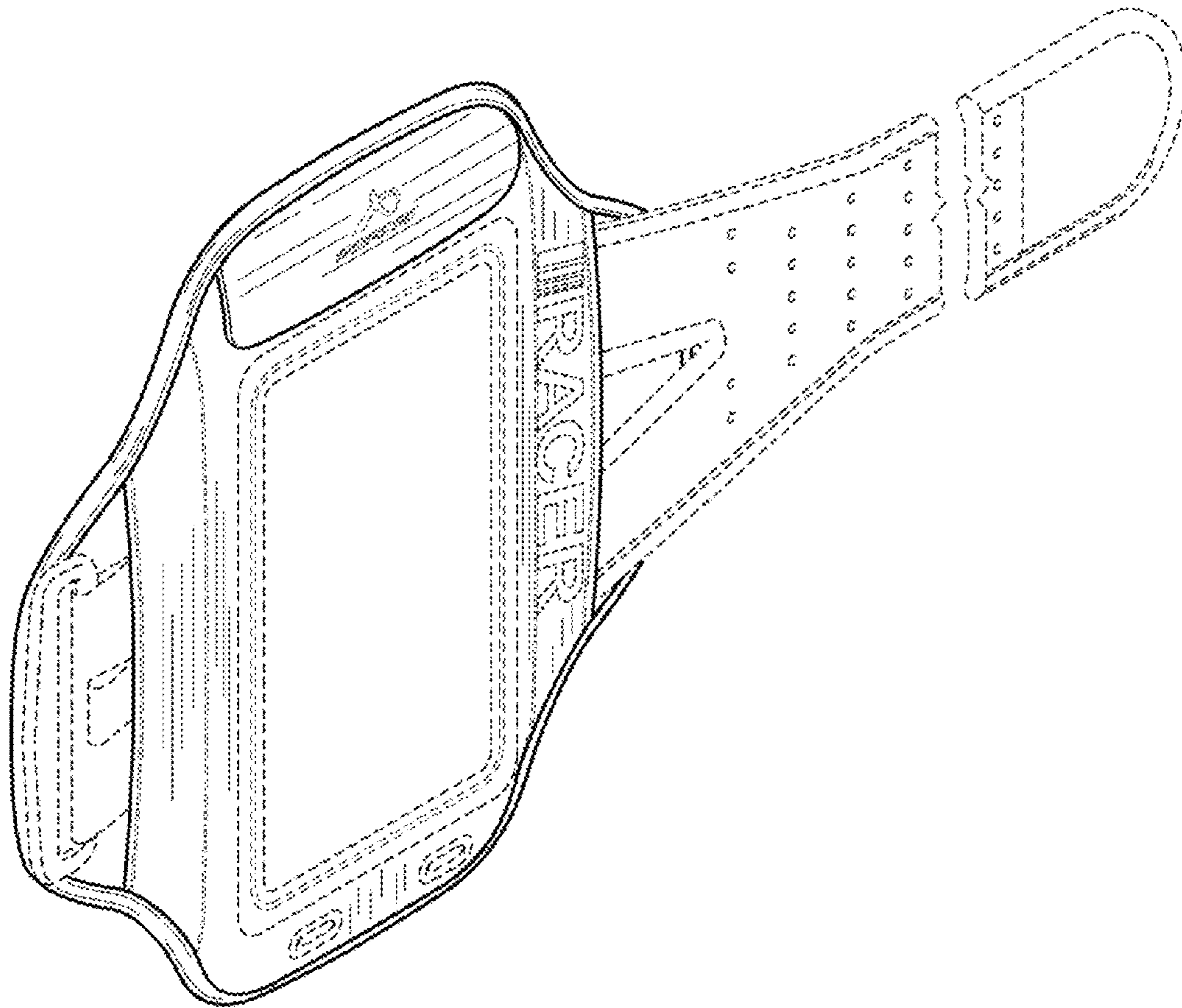

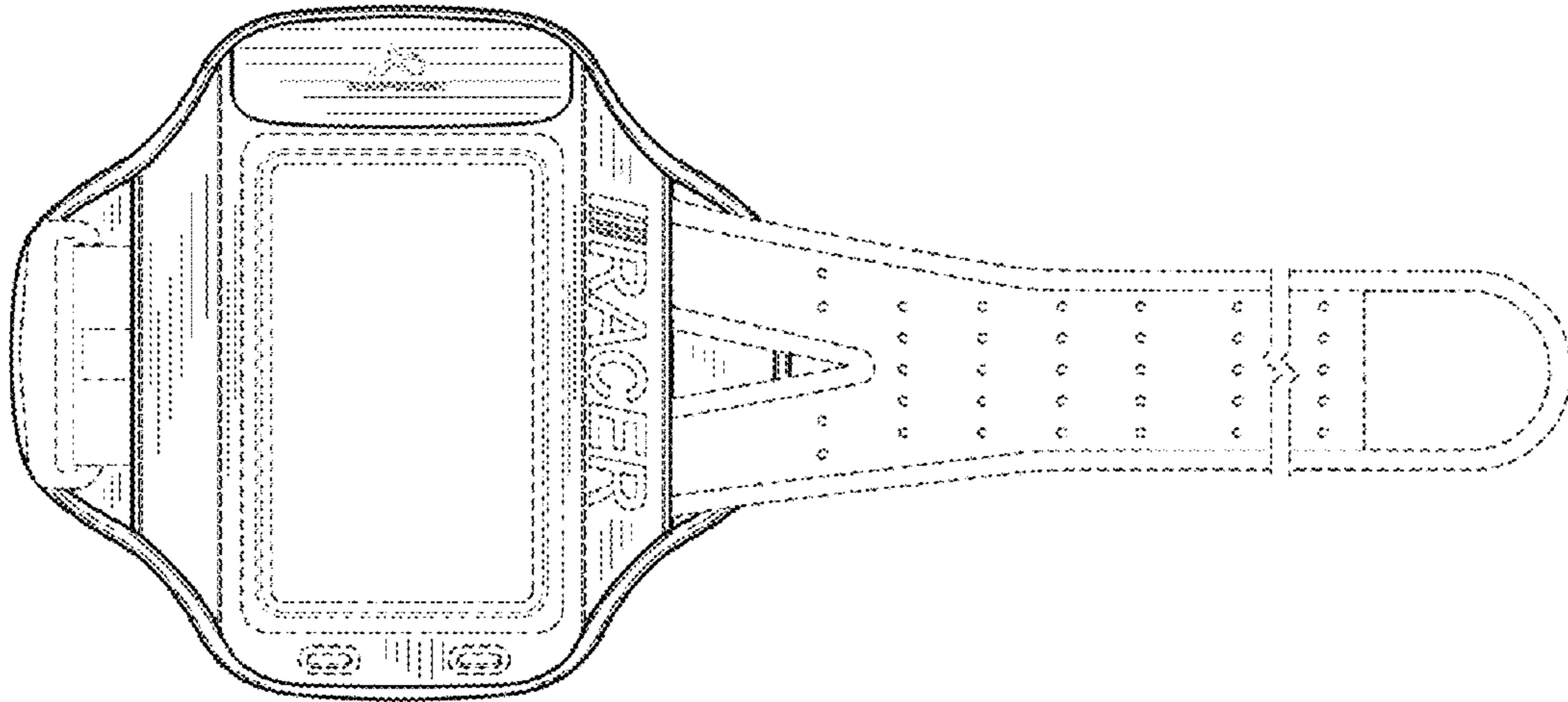

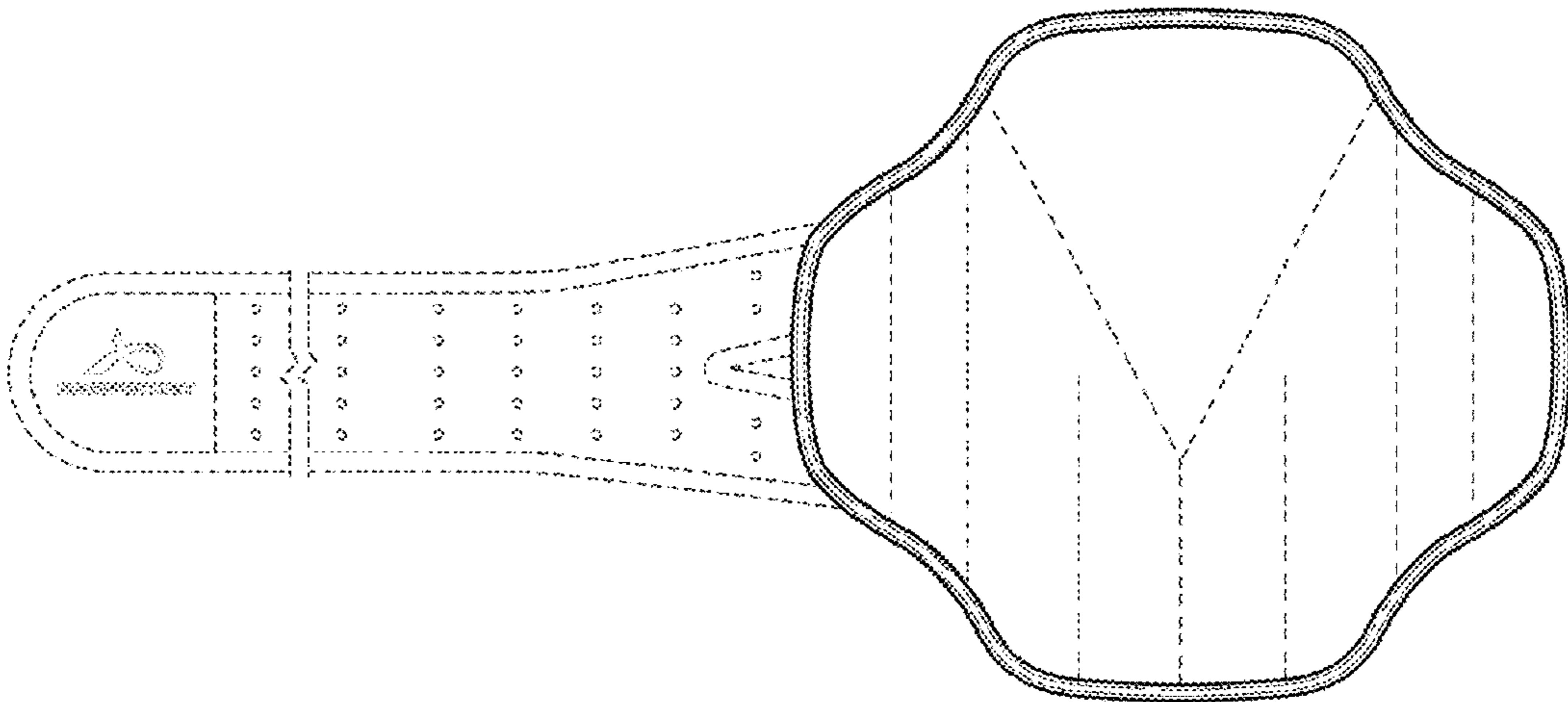

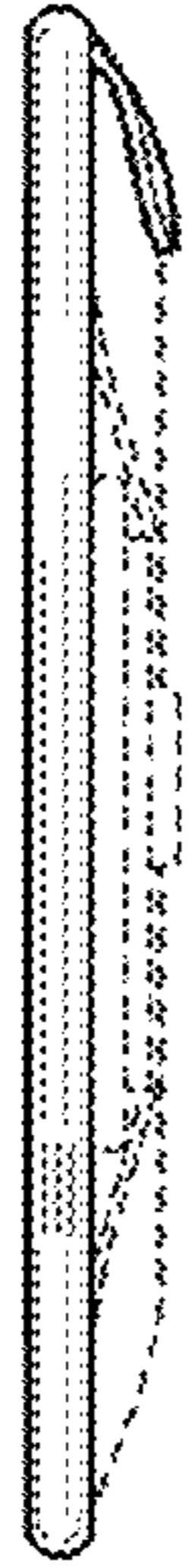

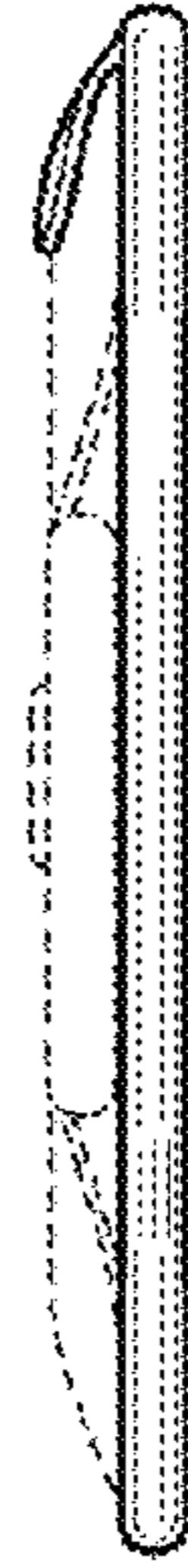

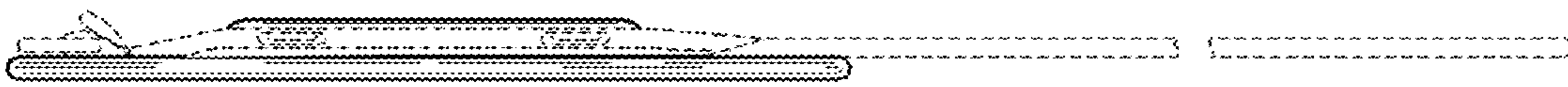

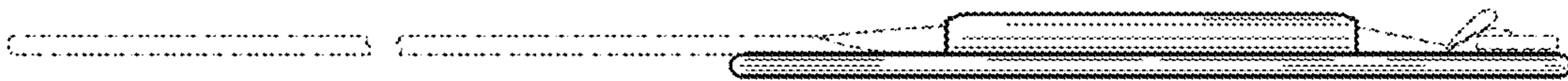

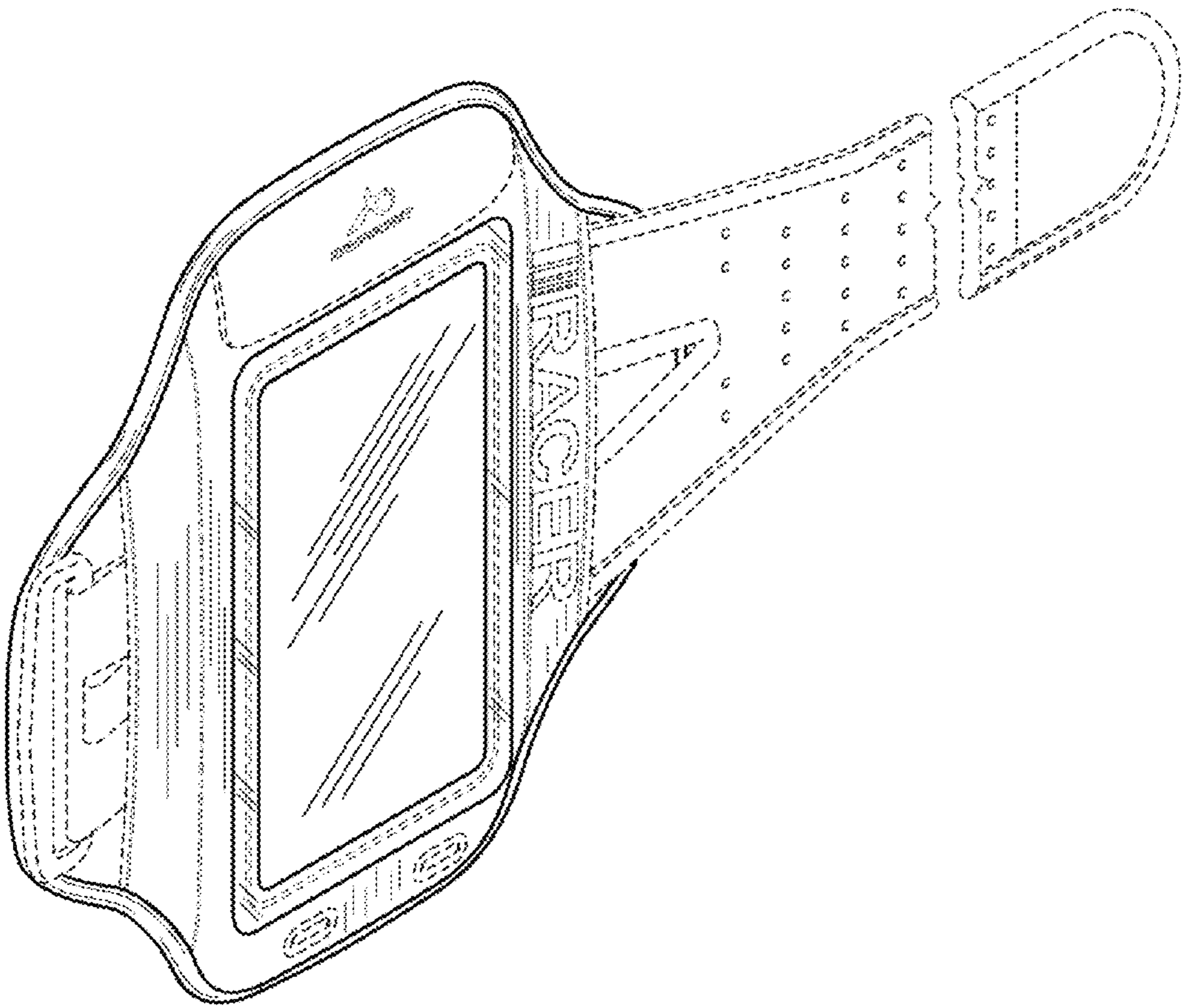

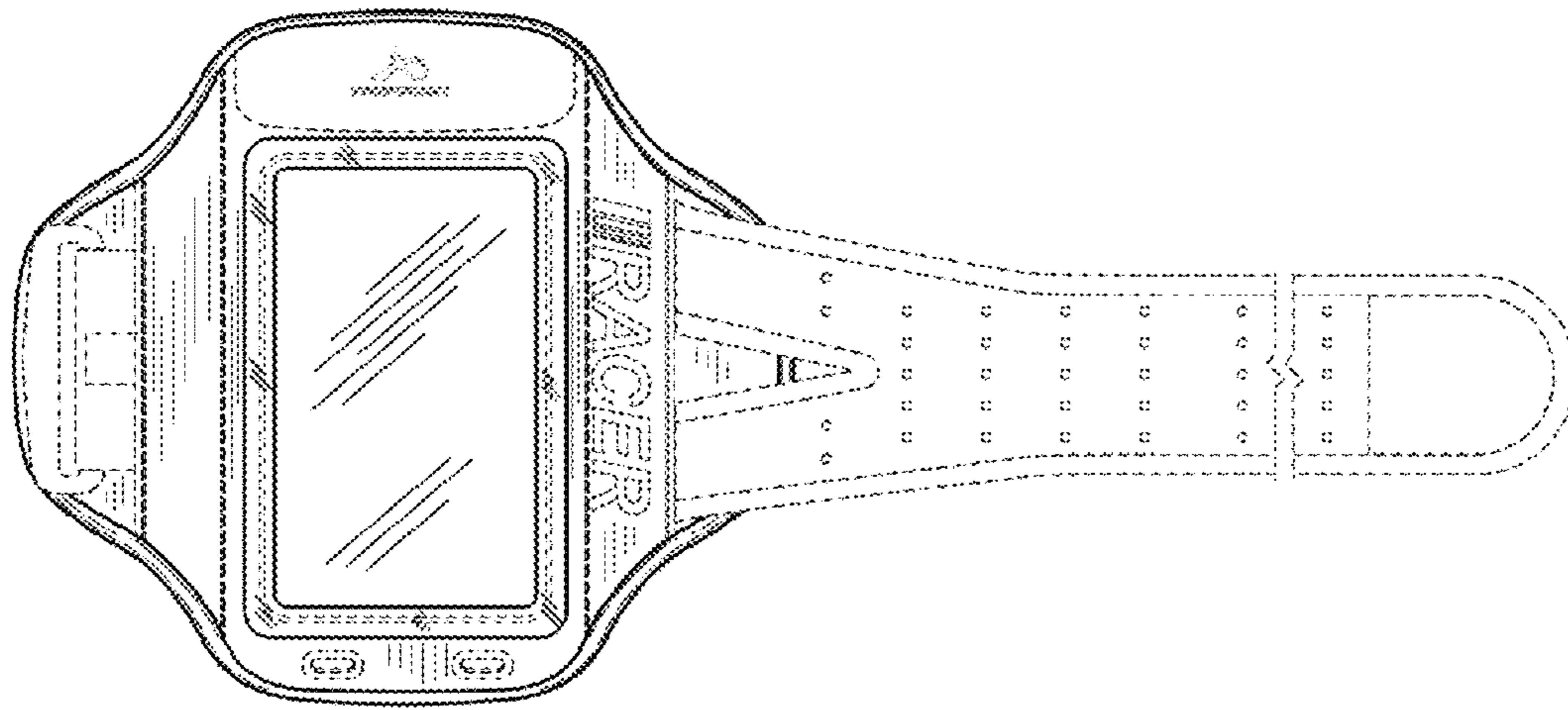

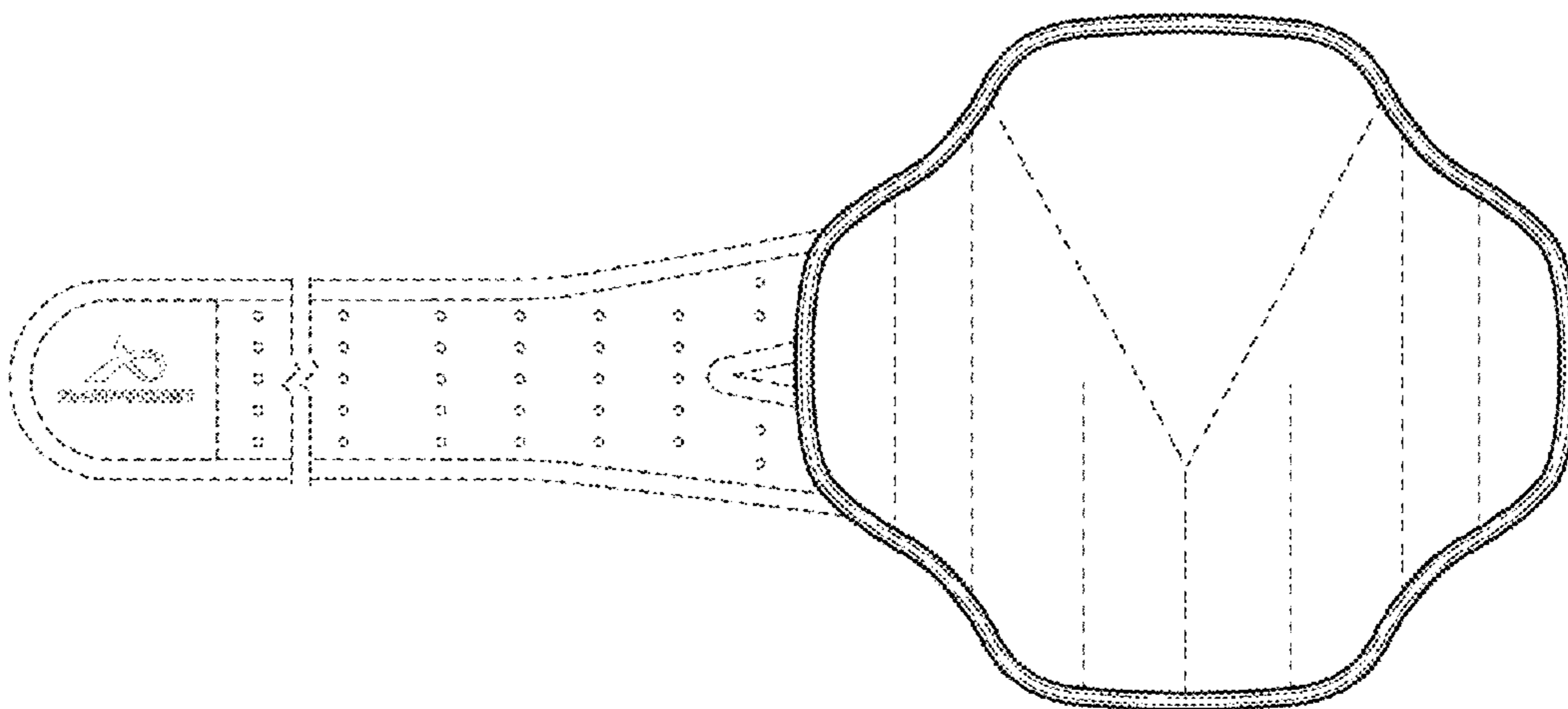

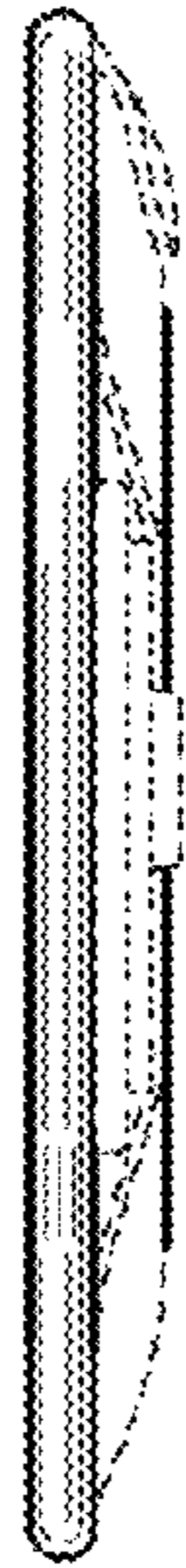

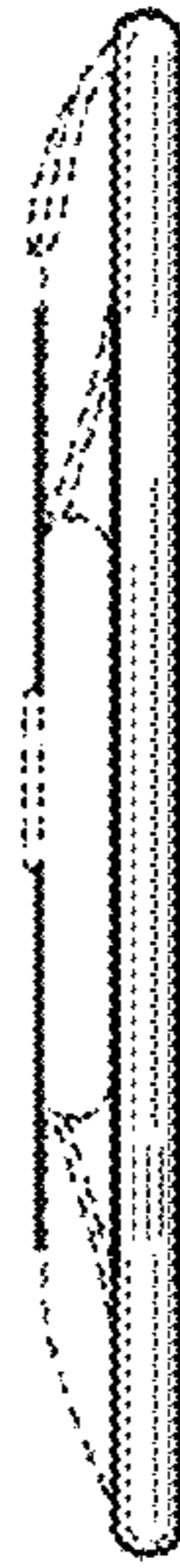

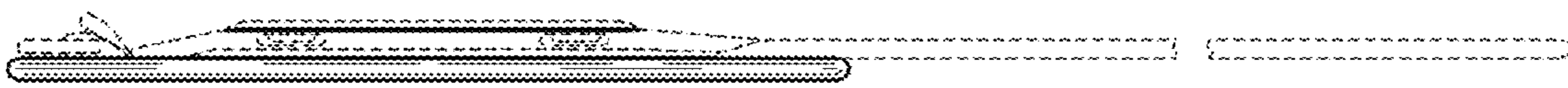

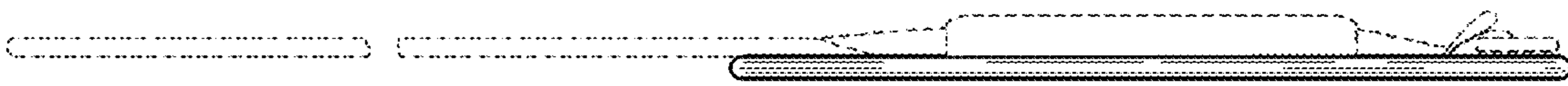
