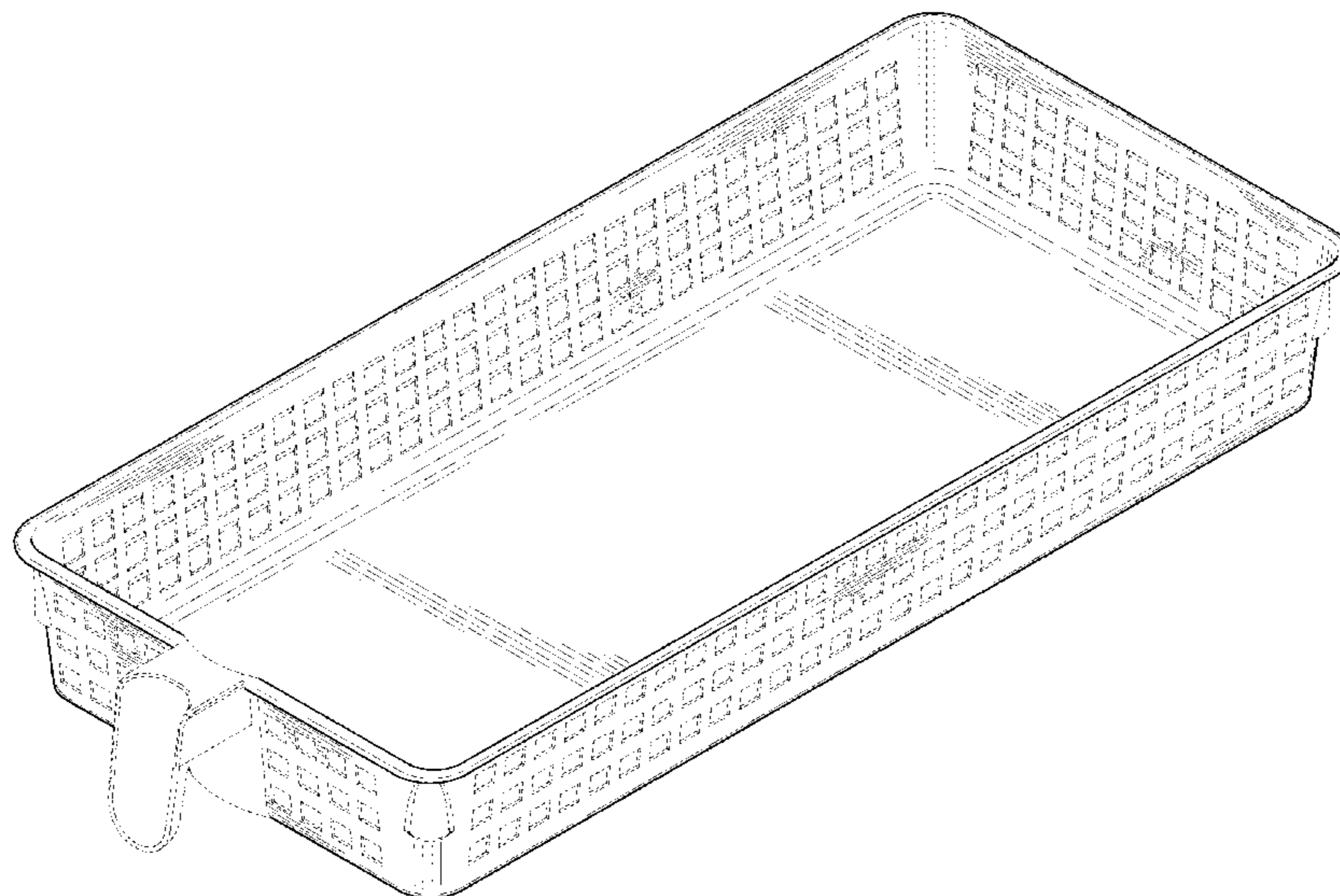

**DESCRIPTION**

FIG. 1 is a perspective view of an example shelf liner; FIG. 2 is a front plan view thereof; FIG. 3 is a rear plan view thereof; FIG. 4 is a right side plan view thereof, with the left side plan view being a mirror image thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. 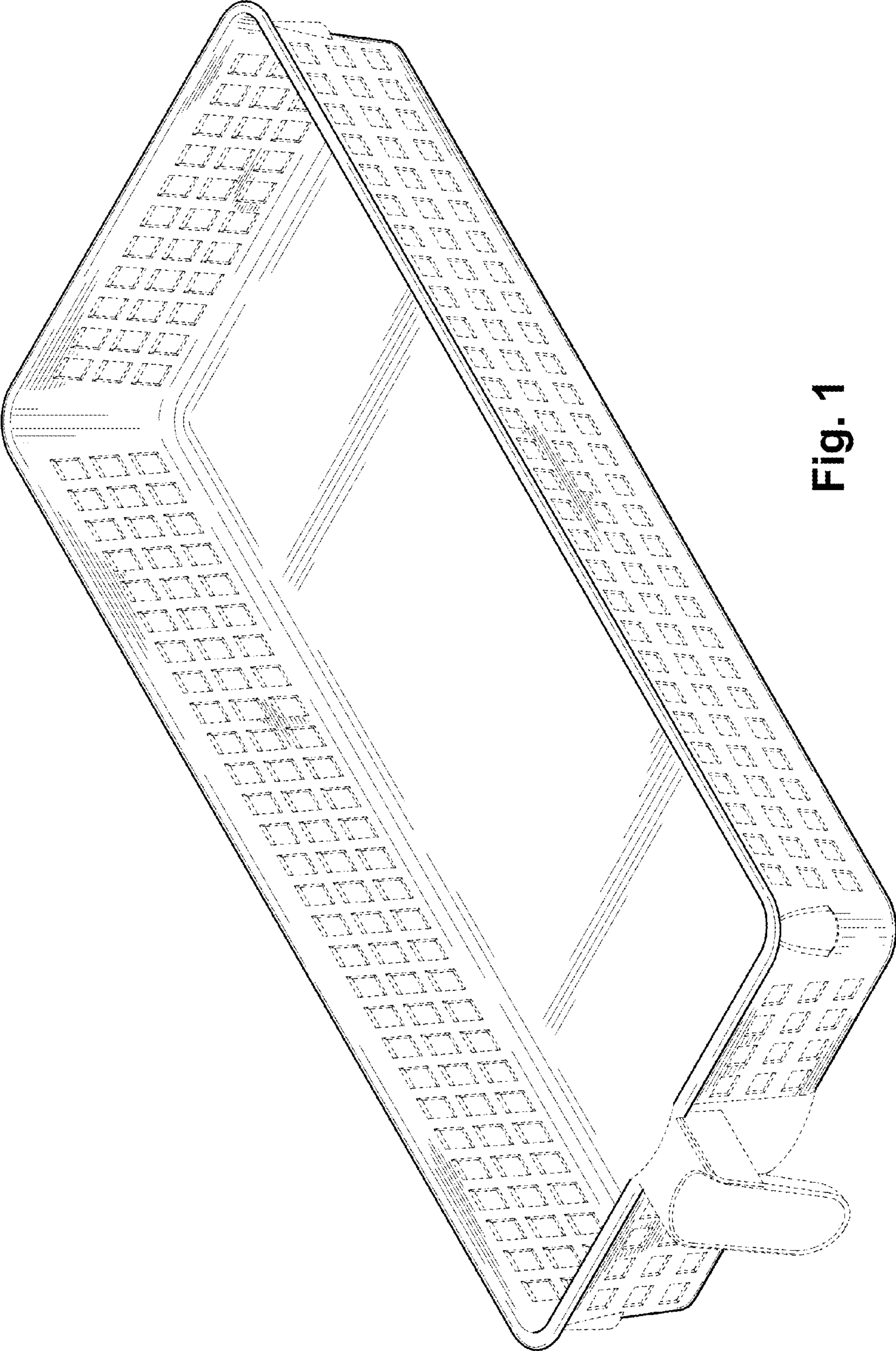

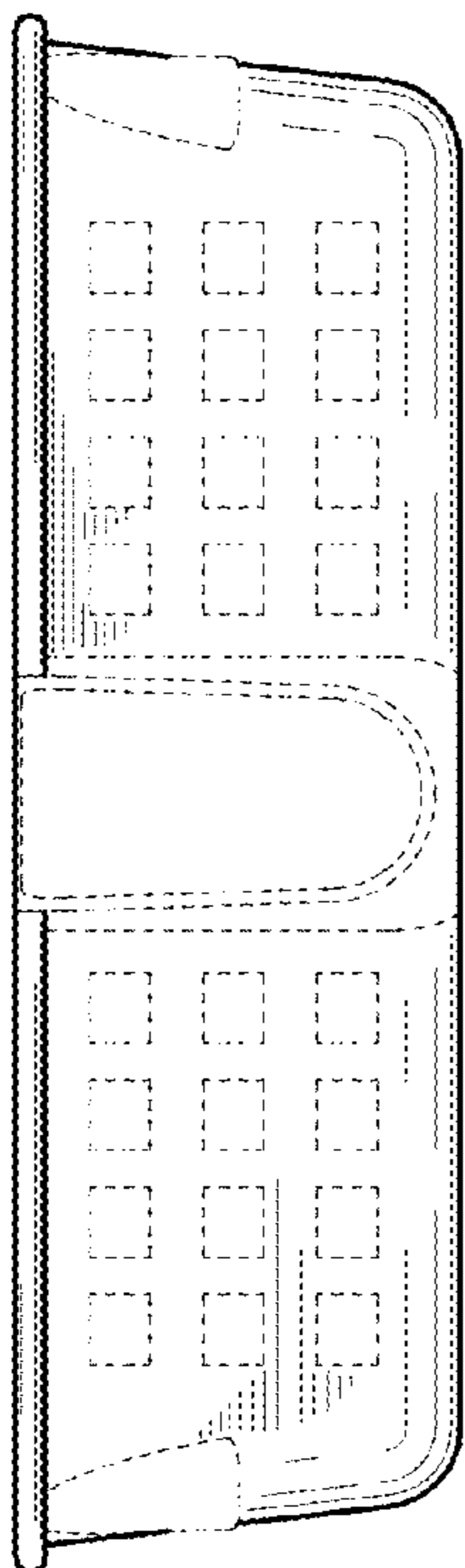

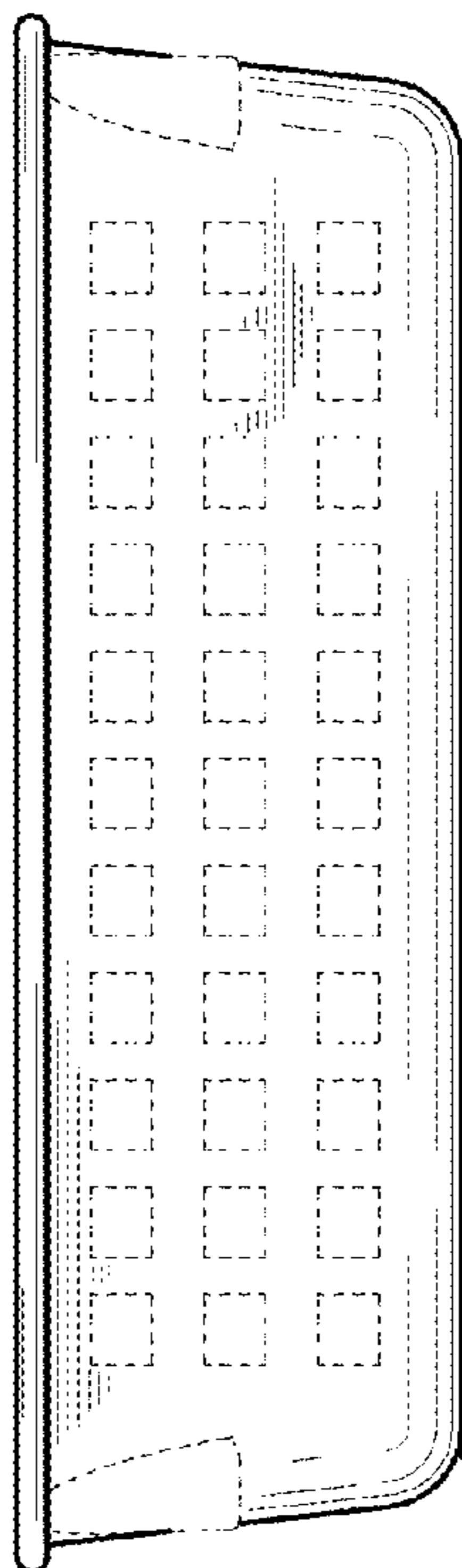

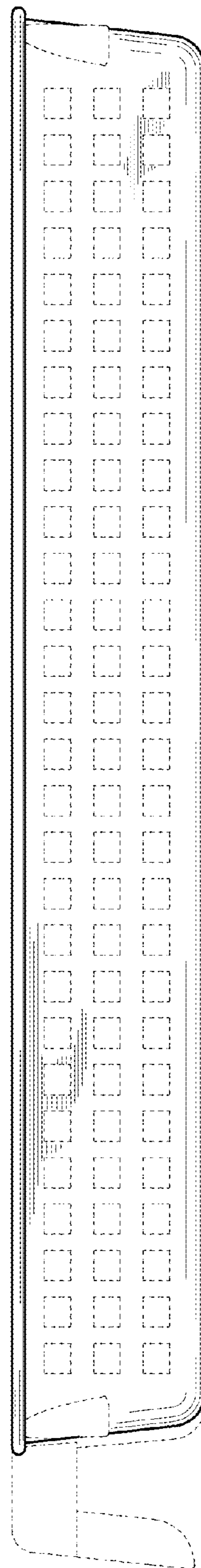

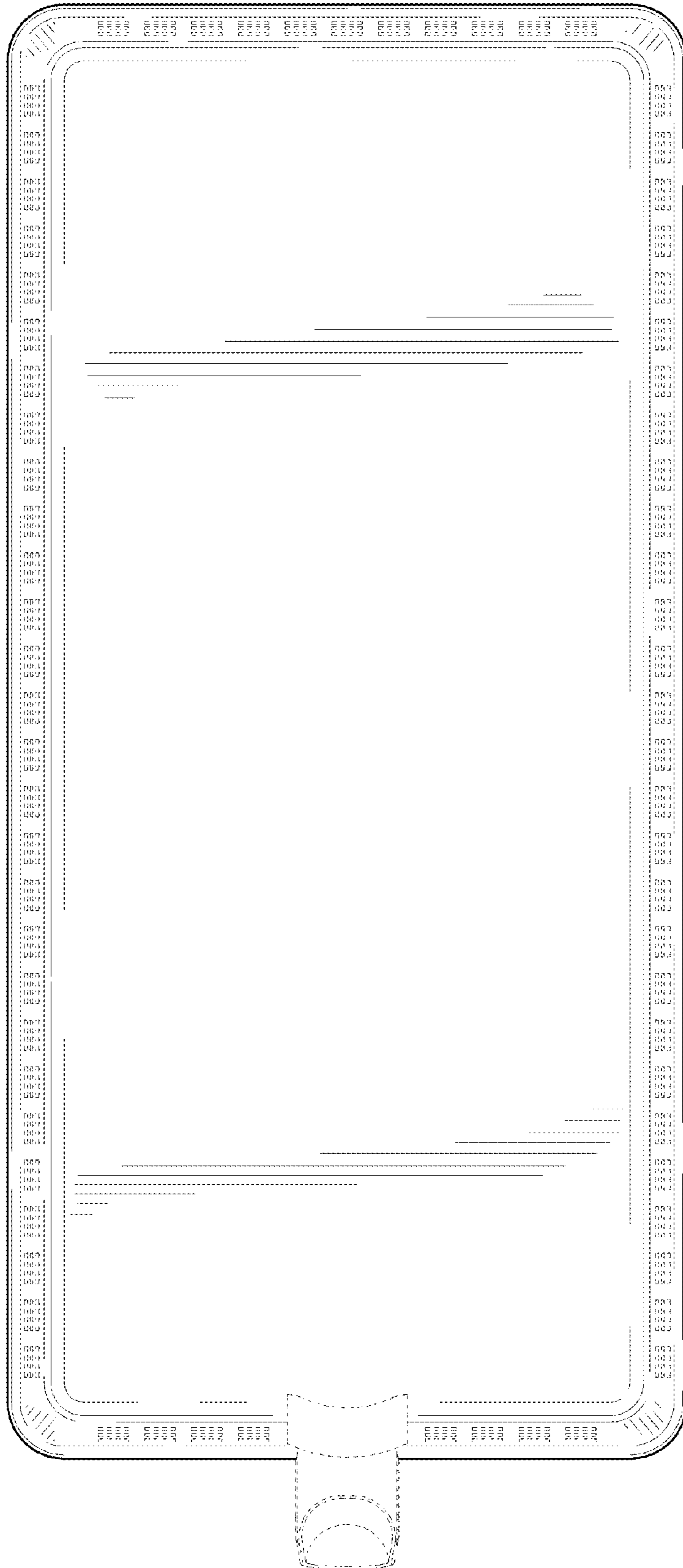

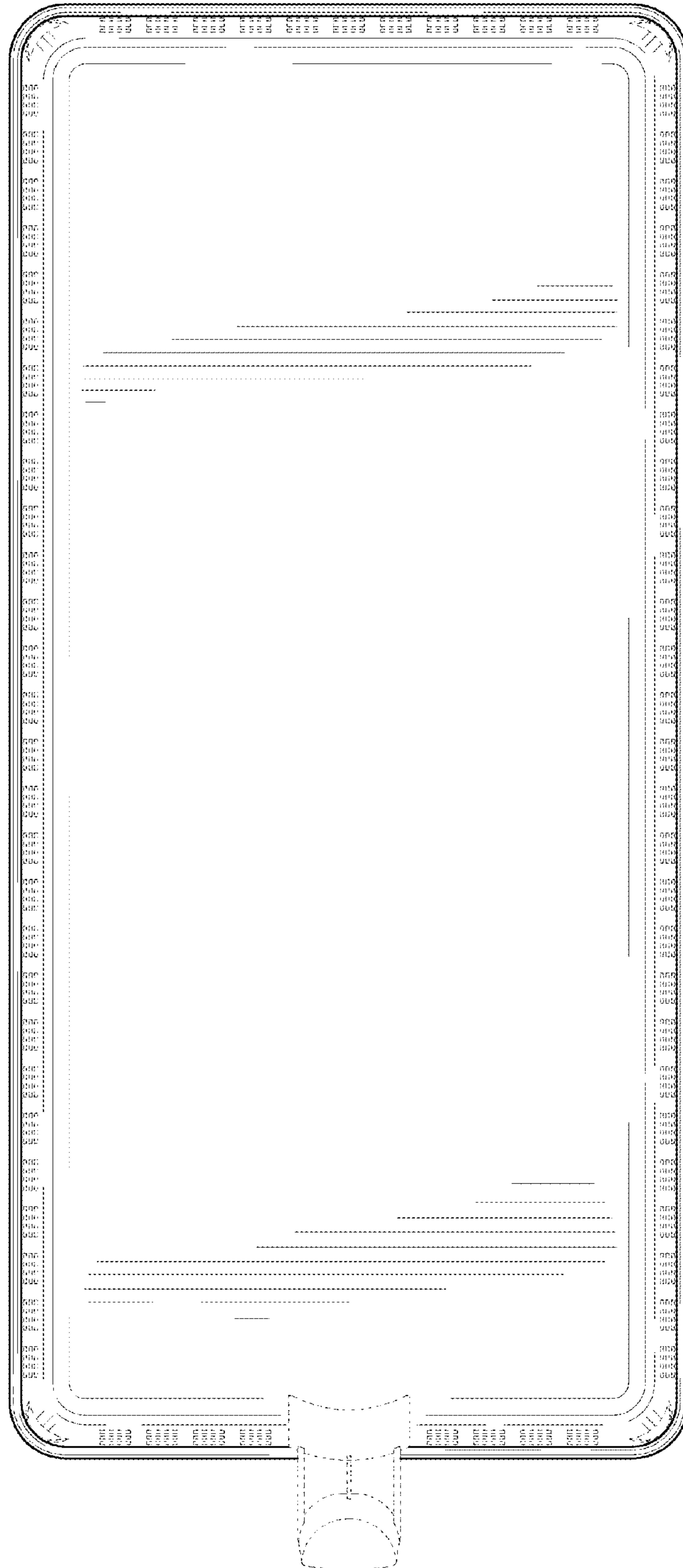
