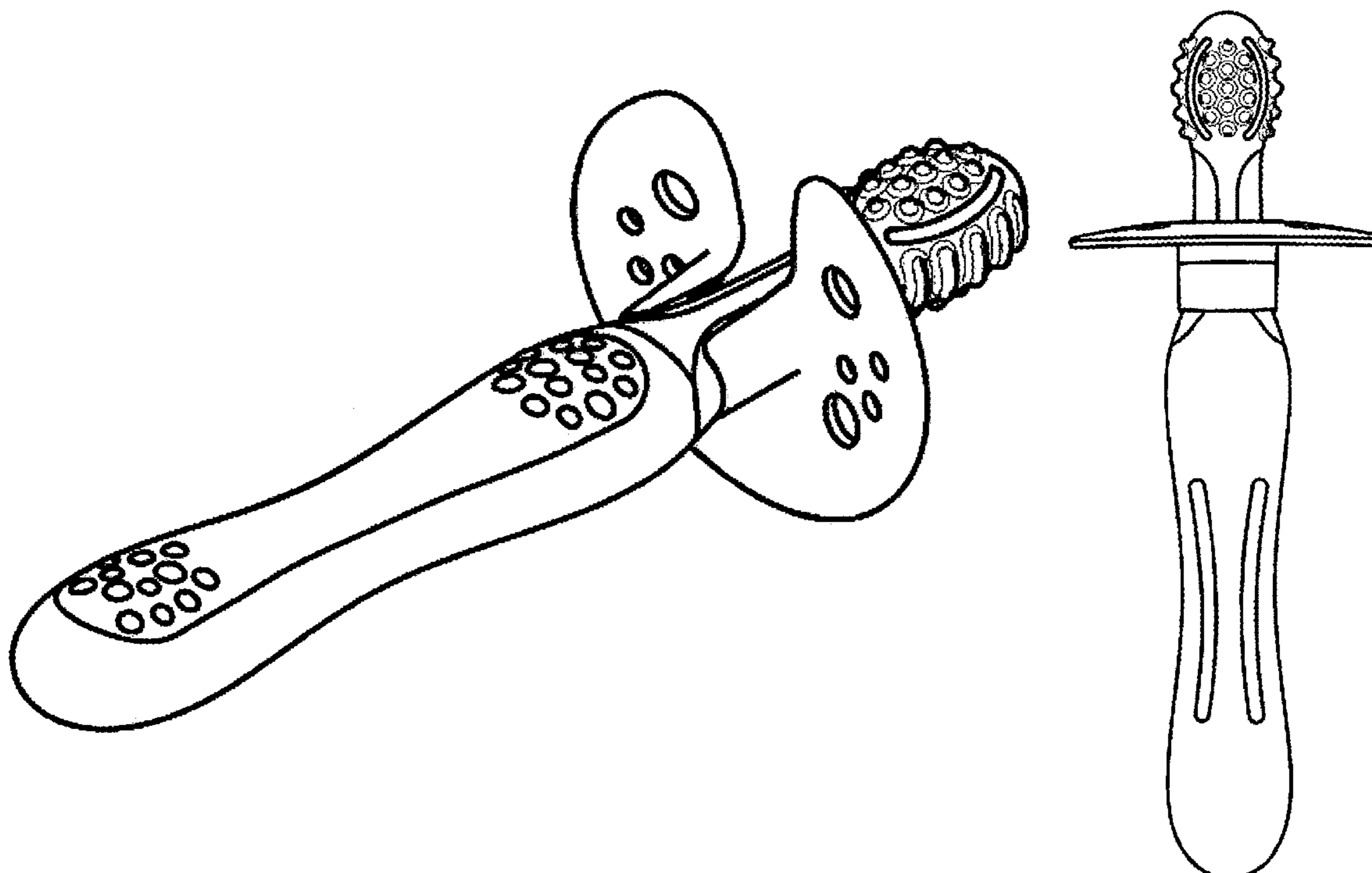
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the front and one side of the toothbrush showing my new design;
FIG. 2 is an elevational view of the front thereof;

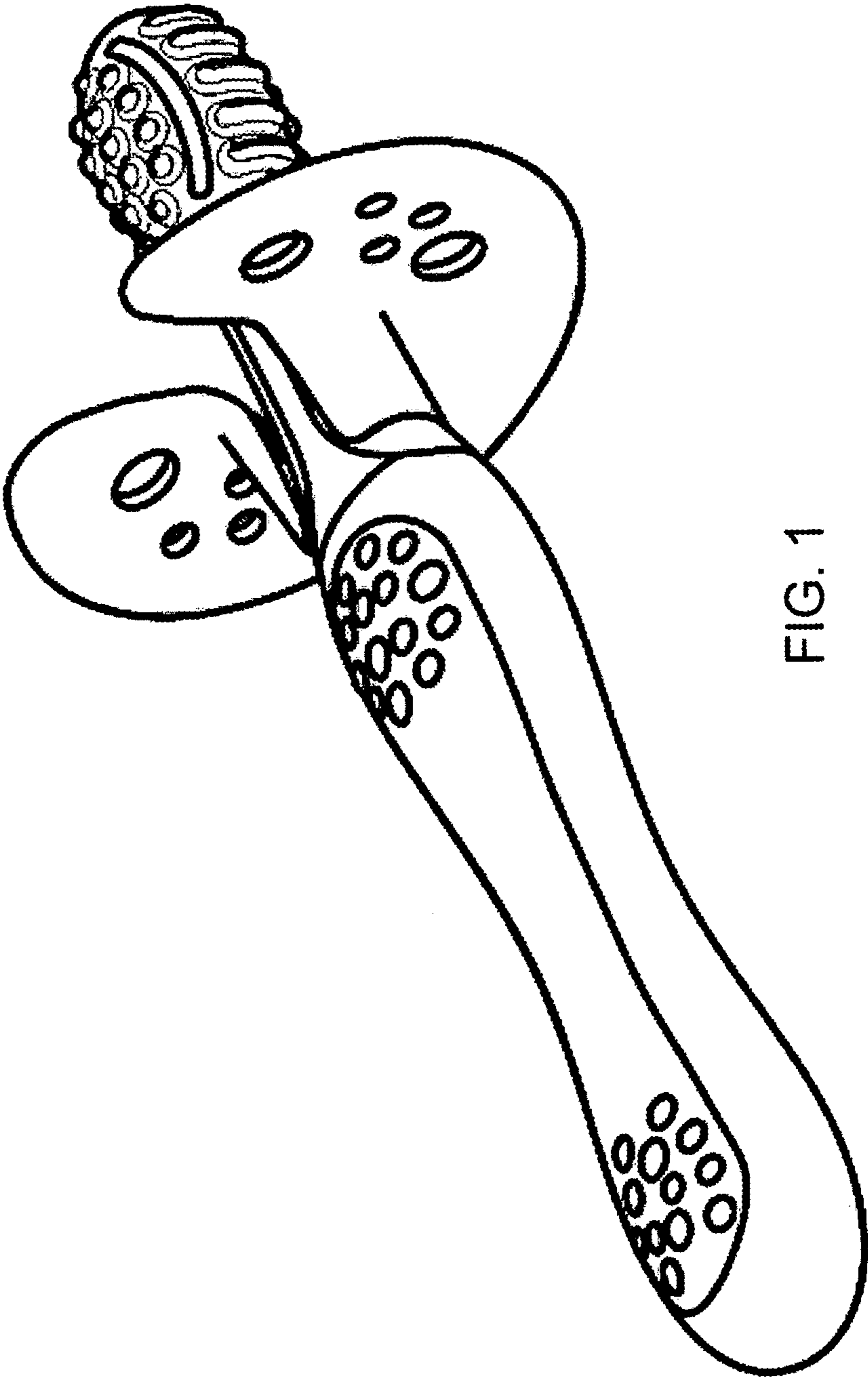

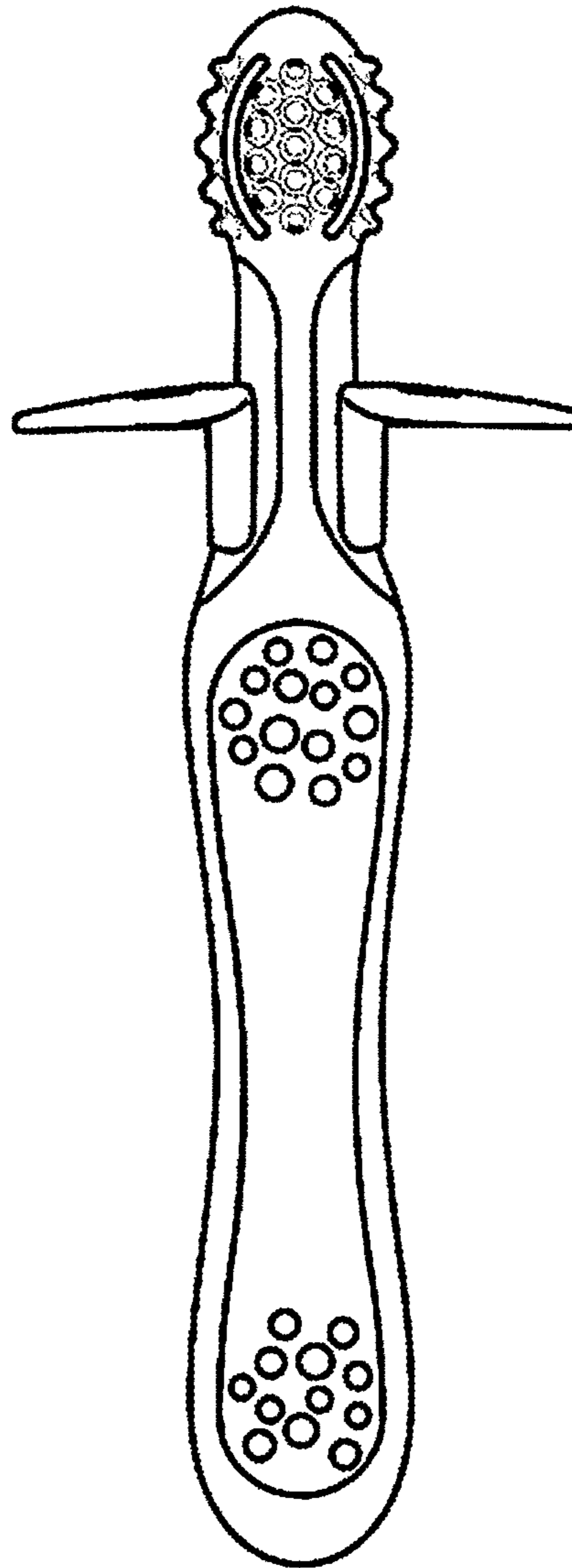

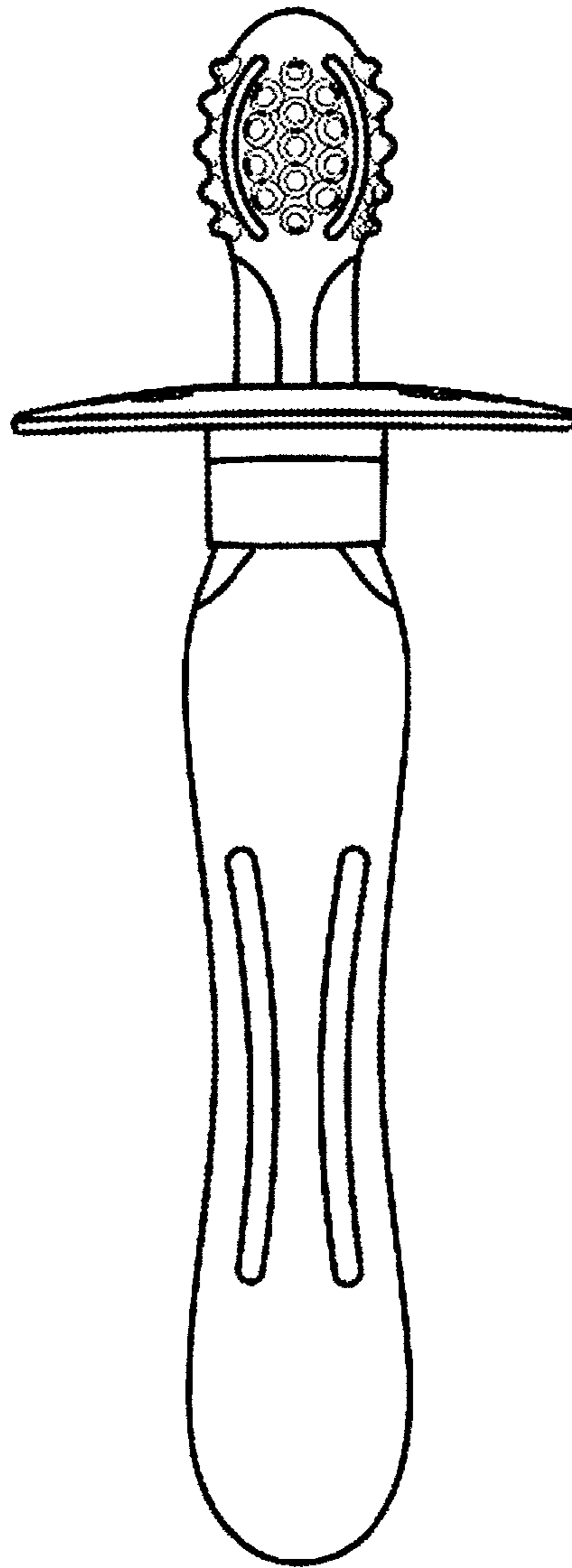

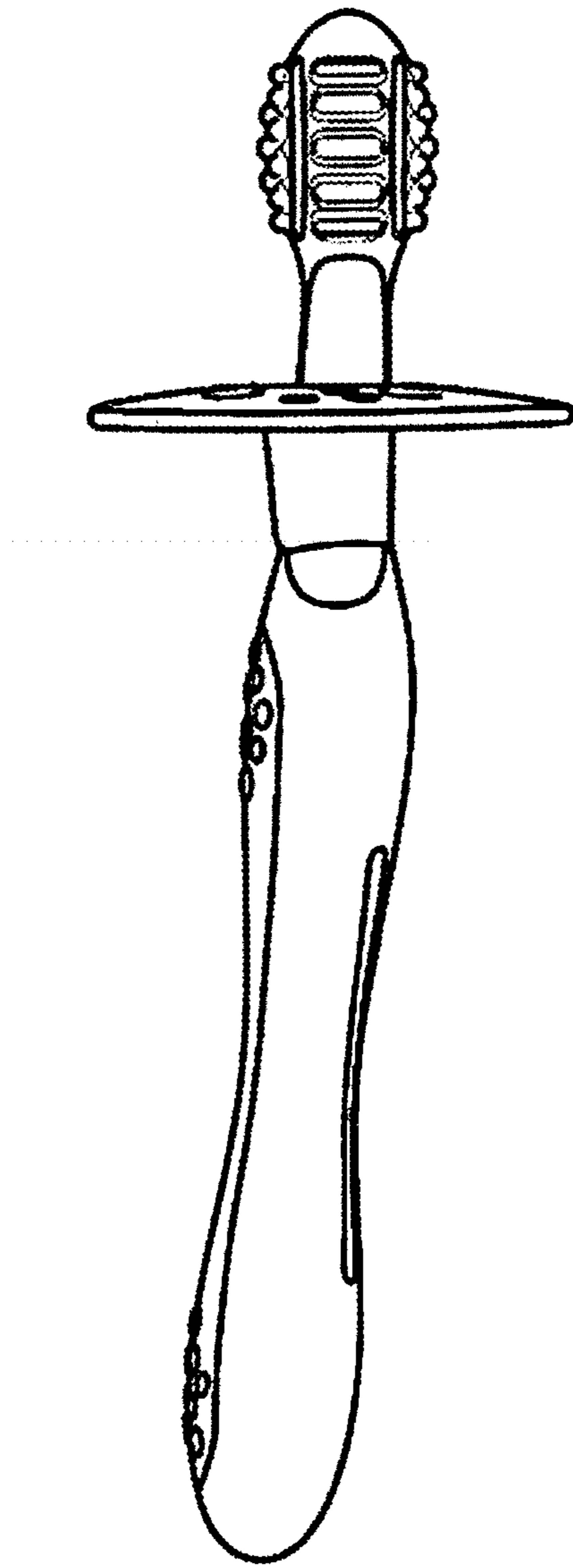

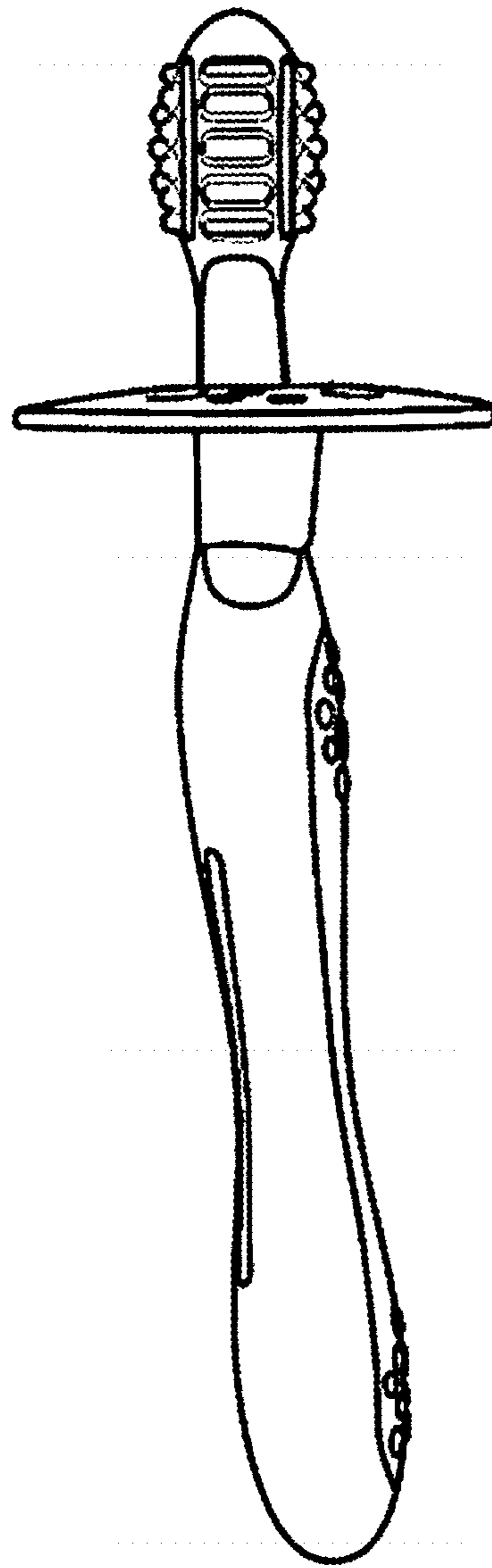

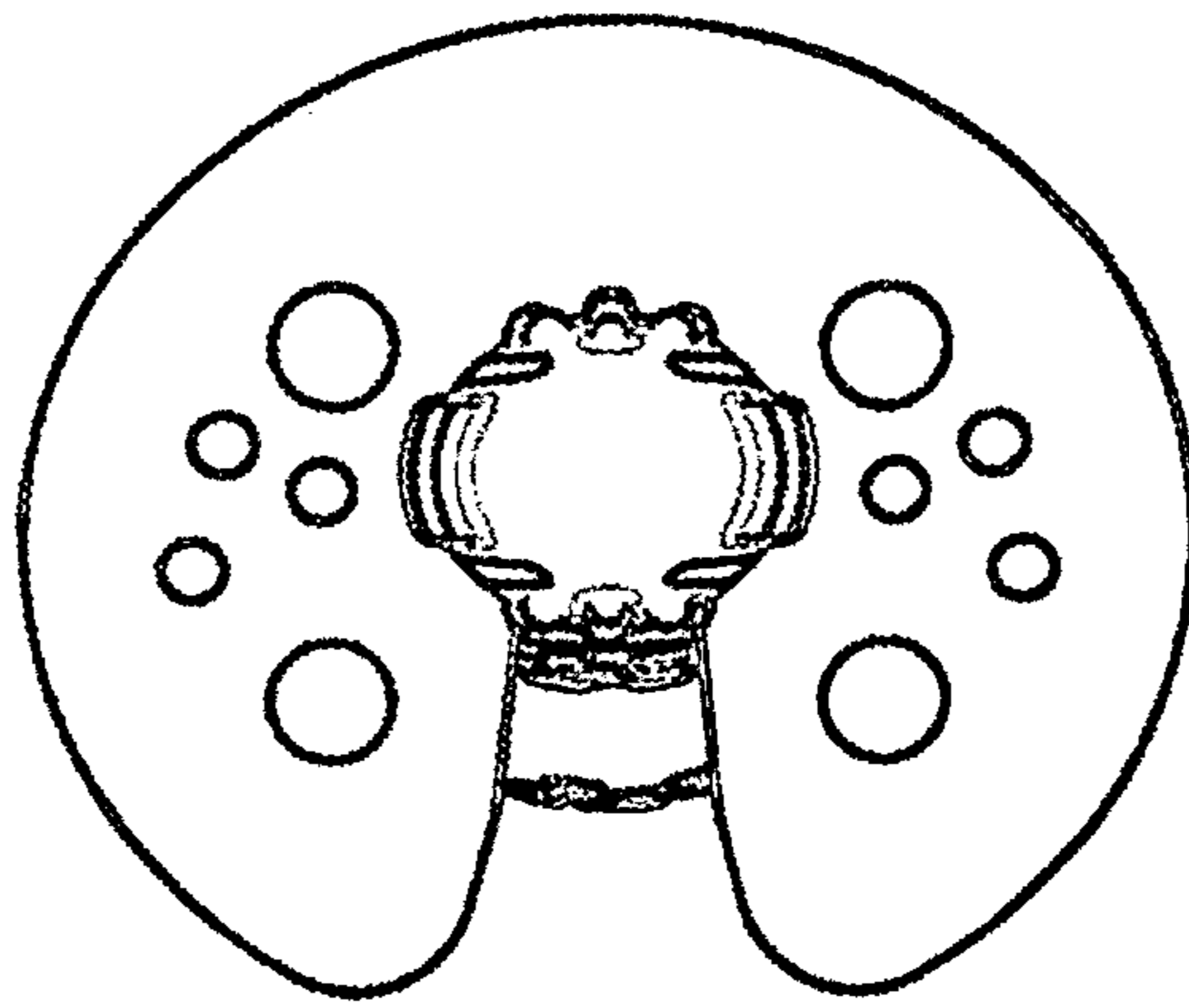

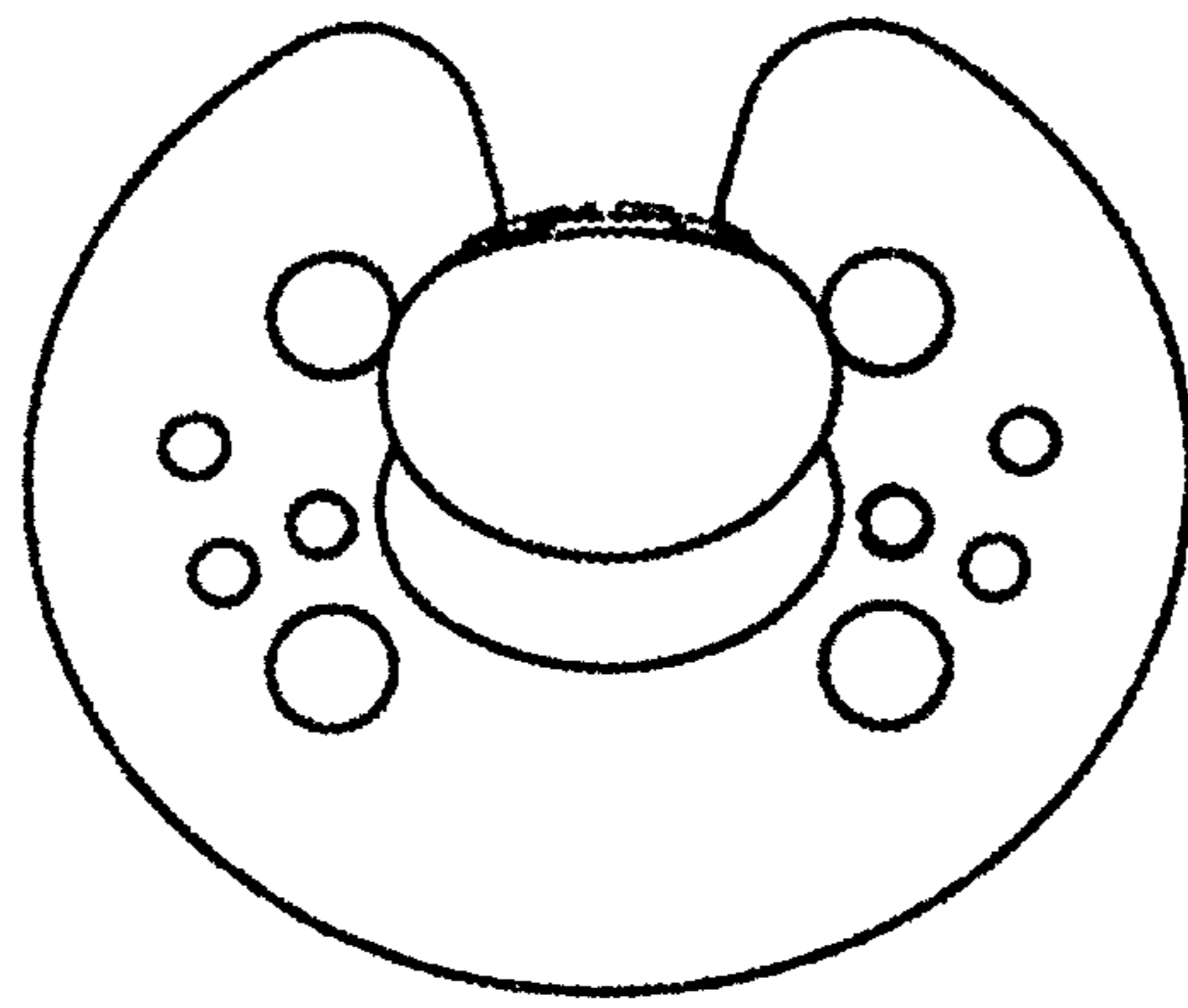
