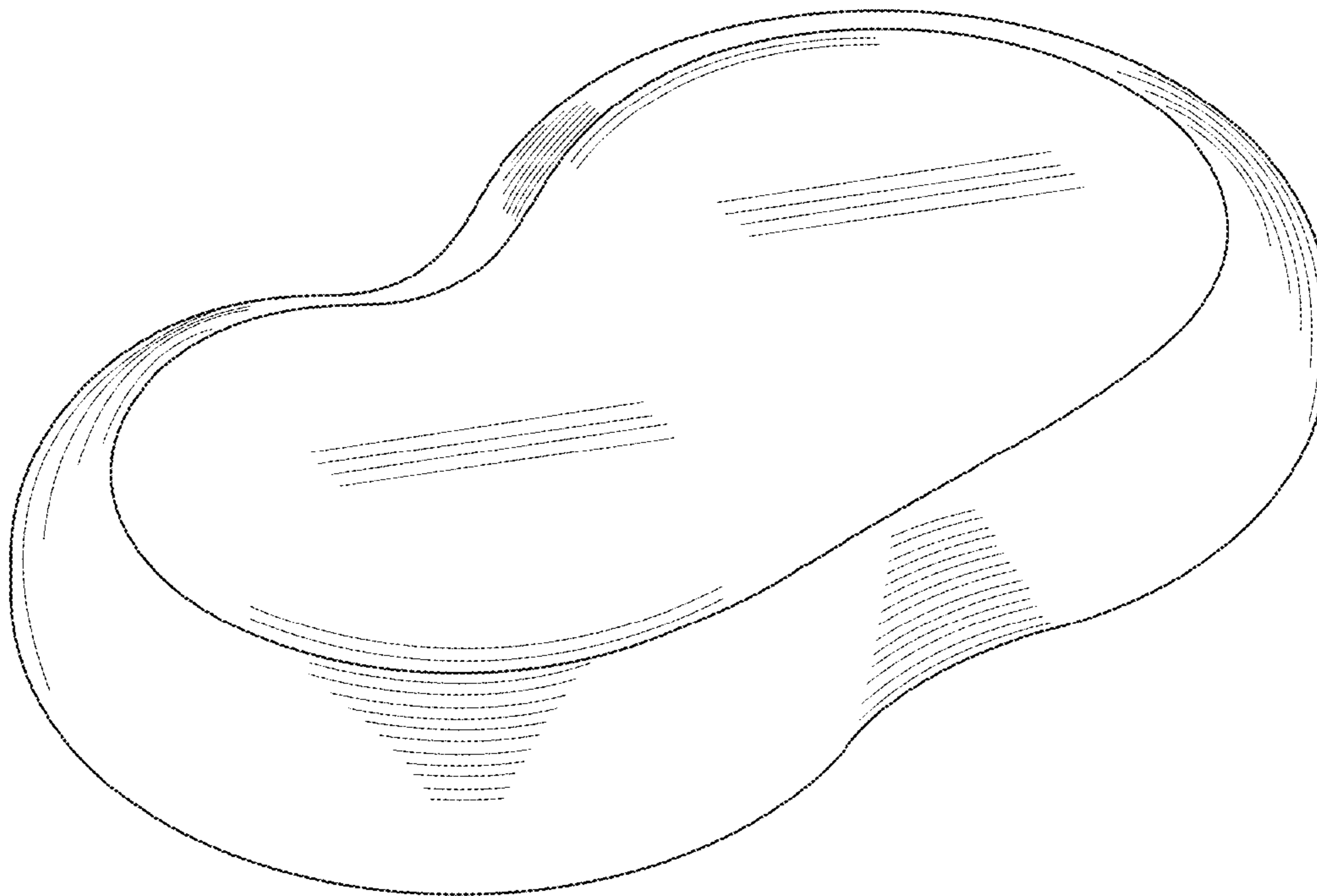

**DESCRIPTION**

FIG. 1 is a perspective view of a pillow showing our new design;  
FIG. 2 is a left side elevational view thereof, the right side being a mirror image;  
FIG. 3 is a front elevational view thereof, the rear side being a minor image;  
FIG. 4 is a top plan view thereof; and,

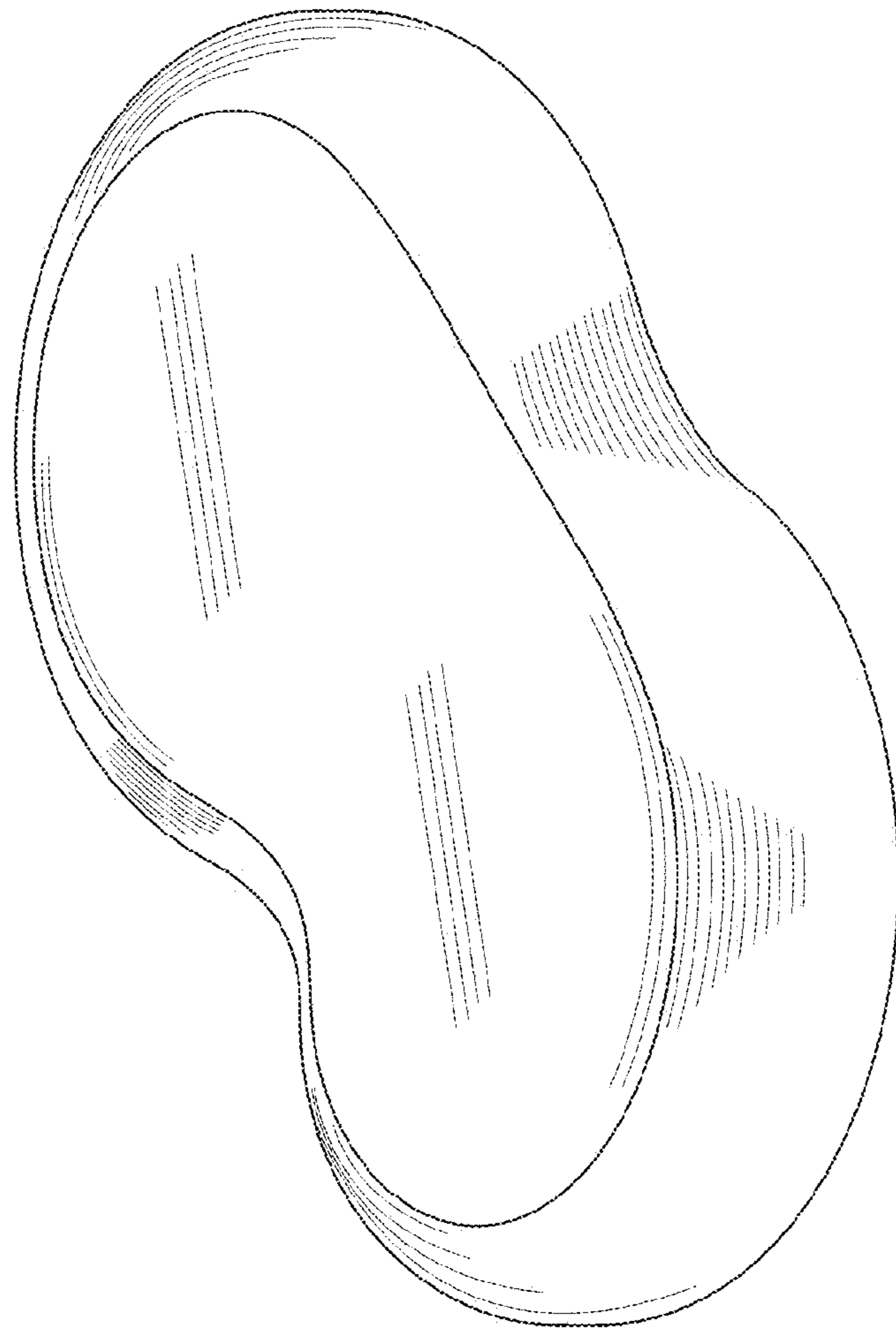

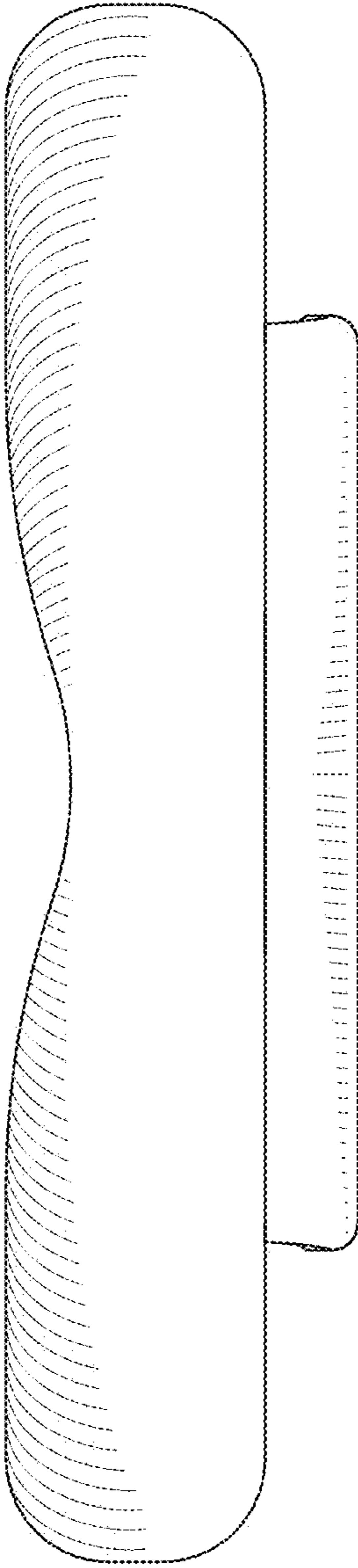

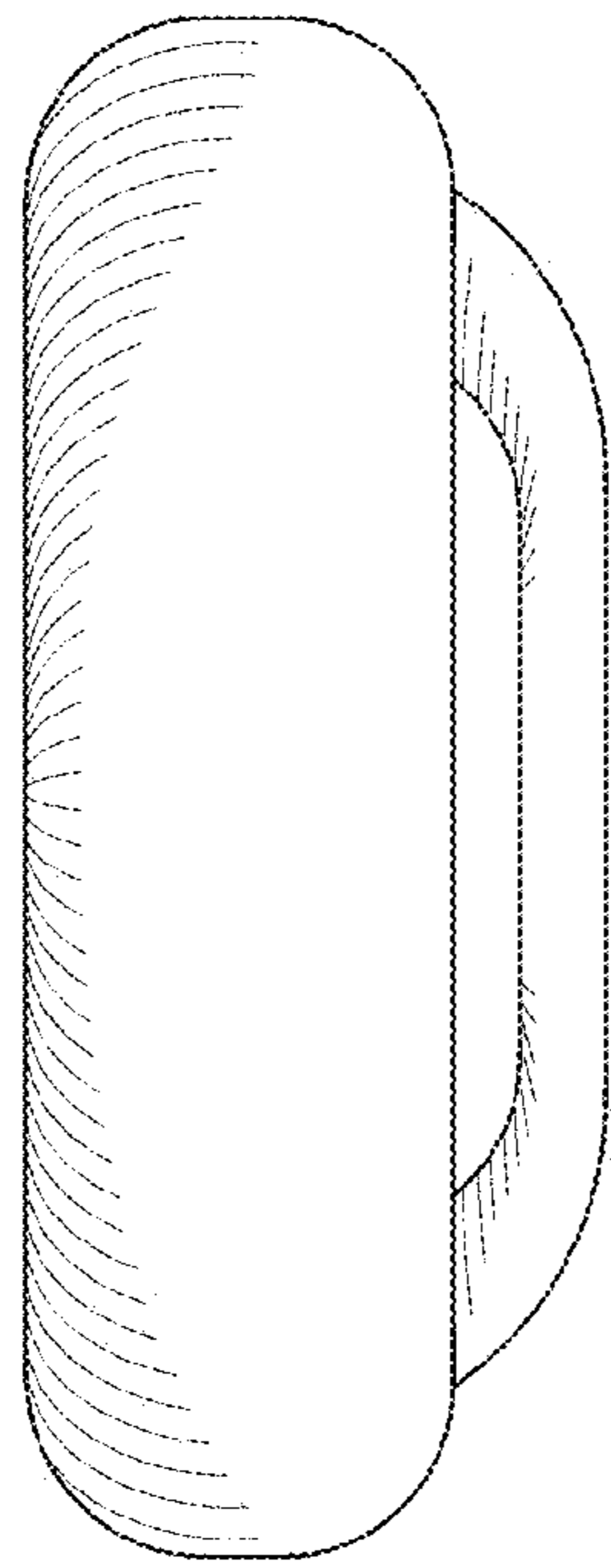

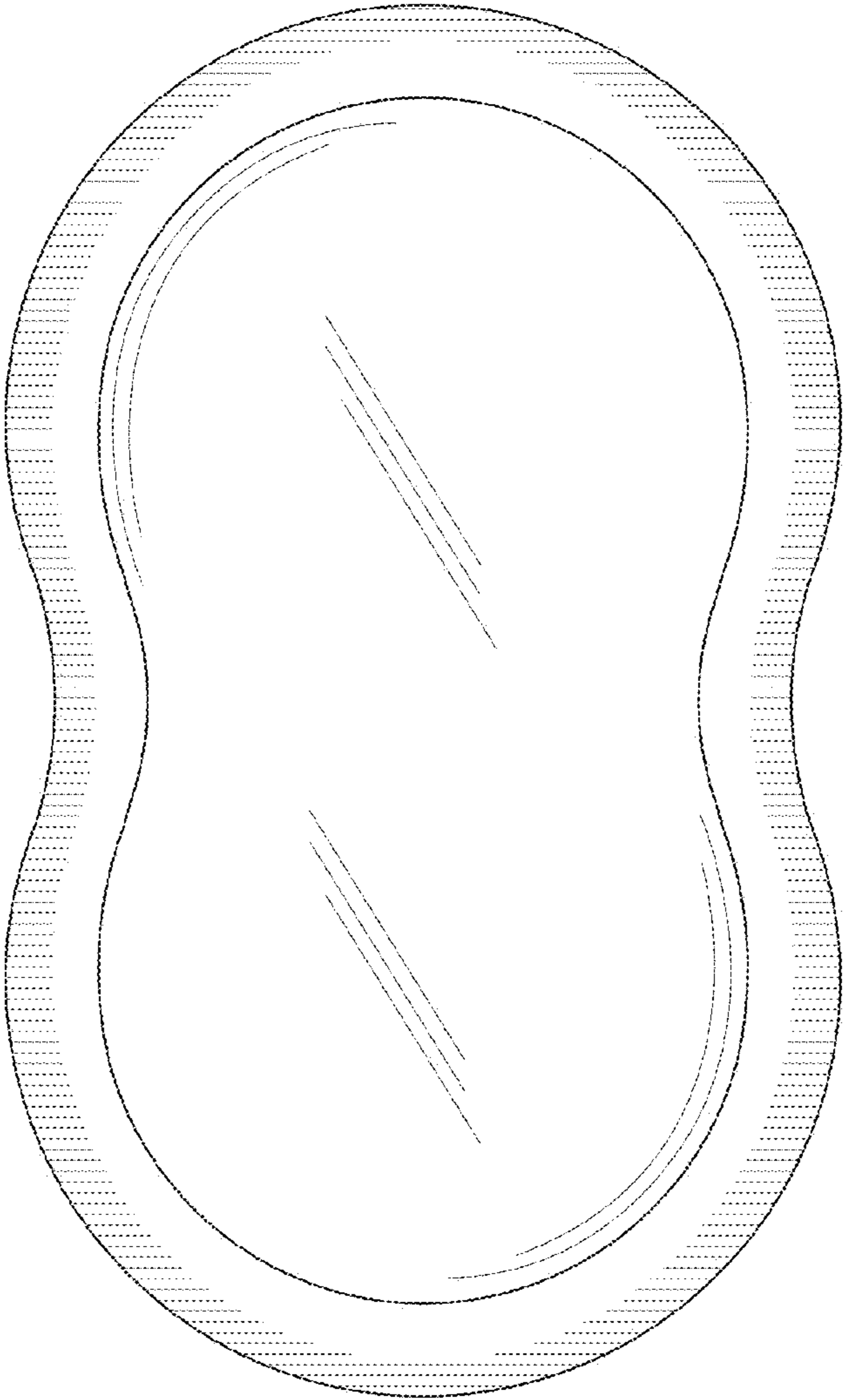

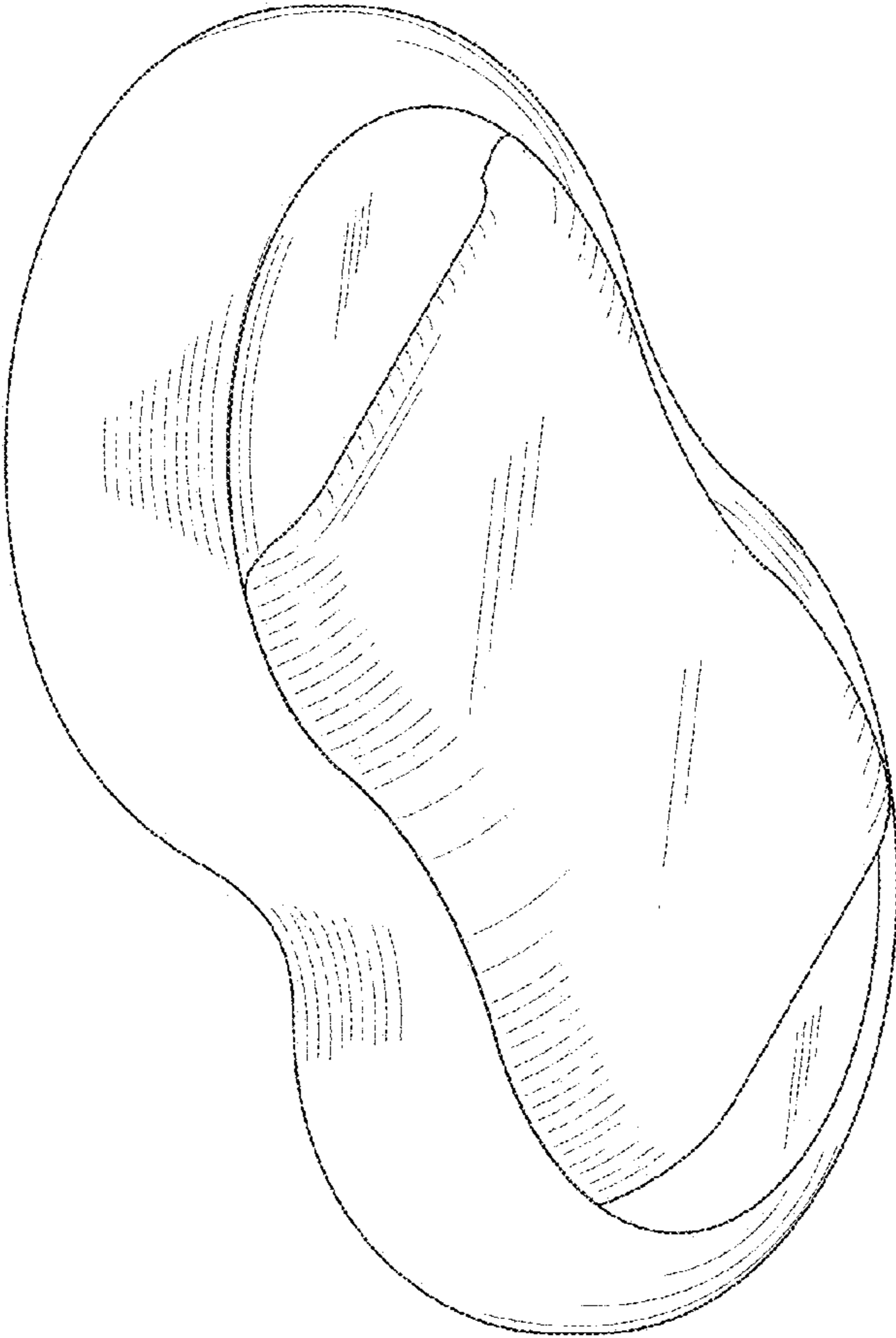
