(57) **CLAIM**

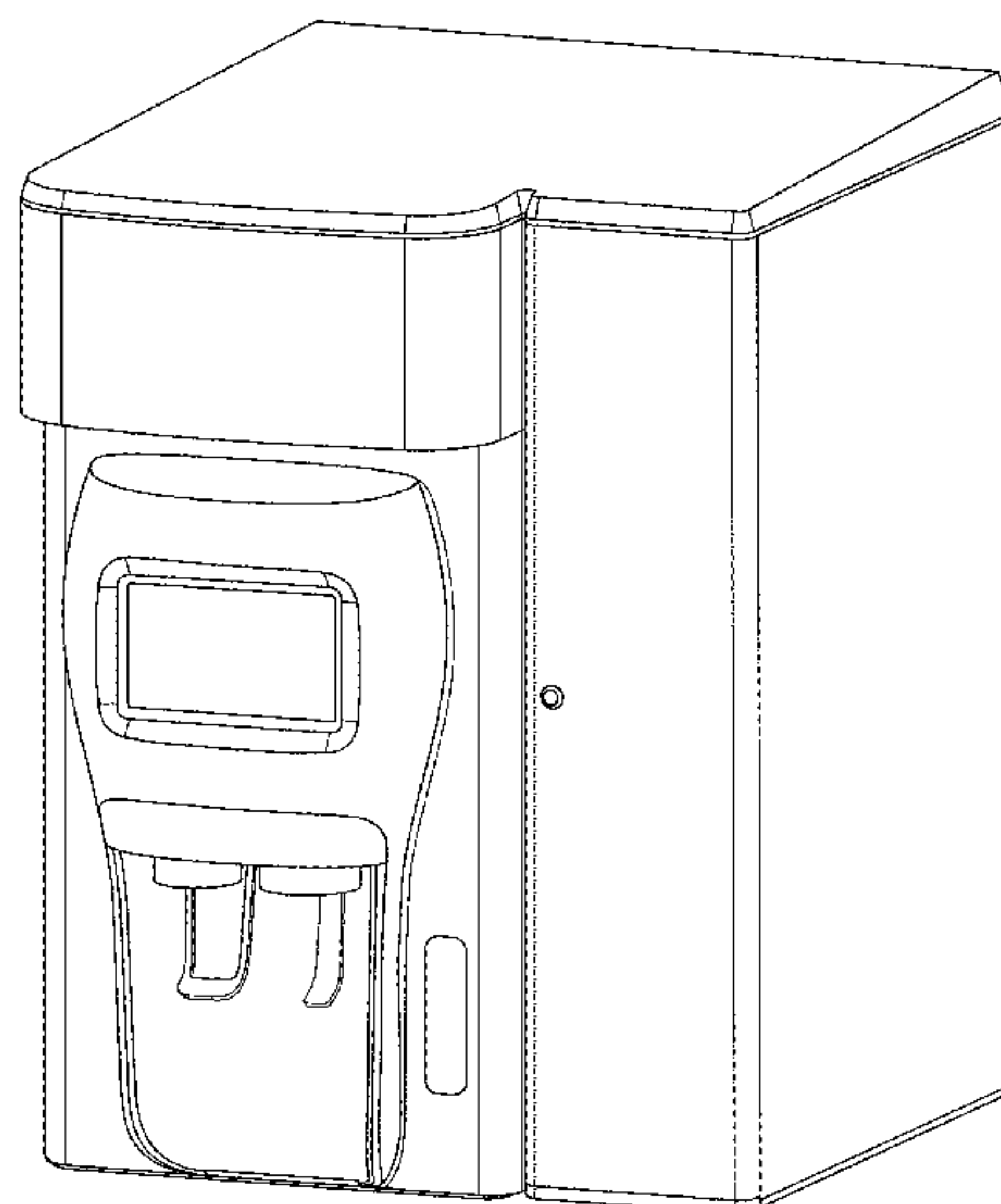
The ornamental design for a beverage dispenser, as shown and described.

DESCRIPTION

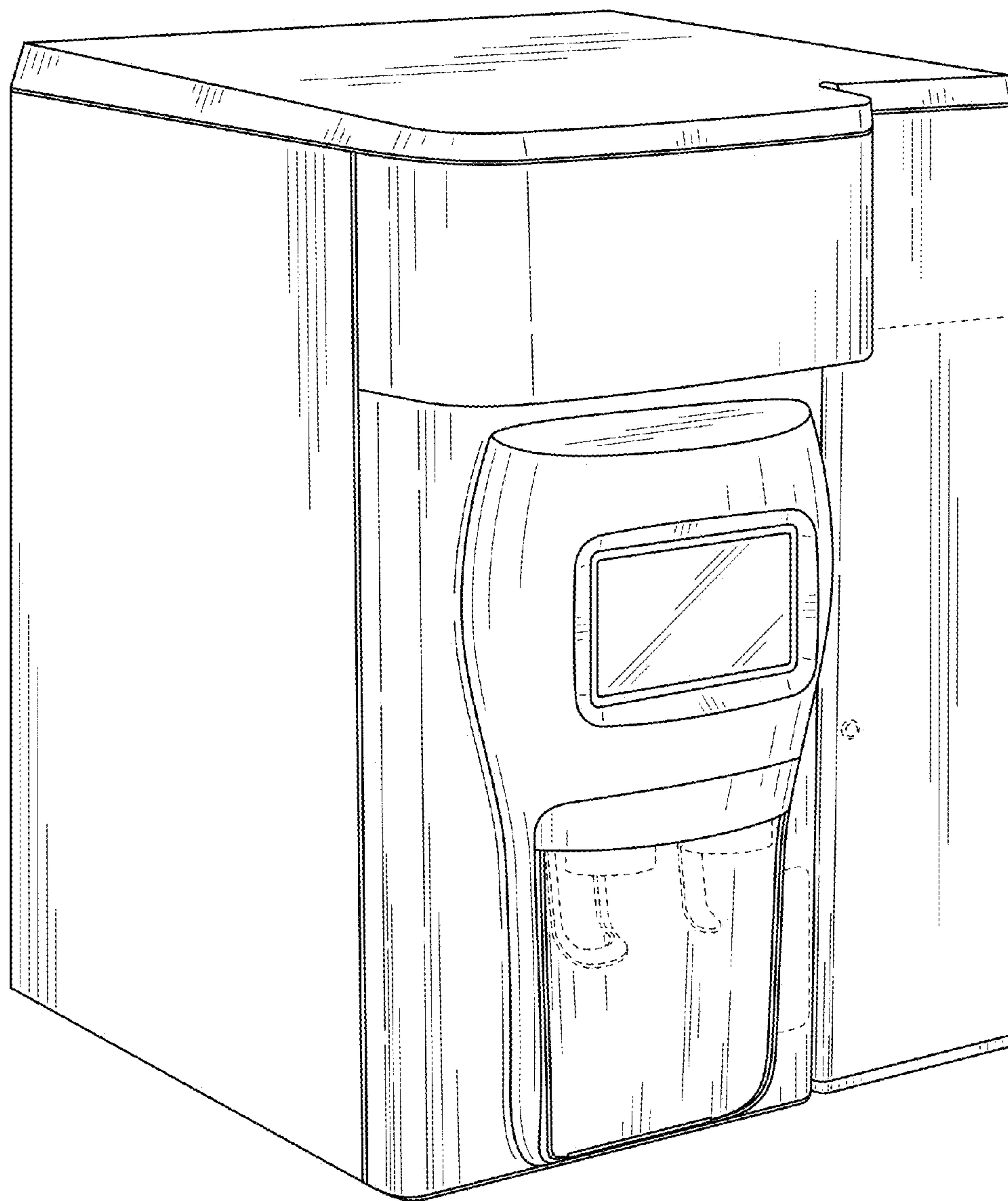

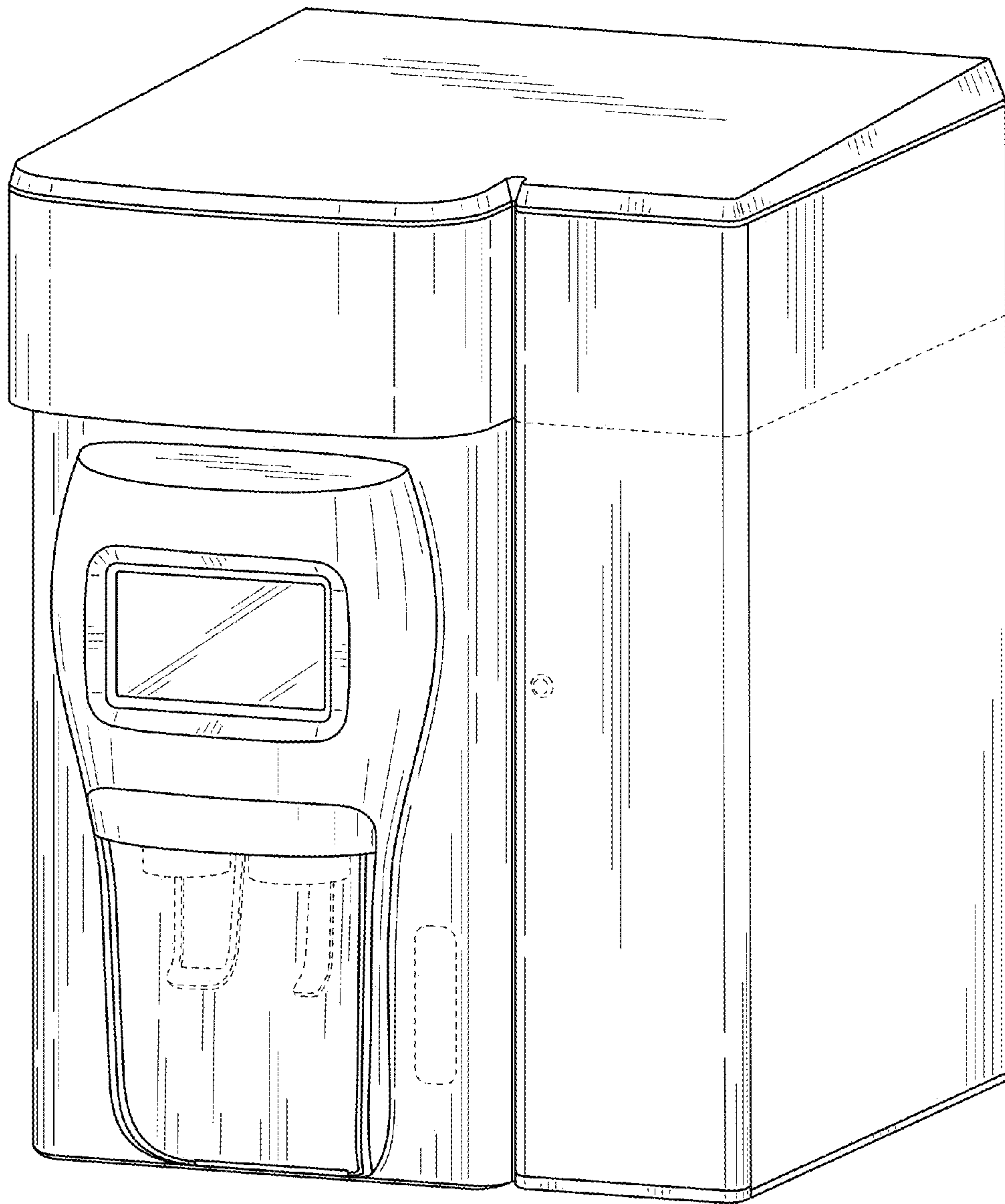

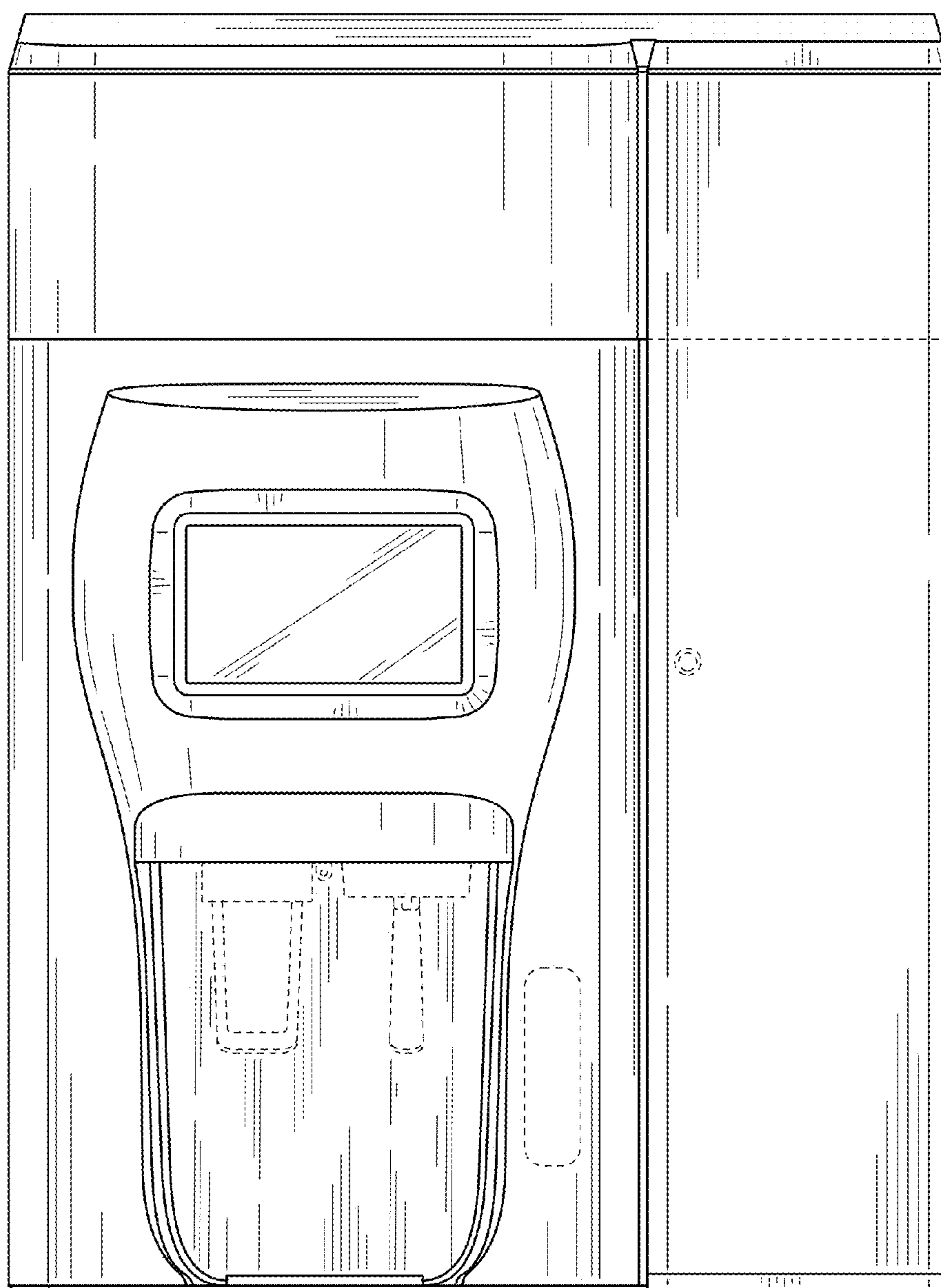

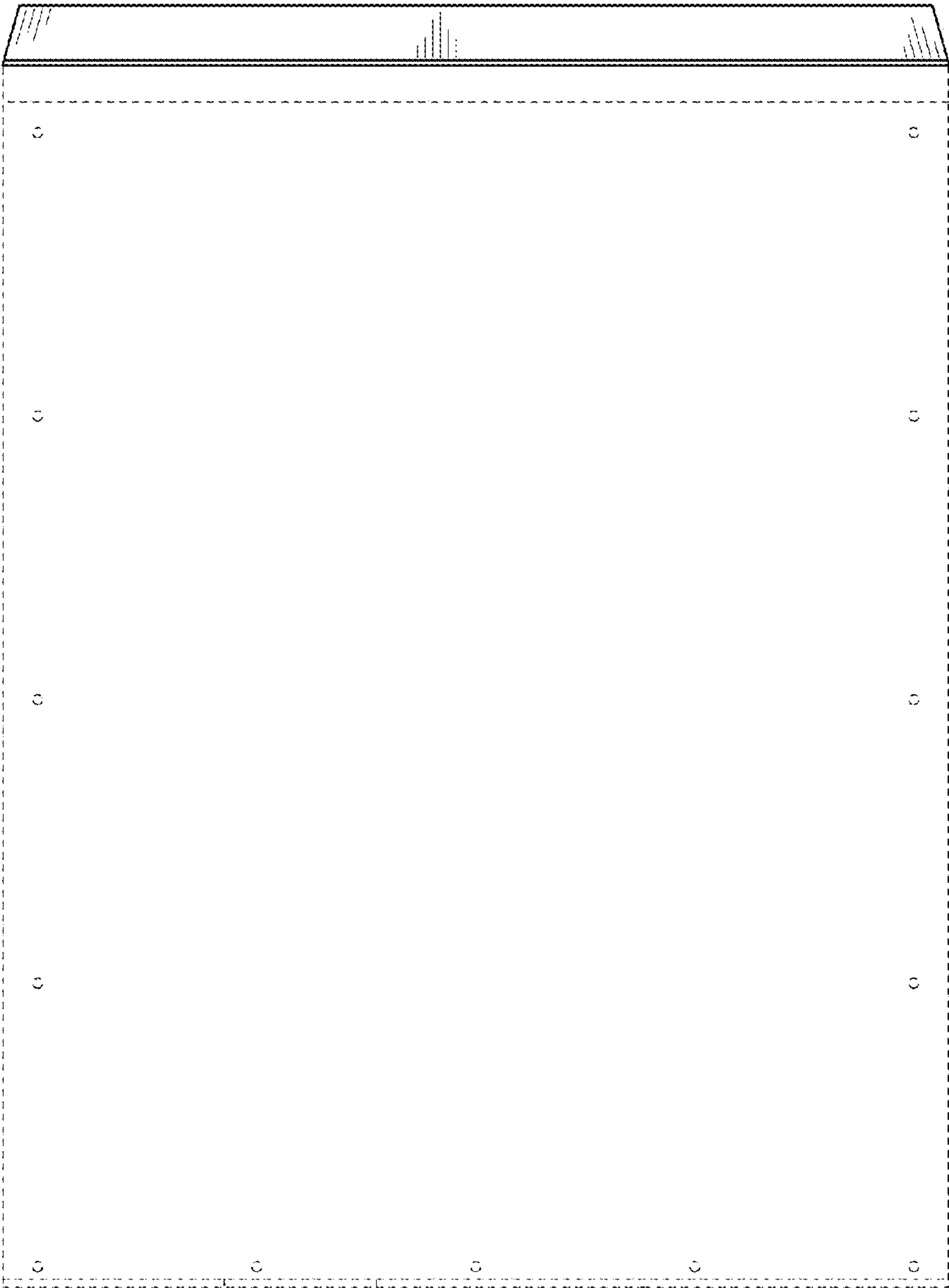

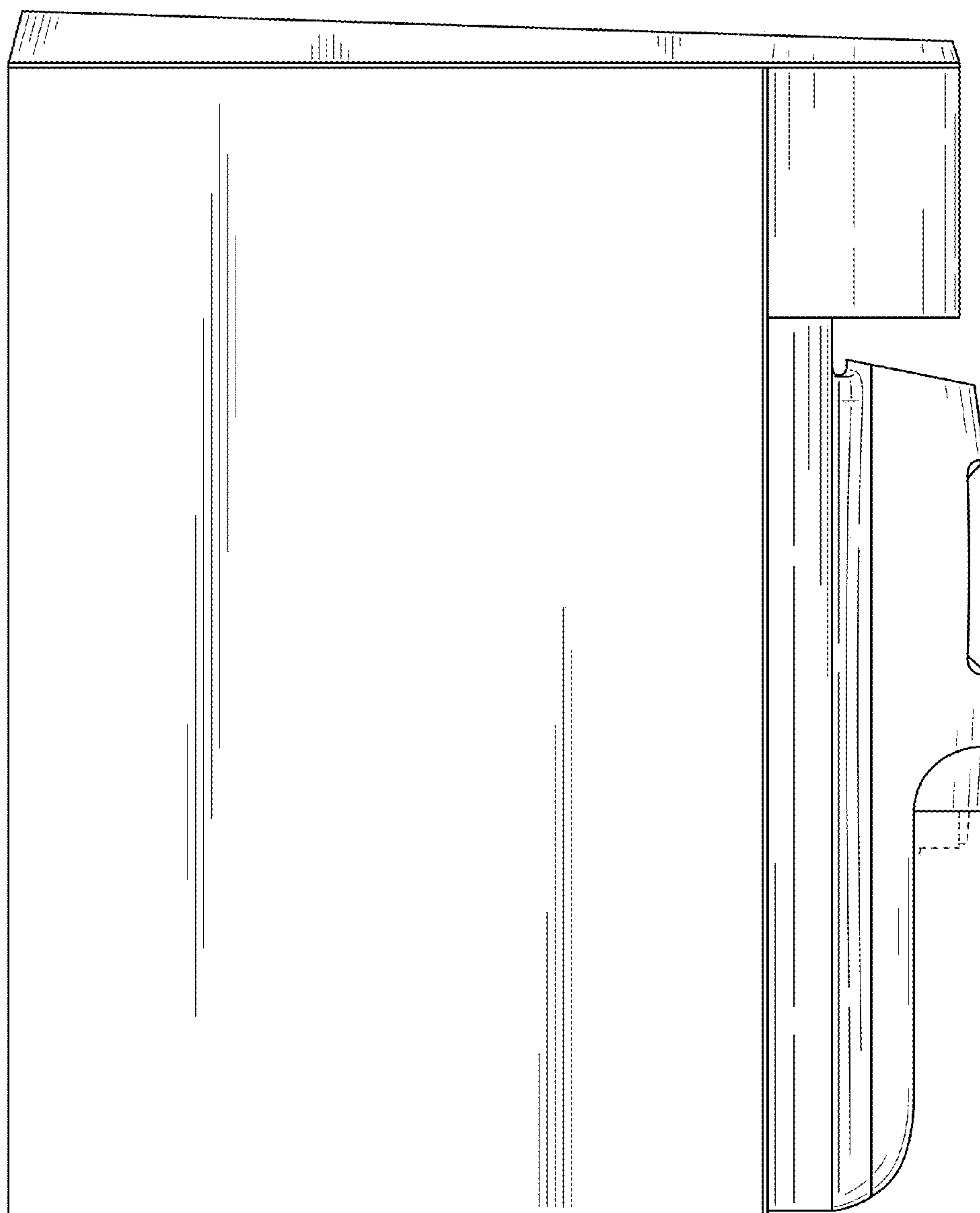

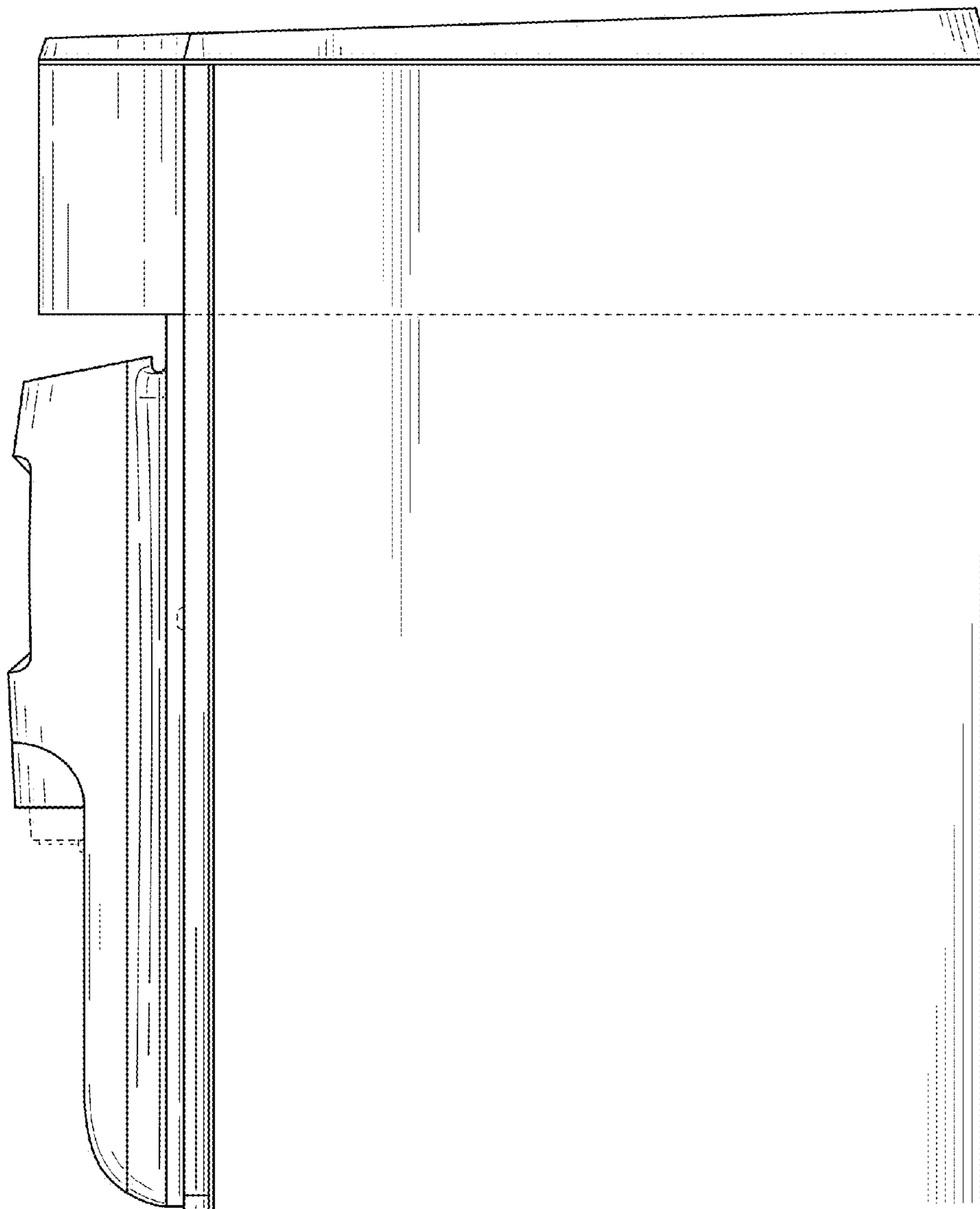

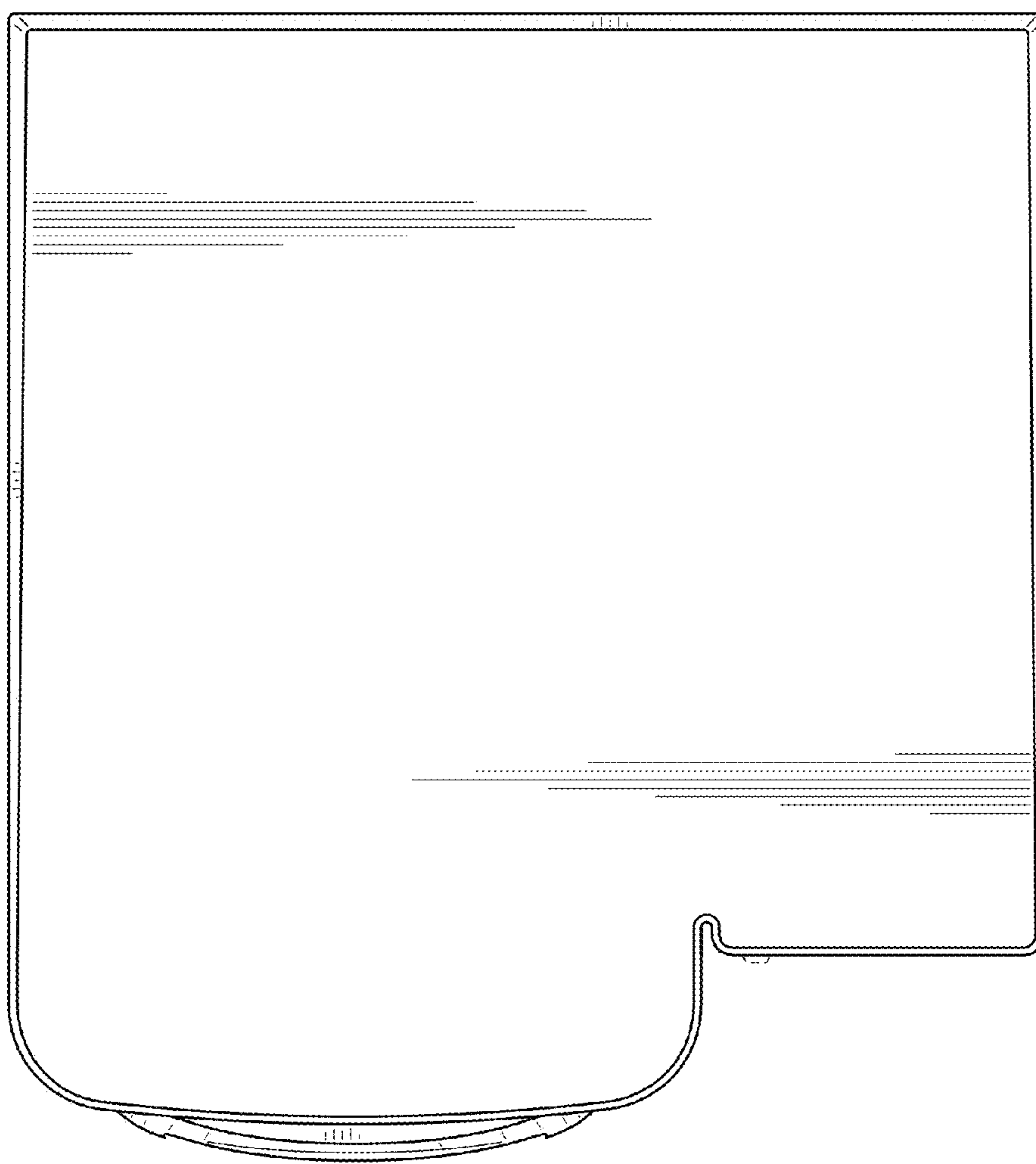

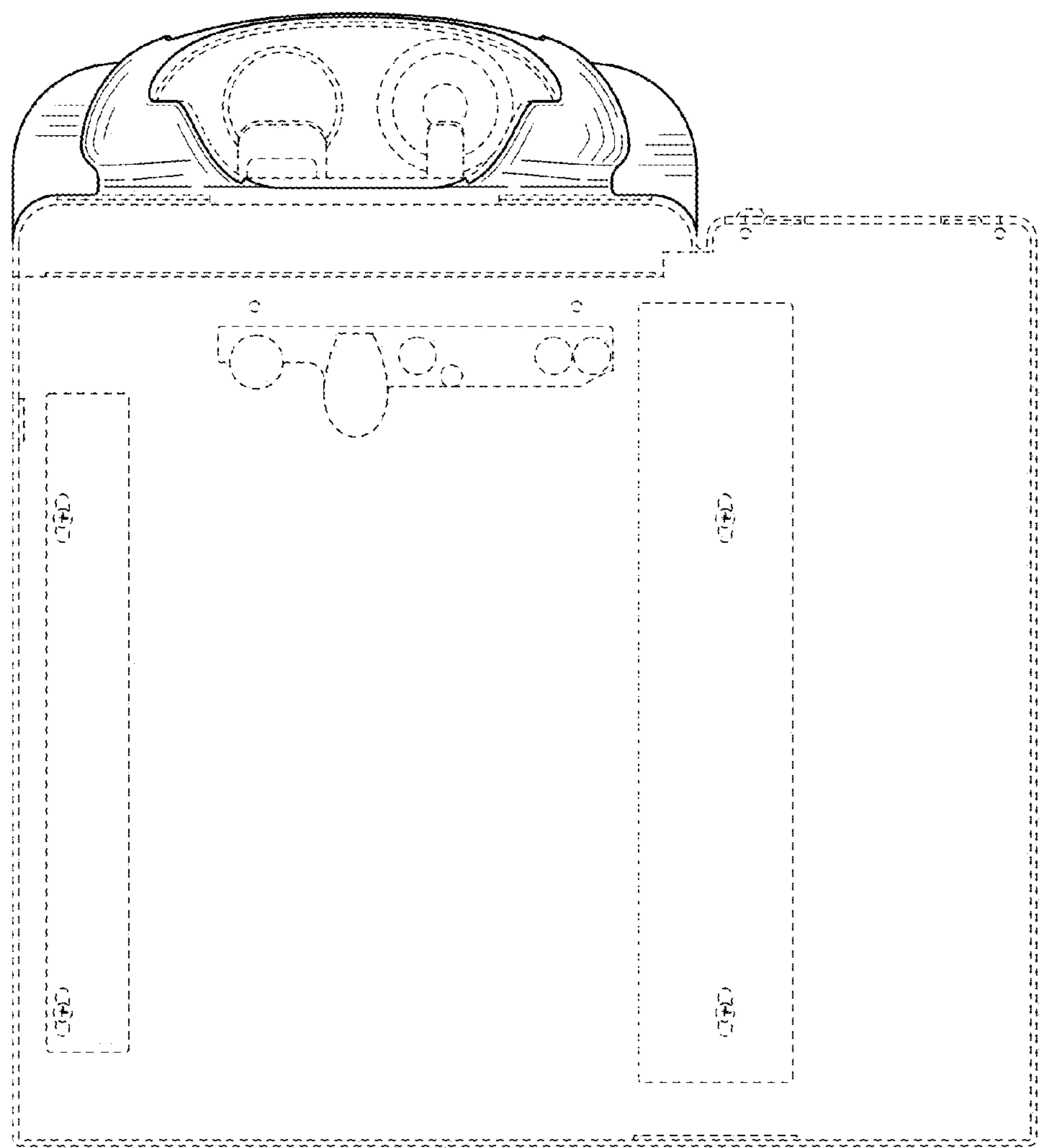

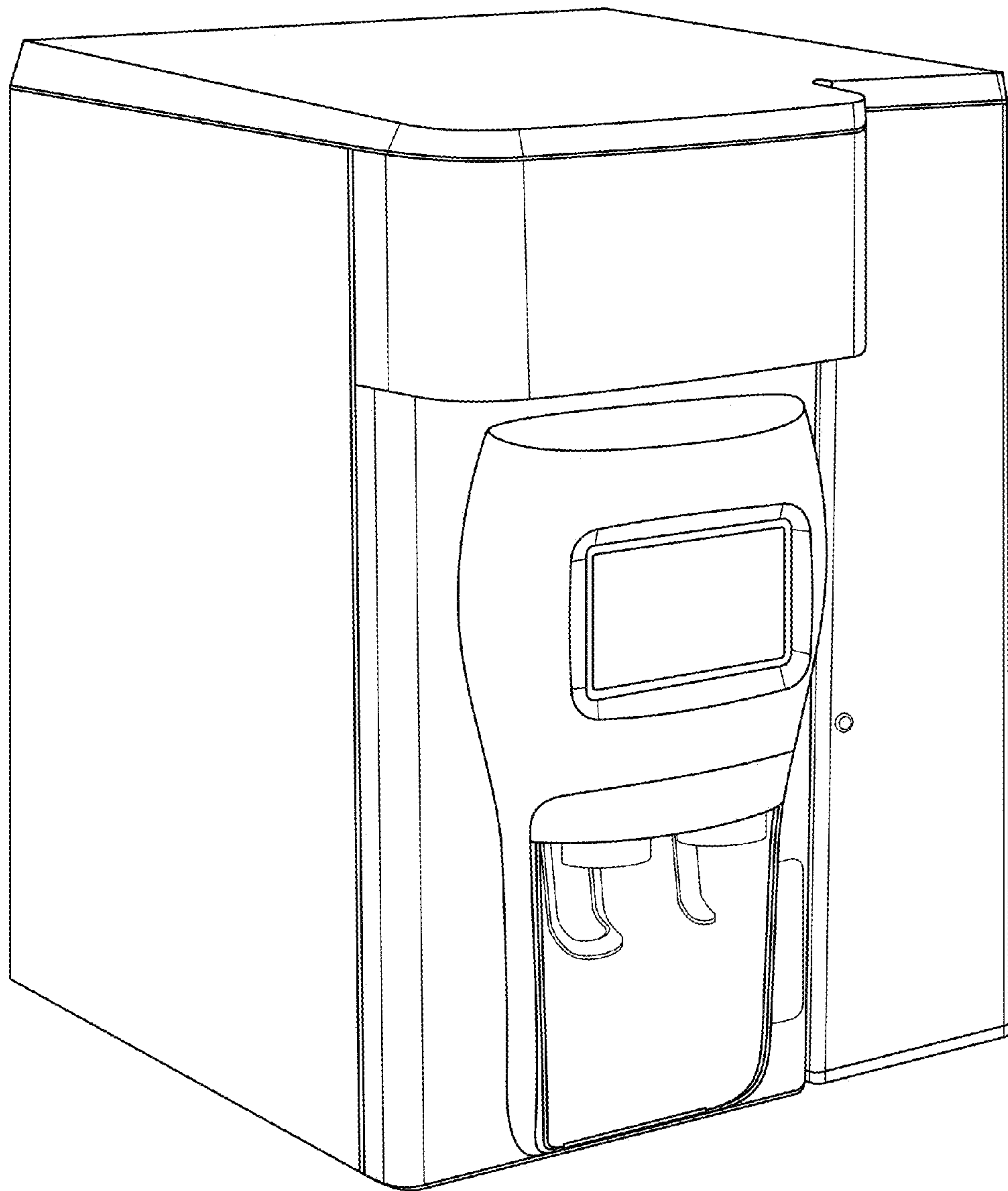

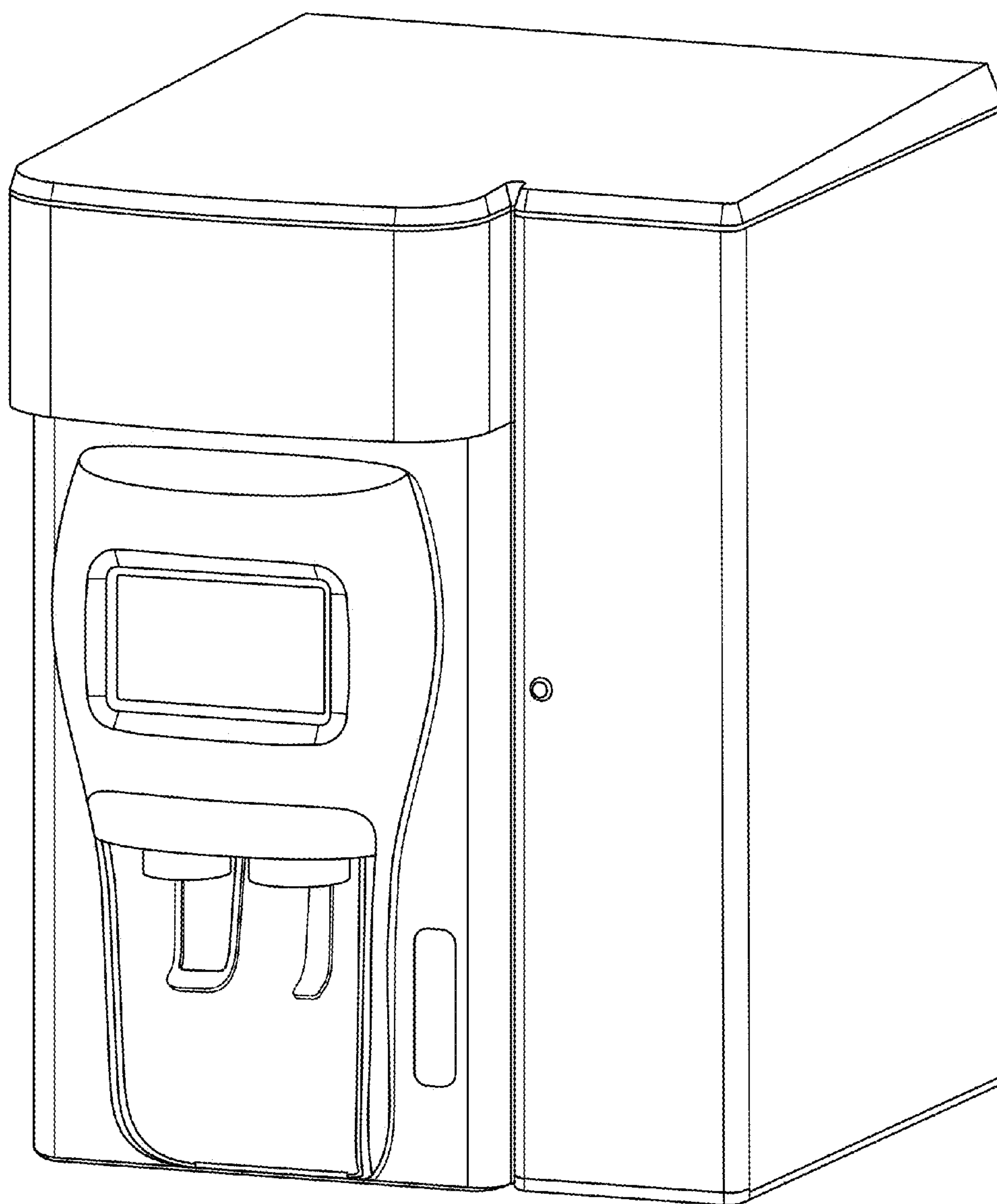

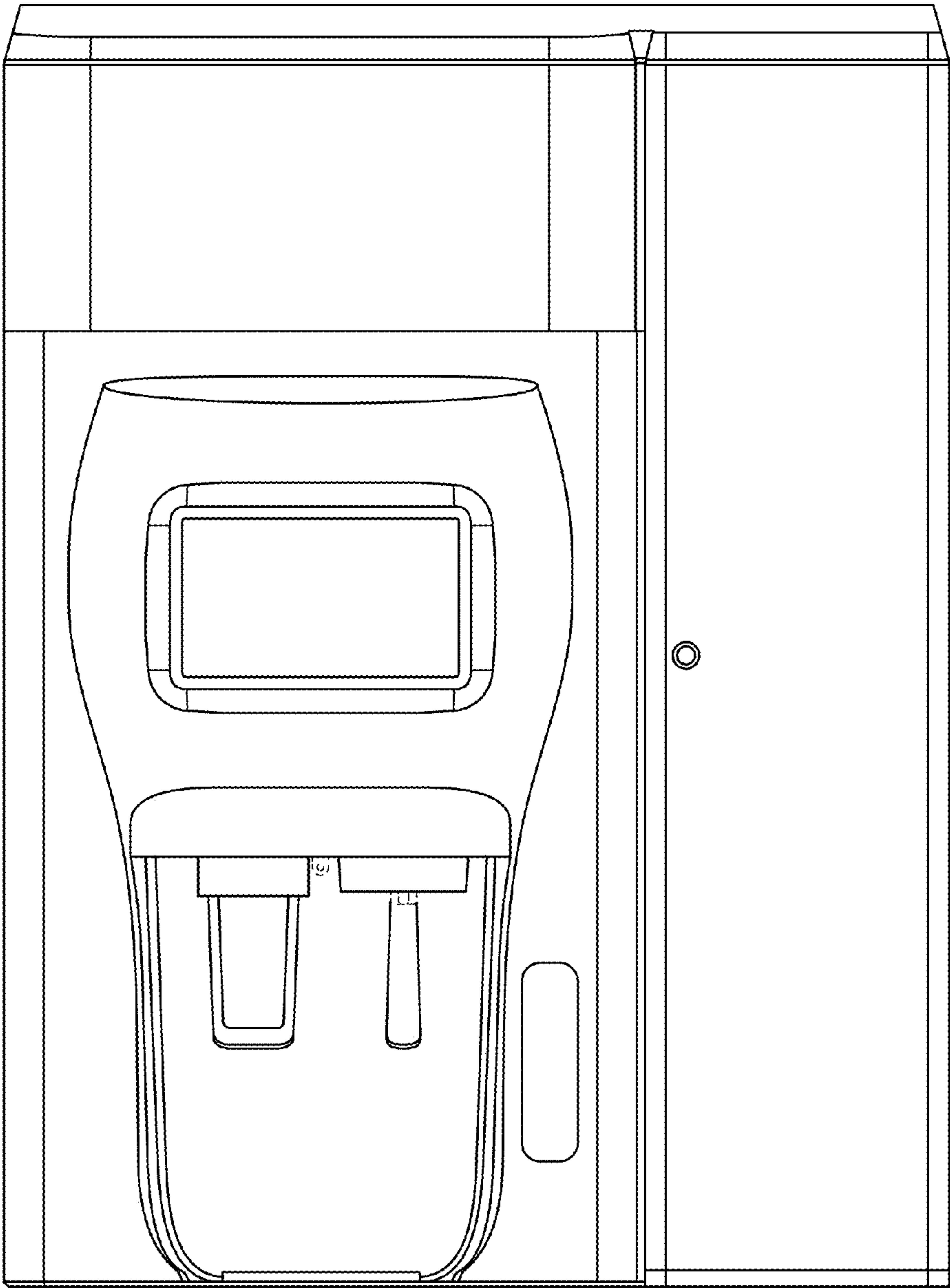

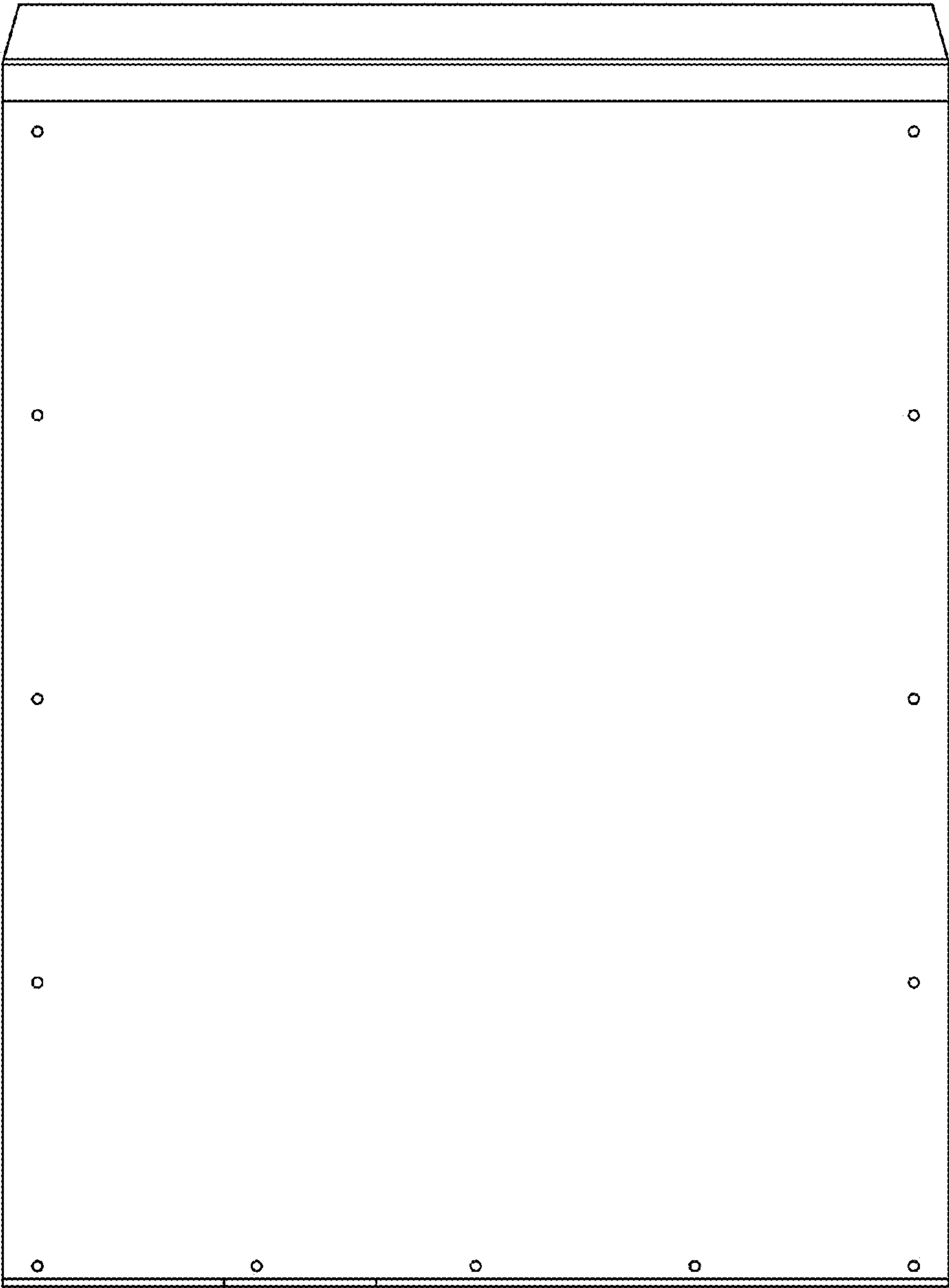

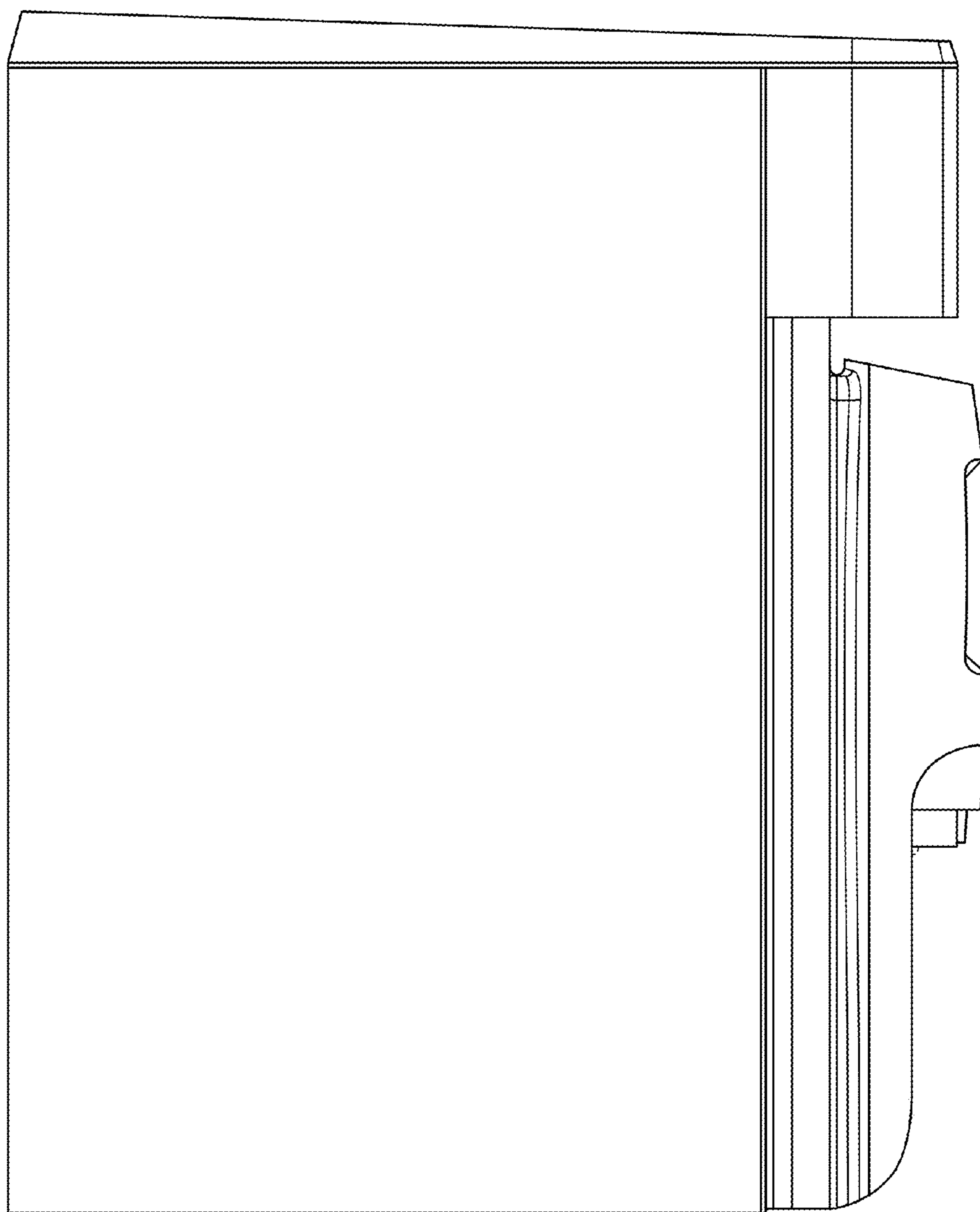

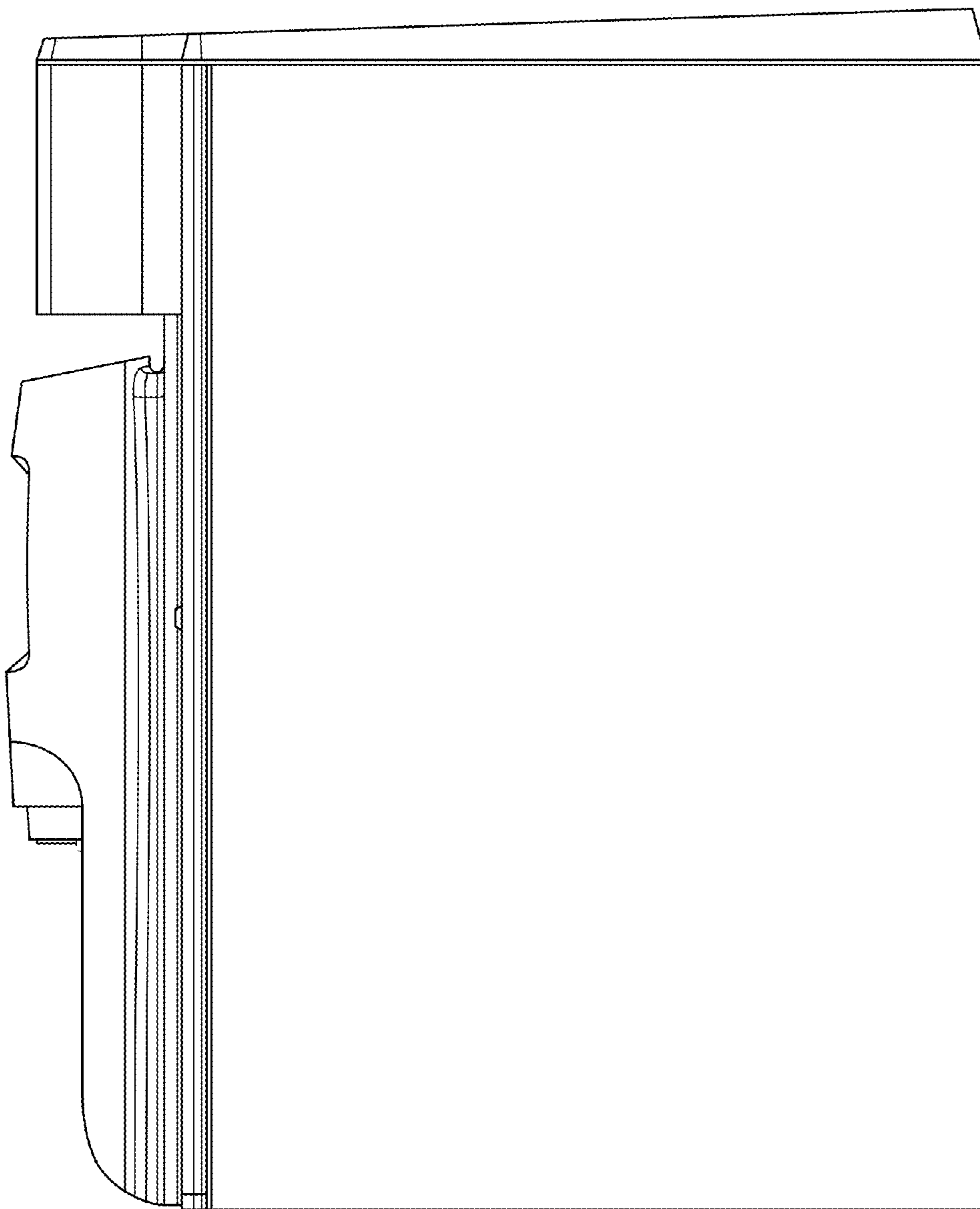

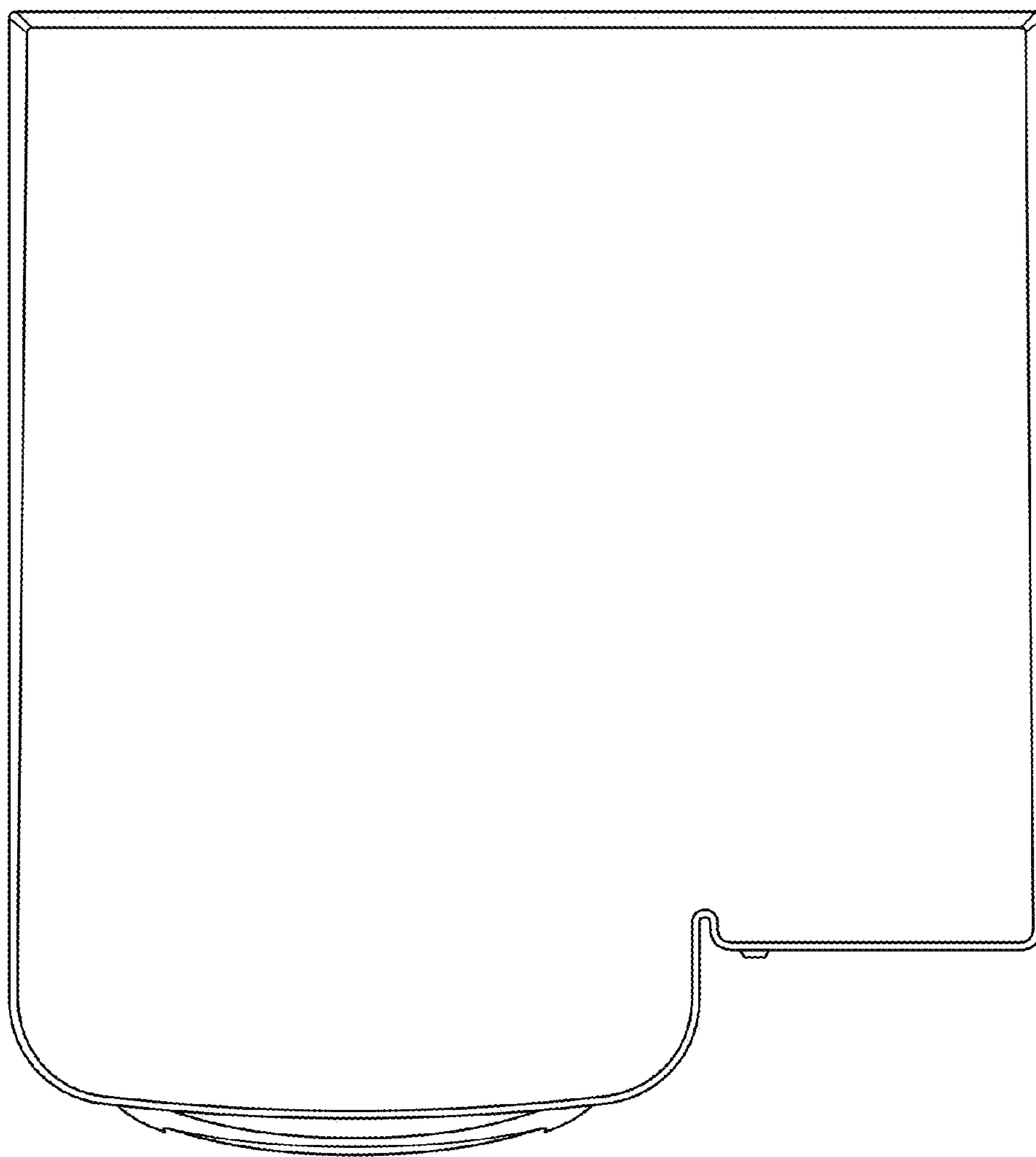

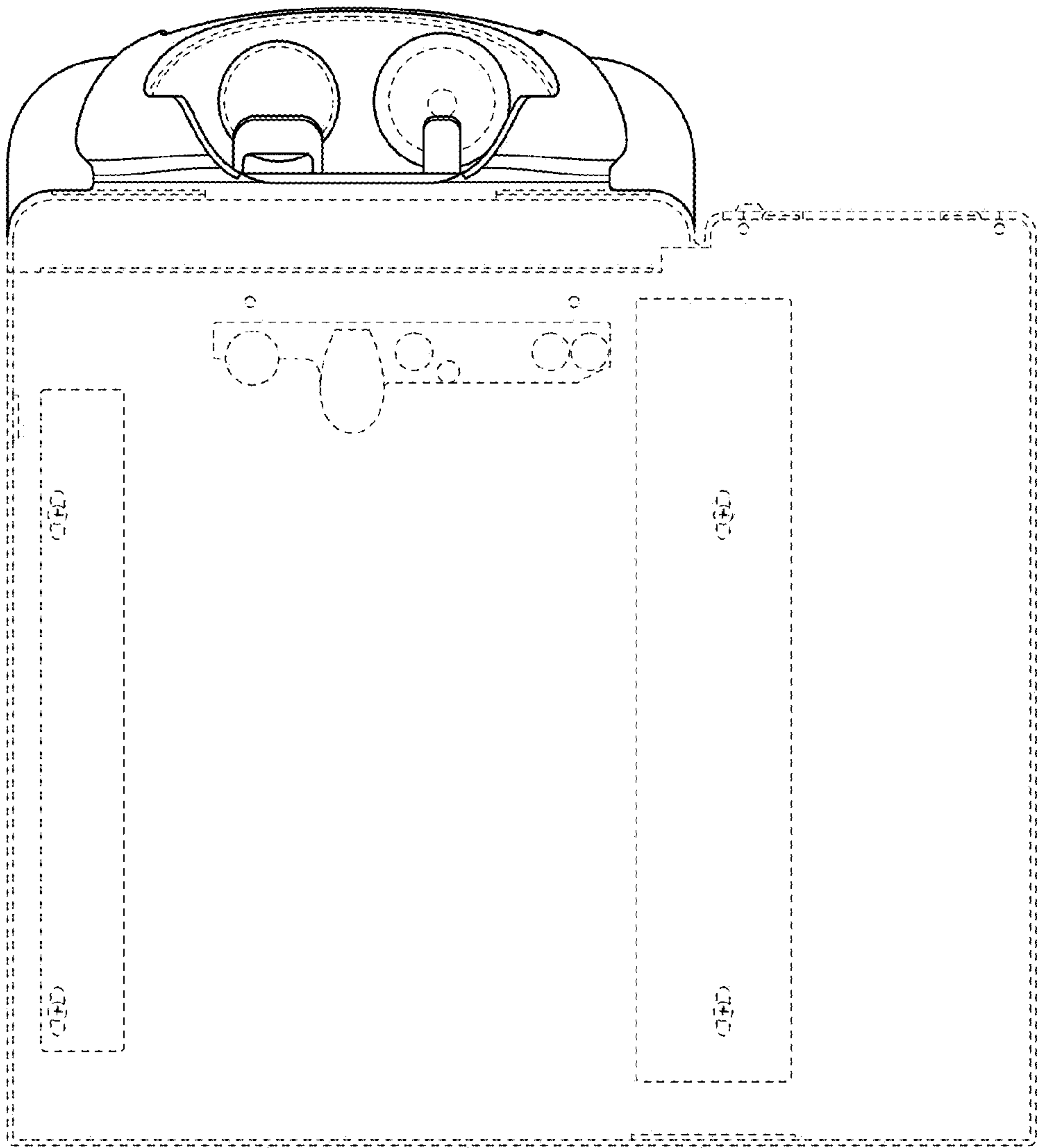
