(57) **CLAIM**

The ornamental design for the combined insert and screw element, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an insert for screw element in accordance with the present design.

FIG. 2 is an exploded perspective view of the insert for screw element in FIG. 1.

FIG. 3 is a front view of the insert for screw element in FIG. 1.

FIG. 4 is an exploded front view of the insert for screw element in FIG. 1.

FIG. 5 is a left side view of the insert for screw element in FIG. 1. The right side view is a mirror image of the left side view.

FIG. 6 is an exploded left side view of the insert for screw element in FIG. 1. The exploded right side view is a mirror image of the left side view.

FIG. 7 is a side view of the insert for screw element in FIG. 1.

FIG. 8 is an exploded side view of the insert for screw element in FIG. 1.

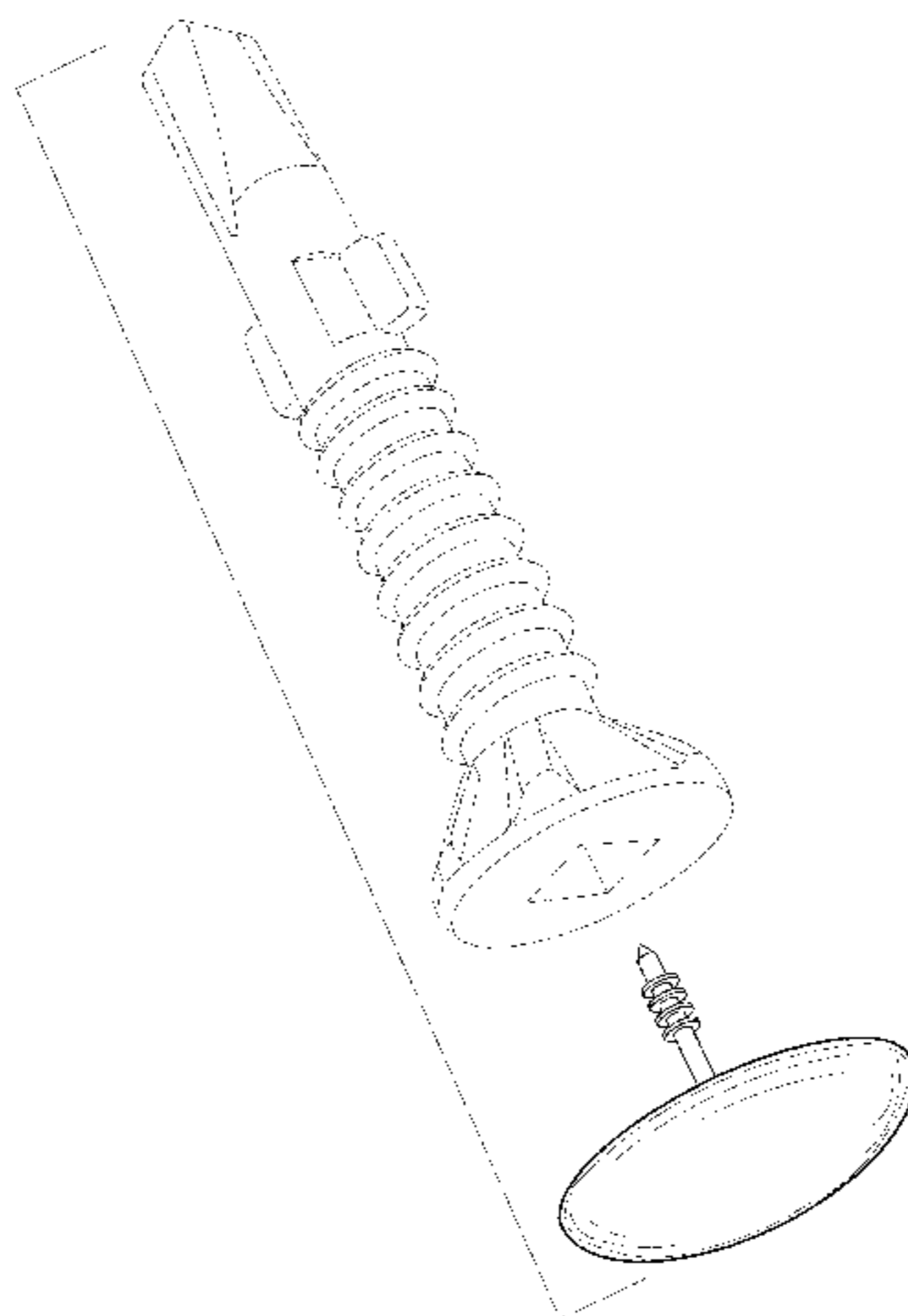
FIG. 9 is a top view of the insert for screw element in FIG. 1.

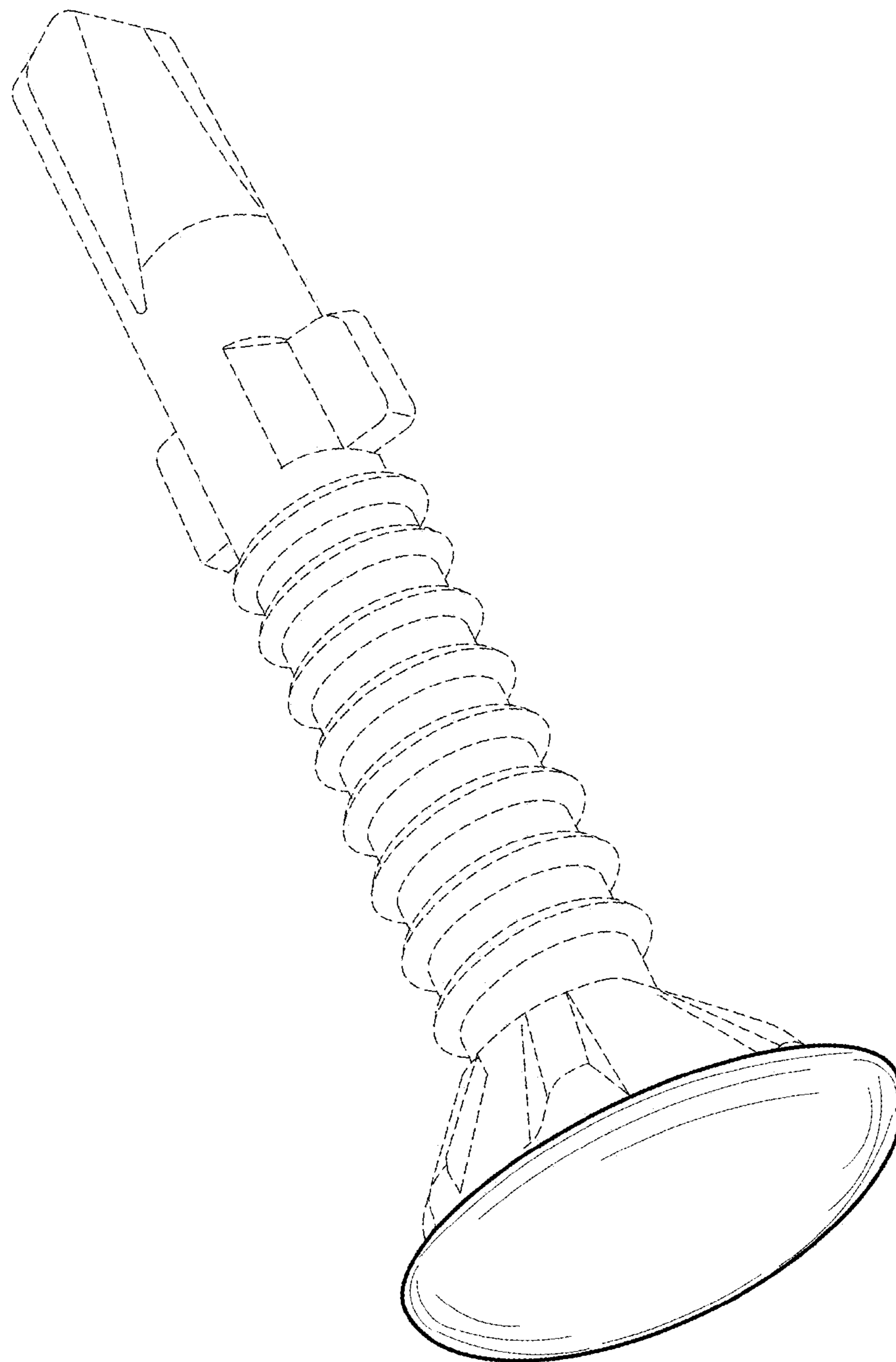

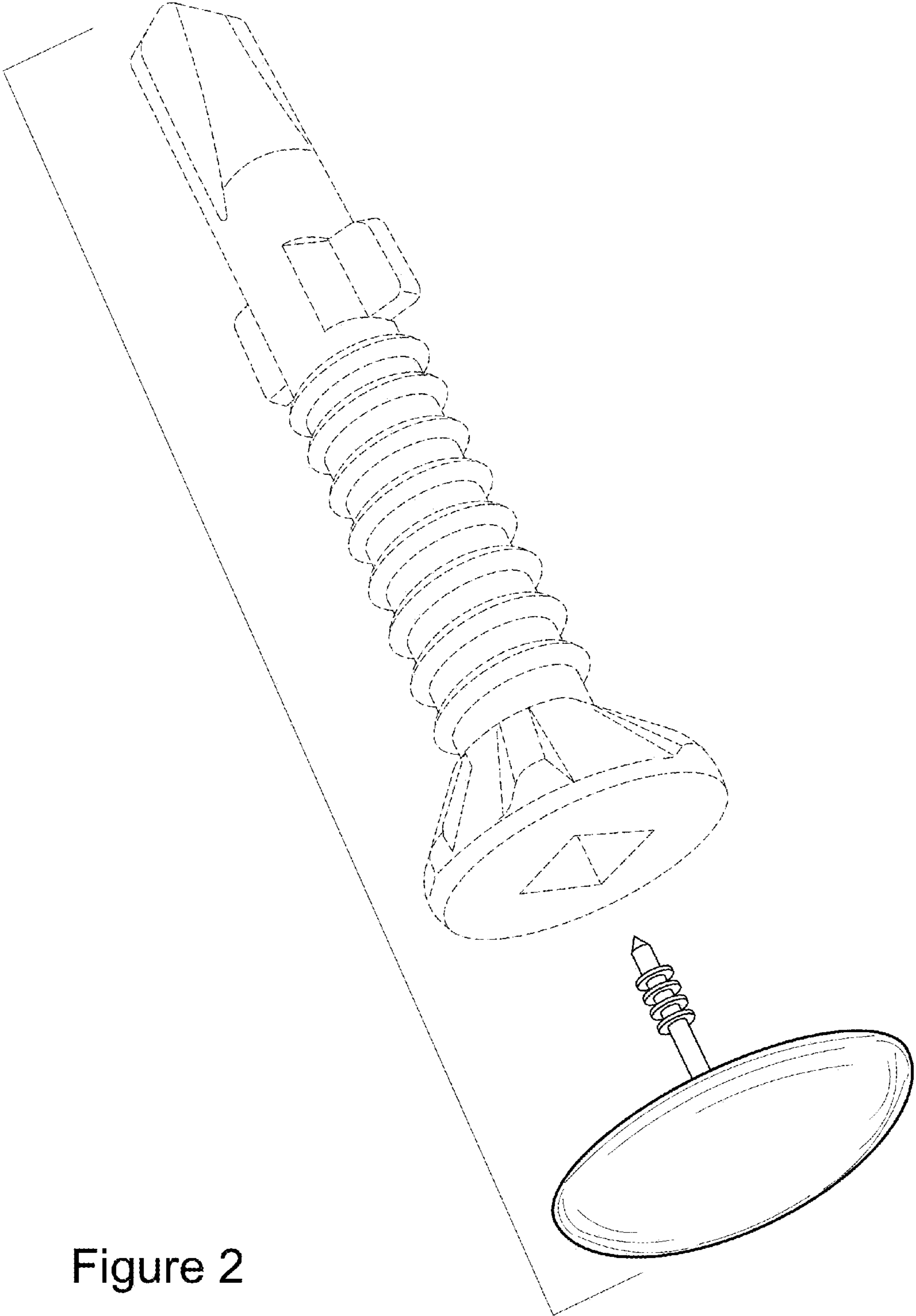

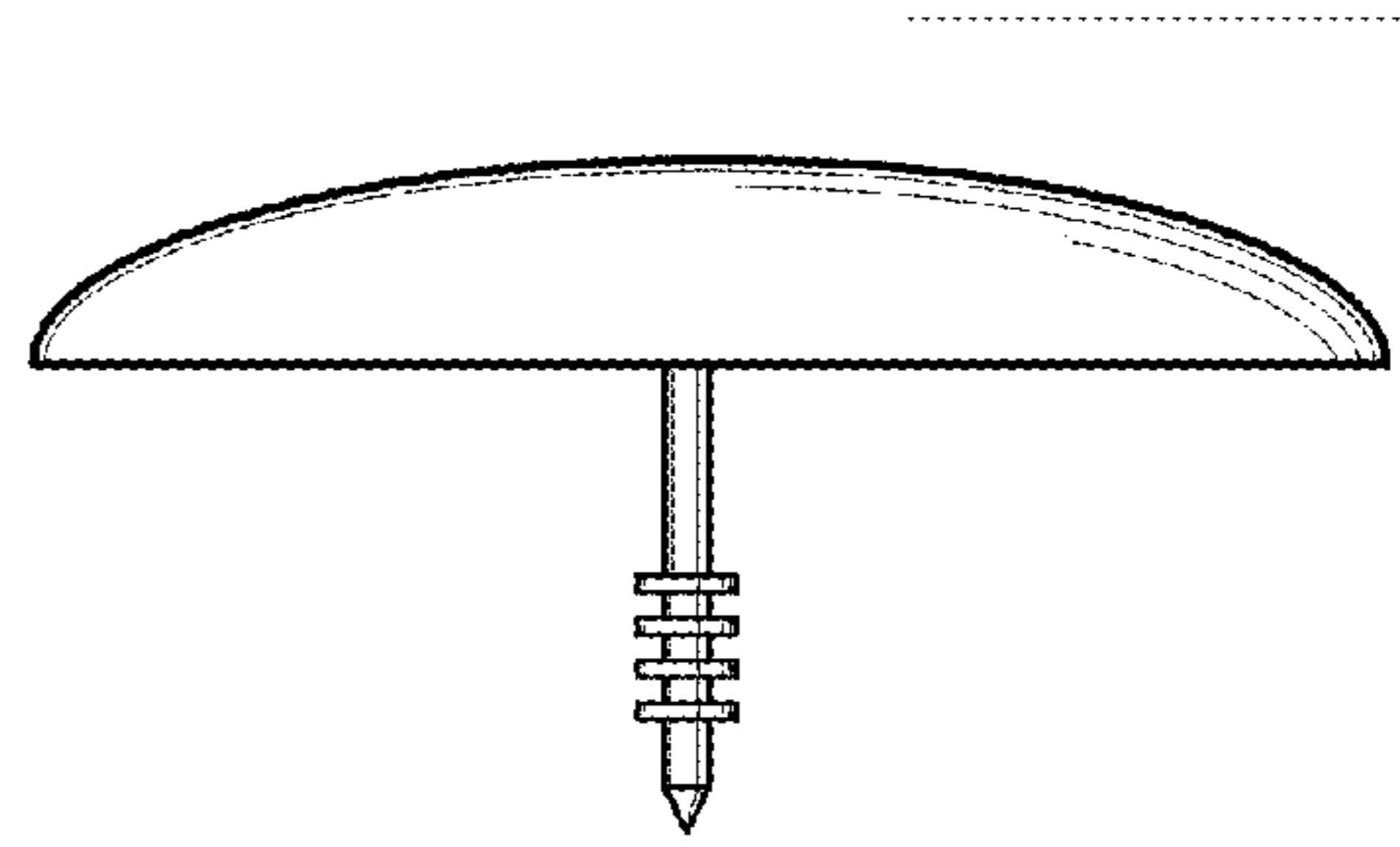
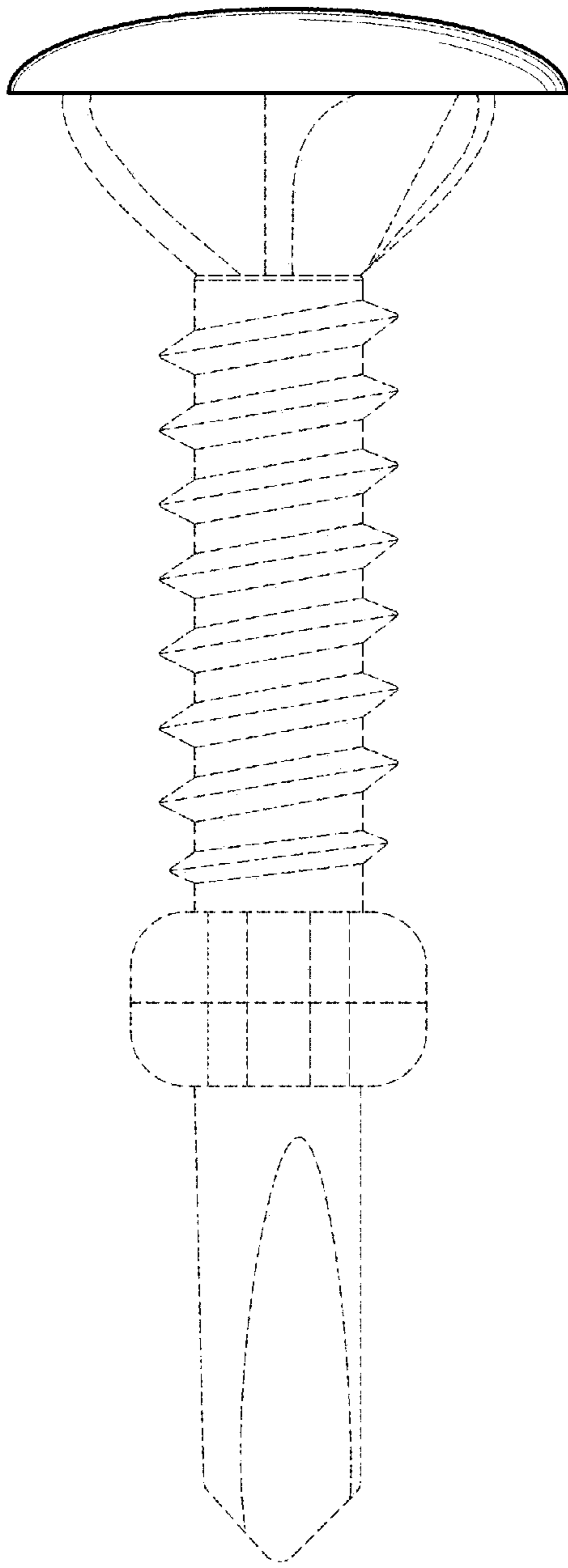

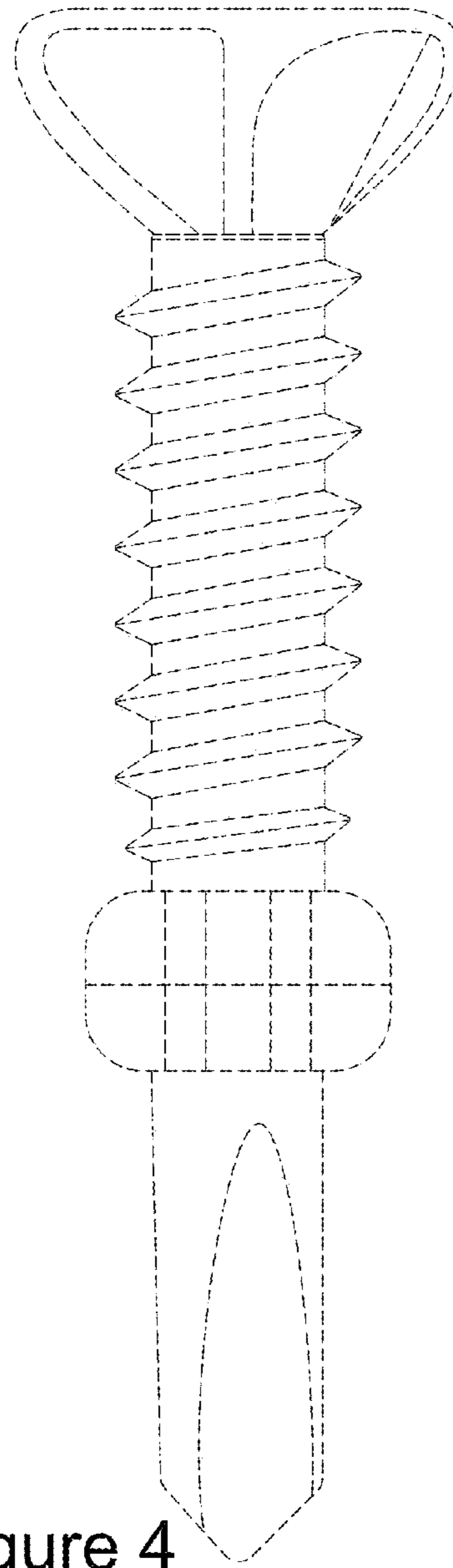

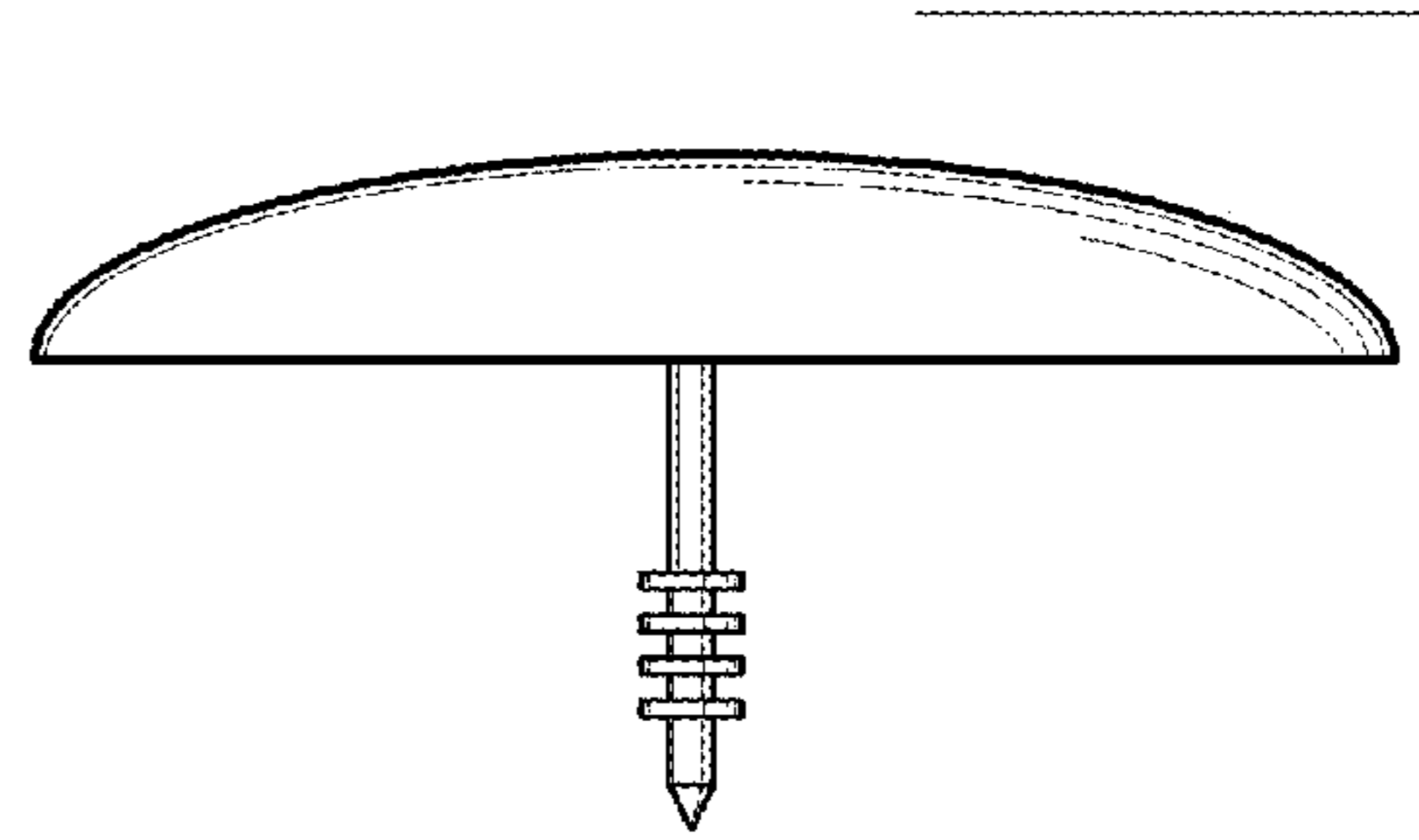
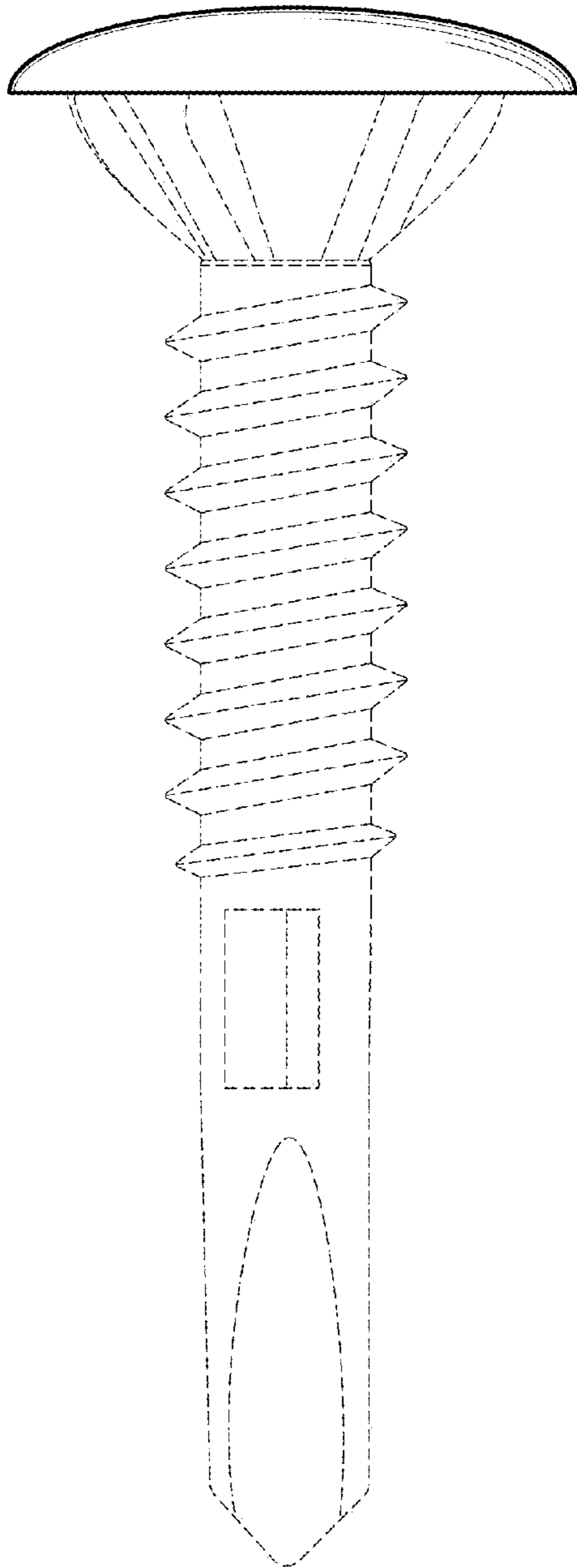

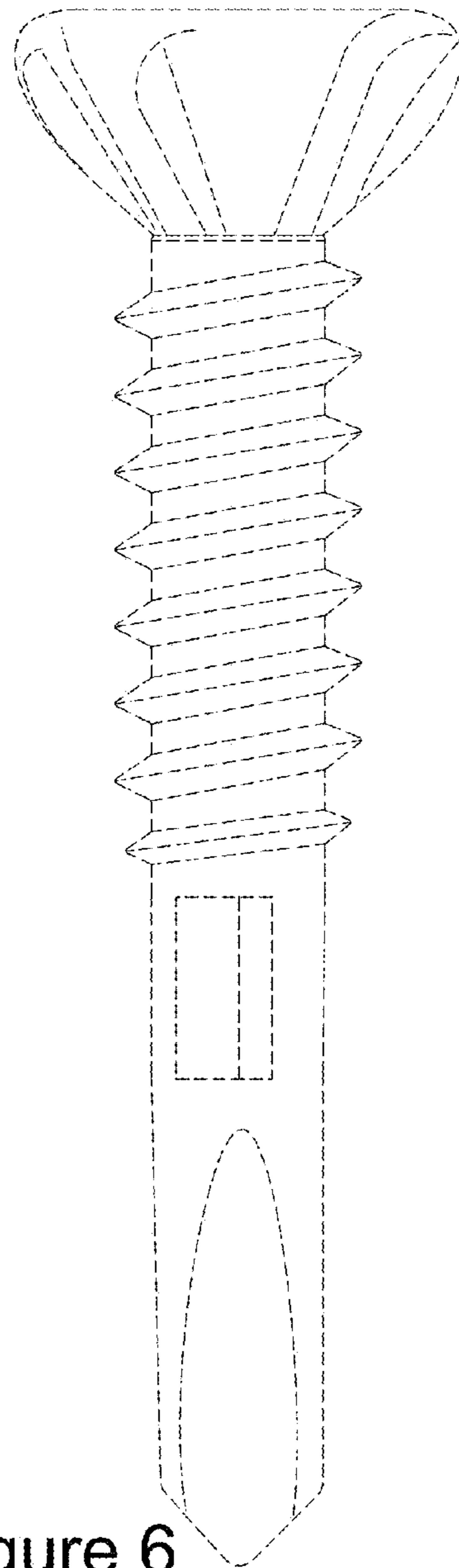

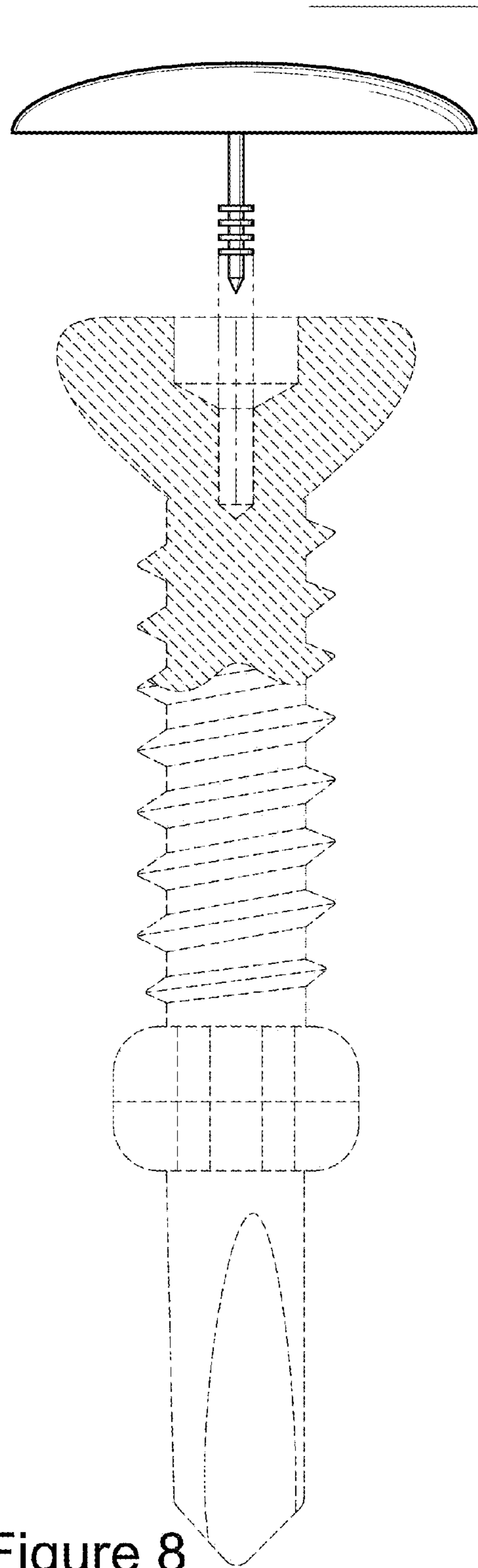
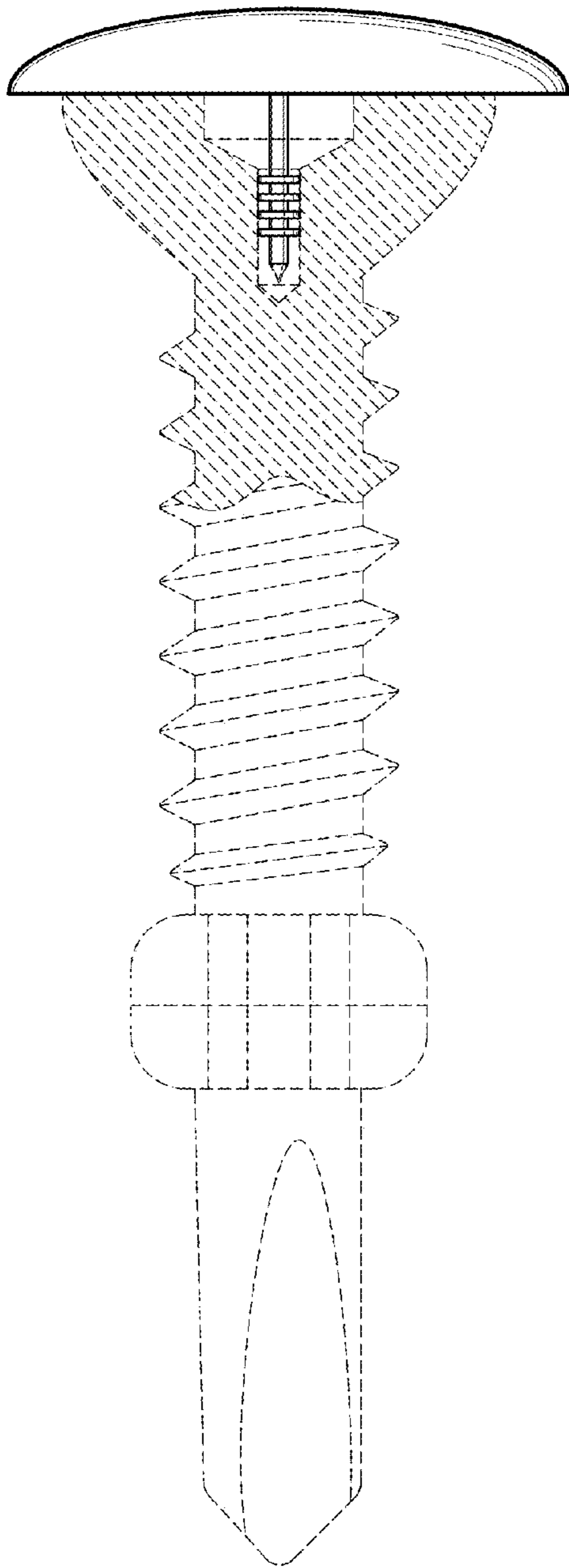

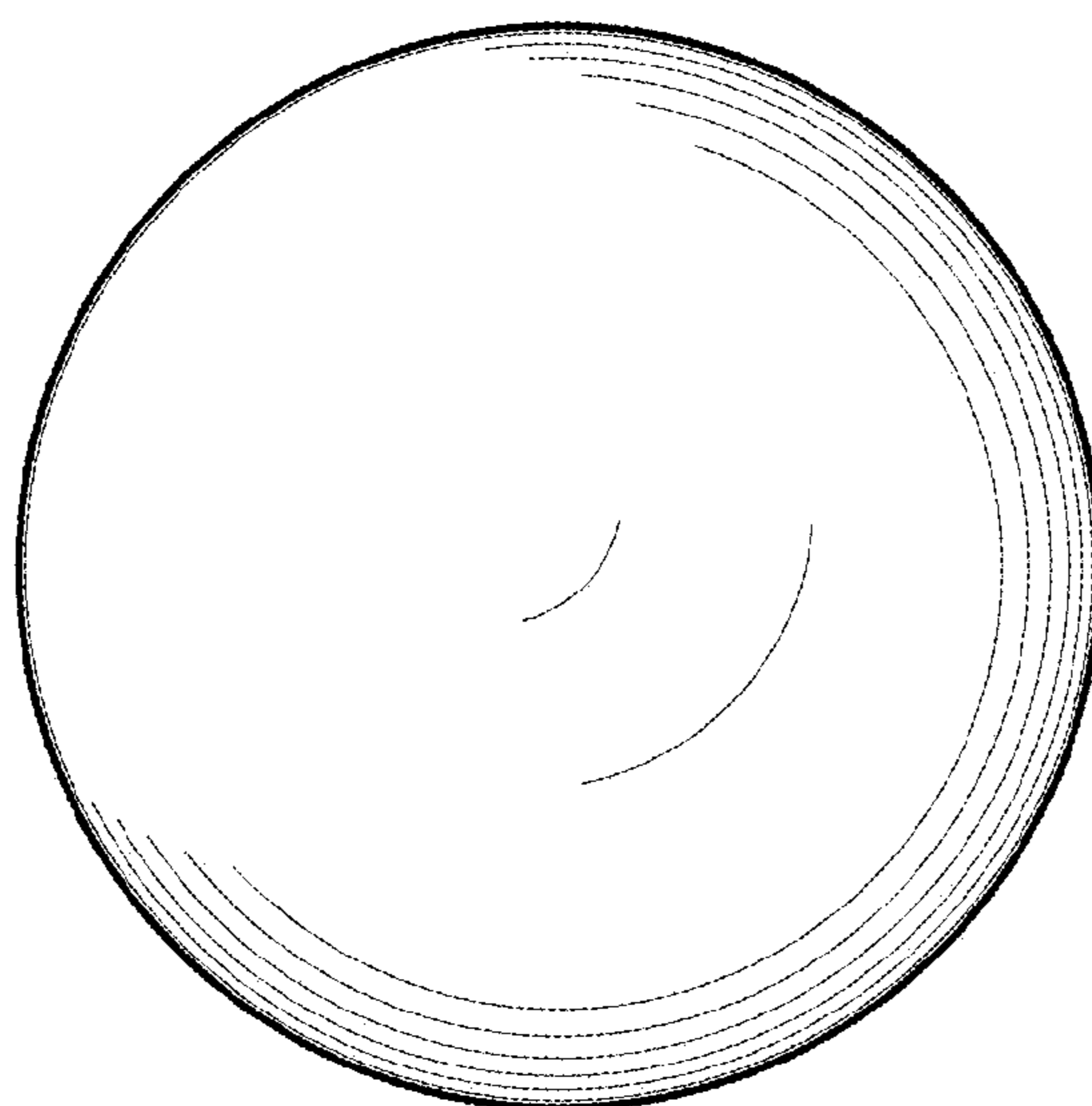

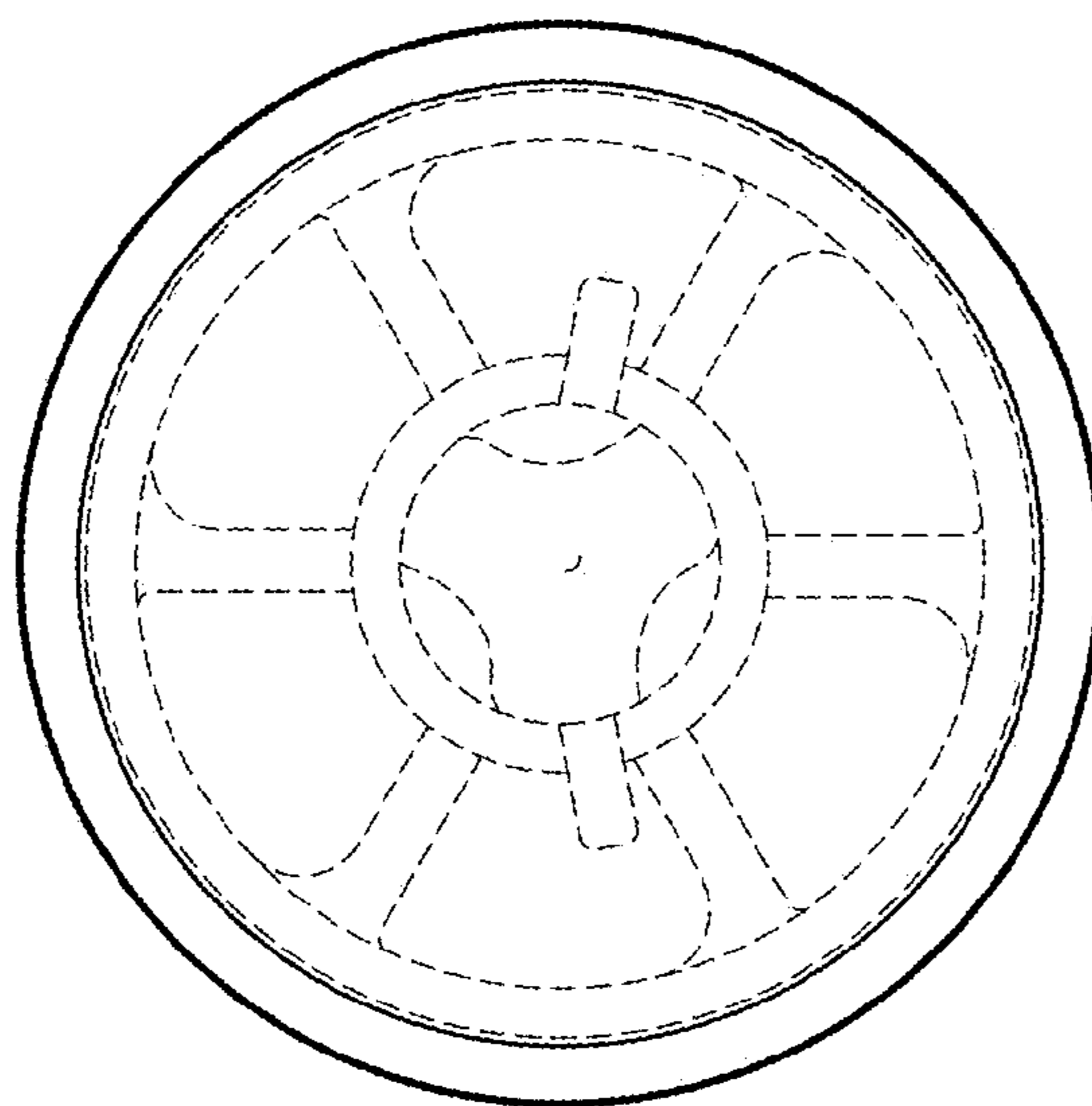

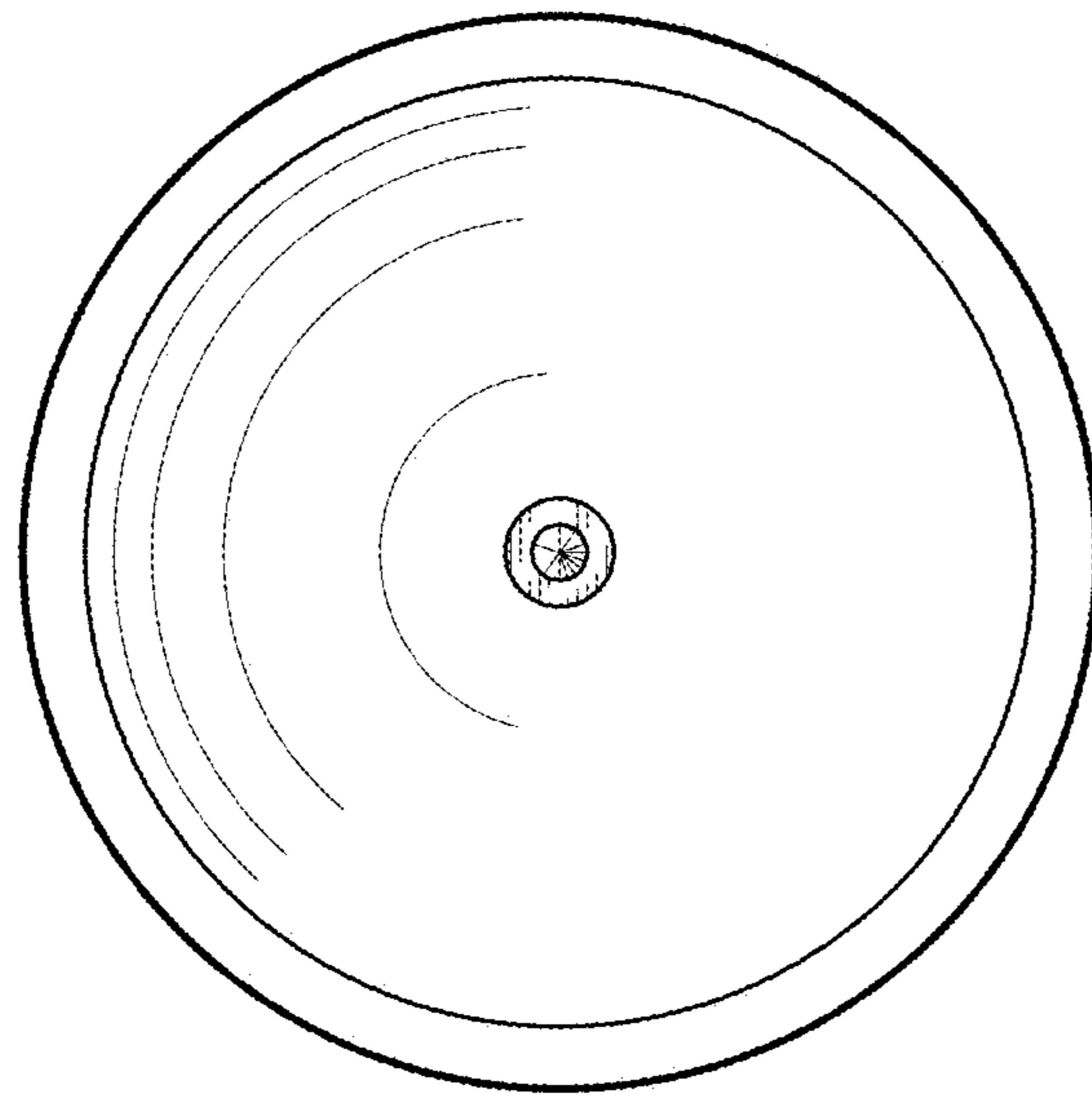
