The ornamental design for a package, as shown and described.

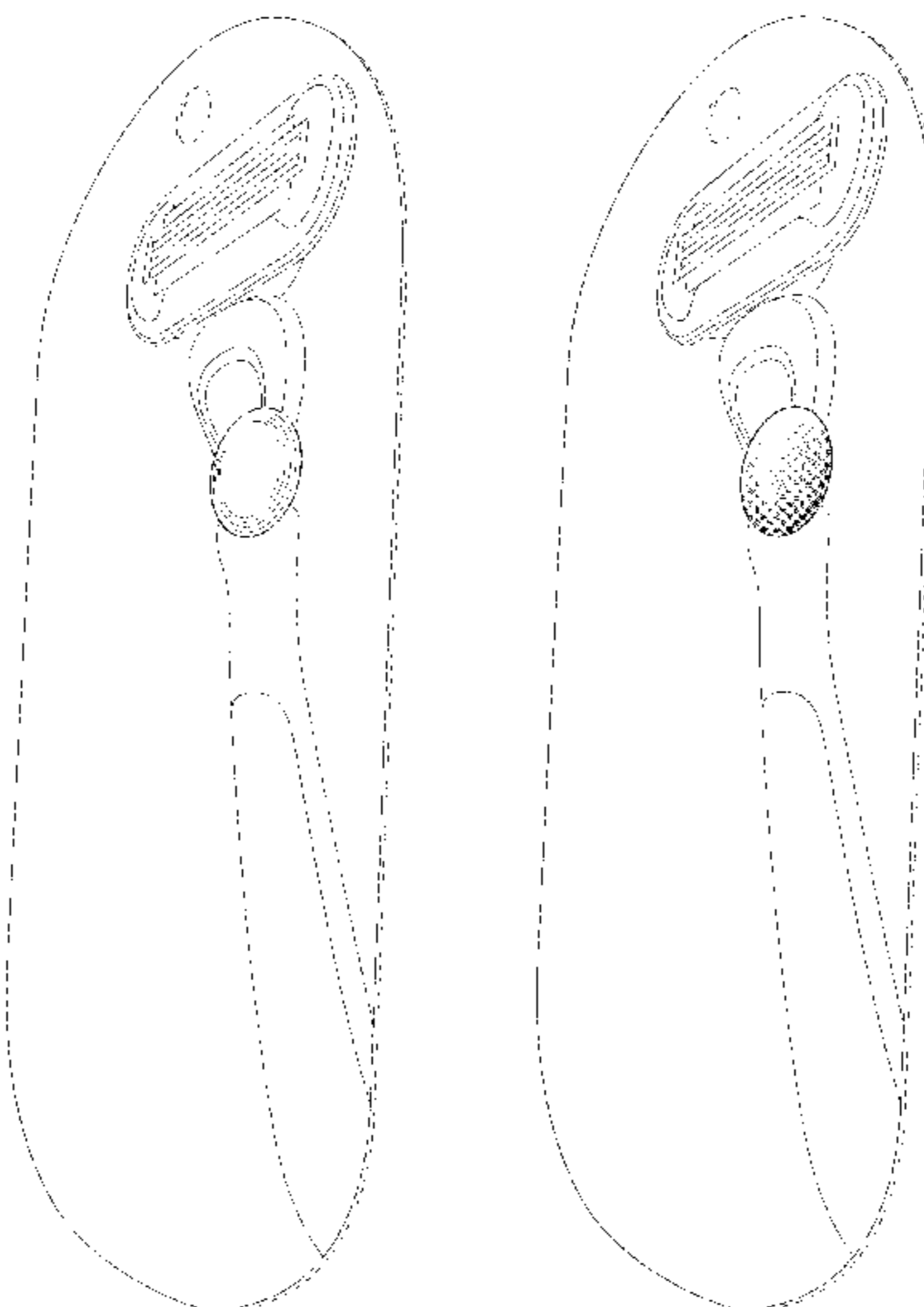
**DESCRIPTION**

FIG. 1 is a front perspective view of a design for a package of the present invention;  
FIG. 2 is a front view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof;  
FIG. 8 is a front perspective view of a second embodiment for a package of the present invention;  
FIG. 9 is a front view thereof;  
FIG. 10 is a right side view thereof;  
FIG. 11 is a rear view thereof;  
FIG. 12 is a left side view thereof;  
FIG. 13 is a top view thereof; and,  
FIG. 14 is a bottom view thereof.

The linear shade lines in FIGS. 1-7 represent a raised surface having no particular distinctive surface quality; the stippling in FIGS. 8-14 represents a raised surface having a matte appearance.

In the drawings, the broken lines depict environment subject matter only that forms no part of the claimed design.

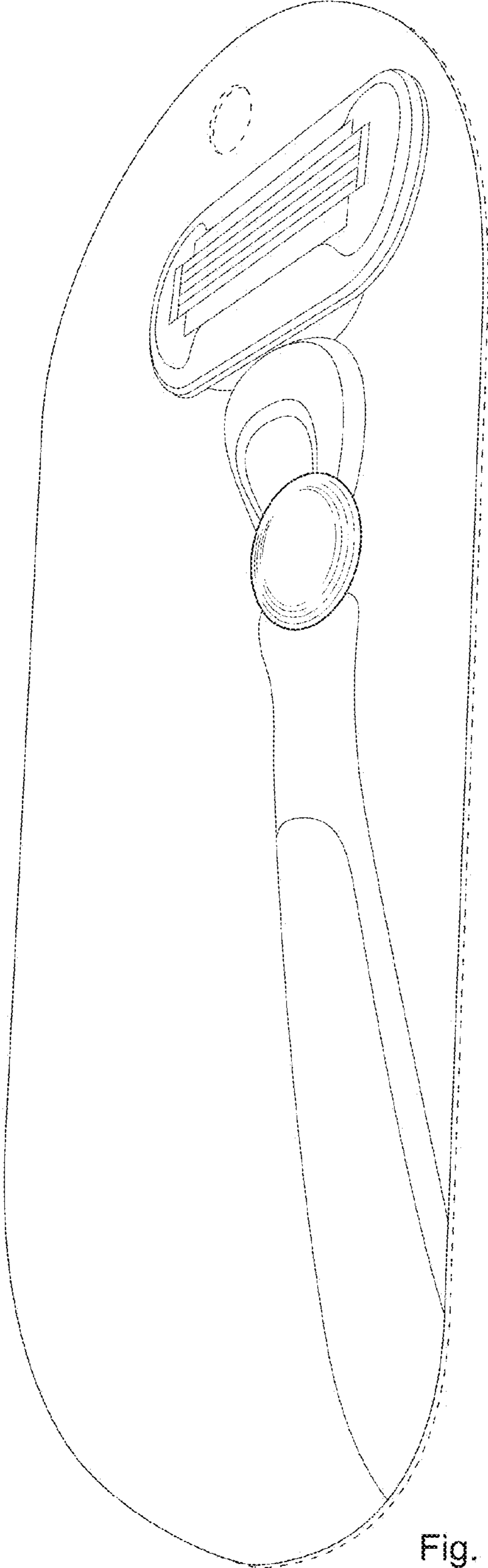

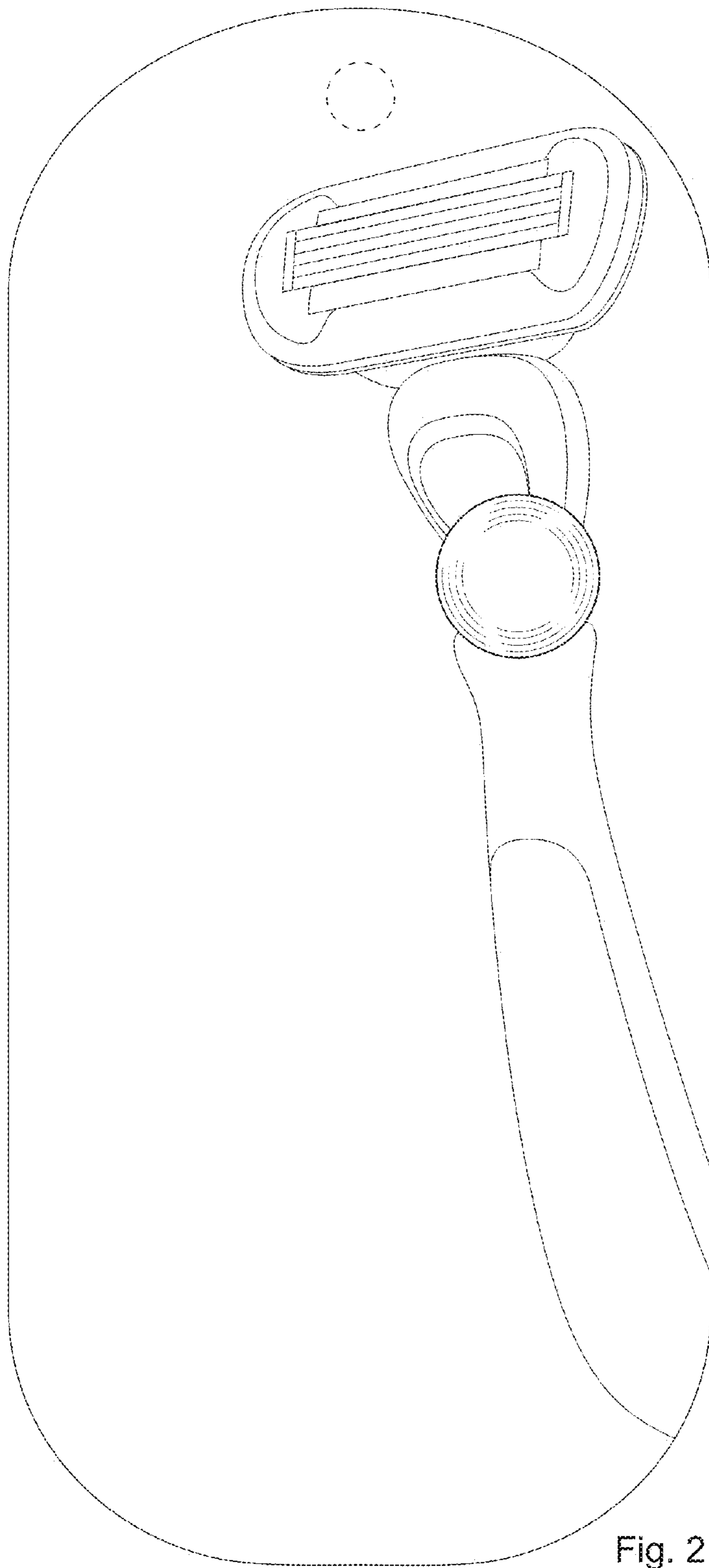

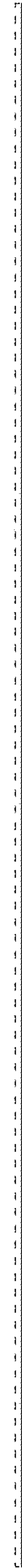

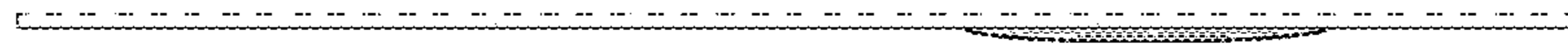

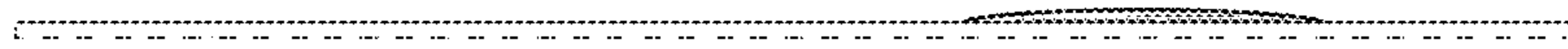

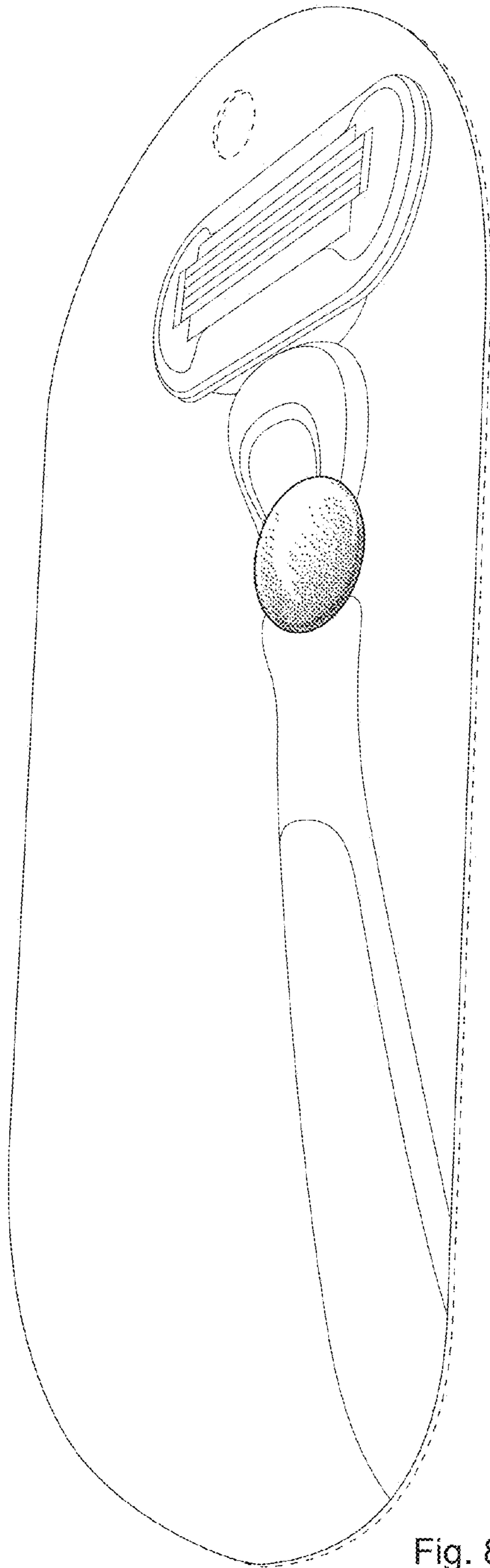

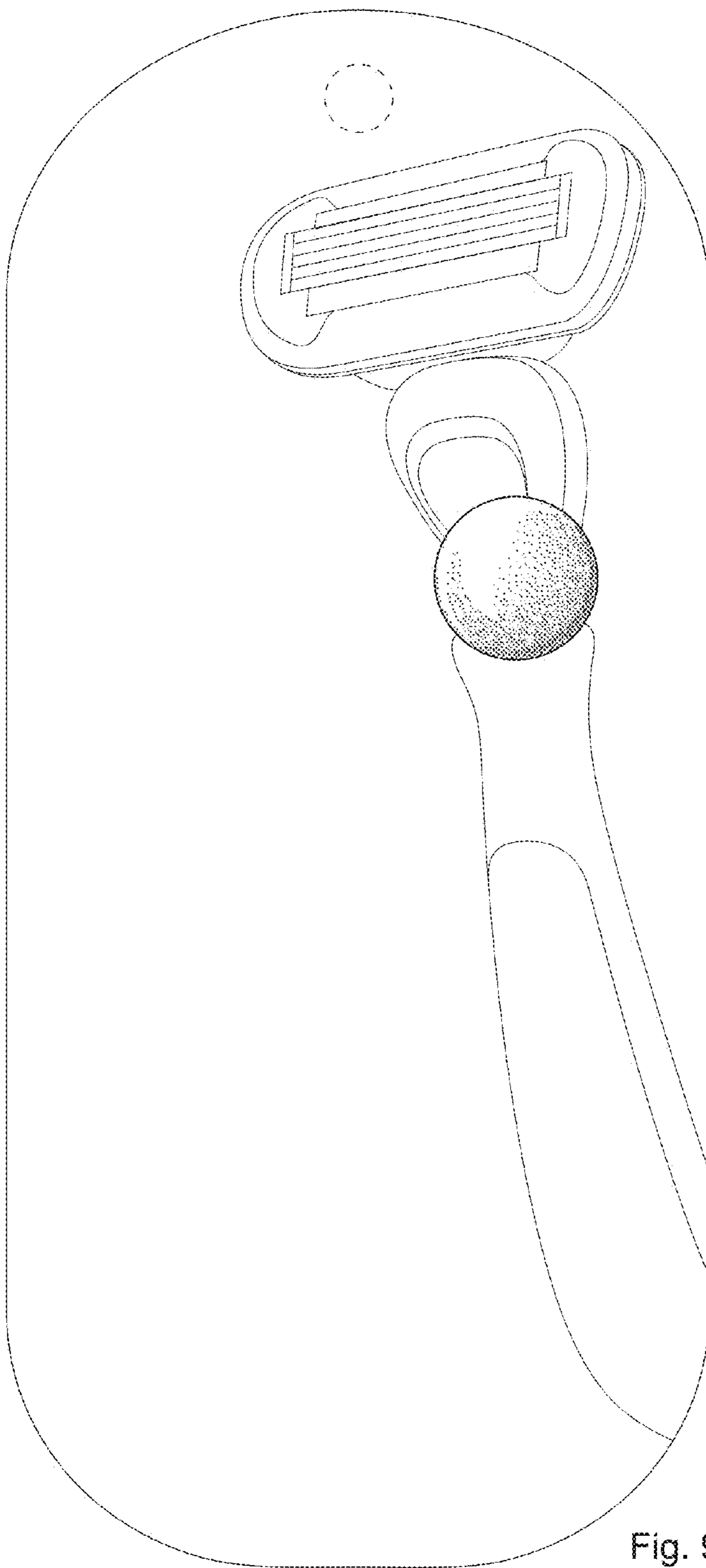

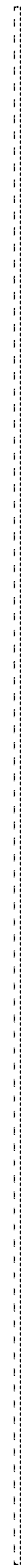

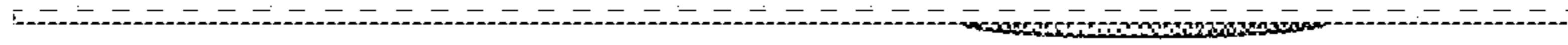

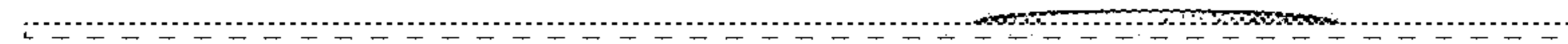
