FIG. 4 is a side view taken generally from the left-hand side of FIG. 3.

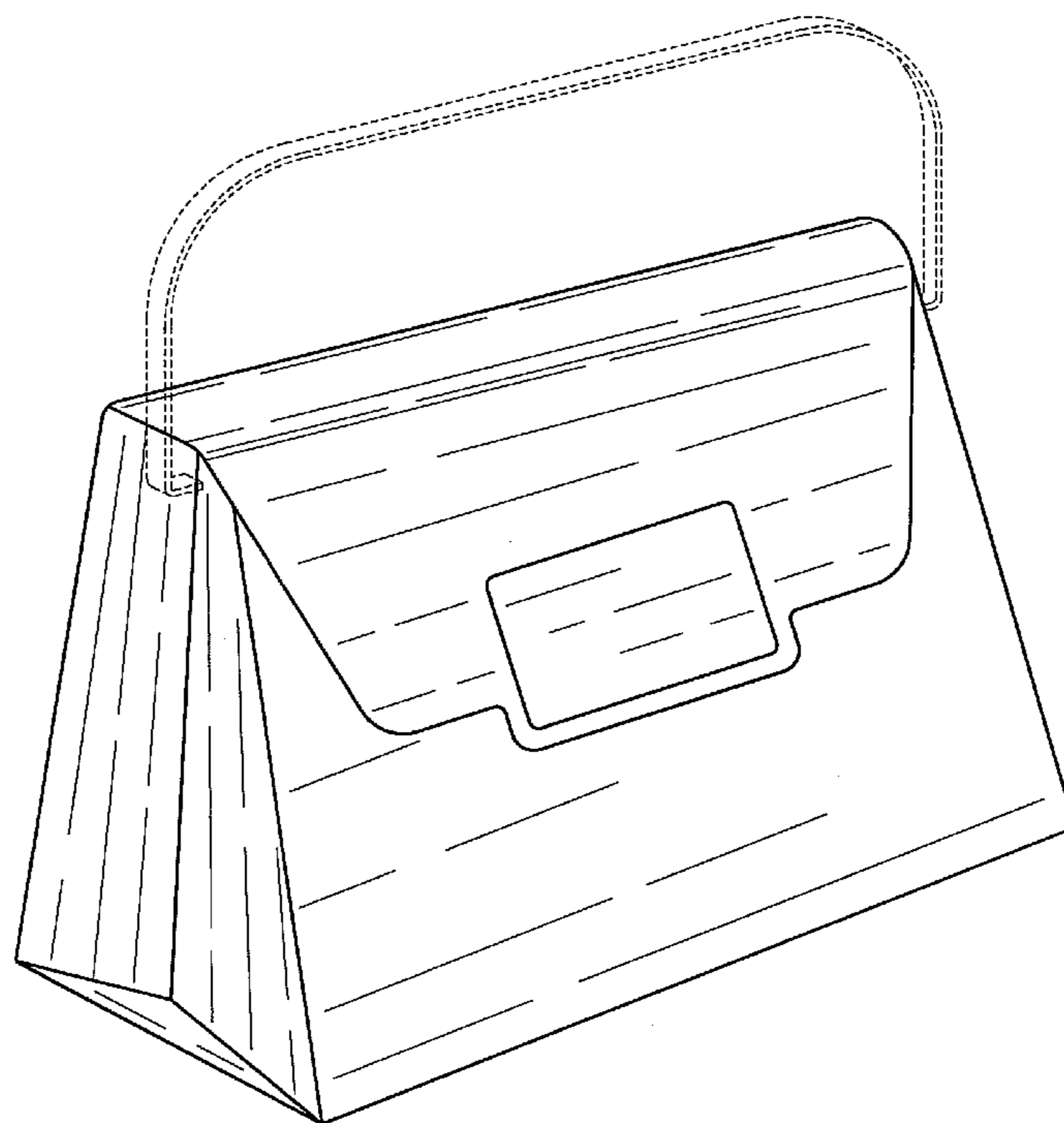
FIG. 5 is a side view taken generally from the right-hand side of FIG. 3.

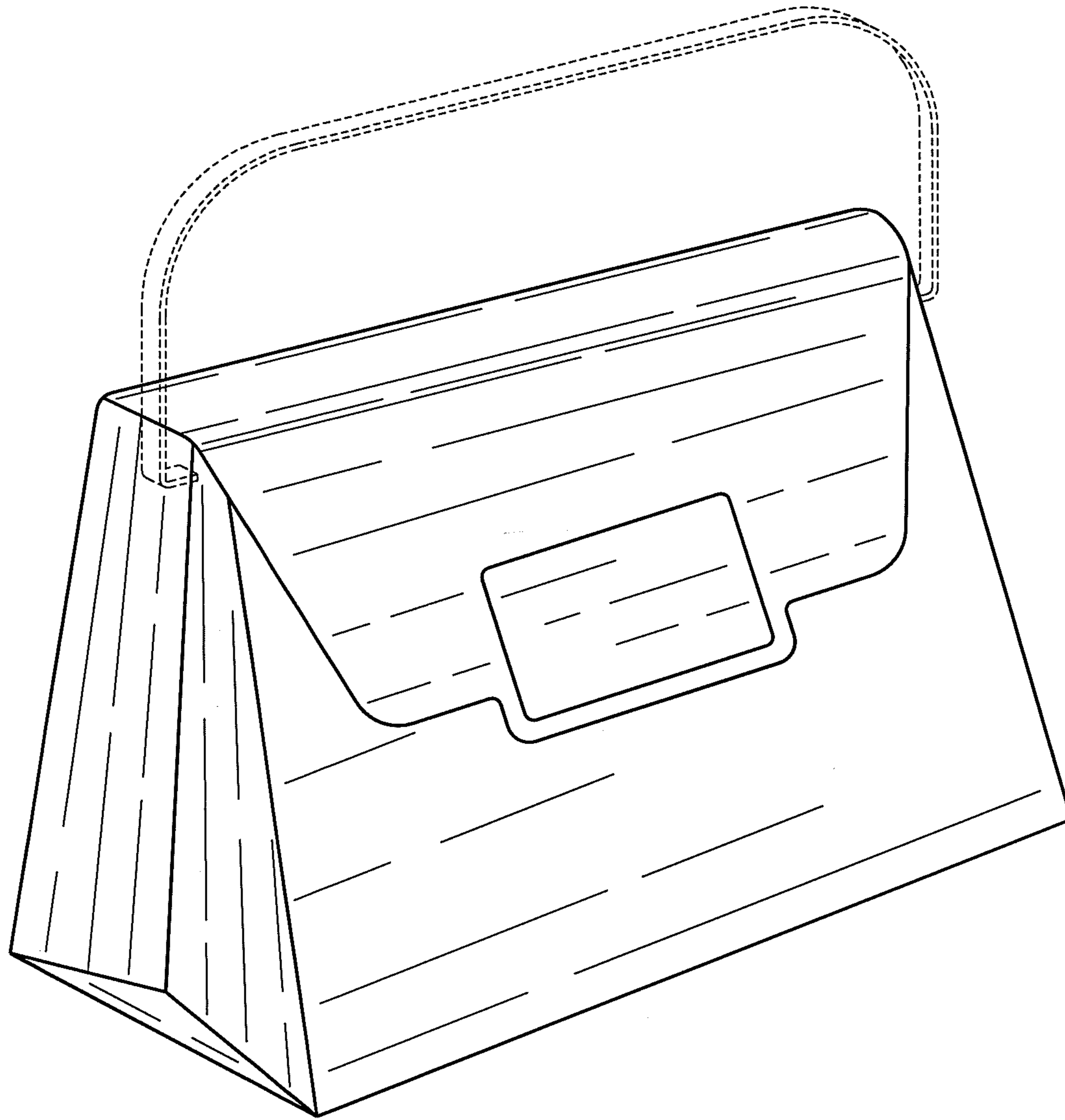
FIG. 6 is a rear view thereof; and,

FIG. 7 is a bottom view thereof.

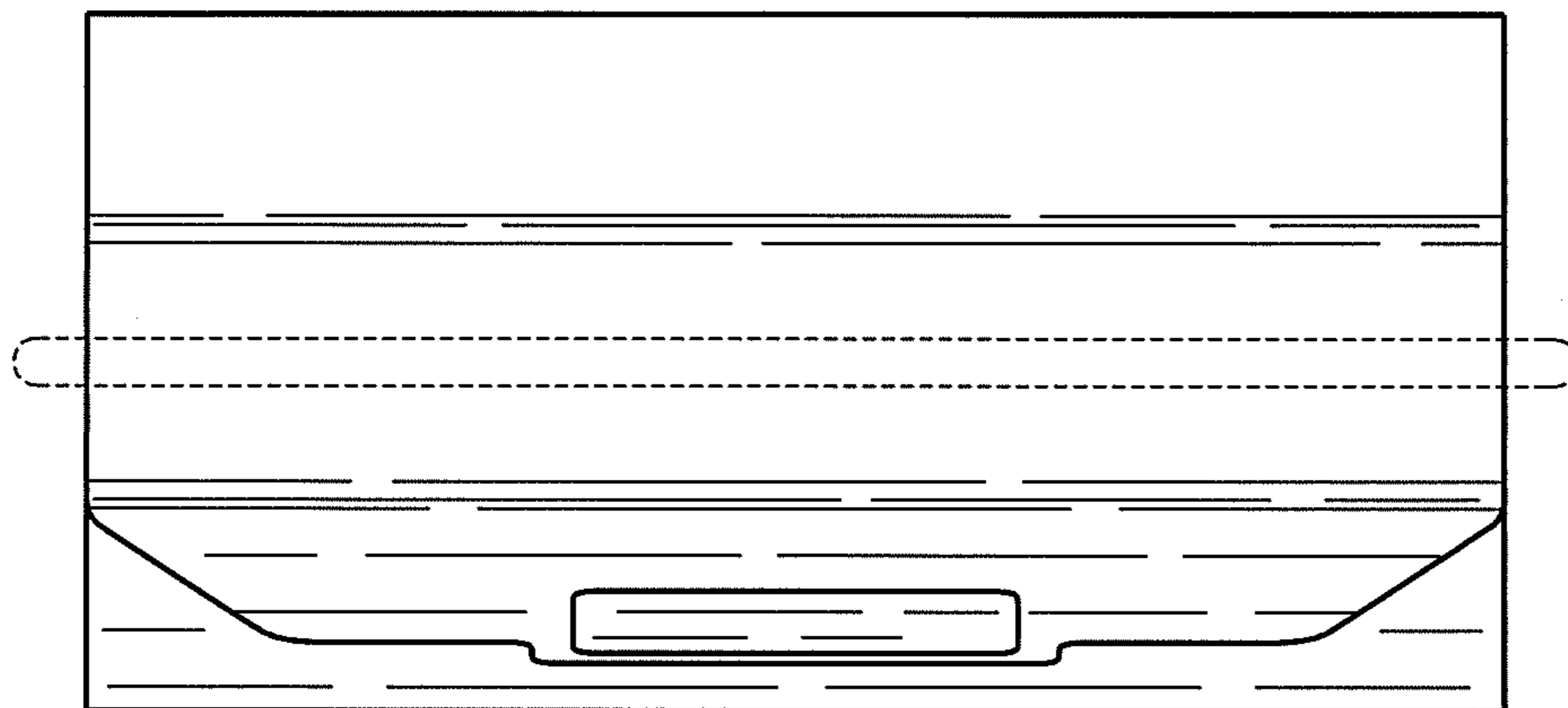
The broken line showings of the food packaging design are included for the purpose of illustrating environment and form no part of the claimed design.

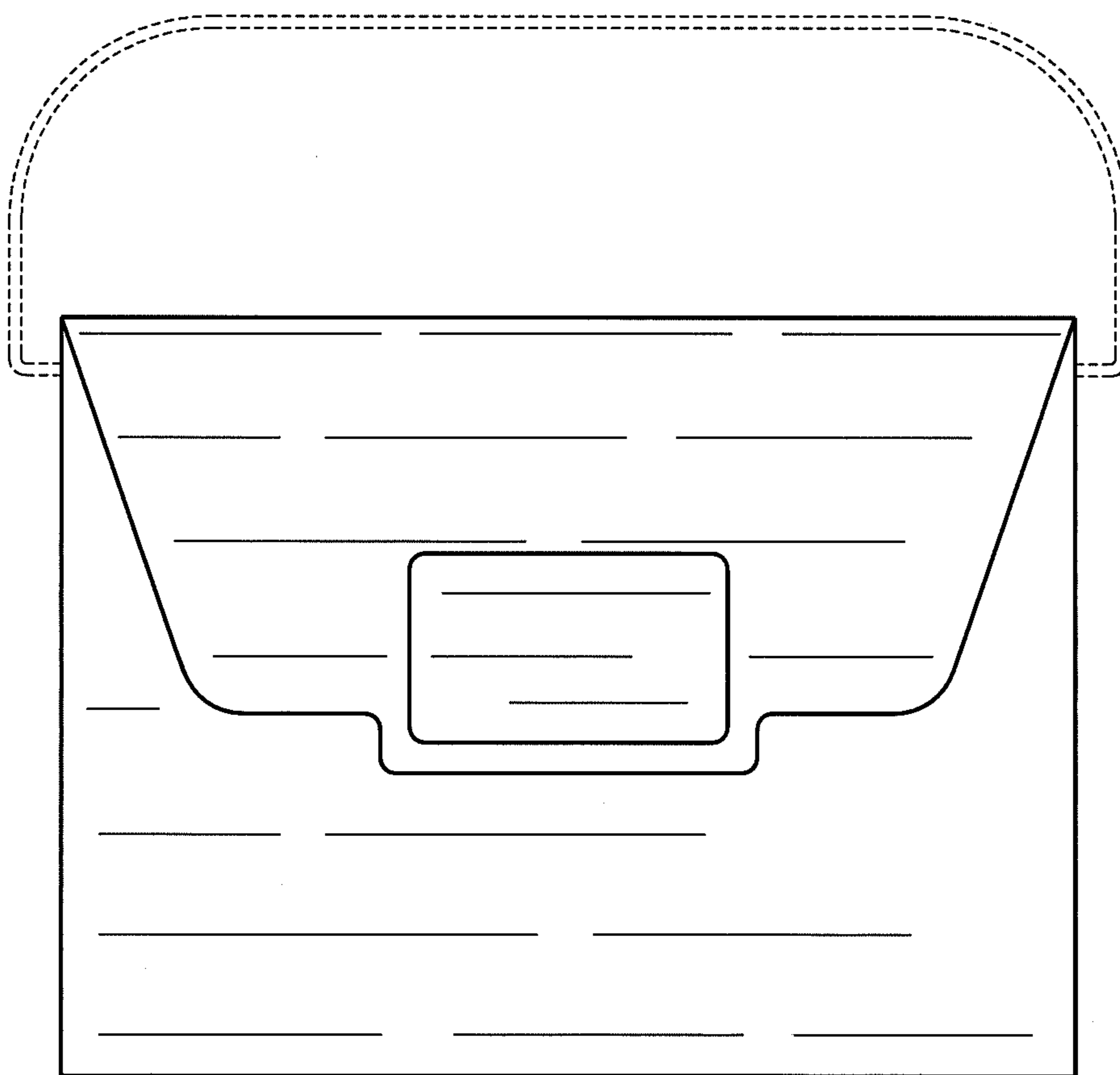




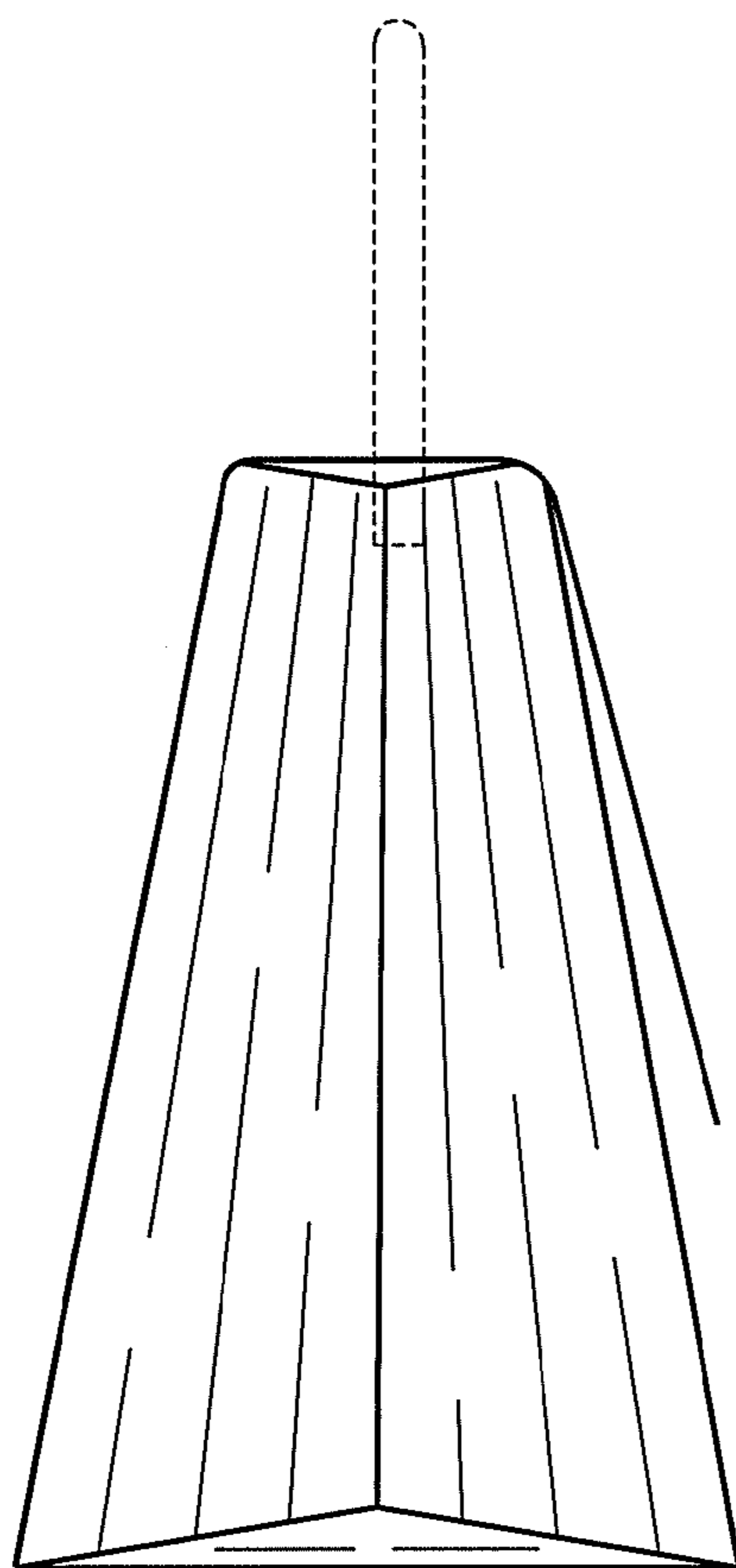

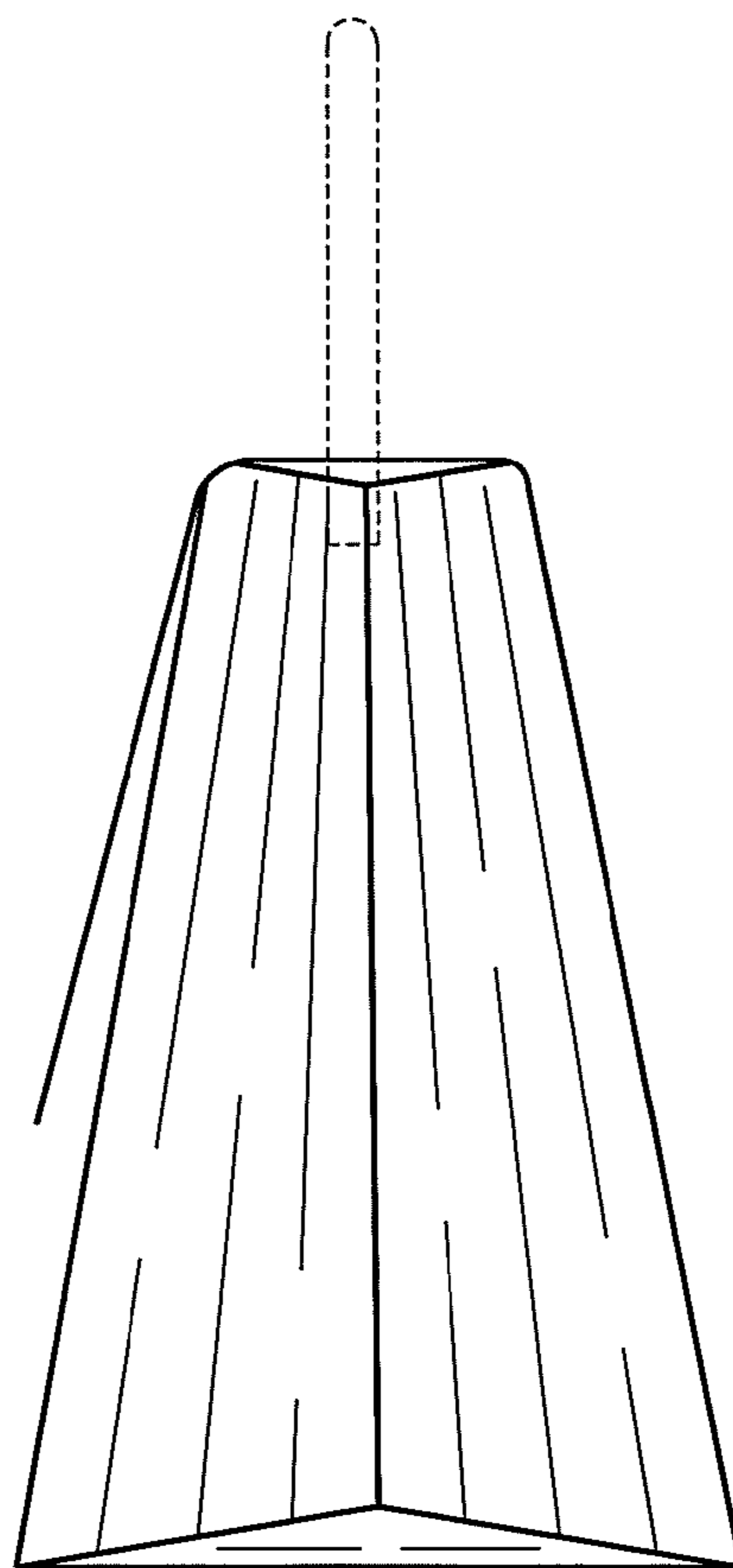

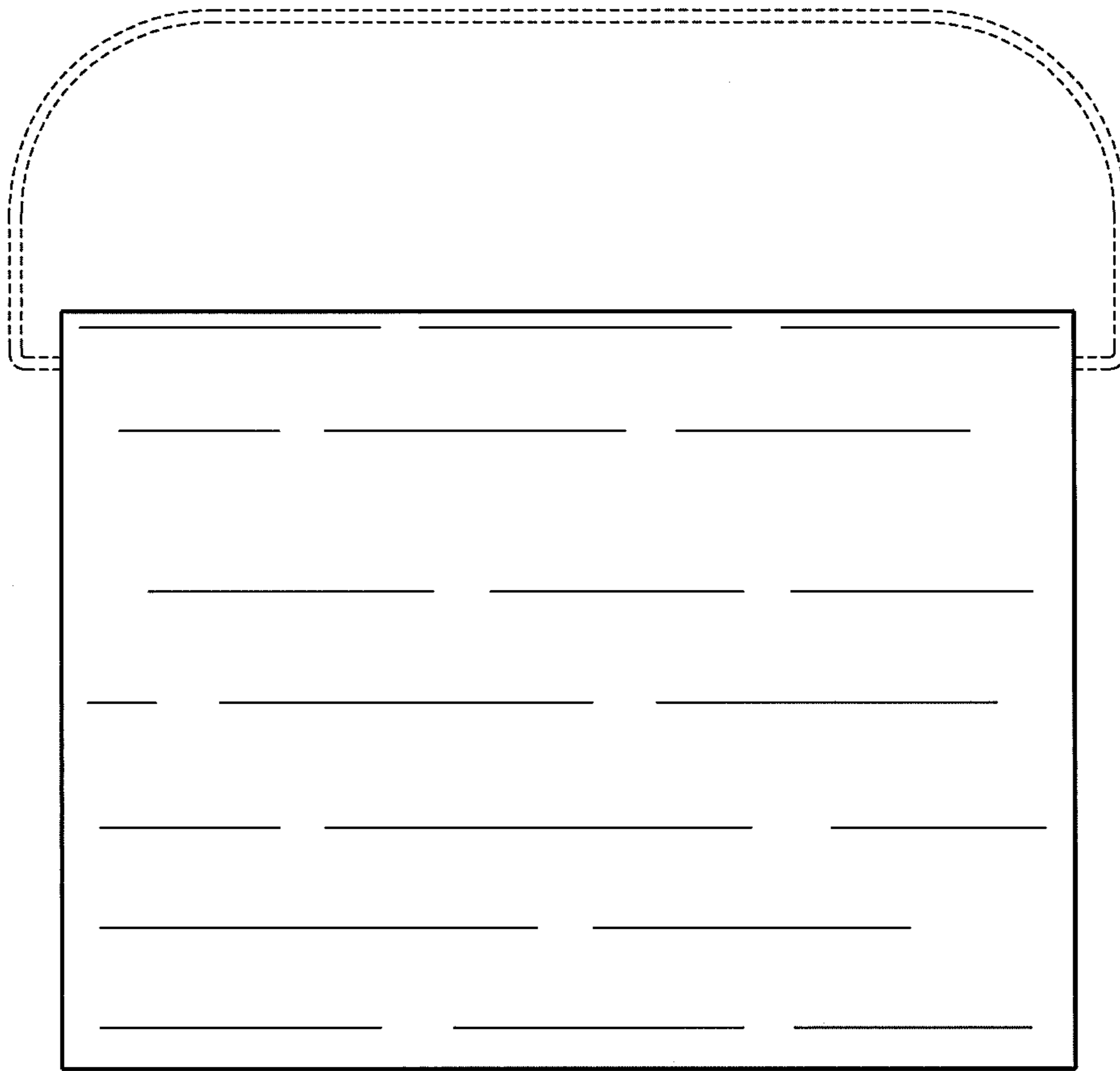

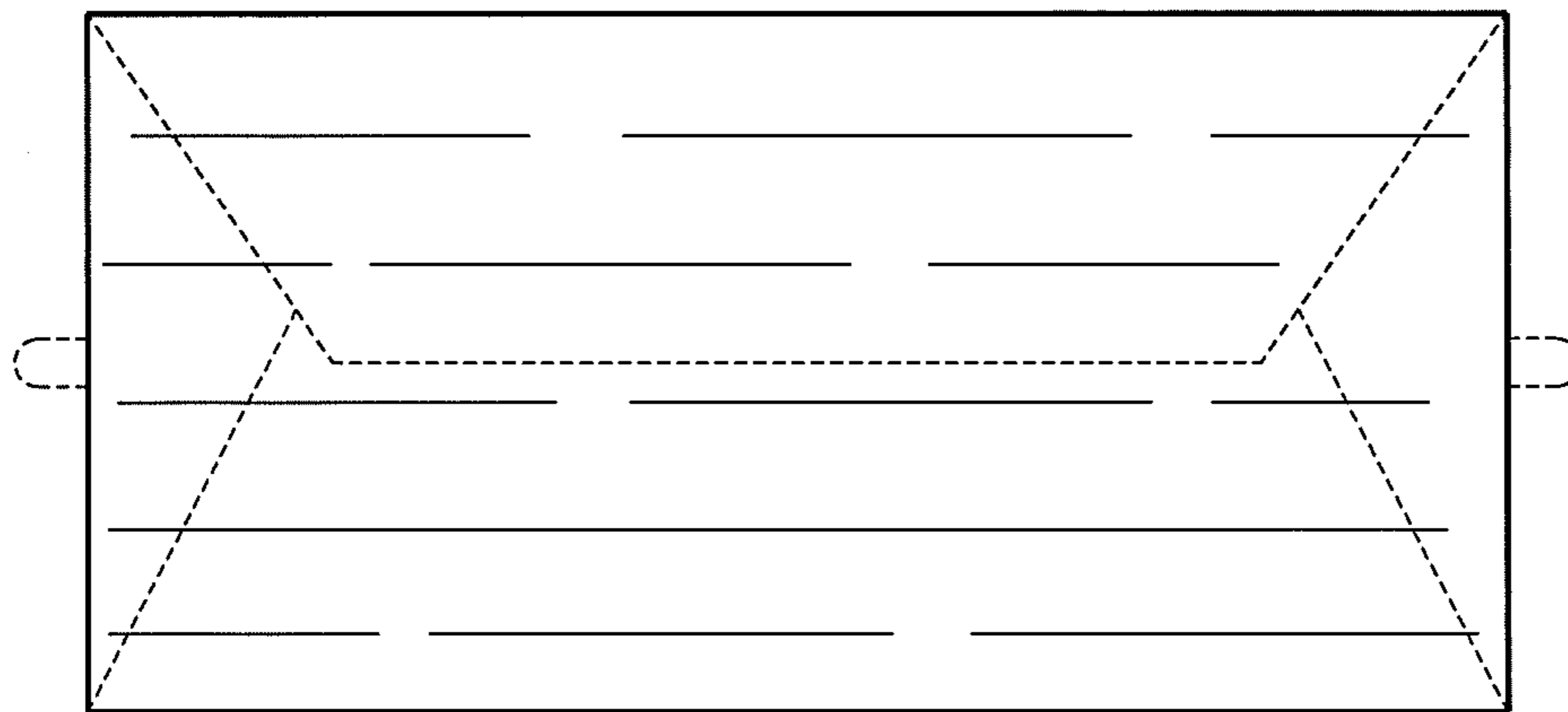
