DESCRIPTION

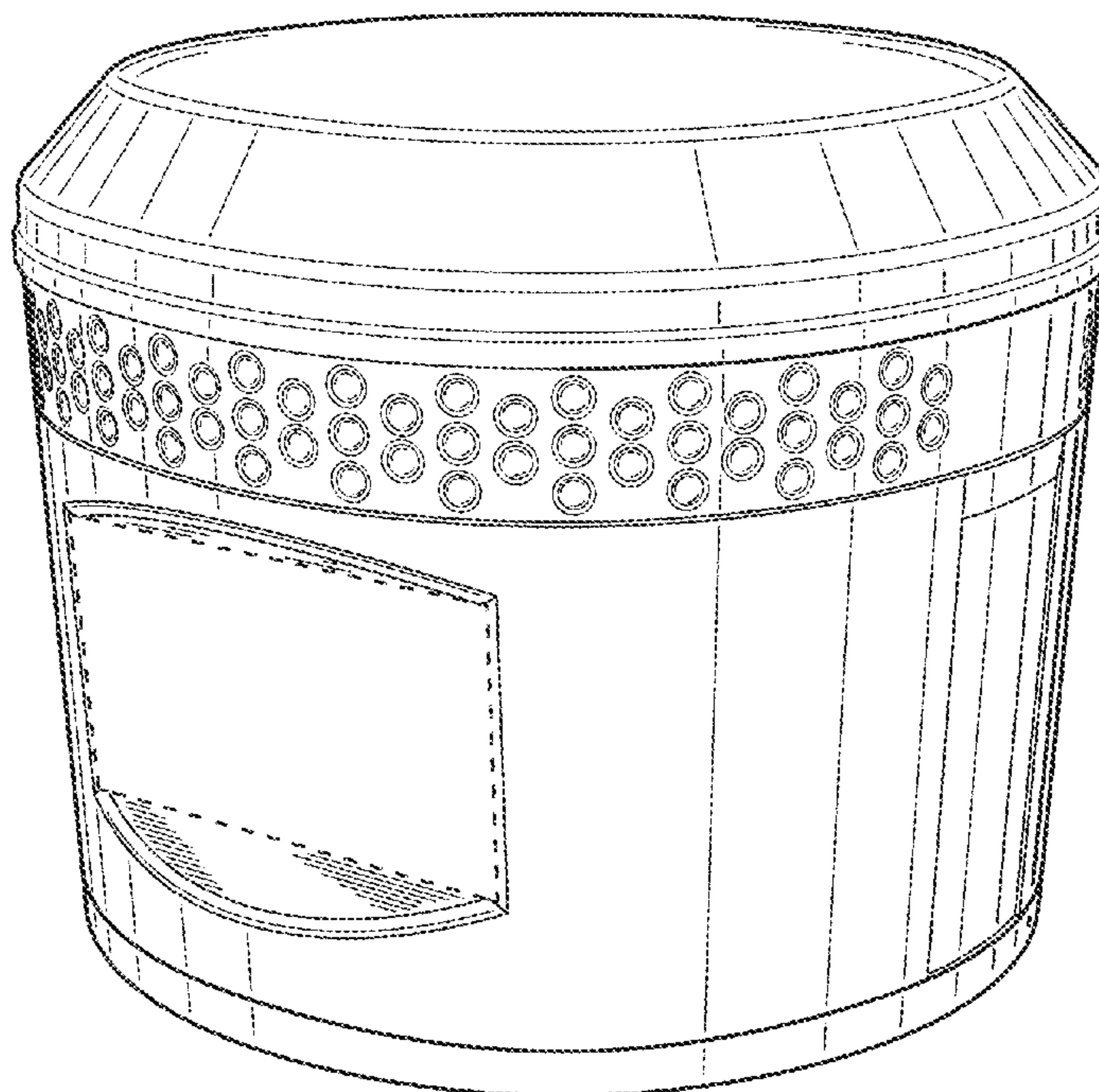
FIG. 1 is a top front right perspective view of a navigation satellite system receiver showing our new design, features shown in broken line are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a front elevational view of our navigation satellite system receiver, features shown in broken line are for illustrative purposes only and form no part of the claimed design; FIG. 3 is a right side elevational view of our navigation satellite system receiver, the left side elevational view is a mirror image thereof;

FIG. 4 is a rear elevational view of our navigation satellite system receiver, features shown in broken line are for illustrative purposes only and form no part of the claimed design; FIG. 5 is a top plan view of our navigation satellite system receiver; and,

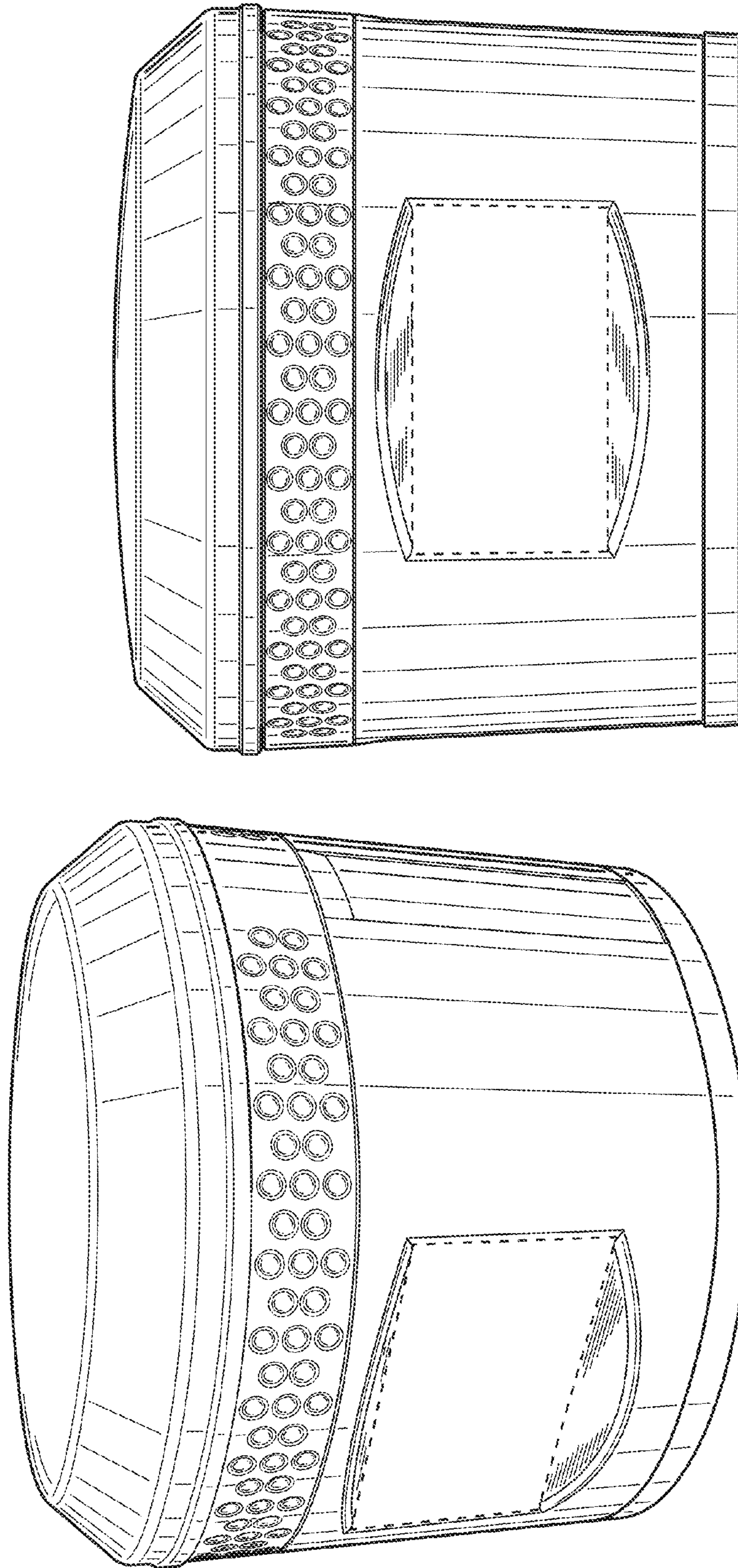

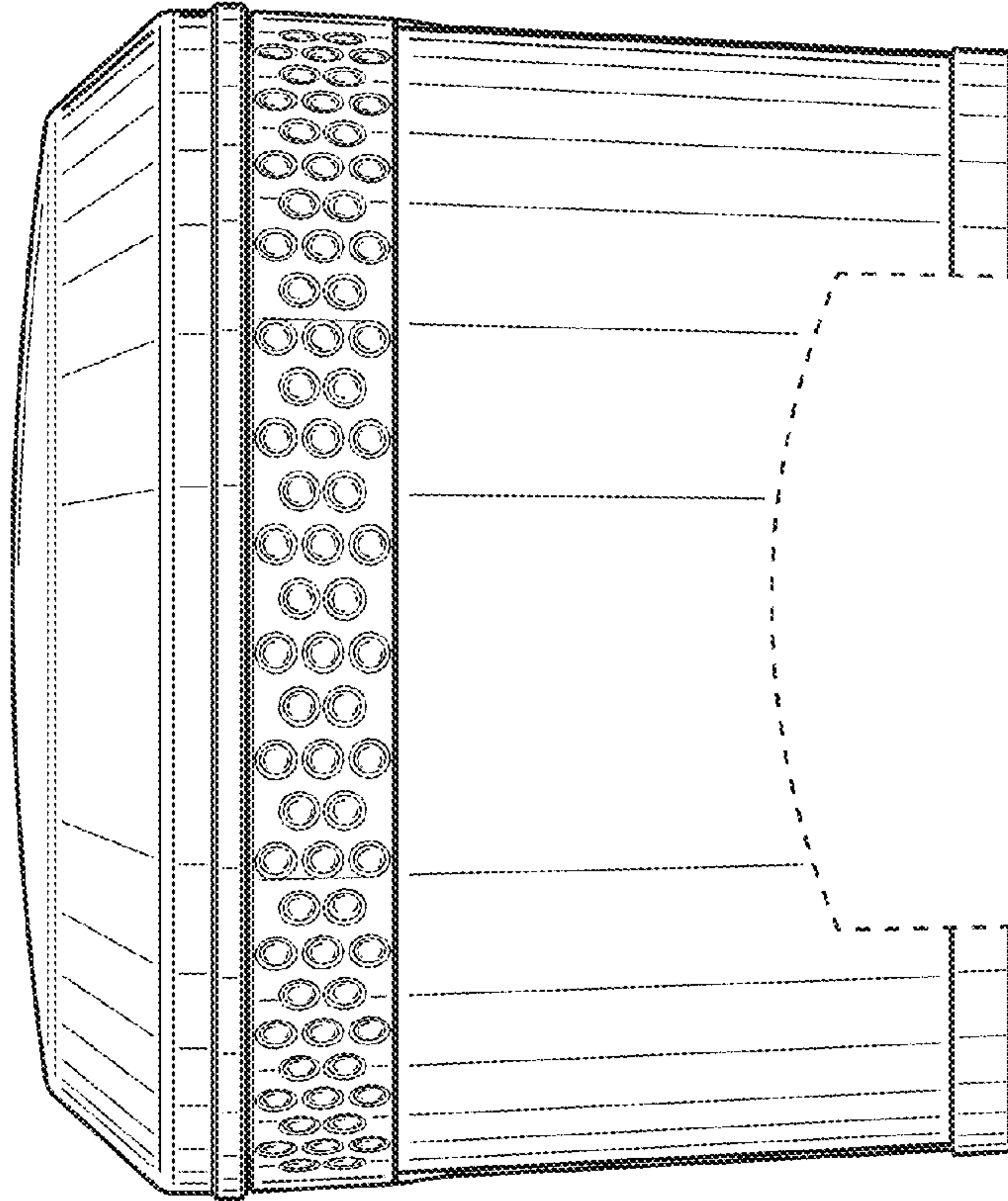

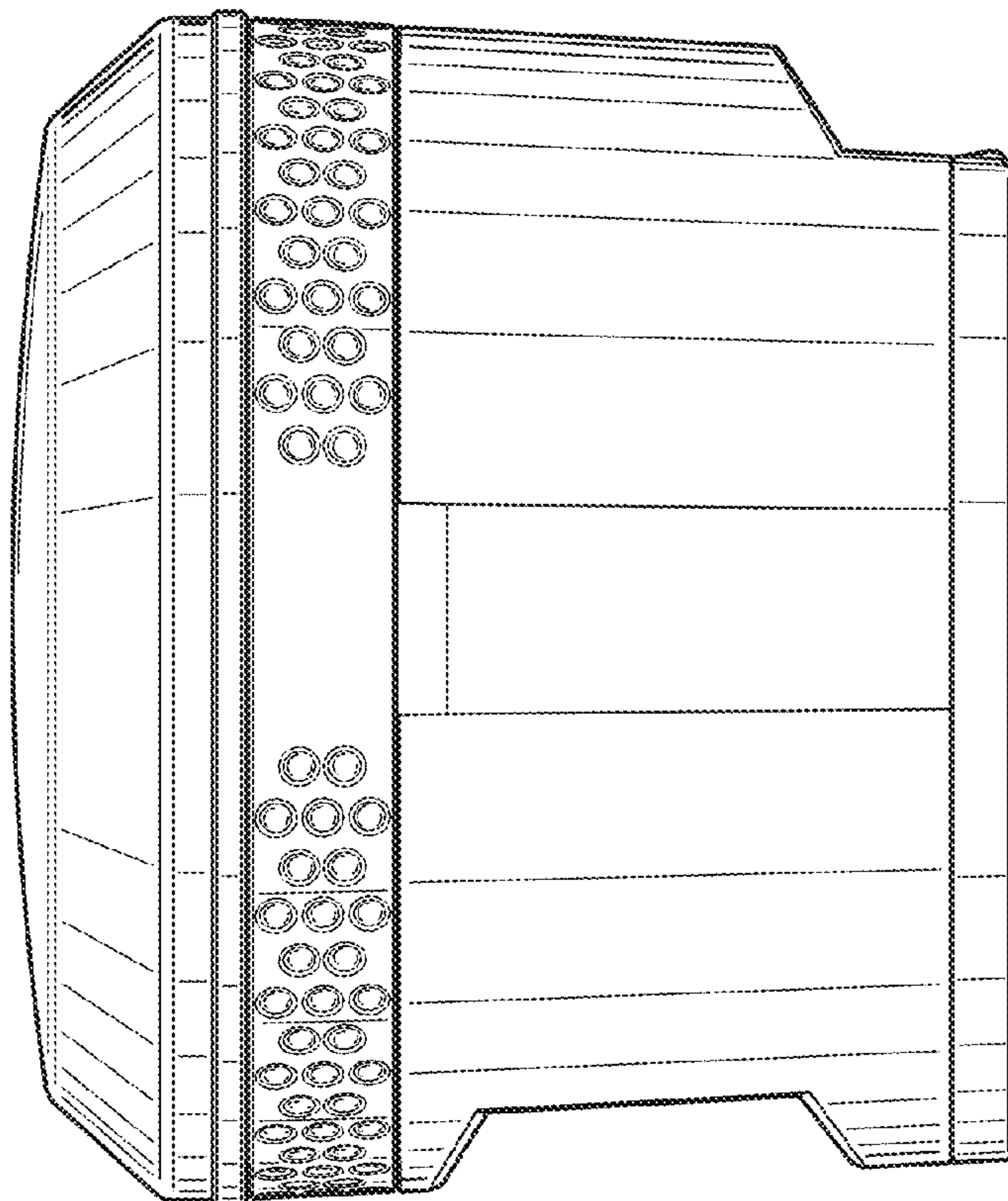

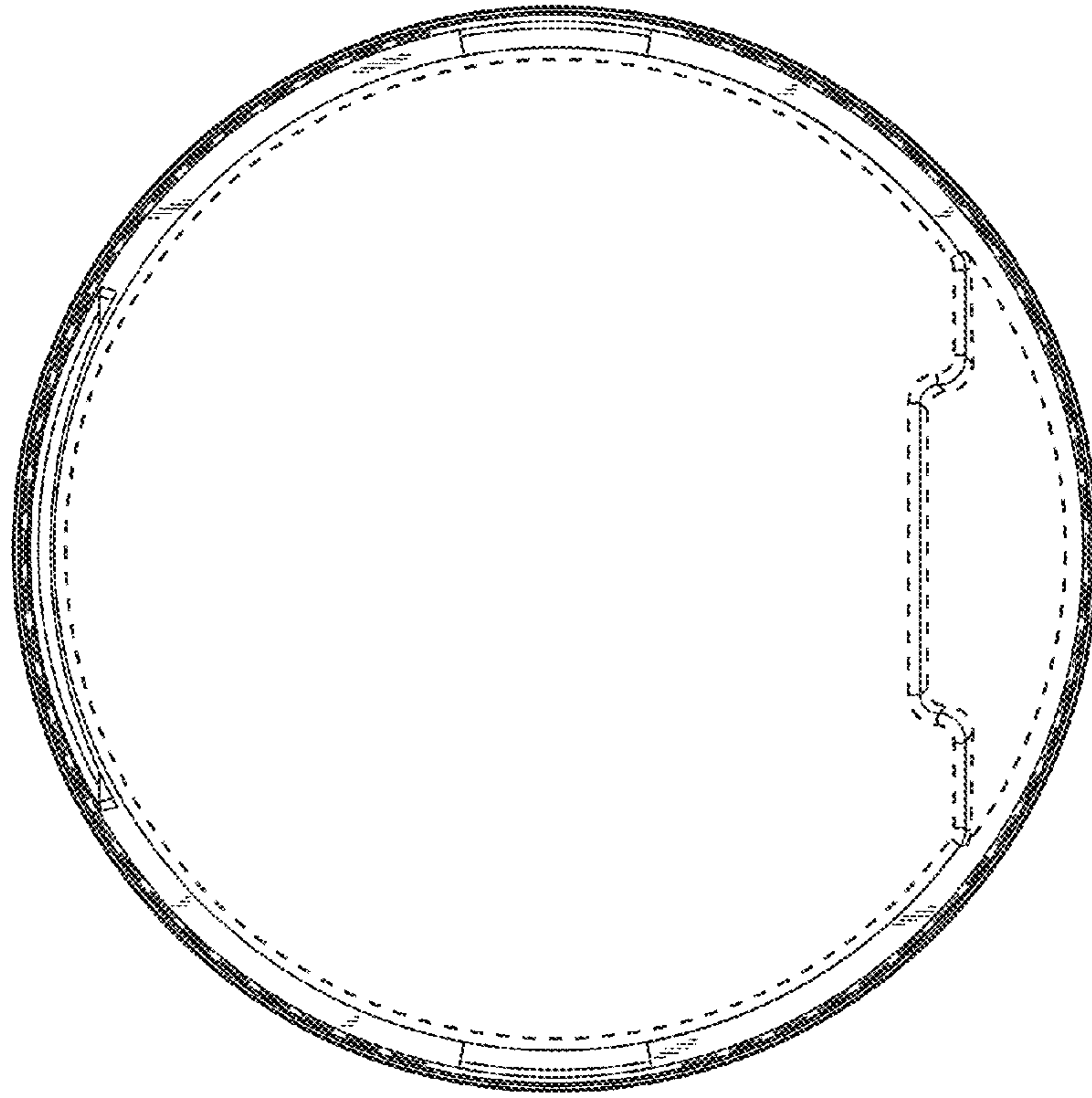

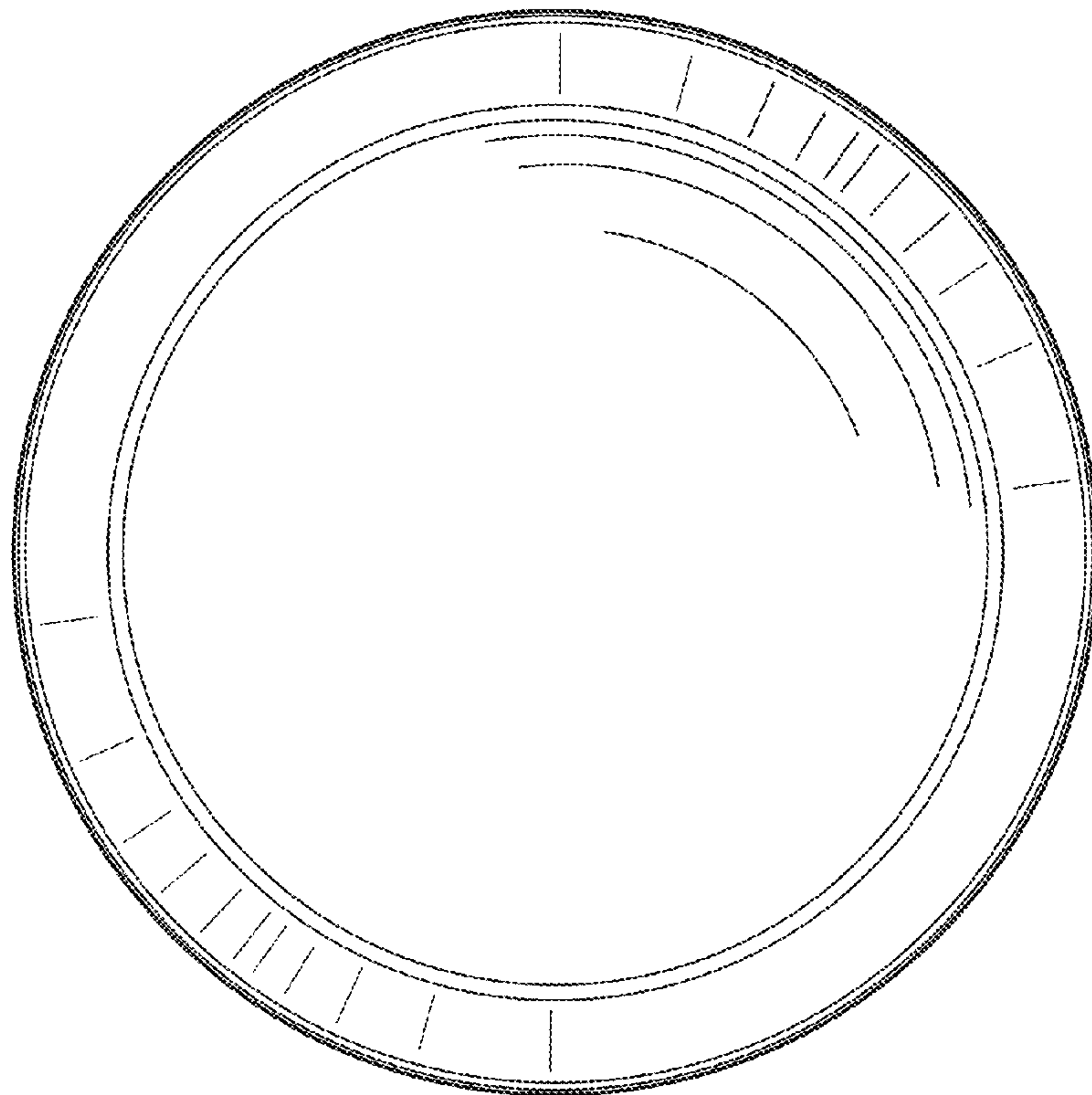
