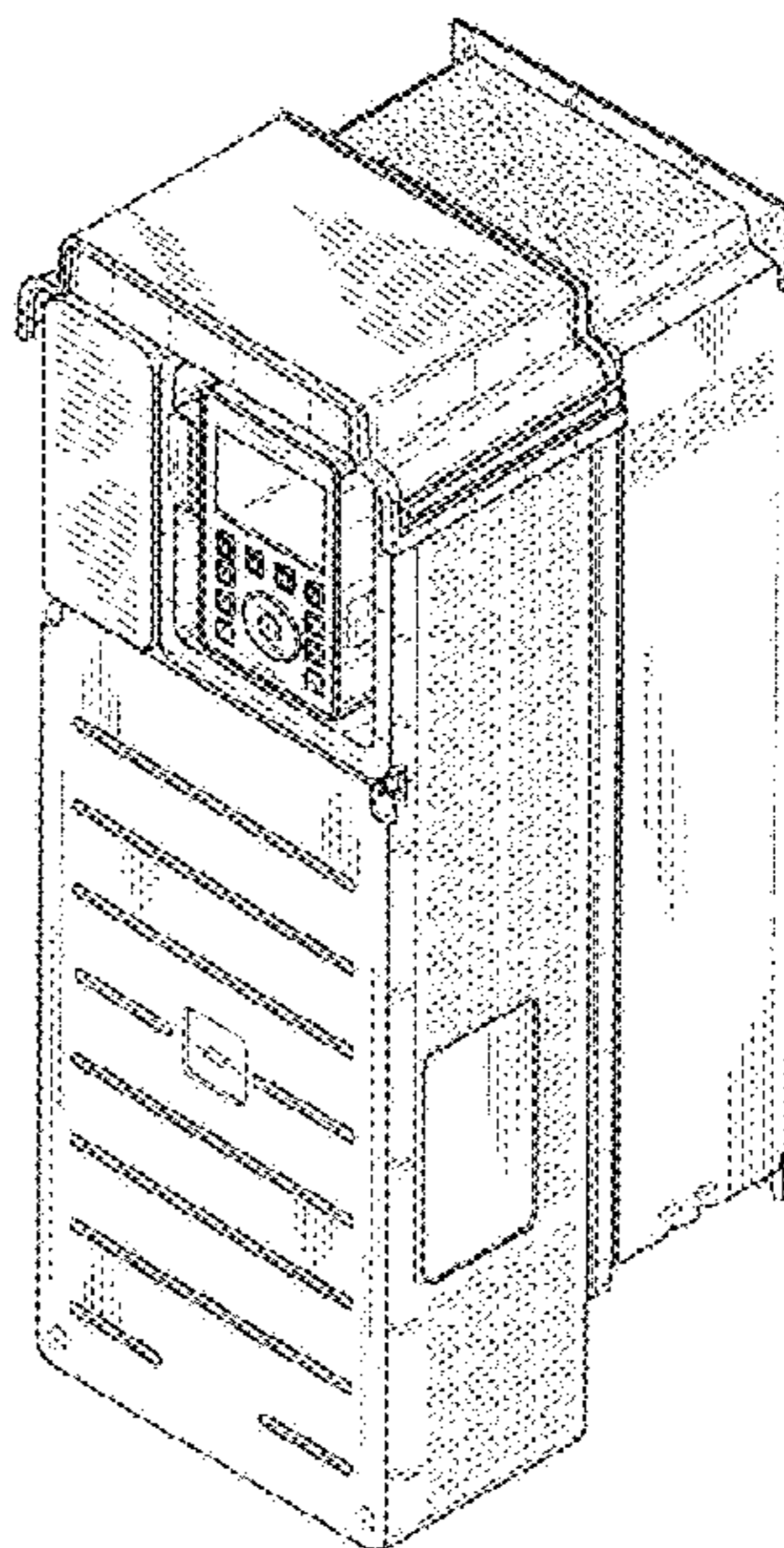

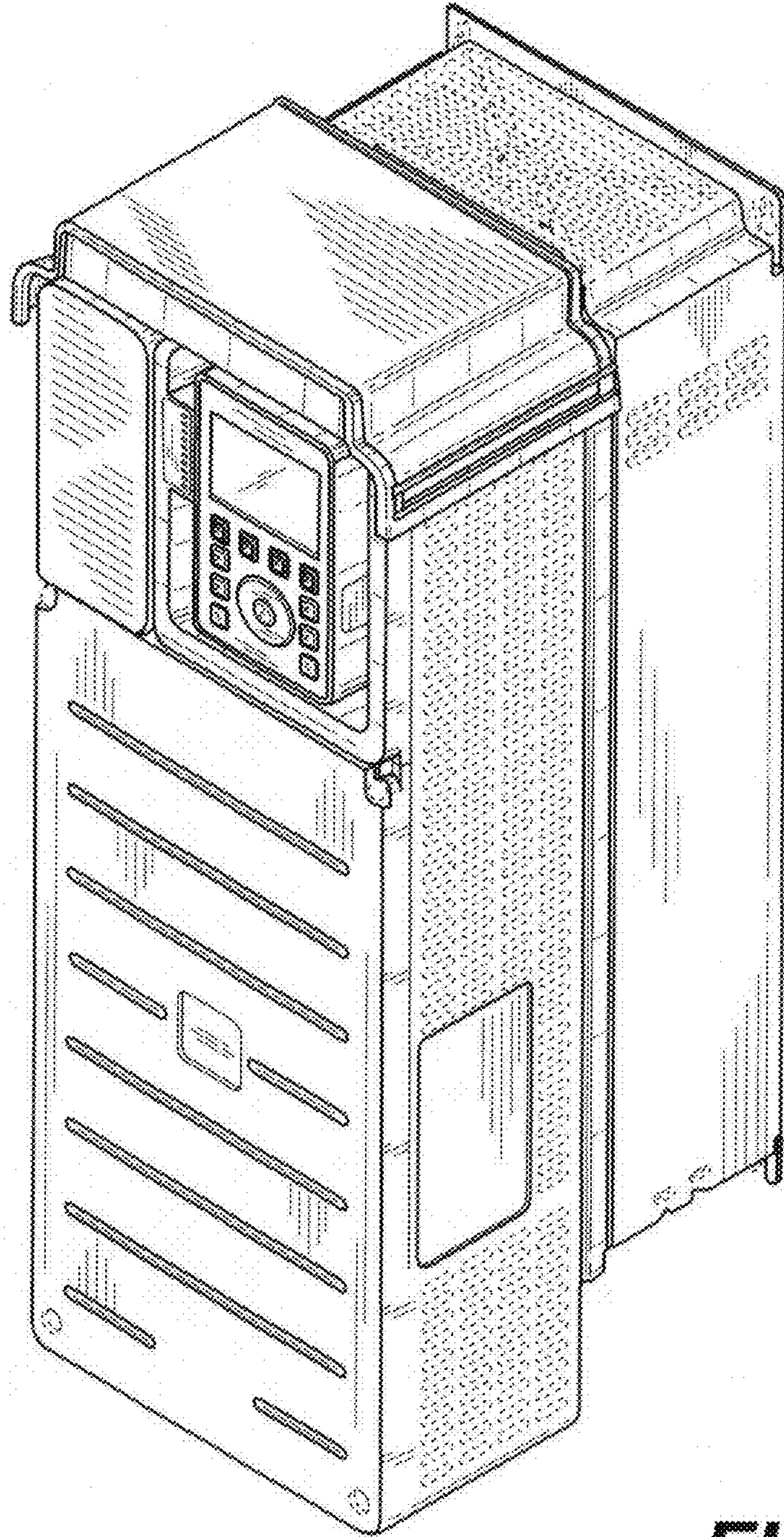
(57) **CLAIM**

**DESCRIPTION**

The broken lines in the drawings depict environmental subject matter only and form no part of the claimed design.

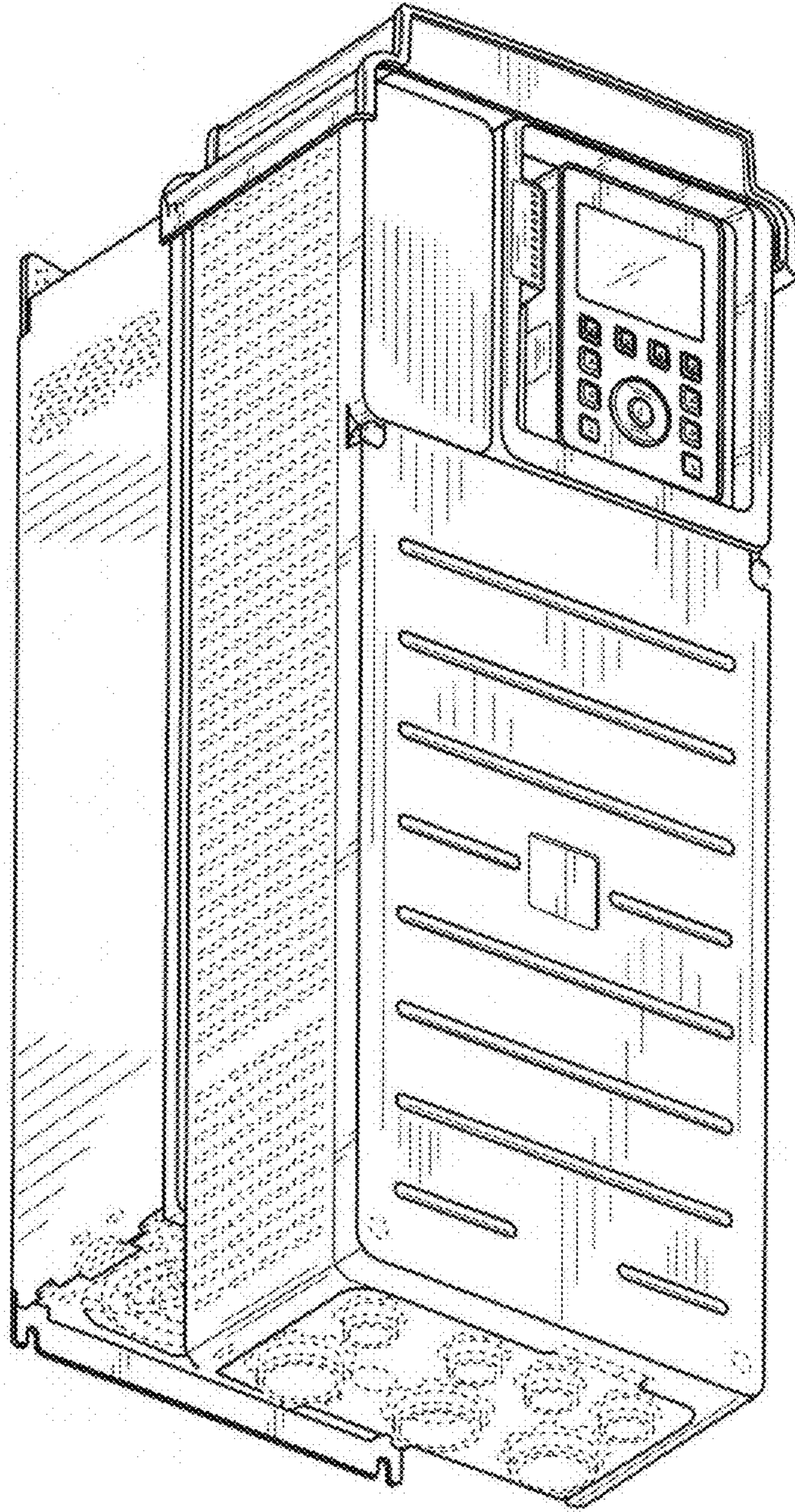

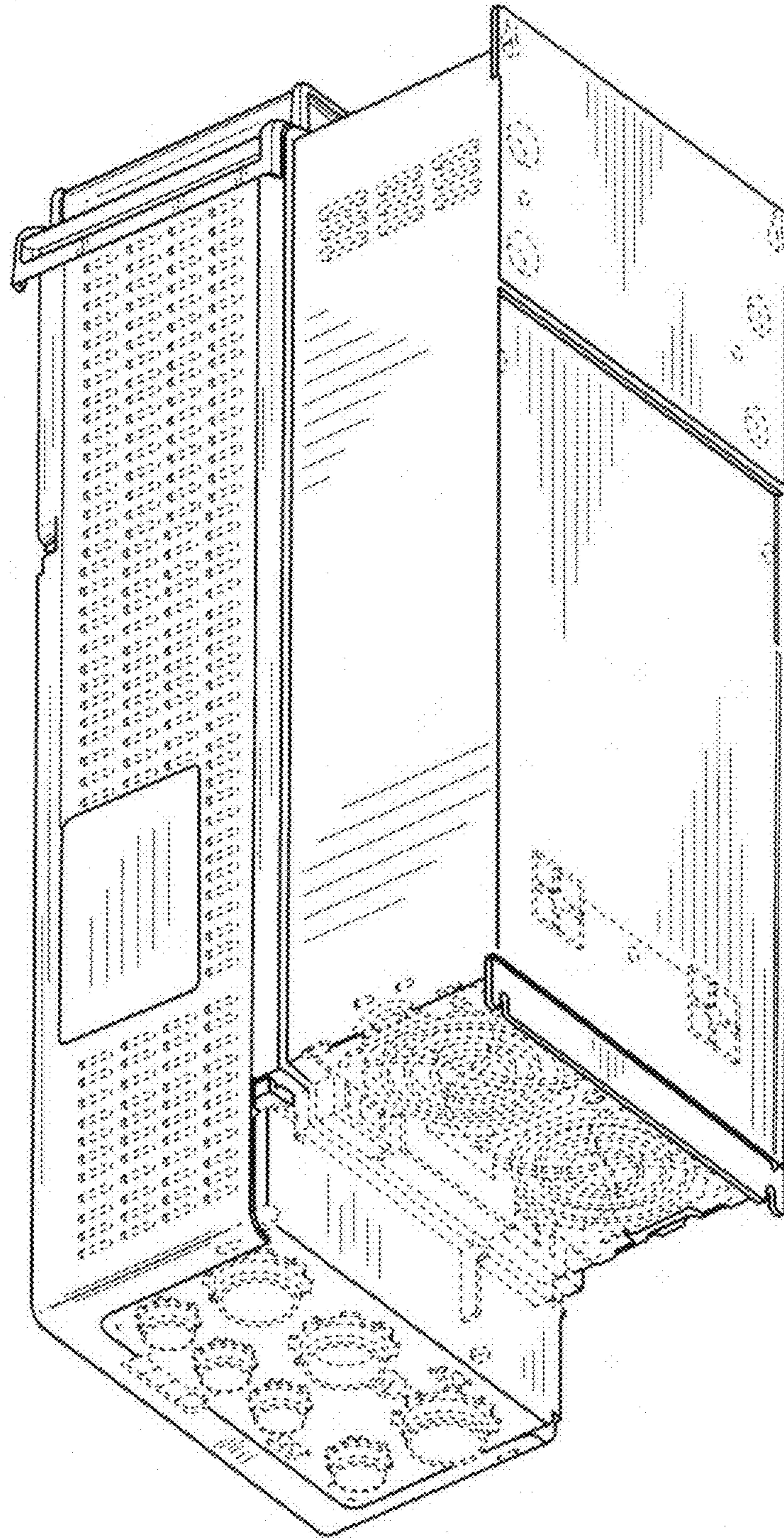

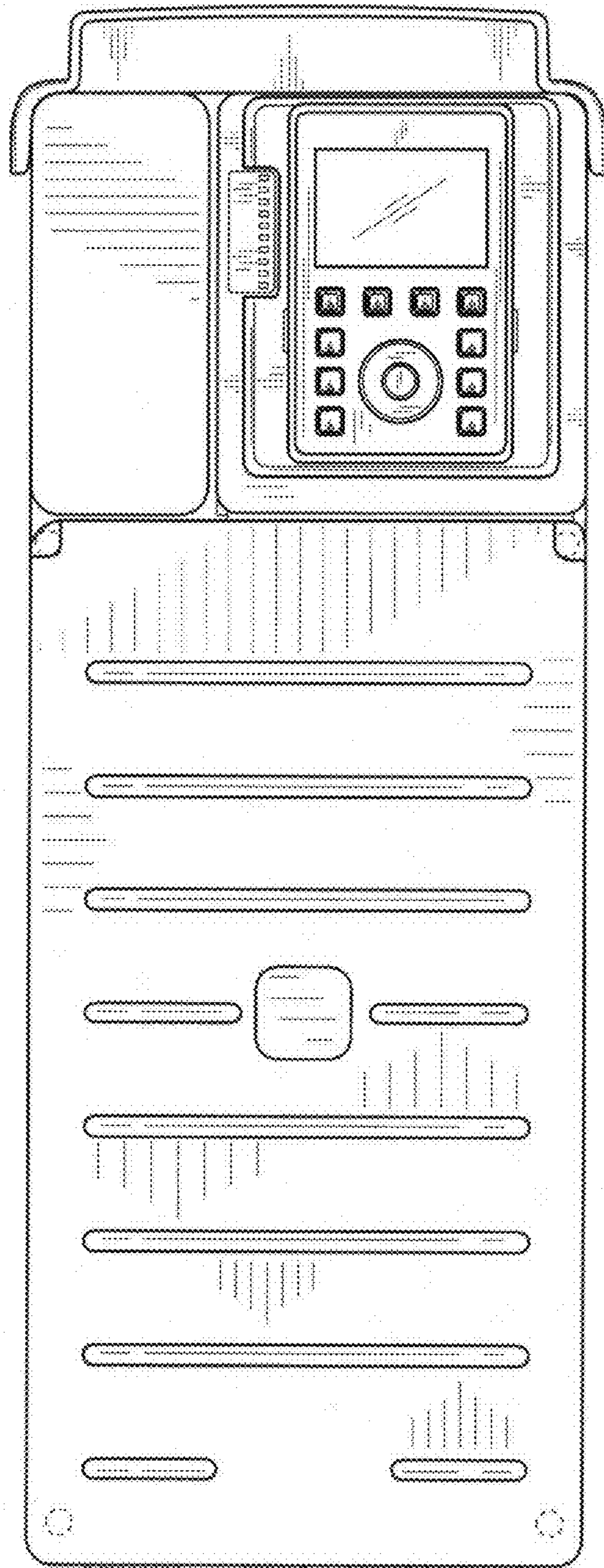

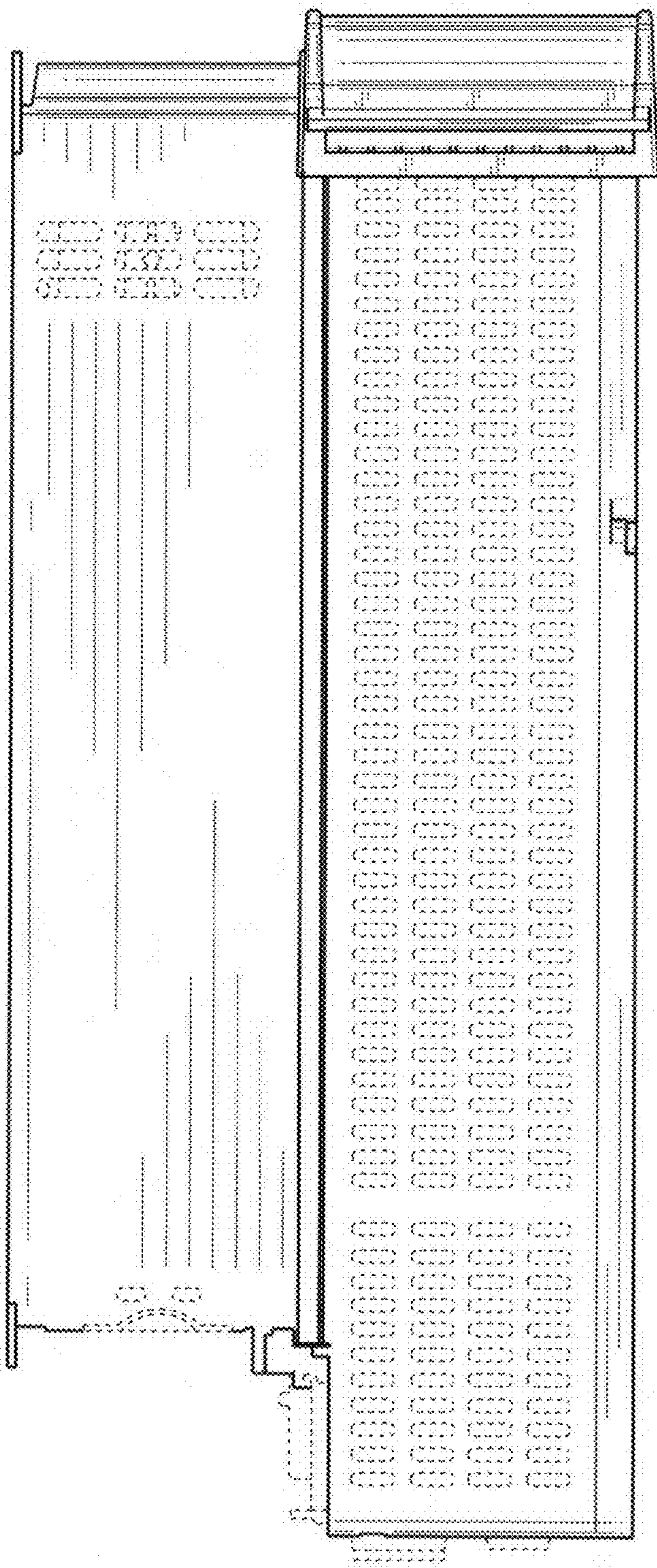
