FIG. 6 is a rear elevation view of the electrical equipment housing;

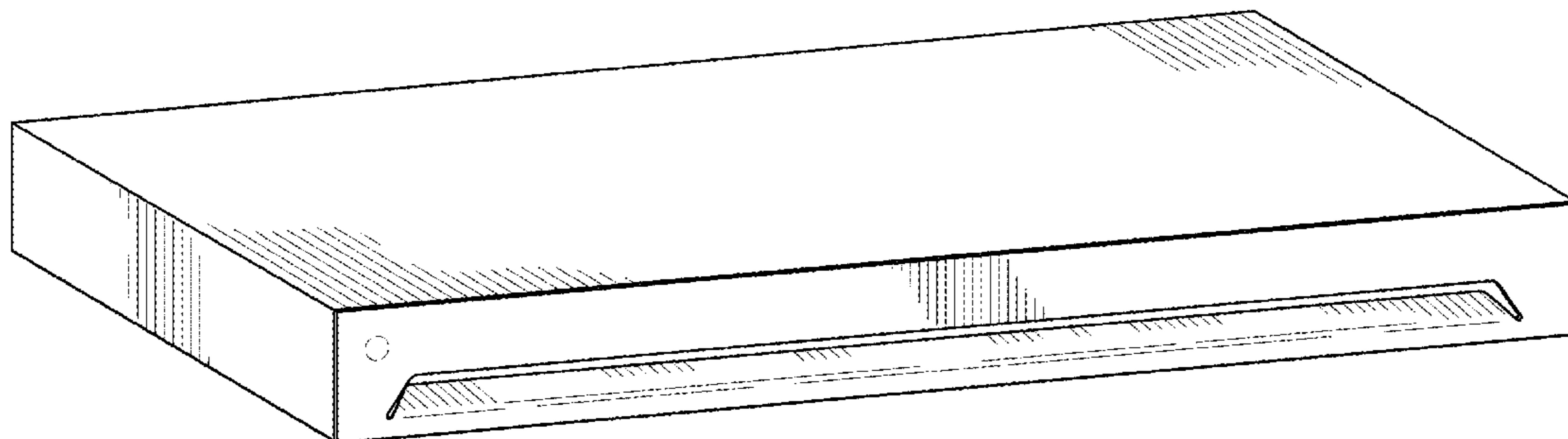
FIG. 7 is a side elevation view of the electrical equipment housing;

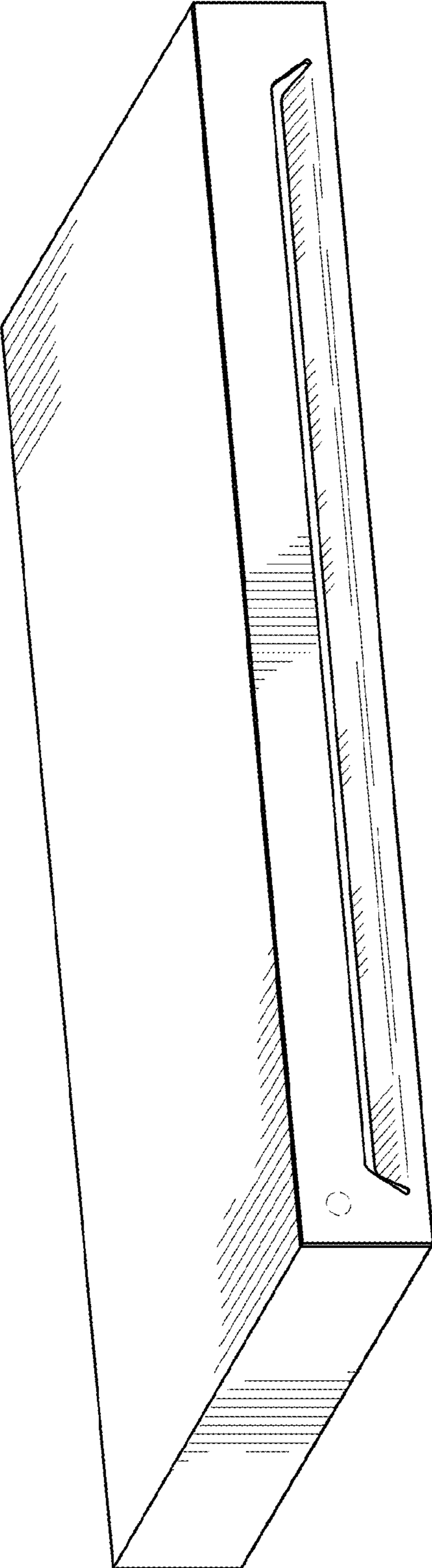

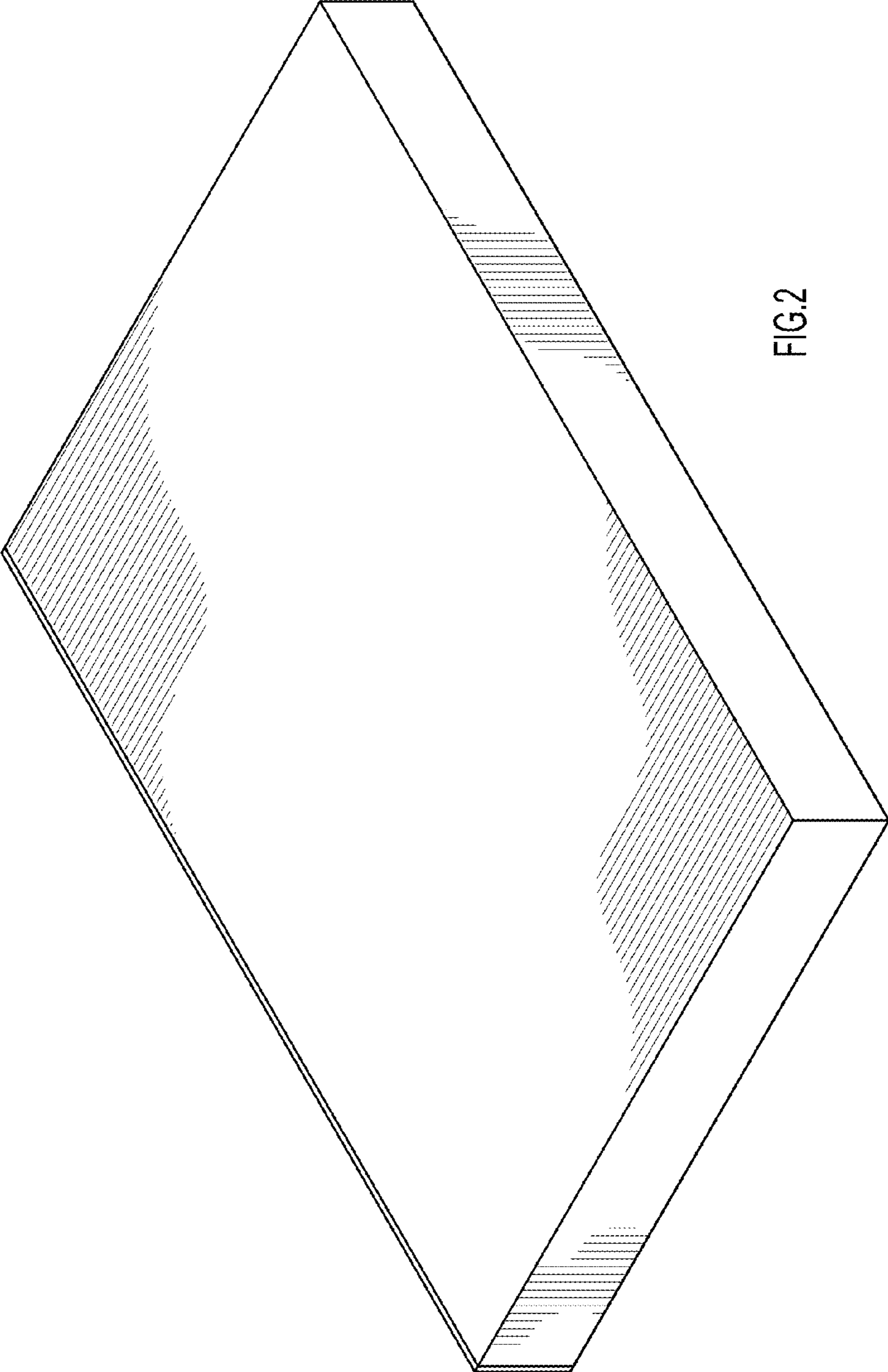

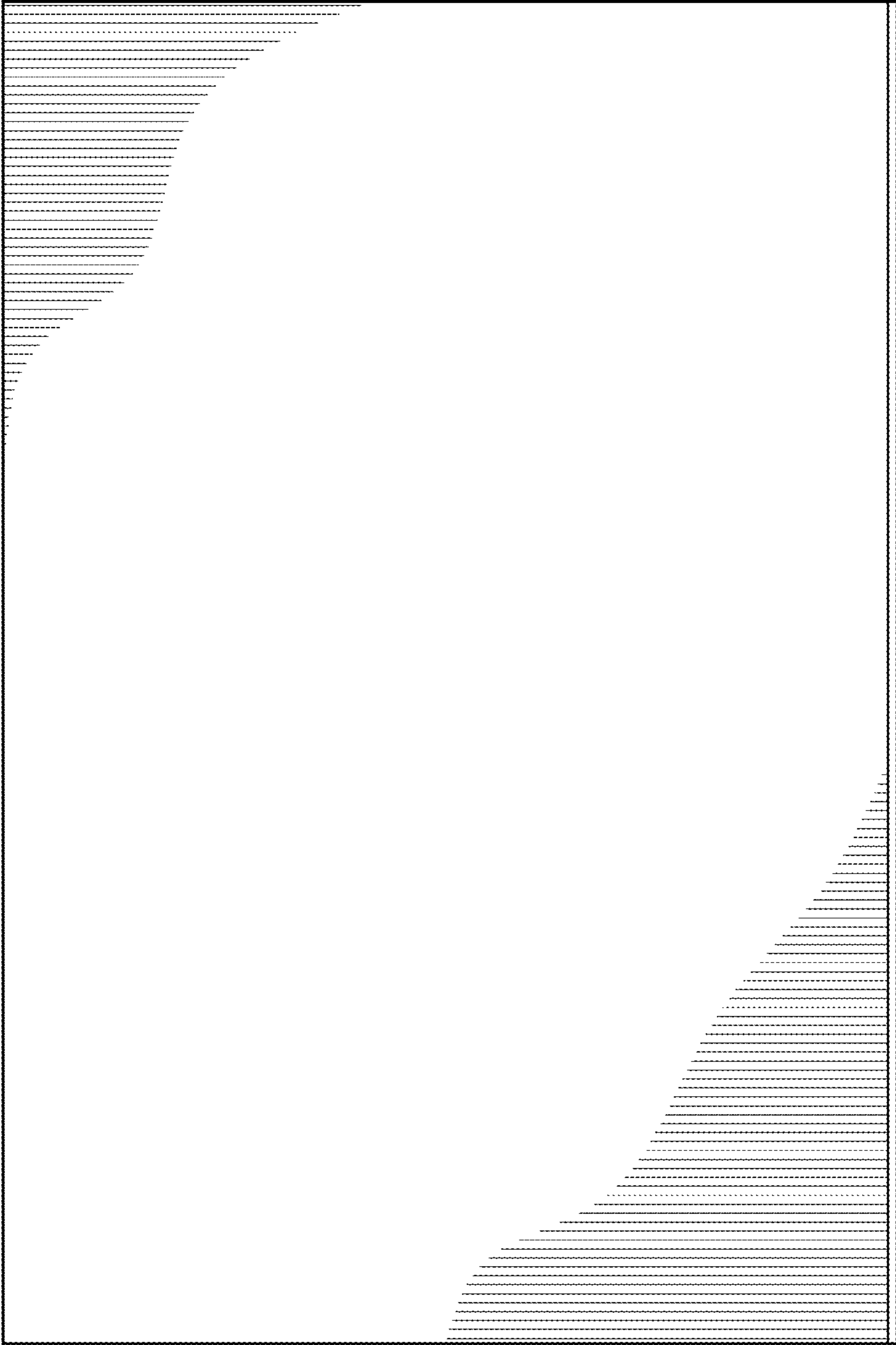

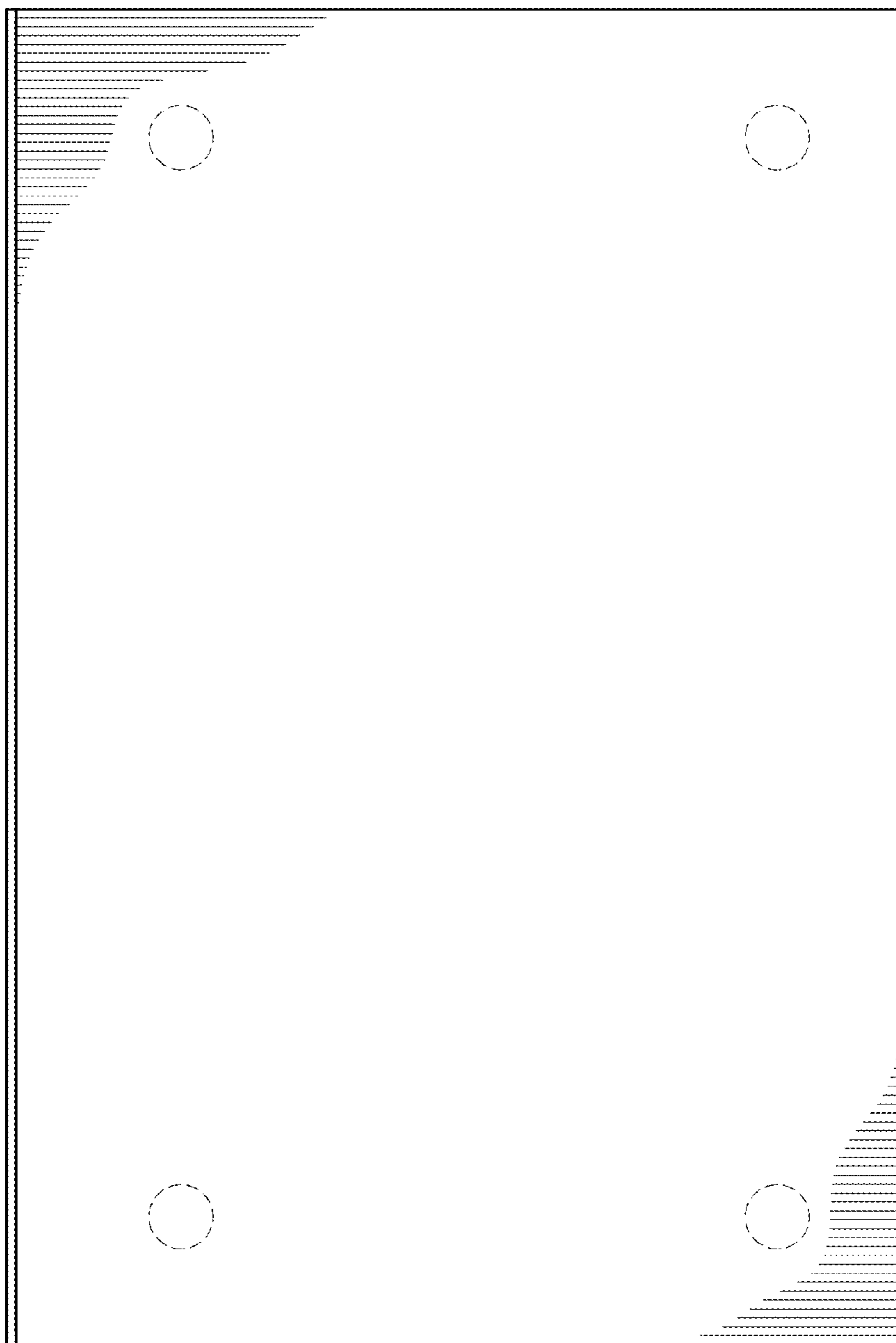

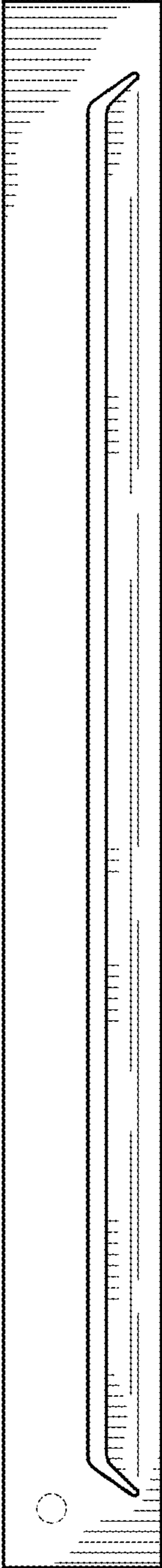

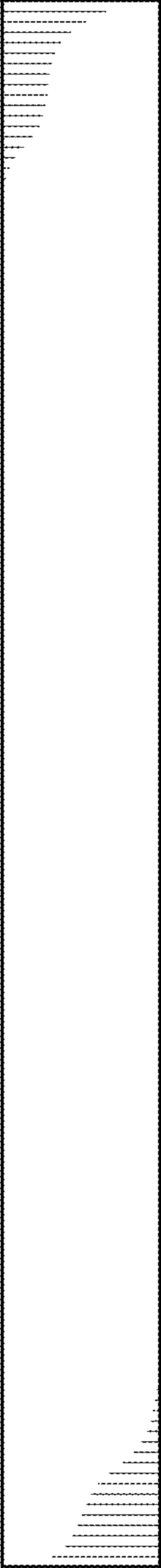

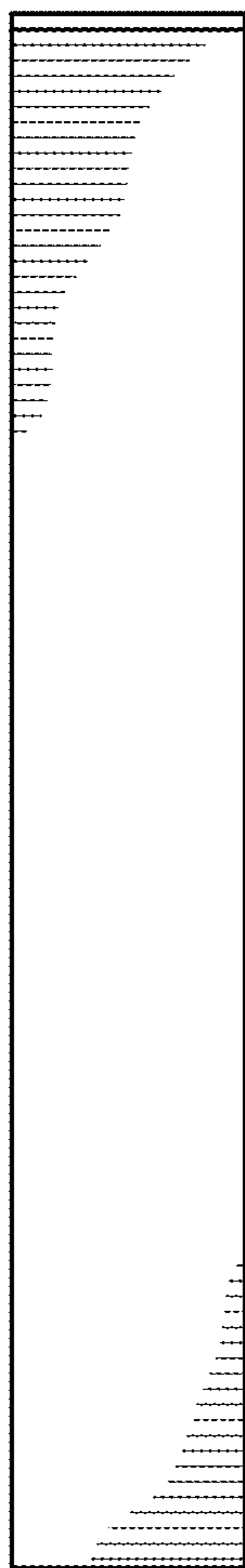

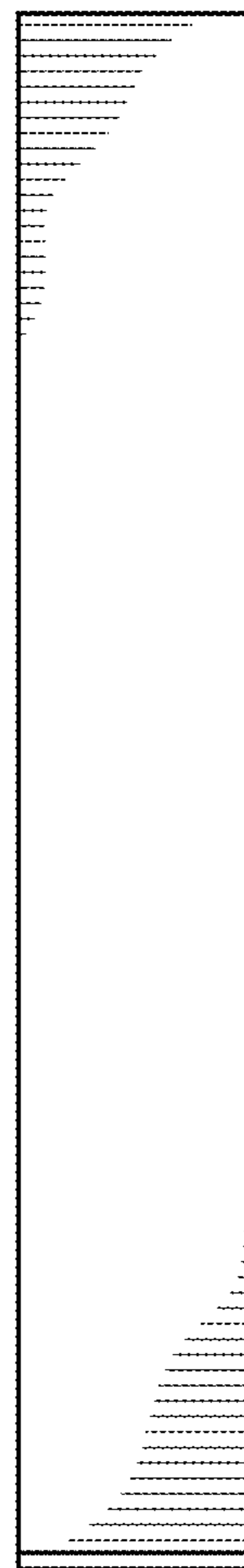

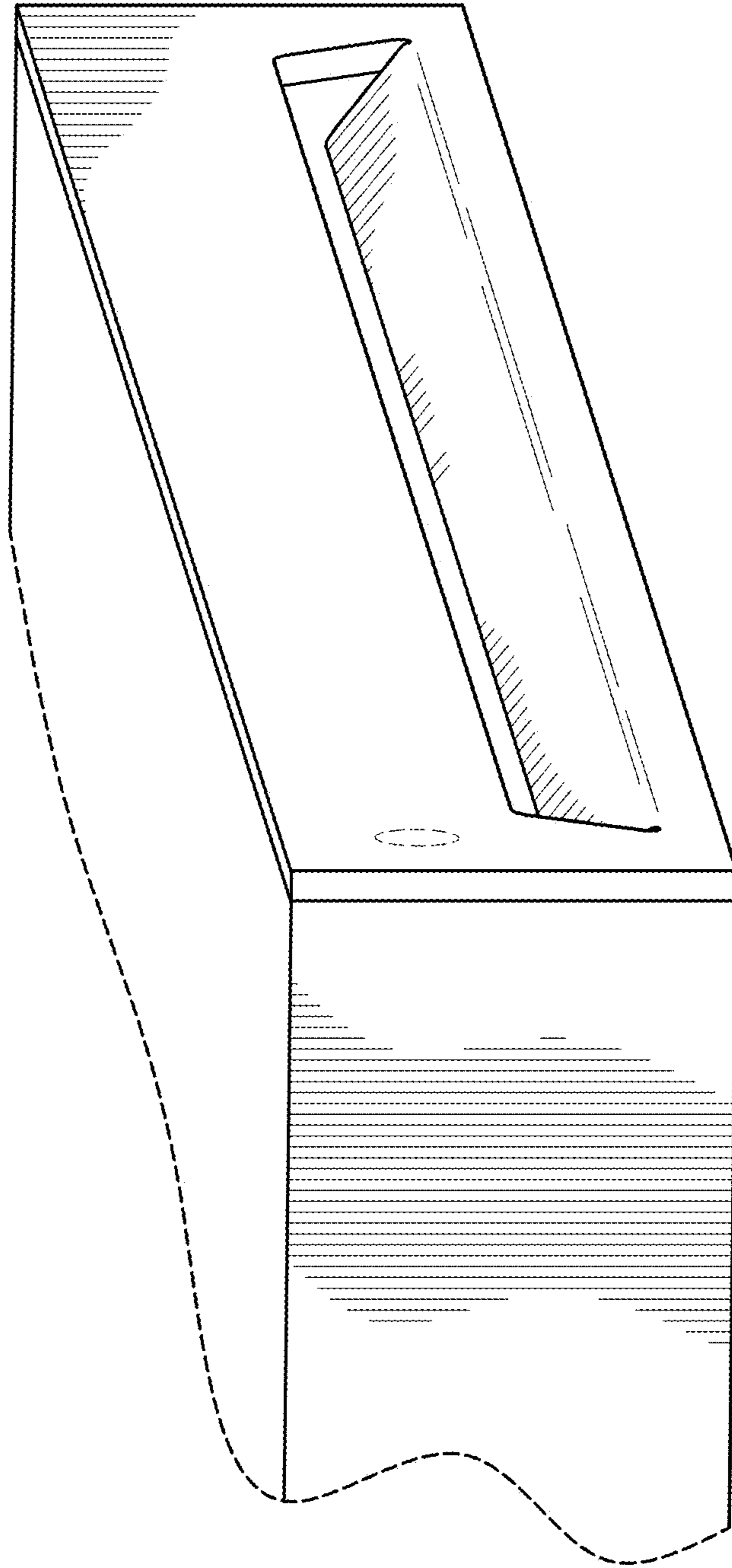
