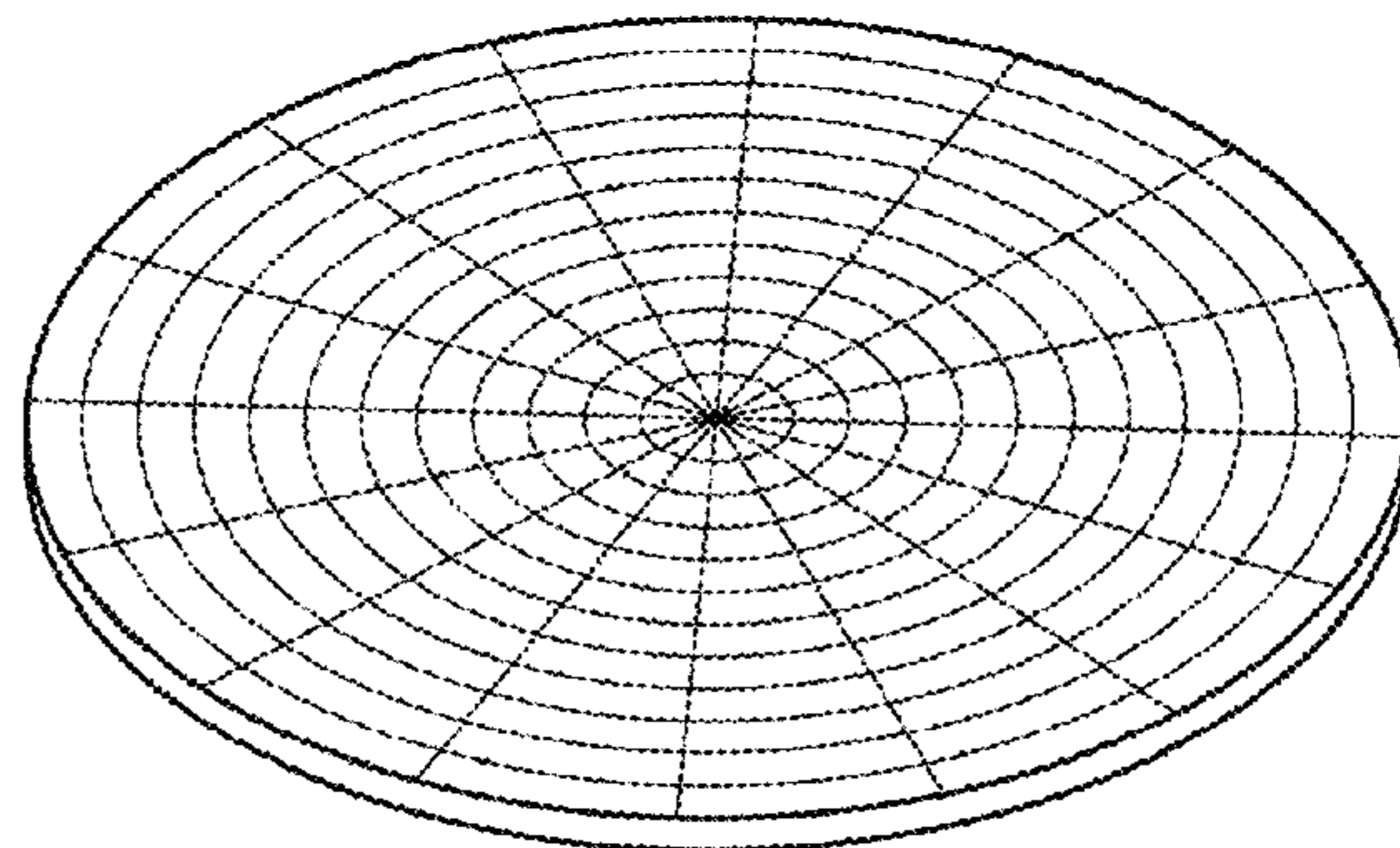

(57) **CLAIM**

The ornamental design for a quilting stencil, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a quilting stencil showing my new design;
FIG. 2 is a top plan view thereof; the bottom plan view being a mirror image thereof;
FIG. 3 is a left side elevation view thereof; the right side elevation view being a mirror image thereof; and,
FIG. 4 is a front elevation view thereof; the back elevation view being a mirror image thereof.

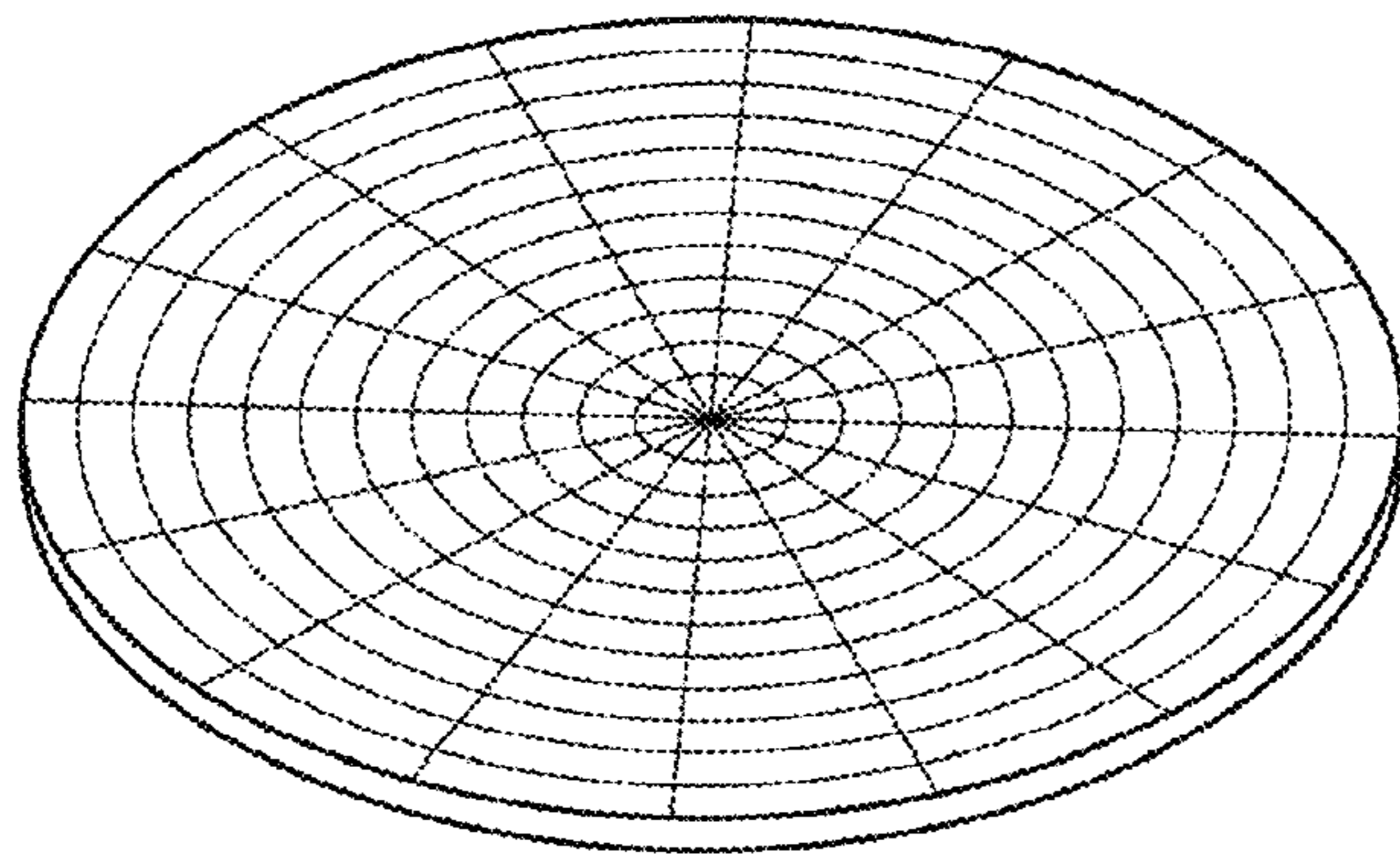

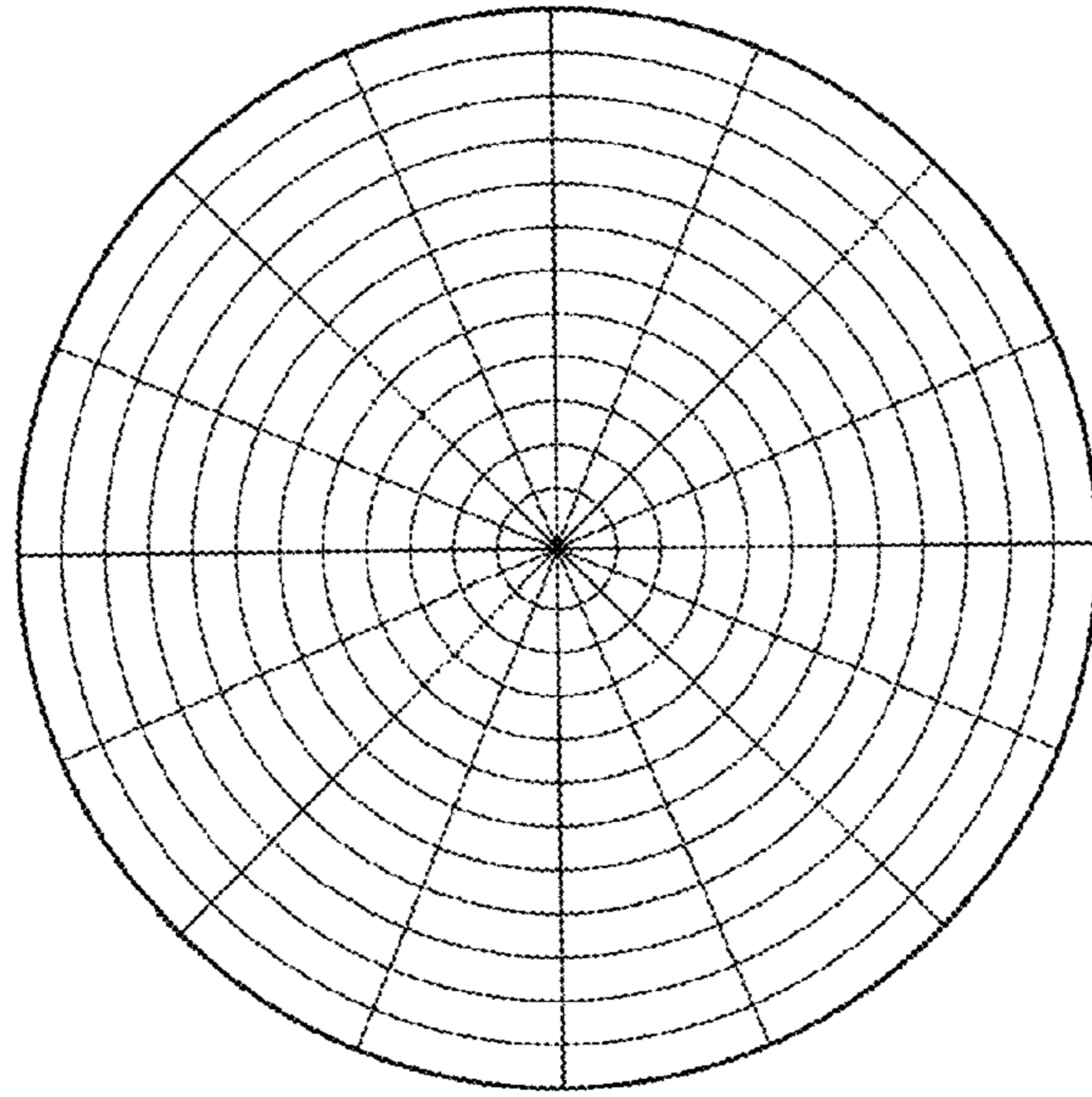

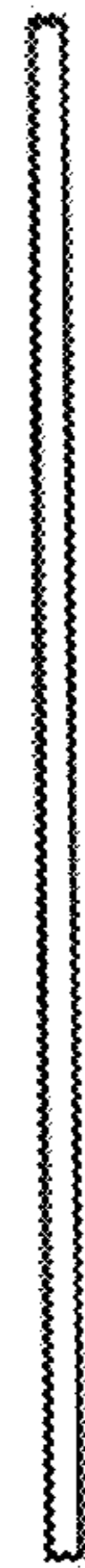

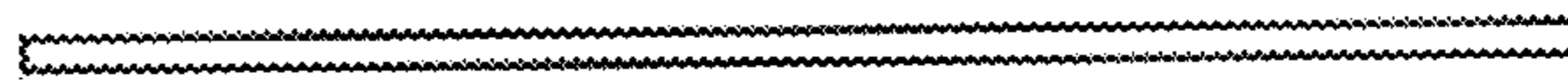
