FIG. 1 is a front perspective view of a firearm tool that includes a tool and docking station in an assembled configuration incorporating the design of the present invention; FIG. 2 is a back perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a front perspective view of the docking station in FIG. 1 with the tool removed; FIG. 9 is a back perspective view of the docking station from FIG. 8; FIG. 10 is a front view of the docking station from FIG. 8; FIG. 11 is a back view of the docking station from FIG. 8; FIG. 12 is a right side view of the docking station from FIG. 8; FIG. 13 is a top view of the docking station from FIG. 8; FIG. 14 is a bottom view of the docking station from FIG. 8; FIG. 15 is a front perspective view of the tool in FIG. 1 removed from the docking station; FIG. 16 is a back perspective view of the tool from FIG. 15; FIG. 17 is a front view of the tool from FIG. 15; FIG. 18 is a back view of the tool from FIG. 15; FIG. 19 is a right side view of the tool from FIG. 15; FIG. 20 is a top view of the tool from FIG. 15; and, FIG. 21 is a bottom view of the tool from FIG. 15. A single side view is provided for each component of the firearm tool as the opposite side is symmetric.

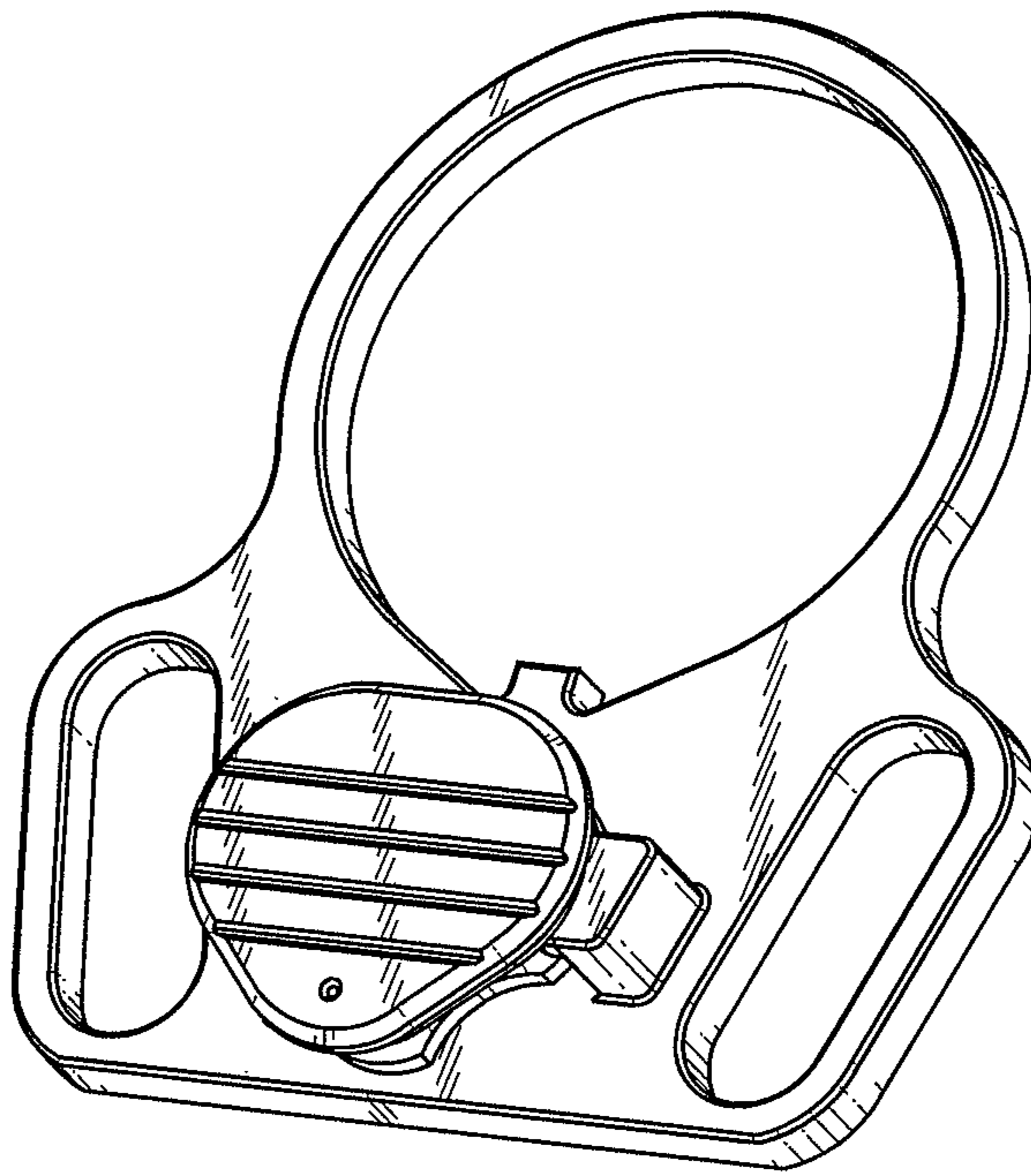

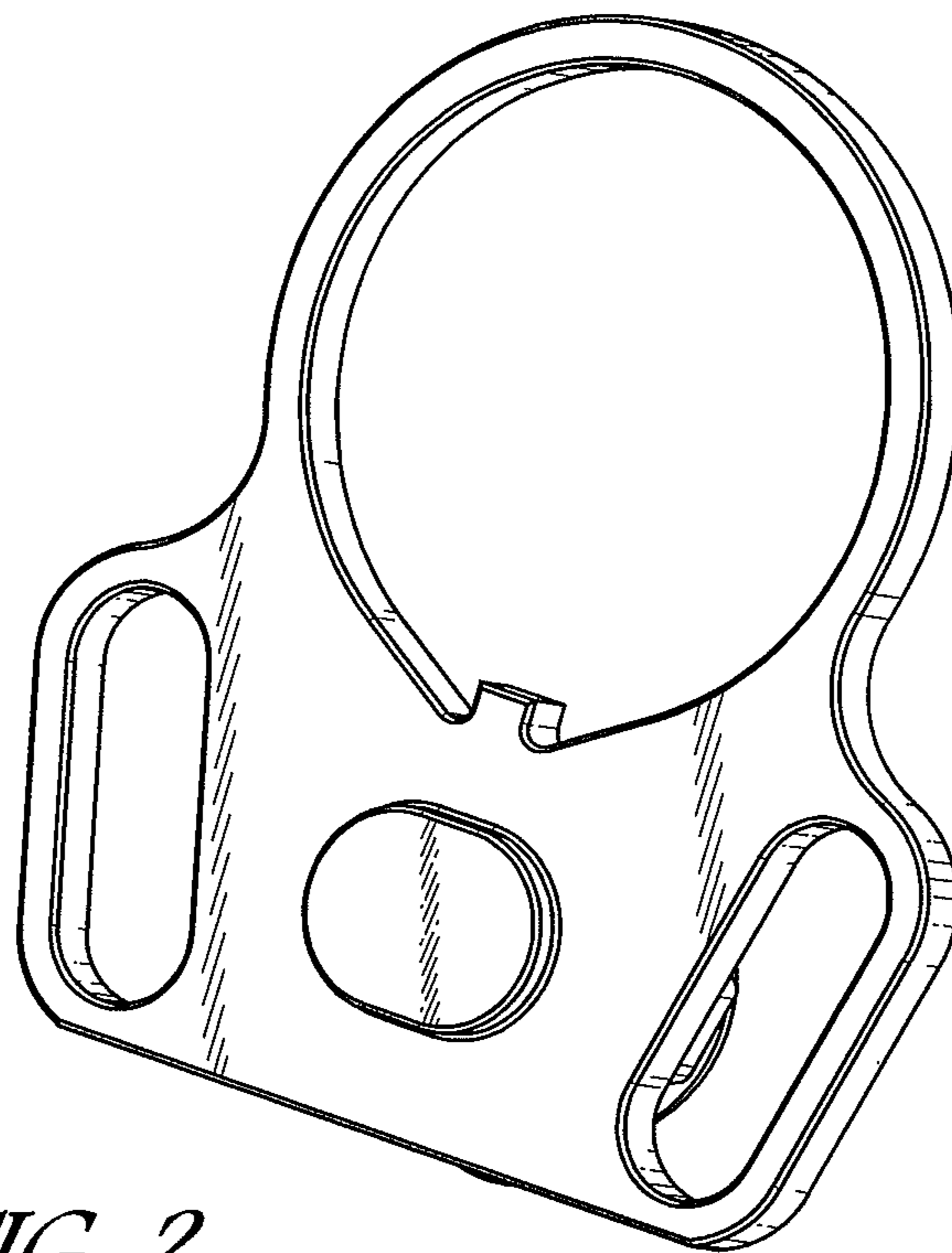

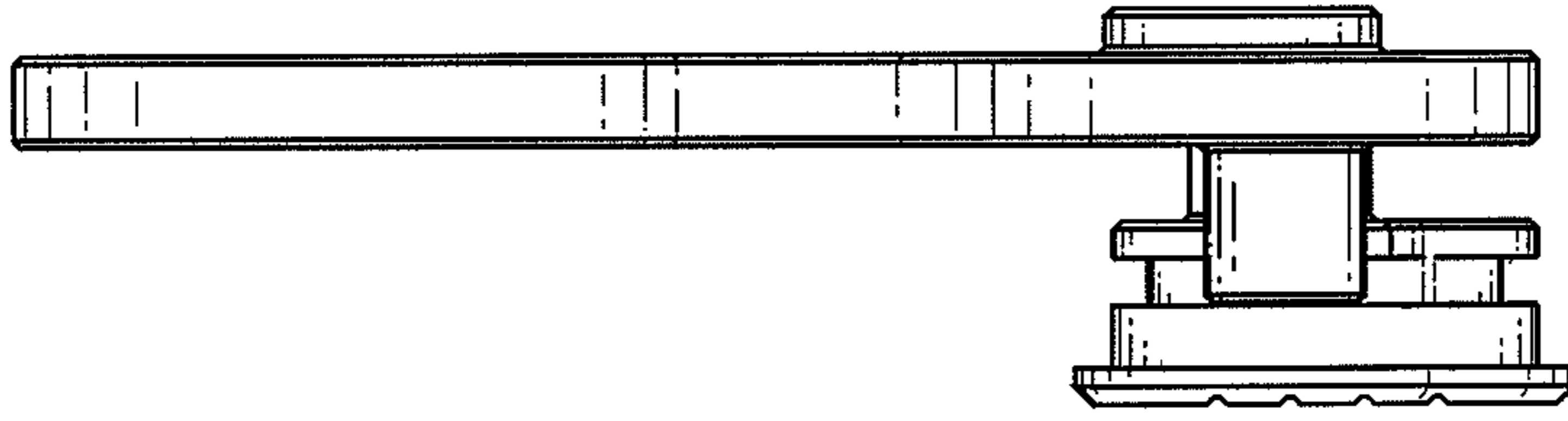

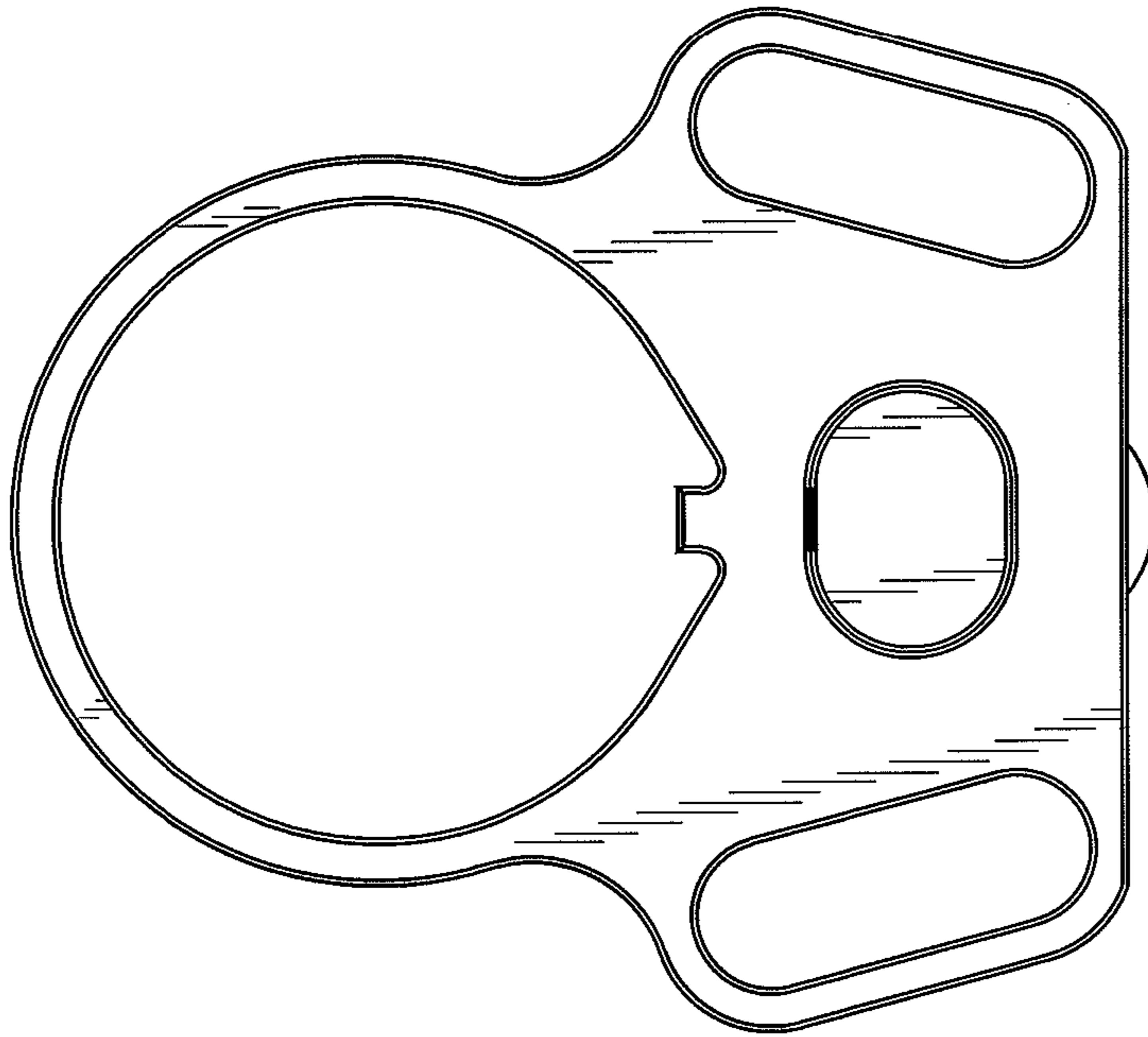

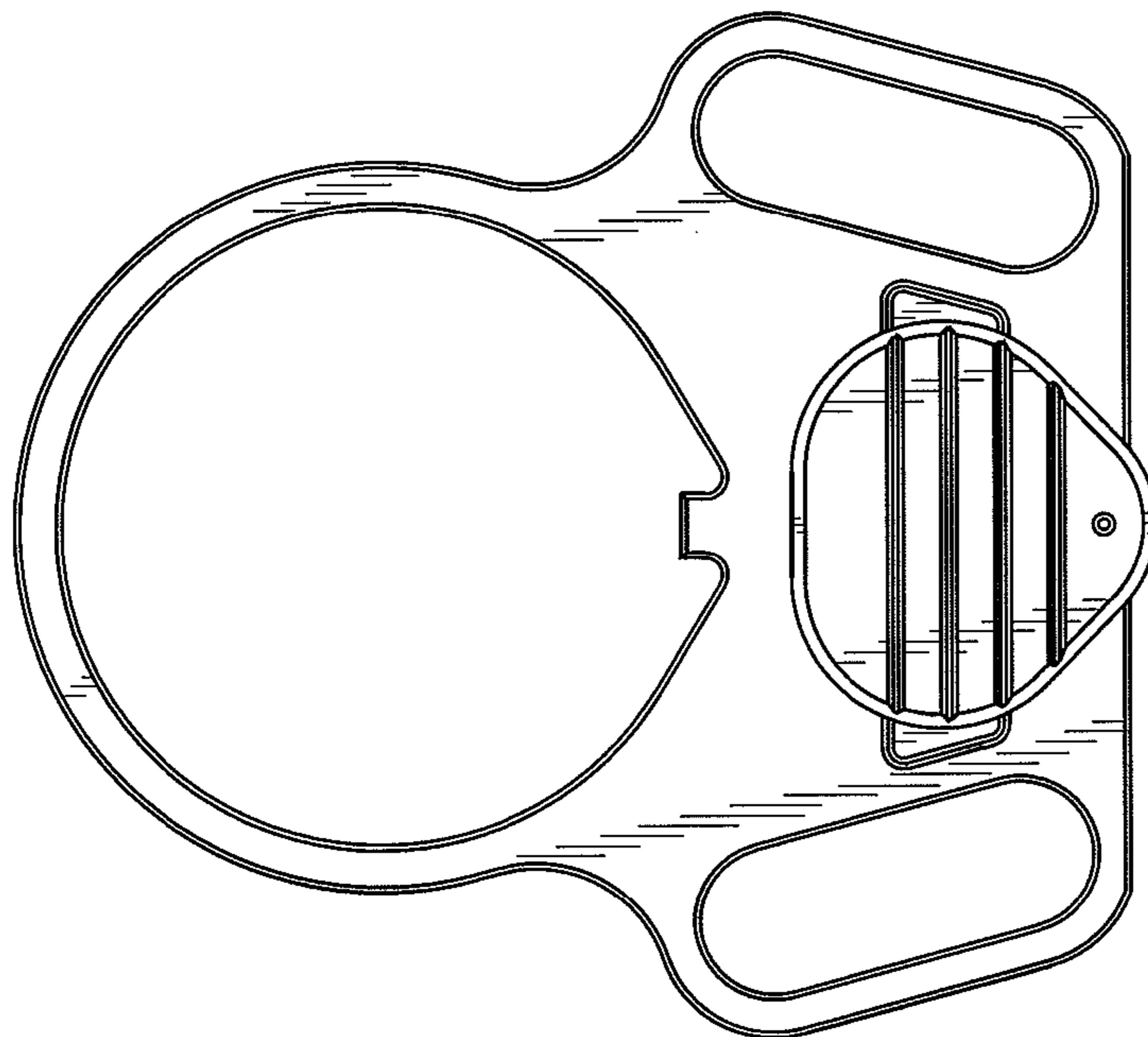

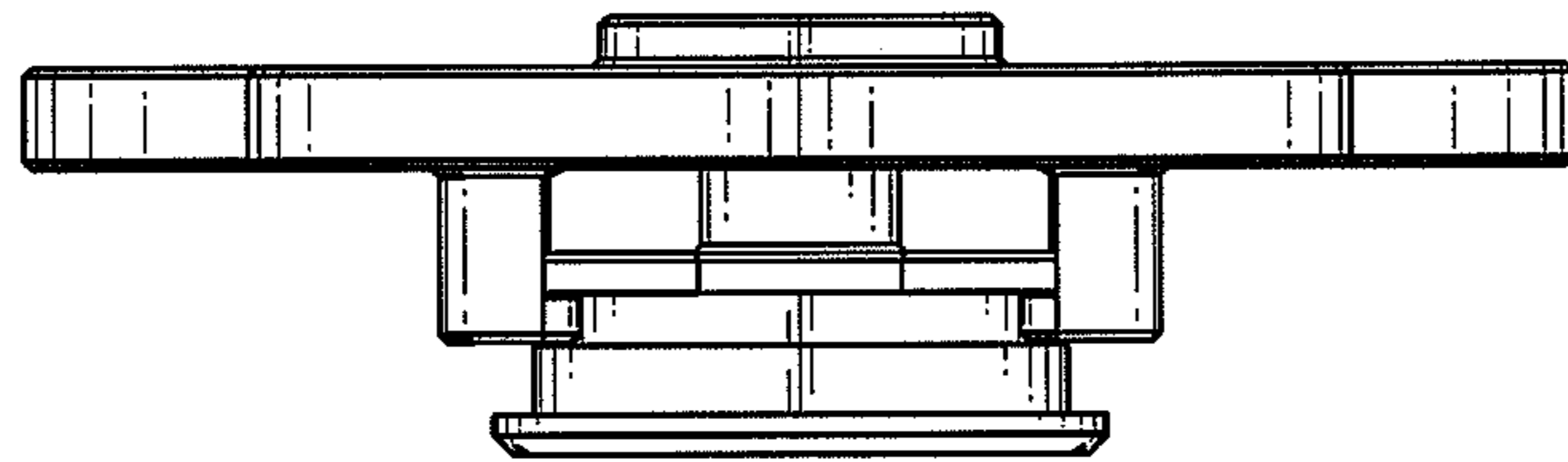

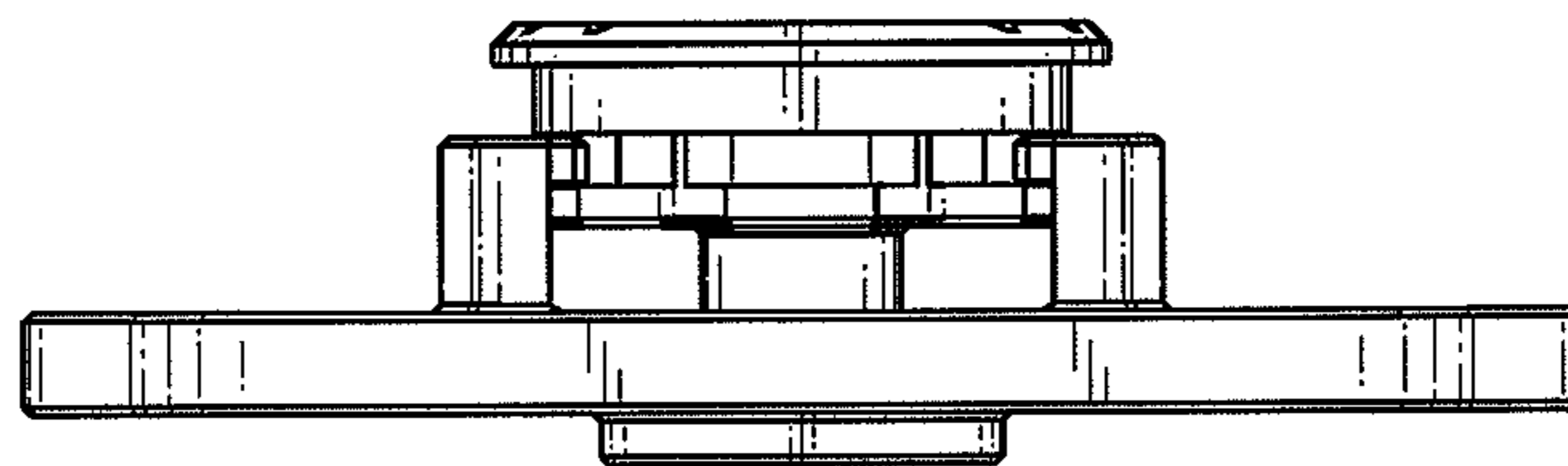

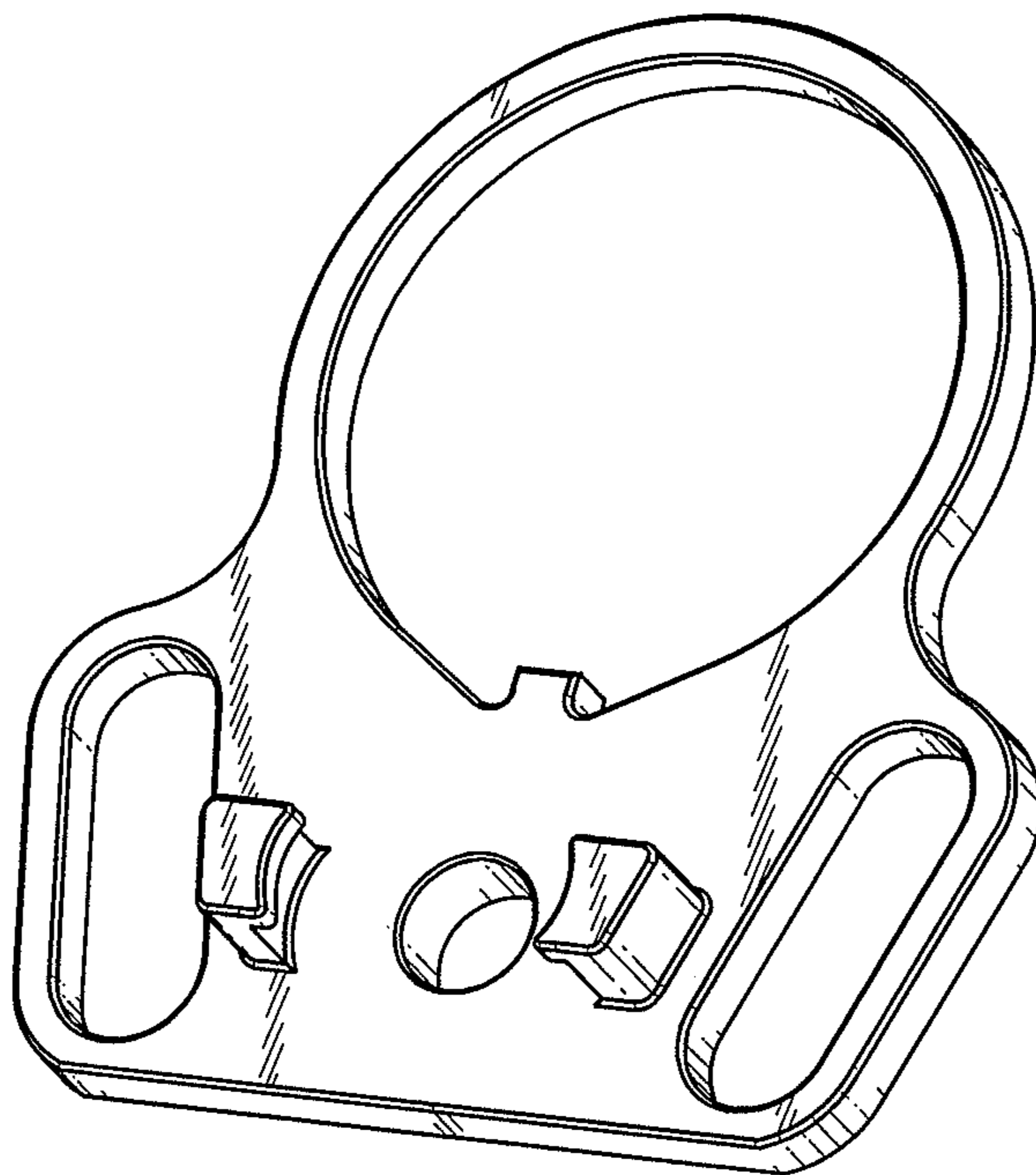

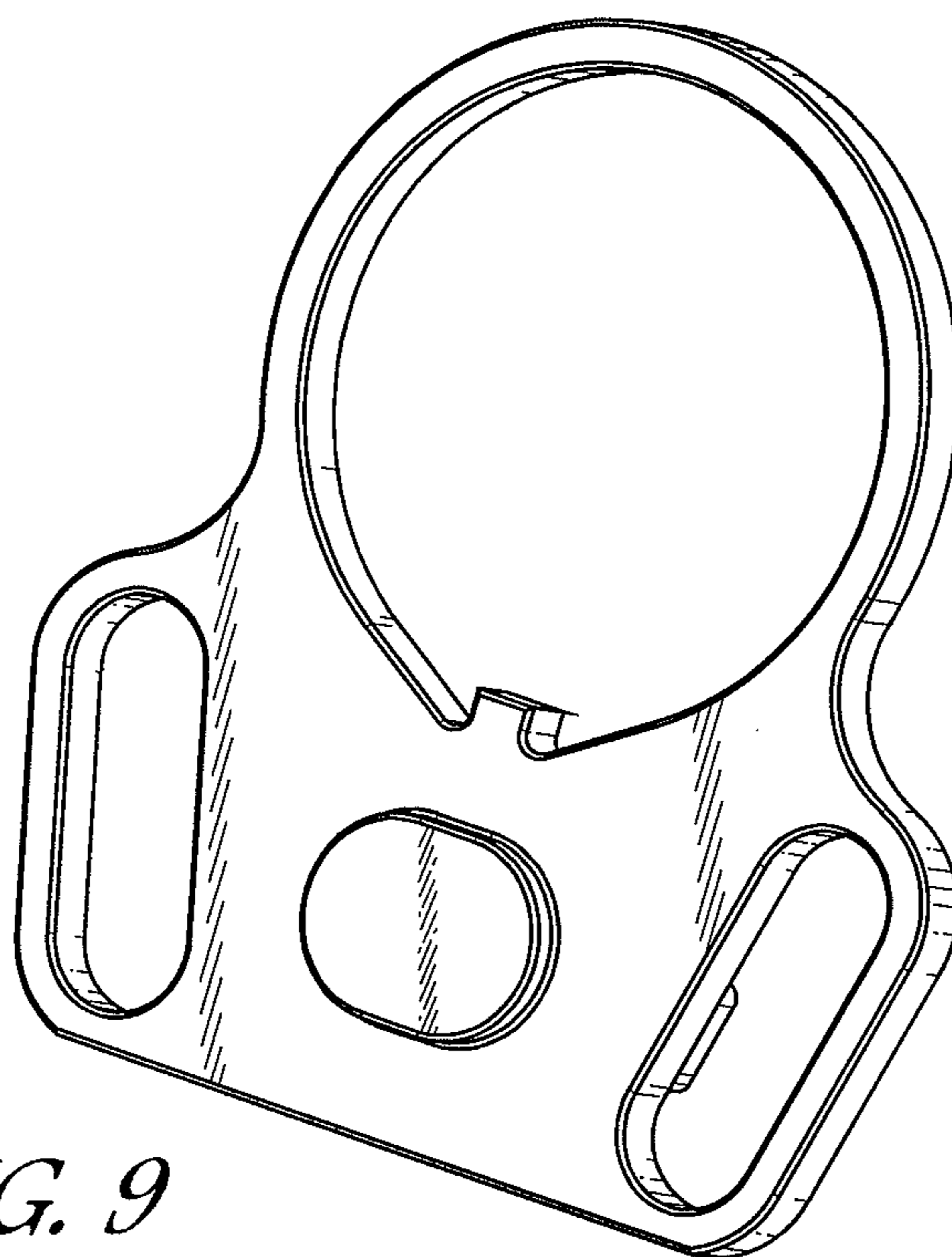

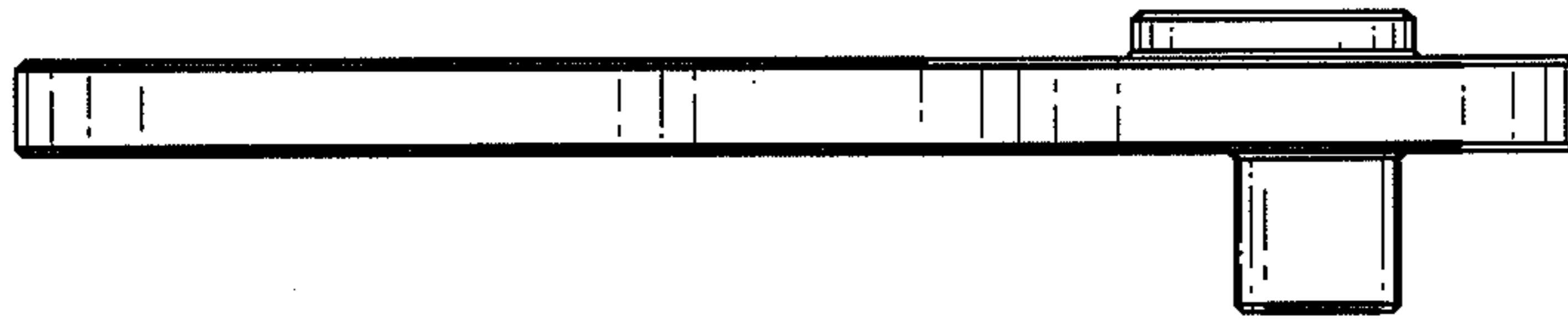

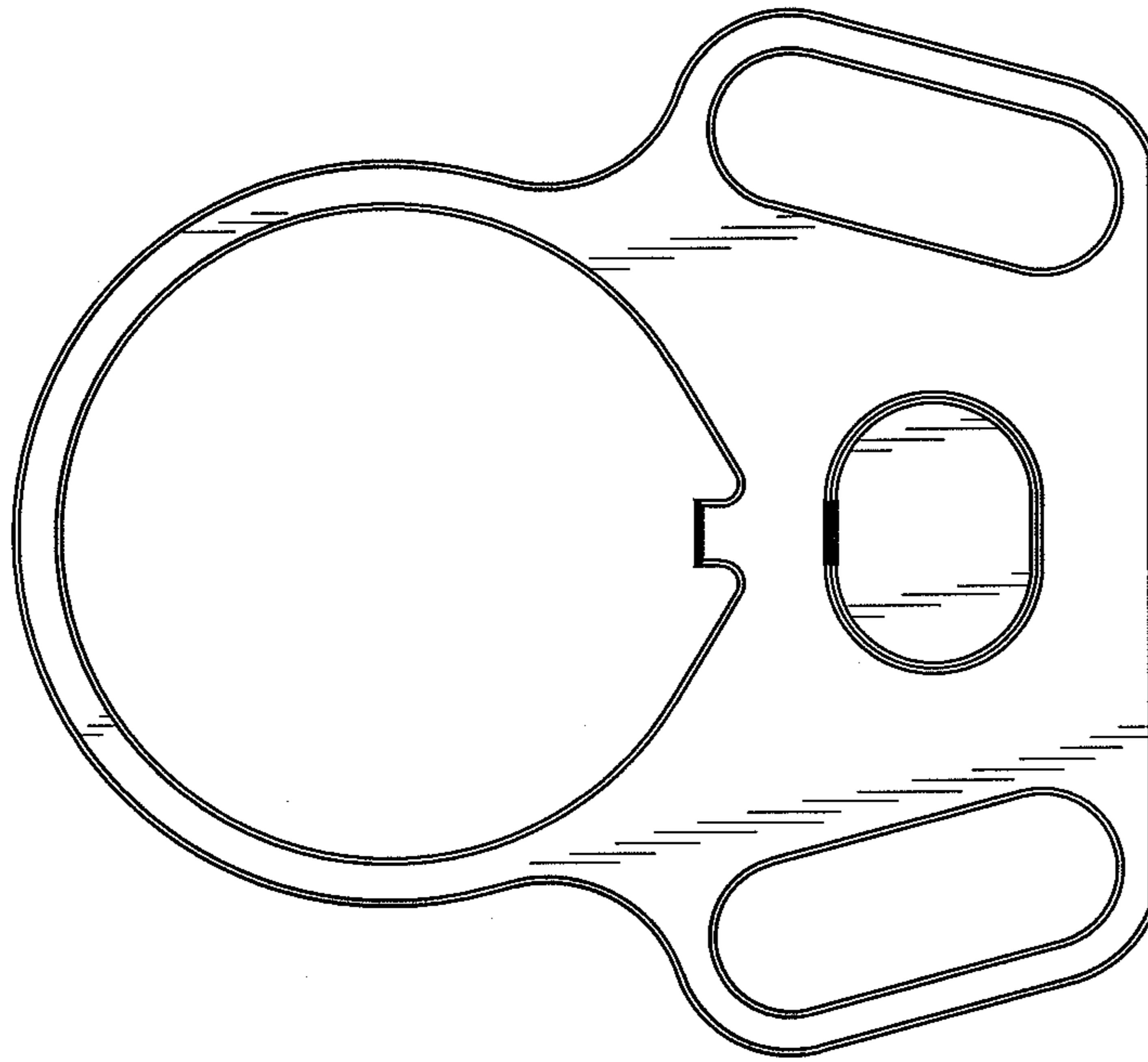

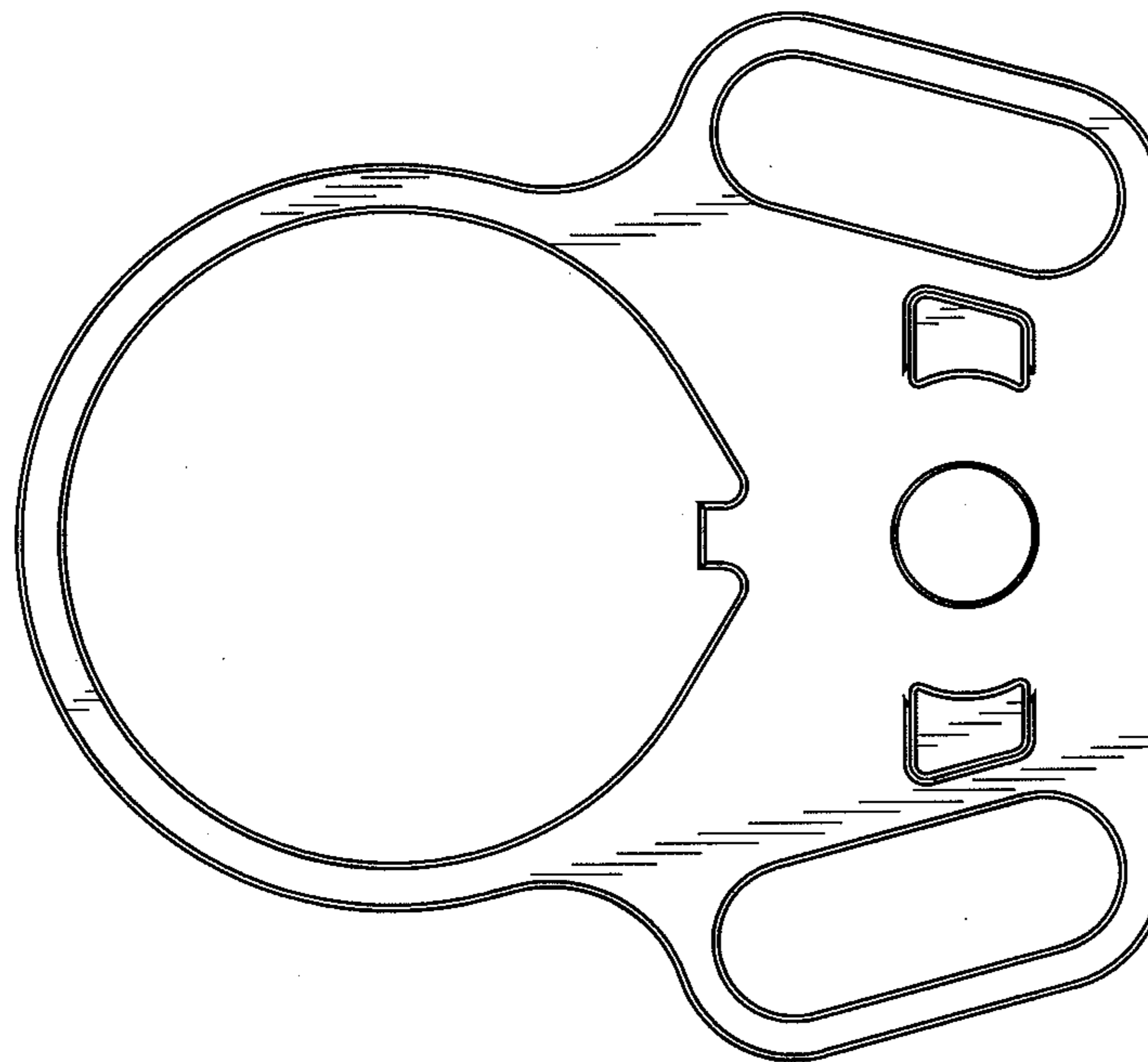

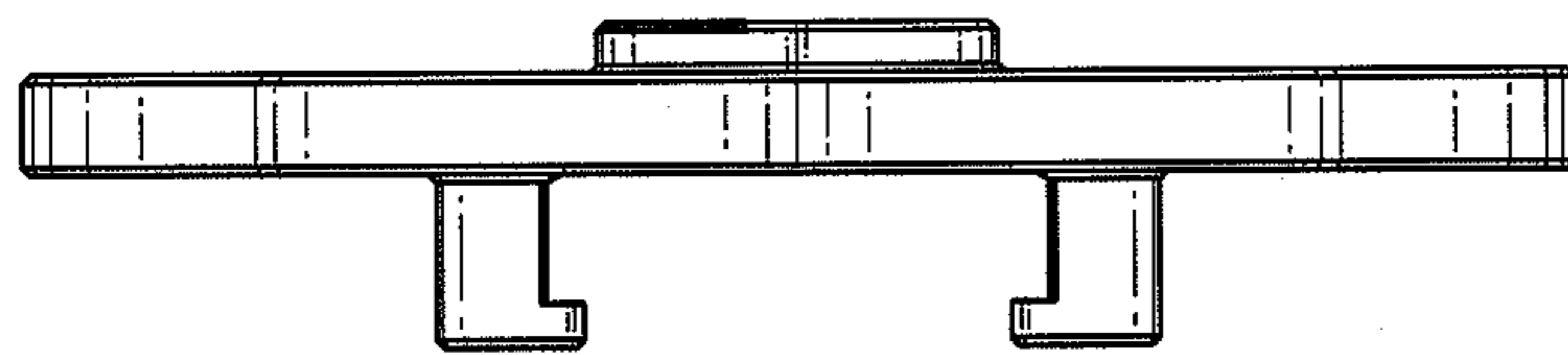

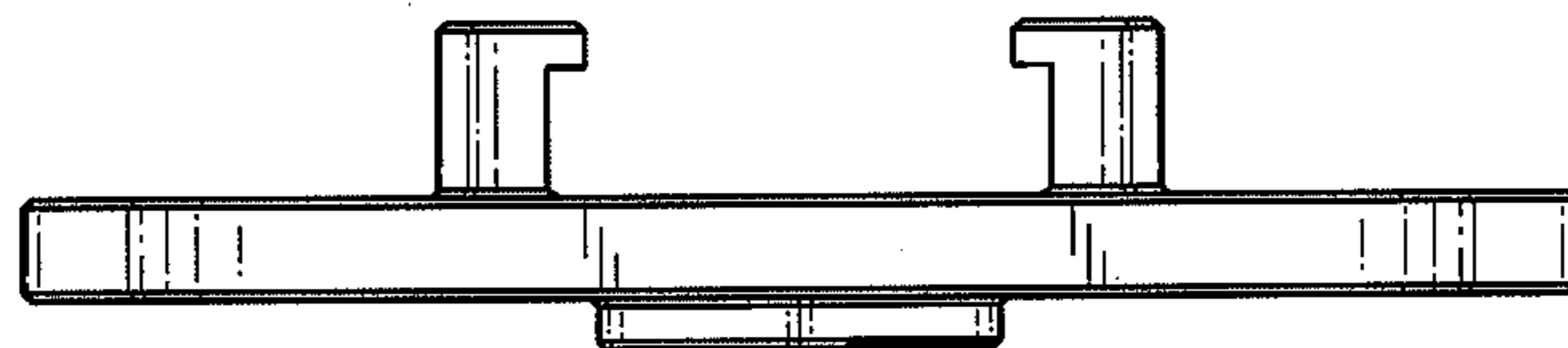

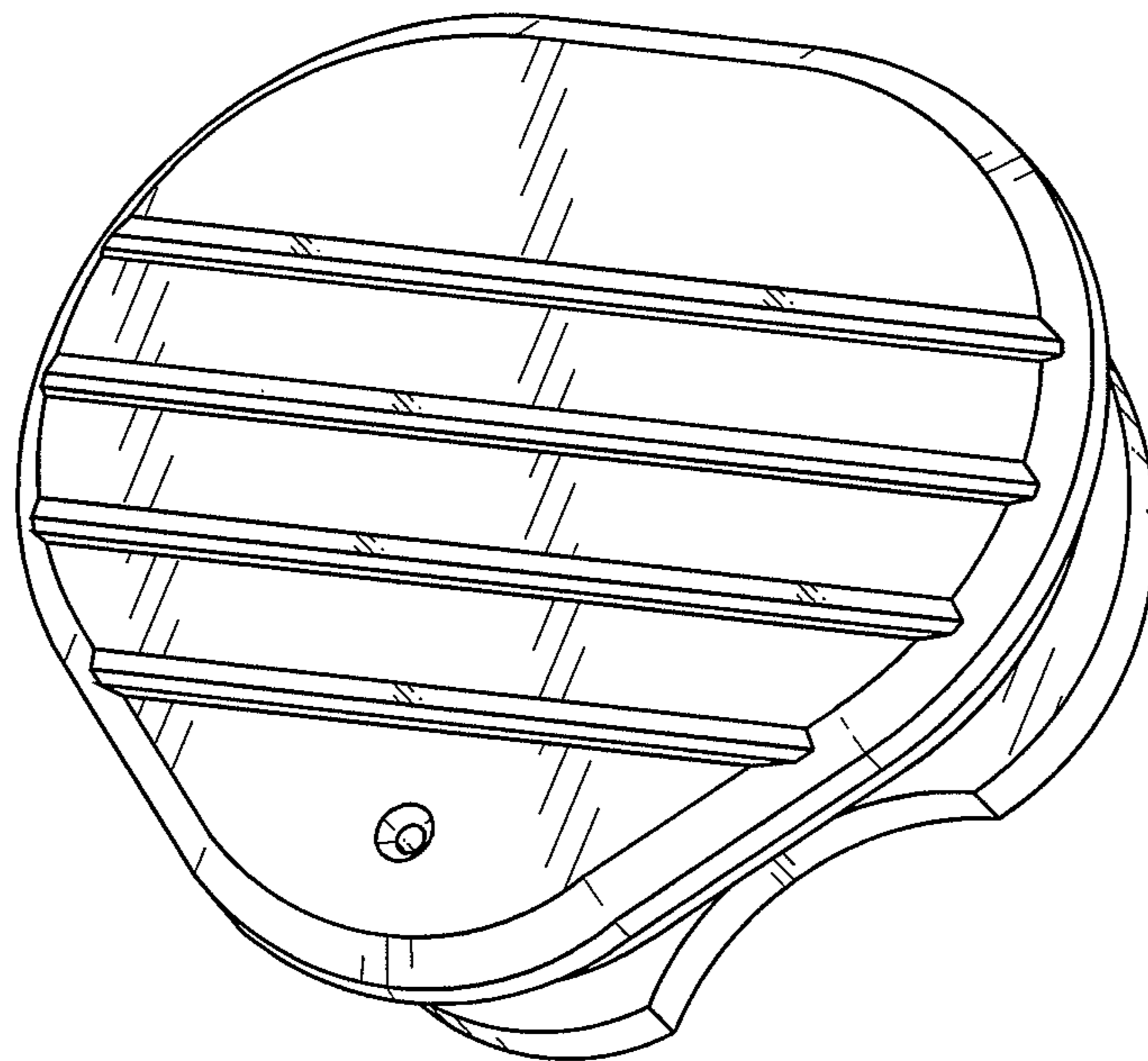

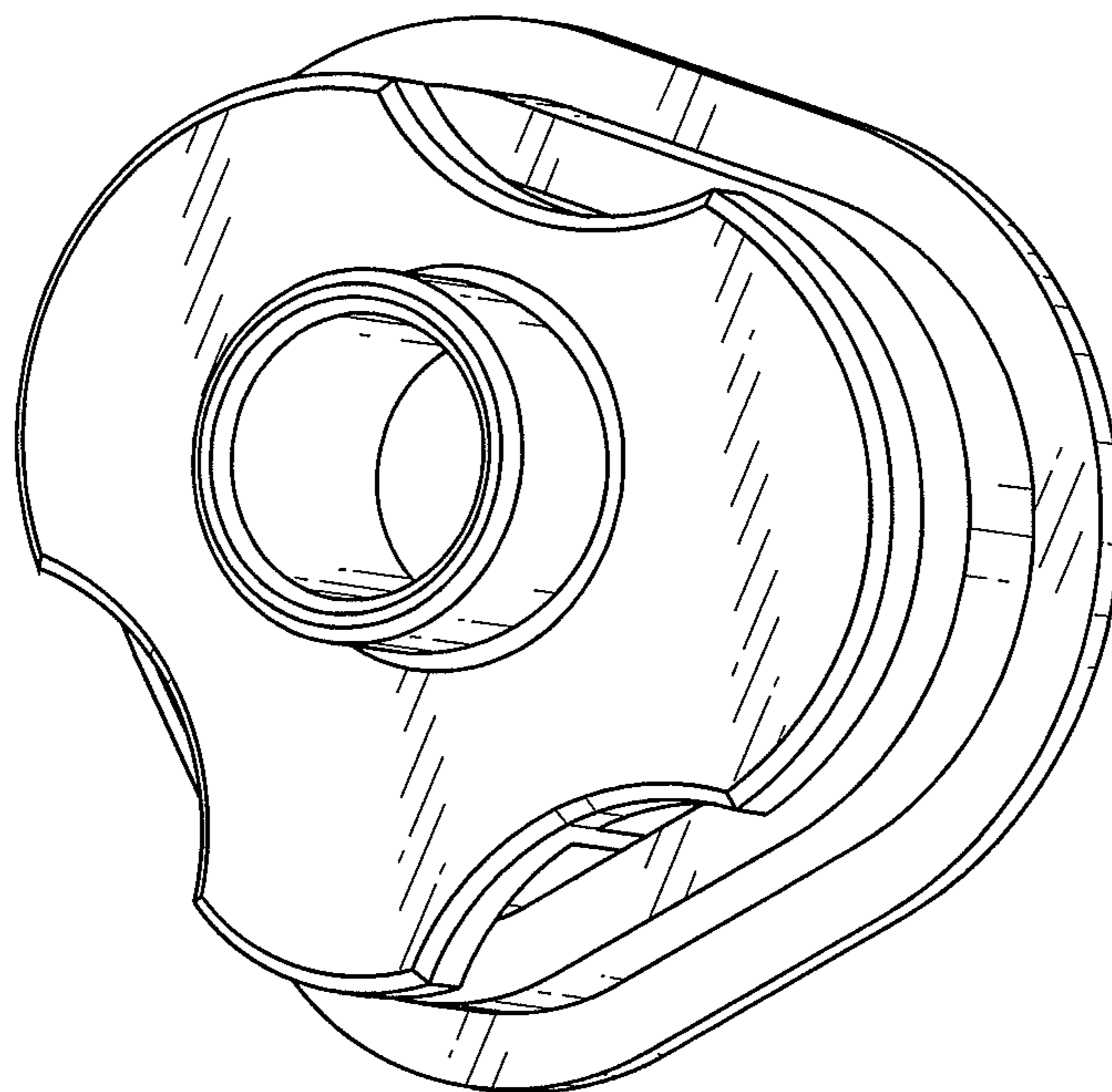

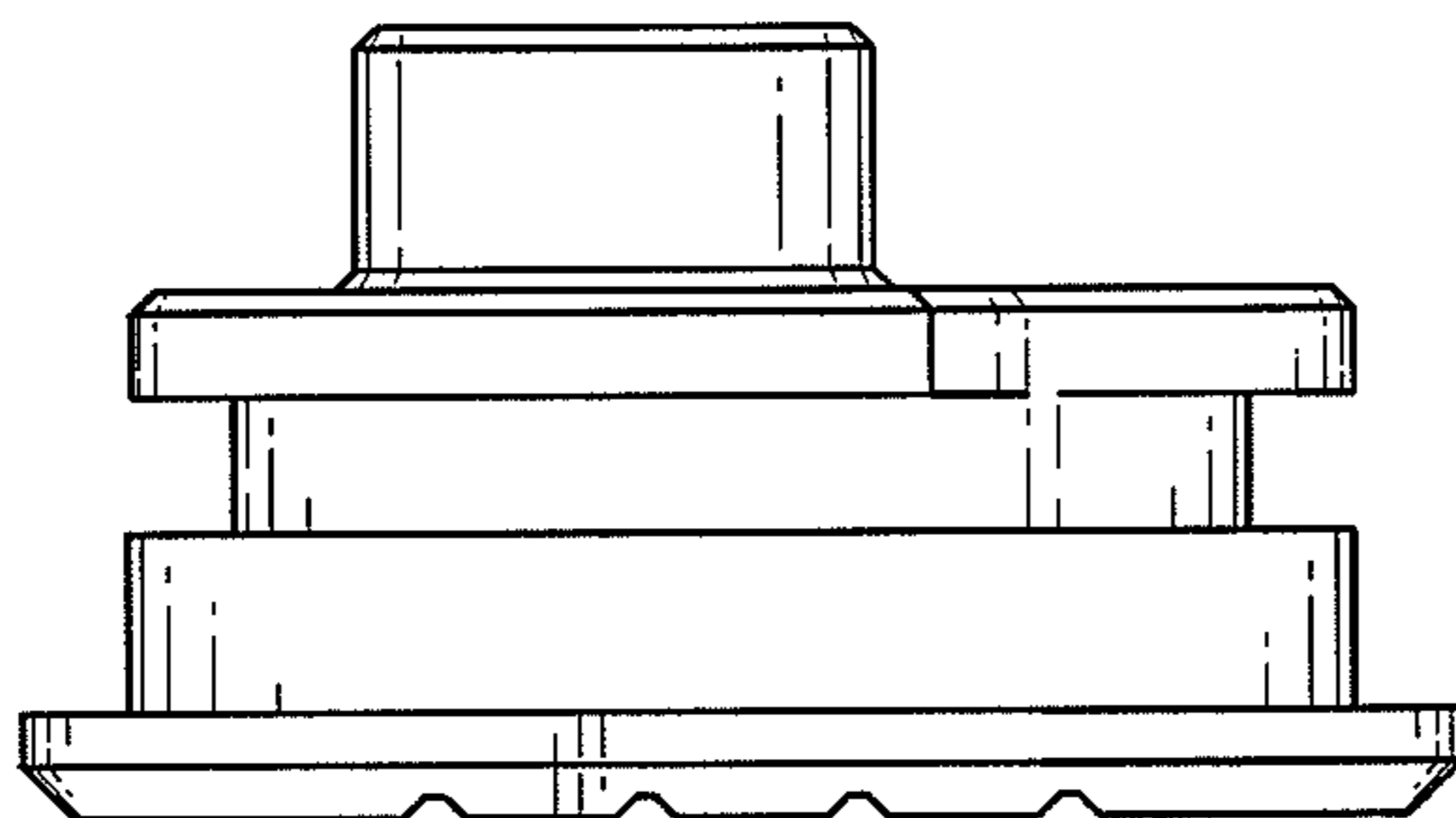

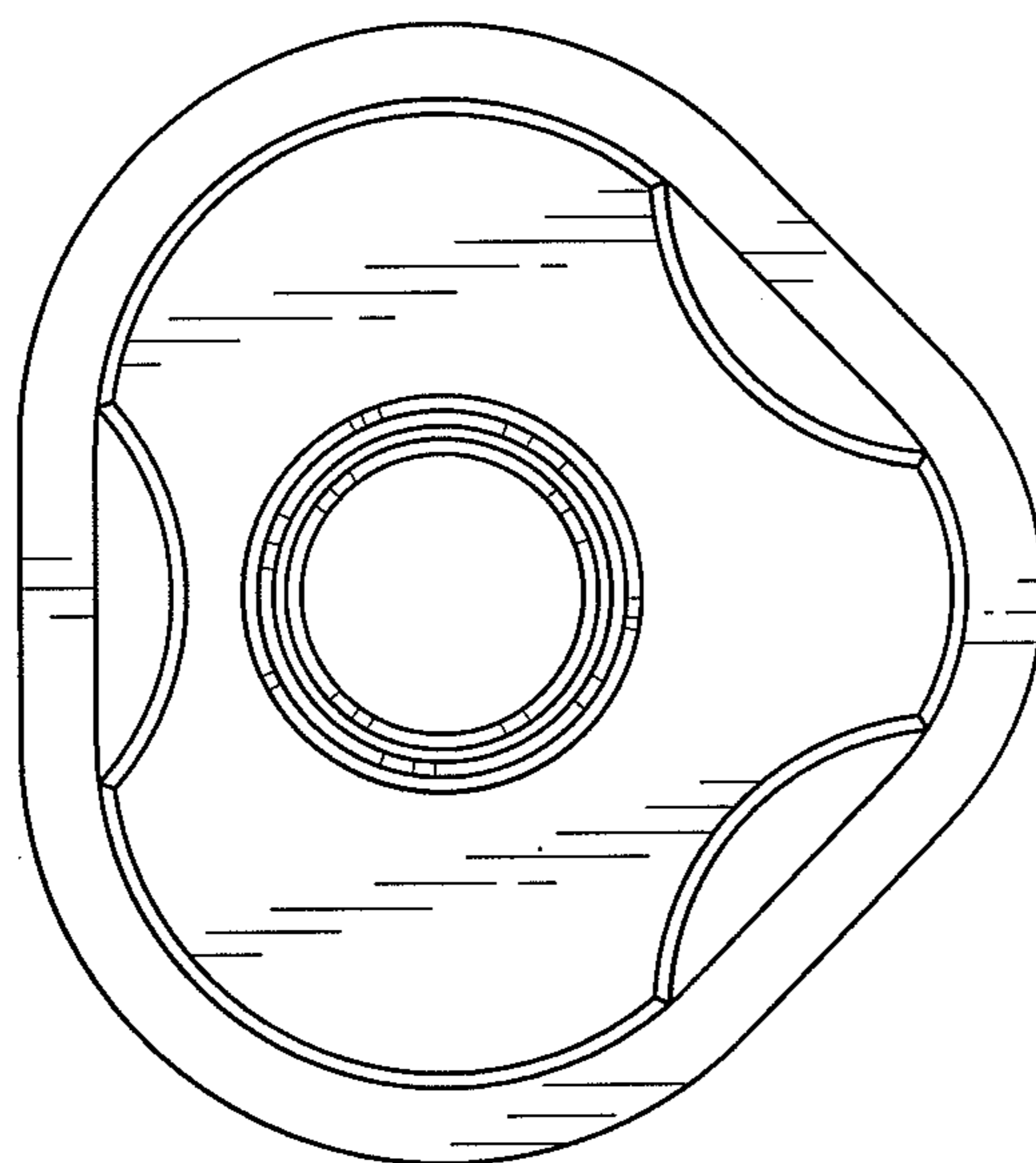

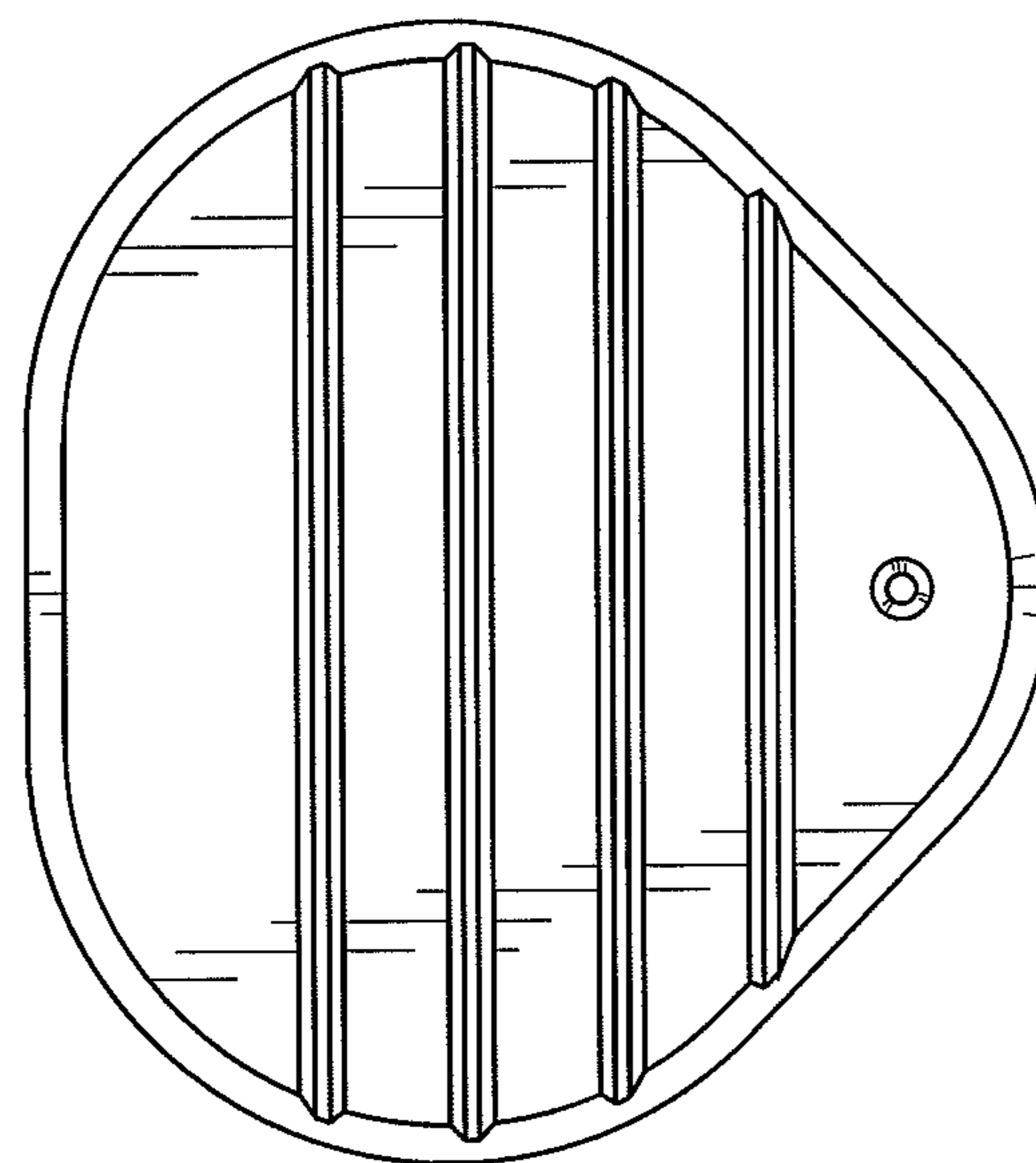

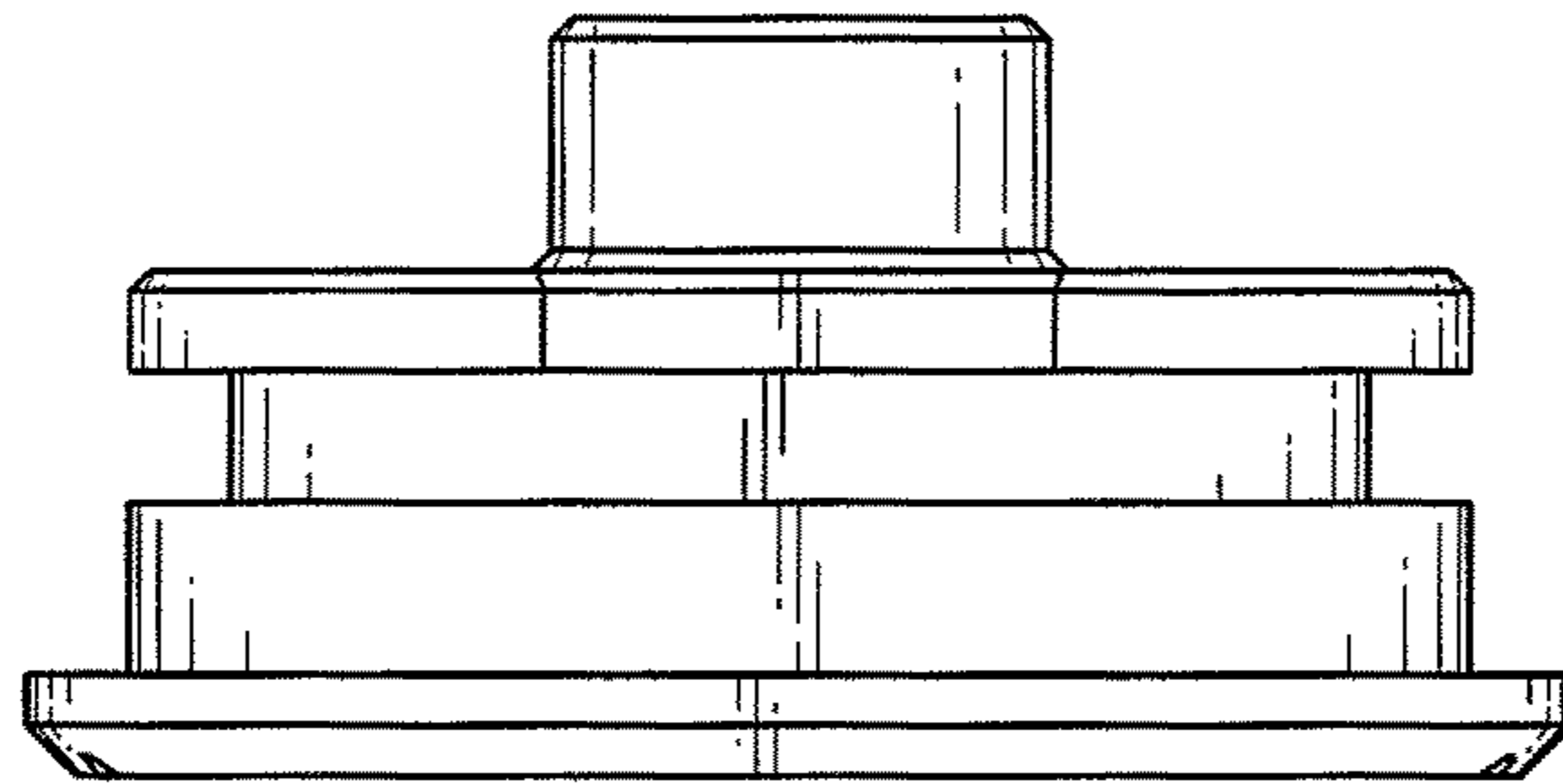

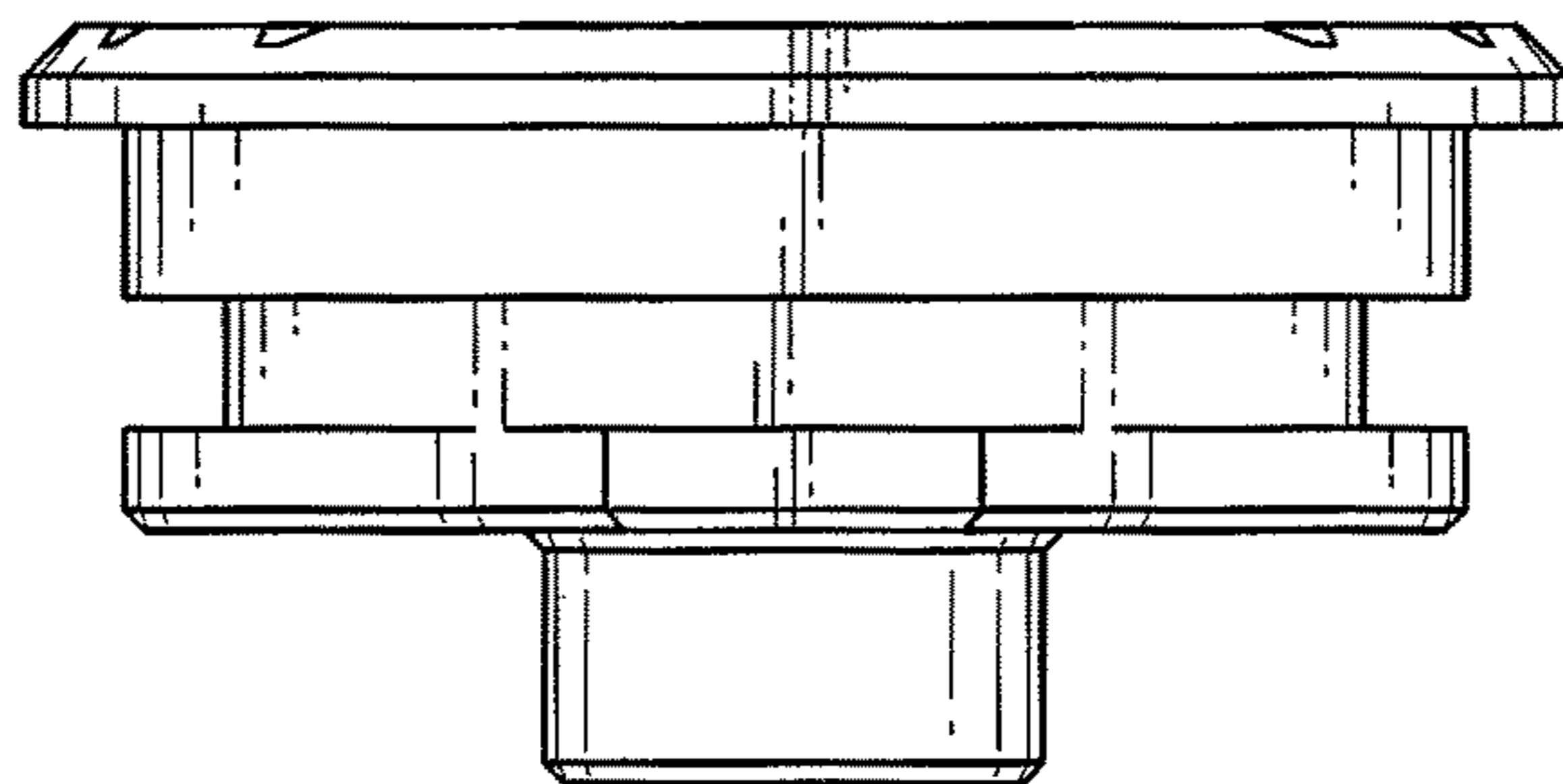
